UN body rejects debate on China's rights record

The UN rights council yesterday rejected Western-led motion to hold a debate about alleged human rights abuses in China's Xinjiang region after a UN report found possible crimes against humanity.

The defeat is only the second time in the council's 16-year history that a motion has been rejected and is seen by observers as a setback to both accountability efforts and the West's moral authority on human rights. The US, Canada and UK were among the countries that called for the motion.

China's envoy warned shortly before the vote that the motion would create a "dangerous shortcut" for examining other countries' human rights records. "Today China is targeted. Tomorrow any developing country will be targeted," said Chen Xu.

Climate change made 2022 drought '20 times likelier'

Say scientists, warn that extreme dry periods will become increasingly common with global heating

Human-caused climate change made this summer's drought across also experienced unusually high the Northern Hemisphere at least 20 times more likely, according to a rapid analysis released Wednesday that warns such extreme dry periods will become increasingly common with global heating.

The three months from June-August were the hottest in Europe since records began, and the exceptionally high temperatures led to the worst drought the continent has witnessed since the Middle Ages.

Crops withered in European breadbaskets, as the historic dry spell drove record wildfire intensity continent's power grid.

CHILDREN'S DEATHS IN GAMBIA

India tests samples of cough syrup

India is testing samples of cough syrups produced by Maiden Pharmaceuticals for exports after the World Health Organization said its products were linked to the deaths of dozens of children in Gambia, the country's health ministry said yesterday. The deaths of 66 children in the West African country is a blow to India's image as a "pharmacy of the world" that supplies medicines to all continents, especially Africa.

The WHO on Wednesday said laboratory analysis of four Maiden products - Promethazine Oral Solution, Kofexmalin Baby Cough Syrup, Makoff Baby Cough Syrup and Magrip N Cold Syrup - had confirmed "unacceptable" amounts of diethylene glycol and ethylene glycol, which can be toxic and lead to acute kidney injury.

Diethylene glycol and ethylene glycol are used in antifreeze and brake fluids and other industrial applications but also as a cheaper alternative in some pharmaceutical products.

WHO Director-General Tedros Adhanom Ghebreyesus told reporters on Wednesday that the UN agency was investigating the deaths from acute kidney injuries with India's drug regulator and the drug maker.

When he did not find his child there, he began the killing spree, Paisal said. "He started shooting, slashing, killing children at the Utai Sawan daycare centre," Paisal said.

About 30 children were at the facility when the attacker arrived, fewer than usual, as heavy rain had kept many people away, district official Jidapa Boonsom, who was working in a nearby office at the time.

"The shooter came in around lunchtime and shot four or five officials at the childcare centre first," Jidapa told Reuters.

At first, people thought the shots were fireworks, she said.

"It's really shocking. We were very scared and ran to hide once we knew it was
