morning, said the DB official, adding that the bail paper and condition don't allow Muktar to leave country.

The police raid at the bar earned criticism after the Department of Narcotics Control and Detective Branch came up with conflicting statements.

DB officials said the bar

is illegal, while DNC officials said a DNC inspector was harassed and kept locked in a room by DB officials during the police raid, and the bar had licence and valid documents to operate.

During the October 7 raid, about 500 bottles of liquor and more than 6,000 cans of beer were seized from the restaurant.

More than 2,000 establishments have been made occupying the riverbanks over the years, which include a multi-storey building of a general hospital and several important government establishments.

Shahjalal University of Science and Technology Professor Zahirul Haque Shakil, said, "Khowai is the lifeline of Habiganj."

"We've been hit hard with waterlogging in recent years as the river is filled with garbage. Keeping the river alive is crucial for the future of Habiganj town," he added.

According to locals, the river was moved 2 to 3 kilometres west from its current location due to flooding in 1976-77. Since then, the previous section of the waterbody is known as the Old Khowai River. It's about 5 kilometres long, stretching from Machulia to Kamrapur. Due to encroachment, this 200-foot-wide river has become 10 or 20 feet in some places.

Water Development Board (WDB) took up a project in 2019 at a cost of about Tk 2,000 crore, called the "Khowai River System Development Project", in collaboration with the district administration to restore the river's normal flow.

More than 600 structures had been identified as illegal, and 500 of them have been demolished by the district administration as part of this project. Fearing

repercussions, many owners have abandoned or destroyed their own establishments during this time.

However, the authorities did not hold on to this momentum for a long time and dropped the ball soon after.

As a result, the structures have been rebuilt on the riverbanks and the status quo went back to square one.

Besides, new structures were built on both sides of the river in various places, including Machulia, Inatabad, Shayestanagar, Mahmudabad, Shyamoli and Puran Munsef residential areas.

Shamsul Mia, a resident of Mahmudabad in the city, said encroachers abandoned their buildings initially when the drives started in 2019. But they started coming back after two to three years, as the authorities did not carry on with the evictions.

Contacted, Shah Newaz, WDB executive engineer in Habiganj, said, "I don't know the status of the 2019 project. However, we've recently started construction of a 500-metre walkway on the river's west bank."

"If we get more allocation, we'll engage more manpower in evicting the illegal structures," he said.

Bijan Banerjee, additional deputy commissioner (revenue) of Habiganj, said the authorities will soon conduct eviction drives to free the riverbanks.

annulled the system with the help of Justice Khairul Haque."

Later, he said the government has politicised the judiciary, which now dictates what the nation's political structure will be.

Fakhrul said the government has also destroyed the country's economic structure through widespread looting and stealing. "The main motive behind all mega projects is theft."

He said the ruling party was boasting for a long time that the country has achieved self-sufficiency in electricity with a power generation capacity of about 25,000 MW. "But we're now facing load shedding."

The BNP leader said Tawfiq-e-Elahi at a programme of businessmen helplessly admitted that they will not be able to provide power during the day, and it will be given only at night.

He said people now cannot freely express their opinions due to the Digital Security Act and other repressive laws.

ID cards of human rights organisations and civil aviation authorities were seized from their procession.

themselves as goldsmiths, while Mozammel Khan alias Akash pretended to be a chemist and nuclear expert.

There are multiple cases against the arrestees with Kalabagan Police Station, Dakshinkhan Police Station, Uttara-Purba Police Station, Kashimpur Police Station and Fakirhat Police Station of Bagerhat.

Abdul Jabbar Sharif, an electronics engineer of the station, said several parts of the frequency image unit have been malfunctioning.

"It [station] cannot determine the speed, strength, intensity and position of the cyclone. Due to the suspension of operational activities, the process of collecting data and information of cyclones have to be run through the stations in Cox's Bazar, Moulvibazar, Dhaka's Agargaon and the one along the Bay of Bengal," he said.

Contacted, Mohibbur Rahman, lawmaker of Patuakhali-4 (Kalapara-Rangabali) and member of the parliamentary standing committee on defence ministry, said, "This is a very important public issue. I have written to the defence ministry regarding this. I have also discussed this in the parliamentary committee meeting."

"A team of experts has already visited the station. Hopefully, the parts will be installed shortly and the operational activities will start soon as well," he added.
