## **Rein in tax** exemptions

### IMF mission prescribes NBR, banking division

Known knowns -- is what best sums up the prognosis of the visiting International Monetary Fund mission so far as it looks to thrash out the conditions for the prospective \$4.5 billion loan.

Take, for instance, the prescription to the National Board of Revenue yesterday during the staff mission's second full day of meetings after it arrived in Dhaka on a 15-day tour.

The mission called for bringing down tax exemptions, which include complete relief from taxes, reduced rates or tax on only a portion of items.

It is a well-established fact by now that the tax exemptions in Bangladesh are unsustainably high and need to be reined in.

And yet, not much has been done on that front over the years.

What is worse is the government has no idea how much the state coffer is being deprived of for this act of generosity.

"There needs to be a systematic estimation we have none," said H Mansur, Ahsan executive director of the Policy Research Institute of Bangladesh. PRI did a study a while back on the

matter and found Tk 40,000 crore is lost every year. That amount would easily be more than Tk 60,000 crore now

"If there is no baseline estimate, we do not know where we stand on this," said Mansur, a former economist of the IMF.

The ten-man IMF mission has now asked the NBR to do that, The Daily Star has learnt from people involved in the discussions held vesterday

"This is an old matter. The question now is who will do what and when," said Zahid Hussain, a former lead economist of the World Bank's Dhaka office.

The NBR though is reluctant to claw back the tax exemptions as it drives GDP growth, according to people familiar with the discussions, who requested anonymity to disclose sensitive deliberations.

The IMF team also urged the NBR to boost its revenue --a longstanding Achilles heel of the Bangladesh economy. At less than 10 percent, Bangladesh has one of the lowest tax-GDP ratios in the world. And yet, not much was done to change the narrative.

The mowers and the rollers had made way into the ground with the Bangladesh team management members congratulating one another near the touchline on a memorable victory. The players were all off the field but the nerves that had just been relieved all rushed back in as umpire Marais Erasmus signalled noball, meaning Mosaddek Hossain had to bowl that final delivery again.

What transpired before that point had already left everyone on the edge of their seats. By no means a death overs specialist, all-rounder Mosaddek had been asked to do a job of defending 16 runs in the last over by skipper Shakib Al Hasan. He fired one at Ryan Burl's pads as Zimbabwe ran for a leg-bye and that was critical as Burl, the recognised batter batting on 27, did not get the strike again.

The High Court yesterday questioned the legality of the rules that allow the police to prohibit assemblies and processions in Dhaka.

The court also issued a rule asking the authorities concerned of the government to explain within four weeks as to why section 29 of

the Dhaka Metropolitan

Police Ordinance, 1976, that

empowers the law enforcers

to prohibit assemblies and

processions should not

be declared illegal and

Section 29 of the

ordinance said, "Police

commissioner may, by

order in writing, prohibit

any assembly or procession

whenever and for so long

as he considers such

prohibition to be necessary

for preservation of the public

unconstitutional.

A long-term plan from the NBR on how it would improve its receipts was sought.

The mission, which will wrap up its tour on November 9, also wanted a progress report on the various reforms undertaken by the NBR, particularly the automation of the tax administration.

"There have been no reforms -- all efforts towards that end were in vain. The NBR has no interest in reforms. If you insist on reforms, they demand more resources, when they are adequately manned," Mansur said.

The Washington-based multilateral lender called for speeding up automation, yet another dragging issue.

"No reform can complete the finish line," Hussain said. The team wanted the status of the amendment of the

### **PRY SCHOOLS** Govt plans 1 shift for all

The government is making a plan to have only one shift at all primary schools, said Aminul Islam Khan, the senior secretary of the Ministry of Primary and Mass Education, yesterday.

Implementation of the plan will begin from January next year, he told reporters on his last day at the ministry.

The plan will be made considering the number of students, classrooms and teachers of the particular schools, he said.

"About 90 percent of the work has been done so far," he said.

There are many primary schools that have just one, two or three classrooms. It is not possible to hold six classes in two rooms, he said, adding that such schools might be turned into preprimary schools.

"No school will face closure, no teacher will lose their jobs. Only the work will have to be shared [by the teachers]," he said.

There are 65,566 primary schools in the country and most of them conduct classes in two shifts.

### Ninth application for recognition of Guerrilla Hafiz turned down AHMAD ISTIAK

Syed Hafizur Rahman, a martyred guerrilla of Liberation War, has once again been denied the state recognition.

Despite a previous assurance to this newspaper of necessary steps if the family applies afresh, the Ministry of Liberation War Affairs outright rejected an application submitted yesterday.

With this, the request for the recognition has now been turned down for the ninth time, leaving the family members in utter despair.

"We've applied nine times now, but never once was our

application accepted, let alone given consideration for further review," said Anwara Khatun, the younger sister of Hafiz.

"We have endured harassment in this manner for years. Now, we are feeling so helpless that we are at a loss for words," she said, her voice tinged with frustration.

"It's as if we've committed a crime by being members of the family of a martyred freedom fighter."

Previously, four of his family members submitted eight applications separately in 1974, 1985, 1990, 1991, 1998, SEE PAGE 2 COL 2
