Ted Kennedy Jr to speak at DU today

Edward (Ted) M Kennedy, Jr, son of late US Senator Edward M Kennedy and nephew of late US President John F Kennedy, will deliver a public speech on "Commemoration of 50 years of US-Bangladesh Relations" at Dhaka University today.

The US Ambassador Peter D Haas and Dhaka University Vice Chancellor Md Akhtaruzzaman will be present during the landmark speech to be delivered at Nabab Nawab Ali Chowdhury Senate Bhaban.

Under the auspices of the US Department of State's Speakers Program, Kennedy will give the speech to commemorate the legacy of his father as a staunch advocate for Bangladesh's fight for independence and will visit the banyan tree his father planted to symbolize the friendship between the United States and Bangladesh.

"During my upcoming visit to Dhaka, my family and I will honour the 50th Anniversary of my father's pivotal role in the Bangladeshi struggle for independence," Kennedy tweeted before arriving here.

Ted's father, the then US senator Edward M Kennedy took a bold stance against the genocide committed by Pakistan during the Liberation War of Bangladesh in 1971 despite the US government's tilled down foreign policy towards West Pakistan.

The Pakistan military administration under General Yahya Khan tried to suppress information regarding the genocide in Bangladesh launched on the night of March 25, 1971.

But Edward Kennedy exposed the brutality of the Pakistani occupation forces to the world communities after his visit to the refugee camps in India in August 1971.

Edward Kennedy planted a banyan tree at the famous "Bottola" on the Dhaka University campus during his visit to the newly born Bangladesh in

As a lawyer and advocate for the civil rights of individuals with disabilities, he will also deliver a lecture on the rights of challenged people at the Edward M Kennedy Centre for Public Service and the Arts here.

The US Embassy in Dhaka termed the visit as "historic" while Edward M Kennedy, Jr along with his family members arrived here on Saturday

Schoolhouse damaged by Amphan lies unrepaired

Boichitala Secondary School in Moheshpur municipality, which was completely damaged when super cyclone Amphan ravaged the country's coastal areas in 2020, has still not been repaired, posing serious risks of accidents to the students and teachers.

Parts of the roof of building, which housed six classrooms, was blown away by gusty winds caused by the cyclone.

The institution, established on four acres of land at Boichitala village in 1968, has a total of 400

students and 10 teachers. Although the school managing committee has somehow managed to repaired four out of the six classrooms, the remaining two are still in a dilapidated state for the lack of funds.

In 2020, Education Engineering Department built a one-storey building with three rooms as an alternative option for conducting classes.

Girl killed as rod of underconstruction school building falls

An eight-year-old schoolgirl died yesterday after an iron rod from an under-construction building in her school collapsed on her at Sunamgani's Tahirpur upazila.

The deceased was identified as Usha Moni, daughter of Anwar Hossain and a second grader at Sreepur Government Primary School.

"The incident occurred after Usha stepped outside her classroom during class hours to drink water," said Syed Iftekher Ahmed, OC of Tahirpur Police Station.

Critically injured, the girl died on her way to a hospital.

"Despite repeated requests and warnings, the contractor was lifting iron rods to the building's roof using ropes instead of carrying them via the stairs. His carelessness claimed the life of one of our students," said Mofazzal Hossain, headteacher

The victim's father has filed a complaint.

"The building is being constructed by the Local Government Engineering Department. We are looking into the matter and will take necessary steps soon," said Syed Abul Khayer, upazila education officer in Tahirpur.

'Drug addicts' kill man, hurt 2 others

A man was hacked to death while two others were injured allegedly by a group of drug addicts in Tangail's Nagarpur upazila on Saturday night.

The deceased was identified as Sultan Hossain Swapan, 55, of Shyampur village and an employee of Agnibina Ideal College.

"Sultan's son Polash was allegedly chased by four men after he barred them from taking drugs at Ghuni Government Primary School ground around 8:00pm," said Sazzad Hossain, OC of Nagarpur Police Station, quoting locals.

"Polash took shelter in a tea stall near Singjora bazar where his father and others were present. The criminals attacked them with sharp objects, leaving Sultan and two others injured."

They were rushed to the Nagarpur Upazila Health Complex where the doctors declared Sultan dead. Of the injured, Azmi, 28, was moved to Tangail General Hospital while Simul, 19, was discharged.

A case, against five named, aged between 18 and 45, and seven other unnamed, was filed yesterday.

Palestinian gunman shot dead after killing Israeli man

A Palestinian gunman killed one person and wounded at least three others in a Jewish settlement in the occupied West Bank before being shot dead by a guard, the Israeli military, medics and a settlement spokesperson said.

The Islamist militant group Hamas claimed the slain Hebron gunman as its member.

"The government must step down. Our MPs are ready to resign from parliament anytime. Our MPs . Rumeen, Harun, Zahid ... are here. They will resign whenever the party asks them to," he added.

During yesterday's briefing, held after a preparatory meeting for AL's national council slated for December 24, Quader also said they will not hold any programmes to counter BNP's.

'The council meeting of Cumilla metropolitan Awami League will be held on November 5. We heard the BNP has a rally in Barishal that day. Will you call it a counter programme? There is no question of countering BNP programmes," said Quader, also the road transport and bridges minister.

Mentioning that AL President Sheikh Hasina will join public rallies outside the capital from now on, he said, "She could not attend any outdoor programmes for long due to the Covid pandemic. She has been saying for the last few days that she would attend outdoor rallies. Initially, she specified two or three district units and gave instruction to hold rallies there and in other districts gradually."

Claiming that the ruling AL did not create any obstacle to any BNP rally, the AL leader told reporters, The transport people are afraid of BNP and that's why they called the strikes.'

Blaming the BNP as the main patron of communal forces, Quader claimed the BNP's rallies get paralysed without these elements. If the BNP resorts to arson again, it will be resisted by the people. Arson attacks will not be allowed in any way.

Speaking about the councils of AL's associate bodies and pro-AL organisations, Quader said those will be held before the party's national council, adding that the party chief has given instructions in this regard.

peace or safety: provided that on such prohibition shall be remaining in force for more than thirty days without the sanction of the government."

Law secretary and home secretary commissioner of Dhaka Metropolitan Police have been made respondents.

The HC bench of Justice Md Mozibur Rahman Miah and Justice Kazi Md Ejarul Haque Akondo issued the rule following a writ petition challenging the legality of the sections.

On October 20, Supreme Court lawyers Abdul Momen Chowdhury and KM Zabir, Chandpur court's lawyer Salim Akbar, and two residents of Dhaka Shah Nuruzzaman and Mohammad Yasin jointly submitted the petition as a public interest

In the petition, they say sections 29 and 105 of the Metropolitan Police Ordinance are against article 37 of the constitution regarding the

freedom of assembly.

According to section 105 of the ordinance, "No police officer shall be liable to any penalty or to payment of any damage on account of an act done in good faith in pursuance or intended pursuance of any duty imposed or any authority conferred on him by any provision of this ordnance or any other law for the time being in force or any rule, regulation, order or direction made or given there under."

Article 37 of the constitution says, Every citizen shall have the right to assemble and to participate in public meetings and processions peacefully and without arms, subject to any reasonable restrictions imposed by law in the interests of public order or

public health." Lawyer Abdul Momin Chowdhury argued for the petitioners, while Attorney General AM Amin Uddin Deputy Attorney General Arobinda Kumar Roy opposed the petition during its hearing last week.
