Help us pass 1971 genocide resolution Researchers urge Bangladeshi community in US

Genocide researchers and activists have called for the members of the Bangladeshi community across the US to engage with their legislators to have the genocide resolution on Bangladesh's Liberation War passed.

The call was made at a press conference organised by the Human Rights Congress for Bangladeshi Minorities (HRCBM) at the National Press Club in Washington DC on

Speakers discussed the importance and implications of the bipartisan House Resolution "H. Res.1430 Recognizing the Bangladesh Genocide of 1971" that was introduced before the US Congress by the Congressmen Steve Chabot and Ro Khanna on October 14.

SM Alam, consul general of Bangladesh in Florida, appreciated the Congressmen for introducing the resolution and requested the members of the Bangladeshi diaspora to engage with other legislators to support the

Columbia University lecturer and Genral Secretary (USA) of Bangladeshi Hindu Buddhist & Christian Unity Council, Dr Dwijen Bhattacharjya said introducing the resolution at the US Congress would encourage other nations to recognise the Bangladesh genocide of 1971.

In her opening remarks, HRCBM's executive director Priya Saha detailed how the Pakistani armed forces conducted one of the worst genocides in history over a period of nine months in 1971.

What good is Universal Salt Iodisation strategy?

20pc of children under five suffer from iodine deficiency, finds survey

Around 20 percent of the surveyed children aged under five years, suffer from iodine deficiency, finds the National Micronutrient Survey

This is the first-ever revelation on the country's iodine status, and it and non-pregnant and nonhas raised questions on the efficacy of the government's Universal Salt Iodisation strategy, said experts, urging to explore the reasons for deficiency.

The national representative second micronutrient survey also revealed that an alarming 70 percent of non-pregnant and nonlactating women have vitamin D deficiencies in addition to their deficiencies in other micronutrients in different percentages.

The survey was carried out by Bangladesh Bureau of Statistics in 250 upazilas from every district, to understand the status of vitamin A, Vitamin D, Zinc, Ferritin, Urinary Iodine and Anemia among children (5 to 59 months) and non-pregnant and non-lactating (NPNL) women of reproductive age (15-49 years).

The findings were shared at an event in Dhaka, organised by the National Nutrition Services (NNS) of the Institute of Public Health Nutrition (IPHN) under the health directorate, in partnership with International Centre for Diarrheal Disease and Research, Bangladesh.

The findings suggest that children under five years of age, lactating women in the country still significantly lack micronutrients.

Among the under-5 children, 31 percent had zinc deficiency, 20 percent had iodine deficiency, and 15 percent had iron deficiency.

In the case of vitamins, 22 percent had vitamin D deficiency, and 7 percent of children had moderate vitamin A deficiency.

Among the non-pregnant and non-lactating women, 43 percent had zinc deficiency, percent had iodine deficiency, 29 percent had folate deficiency, and 14 percent had iron deficiency.

Compared to findings from the 2011-12 survey, the micronutrient deficiency status among this group showed improvement in three indicators (vitamin A, zinc, iodine). It worsened in three indicators (serum iron, Folate). The status remained unchanged in case of vitamin B12.

Additionally, 21 percent of the surveyed children and 29 percent of the surveyed non-pregnant and non-lactating women had mild to

The metro rail authorities will sign an agreement with BRTC on Wednesday to provide shuttle bus services to metro rail passengers as the country's first metro rail service is going to be in operation partially from December, with 10 sets of trains.

State-run Bangladesh Road Transport Corporation (BRTC) will provide the services from both ends -- Uttara and Agargaon -- to some particular destinations, which will be amended later, said officials. DMTCL and BRTC will sign a contract on Wednesday
