Taylor Swift first artist to claim entire top 10 on Billboard 100 song chart

Student yet to get justice as probe drags on

policy adopted for educational institutions upon an HC directive, the committee concerned must submit a probe report within a maximum of 60 working days and must notify the authorities in seven working days if it fails to probe or the issue is not worth investigating.

The DU anti-sexual harassment cell seems to have breached that policy.

The victim further claimed she was mistreated whenever she went to speak to the head of the cell.

She said Zeenat Huda, the head of the cell, every time asked her questions such as: "Why did you submit the complaint directly to the vice-chancellor instead of the chairperson of the department? Which teacher made you do this? There was no CCTV at the place of the incident, how are we going to prove [the allegation]?"

The student added, "During one of these times, the teacher [Muhammad Sazzad Hossain Siddiqui] even sat near me, although I requested him to keep his distance. Even he questioned me along with the other members [of the cell]. When I tried to respond, they would stop me and call me 'rude'."

The student's father said, "We don't know what this probe committee wants. They are intentionally delaying the investigation. All we know is that 'justice delayed is justice denied'."

However, Muhammad Sazzad Hossain Siddiqui claimed he never told anyone that the student would not get justice after her studentship expires.

"The delay is bothering me as well. How long will I bear the burden of this false allegation? But I have nothing to do. As per the law, I have to comply with the authorities, or

there will be another issue."

Contacted, Prof Zeenat told the Daily Star, "I already know about the time limit ... The allegation is under investigation. I don't want to make any further comments as it is a very confidential issue."

Meanwhile, Dr Kaberi Gayen, professor and former chairperson of the mass communication and journalism department, said, "The victim has the right to justice ... The investigation should have been completed within the stipulated time in order to prevent further instances of sexual harassment."

DU VC Prof Md Akhtaruzzaman told The Daily Star, "It is expected that the probe committee will work independently according to ethics and the law. I will follow its activities and remind them [about the probe]. Further delay may arise complications."

government in 2007 and directed the lower court concerned to complete the trial proceedings as early as possible.

The chief metropolitan magistrate of Dhaka was asked to send the case record to the Dhaka Senior Metropolitan Sessions Judge's Court within 10 days of receiving the order.

Trial proceedings against Tarique's mother-in-law Syeda Iqbal Mand Banu were quashed.

On September 26, 2007, the anti-graft body filed the case with Kafrul Police Station against Tarique, his wife Zubaida and her mother Syeda Iqbal Mand Banu for amassing assets worth Tk 4.82 crore through illegal means and concealing the information of Tk 2.16 crore in their wealth statements.

The investigation officer of the case pressed charges against the three with the Chief Metropolitan Magistrate's Court, Dhaka, on March 31, 2009.

Earlier, Tarique was sentenced to life in jail in the August 21 grenade attack cases. He was also sentenced on different terms of punishment in two other cases, including the Zia Orphanage Trust graft case.

Qatar pays for fans'

sign a 'code of conduct', urging them to post favourable comments about the tournament on social media and to report "any offensive, degrading or abusive comments" by others to the SC, preferably with screenshots.

The broadcaster cited two Dutch fans who said they had been selected by the tournament's organisers as "Fan Leaders", and who added that they had been asked to pick a group of 50 loyal supporters for the free trip to Qatar.

"As the tournament nears, we have invited our most active fan leaders to personally nominate a small selection of fans to join us as our guests, as a manner of thanking them for their collaboration," a spokesperson for the SC told Reuters.

On its website, the Qatar World Cup describes its Fan Leaders program as a network of around 400 fans and influencers from 60 countries who have offered "insights, research, content creation and message amplification," for the tournament.

The organisers did not say how many fans they had invited, or provide any financial details.

have been deducted from their income."

CAB said the hiked tariffs include a two-step imposition of VAT and that goes against the interest of consumers, as defined by the law.

According to BERC's tariff order, there is a 15 percent VAT on LNG imports and another 15 percent VAT added at the consumer end.

The VAT at the import stage adds Tk 5.50 for every cubic metre of gas, while the VAT at the consumer end is 15 percent of the total cost of the gas consumed.

CAB said the VAT during import is factored into the total supply cost and passed on to the consumers, who then have to pay VAT on the first value added tax.

"This illegal imposition of VAT on the cost of gas supply has created an unreasonable increase in gas tariff at the consumer level which is also a clear violation of the provisions of [the law]," said the petition.

Energy Adviser to CAB Prof Shamsul Alam said the Tk 11,000 crore subsidy given to Petrobangla was being included in the total cost of supply and the consumers are paying tax on that.

The tariff order documents show that Shamsul had recommended the commission not to allow Petrobangla to do this and had that been done, gas would cost 16 paisa less every cubic metre.

Furthermore, CAB's petition stated, "The Gas Development Fund should have been used for exploration and development of local gas but Petrobangla has been using

the aforesaid fund for other purposes beyond the scope determined by the BERC."

CAB also petitioned that during 2019-20 and 2020-21, LNG was imported less than the quantity estimated by the BERC, and as a result Tk 14,933.1 crore was left in surplus.

It said the BERC increased the gas prices without adjusting for that surplus.

"Their misuse of the fund from the Gas Development Fund has largely contributed to an increase in the gas tariff, creating an additional financial burden on the consumers," said the petition.

Earlier, during a hearing organised on March 21, 2022, Petrobangla had countered some of these allegations made by CAB.

Meeting minutes of the hearing, included within the tariff order, show that Petrobangla's director of finance had said that the surplus from the years 2019-2021 were used up during the last fiscal year when it cost more to import LNG, and that there was no surplus because the government gave only partial subsidies.

He also said that consumers have to bear the brunt of source taxes because Petrobangla does not import with profit. He also said that VAT cannot be adjusted at the consumer level because the cost of importing LNG is more than the price at which the gas is provided to consumers.

The HC on Monday also stayed a committee formed by the BERC to decide on gas prices for consumer, after the CAB said that the committee contains members who have conflicts of interest.
