

80pc Rajshahi ponds filled up in 8 years: study

At least 80 percent of the city's ponds have been filled up in last eight years, finds a study by Bangladesh Environmental Lawyers Association (Bela) in Rajshahi.

Even more than 35 percent of government khas ponds have been filled both legally and illegally during that period, added the study.

Different government institutions, non government bodies and individuals were responsible for filling up the ponds, it said.

The findings were presented at a discussion held at a city hotel on Wednesday. The discussion on "Existential crisis of ponds and water bodies of Rajshahi city" was chaired by Prof Dipakendra Nath Das, president of Shacheton Nagorik Committee.

Tanmay Sanyal, coordinator of Bela's Rajshahi office, presented the study. Analysing government documents, the study said there were at least a thousand ponds in the city in 2014. Of these, less than 200 ponds exist now, many of which are in the process of filling.

The city had at least 48 khas ponds, of which 19 used to carry water for all year round till 2014. But 17 out of the 19 ponds were filled up in the eight years. Of the filled up ponds, nine were legally filled, and no government approval were found behind filling up of eight other khas ponds.

FROM PAGE 3 absconding for decades. Four days after his arrest, Majed was executed in a separate case centring Bangabandhu's murder, as he was convicted in it as well.

It is believed that all the convicts are hiding abroad, and the government could trace the whereabouts of only two -- Rashed Chowdhury, who is in the US, and Noor Chowdhury, who resides in Canada. Authorities have failed to bring them back due to legal tangles.

Asked about the matter, the law minister said the government has already taken legal steps and engaged with the US and Canadian governments to bring back the two.

The Daily Star contacted AHM Khairuzzaman Liton, son of AHM Quamruzzaman, one of the four leaders, for his thoughts.

Liton, currently a praesidium member of Awami League and mayor of Rajshahi City Corporation, said the killers selected only the four national leaders among many other prisoners and killed them to completely ruin the country's independence.

He, however, believes that the killers could not damage the spirit of the Liberation War and independence, as Prime Minister Sheikh Hasina-led Awami League implemented the dreams of independence.

CASE BACKGROUND

A day after the jail killing, Kazi Abdul Awal, then deputy inspector general (prisons), filed an FIR with Lalbagh Police Station.

ABM Fazlul Karim, then OC of the station, was tasked with the investigation.

But the infamous Indemnity Ordinance blocked the investigation and trial for about 21 years, until officers of the Criminal Investigation Department (CID) reopened the probe on August 18, 1996.

In 2004, a trial court handed punishments to 11 perpetrators including Abdul Majed for the killings.

The Appellate Division of the Supreme Court on April 30, 2013 upheld the court's verdict.

The three convicts who were handed capital punishment are Muslemuddin, Marfat Ali Shah and Abdul Hashem Mridha.

The eight jailed for life are Khondaker Abdur Rashid, Shariful Haq Dalim, Noor Chowdhury, Rashed Chowdhury, Ahmed Shariful Hossain, Abdul Majed, Kismat Hasem and Nazmul Hossain.

Four other accused -- Syed Farooq ur Rahman, Sultan Shahrar Rashid Khan, Bazul Huda and AKM Mohiuddin Ahmed -- were executed in the Bangabandhu murder case in 2010.

FROM PAGE 3 He also said the polishing of rice requires additional expenditure for additional power and labour.

"The rice price automatically increases by Tk 3-4 per kilogramme, but those do not contain nutrient [properly]," the minister said.

He also explained that rice fortification will not be any uniform solution to fight against malnutrition. Fortified rice contains vitamin A, B1, B2, folic acid, iron, and zinc.

Starting from 2013, distribution of fortified rice has so far been expanded to reach more than 14 million beneficiaries in 320+ sub-districts under two major safety net programmes of the government.

During the panel discussion followed by the keynote presentation, Dr Tahmeed Ahmed, executive director of the icddr, stressed adopting other methods to fight micronutrient deficiencies including biofortification and improving crops diversification.

Dom Scalpelli, resident representative and country director of the World Food Programme (WFP), said, "Using rice as a medium presents a great opportunity to reduce micronutrient deficiencies in countries like Bangladesh where rice is a staple. It is also the most viable option in situations of limited resources, such as these times of global inflation and economic crisis."

Earlier, five other Biman employees were arrested.

Nine of the arrestees have already confessed to their involvement before courts, Dhaka Metropolitan Police (DMP) Additional Commissioner (DB) Harun Or Rashid told a media briefing at the DMP's media centre yesterday.

Biman was supposed to hold recruitment examinations for 12 posts on October 21. But after authorities of the airline got to know about the leak, they cancelled the test.

Contacted, Biman Managing Director and CEO Md Zahid Hossain said they have already sacked 10 employees after they were arrested.

He said the post of Biman's director (admin) is now vacant, so the official's room was used to copy the papers.
