

HIMU MURDER

HC confirms death for 3

The High Court yesterday confirmed the death sentence of three convicts and acquitted two others in the case filed for killing A-level student Himadri Majumder Himu in Chattogram in 2012.

On April 27, 2012, Himu, a student of Summerfield School and College in Chattogram, was taken forcibly to the rooftop of a four-storey building in Panchlaish Residential Area.

He was severely beaten there and at one stage, the convicts unleashed three dogs upon him.

Later, he was pushed off the building, according to the case documents.

While undergoing treatment at Chattogram Medical College Hospital (CMCH), the victim described how he was tortured.

Himu breathed his last at the Square Hospitals in the capital on May 23, 2012.

Yesterday, the HC upheld the death sentence of Jahedul Islam Shaon, Mahboob Ali Khan Danny and Junaid Ahmed Riad in the case.

The two acquitted accused are Shah Selim Tipu and Md Shahadat Hossain Saju.

The HC bench of Justice Bhishmadev Chakraborty and Justice Khandaker Diluruzzaman delivered the verdict.

Details of the grounds on which the HC delivered the judgement could not be known as its full text was not released yet.

Danny, Tipu and Saju are now in the jail, while Shaon and Riad are on the run.

'This is a fight to save our land'

Civil-society members protest Mongla Port authorities' decision to dump sand on farmland in Banishanta

Mongla Port authorities have declared war against the people of Banishanta union in Khulna's Dacope upazila, as they are adamant to dump sand on cropland despite objection from locals, said civil-society leaders.

As part of their dredging works in Pashur river, the port authorities want to pile up 2.16 crore cubic metres of sand on 300 acres of cropland in Banishanta, adjacent to the river, which could put the livelihood of 5,000 farmers in danger, they said.

They raised the issue at a rally organised at Banishanta on Tuesday.

Syeda Rizwana Hasan, chief executive of Bangladesh

Environment Lawyers Association (Bela), said the port authorities were not paying any heed to finding alternative sites for dumping sand, as suggested by locals and civil-society members.

"Thus, they declared war against Banishanta people by rejecting the plea to save their cropland. The authorities are saying farmers can produce crops only once a year, which is completely false. They have been producing crops there three times a year," she said.

Rizwana urged the government to form a committee consisting of representatives from the agriculture ministry to verify the claim of port authorities.

Khushi Kabir, coordinator of Nijera Kori, said, "Whenever we try to contact the port authorities to

inform our concern, they can't even manage time to listen to us. That proves they don't have any answer to our question."

She also urged farmers to resist the port authorities' move, as this movement is for protecting the country's arable land. "Protect your cropland; lie down on your land when they come to dump sand," she said.

Robaet Ferdous, professor of mass communication and journalism at Dhaka University, said at a time when the prime minister is forecasting a famine and urging people not to leave an inch of land uncultivated, the port authorities are hell-bent on destroying cropland.

minister said people who were behind the murder of Bangabandhu Sheikh Mujibur Rahman committed the jail killing.

"Four national leaders were killed in the central jail, which is a protected place. The killers of Father of the Nation, including Zia and Mostaque, committed these killings," she said at a discussion on the Jail Killing Day in parliament.

Ziaur Rahman killed military officers who fought in the Liberation War and brought anti-liberation forces back to power, she added.

"They wanted to spoil our victory [achieved following the Liberation War] completely and distort history," she said.

Hasina said Ziaur Rahman patronised and rewarded the killers and awarded them jobs in the foreign missions.

HM Ershad allowed Bangabandhu's killer Col Faruk in politics and made him a candidate for the president post.

Criticising Barrister

Mainul Hosen, the premier said he too formed a political party with the killers.

Pointing at the BNP, she said those who came to power illegally couldn't ensure democracy and protect human rights. **MEETING ON OVERALL ECONOMIC SITUATION** The prime minister will hold a meeting regarding the review of the overall economic situation and relevant issues of the country on Sunday, reported our staff correspondent.

With the participation of Hasina, the meeting will be held at the Chameli Hall of the Prime Minister's Office at 9:00am, PMO's Press Wing said in a Facebook post.

Meanwhile, Bangladesh Awami League will hold a programme titled "Cries of Arson Terrorism: BNP-Jamaat Arson Terrorism, Anarchy and Human Rights Violation" in the capital on the same day.

Hasina will attend the programme virtually from the Gono Bhaban.

Imran survives attempt on life

"I heard a burst of bullet shots after which I saw Imran Khan and his aides fall down on the truck," witness Qazafi Butt told Reuters.

"Later, a gunman shot a single shot but was grabbed by an activist of Khan's party."

In purported footage of the shooting, being run by multiple channels but unverified by Reuters, a man with a handgun is grabbed from behind by one of the people at the gathering. He then tries to flee.

TV channels showed a suspected shooter, who

looked to be in his twenties or thirties. He said he wanted to kill Khan and had acted alone.

"He (Khan) was misleading the people, and I couldn't bear it," the suspect said in the video. The information minister confirmed the footage was recorded by police.

No one had yet been charged with the attack.

Khan - who was after his removal from office convicted by Pakistan's election commission of selling state gifts unlawfully, charges that he denied - had been whipping up large crowds on his way to


Islamabad in a campaign to topple the government of rival Shehbaz Sharif.

Sharif condemned the shooting and ordered an immediate investigation.

One member of Khan's party said there were reports one person had been killed in the attack.

Khan aide Chaudhry wrote on Twitter: "It was a well planned assassination attempt on Imran Khan, the assassin planned to kill Imran Khan and leadership of PTI, it was not 9 MM it was burst from automatic weapon... It was narrow escape."
