The title track sung in the sheer might of Cryptic Fate vocalist Shakib Chowdhury and Oyshee, folk 'queen' Momotaz Begum displaying her versatility in the playful Ghur Ghur Poka, Pritom Hasan switching up his style in Ami Durjoy and the period-fitting romantic track Mon Posh Mane Na by Imran Mahmudul and Kona, added to the unsurpassable Rezwana Chowdhury Bannya with her Rabindra Sangeet – all complement the film like a finesse shot lobbed over the head of three defenders like Leo

Messi himself.

The promotional title track that Shakib Chowdhury and Oyshee voiced is to remain one of the only tracks that were built entirely to create hype. "When we listen to songs like 'Cholo Bangladesh', we are infused with patriotic energy. This is why I wanted Shakib bhai to sing this one as well," says the music director, also adding that the team was inspired by Kazi Nazrul Islam's rebellious poetry as well, for the concept of this title track.

"Not just the title song, but in every song, the singers sang out of their own comfort zone, be it Momotaz apa or Pritom," says Nidhi. "Not only that, the entire musical crew were more than accommodating when it came to the promotions as well."

"When the film's opening credits rolled and 7 singers were named, I feel like this was a milestone in our music industry."

Moreover, 160 people and an entire unit were present to shoot the music video, which is nearly unprecedented in Dhallywood.

Although only time will tell if "Damal" will live up to Raihan Rafi's previous superhit, "Poran" and Mejbaur Rahman Sumon's "Hawa", two films still running in halls after months of its release, it is evident that the soundtrack fires on all cylinders.

Anwar Hossain, a resident of Bhola town, said, "I need to get my ailing wife admitted to a hospital in Barishal city. But launches are not operating. Now we are compelled to travel by a speedboat spending additional money.

Many BNP leaders and activists from remote areas in nearby districts have reached Barishal city to join tomorrow's rally. They are staying at hotels and relatives' houses.

Several thousand already gathered at Bangabandhu Udyan, the meeting venue, till last evening.

"As transport strikes will begin tomorrow [today], we have come to the rally venue two days ahead. We will stay at the ground till the meeting ends," said Keramot Ali, a BNP activist from Paschim Muguria village in Barishal's Gournadi upazila.

Some party men alleged that they were intercepted and attacked by AI men on their way to Barishal city.

"Awami League men intercepted us at different places, including Fourlane and Rojopara areas along the Barishal-Patuakhali highway. They even snatched moneybags and mobile phones from some of our fellow party activists," alleged Md Salauddin, a BNP worker from Kalapara of Patuakhali.

BNP Organising Secretary Bilkis Jahan Shirin alleged that a group of AL men attacked BNP activists at Bheduria launch terminal of Bhola, leaving one injured by bullets.

Bhola Model Police Station OC Shaheen Fakir said, "Awami League men scuffled with BNP activists at Bheduria launch terminal. No incident of firing took place there. We are investigating the incident."

Corrupt people plunging country

Lawyer Abdul Kaiyum appeared for the writ petitioners, while lawyers Shamim Khaled Ahmed and Khurshid Alam Khan and DAG Amin Uddin represented the BFIU, ACC and state respectively during the hearing.

On April 7, the HC bench led by Justice Md Nazrul Islam Talukder directed the BFIU to conduct a probe into the allegations of embezzlement and laundering of the money by the e-commerce platform.
