When photographs speak against dictatorship

Dinu Alam's historic photos, now free-for-all

Yesterday, photographer Dinu Alam-who is currently based in Toronto, Canada—hosted a press conference at the National Press Club in Paltan. The conference was held to announce that photographs taken by him during the anti-Ershad mass movement of 1987, would be free-to-use for the public.

Dinu Alam's photographs represent a crucial part of Bangladesh's 50-year history. Particularly, his photo of Shaheed Noor Hossain, who died during the protests on November 10, 1987, are remembered for their impact on dethroning Ershad. Even today, this iconic photo is called the 'photo that brought down a dictator'.

In 1987, Noor Hossain—a young protester, whose body was painted with pro-democracy slogans—was shot dead by the police in Dhaka. His massacred, bullet-ridden body was taken to a jail cell, and dumped by the police there. It would be a photograph taken by Dimu Alam of the incident, that really added steam to the mass uprising, toppling Ershad from his

While the anti-Ershad mass movement was at its height, the opposition parties implemented a "Dhaka blockade" plan. Dinu Alam documented the struggle against the regime at the time with his photographs. Among the collection of his photos from the time, are three close-ups of Noor Hossain's face, taken ten minutes before he was shot near 'Zero Point', now called Noor Hossain

An iconic photo, Noor Hossain's body is

painted with the words 'Let dictatorship die', as he stands directly in front of the procession of the current Prime Minister Sheikh Hasina.

Today, at the press conference, Dinu Alam discussed three investigative pieces about Noor Hussain that were written by BBC News London. On the morning of November 10, 2020, two years prior, journalist Moazzem Hossain from BBC London called Alam in Toronto and informed him that he is conducting research for an investigative story based on the events of November 10, 1987, and the death of Shaheed

Moazzem Hossain—a Dhaka University student-was detained that morning, and kept in the same cell as Noor Hossain, at the Shahbag police station. Three investigative stories from the BBC were released back-toback, one of which was translated into 10 different languages. Several of the pictures Alam took that day, paired with that incident, featured in the BBC article.

Alam discussed the mass uprising and his this exact information.

photographs from November 10, 1987, the former asked for permission to use Alam's photos in the BBC articles. Recalling this incident, Alam said at the press conference, "I gladly granted formal consent to journalist Moazzem Hossain to broadcast my photos on BBC News. However, I was moved by the thought that, what purpose does it serve to ask someone for permission to post old photographs?"

Alam further added, "In light of tomorrow being Shaheed Noor Hussain Day, I want to inform all of you that my photos from back then will be free-to-use for everyone. Under the terms of the Share-Alike International Free-to-Use license, these photos of mine will now be accessible to the general public on Flickr.com and Wikimedia Commons. The photos can be used without paying any royalties.'

Ramp up efforts to stop human trafficking Murder accused

the government has for taken various steps to promote safe migration and prevent human trafficking. Yet, the risks of human trafficking remain high.

About 12 million Bangladeshis work abroad and the remittance they send plays a critical role in the country's economy. Besides, climate change causes the displacement of thousands of people, making women and children especially vulnerable to exploitation.

Siobhan Mullally said significant measures have been taken to combat child labour, which can lead to increased risks of child trafficking.

"Therefore, continued development of exit strategies to eliminate child labour, in particular in high-risk sectors like hospitality and tourism, domestic work, brick kilns, and agriculture, is essential.

"Improving livelihoods for families, and expanding access to education, and training opportunities for children will be important.'

Trafficking of women and girls persist. purposes oi sexuai exploitation within Bangladesh and cross-border, in particular to India, is a serious and urgent concern. Boys are also trafficked within Bangladesh, but receive limited assistance or protection from the state, and are often at risk of both sexual exploitation and exploitation in criminal activities, she said.

She said failures of identification and protection allow such trafficking to continue with impunity.

"More efforts to combat child trafficking are essential, including improving rates of birth registration for all communities and ending child marriage. We know that the children of sex workers are at great risk, and are often not registered at birth," Mullally

She said there are serious concerns that trafficking for purposes of forced labour persists. False job offers, very high recruitment fees and failure to protect migrant workers in all stages of migration allow trafficking to actions, she said.

Returned migrant workers with significant debt are at continued risk of exploitation and face reprisals and threats because of difficulties in repaying debts and securing new employment."

Pressures to settle complaints and accept low rates of the settlement also undermine the goal of accountability recruitment agencies intermediaries, the expert said.

While countries of destination have a responsibility to prevent trafficking and protect migrant workers, Bangladesh, as a country of origin, must also strengthen its action to prevent such recruitment practices and to remedy the gaps in protection, Mullally said.

Migrant women domestic workers are particularly at risk of trafficking for domestic servitude and suffer horrific abuses. This is an area that the international community has been neglecting, but needs stronger

Govt bans foreign

But this time, the government has said it will not provide them any funds for travelling purposes.

The notice said the decision was taken given the ongoing state of the global economy.

The government widened the restrictions on travels as the country's foreign exchange reserves have been depleting fast.

The reserves stood at around \$34.5 billion yesterday, which were \$46.48 billion in November last year.

The decreasing trend of both remittance inflow and export earnings against higher import payments has created a volatile situation in the country's financial sector.

The expatriate Bangladeshis sent home to the tune of \$1.52 billion in October, down 7.4 percent from a

Remittances also decreased by 2.03 percent year-on-year to \$7.19 billion in the first four months of the current fiscal year, as per data from Bangladesh Bank. Export earnings of October also

declined by 7.85 percent year-onyear to \$4.35 billion, according to the Export Promotion Bureau data.

Between July and October this fiscal year, export earnings, however, increased by 7.01 percent year-onyear to \$16.85 billion.

The central bank has not yet published the data of import payments for October.

by Mridha was based on fabricated information. It was designed to "harass and defame" his client.

JP Secretary General Mujibul Hague Chunnu told the media that such a bar on a political party chief 'cannot be valid"

"There is no such precedence. We have appealed to the court seeking revocation of its order. We hope the order will be cancelled. Otherwise, we will move the High Court," he added.

Meanwhile, Joint District Judge Masudul Haque on Tuesday served a show-cause notice to Quader in another case filed with the same Dhaka court. Opposition Chief Whip Mashiur

Rahman Ranga, who was removed from the JP on September 14, filed the case on October 28. In this case, the JP chief was asked

to explain in 15 days why he would not be barred from taking decisions about the party. Court sources said Ouader has

sought time to give his explanations. The court will hold next hearing on the case on January 2 next year.

Both Mridha and Ranga filed separate cases seeking court orders announcing Quader's holding of the

JP chairman post illegal. Quader was made the party chairman on April 6, 2019, after its founder and former president HM

Ershad fell sick. Angered by the JP chief's recent sharp criticism of the government, AL high-ups are allegedly backing Raushan Ershad to put pressure on

Raushan, the chief patron of the party, all of a sudden, on August 31 convened its 10th national council on November 26.

Sources at the JP told The Daily Star that pro-Raushan group planned to remove Quader from the party's helm in the council and take control

of the organisation. Conflict between the two factions intensified as the Jatiya Party Parliamentary Party on September 1 decided to remove Raushan from the post of the leader of the opposition

in parliament and make Quader the opposition leader. The JP chief is now the deputy

leader of the opposition. After that meeting, a letter signed by Ranga was submitted to the

Speaker in this regard. The JP lawmaker on September 20 again wrote to the Speaker saying that

he would withdraw the previous letter. The opposition party now has 26 lawmakers. All but three to four of

them are reportedly loyal to Quader. Speaker Shirin Chaudhury is yet to announce any decision on making Quader the leader of the opposition.

Meantime, JP leaders on October 30 decided to boycott the ongoing parliament session until Quader is made the opposition leader.

A day after, the JP backtracked on its decision saying it received an assurance from the Speaker in this regard.

Sources close to Raushan said the government high-ups changed their stance due to Quader-led faction's decision on boycotting parliament.

Raushan later postponed the Feud between Raushan and Quader broke out over taking the

helm of the party after HM Ershad became sick in early 2019. The conflict worsened following

the death of Ershad in July that year.

50 lakh was transacted by Jama'atul Ansar using mobile banking services, said the officer. Law enforcers said the outfit's Ameer Anisur developed a good relationship with Nathan Bom, who is the chief of CHT Kuki-Chin National

Front (KNF), an armed group of the

Chattogram Hill Tracts. Nathan was

a good friend of the militant's outfit's

adviser Shamin Mahfuz. Both of them were Dhaka University students. The Daily Star could not

independently verify these claims. KNF and the militants made a three-year deal at the beginning in operating firearms and making of last year. The former agreed to

that the money would be spent either provide shelter, training on firearms and explosives and other support to the militants in exchange of Tk 3 lakh a month.

Rab also had information that the

militants gave Tk 17 lakh to KNF to buy weapons. Rab came to know that the militants purchased an AK-22 and an AK-32 rifle to train the young
