

Headmaster, teacher, clerk -- all in one

Lone teacher struggling at school with 120 students

In Char Kajal union of Patuakhali stands Uttar Chhota Char Kajal Government Primary School. This is the only school in this remote area, where some 120 students are currently enrolled.

However, only one teacher is posted at the institution, meaning academic activities at this place is irregular, hampering the studying of these village children.

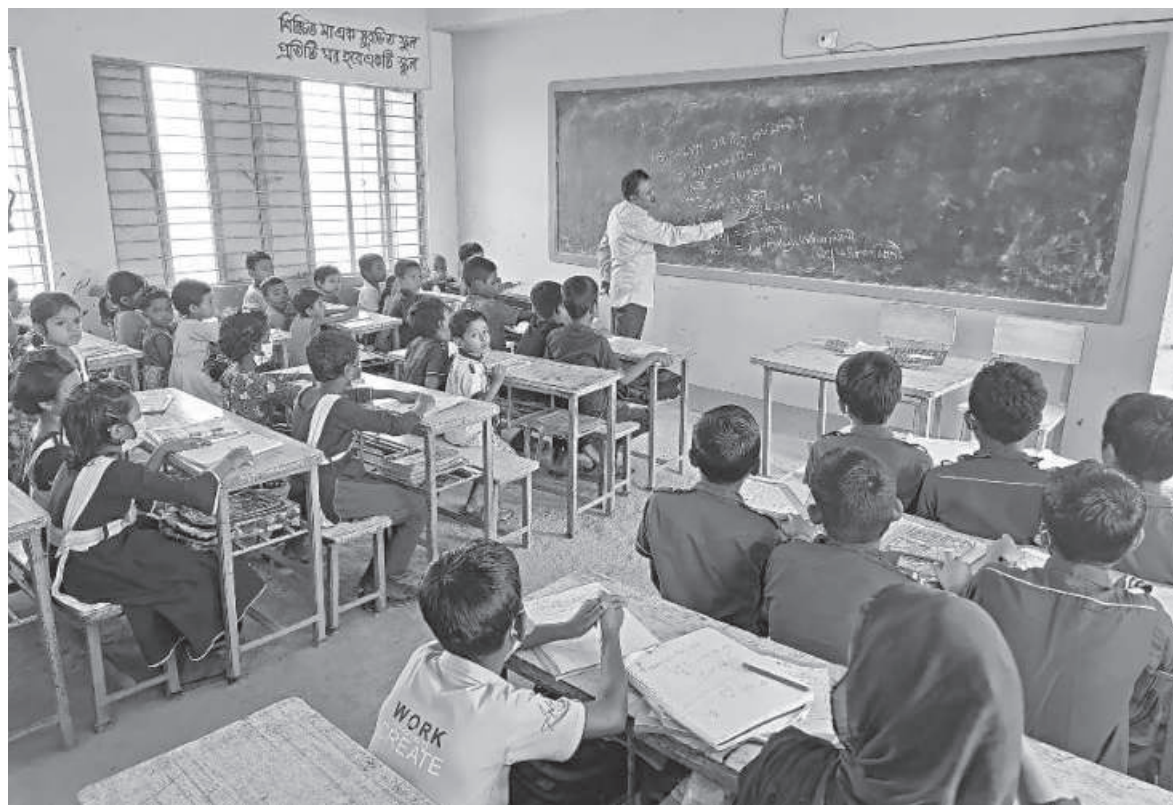
Indrajeet Sheel, the only teacher of the school, has to play the role of headmaster and clerk all by himself, while taking classes on various subjects.

Visiting the school, it was seen that the teacher provides lessons for some 40 students of pre-primary, first, second and third grade simultaneously in the morning shift, and teaches some 80 students in third, fourth and fifth shift at a time in the afternoon.

Mihad Khalifa, a first grader, said students of several classes are placed together in a single room often, which makes it difficult for them to understand the lessons.

Other students echoed the same.

MONEY LAUNDERING 2 former NSU trustees get conditional bail

The High Court yesterday granted conditional bail to two former members of North South University's (NSU) trustee board -- MA Kashem and Rehana Rahman -- in a Tk 304 crore money laundering case.

According to the conditions, accused Kashem and Rehana cannot enter the NSU premises or leave the country without permission from the court concerned.

The HC bench of Justice SM Kuddus Zaman and Justice Fahmida Quader granted them bail after holding hearing on two bail petitions filed by Kashem and Rehana.

They will get released from Kashimpur jail if the Appellate Division does not stay the HC verdict that granted bail to them, said their lawyer Sayeed Ahmed Raza.

He said the HC granted bail to his clients considering their old age, anomalies in the FIR and lack of sufficient evidence against them in the probe report. On August 2, another HC bench refused to grant bail to Kashem and Rehana but issued two rules asking the state and the ACC to explain why they should not be granted bail.
