Uniforms, not plainclothes Ain o Salish Kendra urges law enforcers

Law enforcement agencies must adhere to the law detaining and interrogating people, said rights organisation Ain o Salish Kendra (ASK).

"During recent times, there have been news law enforcement agencies allegedly picking up different people in plainclothes," said the organisation in a statement yesterday.

News reports pointed out that several days after claims of being picked up surface, the people are being shown arrested under different kinds of Authorities allegations. say that the ones picked up were kept in custody for interrogation, said the statement.

"There are that in many of these cases, there have been violations of, and deviations from the law, constitution and the directives of the High Court," said the statement.

Mentionable, arresting any individual, law enforcement agencies must wear their uniform, provide their identity, show a warrant, must produce the arrestee in front of a magistrate and alert the family and legal representative, said the SEE PAGE 4 COL 5

Winter sees more children suffering from **PNEUMONIA**

With winter's arrival, physicians have urged parents to stay extra cautious to keep their children safe from pneumonia.

They advised the parents to ensure proper and timely treatment if their children get infected with the disease to avoid fatalities.

At Dhaka Medical College Hospital, the number of children suffering from pneumonia have already started rising.

"We've been receiving some eight to 10 childhood pneumonia patients every day recently. It will continue rising, as November and December is the peak season for pneumonia cases in our country," Prof Iffat Ara Shamsad, head of the paediatric department at DMCH.

Pneumonia, which is caused by bacteria, viruses or fungi, leaves children to fight for their lives, as their lungs fill with pus and fluid caused by the disease.

"Falling sick with cold and cough sees a rise in inter But there are differences between normal flu and pneumonia. We have to be extra cautious for children, especially those under the age of five," said

As pneumonia is an infection of the lungs, its most common symptoms are coughing, trouble breathing and fever, she said.

"Children with pneumonia usually experience fast breathing, or their lower chest may draw in or retract when they inhale. In case of normal cough or fever, there's no breathing issue."

If parents observe pneumonia symptoms among their children, they should visit a doctor or hospital immediately, she suggested. Pneumonia is still the main cause of deaths for

children under five in Bangladesh. But if intervened timely, pneumonia can be cured, according to the

- Children under 5 most vulnerable to pneumonia
- Bacteria, viruses, fungi common causes for

- Over 24,000 children die of pneumonia in country per year
- Most deaths prevented with vaccines, low-cost

Surveys have found that parents often take their children to the hospital at the last moment, especially when they need critical interventions like oxygen

As a result, more than 24,000 children still die of pneumonia in the country every year, which is around 18 percent of all child deaths under the age of five.

Most pneumonia deaths can be prevented with vaccines, and easily treated with low-cost antibiotics. But a small percentage of one-year-olds in Bangladesh still remain unvaccinated for viral pneumonia, and more than half of children suffering from pneumonia symptoms cannot avail effective medical treatment.

Prisoners must get proper treatment: HC

The High Court yesterday said prisoners across the country must be provided with proper treatment if they feel sick, as they have the legal right to medical treatment.

"Prisoners are usually kept detained in jails. It is not acceptable if they are not provided with proper treatment in times of sickness," the HC bench of Justice KM Kamrul Kader and Justice Mohammad Ali said during hearing a writ petition filed by Supreme Court lawyer Md JR Khan Robin on February 18, 2019, seeking necessary directives on this issue.

The bench also asked the government bodies concerned to appoint doctors on deputation to vacant posts at the prisons and submit a report after by December 11.

Petitioner JR Khan Robin told The Daily Star that there are reportedly only four doctors in 68 prisons across the country, where around 87,000 prisoners currently stay detained.

A total of 137 posts of doctors in the prisons reportedly are vacant, he added. Attorney

CEPA can boost Bangladesh-India trade, investment

Says Indian high commissioner

Indian High Commissioner to Bangladesh Pranay Verma at a session said the Comprehensive Economic Partnership Agreement (CEPA) has the potential to enhance bilateral trade and investment between Bangladesh and India.

Both countries have agreed to negotiate the details of CEPA.

The high commissioner said the agreement will facilitate a new institutional framework and supply chain links.

Prime Minister Sheikh Hasina and her Indian counterpart Narendra Modi directed trade officials on both sides to complete the CEPA negotiations soon and in time for Bangladesh's graduation from LDC status.

Prime Minister Sheikh Hasina will inaugurate the conference virtually at 10:00am on Thursday. Hajj Agencies Association of Bangladesh (HAAB)

President M Shahadat Hossain Taslim disclosed

this information at a press conference in a city hotel

Home Minister Asaduzzaman Khan Kamal; State Minister for Religious Affairs Faridul Haque Khan; State Minister for Civil Aviation M Mahbub Ali; and Ambassador of Saudi Arabia to Bangladesh, among others, will also remain present at the inaugural

ceremony of the conference. Addressing the press conference, the HAAB president said Bangladesh is the 4th largest pilgrimsending country in the world. The country also sends the highest number of pilgrims who perform hajj under private hajj management.
