“Bangladesh is a country which is facing significant problems in terms of climate change. You have climate refugees. This is why the country needs to have a wide vision of development,” he said.  
Predicting Bangladesh as a potential global player, he said, “Bangladesh is a country with a fantastic potential to be one of the crucial global players. But this depends on you and your leadership and that of the society, which you

are going to create in the future.”  
“Investment in the right fields can make it happen,” he added.  
Mentioning the unpredictability of the world, Boris said the earth is in danger because of the climate crisis.  
At the plenary session on “The Integration Agenda: A Roadmap Towards SDGs”, Debapriya Bhattacharya, distinguished fellow of Centre for Policy Dialogue (CPD), emphasised the youth’s potential, who

make up one-third of the South Asian population.  
He said the partnership usually talked about is between the North and the South.  
“However, SDG (Sustainable Development Goal) really allows for, rather promotes South-South cooperation,” said Debapriya.  
Zillur Rahman, executive director of CGS, moderated the inaugural session, while Manjur A Chowdhury, chairman of CGS, chaired the session.

## A step forward for Ctg

City Corporation (CCC) Mayor Rezaul Karim Chowdhury told The Daily Star yesterday that CCC previously conducted a preliminary feasibility study on setting up the metro rail in Chattogram.  
“Based on that study, we sent a proposal to the relevant ministry a few months after I assumed office in January 2021,” he said.  
Mentioning the ever-increasing pressure on the port city’s transport system with the expansion of industrial and business activities, the mayor hoped that the city dwellers will be benefitted from the service.  
With the beginning of the feasibility study, the implementation of the metro rail service in Chattogram will take another step forward, he added.  
Apart from the study, the project also plans on preparing a long-term, comprehensive transport master-plan as well as an environment-friendly metro system to reduce traffic congestion in the city and its adjacent areas, according to a document prepared by the planning ministry.

The project also aims to enhance the organisational traffic-management capacity of Dhaka Transport Coordination Authority (DTCA), Chattogram City Corporation (CCC), Chattogram Development Authority (CDA) and Chattogram Port Authority (CPA).  
According to the ministry document, Chattogram – a city with a population of around 40 lakh – is experiencing a gradual expansion of industrial and business activities and an increase in population.  
These issues are taking an enormous toll on the city’s transport system, resulting in acute traffic congestion, road accidents and air pollution.  
It is mentionable that CDA in 1995 conducted a study on a long-term development strategy for traffic and transport in Chattogram.  
Though different organisations separately took different initiatives for the development of the city’s transport system, the projects failed to mitigate public suffering due to the lack of a coordinated transport plan, stated the ministry document.

Pointing out that ACC can only investigate one out of 27 predicated offences relating to money laundering, he said most of the money laundering offences took place under the guise of share-market business and document forgery, and are related to taxes.  
The commission’s analysis shows that money laundering took place centring tax-related services, share-market businesses and documents forgery. However, the ACC is not mandated by the Money Laundering Prevention Rules (2012) under the Money Laundering Act to carry out investigations on these matters.  
According to the rules, the ACC is given the sole responsibility to investigate money laundering offences related to graft and bribery, while NBR and Bangladesh Securities and Exchange Commission can probe crimes related to tax and capital markets, respectively.  
Replying to a question, Jahurul said they cannot launch investigations on many corruption allegations due to the lack of proper evidence.  
“I seek the media’s help to provide detailed information on


corruption,” he said.  
Asked, ACC Commissioner Mozammel Haque Khan said a person can be implicated in several corruption allegations. “One can be innocent in one case but be involved in other cases. Now, if we make public the details of the cases in which the person is innocent, they take its benefit to be discharged of other cases,” he observed.  
At the meeting, suggestions were made to raise campaigns against lawyers who fought for the offenders, but the ACC commissioner said it is not practically possible.  
“A lawyer fights for a person on the grounds that his client is innocent. The campaign may deprive an innocent person of justice,” he added.  
The ACC was formed through an act promulgated on February 23, 2004, after the abolishment of the Bureau of Anti-Corruption.
