The BNP leader said the government could not stop BNP's seven divisional rallies despite using everything at their disposal to erect various obstacles, as "the people have now woken up".

He alleged that the government has been recycling the old game of filing false cases against opposition leaders and activists to subdue them.

### GOVT THE "BRUTE"

Referring to the killing of Nayan Miah in police firing, he said the government has claimed the lives of seven youths in the current movement for the restoration of democracy and voting rights of people.

"They [AL] have been playing the most brutal

role in the history of the country," the BNP leader observed.

Slamming Awami League General Secretary Obaidul Quader for his comment that the Bancharampur incident was "arranged" or somehow not genuine, Fakhrul said, "How inhuman and cruel can they become that they can't even express a little sorrow?"

He said it is Awami League which has been staying in power by force through stage-managed polls. "You don't have legitimacy. If the constitution of Bangladesh is true, you are not genuine (regime) as you're not elected one. You stuffed ballot boxes at night what now the foreigners are also saying."

Barrister Jyotirmoy Barua said people involved in the judicial process should be taken under training and awareness programmes by mental-health experts.

Ainun Nahar Siddiqua, a panel lawyer of BLAST, said mental health should be taken into account in all cases, especially in the trial of women victims of domestic and other forms of violence.

The participants also demanded increasing budget allocation in the field of mental health, speeding up the implementation of the Mental Health Act, and formulating the rules related to this act.

The discussion was chaired by Supreme Court lawyer and member of BLAST board of trustees ZI Khan Panna.

and district Sadar upazilas will come under the central lottery.

Non-government schools in Dhaka will not be a part of the central lottery. However, they will also need to hold lotteries through committees approved by the education ministry, said Mohammad Belal Hossain, director of DSHE.

He added that non-government schools in others areas will also need to hold a lottery with approval from district admission committees.

"Lottery has been arranged centrally in the schools where the competition is high. The rest of the schools will be gradually brought under the central lottery. If any school does not hold a lottery, action will be taken against them," Belal said.

According to Bangladesh Bureau of Educational Information and Statistics, there are 18,874 secondary schools in the country. Of them, 621 are government run.

The online application process for admissions to all government and non-government secondary schools for the upcoming academic session started on November 16.

The deadline for the submission of forms is 5:00pm on December 6.

Applications for both government and non-government schools will have to be submitted on the website "gsa.teletalk.com.bd".

political situation in Myanmar stand in the way, he said.

"We believe early resolution to the Rohingya crisis through their dignified return... is an essential element for realising the full potential of inter-regional trade and connectivity," he added.

Mustafizur Rahman, fellow of Centre for Policy Dialogue, moderated the session.

Sanjay Kumar Bhardwaj, professor of South Asian studies at Jawaharlal Nehru University, said India has understood that economic prosperity can't be achieved alone. Neighbouring countries must be connected and develop together.

"Bangladesh and India have a complex inter-dependency, which is forcing both countries to think together, apart from shared historic and cultural ties," he said.

observing programmes, like bringing out processions and holding rallies, across the country in support of the abstention.

Bangladesh Water Transport Workers Federation, a platform of eight workers' organisations, has already expressed support for the programme.

Md Shah Alam, the federation's president, said after a movement, the government fixed the minimum wage at Tk 7,500 in 2016 for a five-year period. The wage was supposed to be raised in June last year.

Since then, the federation leaders have been raising their voice for a pay hike, but the government and watercraft owners did not pay heed, he said.

"As the workers were planning to start a movement for a pay hike in mid-September this year, we halted it on request of the director general of Department of Labour, who offered to talk about the demand," he mentioned.

The Department of Labour sat with the federation leaders on September 21 and met watercraft owners' leaders on October 13. In the latest meeting, participants decided to form a

committee comprising a representative of all stakeholders within October 20 to fix new wages, said the leader.

Since nothing has been done till that date, the workers are unwilling to wait more and want to wage a tough movement, he said.

Alam said as prices of all commodities are rising, the wages need to rise too.

Meanwhile, business leaders expressed concern over the work abstention since it would hurt the already volatile commodity market.

Mahbubul Alam, president of Chittagong Chamber of Commerce and Industry, said it is illogical to call a strike for the most important logistics sector of the country, when the whole world's economy is volatile.

If the supply chain is slightly disrupted, the commodity market would become unstable, which would ultimately bring sufferings to consumers, he said.

Mentioning that importers and traders are already struggling amidst the volatile situation, the Mahbubul said the workers should not hold everyone hostage.

He urged the government to take initiative to avoid any stalemate in business activities.

anticipatory bail expired.

"He had been absconding for a long time. But we learnt that he returned home for the rally," said Mazharul Islam, officer in-charge of Boalia police station.

Other than Nadim, at least 33 BNP leaders and activists have been arrested in Rajshahi, Joypurhat, Bogura, Naogaon, and Natore since November 15.

Around 1,000 BNP leaders and activists have also been accused in 21 new cases, filed under special powers act and explosives act, in Sirajganj and five other districts.

On Saturday night, police recovered a sack of

six cocktail bombs from a bush in front of BNP's Gopalpur municipality office in Natore's Lalpur upazila.

The office was later sealed off by police.

Farzana Sharmin Putul, a member of BNP's media cell, said, "The incident of recovering bombs was arranged. BNP members had nothing to do with it."

"We think a transport strike will also be enforced in Rajshahi ahead of the rally, like in other divisions. But our demands will only reach more people with all the obstacles," said Ruhul Quddus Talukder Dulu, BNP's Rajshahi divisional organising secretary.

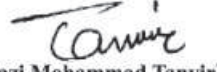
