"We have failed to find out breeding sites. We have to be active during the lean period to overcome the weaknesses of this year," he said.

"An effective insecticide needs to be introduced and registered for the people to use it, along with modern fogging machines. We had given advice to the city corporations several times in this regard but they did not pay any heed in this regard," he added.

Saifur also mentioned that surveillance is crucial and the authorities will have to form a monitoring

cell for the activities. "Dengue has already reached its peak this year and started declining. However, the number of patients is still massive. The authorities need to continue their activities to curb mosquitoes," said Entomologist Manzur A Chowdhury.

such substances. Global Environment Facility (GEF) is supporting the disposal of the 500 tonnes by providing a fund of around Tk 70.09 crore.

The DDT will be destroyed under "The Pesticide Řisk Reduction in Bangladesh" project, with involvement of the DoE, Department of Agricultural Extension, DGHS, and Department of Fisheries.

According to FAO officials, authorities will start loading the pesticide onto a ship from today. The ship entered Bangladesh territory yesterday. It will go through ports of 12 countries before reaching France to raise awareness in those countries about the issue.

to five days to finish loading the DDT powder. FAO

staffers and government officials have been involved in properly packaging the substance since mid 2021.

The hazardous powder will be destroyed at a plant in France. Bangladesh signed the Stockholm banned use of DDT powder in 1989, after importing the substance for four years.

Saso Martinov, senior technical adviser of FAO, told The Daily Star that the whole process was delayed because the mechanism to destroy DDT is complex and time consuming. Only a few countries have plants to destroy the harmful substance.

Mark Davis, senior adviser of technical Pesticide Risk Reduction in Bangladesh, said that They said it will take four authorities have completed

In 2007, an initiative

was taken to destroy the DDT pesticides under the project. It has taken 14 years to come to this stage due to various reasons, including fund complexity

HOW DDT CAME TO CTG mid-1984,

convention in 2001. It government signed an agreement to import 1,000 tonnes of DDT powder from Pakistan to control malaria. A consignment of 500 tonnes arrived at Chattogram port in the first phase in early 1985.

On March 19, 1985. four samples of the DDT were sent to the WHO in Geneva and Dhaka Testing Laboratory. After test reports stated that the substance was substandard, the government asked the Pakistani supplier Exchange International Limited -to take the the process to destroy DDT. consignment back. But it did not do so.
