# Is an olive branch offered?

**GM Quader meets Raushan** to cool tensions

The rift between two Jatiya Party factions, led by Raushan Ershad and GM Quader, could melt away as the two leaders



held a meeting at a city hotel yesterday and discussed ways to overcome their differences.

JP Chairman Quader called on Raushan, also the leader of the opposition in parliament, at the Westin Dhaka where Raushan has been staying since her return home from Bangkok on November 27.

The meeting, the first between the two top JP leaders in one year, was held at a time when the two factions had a face off over Raushan's recent move to hold the party's council and expulsion of several top leaders by Quader in retaliation.

Speaking to The Daily Star, sources close to the two leaders said they discussed how to address the differences and tensions created in the party over the last few months.

"The discussion was cordial. The two leaders agreed to strengthen Jatiya Party by overcoming the differences on party issues. I think that talks were fruitful," a JP leader close to Raushan, who was present at the hotel, said.

JP Co-chairman Syed Abu Hossain Babla, also a lawmaker, and presidium member Shafiqul Islam Sentu, both loyal to Quader, were present at the hotel.

## **BASIC BANK SCAM CASES** Complete probe in 3 months or face action **HC warns ACC**

Issuing a strong warning to the Anti-Corruption Commission over its failure to press charges in any of the 56 Basic Bank loan scam cases in the last seven years, the High Court vesterday directed the graft watchdog to complete the investigations of the cases and submit the reports to the lower court concerned in three months "without fail".

If the ACC fails to submit the investigation reports in three months after receiving the verdict and order of the HC, appropriate legal action would be taken against the commission, the HC bench of Justice Md Nazrul Islam Talukder and Justice Khizir Hayat Lizu said in a verdict. The HC bench delivered the judgment after holding a hearing on three rules that asked the ACC and the state to explain why Mohammad Ali, former manager of the stateowned Basic Bank's Shantinagar branch, should not be granted bail in three graft cases filed by the ACC. The HC, however, denied him bail saying that he as the key official of the bank's Shantinagar branch cannot avoid the responsibility of the misappropriation of money. It appears from the relevant documents that being the branch manager, Mohammad Ali sent the loan proposals to the bank's head office for approval without properly evaluating the values of the mortgaged properties, the HC said. The verdict said there is no scope for taking the offences of money laundering and loan defaulting leniently.

A 32-year-old woman, who was allegedly raped and set on fire in Dhaka's Keraniganj on Monday night, died of her wounds last night.

Lata Sarkar, who was speech impaired, breathed her last at 8:00pm while undergoing treatment at the Intensive Care Unit of Sheikh Hasina National Institute of Burn and Plastic Surgery, said Officer-in-Charge Shah Jamai of South Keraniganj Police Station. After a 999 call around 11:00pm on Monday, a police patrol team went to Kadamtali area, rescued Lata and admitted her to the burn institute, the OC said.

Rohingya man shot, stabbed to death

20 suspects storm his home

Unidentified criminals shot and hacked to death Rohingya leader Shahab Uddin at a refugee camp in Cox's Bazar yesterday morning.

Shahab Uddin, 35, was a sub-majhi, community leader, of Balukhali-12 Rohingya Camp in Ukhia, said Ukhia Police Station Officer-in-Charge Sheikh Mohammad Ali.

Quoting locals and relatives of the deceased, the OC said a group of 20 to 30 people stormed the home of Shahab breaking the door.

They stabbed him in his chest and abdomen.

At one stage they shot him and fled. Shahab Uddin died on the spot.
