Once a source of clean water, now a dumping site

Adjacent to the twin-temple (Shree Shree Anandamoyee Shiva and Kali Mata Mandir) in Mymensingh's Muktagachha, stands a century-old pond.

For decades, this waterbody was the biggest source of clean water for Mymensingh residents.

Sadly, as time went on, this pond has been into a garbage dumping site. Weeds and water hyacinths have completely taken over the waterbody, painting a poor picture of the once sacred pond.

Additionally, influential people have occupied a portion near the pond for commercial purposes, creating an obstacle for hundreds of devotees who regularly visit

Besides, poor people, irrespective of caste, creed and religion, once used the pond for bathing and cleaning due to shortage of clean water in the city.

"However, the pond has become unusable recently due to rampant pollution," said local Arab Ali.

Religious events including Durga Puja, Kali Puja, Kattiyani Puja and Monosha puja are held at the temples every year. Special puja during every full moon and new moon and on the occasion of Pahela Baishakh is also held here. The devotees belonging to Robidas community also celebrate "Surya Puja" in this place.

People from home and abroad throng this place during the festivals, but leave in dismay due to the putrid smell emitting from the pond.

Witnesses said a section of locals throw their household garbage into the pond every night.

At least 380 new dengue patients were admitted to hospitals across the country in the last 24 hours till yesterday morning.

With this, the total number of dengue cases rose to 57,738 this year.

Total number of deaths this year is 254, according to the Directorate General of Health Services (DGHS).

Among the cases, 155 are in Dhaka, 25 in Cox's Bazar, 33 in Chattogram, 11 in Barishal, eight in Khulna, six in Mymensingh, five in Rajshahi, two Narail and one each in Narsingdi, Kushtia, Pabna, Bagerhat, Khagrachhari, Bogura,

Madaripur and Feni. A total of 55,740 patients have already been released, of them 20,151 are from outside Dhaka.

Some 1,744 dengue patients are undergoing treatment and of them, 763 are from outside Dhaka.

Living amidst piles of garbage

Pabna residents suffer due to poor waste management system

Due to absence of government-designated dumping stations, tonnes of household, industrial and medical wastes are being dumped under the open sky on a daily basis in Pabna town, posing a serious threat to public health.

Pedestrians and students have to hustle through the putrid stench emanating from these dumping sites, besides busy walkways on their way to work and schools every day.

But it appears that the municipal authorities have turned a blind eye to this nuisance, despite repeated public demand for a proper waste management system. Around two lakh people live in Pabna

municipality, covering around 27 square kilometre area. Besides, three government and around 50 private hospitals are located

Around 45 tonnes of wastes are being produced daily in the municipal area, said Abdur Rahim, inspector of waste management section of Pabna municipality.

As per existing system, local ward councillors hire some private sweepers, who collect wastes door-to-door riding on threewheeler vans and dispose those of at 12 temporary dumping spots in the town.

Later, the municipality's waste carrying vehicles collect those from the spots and then pile those up at two other permanent dumping spots -- in Fakirpur and Pabna bus terminal area.

All these 14 waste dumping points are located in densely-populated areas, adjacent



to important streets.

"While I pass through piles of garbage, I have to stop breathing for a few moments due to the bad smell," said Md Alauddin, a librarian of Pabna Islamia Madrasa, which is near the bus terminal area

"Not just me, some four to five thousand

students of our madrasa are facing a similar ordeal," he added.

"I filed complaints multiple times with the municipality authorities. But they don't pay heed to our demand," he added.

"Wastes from households, factories and hospitals are dumped here under the open



sky every day, causing pollution. We get putrid smell even two-kilometres away," said Robiul, a resident of Fakirpur.

The situation gets worse when it rains. Murky water flows from the piles of garbage into the road, he added.


