FOREWORD

The objective of the ICAB's National Award for 'Best Presented Annual Reports' is to improve the transparency and accountability of the entities through financial and non-financial disclosures in the published annual reports. The ICAB has also introduced the awards for 'Corporate Governance Disclosures' & on 'Integrated reporting' for promoting and improving the quality of reporting thereon and select one entity as an Overall Winner from winners of 3 categories.

The Annual Reports of the participating organizations have been evaluated following the criteria formulated by the SAFA which judges the compliance of the entities in respect of adequate disclosures to ensure good governance in the financial activities, operations and management of these entities. It also brings a greater sense of responsibility among the management of these entities towards safeguarding the interest of the stakeholders. It may be noted that only the financial statements are audited but other information disclosed in the Directors' Report on the state of the affairs of the entities are not audited, although those are also evaluated for the purpose of these awards.

The evaluations are subject to stringent vetting procedures of a eleven-member Jury Board drawn out from amongst the eminent personalities of the country. They reviewed the whole process of the evaluations and nominations of the winners. It may be noted that this year's entire evaluation processes were carried out using the software developed by ICAB for this purpose where information are uploaded by the participating entities themselves.

Thus, the awards are the outcome of the evaluation of the publicly disclosed audited financials and non-audited other information and therefore do not in any way represent any attestation by the ICAB for the operational performance, financial position, liquidity, capital adequacy or earning status of the evaluated entities. The Awards should not be construed to reflect upon future financial health or profitability of the awarded entities and for making any decision for investment, lending or otherwise.

I take this opportunity to convey my heartfelt 'congratulations' to the winners and my sincere 'felicitations' to all participating entities, in the different categories, which have made these Awards competition challenging and meaningful. My deep gratitude to each member of the Jury Board for their valuable contribution.
