All should work together for peace and stability

Says outgoing Chinese envoy

All countries, including China, India, the US and Bangladesh, should work together as friends, instead of forming groups against each other, for peace and stability, said Li Jiming, the outgoing Chinese ambassador.

"That is our sincere wish -- that is what China is pursuing," he said, citing the Russia-Ukraine war that has created a refugee crisis in Europe and has unfurled economic turmoil the world over.

Bangladesh and China have accomplished a lot during his tenure here, especially during the joint fight against Covid-19, he told reporters after a farewell meeting yesterday with Planning Minister MA Mannan at the planning ministry.

Several major projects were completed and many are on the way to completion next year.

He congratulated Bangladesh for being on the fast track of development, which will help the international community, including

He said he was happy that China played a positive role as a development partner and uplifted the strategic partnership of cooperation between China and Bangladesh to a higher level.

Asked about the Dhaka BRT accident in Uttara that killed five people on August 15, he said that all parties involved learned a lesson from the episode and any repeat should be averted.

China's Gezhouba Group Corporation is implementing the project.

It is up to the Bangladesh government, not China, to take action against the company, he added.

Russia renews missile attacks on Ukraine

Two killed in Zaporizhzhia; G7 pressures Moscow with oil price cap

Ukraine said Russia had destroyed homes in the south and knocked out power in the north in a new round of missile attacks yesterday as the West tried to limit Moscow's ability to finance its invasion by imposing a price cap on Russian seaborne oil.

Air alerts sounded across Ukraine and officials urged civilians to take shelter from what they said was the latest in waves of Russian missile strikes since its February 24 invasion.

Man abducts, kills boy

An 8-year-old boy has been strangled to death after being abducted by his neighbour in Dinajpur's Khansama upazila.

The victim, Arifuzzaman, was a class-1 madrasa student from Kayempur village in the same upazila.

Police detained Shariful Islam, 24, an Alim student of a madrasa, from his home in Daktarpara area on Sunday night in connection with the abduction and murder.

Yesterday afternoon, a Dinajpur court sent the arrestee to jail after police produced him before it in a case filed by the victim's father earlier in the day.

Speaking at a briefing at his office yesterday afternoon, Shah Iftekhar Ahmed, superintendent of police in Dinajpur, said Shariful took Arifuzzaman for ride on a bicycle from near the latter's home on Friday afternoon.

In the evening, Shariful called the victim's father to inform him that he abducted his son and demanded a ransom of Tk 1 lakh. The father soon informed police about the incident and filed a general diary with Khansama Police Station that night.

Angered by this, the abductor killed Arifuzzaman after raping him at his home. He later buried the victim inside a room of the house on Friday night, said the SP quoting arrestee's confession to police.

Police late on Sunday night recovered the body from the abductor's house and sent it to M Abdur Rahim Medical College for an autopsy.

allegations saying that all the farmers

took a loan of Tk 40,000 each. She, however, claimed that the bank authorities illogically filed the case against all the farmers though some

of them repaid loans with interest. Md Ahsanul Goni, deputy general manager of Bangladesh Samabaya Bank Limited, said the case was filed against only those who did not repay the loans.

"A total of 40 farmers took loans, but only three of them repaid with interest. So, the case has been filed

against 37," he said.

Asked about the alleged fraudulence, Ahsanul said the bank authorities issued separate cheques against each of the 40 farmers. The association leaders received the cheques and handed the

money to farmers, he added. "So, the association leaders will be held responsible if any irregularities are uncovered."

On November 24, 12 farmers of Varoimari village were arrested on loan default charges while the rest 25 went into hiding. The arrests sparked widespread criticism.
