Ex-RCC mayor claims he has zero annual income

Mostafizar Rahman, former mayor of Rangpur city, claimed that he did not have any annual income for the last 5 years even though he withdrew over 80 lakh in honorarium during this

He made the claim in the affidavit he submitted to the Election Commission on November 27 for the upcoming Rangpur City Corporation (RCC) elections.

As per electoral rules, each candidate has to submit an affidavit containing various information, including a financial statement, educational background, declaration of profession, and a record of criminal cases, if any.

Mostafizar was elected mayor in January, 2018, and his tenure ended in November this year. He is running with the Jatiya Party ticket.

According to RCC sources, Mostafizar withdrew Tk 1.35 lakh a month honorarium during this period. The honorarium included festival and travel allowances, alongside other benefits.

The former mayor has withdrawn over Tk 80 lakhs for his services, added an RCC official.

In the affidavit, Mostafizar said he was the former mayor of the city. He also claimed that the dependent members of his family earn Tk 20.5 lakh annually by renting out houses, shops, and other establishments.

He also cited that his wife owns a house and a building, and no one else in the family owns any immovable property.

Mostafizar and his wife jointly own movable properties worth Tk 35 lakh, including cash, jewelry, bank deposits, furniture, and electronic devices. He is not facing any criminal charges, the documents read.

Meanwhile, Mostafizar submitted another statement to the EC on the same day, announcing that he would spend Tk 14 lakhs on his campaign.

According to media reports, Mostafizar in 2017 claimed that his annual income was Tk 3.5 lakh.

Fighting rages in east Ukraine

Russia says US not showing 'constructive' approach to war; West eyes more sanctions on Moscow

Russian forces pounded targets in eastern and southern Ukraine with missiles, drones and artillery, Ukraine's General Staff said yesterday, while millions remained without power in sub-zero temperatures after further strikes on key infrastructure.

In a flurry of weekend diplomacy, Ukraine's President Volodymyr Zelensky spoke with the leaders of the United States, France and Turkey ahead of planned Group of Seven (G7) and EU meetings that could agree further sanctions on Russia.

There are no peace talks and no end in sight to the deadliest conflict in

Europe since World War Two, which help the United States has provided. Moscow describes as a "special military operation" and Ukraine and its allies call an unprovoked act of aggression.

Russia does not vet see a "constructive" approach from the United States on the Ukraine conflict, RIA news agency quoted Deputy Foreign Minister Sergei Vershinin as saying yesterday. The two countries have held a series of contacts in Turkey.

US President Joe Biden told Zelensky during a call on Sunday that Washington was prioritising efforts to boost Ukraine's air defences, the White House said. Zelensky said he had thanked Biden for the "unprecedented defence and financial" centre of the country.

On the ground in Ukraine, the Black

Sea port of Odesa yesterday resumed operations that had been suspended after Russia used Iranian-made drones on Saturday to hit two energy facilities. Power is slowly being restored to some 1.5 million people, but the situation remains difficult, national grid operator Ukrenergo said in a statement vesterday.

Zelensky said other areas experiencing "very difficult" conditions with power supplies included the capital Kyiv and Kyiv region and four regions in western Ukraine and Dnipropetrovsk region in the

Japan International Cooperation extended part. Agency (JICA), which is providing FULL-FLEDGED OPERATION IN a soft loan for the Tk 33,472 crore 3 MONTHS project, vesterday arranged a press tour at the metro rail depot and Uttara North Station.

Representatives of contractors and consulting firms involved in the project, formally known as Mass Rapid Transit Line-6 (MRT Line-6), demonstrated different elements of services and showed their readiness for partial commercial operation.

As per the pre-announcement, around 12km line from Uttara to Agargaon would be launched in December this year, while the rest eight km by December next and the one km extended part from Motijheel to Kamalapur by June

The original cost of the project

was Tk 21,985 crore, but it rose to two minutes at the beginning, inaugurated on the day set by the acquiring new land to change the accustomed. station design and building the

Siddique said they have started service trials from December 4, which are expected to be completed within 15 days. Dry runs are expected to start from December 18 or 19.

The service trial is the final checkup after the integration, while the dry runs means operating the trains without passengers to ensure every aspect is ready, officials said.

The MD said that, as per the international practice, the metro trains will initially operate with less than capacity and an increased "dwelling time" -- the time a train is stationary for boarding and disembarking.

Messi, a seven-time Ballon d'Or winner, has achieved all at club football and also guided his country to a first-ever Copa America title in 28 years. The 35-year-oldhas appeared in all World Cups since 2006 and has overtaken Diego Maradona's record

of World Cup goals. He has also recently broken his duck of scoring in World Cup knockout games. With all those trophies in the bag and all those feats, there is just one trophy missing from his cabinet; the one that matters most, the glaring absence of which could define the legacy of one of the greats of all time. Like Messi, Modric, too, has won everything at club level and an eradefining Ballon d'Or. The Real Madrid midfielder pulls the strings in the midfield and orchestrates the attacks of a resilient Croatia side, his own resilience and doggedness reflected on the whole squad. Like Messi, Modric too suffered the heartbreak of losing a World Cup final.

bank tumbled into chaos. The central bank is now carrying out an investigation into Islami Bank for authorising Tk 7,246 crore in loans

to nine companies in recent weeks violating banking rules. Most of the companies used fake addresses in their loan application forms.

The re-appointment of the observer in Islami Bank may not bring positive output as the directors of the lender are highly politically connected, said Ahsan H Mansur, executive director of the Policy Research Institute of Bangladesh.

The central bank should disband the Islami Bank board for an unbiased investigation.

In 2017, the Islami Bank board was populated with representatives of the S Alam Group. The companies the directors represent exist only on paper, shows the bank's internal

documents.

"It is a good initiative that the central bank is now carrying out an inspection. But the board members the bank may intervene in the investigation, which is why the board should be dissolved."

In addition, the central bank earlier did not get any good results from appointing observers in the weak banks in most of the cases, said Mansur, also the chairman of Brac Bank.

Fahmida Khatun, executive director of the Centre for Policy Dialogue, also expressed doubts that the observers would yield any positive outcome for

the banks. She, however, said that this is a positive move taken by the bank.
