

# Glimpses of struggle and sacrifice

Exhibition of rare Liberation War photos taken by Anne de Henning kicks off

About 10 million people faced displacement and fled to neighbouring India during the Liberation War in 1971. Besides, about 50 million people were internally displaced. Such wartime displacement is rare in the world's history, said Prime Minister's Energy Adviser Tawfiq-e-Elahi Chowdhury yesterday.

He was addressing the inaugural ceremony of a photography exhibition at the capital's Liberation War Museum, organised by Centre for Research and Information and Samdani Art Foundation. The exhibition – "Witnessing History in the Making: Photographs by Anne de Henning" – features rare photographs of Liberation War and Bangabandhu, captured by the celebrated French photographer.

He said going through the exhibition, the new generation will get glimpses of struggle and sacrifice made by people to achieve independence. He thanked Henning for storing the rare photographs in her archive.

State Minister for Power and Energy Nasrul Hamid, also a CRI trustee, said they are planning to host a "permanent exhibition" at Shilpakala Academy, where rare photographs of the Liberation War captured by foreign photojournalists will be on display.

Education Minister Dipu Moni said the photographs captured by Henning are "historic" and chronicle wartime atrocities by the occupation forces as well as expectations of people who dreamt of independence.

French Ambassador Marie Masdupuy said the photographs captured by Henning were earlier on display in France's Guimet Museum, and the exhibition was a great success. "I'm sure this exhibition too is going to be a tremendous success."

State Minister for Cultural Affairs KM Khalid said the exhibition will give a chance for the next generation to learn from the history.

According to organisers, Henning is expected to be present at the exhibition today, marking her visit to Bangladesh after 50 years. She is also expected to revisit some of the places from 1971.

Besides Henning's photos during the Liberation War, the exhibition also features photographs of Bangabandhu giving a speech at the first council of Awami League after independence in 1972.

The exhibition also features other works from her archive including her coverage of the Vietnam War.

Curated by Ruxmini Reckvana Q Choudhury, the exhibition will continue till December 24.

# Four arrested over gang rape

Rab has arrested four people in connection with raping a woman in Khulna.

Belal Moral, Azizur Rahman Mithu, Jihad Munsif and Md Russell were held on Wednesday night, said officials yesterday.

Among the arrestees, Azizur and Belal are easy bike drivers, Jihad is a bakery worker and Russell, a fourth-year honours student at a local college.

Lt Col Mostaq Ahmed, CEO of Rab-6, told a press briefing at its office that on Tuesday evening the 35-year-old and her husband went to Aranghata bypass for a walk.

On their way home, four police imposters set up a check post, intimidated them and took the couple to Belal Moral's house at Aranghata. Later, three of them raped the woman and the other videoed the scene. Afterwards, they released them. The accused were arrested by tracking a mobile number, which they gave the couple, he said.

Aranghata Police Station OC Md Wahiduzzaman said the woman filed a case against the four.

# Live-streaming and pocketing crores

6 of racket arrested, says CTTC

Counter Terrorism and Transnational Crime (CTTC) yesterday claimed to have arrested six people, including the mastermind, of a racket involved in illegal money transactions using a video streaming platform.

For the fraud, the racket used an international live-video platform. In Bangladesh, the prime agent for the platform is Abu Musa Imran Ahmed Sony, who has been arrested.

While addressing a briefing at Dhaka Metropolitan Police media centre, Md Asaduzzaman, chief of CTTC, made the disclosure yesterday.

The five other arrestees are Abu Shama, Fatema Akter, Shyla Akter, Shah Arman, and Md Selim.

Sony appointed around 120 more agents across Bangladesh and 30 in the Middle East to operate. The agents' task was to appoint influencers, mainly girls, for live-streaming largely pornographic content, said

A lack of renovation of sewers for a long time causes waterlogging in Khulna city on a regular basis, said speakers at a press conference yesterday.

The 165.84km of drains in the city's 31 wards has remained inoperative resulting in inundation during the monsoon.

This also brings sufferings to people especially the slum dwellers, they further said.

The absence of a planned drainage system triggers such a situation even after a brief rain,
