BOARDS OF STATE LENDERS

Finally, criteria set for directorship

The secretaries of ministries have been barred from serving as chairpersons and directors of the 16 state banks and financial institutions in the latest guideline from the finance ministry as the government looks to enhance corporate governance in the organisations.

Besides, government officials equivalent to the rank of a secretary are also disqualified from the posts, according to the notice on December

The financial institution division of the finance ministry will form a selection committee led by its secretary for the boards of state lenders.

The roles can be assumed by people with knowledge of economics, banking, financial market, monetary policy and financial management, business studies and administration, agriculture, industry, law and information technology.

The board must have at least one chartered accountant, a retired district judge or attorney general and a banker.

While one-third of the boards should be populated with females, the persons must have sufficient experience.

All nominated directors must have at least 10 years of experience in the field of administrative or management-related work.

People involved in illegal activities, including criminal offences and financial corruption, will be disqualified for the posts. No defaulter will be allowed on the board of state lenders.


Once appointed, a director can serve for three terms or nine years in

The guideline is a good initiative as there were no criteria before on who could be appointed as directors to state banks, said Salehuddin Ahmed, a former governor of the Bangladesh Bank.

He suggested the finance ministry take prior suggestions from the central bank before appointing directors such that people with a clean image can be recruited.

"The policy seems good but is inadequate," said Debapriya Bhattacharya, a distinguished fellow at the Centre for Policy Dialogue. The regulations do not mention anything about the screening

8 more lives lost on roads At least 10 hurt

At least eight people died and 10 others were injured in road crashes that took place in four districts between Friday night and vesterday

In Kurigram, three people were killed and four others were injured in two separate accidents.

In the town's Trimohini area around 9:30pm on Friday, a bus hit a three-wheeler and a pedestrian, leaving Abdul Mannan, 44, and Biplob Mia, 36, dead and four others

In Phulbari upazila of the same district, a sand-laden tractor lost control and plunged into a roadside ditch in 18, last afternoon.

Mahfuzul Islam confirmed the matter to The Daily Star. In Dhaka's Savar, a man died and another person was injured after a vehicle hit a motorbike in Noyarhar area on the Dhaka-Aricha Highway around 1:00am yesterday.

The deceased was identified as Asadul, and the injured as Ibrahim, said Savar Highway Police Station OC Azizul

Meanwhile, the death toll from Friday night's collision between a human haulier and a minibus in the upazila rose to four, after its driver succumbed to his injuries

Peter Michael Rosza, 45, of San Diego, and Conor Woulfe, 39, of Maryland, say they forked over \$3.99 each to watch the Richard Curtis comedy on Amazon Prime, only to discover that de Armas had not made the final cut.

A class action suit filed earlier this year alleges fans had been led to expect the Cuban "No Time To Die" star would feature prominently.

However, they "did not receive a movie with any appearance of Ana de Armas at all," says the suit, reported by US media on Friday.

Accordingly, "such consumers were not provided with any value for their rental or purchase," the suit added.

UNSC trying to 'destabilise' Myanmar: junta

Myanmar's junta has slammed a United National Security Council resolution calling for an end to violence and release of ousted leader Aung San Suu Kyi, accusing the body of attempting to "destabilise" the country.

The Security Council adopted its first ever resolution on the situation in the turmoil-ridden Southeast Asian nation on Wednesday, after junta allies China and Russia abstained rather than veto the document.

The 15-member Council has been split on Myanmar for decades and was previously only able to agree on formal statements about the country.

The resolution contained "several intrusive elements on Myanmar's internal affairs that contravene the principles and purposes of the United Nations," the junta's foreign affairs ministry said in a statement on Friday.

"Exerting pressure to destabilise Myanmar rather than supporting the government's efforts does not help the country and Myanmar will not accept such acts."

The text was adopted with 12 votes in favour. Permanent members China and Russia abstained, opting not to wield vetoes following amendments to the wording. India also

In its Friday statement the junta repeated its claim of alleged widespread voter fraud during the November 2020 election, won resoundingly by Suu Kyi's National League for Democracy party.

International observers said the election was largely free and fair.

Suu Kyi, 77, has been a prisoner since the army toppled her government almost two years ago.
