6 'Al Qaeda-inspired' men held in Dhaka, Chattogram: CTTC

Counter Terrorism and Transnational Crime (CTTC) unit has arrested six suspected militants who, the unit claims, were inspired by the international terrorist outfit Al Qaeda.

The unit said after training, the arrestees planned to 'wage jihad" for establishing Islamic rule in Bangladesh. They got the idea after seeing extremist posts and videos online.

CTTC Additional Commissioner Md Asaduzzaman said they arrested Abdur Rob, 28, Md Shakib, 23, Md Shamim Hossain, 18, Md Nadeem Sheikh, 19, Md Abshar, 20, and Md Sayeed Uddin, 18, from the capital's Syedabad Bus Terminal, Chattogram and Teknaf on Sunday.

Based on initial interrogation, the CTTC chief said the arrestees formed a team by communicating on social media and different apps.

"They migrated to Teknaf and stayed there for militant activities, after training with local collaborators. They have more associates. An operation is underway to arrest them," Asaduzzaman told journalists at a press briefing at Dhaka Metropolitan Police's media centre yesterday.

He said Abdur Rob is the coordinator among the six. Rob went to Saudi Arabia in June 2019. During his stay there, he was inspired to carry out militant activities

by seeing various extremist posts and videos online, he added. Rob got introduced to Sayeed through a comment on

a video on social media. In a similar way, he contacted Shamim, Shakib, Nadeem and some others.

Asaduzzaman said being the coordinator, Rob would

much worried about the next national election, noting that the election will be held timely and fairly. Momen said the government is

committed to holding a "free, fair, transparent and inclusive" election. He said it would be good if all the

parties join the next elections, if not, that is okay.

Asked whether the government could assure the foreigners about a fair election, Momen said, "It's not our headache, it is your headache. Why should I assure foreigners? If we work accordingly, they will understand."

He said the next election is still far away and in other countries they see election-related events just two months ahead of the scheduled election. "Here we see election-centric noises one year ahead of the election. This is very sad."

Awami League's decision to not compete for two of the recently vacated seats, rather letting its allies vie for them, is aimed at strengthening its relations with partners ahead of the 22nd national

election, slated for January 2024. On the other hand, AL's decision to not give the party symbol to

anyone competing in the upcoming Brahmanbaria-2 by-polls is an effort to keep the main opposition, Jatiya Party, in its fold, according to AL insiders.

A gap started forming between partners of the 14-party alliance and Awami League. This gap has widened day by day due to AL ignoring its partners.

This friction was exposed on December 8, when AL convened a meeting with its partners. The ruling party drew heavy flak from its left-leaning allies for ignoring them while taking crucial political decisions and for starting "electioneering" for the next national polls by keeping its partners in the dark.

A total of Tk 13.85 lakh was loaned to them, the case statement read. Contacted, Mujibur said, "Some are saying that I bribed them to secure votes in the election, but this claim is false."

"As I was a member of the zilla parishad, I had close relations with all representatives in the upazilas, and they used to take loans from me. The amounts are such that they are not willing to return," he said.

In the last election held in 2008,

AL left Thakurgaon-3 for Workers Party, Bogura-4 for JSD-Inu, and Brahmanbaria-2 for Jatiya Party, but BNP won those seats. The ruling party has decided to

contest for three of the six seats that remain vacant since the recent resignation of BNP lawmakers. The election of those six seats will be held on February 1. On December 11, a day after BNP's

rally in Dhaka, seven BNP MPs, one from reserved seat, tendered their resignation letters to the JS speaker as part of their party's anti-government movement. And so, six seats --Brahmanbaria-2, Thakurgaon-3, Bogura-4, Bogura-6, Chapainawabganj-2 and Chapainawabganj-3 -- were vacated.

Awami League's decision came after Workers Party and JSD wrote letters to the ruling party to sacrifice those two seats for them. According to insiders, as AL

AL President Sheikh Hasina, also the prime minister, held a meeting with two top leaders of Jatiya Party, while top leaders of AL had several meetings with its left-leaning

CID arrests four human traffickers

Criminal Investigation Department (CID) yesterday arrested four members of a human trafficking racket from Satkhira's Kolaroa area.

The four are Mokhlesur Rahman, Shahiduzzaman Babul, Anarul Islam and Kazirul Islam.

CID found the arrestees' involvement in human trafficking while investigating a case filed with Fatullah Police Station of Narayanganj in March 2021.

The four accused are active members of a gang, who trafficked women and children to India, said CID's Special Police Super (Serious Crime) Nazrul Islam.

One Anwar Hossain, who is now behind bars in India, is the mastermind of the gang, he added.

CID on December 19 last year arrested accused Abdus Sattar from Keshabpur in Jessore after another accused Fatema revealed his name in her confessional statements.

Later, Sattar confessed to the magistrate that he, along with other accused -- Mokhlesur Rahman, Babul, Anarul and Kazirul -- took the victims to Satkhira from Jashore and trafficked them to India with help of their associate Nazrul.
