NHRC team finds proof of arson

Alam, its Deputy Director Mohammad Gazi Salauddin, and Assistant Director Md Robiul Islam.

Around a dozen homes in Lama upazila's Rengyan Mro Para village were torched and vandalised by unidentified attackers in the early hours of Monday.

The victims alleged that the attack was carried out by people of a rubber plantation, Lama Rubber Industries Limited, to drive them away from the area. The company, however, denied the claim and said the indigenous people were building houses on its allocated land.

While visiting the area, the NHRC team spoke to the victims as part of its probe.

Village chief Rengain Mro, who was also a victim, said, "Over 100 people of the plantation came to our village on six trucks and began attacking."

"They torched and vandalised at least six houses, ransacked several others and also looted our valuables."

case, but the judge refused as his court hours had ended, Tushar said.

The lawyers then started shouting in the courtroom and scolded the judge and the court officials, prompting the judge to send a letter to the Supreme Court registrar general seeking a necessary decision to this effect, he said.

Tushar added that documents, including footage of the incident, have been sent to the SC registrar general's office.

On November 15 last year, the same HC bench blasted and rebuked Pirojpur Public Prosecutor Khan Md Alauddin for misbehaving and threatening the district's chief judicial magistrate in the courtroom during the proceedings of a criminal case on July 25.

Meanwhile, footage of the lawyers misbehaving with the judge went viral on social media.

He added, "We are still spending our days in fear of further attacks."

Another victim, Sing Chang Mro said, "The company people are continuously torturing us with the aim to evict us from our land. They torched our rubber garden, crops and houses. We are helpless."

Chomraw Mro said, "Jhum cultivation is our main source of income. The company people are repeatedly torching our crops and homes."

Shahidul Islam Chowdhury, officer-in-charge of Lama Police Station, was also present at the spot during the NHRC visit.

"After the incident, we have kept the area under our surveillance. Police patrol has been beefed up. We are working to keep the situation under control," he told reporters there, adding, "We will take necessary legal action against the attackers after investigation."

No representative of the rubber plantation was present there at the time.

Contacted, it's Manager Kamal Uddin denied the allegations and

said they have no involvement in any such attacks.

"We don't know who carried out the attack on the Mro community. They are bringing the allegations against us but those are not true," he told The Daily Star over the phone yesterday.

"We want to maintain a good relationship with them."

The people of three villages -- Rengyan Mro Para, Langkam Mro Para and Joychandra Tripura Para, which are next to one another -- depend on jhum cultivation as their main source of income.

The villagers alleged that the company's employees on April 26 last year torched crops on over 300 acres, which belongs to them.

Meanwhile, the attacks outraged eminent citizens and rights bodies, who expressed concerns and demanded punishment to the perpetrators.

According to media reports, the villagers also alleged that miscreants poisoned a small stream of water in the hills of Rengyan Mro Para on September 6.

the administration's cooperation as many of them become jobless during such cold spells.

According to the Bangladesh Meteorological Department, a mild cold wave was sweeping over Rajshahi, Pabna, Dinajpur, Panchagarh, Nilphamari, Chuadanga, and Kustia.

The lowest temperature in the country was recorded in Jessor at nine degrees Celsius till 9:00am yesterday while Dhaka experienced 12.5 degrees.

Among other districts that experienced a mild cold wave, Chuadanga recorded 9.2 degrees Celsius, Pabna 9.5 degrees, Sylhet 9.6 degrees, Dinajpur 9.8 degrees, and Rajshahi and Tengulia 10 both degrees Celsius.

"The temperature will start rising from today and will continue for the next two or three days. It will start falling again after 10 to 12 days," said meteorologist Abdur Rahman Khan.

The ceasefire order came a day after Moscow lifted its reported toll in its worst single reported loss from a Ukrainian strike to 89 dead.

Ukraine's military strategic communications unit has said nearly 400 Russian soldiers died in the town of Makiivka in eastern Ukraine, held by pro-Russian forces. Even Russian commentators have said the death toll may be far higher than the Kremlin's figures.

The deadly Makiivka strike came after months of discontent within Russia towards the military following a series of battlefield defeats and a hugely unpopular mobilisation drive.

As Moscow grapples with the aftermath of the strike, the head of the Wagner mercenary outfit said the first group of Russian prisoners offered an amnesty in return for fighting in Ukraine had been released.

Wagner boss Yevgeny Prigozhin appeared in a video released Thursday speaking to a gathering of men -- some injured and whose faces were blurred.

under the Police Assault and Explosives Act against 45 named and 150 to 200 unnamed people the next day.

On November 22, the High Court granted bail to all 43 accused for six weeks. They appeared in the lower court yesterday as their bail expired.

Rubel Ahmed Chowdhury, general secretary of district Chhota Dal, claimed the case filed by the police was a false one and the court is denying bail despite the fact that the accused have been charged with bailable offences.

The official also claimed that they spoke about the matter with the NBR so the latter could make its own decision.

However, a top NBR official told The Daily Star that they drew a lot of flak after the 2019 incident, adding that they did not want to face a similar backlash.

"This time, we want to avoid doing what we did in 2019. That's why we sought the ministry's opinion to settle the matter as per law," he said.

Contacted, Navana Ltd Assistant General Manager Ripon Prakash Das said, "We have applied to the ministry, NBR, and Customs for the duty-free facility to release the car as it has been lying at the port for nearly three and a half months."

He said if released, the vehicle could be used by family members of the deceased MP.

It may be noted that official vehicles are available to MPs for five years at a time and can be kept for personal use after paying the duty initially waved.

The Daily Star tried to reach the family of Sajeda for comments but failed despite repeated attempts.

the case with Kafrul Police Station against Tarique, his wife Zubaida and her mother Syeda Iqbal Mand Banu for amassing assets worth Tk 4.82 crore through illegal means and concealing the information of Tk 2.16 crore in their wealth statements.

The investigation officer of the case pressed charges against the three with the Chief Metropolitan Magistrate's Court, Dhaka, on March 31, 2009.

Earlier, Tarique was sentenced to life in jail in the August 21 grenade attack cases. He was also sentenced on different terms of punishment in two other cases, including the Zia Orphanage Trust graft case.
