### DB arrests 5 for defaming S Alam owners

Police arrested five people, including a 70-year-old businessman and two minors, for allegedly pasting posters and making social media posts to defame the owners of Chattogrambased S Alam Group.

Abdul Kuddus, a deputy manager of S Alam group, filed the case with Gulshan Police Station on January 5 under the Digital Security Act.

The arrestees are businessman Mohammad Nur Un Nabi, 70; Afsar Uddin Roman, 42; and Abu Sayeed Saju, 21. The two minors are aged between 17 and 15.

The DB produced the three adult arrestees before a Dhaka court yesterday and sought a five-day remand for each.

The court, however, sent them to

Kuddus in the case accused Nur and Golam Sarowar Mia, and Mazharul Islam alias Rasel. Saju and Roman had not been mentioned.

#### Journo stabbed to death in B'baria **BCL** activist detained over killing

Police detained a Chhatra League activist for his alleged involvement in stabbing a local journalist to death in Brahmanbaria town yesterday evening.

The deceased, Ashiqur Rahman Ashiq, 27, of Medda area of the town, was the district correspondent of the daily Porzobekkhon.

Around an hour after the incident, police detained Raihan Mia from the town in connection with the killing, said Emranul Islam, officer-in-charge of Brahmanbaria Sadar Model Police

Ashiq was also a member of "Batighar", a voluntary organisation that buries unclaimed bodies.

"Raihan and four-five other youths stopped the easy bike carrying Ashiq when he was returning after a monthly meeting of Batighar at Faruqi Park in the town. They then stabbed him mercilessly and fled,"

# Brazil locks down Congress area after riots

1,500 held; President Lula blames Bolsonaro fans; world leaders condemn attacks

Brazilian security forces locked down the area around Congress, the presidential palace and the Supreme Court yesterday, a day after supporters of ex-president Jair Bolsonaro stormed the seat of power in riots that triggered an international outcry.

In stunning scenes reminiscent of the January 6, 2021 invasion of the US Capitol building by supporters of then-president Donald Trump, backers of Bolsonaro broke through police cordons and overran the seats of power in Brasilia, smashing windows and doors and ransacking offices.

Initially overwhelmed security forces used tear gas, stun grenades and water cannon to fight back the rioters until they finally subdued them.

Newly inaugurated President Luiz Inacio Lula da Silva, the veteran leftist who narrowly won Brazil's bitter, divisive October elections, condemned the invasions as a "fascist" attack.

condemned "pillaging and invasions of the ramp from the Planalto presidential public buildings" in a tweet. But the politician palace -- the same ramp Lula climbed a dubbed the "Tropical Trump" rejected Lula's week earlier at his inauguration.

claim he incited the attacks, and defended the right to "peaceful protests."

Lula, who was in the southeastern city of Araraquara visiting a region hit by severe floods, signed a decree declaring a federal intervention in Brasilia, giving his government special powers over the local police force to restore law and order in the capital.

"These fascist fanatics have done something never before seen in this country's history," said Lula, 77, who took office a week ago.

"We will find out who these vandals are, and they will be brought down with the full force of the law."

Lula returned to Brasilia and viewed the damage at the presidential palace and the Supreme Court. He said he would work out of the palace despite all the destruction.

Federal District police said at least 1,500 people had been arrested in connection with the unrest.

#### Man lands in jail over rape, murder of 6-year-old

A Dhaka court yesterday sent a man to jail for abducting, raping, and killing a six-year-old in Ashulia's Khejurbagan area.

Abdul Kabir, 20, kidnapped the child on Wednesday from her residence and raped her. He then killed the girl and dumped her body in a nearby manhole on Sunday. He later contacted the victim family and demanded a Tk 6 lakh ransom, said Lt Rakib Mahmud Khan, commander of Rab-

The child's father filed a general diary with Ashulia Police Station and also filed a written complaint with Rab-4, a day after his daughter

The girl's father transacted Tk 15,000 as ransom in two phases through Bkash, a mobile banking service provider, so that Abdul could be tracked However, he could not be traced initially as he had switched off his cell phone, the commander added. On information, Rab, on Sunday, went to a local

shop that Abdul visited to withdraw the money after the second transaction, and arrested him. Based on the information given by him during

interrogation, the victim's body was recovered later that day.

# Fakhrul, Abbas walk out of jail

Speaking at the jail gate, Fakhrul said their struggle for restoration of democracy would be successful through the people's movement. "A huge number of BNP leaders

and activists are still behind bars. The sad thing is that they are living in inhumane conditions. I am demanding their prompt release," he said. Earlier in the day, defence lawyers

also withdrew the chamber judge's order, which on January 4 asked the counsels for Fakhrul and Abbas not to furnish bail bonds before the lower court concerned until Sunday.

Besides, the apex court asked the HC to dispose of, within 30 days, the rule that on January 3 ordered the state to explain why the two BNP leaders should not be granted regular bail in

The two were earlier denied bail four times by different lower courts.

The case was filed with Paltan Model Police Station on December 8, a day after a clash broke out in front of the BNP's Nayapaltan central office, leaving one dead and many injured.

Fakhrul and Abbas were picked up from their homes in the capital around 3:00am on December 9, a day before the BNP's divisional rally in Dhaka. They were sent to jail after Dhaka Metropolitan Magistrate Mohammad Jashim rejected their bail petitions.

The two were accused of provoking party activists to attack police.

As he waved his hand, claps and shouts of "Joy Bangla" rose high into the air. Most who were present there had their eyes brimming with tears the man who freed them stood right before them.

As the president of the newly born state, Mujib was given a 21-cannon salute and a guard of honour.

"The scene, even from the air was totally overwhelming. There was an ocean of human heads ...," Dr Kamal Hossain, eminent jurist and politician, wrote in his book titled "Bangladesh: Ouest for Freedom and Justice".

Kamal was also jailed in Pakistan and accompanied Bangabandhu from there to Dhaka via London and Delhi.

In his book, he further remembered how on December 26, Bangabandhu was brought to a police academy in Shihala, not far from Pakistan's Rawalpindi.

Bangladesh as an independent country. Then UK Prime Minister Sir Edward Heath welcomed Sheikh Mujib in the evening and said they had, in principle, decided to recognise an independent

Heath then arranged his own plane the British Royal Air Force comet jet for Bangabandhu to fly to Dhaka via Delhi. The plane reached Delhi's Palam

Airport in the morning of January 10, where Indian president VV Giri, prime minister Indira Gandhi and other dignitaries received Mujib.

Addressing a public rally in the Indian city during his short layover, he expressed gratitude towards the people of India and its government for lending support to the Liberation War of Bangladesh.

Shortly afterwards, he started his journey towards his motherland.

landing in Dhaka, Bangabandhu was taken on a truck accompanied by other leaders.

It went through cheering crowds all the way to the Ramna race course, where he made his historic homecoming speech.

"His unbridled joy came through in his speech, as did a deep sense of fulfillment of the mission to which he had dedicated his life," Kamal wrote.

"Today, when I landed in Dhaka, I couldn't hold back my tears, because never did I think I would be back to the land, the people, and the country, Bangladesh, that I love so much," Tarik Sujat quoted Bangabandhu as saying in his book titled Bangabandhur Swadesh Pattyabartan Comet Biman

O British Gopon Dalil. Mujib said he did not know whether he would be able to return to his people, adding, "I had only said one thing: I have no objection if you kill me, but please return my body to my Bangalees."

"...I did not know I was sentenced to death by hanging. A grave was dug for me beside my cell. I had prepared myself. I had said, I'm a Bangalee, I'm a man, I'm a Muslim; I can only die once but not twice. I had said that if death awaits me. I will approach it with a smile on my face. I will not dishonour my Bangalees, I will not beg for pardon."

Sheikh Muijib in his speech made sure to pay due tribute to the millions who sacrificed their lives during the war and played vital roles in rebuilding the nation. After the rally, around 5:35pm,

he boarded a car with a flag of independent Bangladesh and left for his Dhanmondi house. He was greeted with the embrace

and tears of joy of his eldest daughter and first born - Sheikh Hasina, the current prime minister of Bangladesh. After exchanging hugs and tears

with Sheikh Rehana and the others, he went to meet his parents. He touched their feet first before

greeting them. And then, upon hugging his mother, he burst into tears and cried

like a child in her arms. He then met his wife Bangamata Sheikh Fazilutnnesa Mujib – who was considered his rock throughout his entire ordeal and for the rest of his life.

Meanwhile, 17 large and 14 small digital boards displaying traffic rules and speed limits were set up at some key points, but they remain largely ignored. Dhaka Metropolitan Police set up those displays at a cost of Tk 27

Many of them have since been removed for ongoing projects like

metro rail and U-loops. The traffic in the city of more than two crore remains chaotic.

Dhaka is the seventh worst city in terms of traffic management among 241 surveyed, according to the World Traffic Index 2020.

Buet's Accident Research Institute (ARI) said the country lost an estimated Tk 55,685 crore due to traffic congestion in Dhaka city last Urban transport experts blame

unthoughtful traffic management, unrealistic projects and unplanned permission for new vehicles on overcrowded road for the situation.

Poor road conditions, rickety public transport, jaywalking, and non-

motorised vehicles also contribute to gridlocks, they said.

Adil Mohammad Khan, former general secretary of Bangladesh Institute of Planners, said, "Though the government had prepared a Strategic Transport Plan (STP) in 2005 for 20 years, later revised for 2015 to 2035, it was not followed properly."

In the STP and RSTP, experts suggested clearing footpaths, constructing eight roads connecting roads outside Dhaka, three ring roads, and discipline in public transport management, said Adil, adding that there were proposals for five metro rails, two bus rapid transport systems, six expressways, and 21 transport hubs.

He said metro rail alone will not solve the problem as it would cater to only 10 percent of the passengers.

Even though the government is working on a bus route rationalisation system, only three routes have been opened and those failed to provide optimum benefits to people due to a lack of buses, he said.

Adil said 20 to 25 percent of areas of a city should be roads but in Dhaka less than 10 percent of the area are roads. "Even the existing roads cannot

function more than 60 to 70 percent

due to a lack of coordination among

city corporations and utility service providers, uncontrolled parking, and mismanagement of hawkers. Monibur Rahman, additional

police commissioner (traffic) of Dhaka Metropolitan Police, said an integrated plan is important to make the city's traffic signals functional and to implement that plan, coordination among all the relevant stakeholders is

He said traffic police is just one stakeholder among others like Dhaka North City Corporation, Dhaka South City Corporation, Bangladesh Road Transport Corporation, Bangladesh Road Transport Authority, Roads and Highways Department, and Dhaka Transport Coordination Authority.
