EC enrols 79.83 lakh new voters

Final list on March 2

The Election Commission yesterday announced a draft voter list with an enrolment of 79.83 lakh new voters, who will become eligible to cast their votes in the next parliamentary elections for the first time.

Among the new voters, 40.72 lakh are men and 39.10 lakh women, EC Secretary Jahangir Alam said while talking to reporters at his EC office.

Anyone will be able to raise objections over the voter list by February 7 at all upazila elections offices and the EC

will hold a hearing on February 14 to settle the objections. The draft list will be displayed at important places at the EC field offices.

The final voter list will be published on March 2, Jahangir said adding that the next general polls will be held using this list.

The EC is planning to hold the 12th parliamentary polls in late December this year or early January next year.


This was the last registration process for prospective voters before the next election. EC enumerators went door-to-door in May-June last year, to gather information. This time, EC representatives also collected data on

citizens born on or after January 1, 2005, January 1, 2006, and January 1, 2007, who would gradually be included in the electoral roll when they turn 18.

Jahangir also said that while updating the voter list, the names of 22.09 lakh deceased voters were dropped.

The total number of voters in the country now stands at 11,90,61,158 among them 5,86,77,209 were women, he

AL MP Golap owns nine properties in New York City

Awami League lawmaker A b d u s Sobhan Miah Golap concealed



information about being an American citizen and owning nine properties in New York City in his election affidavit in 2018, found an investigation by a global media agency raising questions about his seat in the parliament.

Golap, who was given the post of central committee's publicity and publication secretary in the AL's national council last month, bought the properties between 2014 and 2019, according to a report by the Organised and Corruption Reporting (OCCRP), a global network of investigative journalists.

PROPERTIES IN DUBAI Investigate allegations against 459 Bangladeshis

HC asks 4 govt agencies to submit reports in 30 days

The High Court yesterday directed the authorities concerned to conduct separate enquiries into the allegations against 459 Bangladeshis of purchasing properties in Dubai without disclosing information about those.

Anti-Corruption Commission, Bangladesh Financial Intelligence Unit (BFUJ), Criminal Investigation Department (CID) of Police and National Board of Revenue (NBR) have been directed to conduct the enquiries and to submit progress reports to the HC in 30 days.

In response to a writ petition, the court also issued a rule asking the respondents to explain why their inaction to take appropriate steps against those who are responsible for purchasing houses, flats, cars and other properties by money laundering in Dubai, capital city of United Arab Emirates, should not be declared illegal.

In the rule, the HC also asked the respondents to explain why they should not be directed to take action against the Bangladeshi nationals who purchased properties using money laundered to

The respondents to the rule include the Cabinet, finance and law secretaries; chairmen of the ACC and NBR; heads of BFIU and CID; and the Bangladesh Bank

Secretary, transport leaders slam road safety campaigners

Also question authenticity of WHO report

Transport authorities and leaders yesterday came down heavily on road safety organisations for publishing what they claimed to be "fabricated" reports on road crashes, creating confusion among the people and tarnishing the country's image abroad.

speaking at a workshop, they claimed the numbers of both road accidents and deaths have come down significantly last year, compared to previous years, if the rise in the number of vehicles is taken into account.

Bangladesh Road Transport Authority organised the workshop at its headquarters to exchange views on its digital services and to inform the attendees about

the rules of the Road Transport Act-2018. However, accidentrelated issues dominated the discussion.

One of the leaders said the activities of road safety organisations are tantamount to treason, and demanded legal action against them if their reports are not based on facts.

"Those who are publishing the reports [of accidents], please

give us proof. If you fail to provide it, then tell the people you have published reports based on assumptions," said ABM Amin Ullah Nuri, secretary of the Road Transport and Highways Division. "We won't give anyone the authority to

publish fabricated reports.'

He also questioned the authenticity of the accident report by the World Health Organization, saying the UN body prepares

reports based on very limited samples.

However, representatives of two road safety organisations present there said their reports were based on media reports and prepared with due diligence.

Meanwhile, a representative of another organisation was not allowed to speak due to "time constraints".

Officials from the road transport and bridges ministry, BRTA, police, transport associations, road safety organisations and experts, and journalists took part in the workshop, in which Nuri was chief guest and BRTA Chairman Nur Mohammad Mazumder was the chair.

said 7,713 people were killed in 6,829 crashes last year - 27.14 and 22.74 percent higher than in 2021.

2 bullet-hit in row over MFS transaction in Gulshan

Two people were shot in the capital's Gulshan area yesterday afternoon following a dispute over an MFS (Mobile Financial Services) transaction, say police.

Injured Abdur Rahim, a rickshaw-van driver, and Aminul Islam, a professional driver, were hit in their legs.

They were taken to the United Hospital, where Rahim was treated and sent home. Aminul, however, has been admitted to the hospital.

Meanwhile, police have detained three people, Islam Mintu, Wahidul suspected of opening fire, and his associates Arif Hossain and Monir Ahammed, said Jahangir Hasan, additional deputy police commissioner (Gulshan division).

Police also recovered a pistol, 16 bullets, three empty bullet shells, and four magazines, the official added.

Mintu is a contractor profession and a member of the Awami Swechchhasebak League, police sources say.

Contacted, Abdul Ahad, deputy police (Gulshan commissioner division), said Arif Hossain went to Alfa General Store, near the Gulshan Shopping Plaza, around 4:00pm, and asked the shopkeeper to SEE PAGE 6 COL 3

Egypt unveils ancient royal tomb in Luxor

Egyptian authorities have announced the discovery of an ancient tomb in Luxor dating back around 3,500 years that archaeologists believe holds the remains of an 18th dynasty royal. The tomb was unearthed by Egyptian and

British researchers on the west bank of the River Nile, where the famous Valley of the Queens and Valley of the Kings lie, said Mostafa Waziri, head of Egypt's Supreme Council of Antiquities, on Saturday.

> The first elements discovered so far inside the tomb seem to indicate that it dates back 18th dynasty' pharaohs Akhenaton and Tutankhamun, Waziri said in a

statement. dynasty, part of the period of Egyptian history known as the New Kingdom, ended in 1,292 BC and

is considered among the most prosperous years of

Piers Litherland of the University of Cambridge, head of the British research mission, said the tomb could be of a royal wife or princess of Thutmosid

Egyptian archaeologist Mohsen Kamel said the tomb's interior was "in poor condition".

Parts of it including inscriptions were "destroyed in ancient floods which filled the burial chambers with sand and limestone sediment", Kamel added, according to the antiquities board's statement.

Egypt has unveiled several major archaeological discoveries in recent years, most notably in the Saqqara necropolis south of the capital Cairo.

Critics say the flurry of excavations has prioritised finds shown to grab media attention over hard academic research.
