Promises falling flat

Fickle-minded, ill-prepared authorities likely to launch half-baked service in August

When the government took up a project in November 2012 to build a 20.50km road dedicated for buses between Dhaka airport and Gazipur, the plan was to operate spacious and comfortable articulated buses.

But Dhaka Bus Rapid Transit Company Ltd (Dhaka BRT) later decided to operate electric buses instead and started the process to procure 130 electric buses in July 2022.

However, the company changed its mind again and floated a tender to procure 137 diesel-run AC buses for the service expected by August, more than six and a half years behind the original deadline.

Since the company will not be able to hire an operator until the middle of next year, it will engage Bangladesh Road Transport Corporation

(BRTC) to operate the buses. Moreover, all of the 25 stations will not be fully ready to provide automated ticket sales at the beginning, meaning the BRT service "semi-automated"

at launch. Also, a portion of the flyover may not be fully ready at the beginning.

Shafiqul Islam, managing director of Dhaka BRT told The Daily Star, said he was hoping that 50 buses would arrive in the first lot by July or August and they would launch the service soon afterwards. The next lot would arrive within the following six months.

The BRT Line-3 from Hazrat Shahjalal International Airport to Gazipur was actually an extension of the original plan, which was to build the BRT from the airport to Jhilmil project in Keraniganj.

Another plan to extend the line to Mohakhali was dropped due to what officials said was the bad experience during the BRT implementation. Experts said the partly functional BRT will not ease traffic congestion to the level expected at the outset.

Rohingyas accuse APBn of abuse Says HRW report

A 36-year-old Rohingya refugee activist was preparing a list of refugees allegedly abused by Bangladesh's Armed Police Battalion (APBn). In consequence, he faced arrest, arbitrary detention and torture, he claimed.

"I was picked up on December 3, 2021, from Thaingkhali Camp-13 on my way to offer Juma prayers in a mosque. I was kept in a room from that day till December 12, 2021, when I was shifted to Ukhiya Police Station," he claimed.

He alleged that he was indiscriminately tortured, and a burning candle was held to his genitals.

In a report by Human Rights Watch released yesterday, he was quoted as claiming, "I was put in a single room that looked like an APBn torture cell with equipment like sticks, rods, and electric shock materials. They kicked me with their boots every time someone came to interrogate me."

Many charges were brought against the refugee, starting from attempted murder, abduction, kidnapping, extortion, assault, to theft and unlawful assembly.

While in detention, his diabetes spiralled out of control and his injuries were so bad that he had to be taken to the field hospital, documents show.

The Daily Star is withholding the names of the refugee and the APBn unit.

The HRW in the report alleged that the APBn was committing extortion, arbitrary arrests, and harassment of Rohingya refugees with impunity.

The rights watchdog based its statements on interviews with over 40 Rohingya refugees, including 10 alleged victims who said that they were detained on apparently fabricated grounds of trafficking yaba. The organisation reviewed police reports and documented more than 16 cases of serious abuse by APBn officers.

A 27-year-old man who allegedly ran a YouTube channel was arrested and charged with possession of yaba tablets, a first information report dated June 25 of last year shows.

The FIR states that the man was hiding 620 yaba pills under his pillow which was discovered by the APBn during a raid. However, a Rohingya man named in the FIR as a witness to the incident disagreed.

"He is not into drugs," the witness, Md Jamal, told The Daily Star. He also said that he was unaware of being named in the case as a witness.

The man allegedly framed could not be reached, because shortly after being released he chose to leave the camp by sea on a trawler, said the witness.

6 die as 'drowsy' ambulance driver rear-ends truck

Computer engineer Lutfurnahar Lima had been living in Florida for over a decade with her father. The 30-year-old returned home around five months

ago to her ailing mother Jahanara Begum, 55. Lima was preparing documents to take her mother to the US. Her mother was suffering from kidney disease and diabetics.

On Monday afternoon, Jahanara suddenly fell very sick. She was rushed to a hospital in Barishal from her College Avenue home. As her condition was deteriorating, Lima hired an ambulance and started heading towards Birdem Hospital in the capital around 1:00am yesterday.

Their relative Fazle Rabbi, 28, and his friend Masud Rana, 28, also Barishal bureau chief of daily Nabochatona, were accompanying them.

But they could not reach Dhaka. All four and the ambulance driver Rabiul Islam, 29, and his assistant Jilani, 28, died after their vehicle rear-ended a truck at Naodoba in Shariatpur's Jajira

on the Shibchar highway around 4:20am. Talking to The Daily Star, Jahanara's elder brother Ashraf Ali said, "We, all the family members and relatives, are speechless."

More laws to control media will harm journalism Noab tells Quader

The government has taken an initiative to enact five laws alongside the existing law regarding the mass media. But attempts to control the mass media $with \, so\, many\, laws\, will\, harm$ journalism, newspaper owners said.

Leaders of the Newspaper Owners Association of Bangladesh (Noab) met Road Transport and Bridges Minister Obaidul Quader yesterday and expressed these concerns.

Quader, also the general secretary of ruling Awami League, was handed Noab's written commentary on the five draft laws regarding the mass media.



AG office 'sought stay 13 days before HC bail order'

The attorney general's office allegedly filed a petition with the Appellate Division of the Supreme Court, seeking a stay on a High Court bail order that had not even been passed yet.

The bail order came 13 days after the stay petition was filed, according to court documents and defence

In the petition, which was filed on December 21, 2021, the AG office claimed the HC granted six months' ad-interim bail to Hefajate-Islam leader Mufti Harun Izhar on December 8, 2021, in a murder case filed after the Hefajat's mayhem at the capital's Shapla Chattar on May

Actually, the HC granted bail to Harun Izhar, education and cultural affairs secretary of Hefajat, on January 3, 2022, not on December 8, 2021, his lawyers AM Mahbub Uddin Khokon and Mohammad Mujibur Rahman told The Daily Star yesterday.

In response to the petition filed by the AG office on behalf of the state, the then chamber judge of the Appellate Division on December 21, 2021, stayed the "December 8, 2021, bail order".

The AG office didn't attach the bail order to its petition as it was not

Mahbub Uddin Khokon said the AG office obtained the stay order on the basis of false information.

And because of this, Harun Izhar could not walk out of jail though he was originally granted bail by the HC on January 3 last year, Khokon added.

Yesterday, a three-member bench of the Appellate Division, headed by Justice Md Nuruzzaman, dismissed the AG office's petition and upheld the HC order that granted bail to Mufti Harun on January 3 last year.

Mahbub Uddin Khokon said his client had to stay behind bars for more than a year due to the AG office's placing of a wrong petition before the chamber judge.

"We earlier tried to mention this issue before the Appellate Division to redress the situation but in vain. We will make a decision on whether a case will be moved before a court seeking compensation for Mufti Izhar after he gets released from jail," he said.

9,000 civilians killed since Russian invasion

Says Ukraine; Zelensky calls for faster weapons supply from West

Over 9,000 civilians, including 453 children, have been killed in Ukraine since Russia's invasion last February, a senior Ukrainian presidential aide said

"We have registered 80,000 crimes committed by Russian invaders and over 9,000 civilians have been killed, including 453 children," Andriy Yermak, head of the Ukrainian presidential staff, said at the World Economic Forum in the Swiss resort of Davos.

"We will not forgive a single (act of) torture or life taken. Each criminal will be held accountable," he said, reiterating that Ukraine wants a special international tribunal to try Russian political leaders and reparations for the destruction caused by Russia's invasion.

The Office of the UN high commissioner for human rights said on Monday that more than 7,000 civilians had been killed in Ukraine since Russia invaded.

In eastern Ukraine, 25 people were still missing after a Russian missile strike on a block of apartments that killed at least 41 people in the city of Dnipro.

Saturday's strike was one of the deadliest attacks since Russia invaded Ukraine nearly a year ago. The Kremlin denies that Russian troops were responsible.

Ukraine came a step closer yesterday to winning the fleet of Western battle tanks it hopes could turn the course of the war, after Germany said tanks would be the first item on the agenda of a new defence minister.

Stop digital surveillance without rules

Article 19 urges govt

Rights organisation, Article 19, has called for a postponement on surveillance using the integrated lawful interception system technology without formulating any rules.

In a press release yesterday, the UKbased body expressed deep concern over the government's recent initiative to monitor mobile, internet and social media through controversial technologies without having specific rules.

On January 12, Home Minister Asaduzzaman Khan told the House that the government has taken initiative to introduce an "Integrated Lawful Interception System (ILIS)" to monitor social media and thwart various antistate and anti-government activities.

A female burn victim, who was injured in a fire that broke out at her house in the capital's Dhamrai on January 7, died at a city hospital last morning.

With her, all the five persons who sustained burn injuries in the incident, have died.

Hosna Akter, 30, breathed her last around 9:00am while undergoing treatment at Sheikh Hasina National Institute of Burn and Plastic Surgery. She sustained 25 percent burns on her body, said its resident surgeon SM Ayub Hossain.

Five members of a family were burnt in a fire on January 7. The other members of the family were Manjurul

Islam, 35, a garment worker, his wife Josna Begum, 25, their one-and-half-year-old daughter Mariyam Akter, and Josna's niece Sadia Akter, 18.

Murder suspect arrested while fleeing to India

Immigration police vesterday arrested a man accused in a murder case as he was trying to flee to India via Brahmanbaria's Akhaura land port.

Swapan Miah, 40, of Manikkandi village in Cumilla's Titas upazila, was barred from leaving the country because he was accused in a murder case in Cumilla, said Dewan Morshed, officer-incharge of Akhaura Immigration Police.

"He arrived at the immigration office in Akhaura to request entry to India. However, the digital database at immigration identified him as being on the blacklist. He was then arrested and handed over to Akhaura Police Station." added the official.

Articulated or bi-articulated buses are used for BRT services to cope up progress as of last month. with the large number of commuters that this makes transport more efficient, said transport expert Shamsul Hoque.

The authorities originally wanted to buy 50 articulated buses and later increased the number to 120. But that plan was dropped "to reduce operating cost and considering the BRTC's bad experience in maintaining articulated buses".

Then, the decision to buy electric buses was made at the suggestion of Asian Development Bank (ADB), a major financier of the project.

The BRT in July last year invited preliminary expressions of interest, a pre-bidding process, for procuring electric AC buses.

Rohingyas accuse APBn of abuse

On December 19, 2021, a group of seven people were arrested for possessing locally-made one-shooter gun. According to the FIR of the case, a team of APBn-8 was raiding an area close to camp-9 and 10 around 12:45am when they received a tip-off that a group of Rohingya refugees were going to assemble to "commit a crime"

One of the accused remembers the incident differently. "I was called to the area by the Head Majhi. When we all got there. I was detained. Later. we were all charged with possessing a gun," the 34-year-old accused told this newspaper.

The gun was recovered in front of hundreds of people, claimed the FIR. However, the man named in the case as a witness, one Nur Kamal, told The Daily Star that he could not remember the incident.

Lives deprived of hope

Korail children with cerebral palsy living in inhumane condition

Prolonged bed rest, need for round-the-clock care and mobility impairments reduce the quality of life of primary caregivers. And the level of physical, emotional, social and financial burden and stress among them is much higher than those caring for a child with regular needs.

Twelve-year-old Rubaiya's world is limited to her bed. A resident of the Korail slum in the capital, she lives in a dark windowless tin-shed shanty. She has not seen a glimpse of the sky in the last three years. The last time she went on a trip outside was seven years ago, at her grandmother's home in Cumilla.

Rubaiya suffers from cerebral palsy (CP), a form of disability that affects the development of a person's brain, which affects mobility.

"All of our family members can go out and have a day out on weekends, but Rubaiya and I can't. Her life is confined to the small dark room," said her mother Lucky Begum, who works as a house help.

Rubaiya is among the 24 children in Korail slum suffering from this disability without medical care, because their families cannot afford it.

According to Institute of

and Autism at Bangabandhu Sheikh Mujib Medical University (BSMMU), a myriad of factors could cause CP, such as infections during pregnancy, injuries during birth, premature birth, infant infections or accidents that cause traumatic head injuries. Most instances of CP can be identified by the age of two. Sometimes, it can be identified within a few months after birth.

Rubaiya was diagnosed with CP when she was two months old, after a sudden epilepsy that damaged her brain.

Although the brain damage is incurable, her quality of life could have been improved if she had received the required medical care and therapy at the time. But Rubaiya's parents, who struggle to eke out a living, were unaware of the condition. Like most other parents facing the same predicament, poverty and illiteracy forced them to discontinue the treatment.

With the birth of their second child, Rubaiya's mother could not Neurodisorder continue with Rubaiya's regular

exercise for a long time. As a result, her condition worsened and she became completely bedridden.

Last year, she hit puberty, and her mother solely takes care of her menstrual hygiene. Her father has arranged space for her shower inside the only room where they all share a living,

as it is difficult to carry a fullygrown teenager to the common bathroom, where other people in their neighbourhood take

For 10-year-old Fatema, who also suffers from CP, taking a shower is more of a harrowing ordeal. She lives in a wooden shanty, on the second floor. So her mother has to carry her downstairs every time, using the ramshackle staircase with loose railings and spindles.

Fatema's parents cannot afford sanitary pads for regular use. She has to manage with damp rags, dried using only the ceiling fan. This exacerbates her health condition as she chronically suffers from a cold and cough.

Like most other mothers in the slum, Fatema's mother did not go for antenatal check-ups during her pregnancy, and gave birth at home, with the help of an untrained midwife.

'Private investment crucial for growth'

Says IMF DMD Antoinette Monsio Sayeh

International Monetary Fund (IMF) Deputy Managing Director Antoinette Monsio Sayeh yesterday said Bangladesh needs policies to remove excessive regulation and improve corporate governance, as well as the financial sector's efficiency to attract higher foreign direct

Sayeh, who will leave Bangladesh today after a five-day visit, also said increasing private investments is critical for Bangladesh to sustain the recent high levels of growth,

which will require structural

For instance, addressing the weaknesses in the financial sectors by increasing the efficiency of state-owned commercial banks as well as pursuing capital market development to provide new vehicles to channel savings towards long-term investment are

needed, Sayeh said while delivering a lecture at Dhaka University vesterday. She said Bangladesh has one of the lowest

revenue-to-GDP ratios in the world, and it needs to do more to raise public revenues for public investments as well as increase support for the poor directly.

'To achieve its revenue goal, Bangladesh needs to reform its key tax policies, increase tax compliance and broaden the tax base," she added. Replying to questions, the DMD said the IMF

is not against subsidies, which already have a significant role in the country's growth. However, the country needs to provide subsidies to the targeted poor.

The lecture was organised by DU's economics department at Mojaffar Ahmed Chowdhury

Apart from financial support, the IMF will also support the country to strengthen the government's capacity to design and implement effective economic policies on public financial management, tax policy and administration, and banking, supervision and statistics, she added.

In reply to Prof Selim Raihan's query regarding how to ensure implementation of the policy reforms recommended by the IMF, the DMD said, "It's not an IMF programme, rather the IMF is coming in to support the government's programme. That is a key aspect when it comes to the feasibility of the implementation.'

"If children with such developmental delays could be brought to us within three years of age, their life can be improved with medicine and regular therapies. In most cases, they can maintain a balanced life and attend school," he said.

"Mothers must counselled not to get hopeless in such cases. Otherwise, they will consider the children as a burden, even though early management can go a long way," he added.

A yet-to-be-published research -- conducted mostly on the caregivers of children with CP in Korail -- showed that in more than 97 percent of the cases, the caregivers are females. Around 88.6 percent of them are usually mothers, while 8.6 percent are grandmothers. Around 80 percent of those surveyed said other family members rarely extend a helping hand in care-giving.

"Prolonged bed rest, need for round-theclock care and mobility impairments reduce the quality of life of primary caregivers. And the level of physical, emotional, social and financial burden and stress among them is much higher than those caring for a child with regular needs," said lead Noorjahan researcher Begum, who is also a paediatric intensive care the major cause of CP.

"This stress often creates conflict between the caregiver and the sick child, reduces the quality of care and causes relationship troubles," she added.

For example, in 12-yearold Arifa's case, her parents got divorced in the aftermath of the diagnosis of her CP. She was initially at her father's place, where she was fed sedatives all the time, to be kept asleep with little to no food. The continuous strain of being forcefully bed-bound caused bedsores infected her head.

Now she lives with her maternal grandmother in the slum. "She has been living with me since she was three years old. Her parents have already remarried and are busy with their lives," said the grandmother.

"I don't know who will take care of her after my death. Sometimes, I beat her for wetting the bed. But later on, I feel guilty."

Dr Nezamuddin Ahmad, former chairperson of the department of palliative medicine at BSMMU, and the adviser of the Palliative Care Society of Bangladesh -- which works on improving the life of 25 children with CP in Korail - recommended a proper rehabilitation system for them.

"Unlike conventional schooling, these children can be given need-based schooling, along with medication, required therapy and nutritious meals," he said.

Contrary to common conceptions, Dr Ahmad remarked that treatment does not require a huge amount of money.

He also highlighted that expecting mothers of lowincome settlements must be provided with proper antenatal care, to ensure safe delivery, as the failure of which is considered to be





FOOD PROCUREMENT DRIVE

Government target may fall short

OUR CORRESPONDENT, Pabna

Nearly two months have gone since the government's food procurement drive began in Pabna and Sirajganj, but the two districts are far from the target this year.

Farmers and millers are showing no interest in supplying paddy and rice to the government depots because they are getting far better prices in the market.

This year, the government is paying Tk 28 for each kilo of paddy and Tk 42 for each kilo of rice.

The 103-day procurement drive began on November 17 last year and will continue till February 28 this year.

According to Pabna and Sirajganj food controllers' offices, they have set targets to purchase 12,786 tonnes of rice and 3,914 tonnes of paddy through 11 depots in Pabna, and 9,540 tonnes of rice and 3,977 tonnes of paddy through seven procurement centres in Sirajganj.

Although about two months have already gone by since the procurement drive started in the two districts, about 25 percent of the rice-purchase targets have been fulfilled so far, said officials.

They said despite repeated calls, farmers are reluctant to come to the government depots, while most of the millers are not

interested to supply rice at the government

While talking to this correspondent, Pabna District Food Controller Tanvir Rahman said they were unable to buy a single bag of paddy even after two months of the procurement drive.

Moreover, after all these days they managed to purchase only 1,704 tonnes of rice, compared with the target of 12,786 tonnes, he said.

A total of only 92 millers have agreements with the district food office, and this is the major reason behind the uncertainty over fulfilling the rice procurement target in stipulated time this year, Tanvir added.

He said there are over 500 rice millers in the district, but most of them seemed reluctant to contact them. So, officials were planning to increase the supply limits of the listed millers.

Pabna District Rice Millers' Association President Idris Ali Bishwas said it is quite impossible to supply rice at the government fixed rate, as production cost of per kilo of rice is over Tk 43.

When asked why other millers went for the agreement, Idris said those who have auto-rice mills can easily supply the rice at SEE PAGE 4 COL 4

Tangail's Aag Elasin village, went to the US to tea for the last several years. study alternative medicine. After completing his education, he returned to his village and started working with different herbal items, including black cumin, trifola (amloki, horitoki and bohera), and moringa.

Throughout this long period, the multifaceted use of jute was increasing day by day in Bangladesh. Its latest offshoot is jute-leaf tea. The herbal drink has 30 percent more calories than spinach, and contains iron, vitamin C, vitamin D and anti-oxidants, according to scientists at Bangladesh Jute Research Institute (BJRI).

Topu started working with jute leaf in 2014. "I was interested in the herbs that our forefathers used as alternative medicines to fight various diseases," he said. "But then I came to know about the health benefits and prospects of 'green tea', which can be produced from jute leaf."

Topu said he has been preparing the herbal drink fully organically from native (Deshal) jute leaves. The powdered leaves are being marketed commercially in the form of perfectly hygienic and modern tea bags.

He sells the products at the Jute Diversification Promotion Centre (JDPC) of Dhaka, an autonomous government body responsible for the promotion and diversification of jute use in Bangladesh. His herbal teas are a regular feature at the fairs of JDPC. The specially made jute drinks can also be found in different shops and markets in Dhaka and Tangail.

Seema Bose Adahra, director of marketing of JDPC, said Topu's jute tea has also been sent as a gift to the guests at the Climate Summit in Glasgow, Scotland through Prime Minister Sheikh Hasina.

Ex-UP chairman jailed over embezzlement of Tk 47cr

A Cumilla court yesterday sent a former union parishad chairman to jail in connection with two cases filed over misappropriation of Tk 47 crore.

ACC Deputy Director Fazlul Haque arrested Jakir Hossain, former chairman of Pirjatrapur Union Parishad in Cumilla's Burichang upazila, yesterday and placed him before the Senior Special Judge's Court.

The ACC filed two cases against Jakir and seven others on May 10, 2022. As per the case documets, Rana Builders got a contract to develop Port Connecting Road in Chattogram. Later, the company gave the project's subcontract to Jakir's company Jakir

Enterprise. The two companies took a loan of Tk 40 crore from United Commercial Bank's Cumilla branch for the project.

Investigators later found that the loan was received using forged documents, and the bank officials were also involved in the process.

The total outstanding loan, including interests, now stands at Tk 46.32 crore.

Khoka's PS jailed for amassing Tk 1.5 crore

A Dhaka court yesterday sent Monirul Islam Khan, personal secretary to former Dhaka City Corporation mayor Sadeque Hossain Khoka, to jail for illegally amassing wealth worth Tk 1.51 crore.

The court also fined the convict Tk 84.80 lakh, in default of which, he would have to serve six more months in jail.

Meanwhile, the court acquitted the convict's wife Shahnaj Islam of charges as the allegations brought against her could not be proved.

Faruque Ahmed, assistant director of the Anti-Corruption Commission, filed a case against the couple with Ramna Police Station on January 3, According to the case statement, on March 15,

2017, the ACC issued a notice asking Monirul and his wife to submit their wealth statements within The couple submitted their wealth statements

to the ACC on April 13, 2017. After going through ne statements, the ACC found that the couple illegally earned wealth worth Tk 15,187,973. Eight prosecution witnesses testified before the

Monirul was also jailed for seven years in the Zia Charitable Trust graft case on October 29, 2018.

Public service bill placed in JS

The Public Service (Amendment) Bill, 2023 was placed in parliament yesterday. The proposed law will force autonomous, legislative, and local government bodies to take clearance from the Finance Division over financial expenditures.

State Minister for Public Administration Farhad Hossain placed the bill, which was sent to the parliamentary standing committee on the public administration ministry for scrutiny.

The committee was asked to submit its report within 30 days.

Under the existing Public Service Act, 2018 Finance Division has authority over financial matters of government entities, officials, and employees. However, it isn't clear what jurisdiction the division has over the autonomous, legislative, and local government bodies.

However, under the proposed law, public universities, Election Commission, or local bodies like city corporations and union parishads will have to take the opinion of the Finance Division over their financial expenditures.

The revision will also make it mandatory for autonomous, legislative, and local government bodies to take clearance from the finance division.

people, who have been fans or have seen his acting and directing skills. His contributions to the silver screen are immense and unforgettable.


In many ways, Aly Zaker was a pioneer and visionary. He, along with his theatre troupe, were one of the first to start selling tickets for entry to theatre shows.

Pak PM makes conditional talks offer to India

Pakistan Prime Minister Shehbaz Sharif has made a conditional offer to his Indian counterpart to open talks on all outstanding issues between them, including disputed Kashmir, which he believes could be facilitated by the United Arab Emirates (UAE).

"My message to the Indian leadership and Prime Minister Narendra Modi is let's sit down at the table and have serious and sincere talks to resolve our burning issues, like Kashmir," Sharif said in an interview with Al Arabiya news channel, telecast by Pakistan's state run TV yesterday.

However, a statement issued by Sharif's office after the interview aired added that such talks would only be possible if India restored the autonomous status in the part of Kashmir it rules that was revoked in 2019.

"Without India's revocation of this step, negotiations are not possible," it said.

The Indian foreign affairs ministry did not immediately respond to a request for comment. New Delhi has ignored such calls from Pakistan on Kashmir's status in the past. In the interview, Sharif said he had taken up the issue

with UAE President Sheikh Mohammed bin Zayed on his recent visit to the Emirates. "He's a brother of Pakistan. He also has good relations

with India. He can play a very important role to bring the two countries on the talking table," Sharif said. Sharif said the wars between the two countries brought

China population shrinks for first time in 60 yr

China's population shrank last year for the first time in more than six decades, official data showed yesterday, as the birth rate slows in the face of mounting financial pressures and shifting social attitudes. The world's most populous country is facing a looming demographic crisis as its workforce ages, which analysts warn could stymie economic growth and pile pressure on strained public coffers. Analysts point to the soaring cost of living -- as well as a growing number of women in the workforce and seeking higher education as reasons behind the slowdown. The mainland Chinese population stood at around 1,411,750,000 at the end of 2022, the National Bureau of Statistics (NBS) reported, a decrease of 850,000 from the end of the previous year. The number of births was 9.56 million, the NBS said, while the number of deaths stood at 10.41 million. The last time China's population declined was in the early 1960s, when the country was battling the worst famine in its modern history.

MAJOR ANTI-GRAFT PURGE Vietnam president Phuc resigns

Vietnam President Nguyen Xuan Phuc has resigned, state media said yesterday, after days of rumours he was about to be sacked as part of a major anticorruption drive that has seen several ministers fired. The sudden departure is a highly unusual move in communist Vietnam, where political changes are normally carefully orchestrated, with an emphasis on cautious stability.

Why this cruelty to an ordinary citizen?

Authorities must respect people's right to protest, prevent police excesses

Just when the government seems to have scored a point in its fight against US sanctions on Rab, with a visiting US official praising progress in reducing extrajudicial killings, it is painful to learn of an ordinary citizen facing extrajudicial excesses in the form of police torture. Allegedly, Md Mostakim, who last week was arrested for protesting a hike in kidney dialysis fees at the Chattogram Medical College and Hospital, was beaten mercilessly while in custody. The goal, apparently, was to teach him a lesson for "disrespecting" the officer-in-charge of the local police station when protesters were dispersed in front of the hospital.

In photos published by a national daily, his left leg is seen covered in bruises. Mostakim alleged that he had been beaten for 15-20 minutes by a cop before he secured bail on Sunday. The very nature of the case in which he and others were implicated – for "obstructing government work and attacking police", despite himself being a victim of assaults even on the protest site – smacks of excesses. The Human Rights Foundation, which fought for his bail in court, has appealed to the Inspector General of Police to take action against the policeman involved in custodial torture, and also demanded that the case be transferred to Rab, PBI or CID.

One side-effect of this incident is that an important issue like the increase in subsidised dialysis fees for the poor has been pushed into the background. This could be a reference point for how subsidy reductions in various sectors are becoming a trend, pushing up the cost of living. This could be an example of how people's out-of-pocket healthcare expenses are rising while government spending on public health is declining, despite promises to the contrary. Instead, it has become a case of random acts of cruelty and intimidation, using legal tools or official badges. Such excesses are precisely why the very name of police still conjures up feelings of dread in citizens.

The fact is, despite recent efforts to paint a picture of accountability within security agencies, the latter remain largely unaccountable, especially when it comes to violations of political rights, including the right to protest and peaceful assembly. While the government may use permission being given for protest rallies by opposition political parties as an example of democratic freedom in the country, the truth is, it doesn't come without haggling or, for activists and general citizens alike, a threat of violence and legal repercussions with police often deviating from established practices to handle street gatherings.

It goes without saying that when legitimate grievances are suppressed this way, it only leads to further shrinking of civic space. We urge the authorities to respect people's right to protest and address their grievances. They must ensure that no excesses occur in handling protests or in police custody, especially when Bangladesh is trying to mend its image in this regard. As for Md Mostakim, the case against him and others should be withdrawn, and the allegations of torture by police should be properly investigated.

A commendable initiative, indeed!

High time to make our educational institutions inclusive

We applaud Dhaka University for taking the decision to include a special quota for transgender students in its undergraduate programmes. It has done so in an attempt to promote diversity among its student body, recognising the systematic stigmatisation faced by the community. This decision comes on the heels of another notable development in recent days, when Ankita Islam became the first openly trans woman to be admitted to the university to pursue her MBA.

The decision is significant because the transgender community in Bangladesh suffers from a range of exclusionary practices, including limited access to jobs, education, legal and health services, and decision-making at the policy level. A majority of them, particularly those who identify as hijras, struggle to complete their education, ostracised by their families and society from an early age. They are denied a safe learning space, having to constantly confront harassment and bullying from classmates as well as teachers throughout their education journey. As a result, most of them eventually drop out, limiting their prospects of a future job and a stable life.

We hope DU's stance in this regard will encourage other educational institutions to follow suit, and take inclusive measures to create a safe space for members of marginalised communities. It goes without saying that they, too, deserve a dignified life, which includes the right to education.

While the government has taken some notable steps to give recognition to the transgender community of the country over the last few years, these initiatives have at times fallen short of their desired outcomes because of a fundamental failure to understand the lived realities of the community in question and a general ignorance about the fluidity of gender, diversity and sexuality. For one, there is a tendency to conflate transgender with the term "hijra", though not all hijras identify as trans, and certainly not all transgender folks identify as *hijras*.

Given the widespread confusion, hijras are often asked to "prove" their authenticity by going through intrusive physical examinations. In 2016, for instance, the government took the laudable decision to provide employment to the community; however, their employment was contingent upon a medical checkup, the process of which ended up being harassing, humiliating and dehumanising for the community members, according to a report by the Human Rights Watch. Twelve of their pictures were even published in print and online platforms, and they were shamed as being "frauds" because their bodies did not conform with our expectations.

As an academic institution we hold in high regard, with a reputed gender studies department, we hope DU will not make similar mistakes. However, we remain wary of the statement that trans people will need to provide "related papers for confirmation". We urge the authorities to make the process smooth and dignified. People who have been humiliated all their lives do not need to go through further humiliation to prove their marginalised status.

A poor dose of the right medicine

The herbal medicine prescribed by a rural kobiraj may be scientifically right, but its inadequate dosage often fails to cure the diseases of patients in the village. The same has been true of our latest monetary policy for the January June term of FY2023.

Despite all good intentions, Governor Talukder fails to change the parameters of monetary policy well enough to make a perceptible reduction in inflation and prevent the probable depletion of foreign currency reserves.

The policy brands itself as "cautiously accommodative" - a phrase akin to saying that something is "bitterly sweet." No matter what numeral tricks regarding inflation are displayed by the bureau of statistics, whose data is often disputed because of its faulty basket and cunning calculations, inflation is the number one torture for the mass whose savings are evaporating, and livelihood has come under hardship.

Even with the disputed data of BBS, the downward trend of inflation - which some policymakers are seizing with ample self-complacency – is statistically insignificant. The imperceptible downward trend of inflation is attributable to global commodity and fuel prices, and is not a credit to local policymaking, which actually fueled high prices by stubbornly clinging to the strange nine-percent lending rate, and thus letting the rich borrow banks'

money at zero real costs.

Despite all the cosmetics of the new monetary policy, that anti-theoretical nine-percent cap still prevailed by signaling that money is still as cheap as dirt for wealthy industrialists who often turn into defaulters. It signals that money is more expensive for people of the middle or lowermiddle classes, who resort to availing consumer loans for buying their durables like refrigerators, televisions, small vehicles, and furniture.

The policy twist of the nine-percent cap for capitalists and the 12-percent for fixed-income-earning consumers is an open testimony of favoritism for the super rich. The selective tightening of consumer loans is discriminatory to blisters their economy.

Usually, economists are noted for their wide differences of opinions. As the British social economist Barbara Wootton observed, when six economists gather, seven opinions emerge.

But not a single economist in Bangladesh supported the ninepercent cap on the lending rate in the face of galloping inflation. Still, the finance minister manufactured his own theory by arguing that the cap is beneficial for the economy.

The nine-percent cap was imposed in 2020, during the pandemic. But oddly, the music is still on when the Covid-induced debility has ebbed long ago. The intent of keeping this cap is to continue nourishing the tycoons at the cost of high inflation.

Recently, FBCCI business leaders met the BB governor and argued for keeping the cap to serve their interests. And the governor catered to their demands. Although he indicated that removing the cap is only a matter of time, it's hard to understand what better moment there could be to justify removing the nine-percent cap than right now. At present, no sensible country in the world has kept any such cap on lending rates as inflation the reverse repo rate. The repo rate the rate at which banks are allowed to borrow funds from the central bank has been raised by only 25 basis points, to be six percent, which is much lower than the existing call money rate. This suggests that the central bank's move to raise the policy rate is correct in its direction, but that its magnitude is farcical – an attempt to show that BB has only a theoretical understanding of how to fight inflation by raising policy

But the magnitude of 25 basis points resembles the herbal dose of miserably inadequate to make any perceptible changes in the patient's health and for inflation, respectively. If inflation goes down, it will be due

to luck and a global price reduction for oil and other commodities. BB cannot claim any credit for making it happen. Rather, its inertia towards the dirtcheap lending rate for businessmen and defaulters will keep stoking inflation. Had the nine-percent cap been dismantled, inflation would have gone down, giving some comfort to poor and middle-income people.

from which during the previous governor's regime caused the severity of the current dollar crisis and foreign exchange depletion. The governor commanded his apparatus to find the cheating of importers who accomplish money laundering by over-invoicing. Importers also resort to under-invoicing to dodge import duties, worsening Bangladesh's fiscal capacity, which is already the weakest in the region. This murky area was never diagnosed so closely as it is being done now, bringing some hope of tightening the outflow of funds. The governor should seek the nervous village kobiraj – both are magisterial power to punish some notorious importers who are largely responsible for laundering USD 8 billion annually from Bangladesh, as per World Bank data.

The government has started frantically borrowing from the central bank since its revenue collection lagged behind the target, as usual, and its sanchavpatra source has stopped laying golden eggs of late. The credit growth target in the government sector of almost 38 percent – a desperate rate never seen before in recent decades - must be curtailed if BB wants to Bangladesh Bank has missed the combat inflation. Otherwise, the central bank will remain a helpless observer of inflation that draws its vitamins from huge public sector credit and hunky industrial loans.

What will we get out of Lu's visit?

The recent visit of US Assistant Secretary of State for South and Central Asian Affairs, Donald Lu, in my opinion, was a type of stock-taking visit since, over the past few years, the relationship between the US and Bangladesh has been a source of some worry. Prior to this, a senior director from the national security council also came to Bangladesh.

In terms of the outcome, it is positive that there was an exchange of ideas and that understanding between the countries has been improved. This visit has ensured that the relationship between the two countries still stands on firm ground, despite some earlier concerns about human rights abuses by law enforcement agencies. There was a concern regarding whether or

not there would be sanctions from Bangladesh's side. These issues have

now been resolved. Another thing to note is that Donald Lu has clearly stated the expectations of his country regarding Bangladesh. He gave an indication as to what should be done to meet these expectations, too. For example, he has given an update about the sanction on Rab and indicated that the agency has improved in terms of human rights abuses and dropped hints about what more the agency should do. Lu has also expressed his expectations about the upcoming national election. He has said that the US wants to see a peaceful environment and expects a credible election. Citing the prime minister's promise to hold a free and fair election,

Lu has expressed his expectation that the premier will deliver on her promise.

Donald Lu also raised issues about labour rights and has advised on what the government should do in order to improve the labour conditions. Our country currently does not enjoy GSP privileges. Lu has given an indication as to what the government should do in terms of enacting better labour laws to meet the requirements for regaining the GSP status. There were discussions

about regional strategic issues as well. Though these discussions have not been made public, my guess is that the US wants Bangladesh to be a part of its regional strategy. Bangladesh could be a productive partner in that process. If we become a part of the Indo-Pacific Strategy and calibrate that to explore our interests, especially in the economic domain, and also to protect other national security issues from our side (such as resolving the Rohingya crisis) that would be useful to Bangladesh.

Overall, the three main dimensions which were discussed are governance issues (from elections to human rights), economic issues and bilateral business, and strategic issues. This is part of an ongoing discussion, and

any discussion is welcome as it clears the air. But the US' expectation is very clear. They want the promotion of human rights and democracy, and they will continue to push for reforms in that regard.

Donald Lu has also met the law minister and home minister. And I presume that the Digital Security Act was an issue of discussion at the meeting with the law minister. It is possible that there may be some updates and amendments to the law as a result of the US and European interest in reforming the law.

Labour rights is an urgent issue for the US as well as for us, as many of our future opportunities will be contingent on how the concerns are resolved. In terms of sanctions, there need to be more reforms in the system(s) for the existing sanctions to be considered for withdrawal.

Finally, we can say that Lu's visit was a positive one as there was an exchange of ideas and expression of appreciation of each other's position for both countries concerned. But the visit did not bear much concrete fruit besides this.

The who's and how's of allocating loss and damage funds

During the negotiations on funding for loss and damage in COP27 in Egypt last November, representatives of developed countries had a lot of reservations about such a proposal. My answer to them was that, while their questions were quite legitimate, they would only get answers after we received a political commitment from their leaders to establish the funding mechanism in the first place.

Fortunately, the leaders of all the countries agreed to establish the funding mechanism at COP27 and also to set up a Transitional Committee to address the questions that were being asked. The negotiations at COP28 in Dubai in November this year will be when we will once again agree on how to address those questions and get the funding up and running.

In the meantime, it can't hurt to share some of my own thoughts on the questions that need to be addressed.

How much money is needed?

Given the ongoing impacts of climate change, the estimates of the total losses and damages run into many trillions of US dollars. However, it is not expected that such sums of money would need to be made available, at least not immediately. So, in the short term, a few tens of billions of US dollars a year to support the poorest and most vulnerable communities would be worth targeting. It is important to note that such funds are to address loss and damage and are different from funds used for adaptation and

Where would the money come from?

There is an assumption that money would have to flow from the governments of developed countries to the governments of developing countries, but this need not be the only option. There are many ideas being floated for sourcing the money, including making polluters pay.

My own preference is for all countries to agree to impose a tax on every fossil fuel company registered in their jurisdiction and put that money into a new Global Loss and Damage Fund. This would immediately generate a lot of funds and would not even hurt the fossil fuel companies, as they would retain most of their exorbitant profits.

Who would manage the funds?

There are quite a few ways in which to manage the funds, including

the Green Climate Fund (GCF) and Adaptation Fund (AF) under the United Nations Framework Convention on Climate Change (UNFCCC), or other funds outside the UNFCCC.

My own view is that we are likely to end up with a mosaic of funding channels for different activities, some under the UNFCCC and some outside it. It will, however, require close collaboration amongst all the funding entities to ensure synergies and avoid overlaps.

Who would be eligible to receive funds?

This is a tricky question in the context of the UNFCCC since there are several groups, such as the Least Developed Countries (LDCs), the Small Island

employing existing entities such as Developing States (SIDS), as well as some countries in Africa, who are formally defined as "particularly vulnerable." But these lists exclude countries such as Pakistan, which suffered unprecedented flooding last year. So there will need to be some give and take, again in good faith, amongst the developing countries themselves as to which countries should be eligible to receive funds.

How would funds be allocated?

Besides the question of which developing countries should be deemed eligible to receive funds, deciding on the ultimate recipients at the local or community levels is also important, and they could belong to some middle-income countries as well.

In my view, this is by far the most important as well as most urgent question to be addressed, and put off for the cumbersome UNFCCC negotiations process, which will inevitably take time. Those in charge of existing funds that have already been committed, such as the Global Shield and the Loss and Damage window under the V20 Fund of the Climate Vulnerable Forum (CVF), should pay close attention to this question. The test now will be to see how quickly they are able to respond to the needs of communities already suffering from impacts of humaninduced climate change.

How can funds be accessed, and by

Accessing any of the existing channels

of funds requires an exhaustive process of applications from countries or entities, with funds typically taking years to be delivered. Addressing the needs of communities suffering from the adverse impacts of humaninduced climate change will require a nimbler and more proactive approach to taking the funds to the victims instead of waiting for applications. This is very much the domain of global humanitarian actors such as the Red Cross, Red Crescent, and the World Food Programme (WFP). It is therefore essential that humanitarian actors be brought into these discussions.

Who should coordinate actions?

As it is likely that we will end up with a mosaic of actors, some under the UNFCCC and others outside it, there is a need for someone to act as a coordinator. My advice is for the secretary general of the United Nations to appoint a special envoy for loss and damage for at least five years to coordinate between the UNFCCC, the UN OCHA, and each individual country and stakeholder.

As we have only just started facing loss and damage from humaninduced climate change, this role will become increasingly more important, requiring actions on a daily basis.

Most importantly, who pays for loss and damage from human-induced climate change?

We must always remember that for every impact that is currently occurring, whether in poorer or richer countries, the people who are paying for the losses and damages are the victims themselves. Sometimes they get assistance from their neighbours or from local and national governments, but this is usually much less than what they need. Therefore, the challenge before the UNFCCC is to get the new funding systems to help the poorest victims access funds for addressing loss and damage as quickly as possible.

Let COP28 be the place where this begins as a practice.

The risk of defaulted loans is increasing and the authorities need to be very alert to that and take action regarding the matter.

Al-Shabaab launches deadly attack on Somali military base

Al-Shabaab launched a deadly attack on a Somali military base yesterday, just a day after the government claimed a "historic victory" over the jihadists with the capture of a strategic coastal town.

There were conflicting reports about the death toll after the Islamist fighters stormed the camp in the town of Hawadley north of the capital Mogadishu. Army chief Odowaa

Tamim rediscovers his mojo

Prior to the start of the game against Rangpur Riders yesterday, Khaled Mahmud Sujon, head coach of a Khulna Tigers team still searching for a first win in the Bangladesh Premier League, was asked about his thoughts on the experienced Tamim Iqbal, who has been struggling with the bat. He replied simply: "Form is temporary but class is permanent."

At the end of the game, those words rang true as Khulna finally registered their first win with a nine-wicket triumph after Tamim smashed an unbeaten 60 to chase down a modest 130-run target at the Zahur Ahmed Chowdhury Stadium in Chattogram.

The 33-year-old has been out of action in recent times as he battles injuries, notably missing the last home series against India with a groin injury.

Interestingly, it was Tamim's first fifty Zimbabwe in August last year. Although

the left-hander was mostly sidelined over the last six months by various injuries, the fact that he had not scored 50 in his last ten innings belied his caliber.

Bangladesh's ODI skipper scored a 37ball 40 in the second game of the BPL against Chattogram Challengers, but the southpaw did not look comfortable at all.

Yesterday was a different case, with Tamim looking more assured despite being watchful initially. Finally, the stylish batter came down the track and unleashed a gorgeous inside-out shot to off-spinner Mahedi Hasan for a six over extra cover.

It was one of two sixes to go along with

four boundaries, but the most important aspect was that the innings came at a time when Khulna were desperately seeking a first win after losing three on trot.

There was no looking back for Tamim after that first maximum, with the veteran playing strokes all across the ground.

His flick off Pakistani pacer Mohammad at any level since a half-century against Haris provided a glimpse of the vintage Tamim when on song.

Despite losing Munim Shahriar at the other end, Tamim showed no intention to hold back. Alongisde young Mahmudul Hasan Joy, he added an unbeaten matchwinning 89-run stand.

Tamim also ran hard between the wickets to eke out those singles and doubles, reflecting his fitness, which has also come under the scanner since his injury. Unlike in the first three games, Tamim looked comfortable using his feet against both pacers and spinners

Tamim smashed his second six when he came charging down the track to left-arm spinner Mohmmad Nawaz, bashing the ball over long-on and hinting at a return to form as he reached his fifty off 35 balls.

It was Tamim's 24th BPL fifty and his first in this edition, but more importantly the innings was one that is bound to provide the left-hander relief.

Djokovic gets rapturous reception on return

Intense heat and torrential rain played havoc at the Australian Open on Tuesday, but Novak Djokovic and Andy Murray battled past their opponents and the elements to emerge with momentous victories.

Djokovic swept past Spain's Roberto Carballes Baena to launch his bid for

a 10th Australian Open title Tuesday, with the Serb enjoying a rousing reception following his deportation a year ago.

The 35-year-old showed few signs of the hamstring niggle he picked up in Adelaide this month as he raced to victory on Rod Laver Arena 6-3, 6-4, 6-0.

After not being able to play last year over his Covid vaccination stance, there were concerns over how he

might be received by fans in Melbourne. But, as in Adelaide, the fourth seed walked out

to loud cheers and chants of "Nole", with vocal backing during the match from a stadium awash with Serbian flags.


"Definitely this court is the most special court in my life and I couldn't ask for a better start to the tournament."

BIJOY IN PHONES Criticism follows BTRC directive

Questions over conflict of interest raised

Bangladesh Telecommunication Regulatory Commission's order to pre-install Bijoy app in all imported and locally-manufactured android phones has drawn sharp criticism.

According to the directive, all imported and locally manufactured Android smart handsets must have the app pre-installed before receiving marketing permission. Otherwise, the commission will not certify them, the directive said.

The BTRC order was issued on Friday to the relevant akeholders, including all mobile manufacturers and the president of the Bangladesh Mobile Phone Importers

Since 1988, the Bangla typing software "Bijoy" and Bangla keyboard known as the "Bijoy Keyboard" is patented to Mostafa Jabbar, posts and telecommunications division minister.

The BTRC reports to this division.

'The BTRC's directive to use Bijoy keyboard on all Android phones is another absurd, ridiculous and rightsviolating decision," said Faiz Ahmad Taiyeb, a writer on ICT, in a Facebook post.

Asked about the decision, the minister, however, said Bijoy has already been recognised as a "standard" keyboard.

He said, in 2017, Bangladesh Computer Council recommended Bijoy as a standard keyboard for smartphones and computers. Based on that recommendation, Bangladesh Standards and Testing Institution (BSTI) recognised Bijoy. The recent decision came following those recommendations.

Besides, the app will be given free of cost, he added. "It is only mandatory for the local manufacturers and

High Court blasts three lawyers

Orders to remove video from social media

The High Court yesterday blasted the president and two other lawyers Brahmanbaria District Bar Association (BDBA) for misbehaving with the judge of Nari O Shishu Nirjaton Tribunal-1 and creating chaos in the courtroom on January 2.

At the same time, the court ordered the Bangladesh Telecommunication Regulatory Commission immediately remove the videos of the incident from social media.

The manner in which the lawyers scolded the judge of Brahmanbaria is very rare in the history of the world. and if such incident continues to take place, laws and courts will not survive, said the HC bench of Justice JBM Hassan and Justice Justice Razik-Al-

The bench was holding a hearing of a contempt of court rule against BDBA President Md Tanbir Bhuiyan; Secretary (administration) Akkas Ali and lawyer Zubayer Islam.

"The court is not a place for showing powers. Don't boycott the court. Don't think of only votes..." the bench observed.

"After issuing the rule, we have gone through the precedents of different countries of the world. No incident like that of the Brahmanbaria court took place there. The incident is on January 2.

The bench added that if the lawyers don't respect the court, they will not get respect from others.

Attorney General AM Amin Uddin represented the state while a section of Supreme Court lawyers including Supreme Court Bar Association President Md Momtaz Uddin Fakir and its Secretary Md Abdun Nur Dulal appeared for the three Brahmanbaria lawyers during the hearing. Momtaz Uddin Fakir said the judge

Scientists use laser to guide lightning bolt

Scientists said Monday they have used a laser beam to guide lightning for the first time, hoping the technique will help protect against deadly bolts -- and one day maybe even trigger them.

Lightning strikes between 40-120 times a second worldwide, killing more than 4,000 people and causing billions of dollars worth of damage

every year. the protection against these bolts from above is still the humble lightning

conceived American polymath Benjamin Franklin in 1749. A team of scientists

six institutions have been working for years to use the same

idea but replace the simple metal pole with a far more sophisticated and precise laser. Now, in a study published in the journal Nature

Photonics, they describe using a laser beam shot from the top of a Swiss mountain -- to guide a lightning bolt for more than 50 metres.

'We wanted to give the first demonstration that the laser can have an influence on lightning -- and it is simplest to guide it," said Aurelien Houard, a physicist at the applied optics laboratory of the ENSTA Paris institute and the study's lead author. But for future applications "it would be even

better if we could trigger lightning," Houard told

Umrah now Tk 4,000 cheaper for Bangladeshis


