Govt doing opposite of what's needed

It can fuel inflation, intensify balance of payment pressure

REJAUL KARIM BYRON

It seems the government is doing an aboutturn from the austerity stance taken at the start of the fiscal year.

Take the case of the annual development programme. As part of the belt-tightening measures, the finance division in a notice on July 3 last year pared back the programme.

Projects were classified into A, B and C categories. The A-category projects will go on as normal, while up to 75 percent of the allocation for the B-category projects can be spent. All C-category projects were put

Now, the government is walking back from that position.

As is practice, the ADP project invariably gets revised down during the course of the year, with the chop coming from the amount allocated from foreign aid.

Given the foreign exchange reserves crunch and the narrow fiscal space, the calibration in the ADP budget was expected to be different: the foreign aid portion

would stay intact, while the government's own fund is pared back.

But it is business as usual. The original ADP is expected to be trimmed down by about 6.1 percent to Tk 231,000 crore, The Daily Star has learnt from finance ministry officials involved with the exercise.

The foreign fund portion would be slashed by about 16.4 percent to Tk 76,954

The fiscal coordination council has decided to go for an expansionary fiscal policy, according to the finance ministry

This would revive economic activities and generate employment.

"So, we have been asked not to cut down the government's own fund portion in revised ADP," said one of the officials, who insisted on anonymity to discuss private conversations.

In the ADP budget for fiscal 2022-23, Tk 149,016 crore has been allocated from the government's own fund.

Kamal unveils list of top 20 defaulters

Usual suspects missing

Finance Minister AHM Mustafa Kamal yesterday disclosed the names of the top 20 defaulters who together account for Tk 16,588 crore of soured loans.

As of September last year, the total defaulted loans in the banking sector stood at Tk 134,396 crore, which is the highest yet, according to data from the Bangladesh Bank. That is 12.3 percent of all outstanding loans.

Kamal placed the list of the top 20 loan defaulters in parliament in a scripted response to a query from ruling Awami League MP Shahiduzzaman Sarker.

CLC Power Company tops the list of defaulters with its bad loan of Tk 1,649 crore, followed by Western Marine Shipyard (Tk 1,529 crore), Remex Footwear (Tk 1,077 crore), Rising Steel Company (Tk 990 crore) and Mohammad Elias Brothers (Tk 965 crore).

Rupali Composite Leather Wire, Crescent Leathers Products, Quantum Power Systems, Saad Musa Fabrics, BR Spinning Mills, SA Oil Refinery, Maisha Property Development, Radium Composite Textile, Samannaz Super Oil, Manha Precast Technology, Asian Education, SM Steel Re-Rolling Mills, Apollo Steel Complex, Ehsan Steel Re-Rolling and Siddiqui Traders are the other big defaulters.

Kamal said the total number of defaulters in Bangladesh is 786,065.

Finance Minister AHM Mustafa Kamal placed the Universal Pension Management Bill-2023, which was passed by a voice

All citizens aged between 18 and 50, including expatriate Bangladeshis, are eligible for this scheme.

The bill seeks to bring the growing elderly population under a sustainable social safety net so they can better cope with the fallout from unemployment, disease, old age complications, or extreme poverty amid the

STUDENT INFORMATION FORM Mother's name too will do

Declares HC in landmark verdict

From now on, students can also mention the names of their mothers or legal guardians while filling out a student information form for examinations if their fathers' names

The High Court yesterday declared this in a landmark verdict on a 14-year-old writ petition, removing a gender discriminatory practice that has been a hurdle for many in pursuing education.

Using the father's name in the form was mandatory when the writ petition was filed in 2009. Now students need to name both the father and mother in the SIF form, said Prof Tapan Kumar Sarkar, chairman of Dhaka education board.

Delivering the judgement, the HC bench of Justice Naima Haider and Justice Md Khairul Alam declared illegal and unconstitutional the refusal to provide admit cards to SSC and HSC candidates who have not used their fathers' names in the student information form (SIF).

The court said students may have difficulties in mentioning father's name in the form, and if they are not allowed to fill in the form for omitting father's name, they will be deprived of education which is contrary to their fundamental rights enshrined in the constitution.

Details of the HC verdict will be known after the release of the full text of the judgment.

From slumber to whirr of machines

A Narayanganj village braced for a sea change to make way for MRT-1 depot

Pitalganj, next to the Shitalakkhya and located around 1.5km south of Kanchan Bridge in Narayanganj's Rupganj upazila, is like any other village across the country.

Quiet and serene, it has almost the same socio-economic situation like the rest, where people earn their living mostly by farming or doing small businesses.

However, that scenario is about to change completely as the government is to build a depot of the country's first ever underground metro rail line there.

Though the place will witness new heights of development, it is the villagers who will have to pay a price for it, as at least 698 households will be

Prime Minister Sheikh Hasina will inaugurate the physical work of the project on February 2, setting off a flurry of activities for the second biggest infrastructure project in Bangladesh, after the Rooppur nuclear power plant

The civil works of the Tk 52,561.43 crore project, the biggest one in the transport sector, will start with land development for the depot on 92.97 acres in Pitalganj.

Framed by DB, two men have their names cleared at last

Two men, framed by the Detective Branch of police for the possession of fake bank notes, won the legal battle they have been fighting for six vears to clear their names.

Judge Tahsin Iftekhar of the Metropolitan Special Tribunal-15 in Dhaka today acquitted Hasan Majumdar, manager of a city hotel, and Sohel Rana, chef of the same hotel, as charges brought against them could not be proved beyond doubt, said court sources.

During a raid at Hotel Bondhu in the capital's Paltan on November 6, 2016, plainclothes detectives detained the duo. The event was recorded in the hotel's security

A sub-inspector of the DB then filed a case against them with Motijheel Police Station under the Special Powers Act.

The first information report, prepared by the police, depicted a completely different story.

According to this document, the DB arrested the duo in the Fakirapool area around 4:15pm on November 6, 2016, while they were fleeing with fake bank notes worth Tk 25 lakh.

Hasan, however, alleged that the false FIR was written because he refused to give the detectives Tk 3 lakh in bribe during the raid.

The next year, Sub-Inspector Dewan Uzzal Hossain, one of the officers who conducted the raid and also the investigation officer of the case, pressed charges against Hasan and Sohel.

After the incident, the victim Hasan and his brother Hossain Majumdar also filed several complaints against nine DB men with the Police Headquarters, Dhaka Metropolitan Police, Prime Minister's Office and the home ministry, seeking a remedy.

LEOPARD TANKS FOR UKRAINE

Germany promises swift answer

Encourages allies to start training Ukrainians; Kyiv purges officials in biggest shake-up of war

Germany yesterday said it would decide "shortly" whether to authorise the export of powerful German-made Leopard battle tanks long sought by Kyiv and encouraged allies to start training Ukrainian forces to use them.

While Western nations have pledged ever more sophisticated military hardware in recent weeks to help Ukraine repel Russia's invasion, all eyes in Kyiv are on the battle

Berlin yesterday stopped short of granting permission for the transfer but underscored that a decision was imminent, provoking a defiant response from the Kremlin.

Poland also upped the ante by putting forward a formal application for the delivery of the German-made tanks from its stocks to Ukraine.

But in Kyiv, Ukrainian President Volodymyr Zelensky was battling a deepening corruption scandal within his government, sacking several officials over graft while others resigned.

Ukraine and several of its allies have been urging Germany for weeks to allow nothing good to the future relationship" the delivery of the Leopards, but a US-led between Berlin and Moscow.

meeting of Kyiv's allies in Germany last week failed to yield a decision.

German Defence Minister Boris Pistorius indicated that the moment of truth could be imminent, saying he had "expressly encouraged partner countries that have Leopard tanks that are ready for deployment to train Ukrainian forces on these tanks".

"I expect a decision to be made shortly," he added following talks with Nato Secretary General Jens Stoltenberg in Berlin.

Stoltenberg welcomed the message" from the minister because it "will take some time" to ready the tanks and train Ukrainian soldiers to use them after a decision on their delivery.

"We must provide heavier and more advanced systems to Ukraine, and we must do it faster," Stoltenberg said, adding that he expected a decision by Berlin "soon".

Moscow shows no signs of changing course in its invasion, Stoltenberg added, noting that Russia has mobilised more than 200,000 troops and is acquiring new weapons from countries like North Korea or Iran.

Kremlin spokesman Dmitry Peskov said the delivery of the tanks would "bring "They will leave a lasting mark," he

Under Germany's war weapons control rules, countries using German-made armaments are required to seek Berlin's permission if they wish to transfer them to a third party.

Poland, one of the loudest voices calling for permission to send Leopard tanks, said earlier this month it was ready to deliver 14 of them to Kyiv within the framework of an international coalition of countries.

Defence Minister Mariusz Blaszczak on Tuesday said the country had now sent in a formal request.

Five sent to jail over fraudulence

12 brick kilns fined Tk 69 lakh

One killed, two injured in Nepal quake

One person was killed and two were injured after an earthquake struck western Nepal yesterday, a local official told AFP, with authorities still searching for damage.

The 5.6-magnitude quake's epicentre was in hilly Bajura district, 400 kilometres (250 miles) west of Kathmandu, according to the US Geological Survey.

The jolt hit at around 2:43 pm (0858 GMT), with tremors felt as far away as India's capital New Delhi, where buildings briefly shook.

One woman was reported dead, two people were injured and up to 40 houses damaged, district chief Pushkar Khadka told AFP.

Five injured as explosive goes off in Moghbazar

Five people were injured when an explosive kept in a garbage container went off in Dhaka's Moghbazar area yesterday morning.

The injured were taken to Dhaka Medical College Hospital for treatment. Four of them took primary treatment, while Atiqul Islam alias Akhil, 15, was still being treated till yesterday evening.

DNCC bowing down to police's wants?

Officials ditch drive to evict police box due to 'resistance, threats' from law enforcers

Dhaka North City Corporation was forced to abandon a drive to evict a traffic-police box in the capital's Asad Gate intersection yesterday allegedly due to resistance from police and threat of arrest.

Mafizur Rahman Bhuiyan, deputy chief waste management officer (additional charge) at DNCC, said he along with four other officials started the drive, as the police box was being built on the road's median without getting permission from DNCC.

Soon after they reached the spot at 6:30am, four policemen tried to resist them. Later, around 30 officers joined, he claimed.

They rebuked and even threatened the city corporation officials, Mafizur alleged.

Mafizur then informed the matter to DNCC zone-5 Executive Officer Mutakabbir Ahmed, who after talking to police high-ups, asked the drive team to leave the spot. The city corporation officials left the area after an hour,

Contacted, Mutakabbir said the police box was constructed without permission. Police cannot do this.

Deputy Commissioner Traffic (Tejgaon division) Shahed Al Masud denied that police misbehaved and threatened to arrest the officials. "If DNCC had informed us beforehand, police would have dismantled it on their own initiative."

Swallowing yaba for a living

Smuggling drugs inside human stomach on the rise, say DNC officials after arresting 5 carriers

It takes around 4 hours to swallow 54 small packets of yaba for 41-yearold Josna Khatun. Each packet contains 50 pills.

"I gobbled those packets with Banana. I was about to vomit when I tried to swallow those. But I managed somehow, thinking of the payment that was promised to me," Josna told this correspondent after a team from the Department of Narcotics Control (DNC) arrested her from Dhaka yesterday.

Hailing from Pabna, Josna said she still bears the pain of carrying the yaba pills inside her stomach. The smugglers offered to pay Tk 10,000 for carrying a thousand pills from Cox's Bazar to Dhaka.

For the successful delivery of the 54 packets, Josna was supposed to get a payment of Tk 25,000. She went to Teknaf from Pabna two days ago after getting in touch with the syndicate.

Inside a house in Teknaf, she gobbled the packets along with four others -- Selina Khatun, 27, Jony Sheikh, 21, Md Hasan, 40, and Babul Hossain, 32.

They reached Dhaka yesterday morning on a passenger bus. The syndicate members in Dhaka were supposed to receive the five from to a hotel to bring out the tablets from their stomachs.

Based on a tip, the DNC team director of DNC, told The Daily Star.

"We are now conducting a drive to locate and arrest other members of the syndicate," he said.

Another arrestee Selina said she managed to gobble around 40 packets, which contain around 2,000 pills. She was promised a payment of Tk 20,000.

According to DNC officials, the number of cases of carrying yaba inside a human's stomach has sharply increased in recent times, compared to previous years.

'We have recovered around 4.66 lakh yaba pills in 2022. The number was 1.80 lakh in 2021. Around 35 to 40 percent of the pills were smuggled inside a human stomach, which was around 20 to 25 percent in 2021," Md Rasheduzzaman, deputy director of DNC Dhakanorth, told The Daily Star yesterday.

Earlier, pills were also smuggled inside onions, red chilis, tires, tiffin boxes, shoes, or mobile batteries. However, smugglers and carriers were getting busted following these methods, said the official.

"Despite the technique being life-threatening, syndicates have managed to get the carriers on board by promising Tk 10,000 to Tk 30,000 per consignment," he said.

On January 5 this year, the DNC (Dhaka north) arrested Shahidul Islam, 30, and his associate Mitu Akter, 29, and recovered around 7,500 pieces of yaba from their stomach.

Bangladesh must strengthen its diplomatic efforts Say foreign policy analysts on regional cooperation

As the world faces unprecedented geopolitical and economic challenges following the pandemic and the Russia-Ukraine war, Bangladesh needs to ramp up its diplomatic efforts for regional cooperation in South and Southeast Asia and beyond, say foreign policy

The observations came at a seminar, titled "Strengthening Bangladesh's Foreign Relations with Neighbours in the Evolving Global Order", organised by Bangladesh Institute of International and Strategic Studies (BIISS) yesterday.

Speakers said South Asia is one of the least integrated regions of the world. Its exports are mostly to the West and the supply chain was affected during the pandemic and the Russia-Ukraine war, which should prompt the regional countries to redefine the approaches for promoting regional trade and investment.

Bangladesh Enterprise Institute President M Humayun Kabir said generally, all countries prioritise prosperity and security in their foreign relations.

Humayun Kabir, also a former ambassador, said Bangladesh has made significant improvements in socio-economic spheres but now faces challenges as it is graduating from LDC in 2026.

He suggested coordination among various

Significantly more children died in road crashes and drowning incidents last year, when compared to the previous one, found a report of Manusher Jonno Foundation (MJF).

The report, which used newspaper reports, revealed the finding during a press conference in the capital's Jatiya Press Club yesterday.

As per the report, 196 children died in road crashes in 2022. The death toll was 96 the previous year.

The number of children who drowned to death stood at 1,419 in 2022, while it was 405 in 2021, mentioned the report. Meanwhile, the report found

"We believe the inner core rotates, relative to the Earth's surface, back and forth, like a swing," they told AFP.

"One cycle of the swing is about seven decades", meaning it changes direction roughly every 35 years, they added.

They said it previously

changed direction in the early 1970s and predicted the next about-face would be in the mid-2040s.

The researchers said this rotation roughly lines up with changes in what is called the "length of day" small variations in the exact time it takes Earth to rotate on its axis.

Amend road safety act or make new law

Demands Road Safety Coalition

The government must either incorporate a new chapter on road-safety issues into the Road Transport Act-2018 or make a new law to ensure road safety, demanded Road Safety Coalition Bangladesh yesterday.

The coalition, a platform of nine organisations working on road-safety issues, made the demand at a press conference at the capital's Jatiya Press Club, as according to it, the existing law and rules are not enough to ensure road safety.

In this regard, the coalition demanded the government either incorporate a new chapter into the existing act or enact a separate "Road Safety Act" to deal with all such

CHILDREN WITH DISABILITIES

Majority not enrolled in formal education

Says national survey

STAFF CORRESPONDENT

More than half the children with disabilities in Bangladesh are not enrolled in any formal education, according to new national-level data.

The findings come from the recently published National Survey on Persons with Disabilities (NSPD) 2021, conducted by the Bangladesh Bureau of Statistics (BBS) with technical support from Unicef, said a press release issued by Unicef yesterday.

The survey reveals that among children with disabilities (aged 5-17 years), only 65 percent are enrolled in

enrolled in secondary school. In total, communication, learning, playing or 60 percent of children with disabilities controlling behaviour. aged 5-17 years are not in education.

The survey also found that children with disabilities who do attend formal education lag academically by over two years for their age on average.

"The data from this national survey

- the first of its kind by the BBS highlights the challenges children with disabilities face growing up. The findings will support the government to formulate policies and initiatives to ensure the rights of persons with disabilities in Bangladesh," said Iftekhairul Karim, BBS project director.

According to the survey, 1.7 percent of children in Bangladesh live with one of twelve types of disability defined in the Persons with Disability Rights and Protection Act 2013, while 3.6 percent of children face functional difficulty in at least one of the domains of primary school and only 35 percent are seeing, hearing, walking, motor skills,

They issued 5,000 birth certificates breaching server' Four of racket held in port city

Chattogram police vesterday arrested four people over issuance of birth certificates illegally by breaching the government server.

Members of the counter-terrorism division of Chattogram Metropolitan Police arrested them during a drive in the port city's Patenga and EPZ

Collaborating with several organised, techsavvy criminals, a gang has issued around 5,000 birth certificates across the country, by using false information and taking huge amounts of money from people, said police.

The arrestees are Md Mostakim, 22, Md Delwar Hossain Saimon, 23, and Abdur Rahman Arif, 35. The other arrestee is a juvenile, they said.

Over 500 birth certificates were issued illegally under five wards of CCC from January 8 to January 20, using addresses of different districts. Noticing the unusual activity, Chattogram City Corporation had temporarily suspended the birth registration

CCC to allocate 115 spots for posters, set fees

The Chattogram City Corporation (CCC) will designate 115 specific spots in the port city where people can put up posters for a fee.

This decision has been taken in a bid to keep the city neat and clean, said CCC sources.

However, instead of managing the system itself, CCC will go through a tender process to select a private company for management, they said, adding that the decision was made in an internal meeting of CCC's conservancy department on Monday.

Contacted, CCC Chief Conservancy Officer Abul Hashem said the tender would be floated by publishing a circular in newspapers in a day or

"The highest bidder would be selected through the tender. The selected company would set up steel structures of 10 feet by 6 feet in the dedicated spots and realise fees from individuals or organisations putting up posters," he said. "The fee would be fixed by CCC," he added.

Hashem said a fine would be imposed on those who paste posters beyond the specific spots. A part of the revenue from the fees will go to

In 2021 alone, climate-related disasters internally displaced more than 23.7 million people, while many others fled their countries altogether.

Power returns to Pakistan after outage

AFP, Islamabad

The national power grid was restored in Pakistan, the energy minister said yesterday, a day after a nationwide breakdown left most of the country's 220 million people without electricity and caused tens of millions of dollars in industry losses.

The outage started around 7:30 am (0230 GMT) on Monday, a failure linked to a cost-cutting measure as Pakistan grapples with an economic crisis. Energy Minister Khur-

ram Dastgir Khan said the grid was repaired at around 5:15 am but load-shedding would continue over the next two days as coal and nuclear plants were brought back online.

'There is a need to invest in the energy sector, especially to improve the distribution system, which has long been neglected," he told reporters in Islamabad.

Seven dead in new mass shooting

AFP, Half Moon Bay

A suspected gunman was in custody Monday over the killing of seven people in a rural community in northern California, just two days after a mass shooting at a Lunar New Year celebration near Los Angeles.

The latest bloodshed occurred at two farms around Half Moon Bay, a coastal community south of San Francisco.

San Mateo County Sheriff Christina Corpus said seven people were killed and one wounded in the twin shootings, and that a 67-year-old Half Moon Bay resident named Chunli Zhao had been taken into custody.

Reports said the dead were Chinese farmworkers, and that Zhao had worked at one of the farms.

Corpus said deputies had been dispatched to two nurseries around Half Moon Bay, a rural spot known for surfing contests and a pumpkin festival, around midafternoon on Monday.

Four people were dead at one of them and one was critically wounded, while three more fatally wounded victims were found at a second location.

Corpus said children were present at one of the sites. "It was in the afternoon when kids were out of school and for children to witness it is unspeakable," she said.

Corpus said Zhou then drove to a sheriff's substation in Half Moon Bay, where ABC7 crews captured dramatic footage of him being pulled to the ground by armed

At the second shooting location, a short distance from the mushroom farm where four people were killed, sheriff's deputies' cars packed a roadside business plaza, home to shops offering party rentals, landscaping supplies and other services.

Ardern makes last bow as NZ PM

New Zealand prime minister Jacinda Ardern said yesterday she was grateful for her time in office, insisting that a sustained barrage of online abuse was not the reason for her shock resignation.

The 42-year-old said last week she no longer had "enough in the tank" after a turbulent five years, during which she steered the country through natural disasters, its worst-ever terror

attack and the Covid-19 pandemic. Chris Hipkins, who will take over as prime minister, has said Ardern experienced "utterly abhorrent" abuse while leading the country. Ardern however said she would not describe it that way.

While on her last public engagement as prime minister, visiting the Maori settlement of Ratana in the North Island, she said she would "hate" for her departure to be seen as "a negative commentary on New Zealand"

"I leave feeling gratitude for having this wonderful role for so many years," she told reporters from the birthplace of one of the country's most influential indigenous

political movements. The popularity of Ardern's Labour government has soured in recent months, hampered by a looming recession and a resurgent conservative opposition.

Hipkins will be sworn in as prime minister on Wednesday, saying it was "bittersweet" to replace his friend of 20 years.

"I'm really honoured to take on the role, but Jacinda is also a very good friend of mine," he told reporters vesterday. Hipkins, 44, admitted there were "moments when it

sinks in, and moments when it doesn't feel quite real". Ardern said she would now be stepping back from domestic politics, and offered some advice for Hipkins.

China offers debt aid to crisis-hit Sri Lanka

Colombo sources unclear if Beijing's letter will be enough for IMF

The Export-Import Bank of China has offered Sri Lanka a two-year moratorium on its debt and said it will support the country's efforts to secure a \$2.9 billion loan from the International Monetary Fund, according to a letter reviewed by

UN aid chief raises concerns with Taliban

The United Nations' aid chief visited Kabul on Monday and raised concerns over women's education and work the Taliban administration's acting minister of foreign affairs, Afghan ministry statement said.

The vulnerable need food support

Why cut back on public food distribution programmes when they are needed the most?

That ordinary people in Bangladesh are struggling with a cost of living crisis seems like an obvious statement to make. In recent months, this daily has, many times, reported on the soaring prices of essentials, energy and fuel price hikes, and growing food insecurity for households struggling to deal with

However, it seems that this struggle is not so obvious to our policymakers. Why else would they, instead of scaling up public food distribution programmes for the poor, be cutting back on them instead? Yet, according to the food ministry's own data, that is exactly what has happened. The amount of rice given out in this fiscal year so far – 15 lakh tonnes – is down by six percent compared to the previous year.

Just a cursory look at the numbers demonstrates how misguided this is. In December, inflation stood at 8.71 percent (8.86 percent in rural areas), and economic forecasts suggest it is likely to go up further. During the same period, the wage rate grew at 7.03 percent, meaning even less disposable income in people's hands. And, in a report released in the same month, the Food and Agriculture Organization (FAO) listed Bangladesh as one of 45 countries that require external assistance for food a result of severe localised food insecurity, created by a perfect storm of economic constraints, climatic upheavals, and high prices of important food items.

In such a situation, ensuring food security should be a top priority for the government. In fact, in November last year, the prime minister said as much, and instructed Bangladesh Bank to intervene if any bank faced a dollar shortage while opening letters of credit for importing food, fertiliser, and other agricultural inputs. All of these measures were meant to ensure uninterrupted food supply; yet, a top official of the Directorate General of Food cited supply chain disruptions, brought on by the pandemic and the Russia-Ukraine war, as one of the reasons behind reduced food distribution.

However, this excuse does not hold up when we consider that the government currently has 19 lakh metric tonnes of food stock, whereas 12 lakh is considered adequate. While it is true that wheat stocks have been disrupted, and it may explain why the government has scaled back wheat distribution by 27.5 percent, why hasn't this been replaced with rice instead?

In fact, the same official also said that the government saved about 75,000 tonnes of rice after getting rid of "fake beneficiaries" who were taking advantage of food distribution programmes. So, why has this surplus not been given to the people who really need them?

Whenever the issue of food insecurity has come up, government officials have provided reassurances of having sufficient food stock in hand. So it is beyond our comprehension why, in this time of need, authorities have failed to expand social safety nets and provide adequate food support to vulnerable populations. It is imperative that the government expand public expenditure and implement pro-poor policies. While long-term policies must be there to ensure uninterrupted food supply, in the short run, authorities must provide immediate food support to the people who need it the most.

Will Nadia's tragic death change anything?

Road safety remains a neglected issue

More than four years after the Road Safety Movement, where the death of two students in a road crash led to mass protests and pushed authorities to formulate the Road Transport Act (RTA) 2018, we are deeply saddened to witness the same kinds of unjust and tragic deaths continue to occur on our roads. The latest victim is Nadia Sultana, a 19-year-old student of Northern University, who was killed on January 23 when a bus of Victor Paribahan hit the motorbike she was on near Jamuna Future Park in the capital's Bhatara area.

After her death, hundreds of students blocked roads with their demands, which included arrests of the driver and helper, and compensation for the victim's family. The question is, how many more times will we have to see the same events be repeated? Why are people still needlessly dying in road crashes?

Despite government promises to seriously and urgently deal with the issue, the country continues to witness an alarming surge in road crashes and deaths, year after year. According to Jatri Kalyan Samity, 9,951 people were killed in 6,749 road crashes in 2022, while the number of deaths and crashes, reported by the Road Safety Foundation, were 7,713 and 6,829 respectively. Last year's numbers were much higher compared to 2021.

What have our transport authorities done to check the rising number of road crashes? Apparently, nothing noticeable. They have not only failed to check the number of unfit and unregistered vehicles on the roads, but have also been largely unable to take underage and unlicensed drivers off the roads. Although the driver and helper of the bus that killed Nadia have been apprehended, we are yet to know any details regarding the driver's license, his ability to operate the bus, and the fitness of the vehicle itself.

However, the issue here is not just the culpability of one driver or the fitness of one vehicle, but the fact that the entire transport industry is highly undisciplined and mostly unregulated. It is unacceptable that, this entire time, the RTA has been practically defunct in the absence of necessary rules, which were formulated only last month. How can there be change if the laws to bring about change are not enforced properly? The last four years of inaction have cost the country dearly, and have brought into serious question the government's ability and will to hold those responsible to account.

We urge the authorities to bring the alleged killers of Nadia to justice and to compensate her family according to the RTA 2018. We are also keenly aware that, to this day, the authorities have more or less failed in carrying out their responsibilities in upholding said law. Will the government finally take action, or will we only continue to witness history repeat itself?



Now that we have stepped into a new year, it may be time to take a brief pause from our hectic schedule. Not to reminisce about the beach vacation in Thailand or the shopping spree in India, but to take a peep into a post-Covid world. Personally, I would like to assess whether or not I have made the life choices that I thought I would once the tsunami subsides. Am I at a place that I visualised I would be in – a less frenzied pace, a sharper awareness of our blessings, and a deeper appreciation of "others" and their needs?

Covid has not just been a deadly virus that spread in our bodies, but much more. It crept into our souls and shook our inner core, giving us a chance to closely examine the technology-driven world we created with the idea that it will make us, humans, invincible. The pandemic extracted a high toll, especially from the underprivileged. Towns and megacities of the world shut businesses and sent working class citizens back to jobless uncertainty. The top few sat in the comfort of their homes, maybe not worrying about the next meal, but counting the minutes and days of unstructured time in the absence of social interactions and family reunions. Barred from hugging an old friend or kissing a grandchild, our material possessions, closeted in lonely houses, became meaningless. And we realised how we are all interconnected and cannot live our dreams in a bubble. Many thus reflected on the value of compassion and sharing, with the resolute intention of severing their ties with the past and creating a more inclusive and equitable world.

But once Covid somewhat abated, did we succeed in crossing the mental Rubicon? If anything, 2022 indicated that the spiritual lessons learnt lost out to the allure and the glitter of a hardcore material world. And is compassion dependent on wealth and resources, or can it flow spontaneously in the way the homeless woman shared her blanket with the dog?



Intriguingly, some of these same MNCs are listed in equity markets of other countries such as India. So how are the incentives offered by other countries different? An obvious strategy is to expand the tax-differential relative to private firms. The existing tax gap stands at On top of that, MNCs likely have good long-term relationships with domestic banks, further reducing their need to enter the equity market.

Finally, I suspect an additional reason has to do with financial reporting. Since private firms have greater leeway to hide their true income, mere widening of the tax gap may not be a sufficient incentive. Regular and more thorough audits could help create a more level-playing field between public and private firms.

Another key reason behind the stock market-real economy disconnect is the dearth of institutional investors, such as mutual funds. The size of the mutual fund sector in Bangladesh is less than one percent of our GDP. Mutual funds are an important source of financial intermediation, which provides households with access to a diversified portfolio of stocks at low cost. In the US, for example, households often invest their retirement money in mutual funds. In fact, mutual funds can serve as a vital source of financial inclusion by giving relatively less experienced and lower-income households access to public equities that are managed by professionals. Greater presence of professional fund managers will reduce the importance of "rumour-based" trading, and bring greater harmony between real economic conditions and equity prices.

Regulators in Bangladesh should take notes from best practices around the globe to help develop this sector further, particularly in terms of the ease with which new funds can be opened, simplifying existing rules, and providing fund managers greater discretion in their investment decisions.

A vibrant financial sector requires both banks and a stock market to efficiently intermediate capital and accelerate financial inclusion. Unless policymakers address these structural issues, the stock market-real economy disconnect will become a perennial problem. Ultimately, ordinary citizens pay the price of an undeveloped stock

Is global governance failing to deliver climate commitments?

deliver on the climate commitments made by global leaders at the historic COP21 and COP26 of the United Nations Framework Convention on Climate Change (UNFCCC), several institutions will have to be reformed and improved to benefit the Global South, where people are facing economic, social and environmental challenges, and are most vulnerable to impacts of climate change. One of the reasons for international environmental and climate governance not delivering on the aspirations of the world is that they are very complex, and not only includes several organisations, but also agreements and treaties, policies and measures, rules, procedures, financing frameworks, and technology mechanisms. Environmental governance also connects with other areas of global governance, such as international trade.

Unfortunately, despite these initiatives, environmental degradation continues. Deforestation, desertification, air and water pollution, and biodiversity loss are increasing, with the most dangerous threat being that of climate change.

One of the key global governance mechanisms for addressing this is the UNFCCC, which provides the framework for international action for the Paris Climate Agreement 2015. In line with the Paris Agreement to limit global warming to well below 2 degrees Celsius, commitments of greenhouse gas emissions were made at COP26 in December 2021. More than 150 countries have set deadlines for achieving net zero emissions by the middle of the century, and submitted their plans on how to do so and by how much with their target periods.

However, it did not take even a year after COP26 for some advanced countries to move away from their

climate pledges. In the wake of the Russia-Ukraine war, even the champions of net zero have moved backwards and resorted to coal for energy. This gives an ominous signal to the world. Such retreat from climate commitments is not going to fulfil the global ambition for net zero by 2050. Indeed, the Glasgow targets were not enough to meet ambitions for emission reductions. According to UN emissions gap estimates, despite these commitments, the world will see a 2.5 degrees Celsius temperature rise by the end of the century. Hence, enhanced commitments are needed, which must be stronger than what was set at COP26.

In 2009, at COP15, developed countries committed to USD 100 billion per year by 2020 for vulnerable climate-affected countries, which was later extended till 2025. However, till 2020, about USD 83 billion has been mobilised. Moreover, the distribution of funds is biased towards mitigation activities, which comprise 58 percent of total climate funds. But the Global South needs

more adaptation funds to cope with environmental challenges to lives and livelihoods. Climate vulnerable, small island, least developed and developing countries need funds for early warning systems of natural disasters, floods and cyclones, as well as funds for food security.

There is also demand for separate financing facilities exclusively for loss and damage in climate vulnerable countries. For a long time, developed countries refused to recognise even the concept of loss and damage, which is the compensation to be paid by them for historical actions towards causing climate change. Recently, there has been a recognition of this responsibility by some developed countries, and a few also made commitments at COP27 to pay for loss and damage.

There is also a commitment by developed countries to support climate action in LDCs and developing countries through technology transfer under the traderelated intellectual property rights (TRIPS) agreement. But one observes slow progress in this case, too.

Several global organisations are part of climate governance, as they have linkages with environmental and climate issues. The World Trade Organisation (WTO) is one example. International trade has impacts on climate change, and vice versa. Countries can also address climate challenges through trade cooperation and trade policy measures. However, due to the slow progress of WTO negotiations, countries are not able to benefit from climate supportive trade measures.

Given that there are already so many institutions that deal with environmental and climate issues, there is no need for new ones. Rather, the existing ones should be strengthened and made more effective and functional. Countries in the Global South can work together to make this happen. There is a need for a thorough assessment of measures for each organisation to avoid and resolve any conflicting between organisations. Therefore, a major task of the Global South is to ensure more transparency, comparability, compatibility, and harmonisation of environmental and climate measures. This will facilitate smooth implementation of climate promises.

PITCHING THE POLOS

The centuries-old Polo Bawa festival is one deeprooted into the Bangalee culture. Every year during winter, beginning from the Bangla month of Poush till Maagh, when the water levels of various water bodies go down, fishermen and villagers across the country gather near various water bodies in their respective districts to catch fish together. Celebrated for over 200 years, the month-long festival is announced a week earlier with tin drums to invite everyone. Azarenka beats 'fears of failing'

Victoria Azarenka reached her first Australian Open semi-final since winning the title in 2013, then opened up Tuesday about overcoming "anxiety" and "fears of failing"

The Belarusian, who won back-to-back Australian Opens in 2012 and 2013, knocked out third seed Jessica Pegula 6-4, 6-1 on Tuesday.

The 24th seed outlasted her American opponent in a marathon 64-minute first set before running away with the second to set up a last-four encounter against Wimbledon champion Elena Rybakina at Melbourne Park.

Asked about her battles with nerves and anxiety, Azarenka detailed what she had been through in recent years and how it had held her back from winning another

"I don't think you recognise it right away. I think it builds up until you hit kind of a pretty bad spot where nothing kind of makes sense," she told reporters. "You feel kind of lost. I was at the point where I couldn't

find anything that I feel good about myself, not like even one sentence. Asked what her biggest worries were, Azarenka gave a

blunt answer. "Fears of failing is a big one. To not be able to do what I

want to do," she said. "I've had panic attacks before." The Belarusian said she now has a process to cope when

the nerves rear up, and she has cut a noticeably calmer figure at Melbourne Park this year.

"I kind of tried to take it more simple. Kind of working through it," said the 33-year-old Azarenka.



"I'm pretty happy that the process that I'm going through makes me feel confident about myself, happy about myself, and helps me to be more open, be more accepting, be compassionate.

"Compassionate' was a very hard word for me to

Pegula was in her third Australian Open quarter-final and had never reached the semi-finals of a Slam in four previous attempts, failing to win a set in any of them.

It was a sorry statistic that was to be extended under the roof at Rod Laver Arena.

"Well, it hurts to beat her because I always want her to do well," said Azarenka, who is close friends with Pegula.

"Today I knew I have to play fast, I have to not give her portunity to step in, I have to mix it up because don't there's nobody better than Jess, she just doesn't

Pegula was immediately put under the pump by the relentless groundstrokes of her opponent.

Azarenka sped into an early 3-0 lead then forced Pegula to save six break points in an attritional 10-minute fourth game. She saved two set points on her serve to get to 3-5, two more in the next game, broke back to 4-5 but eventually succumbed after 64 relentlessly physical minutes.

Early breaks were exchanged in the second set before Azarenka made the decisive move. She broke for 3-1 and held her own service game, with an increasingly frustrated Pegula complaining to her player's box.

"I don't know what to do. The ball's not going anywhere,"

Serving for the match, Azarenka brought up two match points but only needed one as she powered through in 1hr 33min.



Shanto answers his critics

He is probably the most criticised Bangladeshi cricketer on social media, but Najmul Hossain Shanto has seemingly managed to dealt with the situation and transform himself into a consistent performer in recent times, reflecting the player's strong character.

The left-hander, who has been in good touch in the ongoing Bangladesh Premier League, helped Sylhet Strikers clinch a crucial tworun win over Fortune Barishal with a brilliant unbeaten fifty under tremendous pressure yesterday.

Shanto has shown great consistency since finishing as Bangladesh's leading run-getter in the ICC T20 World Cup last year in Australia after scoring 180 runs.

With two fifties from seven games, Shanto is now the thirdhighest run-getter in this edition of the BPL, having scored 281 runs average of 56.20. However despite his performance on the field, he has often been criticised on social media, which, Shanto conceded, affected him mentally at times.



ERRORS IN TEXTBOOKS Govt to form 2 probe bodies

Website link to allow anyone to give feedback, point out mistakes in the books

Education Minister Dipu Moni yesterday said the government would form two probe committees to identify mistakes in textbooks and ascertain whether the errors were the result of any negligence by National Curriculum and Textbook Board (NCTB) officials.

One of those committees would consist of specialists in education, health and religion.

A website link would be made available so that anyone from anywhere can give opinions, file objections and make recommendations, Dipu Moni said at a press conference on the new curriculum at the capital's International Mother Language Institute.

"The expert committee will review all these andtake best decisions. If any error is found, it will definitely be corrected," she added.

The minister said another committee would probe whether there was any negligence by NCTB officials.

"We will definitely take strict actions if there is evidence of negligence by anyone," she said, adding that the ministry would provide further details on the committees on Sunday.

Dipu Moni urged all to inform the government about mistakes in textbooks.

She said there are some people who are beating about the bush. "Those might not have read the textbooks at all."

"Being human beings, we can make errors. I think we should not be ashamed of apologising for making errors. But we will have to see whether any mistake was made deliberately, whether we tried to create instability in the society or whether we humiliated anyone."

Climate change makes Bangladesh more vulnerable

Says UN report

Human trafficking cases in Bangladesh and the Philippines increased after devastating cyclones and typhoons displaced millions, the United Nations said vesterday.

"Climate change is increasing vulnerability to trafficking," the United Nations Office on Drugs and Crime (UNODC) said in a report.

"While a systematic global analysis of the impact of climate change in trafficking in persons is missing, community level studies in different parts of the world point at weather induced disasters as root causes for

trafficking in persons," it said.

The report is based on data from 141 countries collected from 2017 to 2020, and the analysis of 800 court cases.

Evidence is emerging that climaterelated disasters are becoming a cause of human trafficking as criminal gangs exploit a growing number of uprooted people, the UN drugs agency

The continuing war in Ukraine is also another risk factor for increased human trafficking, the UNODC said in

The Covid-19 pandemic limited the ability to detect cases, especially in low-income countries in Asia, Latin America and Africa, the report added. Bangladesh acceded to the UN

Protocol to Prevent, Suppress and Punish Trafficking in Persons,

Especially Women and Children in Bangladesh acceded and to the UN Protocol to legislation Prevent, Suppress and trafficking in persons Punish Trafficking in in Bangladesh Section 3 of the Women and Children Prevention Suppression in 2019.

Human Trafficking Act (2012) - covers all forms of trafficking indicated in the Protocol.

In 2020, national authorities recorded 730 cases of trafficking in persons in Bangladesh. In 2017 and 2018, the Bangladeshi Police reported 778 and 561 cases of trafficking in persons for each year respectively.

A group of people from Myanmar have filed a criminal complaint in Germany accusing their country's military genocide, war crimes and crimes against humanity, a rights organisation said yesterday.

The case was lodged with Germany's Federal Public Prosecutor General under the principle of universal jurisdiction, which allows the prosecution of certain grave crimes regardless of where they took place, and has been used to try Syrians over atrocities committed during the civil

The 16 complainants live in several countries, including Myanmar, and are drawn from a crosssection of the country's numerous ethnic groups

including Rohingya, the dominant Burman and minority communities.

Earth's inner core may have started spinning other way

Far below our feet, a giant may have started moving against us.

Earth's inner core, a hot iron ball the size of Pluto, has stopped spinning in the same direction as

the rest of the planet and might even be rotating the other way, according to

a research. R o u g h l y , 0 0 0 kilometres (3.100)miles) below the surface we live on, this

"planet within the planet" can independently because it floats in the liquid metal outer core.

Exactly how the inner core rotates has been a matter of debate between scientists.

What little we know about the inner core comes from measuring the tiny differences in seismic waves -- created by earthquakes or sometimes nuclear explosions -- as they pass through the middle of the Earth.

Seeking to track the inner core's movements, the new research, published in the journal Nature Geoscience recently, analysed seismic waves from repeating earthquakes over the last six decades.

The study's authors, Xiaodong Song and Yi Yang of China's Peking University, said they found that the inner core's rotation "came to near halt around 2009 and then turned in an opposite

Classified docs found at former **US VP Mike** Pence's home

Documents marked as classified were discovered at former US Vice President Mike Pence's Indiana home last week, and he has turned those classified records over to the FBI, his representative said in letters seen by Reuters.

Pence's representative sent a letter to the National Archives notifying them of the documents and in a separate letter said the FBI came to the former vice president's home to collect the documents.

The discovery puts Pence in the company of his former boss, former President Donald Trump, and President Joe Biden after documents with classified markings were found at their residences.

Pence's representative, Greg Jacob, said in a letter dated Jan. 18 to the National Archives that "out of an abundance of caution" Pence had engaged outside counsel to review records stored in his home after reports about the materials found at Biden's residence.
