This year, 901 units and 38 pavilions of 654 organisations have been allocated, he added.

He also said the book fair will be open from 3:00pm to 9:00pm every day from February 1 to February 28. It will run from 11:00am to 9:00pm on holidays. On February 21, the fair will start at 8:00am and will continue till 9:00pm. He said that a seminar will be held on the main stage of the book fair at 4:00pm every day. There will be a cultural programme every evening throughout the month.
