Internal GCC enquiry upon directive of LGRD ministry exposes countless misdeeds of suspended mayor Zahangir Alam

He and his cronies spared nothing. Not even the funds meant for feeding the destitute on National Mourning Day.

Their hands reached into every cookie jar in Gazipur City Corporation. Mohammad Zahangir Alam, the suspended Gazipur mayor, and associates left imprints of corruption everywhere -- from major public operations like distribution of GCC grants, sand-filling, widening of roads and cleaning of sewer lines to small-scale activities like catering for the devotees at Biswa Ijtema.

They did not sit out even when it came to the money earmarked for the celebration of Bangabandhu's birth centenary.

Myriad corruption allegations against Zahangir were meticulously detailed in an internal enquiry report of the GCC.

A probe committee, formed by the LGRD and cooperatives ministry, had the GCC prepare the report, which included observations alongside the findings. The Daily Star has the documentsthat were submitted to the ministry.

Gazipur City Corporation spent Tk 12.43 crore for clearing garbage in eight areas over three fiscal years: (2018-2019, 2019-2020 and 2020-

The bills were paid without any garbage being cleared in those areas. The GCC investigation report chronicles how all laws were disregarded and corruption became all-encompassing on his watch.

Zahangir, also the expelled general secretary of the Gazipur city Awami League, hogged headlines again after the ruling party granted him amnesty on January 21 following a mercy petition.

The International Monetary Fund has laid out 20 conditions for Bangladesh for its \$4.7 billion loan programme aimed at restoring macroeconomic stability, accelerating overdue macroeconomic reforms and

targets that must be met. Four of the conditions are indicative targets (ITs), which are similar to QPCs in that those are quantitative indicators to assess progress in meeting a programme's objectives.

"A modest buildup in NIR, as a QPC (floor), is targeted in the first year of the programme, with further increases programmed

over the medium term, to cover four months of prospective imports. Greater exchange rate flexibility will help accumulate reserves, strengthen external buffers, and build resilience,' said the staff report prepared for the executive board's consideration.

For program monitoring purposes, the NIR is defined as gross international reserves minus reserve-related liabilities.

Govt seeks revision of deal with Adani Power

Delhi says it is not involved

The government has sought to revise its power purchase agreement with Adani Power in light of the skyrocketing price of coal.

The development was confirmed by multiple officials of the Bangladesh Power Development Board (PDB), who insisted on anonymity due to the sensitivity of the matter.

The power purchase agreement signed with Adani in November 2017 stipulates that Bangladesh will pay the market price for coal that would be used to fire the power plant in Jharkhand, India, reports The Washington Post, which got three industry experts to review the confidential 163-page agreement.

Other agreements with foreign power suppliers, also seen by The Post, include clauses that would put a cap on the prices Bangladesh pay if the cost of coal skyrockets.

In December last year, the price per metric tonne of Australian coal was \$379.2 on average, according to the World Bank commodity price data of January. In 2020, it was \$60.8.

The coal for the power plant will probably be supplied by Adani's Carmichael mine in Australia, The Post said.

"Industry analysts say the coal will probably come on Adani ships to an Adani-owned port in eastern India, then arrive at the plant on a stretch of Adani-built rail. The electricity generated will be sent to the border over an Adani-built high-voltage line. Under the contract, shipping and transmission costs will be passed on to Bangladesh," the report added.

The request for the review of the power purchase agreement came after Adani Power sent a request to PDB, which would be buying all the power generated by the plant, to issue a demand note that it can present

SIX BY-ELECTIONS

Public apathy to blame for low turnout

Say experts

The turnout of 16 percent voters on Wednesday's by-polls to Brahmanbaria-2 was the lowest in any by-election held in the last four years, excluding the ones held amid coronavirus restrictions.

Turnouts for Bogura-4 and -6, Chapainawabganj-2 and -3 by-polls held the same day were among the lowest, according to Election Commission (EC) data.

However, voter turnout in Thakurgaon-3 was one of the highest since the 11th national polls held on December

Experts blame the absence of participatory and competitive elections and the erosion of people's trust in the EC because of its failure to hold the last two general elections in a free and fair manner for the people's apparent nonchalance towards voting.

However, the EC officials said BNP's absence in the elections and the lack of an Awami League candidate in three constituencies were the reasons why voter turnout was low. Besides, people are aware that the individuals elected in the by-polls will get to be lawmakers for less than a year.

PVT HAJJ PACKAGE Cost goes up by Tk 1.5 lakh

The cost of performing hajj this year under a private agency will be at least Tk 6.72 lakh, about Tk 1.5 lakh more than the minimum cost last year.

Besides, a pilgrim will have to pay an additional sum to the Islamic Development Bank in Saudi Arabia for a sacrificial animal, said the Hajj Agencies Association of Bangladesh (HAAB), which has around 1,500 members.

This year, 1,27,198 people will get to perform Hajj from Bangladesh.

Around 15,000 of them will perform hajj under the government management and the rest under private management, the association told a press conference.

The cost of pilgrimage under the government management reached Tk 6.83 lakh this year, the religious affairs ministry announced earlier.

Announcing the hajj packages yesterday, HAAB President M Shahadat Hossain Taslim said every pilgrim taking the base package will be accommodated at a maximum distance of 1.5km from the boundary of the outer premises of the Holy Haram Sharif.

Any additional fees imposed by the Saudi Government will be paid by the pilgrim, he said.

Shop owner stabbed to death

A man was stabbed to death by unidentified criminals in Sreenagar upazila of Munshiganj on Wednesday night, said police.

Satyaranjan Dutta, 64, owned an animal feed store, near the M Rahman shopping complex in the upazila.

Every evening, after closing his shop, he returned home around the same time. When he did not get home at his usual time on Wednesday night, his family started looking for him.

Satyaranjan was eventually found critically wounded next to the graveyard near his house in Jushurgaon area of Patabhog union around 9:30pm.

H was rescued and taken to the Sreenagar Upazila Health Complex, where the on-duty doctor declared

The victim's brother Adhir Dutta, also the general secretary of the Upazila Puja Celebration Committee, said, he was in Dhaka when he heard about the incident.

"By the time I reached the hospital, my brother was already dead!

"I suspect criminals planned the attack on my brother. But, I don't understand why they would kill him. We don't have enmity with anyone. We did not even have any recent quarrels with anyone," he added.

Police said the victim's body bore multiple stab injuries.

Speaking to this newspaper, Aminul Islam, officer-in-charge (OC) of the Sreenagar Police Station, said, "An autopsy of the victim's body has been done. A case will soon be filed over the incident."

Additional Contacted, Superintendent of Police (Sreenagar Circle) Md Tofail Hossain Sarkar, said, "It appears as though the murder was a planned one. So far, we do not have a lead. But, we are investigating the incident from all angles.

"We will soon get a lead. We have some suspects. But no one has been arrested. A case has been drafted and will be registered soon."

Russia keeps up pressure in eastern Ukraine

Three killed, 18 injured in missile strike on Donetsk apartments; Zelensky urges more sanctions against Moscow

Ukrainian President Volodymyr Zelensky yesterday urged EU leaders during talks in Kyiv to slap more sanctions on Russia, as Moscow's forces pressed their offensive in eastern Ukraine and fired missiles into the city of Kramatorsk near the front line.

One missile destroyed an apartment building late on Wednesday in Kramatorsk of Donetsk, killing at least three people and wounding 18, police said, while Russia said yesterday it had struck US-made rocket launchers in the area.

The head of the European Commission pledged more EU aid for Ukraine as she arrived in Kyiv by train along with more than a dozen other senior EU officials for two days of talks seen as key to Ukraine's hopes of one day joining the bloc.

The West has imposed sweeping sanctions on Russia since its invasion of Ukraine on February 24 last year, aiming to cripple its ability to wage a war that has devastated Ukrainian cities and towns, killed tens of thousands of people and forced millions to flee their homes.

Zelensky called for more sanctions, saying the pace had "slightly slowed" of late and that Moscow was adapting to

Von der Leyen said the EU would have a new package of sanctions in place for the first anniversary of the war, the biggest armed conflict in Europe since World War

But she avoided any commitment to fast-track Ukraine's EU membership bid, which is expected to take years.

Meanwhile, President Vladimir Putin said yesterday that Russia is being threatened by German tanks "again" as it was during World War II, warning that Moscow is ready to respond to aggression from the West.

Speaking at events marking the 80th anniversary of the Red Army's victory over Nazi Germany in Stalingrad, Putin drew parallels between the Soviet Union's fight in World War II and Moscow's intervention

14kg gold seized at Dhaka airport

Customs officials yesterday seized 120 gold bars worth around Tk 13.5 crore at the capital's Hazrat Shahjalal International Airport.

Following a tip-off, a team of customs officials raided a bus that was transporting passengers from an aircraft to the terminal area and found the gold bars, weighing around 14 kgs, taped behind a passenger seat, said Syed Mukaddes, deputy commissioner (preventive) of Customs House.

"We have detained the driver Harunur Rashid. We suspect he is involved in a smuggling ring." A case is being filed in this regard, he added.

3 arrested for stealing copper wire from Rampal power plant

Ansar and VDP members early yesterday detained three men in Bagerhat and recovered nine kgs of copper wire from their possession near the Rampal Thermal Power Plant.

Mamun Akon, 23, Billal Sheikh, 20, and Imran Sheikh, 21, were apprehended near the main entrance of the plant, said Chandan Debnath, commander of 3 Ansar Battalion.

The detainees and the recovered goods were handed over to the Rampal Police Station. A case was also filed with the station.

Over the last 10 months, different teams of the battalion detained 38 smugglers and recovered goods worth around Tk 58 lakh in 52 raids conducted at the power plant, the commander

Body of a man recovered from his house

Police yesterday recovered the dead body of a man from his house in Chapainawabganj municipal area.

Golam Morshed Milon, 40, of Shiala- Gabtala Moholla, was found dead in his house around 9:30am. His throat was slit, said Alamgir Jahan, officer-in-charge of Sadar Model Police Station.

"During primary investigation, we found that the victim had a property-related dispute with his elder brother Elias Hossain, a lawyer.

One of their uncles had visited them the night before to mediate between the two. Elias disagreed with their suggestions. He killed Milon later in the night and fled the house, the OC said quoting family members.

The body was sent for an autopsy while police are trying to find and arrest Elias.

The previous two ECs were criticised for holding "one-sided" polls in 2014 and 2018. In the former, 153 out of the 300 MPs were elected unopposed. In the latter, there were widespread allegations of ballot stuffing the night before the polls.

"Questions about the acceptability of 2014 and 2018 national elections and many other polls have gradually eroded most of the people's trust in the Election Commission. The latest poor turnout was a result of that lack of trust," said election expert Abdul Alim, who earlier worked on behalf of the United Nations with an EC.

The recent resignation of six BNP lawmakers from parliament made Wednesday's by-polls necessary.

Since the last general election, the current EC had held 30 by-polls. Thirteen of those were held amid coronavirus restrictions between March 17, 2020, and August 19, 2021.

Five by-polls were held before the restrictions were imposed and 12 after they were lifted.

No voting was needed in four byelections because only one individual ran for MP in each.

Voter turnout on Wednesday was 16.10 percent in Brahmanbaria-2, 22.33 percent in Bogura-6, 23.92 percent in Bogura-4, 29.07 percent in Chapainawabganj-3, 34.78 percent in Chapainawabganj-2 and 46.30 percent in Thakurgaon-3.

The Awami League did not nominate anyone in Brahmanbaria-2, Bogura 4, and Thakurgaon 3. However, the AL's support for independent runner Abdus Sattar Bhuiyan in Brahmanbaria-2 was obvious. The ruling party officially supported candidates in two other constituencies.

The previous lowest turnout, 21.29 percent, was recorded in October 2019 during the Rangpur-3 by-polls.

Late Jatiya Party leader HM Ershad's son Rahgir Al Mahi Saad Ershad won that election in which no AL nominee participated.

'The voters lose interest when elections are not participatory and competitive," said Abdul Alim. Contacted, Election Commissioner

Rashida Sultana yesterday said turnout was good in Thakurgaon and Chapainawabganj and comparatively lower in Brahmanbaria and Bogura.

Bogura is known as a BNP stronghold, she said. Since the party was not a part of the by-polls, the BNP supporters did not come to the polling stations.

"The tenure of these MPs is only eight or nine months. That's why the voters didn't feel much interest in these by-elections," she said.

"In our view, the coal price they have quoted is excessive – it should be less than \$250 per metric tonne, which is what we are paying for the imported coal at our other thermal power plants," a PDB official told UNB.

The Adani power plant's coal will be \$346 per metric tonne, which is much higher than the amount paid by the local coal-fired power plants, according to a report prepared by the Power Cell in January.

PDB pays \$245 per metric tonne for the coal used in the Payra power plant in Patuakhali, \$254.38 for the Alam power plant in Chattogram's Banshkhali and the Rampal power plant in Bagerhat, and \$270 for the Barishal 307MW coal-fired power

Save for Payra, all power plants are using coal that has the same 4600 calorific value, the report said.

"This is not an official analysis vou cannot compare one power plant with another," Mohammad Hossain, director general of Power Cell, told The Daily Star.

One power plant's evacuation cost is high, while another would have high land development costs.

'Since the Adani plant would be importing coal and a dedicated transmission line was built to transport the power, the price is slightly higher than the local coal-fired power plants."

Hossain, however, declined to confirm whether PDB has sought to review the power purchase agreement with Adani Power.

The groundwork for the power purchase agreement was laid by Indian Prime Minister Narendra Modi during the 2015 state visit to Bangladesh, reports The Post.

Modi asked Prime Minister Sheikh Hasina to "facilitate the entry of Indian companies in the power generation,

transmission and distribution sector of Bangladesh," according to an Indian foreign ministry readout of their

meeting. "After Modi's trip to Bangladesh, that country's power authority contracted with Adani to build a \$1.7 billion, 1,600-megawatt coal power

For Modi, it was an opportunity to bolster his "Neighbourhood First" foreign policy and promote Indian business, the report said.

But the Indian government now appears to be distancing itself from the

Asked by an Indian journalist about the Bangladesh government seeking revision of the power purchase agreement, Arindam Bagchi, pokesman for the external affairs ministry, said: "I don't have anything on it. I understand you are referring to an agreement between a sovereign government and an Indian company. I am not aware of it. I don't even think we are involved in it."

Replying to a follow-up question by another Indian journalist on Adani Power vis-à-vis the Bangladesh issue, Bagchi said that as part of its larger 'Neighbourhood First" strategy, India would like to see greater economic integration and inter-connection with its neighbours, "which assists our process of development".

India wanted its neighbouring countries to benefit from its economic growth through the strengthening of connectivity links and cooperation in the power and waterways sectors, reports our New Delhi correspondent.

"However, if some project is not working for financial or economic reasons, I don't think it is a reflection on the relationship and we will continue our efforts how to bring our two countries closer through greater investment and trade linkages."

Accordingly, Gazipur Corporation spent Tk 9.4 crore for the Bishwa Ijtema for 2019-2020 and 2020-2021 fiscal years.

Of the amount, Tk 1.34 crore was set aside for repairing tube wells at the venue. And around Tk 24.33 lakh was earmarked for the food supplied by Abul Kashem Gong, a leasing company that got the tender.

GCC made the payment, but the food never came, according to the corporation's enquiry documents. It also did not find any voucher in support of the money being spent for food.

What is more surprising is that the tube wells that were repaired were not installed at the Bishwa Ijtema ground. They were instead placed in different areas under the city corporation's project.

The money that was deposited into the account was collected as advance holding taxes and building plan penalties from four companies Ispahani Foods Limited, Fin-Bangla Apparels Ltd, Honeywell Garments Ltd and GMS Composite Knitting Ind Ltd -- in five pay orders amounting to Tk 2.60 crore.

The pay orders were supposed to be deposited into the city corporation's account instead of the mayor's personal account.

The money that was later withdrawn by the mayor's caretakers Polo Chakma and Shahidul never made it to the city corporation's fund.

The GCC documents state that the mayor personally embezzled the entire amount.

Dhaka South City Corporation (DSCC) felled around 300 trees planted on the median strip of Saat Masjid Road in Dhanmondi to trees. The trees have been here for almost 30 expand the island, much to the dismay of environmentalists and locals.

The felling began over three weeks ago from Zigatola to Shankar's Saat Masjid road, a stretch of around 900 metres. Locals have held human chains over the last few days. demanding an immediate end to the mindless felling of trees.

DSCC cleared the area to expand the median strip without permission from the forest department. The cabinet division in February last year made it mandatory to secure permission to cut any trees even at one's homestead.

During a recent visit to the area, this correspondent saw that the space between the newly constructed strip does not have enough space for planting trees. Besides, another 400 metres of the existing strip have been removed, causing the trees to fall on the

Sajib Hossain, a local tea shop owner, said, "Two weeks ago the trees were cut down at night. Gradually, all the trees were cut down by a crane."

Nandita was born on June 2, 1953 in Patia of Chattogram. Her husband Swami Babul Prasad Barua was a senior official of Bangladesh House Building Finance Corporation. She left behind two daughters and a son. Her daughters Shapla Barua and Senjuti Barua are respectively a poet and writer.

At a programme on Wednesday at BSMMU, Nandita's two daughters also expressed their wish for posthumous body donation.

BSMMU VC Pro Md Sharfuddin Ahmed said, "Humanity will remember her contribution. In the past month, we have successfully transplanted corneas in the eyes of 12 people in this process."

ARBITRARY ARREST Hearing on review petition on Feb 9

The Supreme Court yesterday adjourned till February 9 the hearing of a review petition filed by the government challenging its judgement against the arbitrary exercise of power by law enforcers.

In its 2016 judgement, the SC upheld the 2003 High Court verdict, which ruled against exercise of arbitrary power by law enforcers using some provisions of the CrPC, including Section 54.

Section 54 empowers police to arrest anyone on mere suspicion. A seven-member bench headed by Chief Justice Hasan Foez Siddique passed the order. In a written argument, Attorney General AM

Amin Uddin mentioned some inconsistencies between the SC guidelines and relevant existing laws, said DAG Amit Talukdar without elaborating. The HC delivered its verdict on April 7, 2003,

responding to a petition filed by some rights organisations, including BLAST and individuals after the death of university student Shamim Reza Rubel in police custody on July 23, 1998.

"This behaviour is a threat to independent journalism," added the statement.

Bedlam at Baira over 'syndication'

Chaos overshadowed a meeting of Bangladesh Association of International Recruiting Agencies (Baira) yesterday as attending members created chaotic situations on more than one occasions over alleged "syndication" in sending migrant workers to Malaysia.

During the incident, a journalist covering the event was allegedly manhandled by some of Baira members.

The apex trade body of recruiting agencies organised the meeting at a city hotel demanding opportunity for all of its members to send migrant workers to Malaysia, ahead of Malaysian Home Minister Saifuddin Nasution Ismail's upcoming visit to Bangladesh.

However, at the beginning of the meeting, when a Baira member took to the podium and alleged that several of its executive committee members are part of the "syndicate", a section of the members from the audience started to make noise.

This continued for several minutes as senior Baira leaders including its President Abul Basher, who was moderating the event, were forced to halt the meeting and calm down the audience.

The situation became normal following an on-duty

police official taking to the podium and urging everyone to maintain discipline inside the venue.

Chaotic situation was created again towards the latter part of the event when Baira Joint Secretary Fakhrul Islam took to the podium and started to talk about the

syndicate issue.

Amid the situation, some of Baira members allegedly manhandled and misbehaved with one of the journalists.

At the beginning of the meeting, when a Baira member took to the podium and alleged that several of its executive committee members are part of the "syndicate", a section of the members from the audience started to make noise.

Later, talking with reporters, Basher said he will take action against the culprits after identifying them going through video footage.

Asked about the chaotic situation, Basher said a section of "beneficiaries from the syndicate" might have demonstrated thinking of counting loss if the market is opened for all.

According to Baira members, only 100 recruiting agencies are allowed to send migrant workers to Malaysia at present, after the market was reopened last year following a four-year suspension.

Initially, 25 agencies were allowed to send migrant workers there, which was labelled by sector insiders as "syndicate".

According to the Baira website, it has more than 1,700 active members at present.

Habiganj's lifeline ceasing to exist

Jujnal river victim of encroachment, pollution

There was a time when the Jujnal river used to be the lifeline of Habiganj. Boats used to ply the river with goods and passengers, facilitating agriculture, trade and communication simultaneously.

However, this has ceased to be the reality in recent years, due to rampant encroachment, filling and pollution.

The river, which originated from Khowai river and is situated at Mirpur Bazar in Habiganj's Bahubol upazila, is currently nothing short of a garbage dump. Illegal structures stand on both sides of the river, while part of the river is the victim of constant filling, making it look like nothing more than a mere canal.

During monsoons, the slopes of the river are flooded with dirt and polythene, causing it to remain dead during the dry season.

During a recent visit, this correspondent found traders from the adjacent Mirpur Bazar, along with locals, throwing garbage on the riverside indiscriminately. The area emanates a horrible stench without a garbage disposal facility around.

Besides, there are houses and other establishments by the market's traders on both sides of the river. Many of the owners of these establishments have been illegally occupying the riverside for generations.

Minhaj Uddin, a resident of Mirpur area, said all kinds of garbage, including remains from slaughtered cows and goats, garbage from raw markets and business establishments, are being dumped into the river.

"No one can move through the

space because of the smell. If the administration took appropriate measures, the river could be saved. We could be saved," he added.

Khowai River Waterkeeper Tofazzal Sohel said a certain section, fueled with greed, has been behind the dying state of the Jujunal.

"It is absolutely necessary to dredge the river and ensure its normal flow," he added.

Abdul Karim Chowdhury, member of the executive committee of Bangladesh Paribesh Andolon (Bapa), said, "When I visited the river recently, I saw the market people setting up open toilets on the riverbank."

"According to locals, the filth in Jujunal eventually falls into different connecting rivers, including the Meghna," he added.

Hero Alom's claims have no basis

Says EC Rashida Sultana on vote-rigging allegations; JL leader assaults journos

Election Commissioner Rashida Sultana yesterday rejected the vote-rigging allegations brought by Bogura-4 independent candidate Ashraful Hossain, alias Hero Alom, saying that those have no basis.

Rashida, while talking to reporters in the afternoon at her EC office in the capital, said the returning officer, as well as the district election officer, informed the commission that the results are 100 percent correct.

Hero Alom lost the Bogura-4 (Kahalu-Nandigram constituency) by-polls to ruling Awami League-led grand alliance candidate AKM Rezaul Karim Tansen, by just 834 votes, on Wednesday.

After the announcement of the results, Alom alleged that the results were rigged and he would

go to the High Court to seek justice.

"We have seen the results sheets ourselves.

There is no discrepancy there. When candidates lose, they make some allegations to make the elections questionable. This is the culture of our country, and Here Mem is no expension," she said.

country, and Hero Alom is no exception," she said. Mahmud Hasan, Bogura's district election commissioner and assistant returning officer, told The Daily Star that the chief election commissioner gave the order to take note of the allegations Alom made during a press conference and also on a talk show. "Later, we checked the results again and found that everything was fine," he said.

Meanwhile, a leader of Bogura District Jubo League unit has been accused of beating two journalists for covering Hero Alom's press conference on Wednesday night.

The victims are JM Rauf, district correspondent of Dainik Kaler Kantho and general secretary of Bogura Journalist Union, and Zahurul Islam, a senior journalist of a local newspaper Dainik Bogura. The incident happened at Bogura Town Club adjacent to the Bogura District Awami League office around 11:30pm on Wednesday, said the victims.

The accused Jubo League leader is Shariful Islam Shipul. "Police have been informed and will submit a written complaint," Rauf told The Daily Star.

Nur Khan gets US human rights defender award

The US Department of State has named Bangladeshi rights activist Mohammad Nur Khan as one of the 10 winners of its annual Global Human Rights Defenders award.

The State Department

made the announcement on Wednesday.

In a statement, the State Department said over the past three decades, Nur Khan led two of Bangladesh's best-known domestic rights organisations -- Ain o Salish Kendra and Human Rights Support Society -- and partnered with international organisations to document human rights abuses and promote accountability in Bangladesh.

"His timely interventions, advocacy on behalf of families of victims of enforced disappearances, and leadership amongst the country's active civil society networks, have saved lives and cleared innocent victims of politically motivated charges," it said.

Nine other awardees are: Elaize de Souza Farias (Brazil), Chhim Sithar (Cambodia), Nino Lomjaria and Team (Georgia), Rosa Melania Reyes Velásquez (Honduras), Nasrin Sotoudeh (Iran), The legal team of the Badinan detainees, led by Bashdar Hassan (Iraq), Mohamed Ely El Her (Mauritania), Ding Jiaxi (People's Republic of China) and Ekoue David Joseph Dosseh (Togo).


Bangladesh-born US citizen Imran Sharif yesterday challenged the family court's verdict that dismissed the case filed by him in February last year, seeking custody of his children.

An Indian journalist held in custody for more than two years without trial walked free yesterday after being granted bail in a money laundering

Siddique Kappan was arrested in October 2020 in the northern state of Uttar Pradesh, where he had travelled to report on a high-profile gang rape

He and three others were accused of belonging to an Islamist fundamentalist group and eventually charged with conspiracy to incite violence under anti-terror laws.

Kappan has maintained his innocence and says that he had only travelled from his home state of Kerala to do his duties as a journalist. He was bailed in the case in September last year but remained behind bars for months longer because of a separate money laundering case against him. "I will continue my fight against

draconian laws. They kept me in jail even after I got bail," he told NDTV news network after his release from

jail in the city of Lucknow.

"The United States strongly opposes the Burma military regime's decision to extend the state of emergency, prolonging the military's illegitimate rule and the suffering it inflicts upon the country," State Department spokesman Ned Price said, using Myanmar's former name.

The junta on the coup anniversary said it was extending the emergency by six months, pushing back the date for elections under the constitution. Price said the United States was determined to work with other countries to "deny the regime international credibility."

He also denounced the junta's version of "so-called elections, which will exacerbate violence and instability and will not be representative of the country's people." US earlier announced sanctions Myanmar's energy sector leadership as part of efforts to pressure junta further.

Australia to remove **UK monarch from** banknotes

Australia will remove the British monarch from its banknotes, replacing the late Queen Elizabeth II's image on its \$5 note with a design honouring Indigenous culture, the central bank said yesterday. He was expelled from the AL on November 19, 2021, after a video clip went viral. In the video, he was seen making derogatory remarks about Father of the Nation Bangabandhu Sheikh Mujibur Rahman and expressing doubts about the number of martyrs in the Liberation War.

Seven days after his expulsion from the party, he was suspended asmayor on November 25.

The ministry at that time cited allegations of land grabbing and abuse of power and public money as reasons for the suspension.

Zahangir was sworn in as GCC mayor on July 27, 2018.

According to section 13 (1) of the City Corporation Act, 2009, a mayor can indeed be unseated for those

Later, the ministry formed a threemember probe committee, led by its Additional Secretary Mustaqim Billah Farooqui.

Meanwhile, Zahangir getting party amnesty has had his followers upbeat. and widening of roads. They now expect him to retrieve his mayoral reins, party insiders said.

But LGRD and Cooperatives Minister Md Tazul Islam said a decision regarding his suspension depends on the report of the ministry's probe committee.

"After getting the probe report, we will analyse it and then make a decision," Tazul told The Daily Star at his ministry on Monday.

The Daily Star approached LGRD probe panel chief Additional Secretary Farooqui to know about the status of investigation, but he would not make any comment.

Mohammad Johirul Islam, a member of the committee, told The Daily Star that the probe body was yet to turn in the report.

"We requested Gazipur City Corporation to furnish us with different documents, and the corporation obliged. Now we are analysing those documents. We will complete the report soon," he added.

Meanwhile, the Anti-Corruption Commission is also probing graft allegations against Zahangir.

GARBAGE GRAFT

The GCC has spent Tk 12.43 crore for garbage removal in fiscal 2018-2019, 2019-2020 and 2020-2021.

Of the amount, Tk 3.44 crore was spent for 2018-2019, Tk 3.67 crore for 2019-2020 and Tk 5.31 crore for 2020-2021.

But the government rules and regulations were not followed in paying the bills. More than Tk 10 lakh was paid through vouchers, going against the rules, said the report.

According to rules, a maximum of Tk 25,000 can be paid through avoucher.

It was shown on papers that a tender was floated for drains cleanupin eight areas, and bills were dulypaid. But in reality, no tender was invited, no committee formed and no tender paper collected. All this is tantamount to embezzlement,

according to the GCC enquiry report. Moreover, no drains were cleaned in those areasthough bills were paid, it said. Councillors of those wards also questioned what they said was phantom spending.

DARLING FIRMS

There are around 1,200 construction firms listed with the GCC, but only 16 implemented development projects worth Tk 128.71 crore in the three fiscal years.

The licences of all firms, except 23 including the 16, were not renewed, which, according to the report, was "motivated".

The report said that most of those who won the contracts were new firms, and 23 firms, including those 16, either got fresh licences or had their licences renewed even though the GGC did not issue any circular for fresh enlistment or renewal of firms in the three fiscal years.

Those 23 firms were given the work orders in secret, and the owners of those firms are very close to Zahangir, reads the report.

PAYMENT MADE, ZERO WORK

The report narrates an interesting way of embezzling public money through different small development works like sand filling, earth filling

For instance, MS-ME (JV), owned by one Ruhul Amin, got a Tk 9.78 crore contract for sand and earth filling and road widening -- the stretch from Nayan's shop to Tapu member's house close to the Tongi-Kaliganj Road and from Bogartey Bridge on Joy Bangla Road to Meghdhubi bypass.

The company won the contract on April 26, 2021, as a lone bidder and received partial payment of Tk 3.07 crore in two cheques dated May 4, 2021, and August 21, 2021.

But after visiting the site on May 24, 2022, the investigation committee found zero progress in the development work despite a 31 percent payment being made.

In another case, Chowdhury Amin (JV) got a contract for widening four narrow roads near Tongi and Dhaka

Chowdhury was the second bidder with an offer of Tk 9.46 crore against the lowest bidder M/S Zaman Traders and Confidence infrastructure LTD (JV) offering Tk 9.38 crore.

But Zahangir directed the officials concerned to order NOA (notification of award) to the second bidder, bypassing the recommendation of the tender evaluation committee to award the work to the lowest bidder.

Chowdhury Amin (JV) also received partial payment of Tk 3.36 crore despite zero physical progress as of May 24, 2022, the report said.

The enquiry also found that a number of firms were paid only three days after the issuance of work orders. A few were paid their bills even before the sites were handed over to them.

It found firms received payments showing the same work several times, adding that bills were submitted multiple times after the same tube well was repaired several times. The same was done with water pipeline repair.

The GCC implemented some projects under the Request for Qualifications (RFQ) fund and paid bills of Tk 3.51 crore on December, 26, 2018, and April 2, 2019.

The spending was much higher than the maximum allocation of Tk 60 lakh annually under RFQ, and all the projects were implemented by only five firms, the report said.

HAAT-BAZAAR

The GCC investigation report found that Tk 12.35 crore was the leasing value of 104 permanent haat-bazaars (open marketplaces) under the GCC for three fiscal years (2018-2019, 2019-2020 and 2020-2021), but the corporation only managed to collect

Tk 6.44 crore. The leasing value of a temporary haat-bazaar was Tk 1.80 crore for the same period, but the corporation got only Tk 56 lakh.

According to a 1959 ordinance, the city corporation was supposed to hand over the haat-bazaar to a lessee on the first day of the Bangla calendar only after receiving the

contract money. But in the last three years, the haat-bazaars were handed out to the lessees without receiving the full contract money. It has never been paid by the lessees and the GCC

incurred a huge loss along the way. Besides, the leasing value for both permanent and temporary haats for the last three fiscal years was shown far below the average price.

In many cases, as part of widespread irregularities, temporary haat-bazaars were shown as lowvalued khas haat-bazaars. Even the money collected from khas haatbazaars was not deposited in the GCC coffers.

For instance, on July 16, 17 and 19 of 2021, the then GCC executive officer of area-1 MD Soharab Hossain collected around Tk 1.01 crore under his signature from a temporary cattle market in Tongi.

He deposited only Tk 54.42 lakh to the GCC account through different memos but has yet to deposit the rest Tk 45.57 lakh to date, according to the report.

According to a policy, the employees of the corporation are responsible for collecting the leasing money from the khas haat-bazars.

But the report found that instead of city corporation officials, the mayor's personal assistant collected the lease money, and that money was never deposited in the GCC coffer. BANGABANDHU BIRTH

CENTENARY

The GCC spent Tk 2.11 crore from the city corporation fund for celebrating Bangabandhu Sheikh Mujibur Rahman's birth centenary from 2020 to 2021.

But the corporation's internal enquiry found that no such programmes were held on the date mentioned in the voucher.

For example, documents show that an event was held on Rajbari ground on March 17, the birth anniversary of Bangabandhu, and payments were made from the corporation account for the celebration.

But no such event took place as there were government restrictions on outdoor events on account of Covid pandemic.

The report also read that to celebrate the birth centenary, a Tk 46 lakh cheque was issued for the then GCC secretary Mostafizur Rahman and another cheque worth Tk 45 lakh for the then chief revenue officer Rezaul Bari.

But two GCC workers on muster roll, Nazmul Islam and Soaliman, cashed those cheques respectively

Later, Rezaul Bari informed the

For 2018-19, 2019-2020 and 2020-2021 fiscal years, the GCC estimated the development cost at around Tk 400 crore, and of it, Tk 136 crore was paid out.

The GCC enquiry finds some interesting anomalies in spending.

Only reforms can reignite voter interest

Six by-polls proof that there is a lot to be done before general election

Coming a year before the general election, and nearly a year after the formation of the incumbent Election Commission, it is natural that the six by-polls held Wednesday would be viewed against the wider political backdrop. It was, therefore, frustrating to know how little things have changed, despite the relative lack of violence, which would have been something to look out for under different circumstances. It's quite evident now that any changes, or promises of changes, made over the past year or so only cemented the status quo, which doesn't bode well for our electoral future.

If we're to pick a word to summarise the by-polls, it would be "absence" – absence of voters, absence of interest from the wider society, absence of strong opposition, including BNP, whose lawmakers' resignation from parliament had led to the by-polls. Voter turnout was poor in all the six constituencies. As per an estimate, only about 28 percent of voters showed up, in a trend that has been persistent throughout all local elections and by-polls held over the last few years. The predictable nature of election outcomes, and the lack of trust about the neutrality of responsible state departments, seem to have caused ennui and despair among the people.

It seems almost futile to ask why the Election Commission is failing to address voter apathy despite repeated appeals from election observers. The EC, after the latest by-polls, again stuck to its "peaceful and well-organised" narrative, even though we have received reports of various election-related irregularities from a number of constituencies. The EC's failure to recognise that the mere appearance of elections is not enough is really alarming. We need fair and participatory elections. And we need the EC to restore the trust of all voters and opposition

Another major concern about the by-polls is the "disappearance" of the key rival of the eventual winner in the Brahmanbaria-2 by-poll. This by-poll - which saw the lowest voter turnout of all – has been in the news ever since the winner, expelled BNP leader Abdus Sattar Bhuiyan, was backed by the ruling Awami League, which didn't field a candidate there. Abu Asif Ahmed, an independent candidate, has been missing for about a week now. Which makes us wonder: why is nothing being done to find him? What message does it send to the political opponents of the ruling party? And how long will the EC refuse to address the concerns of the opposition parties?

The culture of fear, distrust and criminality that still plagues our electoral system must be removed, and the ruling party must play a leading role in this. Lack of violence in one election offers little hope given how political violence and repression continue to occur in every other sphere. As the recent by-polls have shown, we have remained stuck in the same spot for too long, and the authorities must allow genuine reforms to break this status quo. They must help create a level playing field for all parties, and restore public trust in the function of the electoral system.

Stop sand extraction from rivers

It's increasing the risk of river erosion, endangering farmland and depleting soil fertility

Despite the fact that sand extraction from rivers is doing severe damage to our environment and local communities, this mindless act is going on unabated across the country due to lack of action from the authorities. According to a report by Prothom Alo, sand is being lifted illegally from the Padma river near the Baulikanda area of Shivalaya, Manikganj. Although locals fear that their homesteads and agricultural land along the river will be at risk of erosion by these acts, they do not have the means to stop these activities because of the involvement of influential people in this.

Reportedly, the local Union Parishad chairman, a UP member, as well as other politically connected sand traders are involved in extraction in the area, making the life of those dependent on the river more vulnerable. Sadly, the local administration is turning a blind eye to the issue.

This is no isolated incident, however. If we only look at the newspapers of the last one month, we will get plenty of reports on sand extraction as well as other types of environmental degradation. For instance, in January, this daily reported how influential locals were illegally lifting sand from the seabed along Chattogram's Sitakunda coast, increasing the risk of coastline erosion. Erosion is, however, just one example of the damage that results from sand lifting; other risks include loss of croplands and depletion of soil fertility.

We see such environmental degradation being carried out through countless other activities - such as polluting and encroaching rivers, cutting down hills, felling trees, destroying mangrove forests, polluting air, etc. Every day, something is being done somewhere to degrade our nature and thereby threaten our survival as a species. It is as if we are waging a war against nature. But it's not a war that we, or anyone, can win in the long run. Can we live a normal, healthy life by ruining the very environment of which we are just a part?

What is inexplicable is why the state is still doing little to stop such acts, despite having of several laws and regulations as well as dedicated administrative wings to address these issues. In many cases, we have seen that local administrations only conducted mobile court drives, which helped little to improve the situation. More often than not, after the drives are over, the unscrupulous people engaged in such activities get back to their work again.

Clearly, protecting our environment from harm will need greater efforts and coordination from all the government agencies concerned. No ad-hoc measure can stop sand traders or river grabbers and polluters. We have ample laws for environmental protection which should be used evenly and effectively. Most importantly, we must break the culture of impunity of the politically connected people who are often the ones harming our environment.

Death or Glory in Russia

Rumours are flying about veiled jockeying within Russia over who will replace President Vladimir Putin, now that his war of aggression in Ukraine has gone so disastrously wrong. Such a struggle cannot fail to expose the morbid pathologies of Russian politics. The key players are not organised political parties, but rather gangs of oligarchs who preside over various informal nodes of power.

This explains why Russia's most effective military force on the front line in Ukraine, the mercenary Wagner Group, is not even a part of the Russian army. Russia is now a land of warlords, something one generally associates with rogue and failed states. Its current and aspiring leaders are trafficking in fever dreams of battlefield glory. Implicit in this martial culture is a Hobbesian view of life as solitary, poor, nasty, brutish, and short - and increasingly cheap.

The rise of private armies in and around Russia has led to some genuinely funny developments. For example, last year, former members of US and other Western armed forces organised a voluntary military unit to fight on the Ukrainian side. With pitch-

perfect irony, they call themselves the Mozart Group – a direct riposte to the Wagner mercenaries (both names being of a German composer). One can only hope they will bomb Russian army positions with weapons more powerful than chocolate Mozartkugeln.

But the humour ends there. Russia's apparent reversion to warlordism has been abetted by a strain of Russian religious fundamentalism that openly celebrates death. Some Russian clergy have been telling their congregations that they can "become themselves" only through the act of killing. The "special military operation" in Ukraine, they are told, is a struggle for "all of God's creation." As one of Putin's chief propagandists, Vladimir Solovyov, said in a New Year's message on Russian television, "Life is highly overrated. Why fear what is inevitable? Especially when we're going to heaven. Death is the end of one earthly path and the beginning of another. Don't let fear of death influence decisions. It's only worth living for something you can die for, that's the way it should be... we are fighting against satanists. This is a holy war, and we have to win."

understand contemporary Russian ideologists like Solovyov and Putin's so-called "court philosopher," Aleksandr Dugin, one must examine the tradition of Russian "cosmism," a philosophical movement that began with the 19th-century educator Nikolai Fedorov. As Jules Evans, a philosopher at Queen Mary University of London, writes, Fedorov "was nicknamed the 'Socrates of Moscow,' because of his ascetic habits and his radical philosophy. He had one allencompassing goal: the achievement of immortality and the resurrection of

the dead." Among Fedorov's 20th-century followers was the Soviet rocket scientist Konstantin Tsiolkovsky (who theorised about space travel), the science-fiction writer Alexander Bogdanov (who believed that one could prolong one's life through blood transfusions), and in a fitting coincidence – the religious thinker Vladimir Solovyov.

According to Evans, this earlier Vladimir Solovyov called for "a universal theocracy under a Russian czar, to hasten humanity's 'long problems.

a Chechen theologian and Russian and difficult passage from beast mankind to God-mankind." Once accomplished, adherents to the faith would "become immortal spiritual beings - only Christ has reached this stage so far, but all humanity will soon follow." While Solovyov believed that this evolution could be advanced with magic, Fedorov himself advocated scientific means. But both ultimately "agreed that humanity would be saved by Russian theocracy."

Denys Sultanhaliiev of the University of Tartu has explored the links between the two Solovyovs and established a clear lineage from Russian cosmism, in both its mystical and scientific forms. There is a direct through line from the cosmism that prevailed in the first decade of the Soviet Union to the nihilism and nuclear brinkmanship on display today under Putin.

A belief in resurrection and eternal life is key. But cosmism could emerge only within the Russian Orthodox version of Christianity, whose basic formula is "God became man so that man will become God." That is how cosmists interpret the appearance of the God-man Christ: as a model for

what all of humanity should pursue. As we watch ideological madness play out in Russia, we must be mindful of its roots in Russian Orthodoxy. Many in the West now view that tradition as an antidote to the liberal decadence that Western Protestantism supposedly unleashed. In a perverse way, they are right: death solves all

Honouring an Institution

have gone by since the passing of Ahmadul Kabir (Monu Bhai to most of us). If you make it into your 80s and have remained a vital presence virtually upto the end of your days, you qualify to be designated as an institution. Monu, however, had more claims to being an institution than owed to his vitality and longevity. He represented a tradition in our public life that is now in danger of becoming extinct. He entered politics without any expectation of personal gain. He came from a social background where he had no strong financial need to make a livelihood from politics. In fact, he invested his personal fortune in supporting political causes that had little scope of prospering, and thereby propelling him into high office from where he could recoup his investments.

In the 1960s, he could have prospered by joining the Ayub Muslim League and could have walked into the cabinet in Islamabad or Dhaka anytime he wanted. But he chose to contest the election to the East Pakistan legislature in 1962 on the ticket of the National Awami Party (NAP), where he remained one of the most vocal spokesmen for the opposition. In the historic 1970 election to the Pakistan National Assembly, he contested and was defeated by Tajuddin Ahmad for the Ghorasal seat. After liberation, he could have joined the ruling Awami League, since he was well-known to Bangabandhu and much of the party leadership, but chose not to do so. After 1975, successive ruling parties would have been more than happy to have Monu Bhai join their ranks and would have offered him a cabinet post of his choice, but he chose to sit in the opposition benches when Jatiya Sangsad.

He remained all his life on the "left," interpreted in its broadest sense. He was actively involved with the Jukta Front in their historic defeat of the Muslim League in 1954, and was a treasurer of the Krishak Samity. In 1957, he participated in the founding of NAP, which brought together the progressive elements of Pakistani politics with those who were also keen to promote regional autonomy, and was elected as a member of its national executive committee.

He remained with NAP, and when it split between its Pro-Moscow and Pro-Beijing components, he sided

It is hard to imagine that many years the then East Pakistan was led by Prof Muzaffer Ahmed. However, his brother-in-law, Syedul Hasan (murdered by the Pakistan army in 1971), was close to Maulana Bhashani who, when visiting Dhaka, usually stayed at his home. Monu Bhai, thus, continued to maintain excellent relations with many of the stalwarts of the Bhashani NAP even when the political divide was quite deep. Monu remained loyal to NAP, but when it fell apart in the 1980s, he constituted his own party, which could at best be termed a political fragment.

> Monu's political identity and stature, however, did not derive from his political affiliations, but was much more personal. He continued to command influence, whether in

In this capacity, Monu was an important nexus between politicians not just of East and West Pakistan, but of varying political persuasions – a role he played right down to his last days. Thus, some of the most interesting and at times important political dialogues and even negotiations took place around Monu Bhai's dining table, where Laila Kabir was often an active participant in the heated with the Moscow faction that in discussions. remain who retain the authority of Monu Bhai to bring contending political elements together to discuss politics in a civilised environment.

Monu Bhai had his own ideas and idiosyncratic views on politics and economics that were sustained by a rather wide and eclectic reading list as well as a rich body of experience. He was quite opinionated and often impatient with views he disagreed with, but he was always open to

Since I was many years his junior, not just in years but also in exposure to politics, I learnt much from him, but also had many disagreements, which he generously tolerated from a younger friend. When I joined hands with Kamal and Hameeda Hossain in 1969 to publish the weekly journal Forum, Monu Bhai generously put the services of the Sangbad press at our disposal to print the paper. I vividly remember spending late nights with Hameeda at the Sangbad office reading the final proofs before Forum was about to be printed, and Monu Bhai dropping in on us with words of advice and good cheer.

Monu had the stature and maturity to appreciate that politics was not a profession but a vocation. He was a true democrat who rejected an absolutist vision of politics, and recognised that you must listen to a variety of views and give space to dissenting opinions if democracy was to work. He was a genuinely secular person in the true sense of the term. This did not mean he was irreligious, but that he passionately believed that religion should not be abused for political gain.

His vision of politics was fully reflected in his more enduring contribution to Bangladesh's public life in the form of the daily Sangbad. Under Monu Bhai's patronage, Sangbad was a paper that gave a home to progressive journalists and offered them freedom to express themselves when most outlets were closed to them for political or commercial reasons. This tradition of committed journalism associated with Sangbad remained integral to the sustainability of progressive ideas in Pakistan and Bangladesh at a time when the political climate was hostile towards radical ideas. In the process, Sangbad helped to influence the consciousness of generation of Bangladeshis who came of age during the period of Pakistani rule.

Over the last half century, few progressive papers could financially survive, and Sangbad did so largely because of Monu Bhai's courage and willingness to invest in his own beliefs. Is 'Faraaz' just another movie?

The answer is a "yes" and a "no." Yes, it's just another movie that will lose significance as soon as a few weeks go by. Then again, it's not "just another" movie. It is a lesson in horrific storytelling that revisits wounds that still bleed at the mention.

The Holey Artisan terror attack was a tragedy that many of us grew up with and lost our innocence to. There is merit in asking whether an Indian filmmaker, with no connection to Dhaka, had any right to recount the story that impacted thousands of lives he will likely never meet. Further, one must contextualise the movie to where it's being released India, a country that remains largely polarised with a populist government using Hindutva to persecute minority Muslims. Despite it not being director Hansal Mehta's intention, it will play into the Indian government's narrative that Muslims are the ideological, and perhaps geographical, "other." In times like these, we should remember that everything is political, and the inherent fear of the "other" will likely propel ticket sales to Faraaz, feeding existing

One can also wonder if the art is accommodating the victims and not turning their grief into a battering ram for box office profits. If we dissect similar instances in the West, a slate of 9/11 documentaries and archival movies – especially in the first five years after the tragic incident - moved forward with the blessings of the victims' families. Many directors noted that they would not have commenced work had the families objected to how the story was focusing on the truth, contributing to its enduring legacy.

In general, it's common for filmmakers to seek the consent of individuals or families who are depicted in films based on real-life events, especially if the portraval could be seen as (in) sensitive or controversial. Mehta has had a long-standing reputation of doing autobiographical films, which, frankly, he has executed well. In Shahid (2013), he bases the film on the life of human rights lawyer and activist Shahid Azmi. Aligarh (2016) was a film inspired by the real-life incident of Dr Shrinivas Siras, a professor who was suspended from his job because of his sexual orientation. Then in 2020 came Scam 1992, a web series based on the life of stockbroker Harshad Mehta and his involvement in the securities scam of 1992, and Chhalaang, a sports drama film inspired by the true story of a physical training instructor in a government school.

How is it that such a seasoned director did not seek consent from the victims' families when making Faraaz? Ruba Ahmed, mother of Abinta Kabir, one of the victims of the Holey Artisan attack, filed a case just before the pandemic to stop the movie. When no word was heard on the film's production, she breathed a sigh of relief, knowing she wouldn't have to revisit the trauma of losing her daughter on the big screen. Then two years went by and Mehta emerged with a fully finished film. There were hardly any

a film's release. Why this secrecy? The director's general disregard of the victims' families' emotions puts into question the extent of sensibility he might have applied into making the film itself.

In this regard, Ruba Ahmed's argument against Mehta strikes the most relevance, "Nobody knew what happened behind those doors, nor can anyone tell what happened." To pick and choose a hero and then highlight that speck of heroism as the most significant aspect in a hostage situation is probably not the most sensitive or sensible act that one could've expected from a veteran director.

There's also the question of how the attackers will be represented. One of the attackers was a student of a private university in Bangladesh, who later transferred to Malaysia, where he was likely radicalised. After the media revealed his face to the public, many in Dhaka were in denial and shock,

either for knowing him personally or knowing of his life's priorities even days before his unexplained disappearance.

He used to be another regular guy with mundane Monday problems, and with the English Premier League dominating his world. On the verge of his graduation, when he was supposed to be worried about his midterms and securing a job, how was it that he found himself worried about waging a "religious war"?

While the Holey Artisan attack reduced him to just another statistic, forever painting him and – just by virtue of association his family as the "inherent evil," it will not be unreasonable to expect pop culture to represent him and his surroundings in a way that represents all of us. For this attacker, too, was once one of us, before radicalisation put a wolf's teeth in that lonely boy. Can an Indian filmmaker, making the first move on this story, go inpromotions or campaigns last year, depth into the character of urban which was odd, given that's what radicalisation that underpinned

one would typically expect before IS' prime recruitment strategy in Bangladesh? Or will he dilute it with a trailer and dialogues that sound reminiscent of Pakistani soldiers in movies like Border or Lakshya?

> These cultural and community intricacies bear significant weight on projects such as these, galvanising more support for local productions to tackle local stories of seismic proportions. Not addressing these wounds not only tells a one-sided story, but also disrespects families who neither had anything to do with the attackers' radicalisation, nor had any idea what really went down below.

> However, there is a greater analysis of fear that becomes pertinent every time a terror attack is commercialised for profit. While pop culture invests its energy and big dimes into the representation of conquering fear, terrorism - and its enduring legacies – are different.

> It's more than just enhancing and enabling stereotypes - it's about how terrorists actively work to create their identity through violence. Any social response that is mildly aggressive only feeds into their ideology, creating a neverending, vicious cycle that breeds radicalisation, especially when terrorist activities are low.

> It is not pop culture's responsibility to rehabilitate the image of terrorists, radicals or religious fanatics. But when movies commercialise traumatic and culturally significant events like the Holey Artisan attack, the onus shifts on the filmmakers to introduce a humanising force that unites everyone in grief, pain and disagreement, simultaneously restoring dignity by leveraging the truth in storytelling. Else, we keep our societies open to the enduring pedagogy of fear - instead of unity - furthering social polarity and the fear-based cognitive dissonance that does more net harm. Will Faraaz and Saturday Afternoon end up causing more harm commercialising trauma? Only time can tell.

> What can be said for certain is that there is something like "too soon," and there definitely is a wrong way to tell a story. But with meticulous research, one can separate the truth from political fiction, and bring comfort to a varied demographic reliving their trauma while they watch it on a big screen. So, if the question is, can artists explore culturally traumatising events? Absolutely; creative avenues should be afforded to filmmakers who exercise the highest care to craft stories that hold up to the standards, and it is not a process previously unheard of. Many victim families opposed movies regarding the Boston Marathon bombing of 2013, but eventually agreed to the production once they were made privy to the research process, and when the plot and the sub-plots avoided significant dramatisation of events to protect the sanctity of

Popular culture's representation of these events helps narrate micro-stories that often don't see the light of day. It's not just a simple conversation about freedom of speech – all the information is out there for any keen person to view. But it's about piecing all that information together to present valuable insights about an event that had ground-breaking significance to you, your family, your culture, your ambitions, and vour future.



The motherhood penalty of female students

Student maternity leave can help remould the entire picture of women education in the country. It will reduce female students' dropout rate and facilitate them to unravel their unexplored talents. SURIYA TARANNUM SUSAN

Motherhood penalty is a term coined by sociologists to refer to the pay gap and workplace biases towards a pregnant woman. A certain amount of attendance is a prerequisite for appearing in exams in almost all educational institutions in Bangladesh. In the absence of a student maternity leave, the biases stemming from motherhood coupled with the legal vacuum are acting as an impediment to such student's right to education. This cannot be anything short of a penalty.

Nausea, dizziness, morning sickness, and fatigue are some of the very common pregnancy-related complications. Moreover, after the delivery, many new mothers experience postpartum depression, and unexpected sleeping and feeding patterns. Academic pressure coupled with pregnancyrelated health complications can be physically and mentally draining for the childbearing

Maternity leave is designed to ensure that a pregnant woman can prioritise her health d of article 15 mentions social security, which and provide necessary care to the newly born child without the tension and hassle of all other responsibilities. Sections 45-50 of the Bangladesh Labour Act, 2006 focus on maternity leave policies. The Act instructs employers to allot four months of paid leave to pregnant women, eight weeks prior to delivery and eight weeks post-childbirth. The newly amended Bangladesh Labour Rules, 2022 deals with the special situations of leave for childbirth after the end of the maternity leave in rule 38(a) and leave for miscarriage in rule

Permanent government servants are entitled to six months of maternity leave

with payment under rule 197(1) of Part-1 of of the Delhi Institute of Pharmaceutical the Bangladesh Service Rules. This provision enables female faculty members and staff of public universities to take maternity leave. It remains a matter of curiosity as to why a legal vacuum still exists regarding the maternity leave for pregnant female students. The stories of expectant student mothers or new student mothers are filled with despair, anguish, and plight. Pregnancy amidst study years impairs many female students from attending exams, and consequently, some discontinue education.

It is quite unfair not to extend the same opportunities to female expectant students. Maternity in its very nature is related to the human body. The unborn babies deserve equal and proper treatment regardless of status or category of the workplace. The lack of attention towards pregnant students is an infringement of article 28, also dubbed as the equality clause of the Constitution of Bangladesh.

Article 15(c) enumerates the right to reasonable recreation, rest, and leisure. Clause provides for undeserved wants arising from disability. Article 28(4) permits the State to make special provisions in favour of women and children. Considering pregnancy as expecting students from others, they can be reasonably classified to avail maternity leave.

It is pertinent to mention that permitting appearance in exams condoning the attendance of pregnant students is not an eccentric phenomenon. In 2013, Calicut institutions. No woman should be penalised University, became the first Indian University to grant long-term maternity leave for women students. In 2008, the Delhi High Court The Writer is a Student of LLB (Hons), University of imposed a fine of Rs. 25,000 on the Principal Chittagong.

Science and Research for declining maternity leave to a student and wasting her one year unjustly. His action was declared ultra vires as the Delhi University Ordinance ensured maternity leave for students as a special case. The Court also directed the college to allow the student to appear in the examination. The Delhi High Court ruled in favour of the petitioners and observed that "....to punish a woman for becoming a mother would surely be the mother of all ironies." The Draft UGC Regulations, 2022 inter alia recognises maternity leave to women candidates for up to 240 days, once in the duration of the PhD

programme. Worldwide top-ranking universities like University of Cambridge, University of Oxford, McGill University, University of Salford, and so forth have their own robust policies ensuring that a pregnant student or new mother can resume her education without any academic

In Bangladesh, the minimum legal age for a female to get married is 18. It is unfortunate that right to education of such students is getting violated due to such lacuna in the legislation. Student maternity leave can intelligible differentia distinguishing help remould the entire picture of women education in the country. It will reduce female students' dropout rate and facilitate them to unravel their unexplored talents. Hence, it is argued that student maternity leave should be mandatorily incorporated into educational for embracing motherhood.

8th Annual Winter School

To educate the youth about genocide and justice

Center for the Study of Genocide and Justice (CSGJ), Liberation War Museum organised the 8th Annual Winter School on 'Hatred, Violence and Prevention of Atrocity Crimes' on 21-28 January 2023 at the Sheikh Hasina National Youth Development Center, Savar. 
Into the details of the Road Safety Rules, 2022

The government has recently enacted the Road Safety Rules, 2022 for the better implementation of the Road Transport Act, 2018. It includes 12 chapters, 167 provisions, 9 schedules and 44 forms. Rule 2 includes all the definitions required for the purpose of the Rule.

Chapter 2 deals with driving licence renewal, expiration of licence and other issues in great detail. Rule 18 of this chapter provides about the procedures for driving licence for persons with disability. In Chapter 3, the Rules have made it mandatory for conductors and supervisors to have a licence which is a new addition. Under rule 27(2) of the Rules, the minimum age required for driving licence is now 20 years and minimum educational qualification has been lifted to junior school. The conductors are now required to have a licence under rule 23, and they will get minimum wages in compliance with the Bangladesh Labour Act, 2006 under rules 32(4)-(5).

In chapter 4, the procedure for registration and fitness of vehicles have been included. Rule 52 of this chapter provides exemption of registration fees for freedom fighters. Under rule 48, one can appeal against an order of cancellation of registration.



Chapters 5,6 and 7 deal with other issues including formation of a transport committee, regulations for vehicle manufacturing, assembling vehicle parts, traffic rules and environmental protection compliance. Use of silencer in motor vehicles has been made mandatory under rule 83. Also, rule 86 has prohibited the use of any vehicle that causes excessive sound. The standard use of helmets for bikers have been included in rule 136, which was absent in the 2018 Act.

Chapter 8 of the Rules provides for compensation to victims in case of accidents and treatment to such victims. Financial assistance fund under a trustee board will be formed under rule 142. The amount and form of the compensation and all relevant details have been mentioned under this chapter. Chapter 11 spells out fines and penal sanctions for violation of any provision under the Rule.

Rule 160 grants power of appeal to anyone, who is aggrieved due to an order under the provisions of the Rules except chapter 9, within 30 days from such order. Digitisation of all possible services and formation of a central database server for preserving all data of the services must be made as per rule 165 of the last chapter.

Even though the Road Transport Rules, 2022 has many new features, it also has some loopholes. Under rule 125, speed limit for vehicles has been provided but no monitoring direction or guideline for punishment for breaking the speed limit has been mentioned. There is also no clear provision for fastening seat belts and children crossing

The Rule has failed to provide any clear provisions to force transport owners to pay compensation to the victims. It has rather replaced the victim's right to sue motor vehicle owners with the right to apply for "financial aid" from a Financial Aid Fund through an executive process and not through the intervention of any courts or tribunals. There is also no provision for a Motor Accident Claims Tribunal unlike the previous Motor Vehicles Ordinance, 1983 which has now been replaced with the 2018 Act.

To end, although the new Road Transport Rules, 2022 can be appreciated for making some positive provisions for, such as, guaranteeing driving licence for persons with disabilities, exemption of registration fees from freedom fighters, stricter provisions for licence holders, bikers and conductors of public transport and so on; it has failed to make transport owners liable with hefty prices if their vehicles kill or injure any

Buttler leads Eng squads for Bangladesh tour

There were a lot of speculations probable regarding first-team omissions due to scheduling conflicts and players' lucrative franchise commitments but England boasted their depth on Thursday when they announced strong squads, led by Jos Buttler, for their upcoming white-ball tour of Bangladesh.

England will play three ODIs and as many T20Is in Bangladesh from March 1 to 14.

England picked teenage legspinner Rehan Ahmed in their whiteball squads for the first time. The 18-year-old Leicestershire bowler became England's youngest men's Test cricketer against Pakistan in Karachi in December and marked his debut in style with a five-wicket haul.

Rehan had played just three firstclass matches before making his Test bow, but has more experience in white-ball cricket, having appeared regularly for his county side.



Uncapped Somerset batter Tom Abell, who is set to captain the England Lions in the upcoming ODI series in Sri Lanka, was also included in both squads.

Pacer Saqib Mahmood, who was named in the ODI squad, made his return to the England squad for the first time since suffering a stress fracture of the back in May last year.

Alex Hales was one of the major omissions as he opted to forgo the tour to honour his lucrative contract in the Pakistan Super League, while Liam Livingstone and Johnny Bairstow remained unpicked due to

Members of the Test side like Joe Root, and Harry Brook were not included as they would conclude their Test duties in New Zealand on February 28 but Ben Duckett and Will Jacks are set to make the tour having been selected for the T20I side.

Chandika Hathurusingha's has been viewed positively around the corridors of the Bangladesh Cricket Board (BCB), with his reappointment having been handled personally by BCB president Nazmul Hassan. But not everyone has been as welcoming to Hathurusingha, who left the Bangladesh team on a sour note in 2017 despite his reputation as the Tigers' most successful coach.

His tenure with Sri Lanka Cricket (SLC) ended in far worse circumstances, with legal disputes needing to be handled by the Court of Arbitration for Sports (CAS) before the SLC finally terminated his contract and levelled charges against him for failure to maintain good relationships with players and failing to prepare the side for assignments.

Farugue Ahmed, who had served as chief selector during Hathurusingha's previous term, was among those who did not see the Sri Lanka's return in a positive light.

"I don't think Hathurusingha's inclusion is a very good decision. Reason number one is the way he left Bangladesh cricket at a very crucial time without giving us any opportunity or time to find another coach. When something like that happens and we go back to the same coach, it means we don't have any options and the coach might behave worse than he used to before," Faruque told The Daily Star regarding BCB's decision to bring back the

looming. Faruque believes that more than bad thing. His resume is not strong enough. performance, team atmosphere has to be

"There will be less accountability and it will always be on his mind that there were no options so whatever he does is okay. Performance is one thing; we want to see Bangladesh winning. But at the same time atmosphere so that everyone does their job the right way.

Under-20 girls looking to regain dominance

Having narrowly missed out on the SAFF U-18 Women's Championship title in March last year, Bangladesh, regional powerhouses in women's football, have the immediate opportunity to taste success as they begin the SAFF U-20 Women's Championship campaign at home, taking on Nepal on the opening day today.

The match will get underway at the Birshreshtha Shaheed Mostafa Kamal Stadium in Kamalapur at 7:00pm after India and Bhutan, the two other teams in the four-team championship, square off at the same venue at

The four teams will first play in a roundrobin stage before the top two teams advance to the final, slated for February 9.

Bangladesh have dominated women's agegroup football alongside India in the South Asian region since SAFF introduced age-group events in 2017. In the past four years, SAFF has staged seven championships for girls from the U-15 to U-20 level. Bangladesh have won three titles while finishing second on four occasions.

They had to settle for second place in the SAFF U-18 Women's Championship last year owing to an inferior goal difference against eventual champions India. The year before, Bangladesh won the title by beating India at home. This event will be an opportunity for Golam Rabbani Choton's charges to get their success story back on track.

"The SAFF age-group events started with a U-15 tournaments in 2017 and we emerged champions. We have played in each of the finals of each age-group tournament since. Our target will be to continue that trend," Choton said at a pre-event press conference vesterday.

Bangladesh's maiden title at the senior level came in September last year, when they beat Nepal in the final of the SAFF Women's Championship in Kathmandu, and will provide extra motivation to this group of players, quite a few of whom have already played at senior level. The recently-concluded domestic women's football league will help keep the players in form, Choton believes.

"The league finished on December 31, and training camp began the next day. Our focus, apart from working on technical and tactical aspects, was to maintain physical and mental fitness," Choton said, adding that this event would go towards preparations for the AFC -20 Championship Qualification campaign, which will begin in March.

Bangladesh captain Shamsunnahar said she wanted to win the title to banish the haunting memories of near misses. "Bangladesh finished as runners-up twice in age-group SAFF events while I was playing. Maybe next time I won't be eligible to play at the age-group level. So I want to win this title," the striker told media.

Nepal coach yam Prasad Gurung and captain Preeti Rai expressed a determination to put up a good fight in the tournament.

LPG price sees steep increase

12kg cylinder to cost Tk 266 more

The price of Liquefied Petroleum Gas has been hiked by Tk 22.15 per kg to Tk 124.85 from the previous price of Tk 102.70 for the month of February.

Bangladesh Energy Regulatory Commission (BERC) announced its latest price through a press release vesterday. As per the new price, a 12kg LPG

cylinder, the most common form of marketing the product, will cost Tk 1,498, Tk 266 up from the previous Contacted, an official of the BERC

said the excessive price hike was the result of a huge increase in the price of the Saudi contract price (CP).

Last month, as per the Saudi CP, the LPG price was \$599.59 per tonne while the current month's CP was set at \$790 per tonne, he added.

Bangladeshi LPG operators usually import their products from Middle-East markets on the basis of Saudi CP.

PM to attend LDC5 in Qatar next month

May visit Japan in April, **India in September**

Prime Minister Sheikh Hasina is likely to make three state visits this year -- first to Qatar in March, then to Japan in April, and India in September.

In Doha, she will be participating in the fifth UN conference on Least Developed Countries (LDC5) to be held from March 5-9.

The PM's participation was discussed at an inter-ministerial meeting, chaired by Foreign Secretary Masud Bin Momen, on January 30, said Seheli Sabrin, director general of the foreign ministry's public diplomacy wing and the ministry's spokesperson, yesterday.

"The issues to be raised by Dhaka in the LDC conference are yet to be finalised," she told this correspondent after a weekly press briefing at the ministry

The LDC5 is a once-in-a-decade opportunity to accelerate sustainable development in places where international assistance is needed most and to tap into the full potential of the LDCs, helping them progress on the road to prosperity.

Neanderthals hunted massive elephants: study

Neanderthals may have lived in larger groups than previously believed, hunting massive elephants that were up to three times bigger than those of today, according to a new study.

The researchers reached their conclusions, published in the journal Science Advances on Wednesday, based on examinations of the 125,000-year-old skeletal remains of straighttusked elephants found near Halle in central Germany.

The bones of around 70 elephants from the Pleistocene era were discovered in the 1980s in a huge coal quarry that has since been converted into an artificial lake.

Elephants of the time were much larger than the woolly mammoth and three times the size of the present day Asian elephant, and an adult male could weigh up to 13 metric tonnes.

"Hunting these giant animals and completely butchering them was part of Neanderthal subsistence activities at this location," Wil Roebroeks, a co-author of the study, told AFP.

"This constitutes the first clear-cut evidence of elephant hunting in human evolution," said Roebroeks, a professor of archaeology at Leiden University in the Netherlands.
