

# 'Why should we continue subsidies?'

PM tells consumers to pay actual cost of gas, power



UNB, Dhaka

Prime Minister Sheikh Hasina yesterday said consumers should pay the actual purchasing cost of gas and electricity to avail the utilities' supply.

"Gas and electricity supply can be provided if all agree to pay the purchasing costs. How much subsidy can be given? And why should we continue subsidies?' she said, adding that the government is providing subsidies to agriculture and food production for the nation's greater interest.

The PM said this while opening the newly constructed "Biniyog Bhaban" (Investment Building) of Bangladesh Investment Development Authority (BIDA) in the capital's Agargaon.

# Business groups influencing state policies

Say economists at Sanem meet

Influential business houses and groups are exerting their influence in order to make rules favourable to them, said a number of economists yesterday. An example of

influence is visible through the retaining of the taka overvalued for a long time to support importers, the focus on the import of liquefied natural gas (LNG) instead of exploring gas resources locally, the electricity purchase through quick rental power plants, and various other regulations.

The issues came at a discussion at the 6th Sanem

Annual Economists Conference at the Brac Centre Inn organised by the South Asian Network on Economic Modeling (Sanem).

At the discussion styled "Regulation has become a source of capital accumulation," Debapriya Bhattacharya, a distinguished fellow of the Centre for Policy Dialogue (CPD), said since independence, capital accumulation has taken place in Bangladesh through the grabbing of abandoned properties, foreign-aided projects, the defaulting on loans taken from specialised banks in the 1980s, and the manipulation of stock markets.

### 'You are killing us' **HC blasts DoE** over air pollution

The High Court yesterday rebuked the Department of Environment for its inaction in curbing air pollution Dhaka's despite repeated directives.

"Air pollution in Dhaka was ranked highest in the world this [yesterday] morning too, though we had issued specific different times to control it. There is no reflection of the directives

"They [DoE officials] have the responsibility to control the pollution. They are neither abiding by the law, nor complying with the court orders ... You are killing us by not curbing the air pollution, as it is bringing increased risks to the public health...," the HC bench of Justice KM Kamrul Kader and Justice Mohammad Ali told DoE lawyer Amatul Karim Swapna during the hearing on a writ petition.

Bangladesh has a low risk of external and overall debt distress despite higher external borrowing in recent terms, said the International Monetary Fund.

"External and overall debt indicators below their respective thresholds under the baseline,' said the IMF's debt sustainability analysis (DSA), conducted to inform its executive board's decision on the \$4.7 billion loan application

Bangladesh. At the end of last fiscal year, the country's total debt external \$166.1 billion, which is 39 percent of GDP and well below the threshold of 55 percent.

# Adani plant to begin transmission from March

No scope for coal price manipulation, says Nasrul

There is no scope of manipulation in coal pricing by Adani Power as the rate will be fixed as per the Newcastle Index, the main price reference for physical coal contracts in Asia, said Nasrul Hamid, the state minister for power, energy and mineral resources.

"We will get coal at a competitive price in the international market -- there is no scope of manipulation in the pricing," he said at a briefing held at the secretariat yesterday.

The coal price for the Adani Godda power plant will not be more than the Payra power plant, said Power Secretary Habibur Rahman, who was also present

at the briefing.
Bangladesh Power Development Board (PDB) pays \$245 per metric tonne for the coal used in the Payra power plant

in Patuakhali, according to a report prepared by the Power Cell in January. It pays \$254.38 per metric tonne for the S Alam power plant in Chattogram's Banshkhali and the Rampal power plant in Bagerhat, and \$270 for the Barishal 307MW coal-fired power plant,

according to the report.

### Idols desecrated at 12 temples in Thakurgaon

Unidentified criminals desecrated 14 idols of Hindu gods and goddesses at 12 temples in Thakurgaon's Baliadangi upazila early vesterday.

The temples are located at Shindurpindi, Collegepara, Kamatpara, and Shahbajpur areas in the upazila, said locals and police.

"I have a temple in front of my house. Like every other day, I woke up early in the morning today [Sunday] and went to the temple for prayers. But I found that the idol of goddess Laxmi was vandalised," said Dulal Chandra Singha, 40, a resident of Shindurpindi.

Similarly, Shamvu Ram Singha, 40, of Kamatpara village, said, "The idol of lord Krishna was vandalised in my temple.'

Both of them said that the incidents sometime between happened Saturday night and the early hours of

"The criminals were very quiet because we did not hear anything,"

"There were idols of various gods and goddesses including Saraswati, Laxmi, and Manasha in these temples. The criminals vandalised these idols to intimidate local Hindu communities," said Tapon Kumar Ghosh, general secretary of Bangladesh Puja Udjapan Parishad's Thakurgaon chapter.

Contacted, local MP Md Dabirul Islam, said, "We have a long history of communal harmony existing in our area. But, vested quarters are trying to ruin the peace. We have asked law enforcers and local administration to catch the perpetrators immediately."

On information, the deputy commissioner and superintendent of police visited the spots and assured that the criminals would be brought to book shortly.

A case was filed with Baliadangi Police Station against unnamed criminals in this connection.

"Police are trying to trace the criminals within the shortest possible time," said Khairul Anam, officer-incharge of Baliadangi Police Station.

# **Battle for Bakhmut** intensifying

Says head of Russia's Wagner group as Ukrainian forces 'fighting to the last'

Heavy fighting was underway in the northern parts of the frontline hotspot Bakhmut yesterday, while Russian missile strikes on Ukraine's second-largest city Kharkiv wounded five people.

Despite the flow of Western weapons to Ukraine, Russia has in recent days claimed gains around war-ravaged Bakhmut in the eastern region of Donetsk.

However, the head of Russia's mercenary group Wagner said yesterday that the Ukrainian army was not retreating and that fighting raged on in northern parts of Bakhmut.

"In the northern quarters of Artemovsk, fierce battles are going on for every street,

every house, every stairwell," Yevgeny Prigozhin said in a statement, referring to Bakhmut by its old name.

"The Ukrainian armed forces are fighting to the last," he said.

Russian forces have been trying to seize control of Bakhmut in the eastern region of Donetsk for months in what has become the longest and bloodiest battle since Russia invaded Ukraine last February, reports AFP.

The fight for Bakhmut has turned the town with a pre-war population of roughly 75,000 into a ghost town dotted with hedgehog anti-tank defences and burnt-out cars. The town has no water, gas or electricity.

### Rohingya man shot dead in Ukhiya

A Rohingya man was shot dead by criminals early yesterday in Ukhiya, Cox's Bazar.

Noor Boshor, 33, of Kutupalong refugee camp, was a night guard for an NGO based in the camp, said Syed Harun-ur-Rashid, additional deputy inspector general of the Armed Police Battalion (APBn).

Quoting family, he said, Noor left home for work early in the morning. His body was later found on the road

at Kutupalong-2 (east) camp.  $\hbox{``On information, APBn members rushed'}$ 

to the spot and recovered his bullet-hit body," said Syed Harun, also commanding officer of APBn-14 in Cox's Bazar. Police initially suspect that the killing

might have taken place as a result of an internal feud between the Rohingya refugees inside the camp.

### Relocation of zero-line Rohingyas begins

The process of relocating stranded Rohingyas who fled into Bangladesh territory from a zero-line refugee camp amid violence began yesterday. To this end, at least 180 Rohingyas from 35

families were taken to a transit camp in Ukhiya's Kutupalong, said Refugee Relief and Repatriation Commissioner Mohammad Mizanur Rahman. They are among the nearly 3,000 people who

fled the gunfights between two Myanmar armed groups near the Tambru border of Bandarban's Naikhongchhari upazila.

After overstressing the engines during a flight, it was mandatory for them to file an air-safety report. This would have ensured the immediate grounding of the aircraft, inspections of the engines, and if needed, replacement of the engines

Filing the report is a Biman flight safety protocol. The pilots did not do that.

allegedly erased the They "maintenance message and fault code message" that should have automatically popped up in the plane's instrument panel. This is according to multiple investigation reports prepared for the government by several agencies, including Biman.

Everything the pilots tried to hide, however, came out because the Dash-8's engines automatically reported to its maker Pratt & Whitney that they had been damaged and let the cat out of the bag.

Biman conducted an investigation but the findings of the investigation report, submitted in March 2022, never saw the light of day.

Biman also had to pay Tk 16.5 crore to fix the plane which was just a vear old. This incident also jacked up insurance premiums for all aircraft in Biman's fleet.

When The Daily Star asked about why he did this, the pilot who was in command refused to comment. THE MISTAKES, COVER-UP

The damage was done during the 2:20pm flight BG601 from Dhaka to Sylhet on February 1, 2022. The plane had 71 passengers.

The pilot in command was 42-yearold Capt Ali Rubyat Chowdhury and his first officer was 27-year-old Rafi Uz Zaman. At the time of the flight, Ali Rubyat had eight times more flying hours under his belt than Zaman.

The investigation report states that the plane took off at 2:33pm and at 2,000 feet altitude, the pilot set the airspeed to 165 knots (nautical miles per hour), which was 20 knots less than the standard operating procedure for the plane.

"As per approved Dash-8 Q400 standard operating procedure, normal climb speed is 185 knots,"

said Biman's investigation report.

While climbing the next 9,790 feet, the pilot changed the airspeed thrice in four minutes, before finally setting it to 170 knots.

The pilots deliberately concealed wanted to climb faster to avoid turbulence and "wind shear", or [thunderclouds] cumulonimbus clouds. This technique to climb out of the weather is not supported by the standard operating procedure," said the report. The meteorological report for the day said that there was "no significant cloud".

The pilot said that they hit turbulence at 12,000 feet just a few seconds after he set 170 knots airspeed.

He said that 12 seconds into the turbulence, the "ice detected" light flashed, meaning ice had started forming on the wings.

However, his statement was not supported by the flight data recorder, which is popularly known as a black box and is an electronic recording device that all commercial planes have to facilitate incident investigations.

As the aircraft's speed was 15 knots below the standard minimum of 185, to begin with, the icing conditions supposedly sent the plane's speed plummeting, the pilots claimed.

"As the selected speed was 170 knots, the speed went [...] to 162 knots," said the report, adding, "They [the pilots] could not recognise the speed requirement in icing

As per the aircraft's manual, they should have maintained 210 knots above 10,000 feet, the report said.

Setting 170 knots was in violation of standard procedure, it added.

The pilots claimed that they were losing altitude but the flight data recorder mentions nothing of that

When the speed supposedly dropped to 152 knots, the pilot disengaged the autopilot and pushed both engines to "emergency" power level, which compromises engine components.

The turbine temperature shot up by over 100 degrees. The temperature should have been 880 degrees Celsius tops, but it shot up to 1,004 and 1,006 degrees Celsius, causing metals inside the engines to melt.

The report states that yanking the plane into emergency power was a deviation from the aircraft operating manual. This power level is for emergencies like trying to avoid a mountain and once this is used, the

and if needed, overhauled.

While explaining as to why they put the engines on emergency mode, the pilots told the investigation "The captain said that they committee that there was severe aircraft," said the report. erratic winds over a short distance.

"It was in their words, a life and death situation, still they did not submit any air safety report," noted the investigators. This is a violation of the safety manual.

In addition, the operations manual says that if the plane is pushed to emergency power, it is to be reported to the aircraft maintenance log, but that was not done either.

"Both the captain and first officer mentioned that after landing [at Sylhet], the captain advised ground engineers to check for any defects/ fault messages in the audio and radio control display unit [ARCDU], and the airframe [plane's structure]. So there were suspected defects. Instead of writing the details of suspicion they recorded 'nil' in the aircraft maintenance log," said the investigation report.

There is more: the committee found that ARCDU had no message about the engines' parameters having been exceeded and suspected that the pilots had erased it.

"It appears that either no maintenance message was displayed due to an aircraft system glitch or because the message was erased," said the investigators.

Another report by a government agency said, "The pilot tried to hide the whole incident by wiping out the maintenance message on the ARCDU.'

### HOW THE COVER-UP FAILED

Approximately an hour after the plane landed in Sylhet, Biman Engineering Services got a notification from Pratt & Whitney.

"CAMP Systems Canada, the engine manufacturer nominated vendor, provides Engine Health Monitoring Services for Biman Dash 8-Q400 fleet. [...] the three brand new Dash-8 Q400 aircraft can transmit data automatically," said the report.

This newspaper has a copy of the notification sent by CAMP.

Biman Engineering Services told the Maintenance Control Centre to investigate, but they could not find any pilot report about such an incident or maintenance message in the plane's systems.

Both analysed the data and recommended grounding the plane and taking the engines out and sending them to an overhaul facility.

But by then, the plane had flown seven flights, any of which could have ended in a disaster, said the investigation report. Repairing the engines cost Biman Tk 16.5 crore "since the damage of

the engines was solely the pilots'

fault". That's why the insurance company did not bear the cost, said a show-cause order signed by Biman Managing Director Shafiul Azim on December 20, 2022. In addition, the plane had to be grounded for three months, leading to a decrease in the number

of domestic flights, and depriving Biman of major revenue at a time when the company was still paying monthly instalments and insurance premiums for the aircraft.

The insurance premium of this aircraft was also hiked by a large margin, according to the document.

Insiders said that all the aircraft in the fleet saw a similar hike as a result of this incident.

When asked for an explanation, the pilot blamed the turbulence and wind shear. In an email sent to the deputy

chief of safety on February 13, 2022, Capt Ali Rubyat claimed that they "suddenly got hit by severe wind shear" and "both of us were struggling to keep the aircraft's wings level and prevent altitude loss because of the violent force of the shear".

But multiple investigations called him out on that. "It is evident from a holistic review that the pilot either has no idea about wind shears or is knowingly taking refuge in falsehood," said one report prepared for the government. The Biman probe stated, "They

"The loss of situational and system awareness was created partially by the turbulence but mostly by their deviation from the standard operating procedure," said Biman's investigation.

In the show-cause order signed in December, Azim said that the pilot's "unprofessionalism and lack of responsibility can be construed as misconduct".

Biman insiders stated that Capt Rubyat violated sections 29 and 33 of the civil aviation act, which criminalises unsafe flying of aircraft, and risking peoples' lives as a result. It carries the death penalty or life

imprisonment and a Tk 5 crore fine. Furthermore, section 27 has provisions for punishing a pilot who "fails to submit or refuses to submit a report required to be submitted under this act, rules" or someone who files a fake report.

But that did not stop Biman's admin head from including Capt Rubyat in a list of pilots for promotion, as per an order dated January 22, 2023.

Capt Rubyat had been issued a show-cause just a month before. The pilot of the 74-seater Dash-8 was promoted to captain of Boeing 787-8, -9 and Boeing 777 300ER. The 787s can seat up to 298 people and the 777s, up to 419. The prime minister uses these aircraft for her foreign trips.

Biman Managing Director and CEO Shafiul Azim said Biman's Command Board made recommendation for his promotion.

The Biman's Command Board is composed of the flight operations director, chief of flight operations, chief of technical and other chiefs of departments with the Biman MD as

the chair. The Biman boss said although the Biman's Command Board made the recommendations for Ali Rubyat's promotion, he would not be able to avail the post until he was cleared by the authorities.

# Proposed data protection law may bring down FDI

Say US, UK envoys

STAR REPORT

The US and British envoys in Bangladesh yesterday expressed concern over the flow of foreign direct investment (FDI) into Bangladesh if the proposed Data Protection Act is enacted, as the law may negatively affect business.

Foreign and local investors may have trouble using data freely through international tools if the DPA is enacted, they said at a discussion on "Online Freedom and Business Investment in Bangladesh", organised by the US embassy in Bangladesh and held at Dhaka's EMK Centre.

The Bangladesh market is very attractive to US investors, said American ambassador in Bangladesh Peter Haas. "For this very reason, we recently opened a Foreign Commercial Service office at the embassy.

"But at the same time, we hear apprehension from businesses that new laws and regulations will make it more difficult for them to do business here," Haas said in his written speech.

The US has concerns about the regulations on digital, social-media, and over-the-top platforms introduced by the authorities and the DPA. "Because we value our partnership with the government of Bangladesh, we have voiced these concerns directly with the government," he

# EC in dilemma over using latest census

STAFF CORRESPONDENT

The Election Commission on Tuesday will finalise its decision on whether it will use population data of the 2011 census or wait for the final report of the latest one to delimit parliamentary constituencies.

The commission is yet to begin delimitation of constituencies, a vital job ahead of the next national election, due to unavailability of the final report.

According to the delimitation law, boundaries of Jatiya Sangsad constituencies should be redrawn considering administrative each constituency convenience, should be geographically intact, and population be distributed as per the final census report.

A top EC official said the election commissioners will sit in a meeting on Tuesday to discuss how to delimit areas. At the meeting, they might take the decision to use 2011's data, as they want to complete the process by June.

If they wait for the final report, they will not be able to complete the job by June, officials said.

EC sources said the commission might put emphasis on maintaining administrative convenience and keeping areas intact while redrawing constituencies this time.

Election Commissioner Md Alamgir yesterday said they will hold a meeting of commissioners on Tuesday for primary discussion on finalising how delimitation work would progress.

"The law first cites administrative convenience and then talks about keeping geographical areas intact. convenience." It puts less emphasis on population

distribution," he said.

Alamgir said it is tough to redraw constituencies aiming for equal distribution of population for each constituency.

Referring to delimitation ahead of the 11th parliamentary election, Alamgir said, "You will see that there were three lakh people in one constituency and 12 lakh in another. If we want to distribute the population equally, then it will be tough for us to maintain administrative





# Abducted boy yet to be traced after 10 days



# MoU with Malaysia

According to the expatriates' welfare ministry, under the MoU, the employers in Malaysia are obliged to bear Bangladeshi workers' migration costs incurred in that country.

The costs include the service charge of the Malaysian recruiting agency, travel to and from Malaysia. and accommodation.

Moreover, the employers will pay the immigration, visa, medical test, insurance, Covid-19 test, and quarantine fees in Malaysia.

Besides, the expatriates' welfare ministry has set the maximum cost of migration at Tk 78,990 at the Bangladesh end to send a worker to Malavsia.

Addressing reporters, Imran Ahmad said there was no fixed agenda for the meeting as the Malaysian minister was on a 'working-visit".

However, various other issues regarding the migrant workers' wellbeing, including migration cost, were discussed at the meeting, he said.

"The only thing we were talking about is to send people through a smooth process and at a low cost."

Malaysian Home Minister Saifuddin said his country's position is to have a system to make things easier and achieve the "final objectives", which would fulfil the demand of foreign workers, reduce screening.

He also said they have cut off the application approval process for foreign workers' recruitment from the previous 20-30 days to within three days at present.

"It's a major policy shift," he

Saifuddin also said in the first week of the ongoing labour recalibration programme, which started from January 27, Bangladeshi migrant workers constituted about 55 percent of those who were given approval.

He added that of about 1.5 million foreign workers in Malaysia at present, there are about 4,45,000 Bangladeshi workers, constituting largest foreign community there.

This shows the importance of Bangladeshi workers' contribution to the Malaysian economy, he said, adding, Bangladeshi workers are mainly employed in manufacturing, construction, and service sectors

Also adding that there was no hidden cost on their part in workers' recruitment, the visiting minister said at present, apart from levy, they charge 20 ringgit for immigration, 100 ringgit for biomedical, 100 for visa processing that goes to the agent, and another 100 for health

# Brutal cold grips northeast US

### Lowest ever wind-chill temperature recorded; infant dies in Massachusetts

A dangerous combination of record-setting cold temperatures and powerful winds buffeted the northeastern United States on Saturday, creating lifethreatening conditions and causing the death of an infant in Massachusetts.

New Hampshire's Mount Washington overnight recorded a wind chill - a measure of how the combined effect of air and wind feels to the skin - of minus 108 degrees Fahrenheit (-78°Celsius), which appeared to be the lowest ever in the United States. The air temperature at the peak reached minus 47 degrees F (-44 C), with winds gusting near 100 miles per hour (160 kilometers per hour), according to the Mount Washington Observatory.

The high winds brought a tree down car in Southwick, Massachusetts, the Hampden district attorney said in a statement, crushing the vehicle and killing an infant passenger. The driver was transported to a hospital with serious injuries.

In Boston, where officials closed down the public school system on Friday due to the impending freeze, the low temperature hit minus 10 degrees F (-23 C), shattering the day's record

set more than a century ago, the NWS said. In Providence, Rhode Island, the mercury dropped to minus 9 degrees F (-23 C), well below the previous all-time low of minus 2 degrees F (-19 C), set in 1918.

The arctic blast flowing into the United States from eastern Canada brought record lows to Albany, New York; Augusta, Maine; Rochester, and Worcester, Massachusetts, among other places, the NWS said.

The NWS office in Caribou, Maine, said it had gotten reports of "frostquakes" - tremors that feel like earthquakes but are caused by the soil cracking suddenly in the cold - as well as trees splitting open, likely due to sap freezing inside the trunks.

Several cities took emergency measures to aid residents, including opening warming centers and conducting outreach to ensure homeless people were sheltered from the brutal cold.

# We must check relentless price increase

### Lack of action to bring down prices of food is deeply concerning

If 2022 was a year of suffering for the poor and people of fixed income - with the cost of living reaching absurd heights – 2023 in its second month already promises to surpass that sad milestone. In January, within the space of just three weeks, the government twice increased the prices of electricity. In the first week of February, the price of LPG has seen steep increase, while an earlier increase in gas prices for industries, power plants and commercial establishments has come into effect. The relentless increase in fuel, gas and electricity prices – and therefore in transport and production costs - already threatens to take essentials further beyond the reach of consumers.

Unfortunately, beyond excuses and sentimental claptrap, our leaders have failed to offer a way to reduce suffering. It's almost as if the poor are expected to somehow make their needs disappear using their magic wand, uncritically accepting the government decision to withdraw subsidies from the energy sector at a time when they are at their most vulnerable. A report by this daily shows us the level of suffering this has caused. A 60-year-old security guard tells us that his family of nine has to borrow to meet basic requirements, despite their collective income of Tk 40,000. A bank clerk says he has cut down on his intake of bread at breakfast against his doctor's advice – with the prices of flour, along with rice and soyabean oil, soaring by up to around 20 percent in a year.

The government's response to this hike-fest has been minimal at best, and non-existent at worst. Even the prices of food items that remain usually low in winter, like potatoes and vegetables, have not come down, suggesting the collapse of any market regulation mechanism that it has. Many have also complained that, for essentials like LPG, they are being charged more than the prices set officially. And it is not just the people of the low-income groups, but middle-income people are also suffering greatly, as the Consumers Association of Bangladesh (CAB) revealed last month. Analysing the pricing trend in Dhaka, the CAB said that the average annual inflation rate in 2022 was 11.08 percent.

Clearly, we have reached a point where drastic action is needed to reverse this trend and minimise people's suffering. We agree with the PM that gas and electricity cannot be subsidised indefinitely, but this is neither the time to fully abandon subsidies nor should the IMF's loan conditions be the only driver behind any reform measures being planned. People's long-term and immediate interests should both be considered while undertaking these reforms, and proper execution is a must to ensure maximum benefits. People's immediate interests dictate that the absurdly high prices of essentials, caused by the energy price hikes and lack of market regulation, should be urgently reduced.

Moreover, the government should consider expanding its social security programmes to reduce the impact of high inflection on the poor, and also take steps to raise the income level of ordinary citizens, including the middle-class. The government must prove its sincerity to understand and address their problems.

# Today's readers, tomorrow's leaders

### Govt must take better care of public and private libraries

Libraries play a crucial role in fostering knowledge for people of all ages and backgrounds. Good libraries act as learning hubs, providing not just books but also various learning opportunities. Libraries are also important because they provide a secure and inclusive environment for people to widen their knowledge, skills, and viewpoints. Investing in libraries is thus an investment in our society's future.

Sadly, we see the exact opposite of this happening at the state-run National Book Centre, which is responsible for all the private libraries in the country, giving grants to more than 1,200 of them presently, according to a report by *Prothom Alo*. However, the office of the centre is located in a traffic jam-prone area (Gulistan) and is hardly noticeable from outside, making it difficult to access it. The activities of the centre are also questionable. Currently, it provides so little annual funding that affiliated libraries can only cover one to two months' expenses with that. The centre has the added challenge of ensuring that the libraries that are getting donations are using them properly, which it often fails to do. Therefore, it is crucial that it maintains the standards of these libraries so that they can encourage and enlighten readers. Readers should be able to access a diverse range of books from these libraries, and their overall environment should be user-friendly.

We may have already entered the era of the fourth industrial revolution where building a knowledge-based society is key. The only way to do that is to have good libraries that are easily accessible to the public. But many libraries in the country are underfunded, understaffed, and frankly, not aligned with the goals of a library. The poor condition of many public and private libraries – which often do not have a wide range of books, and have rather become a hub only for BCS candidates – suggests that the authorities are unwilling to support the drive for the

enlightenment of the people, especially the younger generation. Enlightenment requires that people are able to read profusely, critically engage with diverse topics, form their own opinion, and freely share it with their peers. The plight of our libraries, however, represents a shrinking of the space needed for that kind of intellectual engagement in the country. Such engagements are vital for a healthy democracy and the future of our nation. Instead of encouraging it, the authorities seem to be increasingly allowing barriers to this exercise – through allowing a decline in the quality of libraries, through restricting critical publications, through punishing dissenting voices with the help of various draconian laws, etc.

We, therefore, urge the government to stop this misguided strategy, and encourage free-flowing intellectual interactions for the sake of our nation. And it must improve the condition of all existing public and private libraries, and thereby make knowledge accessible to all.

# What threats does ChatGPT pose to our academia?

US-based artificial intelligence company OpenAI's Generative Pre-trained Transformer 3 (GPT-3) technology, including ChatGPT, has brought about a revolution in the field of AI with its advanced language processing capabilities. Its widespread availability and accessibility bring both benefits and risks. There is potential of misuse, and educators and researchers must be aware of the risks associated with this

One of the ways in which students may misuse the GPT-3 technology is by using it to complete their assignments without actually understanding the concepts or the problem-solving strategies involved. This can lead to a dependency on technology and a lack of critical thinking and problem-solving skills. Developing these skills is essential for success in both education and professional career, and their absence can have a significant impact on a student's future prospects.

Another way in which students may abuse GPT-3 is by using it to plagiarise their assignments. Its advanced language processing capabilities make it possible to generate high-quality text, which can be tempting for students to copy and paste into their own work. This undermines the educational process and devalues the efforts of those students who complete their work independently. Plagiarism is a serious offence and can result in academic dishonesty charges, which can have a

lasting impact on a student's future. Researchers may misuse the GPT-3 technology by using it to manipulate or fabricate data, which can compromise the integrity of research and lead to significant consequences for both the individual researcher and the wider scientific and research community.

In addition, GPT-3 has the potential to perpetuate biases and harmful stereotypes. The technology is trained on a large amount of text data, which includes both explicit and implicit biases. If these biases are not addressed, they can be amplified and perpetuated through the technology's outputs. This can have serious consequences for marginalised groups and undermine the efforts to address societal inequalities.

How do we minimise the risks and maximise the benefits, then?

Our education system must integrate ethical and responsible use of these tools into the curricula, monitoring its impact on student learning and development. Strict ethical standards for research must be adopted, addressing biases and harmful outcomes in the technology's outputs, addressing the potential for malicious use and defining ways to prevent such.

Schools, colleges and universities must integrate new technology usage ethics into their curricula, and online assignment and exam systems, violations of which should be dealt with justified penalties. It's important to educate both the teachers and students about the danger of plagiarism and the consequences of academic dishonesty. Teachers need to provide students with new guidelines and scopes on AI-based text creation, critically evaluate them and avoid conflicts with independent thinking and problem-solving skills.

To restrict the misuse of GPT-3 technology by researchers, strict ethical standards and guidelines have to be installed to ensure adherence to ethical data collection and analysis, as well as prohibition of data manipulation or fabrication. Researchers should also be required to engage in even deeper and heavily engaged peer review and collaboration to ensure that their work is transparent, accurate, and reliable.

On the flip side, language models such as ChatGPT can help improve students' writing and communication skills, as long as it is used as a tool to support learning, rather than a replacement for it.

Bangladeshi school exams are mostly in written form, but there is a growing demand for introducing oral exams and verifying presentation skills comprehensively. In Bangladeshi universities, plagiarism is still a massive problem. In this circumstance, preventing plagiarism through an AI

tool requires new, improved measures. First, the University Grants Commission (UGC) as well as all the education boards must make the use of plagiarism software mandatory, Second, there must be new measures to prevent copy-pasting texts from AI-generated content. Thesis and assignments should be defended through new mechanisms to evaluate the students' understanding of the subjects as well as their critical-

thinking capabilities.

Monitoring ChatGPT's influence on learning and research, and addressing research biases and other harmful aspects of the technology's outputs should be taken as a serious concern. The curricula has to be orchestrated and developed in a new way in the age of open source AI.

The UGC can create a dedicated national consortium body with subject matter experts from all fields of education Bangladeshi educational institutions. This body can ensure that none of the undergraduate, graduate and post-graduate research topics is partially duplicated and mirrored at the national level. The body can also monitor and nurture the quality of Bangladeshi thesis, journals and research papers.

Bangladeshi researchers are scoring extremely poor in the Scopus peer review database. According to the world's largest peer-reviewed database, in 2021, Bangladeshi researchers published only 11,477 papers against 222,849 from India and 35,663 from Pakistan. Bangladesh scores very poorly in other databases too. In the 2020 Scimago review database, Bangladesh had not a single Q1 and Q2 research paper.

In the Global Knowledge Index 2021, Bangladesh ranked 120th out of 154 countries. Bangladesh ranks 102nd among the 132 economies featured in the Global Innovation Index 2022. In the age of open source AI like ChatGPT, the research and innovation qualities of Bangladeshi students and researchers may get worse, so proper steps and actions must be taken now.

The series of extreme weather events in 2022 fuelled by climate change that devastated lives and livelihoods of millions – from the floods in Pakistan and China to droughts in Somalia, Ethiopia, Brazil, and Europe – set a clarion call for the long-awaited climate finance, also known as loss and damage finance. After years of hard negotiations, at the world's global climate change platform last year, the 27th Conference of Parties (COP27), countries agreed to establish a fund to pay for climaterelated losses and damages.

While this has given hope to many low-income countries that have felt the brunt of climate change, it has also left a lot of questions unanswered. What is the arrangement for this funding mechanism? Who will pay into the fund? Who is eligible?

#### Loss and damage finance decision at COP27

Loss and damage was the main topic addressed during the final negotiations at COP27, and the decision to establish and operationalise a loss and damage fund was one of the main talks around the halls. For nearly two weeks, the EU and the US refused demands from poor countries for a new fund to address loss and damage, arguing that existing funds should be redirected for the purpose. The final decision was adopted with the call from the EU to agree to a fund on condition that big economies and big emitters, who are still classed as developing countries under the rules of the United Nations Framework Convention on Climate Change (UNFCCC), should be included as potential donors and excluded as

Ever since the divergent decision at COP26, a number of countries and organisations have stepped up in making financial commitments. This bold step was initiated by the Government of Scotland, who initially pledged two million pounds towards addressing losses and damages, which then inspired the Government of Wallonia in southern Belgium and five more philanthropic organisations to put money for the cause. Since then, a few other countries and philanthropies have followed suit. It is, however, crucial to pinpoint the exact cause of each contribution, since not most of the pledges are for addressing losses and damages. The infographic summarises the monetary commitments from governments and philanthropies to loss and damage (note that the graphic only focuses on funds allocated to "address" loss and damage).

The Government of Scotland's contribution has been allocated for research among the climate vulnerable countries. Government of Wallonia allocated funds to ensure assistance for communities severely impacted by climate change. The Government of Denmark became the first central government of a developed country to propose funding devoted to loss and damage amounting to USD 17.7million, to be used for insurance

Likewise, Austria, another developed country, announced to provide USD 52 million to developing countries facing unavoidable damage and losses caused by climate change, in an effort to own up responsibility.

About USD 7 million will be managed by the Adaptation Fund, with the purpose of the Santiago

Likewise, the World Bank Group has announced a Global Shield Financing Facility, a joint initiative launched by the G7 and V20 nations of Germany, Canada, Ireland and France, collectively funding USD 211 million allocated for disaster risk financing (social protection, government bonds, etc) to vulnerable countries. The Government of New Zealand has allocated USD 12 million over a period of three years dedicated to improving early warning systems and disaster risk insurance in the Pacific countries. The Children's Investment Fund Foundation (CIFF), the European Climate Foundation (ECF), the Hewlett Foundation, the Global Greengrants Fund, and the Open Society Foundation (OSF), among other organisations, have announced a funding of USD 3 and civil society efforts focused at the million to strengthen resilience in

A USD 2 levy on every tonne of carbon the efficacy of raising ample capital dioxide emitted from burning fossil fuels could add up to USD 50 billion a year. Likewise, a levy such rapidly and meet the urgent needs as the International Air Passenger Adaptation Levy (IAPAL) is a proposed purchase tax on air tickets, the proceeds of which would be dedicated to investment in losses and damages. Another innovative mechanism is through the Bunker Fuel Levy, which is a unit tax linked to the establishment of an International Greenhouse Gas Contribution Fund that would collect a contribution on all ships over 400GT, differentiating according to the type of fuel used and proportional to the amount of fuel consumed. The private sector also has the potential to unlock the much-needed finance. Debt relief as part of an international finance architecture reform is another just mechanism to release finance for loss and damage efforts.

#### **Key asks for COP28**

To crystallise the details of the fund, a "Transitional Committee" has been set up, with representatives from both developed and developing parties, which is expected to meet by March 2023 to flesh out the details and make recommendations for COP28.

> While a lot of questions remain unanswered - mainly on who should be paying into the fund and who will be eligible to receive the funding the Transitional Committee should iron out the fund details with utmost urgency, drawing on the lessons from humanitarian aids and the past climate finance mechanisms such as the Green Climate Fund and Adaptation Fund. The fund must be fit for purpose, and fit for any future climate-induced disasters with proper governance structures, accountability and transparency mechanisms to enable effective deployment to the ones who need it most on the ground. In addition, a fair and consistent valuation methodology should be developed in consultation with both affected communities and donor countries. And once this is in place, it is important to ensure knowledgesharing and capacity-building of practitioners and communities to enable access and ensure that pledges can be distributed efficiently.

It is clear that the world has stepped into the era of loss and damage from human-induced climate change, and we need to collectively up our game to respond to the challenge. While the COP27 decision is welcoming and encouraging, this is only the beginning and, thus, success will depend on how quickly this fund gets off the ground. The funds should be set up by COP28 and be up and running by 2025. Failure to do so will result in an inevitable and catastrophic future for us all - the **explored.** time to act is now.



# Revitalizing Delhi's school system: A triumphant journey

The results of the Kejriwal government's efforts to tone up government school education are there for all to see. For the first time in the history of Delhi, the government schools got a **result of 99.9%** in Central Board of Secondary **Education** (CBSE) XIIth examinations in 2022, four Delhi government schools have ranked among top ten government schools in India

for 2021-22.

When Delhi Chief Minister Arvind Kejriwal hit the streets in India's national capital on January 16 this year to protest the alleged nonapproval by the Lt Governor Saxena to his government's proposal to send school teachers abroad for training, it was viewed by his critics as a move to politicize a burning public issue relating to school education. But more than that, it served to bring to the fore the issue of education that has largely remained on the backburner in India's political and electoral discourse.

In fact, education has never been a major poll issue for most Indian political parties except when it was framed in the freebies template like the promise of free schooling. You think of government or municipal schools in vast swathes of India's cities and villages and the images that spring up in your mind are of dilapidated buildings and stories of mismanagement, poor exam results, missing teachers and students and poor quality of mid-deal meal.

the last seven years, particularly after the party came back to power with an overwhelming majority in Delhi legislature winning 67 of the total of 70 seats. In fact, Aam Aadmi Party has brought to the fore education and health as poll planks in a way never seen before. It invested heavily and brought certain structural reforms to overhaul the government school education system which is accessed by the poorest of the poor segment of the

on 1,037 schools run by it to cater to nearly 180 lakh students in nearly 1,000 government schools. The 25 per cent budget has been consistently maintained for the last six years and is more than double what the previous governments spent in the previous seven years.

Delhi government figures show its investment on education as ratio to aggregate expenditure has risen to be the highest among all the states of India. The Kejriwal government focussed on refurbishing the school infrastructure, introducing innovative curriculums, changing the students' mindset, setting up high quality higher education institutes, promoting the spirit of entrepreneurship among students by setting up the Delhi Skills and Entrepreneurship University, Teacher's University and Sports University set up.

The Delhi government teamed up with experts and universities to design new curriculums and roped in private entities to clean hundreds of schools, employed former defence personnel But the Delhi government and Aam as "estate managers" on contract to on his core activity of teaching.

In 2016, the Delhi government made a path-breaking decision to establish school management committees, consisting of parents, teachers, and local officials, as a platform for articulating concerns regarding school education and holding the government accountable. The main goal was to decrease the trust deficit and communication gap among the three essential segments of education: students, teachers, and parents.

Section 21 of the Right to Education Act 2009 provides for the formation of School Management Committees government schools. These committees are expected to perform three core functions in addition to any other functions assigned to them. The AAP government made sure that elections were held in the SMCs after the two-year tenure of its parent-members had ended. The SMCs played a crucial role in streamlining the school admission process, which was often marred by complaints of favoritism and political influence, and in ensuring attendance of irregular students, two major areas of concern in the past. Other important measures taken included regular training of SMC members to increase their capacity and the introduction of an SMC App, which allows schools, parents, and other community members to directly connect with decision-makers.

The use of digital technology in the school admission process and a single admission form that allows for choice of any public school has ensured transparency and relieved children and their parents from having to visit multiple schools for separate admission forms. This was especially helpful for daily wage-earning parents who would have otherwise missed out on their earnings while submitting admission forms at different schools.

The Delhi government claims to have "significantly" increased its budget for teacher training programs, trained abroad in institutions such as Cambridge University, Singapore, and top Indian business schools such as the Indian Institutes of Management. recorded a cent per cent pass rate and In addition, 500 school principals have attended leadership sessions at the IIMs in Ahmedabad and Lucknow. Additionally, 102 school heads 398 schools a rate of over 90%.

This drive was a culmination of the learnings from a 'Chunauti (Challenge) 2018' which the government statistics say led to a 20 % increase in the number of students between class 3-5 who can solve arithmetic division problems, a 12 % increase (between pre-test and post-test) in the number of students in addition to the existing two between class 3-5 who can read a story in Hindi and a 15 % increase in children of class 6-9 who can read 'advance story' in Hindi. Besides, students have been provided financial assistance to achieve academic excellence. However, the creation of three separate groups of students faced some criticism on the ground of creating a feeling of discrimination and inferiority complex among impressionable minds at such a

During the pre-Covid academic year 2019-20, the pass rate of Delhi government schools was 94.24% in Class 12. The CBSE data say the pass percentage of Delhi government schools in Class 10 is 81.36%. Last year, the pass rate for Class 10 was 99.04% and during the pre-pandemic academic year 2019-20, the pass rate of Delhi government schools was 71.6% in Class 10. According to Delhi government data, in 2022, 160 government schools 876 schools recorded a pass rate of over 90% in Class 12. In Class 10, 95 schools recorded a 100% pass rate and

Buoyed by the results, 2.5 lakh children from private schools have shifted to government schools, according to Delhi government statistics, reversing a long-running trend. The Delhi government's efforts to turn around the story of its schools have already produced a change in people's attitudes. While no one expects an exodus from expensive private schools to government schools, the singular achievement of the Kejriwal government through its school education reforms is to challenge the prevailing negative perception about the quality of education and students in government schools. It has clearly demonstrated that students in government schools are no less inferior and may be equal to or even better than their peers in private schools, and there is no reason for condescension

from any quarters. According to official statistics, Delhi government school students have set another performance benchmark--336 girls, which represents 59% of the National Eligibility-cum-Entrance Test qualifying students. Additionally, 64 students have qualified for the Joint will be trained rigorously through Engineering Exams Advanced, and partnerships with renowned global five students have secured a seat in the organizations to improve their skills in Indian Institutes of Technology, which is the highest number from a single Delhi government school.

Starting from the 2021-22 academic session, the Delhi government established a new Delhi Board of School Education (DBSE) by granting affiliation to 30 government schools, consisting of 20 Schools of Specialized Excellence (SoSE) and 10 general schools. The DBSE signed a MoU with the International Baccalaureate (IB) to serve as its knowledge partner and receive support in curriculum and teacher training from the international education program. At a later stage, the option of affiliation will be offered to approximately 1,700 private schools, but it will not be mandatory.

The DBSE will be the third Board national boards, the Central Board of Secondary Education (CBSE) and the Council for the Indian School Certificate Examinations (ICSE). Education experts expect this move to increase competition among the three Boards regarding themes such as access to quality education and equity. If the DBSE schools provide quality education, students from economically disadvantaged backgrounds, who are part of India's aspirational class, can look forward to pursuing higher studies in premier institutions both in India and abroad.

The Delhi government has taken another major step in reforming school education with the motto "Catch them young." In an effort to instill an entrepreneurial spirit in students, the government launched the Entrepreneurship Mindset Curriculum in July 2019 in all government schools for classes IX to XII. It was decided that all students from class 9 to class 12 would receive Rs 2,000 each as seed money to foster an entrepreneurial mindset.

This was launched as a compulsory non-graded subject consisting of a 40-minute class every day for 25,000 students, who will be monitored over a four-year period. A program of student-entrepreneur interaction was initiated in October 2019 with the goal of creating more "jobproviders" in the country. To date, 539 schools have completed at least one entrepreneur interaction in their have shared their learnings.

The Delhi government has established its own secondary and higher secondary boards, including 20 Schools of Specialized Excellence (SoSE) and 10 general schools, which have partnered with the Australian Council for Educational Research (ACER), a research and assessment organization. Additionally, the government launched 20 Schools of Specialized Excellence in Science, Technology, Engineering, and Mathematics (STEM) to help students prepare for advanced careers and elite higher education exams.

Additionally, a school was established for students of social sciences, offering courses in sciences and mathematics based on student interest. The goal of the school is to foster a strong research mindset in its students.

The government has also placed an emphasis on skill and entrepreneurship development to help students become immediately employable and to pave the way for further studies and training at the university level. In terms of performing and virtual arts, students dance, drama, music, and visual arts, enabling them to become professional practitioners. By 2022-23, a total of 17 campuses are expected to be operational.

The two individuals regarded as the architects of the Delhi government's school education reform are Manish Sisodia, who is the Deputy Chief Minister and a close aide of Chief Minister Arvind Keiriwal, and Atishi. who is a former advisor to Sisodia. Atishi, who goes by one name, is an alumnus of St. Stephen's College in Delhi and Oxford University, and also a Rhodes Scholar in educational research.

The Kejriwalgovernment's education transformation system is a project in progress and a learning curve. Despite tangible achievements, the student-toteacher ratio in government schools is far from uniform and many school buildings still need basic upgrades. The government has to work on to set right certain fundamental weaknesses: 21,000 guest teachers still make up 38% of teachers in government schools and more than half of government schools are functioning without proper principals.

Kejriwal hitting the streets on the issue of the Lt Governor's reported holding up of the permission for sending school teachers for training abroad was symptomatic of how the issue of school education reforms can turn into a political tussle. It is a problem inherent in the very foundational structure of the Delhi government. Delhi, like most Indian states, is not a full-fledged state, does not enjoy autonomy in executing its own decisions and has to depend on green signal from the Lt Governor who is considered a representative of the central government controlled by the Bharatiya Janata Party. it is not just education but on several other areas the Kejriwal administration has had several confrontations with the Lt Governor in the past. It would be unfortunate if the progress in government school education reforms is caught up in the whirlpool of politics for it relates to the future of the country.

### BFF in troubled water over Jamie Day wages

Former Bangladesh national football team coach Jamie Day has claimed that world football's governing body, FIFA, has stopped issuing development funds to Bangladesh Football Federation over his payment disputes with the federation.

The English coach had a contract running till August 2022, but the 43-year-old was sacked by the BFF in September 2021. Day was in constant contact with the federation to recover his unpaid wages before eventually lodging a complaint with the FIFA late last year.

FIFA gave the verdict in October 2022 asking the BFF to clear the dues of Day, who has claimed more than \$86,000 in unpaid wages. A deadline expiring on December 27 was also given to the BFF to abide by FIFA's verdict.

"In October 2022, the FIFA Players' Status Committee heard the case between the BFF and me and determined that I was owed compensation of \$86,000 plus interest due to the BFF's failure to comply with the terms of the employment contract between us.

"The BFF did not appeal FIFA's decision to the Court of Arbitration for Sport, and so FIFA's decision is final and

'FIFA imposed a deadline upon the BFF of 27 December 2022 to comply with its decision and pay the outstanding amounts.

"The BFF has chosen to ignore FIFA and this deadline and to date, no amounts have been paid. As a result, the BFF now faces a restriction on receiving a percentage of development funding until they decide to comply with FIFA's decision," Day claimed in messages sent to media

BFF, however, claimed through a press release, that FIFA has not halted its instalment of development fund. It claimed that BFF received the latest tranche in January this year and it was working on clearing the dues of Day.

BFF's senior-vice president and finance department head, Salam Murshedy, responded by saying that they don't have the means to make the payment and were seeking bank loans to help them out of the situation.

"We are seeking help from the banking sector in terms of loans to help clear his wages," Murshedi said.

Previously in 2016, FIFA had instructed the BFF to clear the due wages of sacked Dutch coach Rene Koster, which amounted to 80 thousand euros, including the interest accrued over the unpaid period. Back then, the BFF was also ordered to pay 8000 Swiss francs to FIFA and Koster as proceedings of the case. Ultimately, the BFF took more than a year to transfer payments to the Dutch coach.

# Bangladesh women to play against Singapore

Bangladesh women's football team will play a FIFA friendly match away to Singapore on February 18 and will likely host Cambodia for two matches in March, confirmed Bangladesh Football Federation's women's wing chairman Mahfuza Akter Kiran.

Bangladesh senior women's team's last international match was in September last year when they played and won the SAFF Women's Championship title in Kathmandu. Following the success, there was demand from football fans to allow the women's team more international matches, and BFF officials had promised to arrange matches in FIFA windows.

"We had been saying for some time that we were trying to arrange a match against Singapore during a FIFA window. Singapore tried to arrange a tri-nation tournament involving Bangladesh and another team, but they couldn't convince the other team," Kiran told reporters in Kamalapur yesterday.

"Now we will play a Tier-1 match against Singapore in Singapore on February 18. We will play another unofficial match there the following day. We will also try to play two matches against Cambodia in Dhaka in March. However, the matches have not been finalised as yet," Kiran added.

Bangladesh are currently ranked 140th in FIFA ranking. a jump of seven places following their SAFF success.

However, the first opportunity the best of the half -- fell on India's lap in the seventh minute had the India goalkeeper fumble it when Sumati Kumari found herself through on goal from the left. She had only the keeper to beat from inside the box but Rupna Chakma brilliantly denied Sumati's shot on target with outstretched legs, reminiscent of Argentina's Emiliano Martinez's last-gasp save in Qatar World Cup final.



The Bangladesh No.1 stayed busy throughout the first half -- grabbed on to several aerial balls, broke down counters in a sweeper role, and also got hurt during a collision near the end of the half. Meanwhile, the defending champions stamped their authority, especially with their captain Martina Thokchom pulling the strings from midfield.

India had another chance to break the deadlock with an open header in the 20th minute but connect. On the other hand, it took 26 minutes for Bangladesh to strike their first shot on target. Sapna Rani left-footed drive, albeit a weak one, from outside the edge of the box to a corner, following which a flick shot went over the post.

Unlike India, the charges of Golam Rabbani Choton lacked conviction and composure in possession and they only appeared threatening when Shaheda Akter Ripa attempted to find space with her quick feet and then linked up

with captain Shamsunnahar on the right flank.

The second half saw India introduce a string of substitutes in time while Bangladesh kept their eleven unchanged up until in the last quarter of the game. The two sides had kept their tail up to assert control post-interval.

India had a sniff at goal in the 62nd minute when substitute Neha's side-volley from inside the box went over the bar after Sunita broke through from the right flank and crossed.

Couple of minutes later, Bangladesh had their best chance to score when Shamsunnahar, following good movement outside the box involving Ripa, was oneon-one with the goalkeeper but her accuracy from close-range was not up to the mark as the shot was deflected off India's goalkeeper, Anshika.

The game did not produce any late drama as the defence of both teams nipped threats in the bud.

### Osimhen sends Napoli 16 clear

# Roles yet to be sorted after coach appointment

There has been insinuations and suggestions in the country's cricket fraternity that incoming Bangladesh head coach Chandika Hathurusingha's assistant could feature someone from the local background.

When the question was placed to Comilla Victorians head coach Mohammad Salahuddin on Saturday, he outright rejected the notion that he wanted to be involved with the national setup.

"I think those that are working with the board would fit well. When I want to work somewhere, I need to have an idea of what the coach is like. I don't know what kind of coach Hathurusingha is.

'The age I am at, I don't know if I have the mentality to adjust. I have been working as a head coach for five-ten years and I have to see whether I have the capability to work as an assistant coach



now," said Salahuddin during a press conference while also stating that Hathurusingha might just have a magic wand, given the way the BCB sought him out for a return as head coach.

"Since I have been working for a long time and also worked with the national team before, the board will decide on that. I am not currently thinking of it," Sohel Islam, the Rangpur Riders head coach and mentor to many of the national crickets, said on Saturday.

The question, however, remains whether an assistant coach appointment will have to be run by Hathurusingha first. The Sri Lankan had not been known to actively seek local coaches as a medium to communicate with players during his previous stint with BCB. However, in Khaled Mahmud Sujon who was the team manager back then, he had an assistant coach who not only was well adept at communicating with the players but also managing them.

Without Mahmud in the picture at the moment, would the BCB appoint someone they see fit?

It was learned that the BCB are still looking at the assistant coaching role although related departments are yet to mention any names of

local coaches being approached. "There are certain aspects of role distribution that we have to finalise. We have to figure out what role will be handed to Jamie Siddons and after that we will sort things out regarding other roles," a BCB higher-up told The Daily Star on conditions

Siddons had returned to the Bangladesh team as a batting consultant, having previously served as the head coach. The Australian had expressed his wish to work with age-level players in development before, and thus it remains to be seen what role is attributed by the BCB now.

# MoU with Malaysia likely to be amended

The existing Memorandum of Understanding with Malaysia on sending Bangladeshi workers to the Southeast Asian country is likely to be amended to make the recruitment process easier.

After a meeting with visiting Malaysian Home Minister Saifuddin Nasution Ismail yesterday at the Probashi Kalyan Bhaban in the capital, Expatriates' Welfare Minister Imran Ahmad told journalists that a Joint Working Group meeting in this regard may take place this month.

"The [Malaysia] government is new. There will be significant changes in whatever issues we had agreed upon with the previous government. He [Saifuddin] assured us of this.'

Earlier at a joint briefing, the Malaysian home minister said both parties have agreed that there is an urgent need for senior officials from both countries to sit and look into the contents of the MoU that need to be revised, reviewed and, if need be, revoked.

However, none of the ministers disclosed what issues in the MoU, which was never made public, would be changed. Signed in December 2021, the memorandum lifted a suspension on recruitment imposed by Malaysia in 2018 and made way for sending workers under a new arrangement from August last year.

Since then till December, nearly 50,000 Bangladeshi workers have migrated to Malaysia, according to the Bureau of Manpower, Employment and Training.

### Ex-Pakistan president Musharraf dies in Dubai

Pakistani former President Pervez Musharraf died yesterday following a prolonged illness at a hospital in Dubai, after years in self-imposed exile.

Similarly, the per capita gross domestic product -- a measure of the value of all final goods and services produced in a certain period -- was lower than the provisional estimate of

The per capita GDP last fiscal year was \$2,687, up 9.1 percent year-on-year.

# **Fresh CID probe** finds 30 involved

 $The \ Criminal \ Investigation \ Department \ has found \ involvement$ of at least 30 people in laundering Tk 2,000 crore while investigating a case filed against two Faridpur brothers Sajjad Hossain Barkat and Imtiaz Hasan Rubel.

The number of people involved in the crime may rise as investigation is still going on, said CID officials aware of the fresh probe being carried out following a court order.

"We have almost completed the probe and may submit a fresh charge sheet within a month," Humayun Kabir, special superintendent of CID's financial crime unit, told The Daily

The CID filed the case with Kafrul Police Station in June 2020 against Barkat and Rubel, also leaders of Faridpur Awami

They are accused of laundering Tk 2,000 crore amassed through tender manipulation, drug smuggling, land grabbing and extortion. They are part of a syndicate led by former minister Khandaker Mosharraf Hossain's brother Khandaker Mohtesam Hossain Babar.

Twelve people, including Babar, Barkat and Rubel, were arrested in the case and six of them made confessional statements before courts mentioning names of 52 people.

Assistant Superintendent of Police Uttam Kumar Biswas, then investigation officer of the case, submitted a charge sheet against 10 people, including the three, before a Dhaka court in March last year.

The court, however, ordered a further probe on September 1 last year, saying the charge sheet was submitted without following the proper procedure.

The court said two accused were left out of the charge sheet even though they confessed their involvement in the crime. And several others were not included in the charge sheet

# 'Oldest animal fossil' unearthed in India's Bhopal

A sensational "fossil" discovery in 2020 of a rare 550 million-year-old life form has turned out to be "a case of mistaken identity," according to a

"fossil" found at Bhimbetka Rock Shelters cave site in India's Bhopal city was declared as one that belonged to the primitive animal Dickinsonia tenuis. New research,

published recently in the journal Gondwana Research, however. found it was just the imprint of a recently decayed "giant beehive". The 2020

discovery was also published in the same journal. It was widely reported as evidence that Dickinsonia - one of the earliest animals to have lived on Earth - was likely present in the Indian subcontinent at a time when India. Australia. South America, Africa, and Antarctica were a single landmass.

Scientists behind the earlier study had also argued that the Indian finding resembled a Dickinsonia tenuis fossil previously found in South Australia.

# Sri Lanka likely to pay back \$200m by Sept

### Says Momen on return from Colombo

Sri Lanka is expected to pay back the \$200 million it borrowed from Bangladesh in a currency swap agreement in May 2021 by September as the island nation's economic situation is improving, said Foreign Minister AK Abdul Momen yesterday.

"Sri Lanka is gradually doing better. They are recovering slowly. We have given them until September [to repay the loanl." Momen told journalists yesterday at state guest house Padma on his return from Colombo.

Momen was a guest at Sri Lanka's 75th Independence Day celebrations.

Sri Lanka was supposed to repay the \$200 million in March but the island nation sought more time. Subsequently, Bangladesh Bank gave Sri Lanka six more

"The new government there is running the country pretty well."

The Sri Lankan government is hopeful of recovering from its deep economic problem with support from the International Monetary Fund.

The two parties have recently reached a staff-level agreement on a 48-month \$2.9 billion loan programme that will also help the beleaguered nation to secure short-
