Bangladeshi student in Turkish city narrates horror; another student missing

Faysal Mahmud, a final-year comparative theology student at Gaziantep University, was dozing off in his dormitory room when the 7.8 magnitude earthquake

"We all got up feeling the heavy shaking. At one point, it seemed the building would collapse. I tried to get down from the bed but was advised not to by my Turkish roommate. It took two to three minutes for the massive jolt to stop," the Bangladeshi-born student told The Daily Star over the phone yesterday

"As soon as the shaking stopped, we just rushed out of the six-storey building with whatever we could hold in our hands. Cracks had appeared in the building," he went on.

"Together with other students, I am currently residing at the university's central mosque, and I'm not sure when we'll be able to return to the dorm," said Faysal during the phone call

Life term for manufacturers of fake drugs

Sellers of antibiotics without prescriptions to face fine; cabinet okays draft law

The cabinet yesterday approved the draft of the Drugs and Cosmetics Act-2023 keeping provisions for imposing fines for sale of medicines, including antibiotics, without registered doctors' prescriptions, and handing out a maximum punishment of life term for manufacturing adulterated medicines.

The proposed law also seeks to make licensing mandatory to regulate the manufacturing and marketing

Manufacturers and marketers of cosmetics will have to have licence from the Directorate General of Drug Administration (DGDA).

The approval came at a cabinet meeting at the Prime Minister's Office, with Prime Minister Sheikh Hasina in

Meanwhile, the PM during an unscheduled discussion in the meeting directed the authorities concerned not to destroy any land from where three crops are harvested a year.

Briefing reporters at the Secretariat after the meeting, Cabinet Secretary Md Mahbub Hossain said the premier has given a clear directive that no land on which three crops grow a year can be damaged.

"No project can be taken up involving such land. Rather, such land will have to be saved."

He said the directive will be applicable to all public and private development works. The government from now on will regularly monitor the matter of saving land on which three crops grow, he added.

The directive came as different ministries received proposals for using such type of land for development projects.

A powerful earthquake killed more than 3,000 people across a swathe of Turkey and northwest Syria yesterday, with freezing winter weather hampering efforts to find survivors and adding to the plight of thousands left injured or homeless.

The magnitude 7.8 quake brought down whole apartment blocks in Turkish cities and piled more devastation on millions of Syrians displaced by years of

The worst tremor to strike Turkey this century, it came before sunrise in harsh weather and was followed in the early afternoon by another large quake of magnitude 7.7.

"It was like the apocalypse," said Abdul Salam al-Mahmoud, a Syrian in the northern town of Atareb. "It's bitterly cold and there's heavy rain, and people need saving."

The second quake was big enough to bring down more buildings and, like the first, was felt across the region, endangering rescuers struggling to pull casualties from the rubble.

The epicentre of the 7.8-magnitude quake was 23 kilometres east of Nurdagi, in Turkey's Gaziantep province, at a depth of 24.1 kilometres, the United States Geological Survey (USGS) said.

In Diyarbakir in southeast Turkey, a

woman speaking next to the wreckage of the seven-storey block where she lived said: "We were shaken like a cradle. There were nine of us at home. Two sons of mine are still in the rubble, I'm waiting for them.'

She was nursing a broken arm and had injuries to her face.

The earthquake was the biggest quake



recorded worldwide by the US Geological survey since a tremor in the remote South Atlantic in August 2021.

At least 1,293 people died across Syria, the government and rescuers said. Turkish government officials reported another 1,762 fatalities, putting the combined total at 3,055.

Poor internet connections and damaged roads between some of the worst-hit cities in Turkey's south, homes could. to millions of people, hindered efforts to

assess and address the impact. Temperatures in some areas were expected to fall to near freezing overnight, worsening conditions for people trapped under rubble or left homeless. Rain was falling yesterday after snowstorms swept the country at

It is already the highest death toll from



an earthquake in Turkey since 1999, when a tremor of similar magnitude devastated the heavily populated eastern Marmara Sea region near Istanbul, killing more than 17,000.

President Tayyip Erdogan, who is preparing for a tough election in May, called it a historic disaster and the worst earthquake to hit Turkey since 1939, but said authorities were doing all they

Researcher predicted it 3 days back

A Dutch researcher accurately predicted yesterday's Turkey-Syria earthquake, three days before it happened.

In a tweet sent on Friday, researcher at the Netherlands-based Solar System Geometry Survey (SSGEOS) Frank Hoogerbeets tweeted: "Sooner or later there will be a ~M 7.5 #earthquake in this region (South-Central Turkey, Jordan, Syria, Lebanon)."

Hoogerbeets' tweet came exactly three days before the natural disaster struck Turkey and Syria, in which he also referred to other countries that felt the

Population now nearly 17 crore

Rises by 47 lakh after scrutiny of preliminary findings of 2022 BBS census

Bangladesh's population stands at 16.98 crore finally after a post-enumeration check of the government's preliminary survey conducted by the Bangladesh Institute of Development Studies (BIDS).

Earlier in July last year, the Bangladesh Bureau of Statistics (BBS) published preliminary findings of the "Population and Housing Census 2022", which showed that the country's population is 16.51 crore excluding the

BIDS was tasked to conduct a post-enumeration check of the BBS census data.

The net coverage error was lower this time than in previous surveys in 2011 and 2001, which means BBS's technical standard has been sharpened, said Binayak Sen, director general of BIDS.

The average error rate or under coverage of the BBS survey data is 2.75 percent all over the country, according

to the BIDS evaluation report. In the previous preliminary survey in 2011, the error

BPDB seeks discount from **Adani Power**

No revision of PPA sought, Adani spokesman tells \$\square\$ tar

Bangladesh has sought a temporary discount from Adani Power on the price of coal that would fire the thermal power plant in Godda, Jharkhand in light of the escalating prices, said the Indian electricity producer. On February 3, Adani Power, which is listed on the

Bombay Stock Exchange, made a disclosure about receiving communication from the Bangladesh Power Development Board "requesting us to consider a discount on the energy charge as per the Power Purchase Agreement". A spokesman for Adani Power told The Daily Star

yesterday that the discount requested is a temporary one. "BPDB has written to us to consider discounting the variable energy costs on a temporary basis given the current high thermal-sea borne coal prices, which is under consideration," he said.

But there is no request for revision of the controversial power purchase agreement signed in November 2017 to purchase 1,496 megawatts of electricity from the power plant situated 60 miles from the border in India's northeastern state of Jharkhand.

"We confirm that there is no revision requested by the Bangladesh Power Development Board [BPDB] on the power purchase agreement [PPA] for supplying power," SEE PAGE 2 COL 1

Huge sums of money being laundered abroad Says agri minister

A huge amount of money is being laundered from Bangladesh to different countries, including Canada's Begumpara and the UAE's Dubai, said Agriculture Minister Muhammad Abdur Razzaque.

"Anyone now can easily launder money abroad in various ways, including under- and over-invoicing. It should be stopped strictly," he said while addressing a seminar in Dhaka

ZERO-LINE CAMP Another 273 Rohingyas relocated to **Kutupalong**

Some 273 more refugees from 53 families were transferred to the Kutupalong transit camp in Ukhiya, Cox's Bazar yesterday, on the second day of relocating the stranded Rohingyas who fled into Bangladesh territory from a zero-line refugee camp amid violence.

With this, a total of 457 Rohingyas from 88 families were relocated from Tambru to the transit camp in two days, confirmed Refugee Relief and Repatriation Commissioner (RRRC) Mohammad Mizanur Rahman.

Russia applies more pressure in Donetsk

Says Zelensky; Ukraine's defence ministry in turmoil

Fierce battles are raging in eastern Ukraine's Donetsk region as Russia intensifies pressure before the first anniversary of its invasion of Ukraine, President Volodymyr Zelensky said.

"Things are very difficult in Donetsk region - fierce battles," Zelenskiy said in his nightly video address on Sunday. "But however difficult it is and however much pressure there is, we must endure ... We have no alternative to defending ourselves and winning."

Russia, he said, was applying increased pressure to "make up for its defeats last year. We see that on various sectors of the front and also pressure in terms of information."

Meanwhile, Ukraine sent mixed messages over the fate of its defence

war effort in doubt even as it braces for a new Russian offensive.

A day after announcing that Defence Minister Oleksii Reznikov would be replaced, a top ally of Zelensky appeared to row back for now, saying no personnel changes in the defence sector would be made this week.

David Arakhamia, chief of the parliamentary bloc of Zelensky's party, had said Reznikov would be made minister of strategic industries, while the head of military intelligence, Kyrylo Budanov, would take over the defence ministry.

But Zelensky remained silent on the issue, while Reznikov himself said on Sunday he had not been informed of any move, and would reject the strategic industry job if offered it.

The doubt over the minister's fate comes

minister yesterday, leaving a key post in its as Russian forces have been advancing for the first time in half a year in relentless battles in the east. A regional governor said Moscow was pouring reinforcements into eastern Ukraine for a new offensive that could come as soon as next week.

Two senior lawmakers yesterday noted that rules require Ukraine's defence minister to be a civilian, which would appear to put an obstacle in the way of the immediate appointment of Budanov, a 37-year-old military officer.

Removing Reznikov, who has been warmly received in Western capitals including Paris just last week, would be the highest profile reshuffle in a slew of resignations and sackings in recent weeks, some of which followed corruption scandals, reports Reuters.

The Detective Branch of police yesterday submitted the final report of the case filed over the death of Buet student Fardin Noor Parash, clearing Amatullah Bushra of all charges.
DB Inspector Yasin Shikder, also the

investigating officer of the case, submitted the report before the Chief Metropolitan Magistrate's Court of Dhaka.

On November 10 last year, Rampura police arrested Bushra, a friend of Fardin, from Banasree area soon after a murder case was filed against her. She was released from Kashimpur Women's

Central Jail on December 10. Fardin, a third-year student of civil engineering, was found dead in the Shitalakkhya in Narayanganj on November 7, three days after he went missing.

After investigating the incident for over a month, the DB and Rab in December last year said Fardin died by suicide after jumping off a bridge into the river.

UP member arrested for raping garment worker

Police yesterday arrested a union parishad member for raping a garment worker in front of her husband in the port city's Sitakunda upazila.

Following a tip-off, a police team conducted a raid in Lalanagar area and arrested Zahed Sultan Chowdhury Robin, 40, a member of Sonaichari union Ward-8, said Sudipta Sarkar, additional superintendent of Chattogram police.

Robin and his two cohorts picked up the 30-year-old and her husband while they were returning home from work around 10:00pm on Saturday. They took the couple to a nearby house and raped the woman several times while her husband was tied to a pole, said Tofayel Ahmed, officer-in-charge of Sitakunda Police Station.

They also took the couple's mobile phones and gold ornaments before fleeing. Police rescued the couple after they called the National Emergency Service around 3:00am.

The woman was sent to the One Stop Crisis Centre of Chattogram Medical College Hospital while her husband filed a case with the station accusing the three.

Australian coal at Newcastle Port with an energy value of 5.500 kilocalories per kg (kcal/kg), as assessed by commodity price reporting agency Argus, slipped to \$129.87 a tonne in the week to January 27, the lowest since the week to January 21, 2022, reports Reuters.

The Godda plant would be running on lesser quality coal with an energy value of 4,600 kcal/kg, so its price is expected to

BPDB is not willing to pay more than what it pays to Payra and Rampal plants for coal, said another official familiar with the discussions.

At present, it pays \$245 per metric tonne for the coal used in the Payra power plant in Patuakhali, \$254.38 for the S Alam power plant in Chattogram's Banshkhali and the Rampal power plant in Bagerhat, and \$270 for the Barishal 307MW coal-fired power plant.

A Power Cell estimate in January put the Adani plant's coal price at \$346 per metric tonne.

The PPA signed with Adani Power stipulates that Bangladesh will pay the market price for the coal used to fire the power plant, reports The Washington Post, which got three industry experts to review the confidential 163-page agreement.

Other agreements with foreign power suppliers, also seen by The Post, include clauses that would put a cap on the prices Bangladesh pays if the cost of coal skvrockets.

"Industry analysts say the coal will probably come on Adani ships to an Adani-owned port in eastern India, then arrive at the plant on a stretch of Adanibuilt rail. The electricity generated will be sent to the border over an Adani-built high-voltage line. Under the contract, shipping and transmission costs will be passed on to Bangladesh," the report

Turkish state broadcaster TRT showed a building collapse in the southern province of Adana after the second quake. It was not immediately clear if it was evacuated.

In Syria, already wrecked by more than 11 years of civil war, the health ministry said more than 1,326 people had been injured. In the Syrian rebelheld northwest, emergency workers said 390 people had died.

Occasionally they raised their hands and called for quiet, listening for sounds of life.

In the Syrian rebel-held town of Jandaris in Aleppo province, a mound of concrete, steel rods and bundles of clothes lay where a multistorey building once stood.

"There were 12 families under there. Not a single one came out. Not one," said a thin young man, his eyes wide open in shock and his hand bandaged.

The casualty toll in northwestern Syria was expected to increase, a spokesperson for the UN office for coordinating humanitarian affairs in northwestern Syria said.

He said they received information regarding a university student, Md Rinku, going missing, from another Bangladeshi student. There are five Bangladeshi

students in the Kahramanmaraş province and four of them are safe now, he told this newspaper over the The consul general added that

Nur-e-Alam, also a Bangladeshi student, was with Rinku at a building that was damaged when the earthquake hit. Although Nur could come out

of the building safely, Rinku went missing, he further said.

He also said there are about 30 to 35 Bangladeshis in the Gaziantep province, which is near Kahramanmaraş, but all of them are safe now.

We apologise to our valued readers and the Hatimara Tea Garden authorities for the grave mistake. And, we are also taking appropriate actions against those responsible for letting The Daily Star down by not following journalistic standards.

Undocumented Bangladeshi migrant workers have started to submit applications under an amnesty programme offered by the Greece government, with about 40 to 50 of them already securing "white paper" following

The "white paper" or temporary residence permit will enable a Bangladeshi to work in Greece legally, according to an official at the Bangladesh embassy in Athens. Later, upon scrutiny and approval of the

applications by the Greek authorities, the migrants will be provided with a "residence card" for five years, which will be renewable.

Bangladeshi migrants are expected to avail themselves of this opportunity with the regularisation likely to take place for six months initially.

10 hurt as AL men clash in **Tangail**

At least 10 people, including three journalists, were injured in a clash between two local Awami League groups over the distribution of warm clothes in Tangail's Gopalpur yesterday.

Few cocktail bombs went off, and around 10 motorbikes and two cars were vandalised. The injured were taken to Gopalpur Upazila Health Complex and different private clinics.

Witnesses and locals said Bhuapur Municipality Mayor Masudul Haque Masud along with his supporters went to distribute warm clothes in Gopalpur. When his motorcade reached Alamnagar Board Bazar area around 12:00pm, an attack was launched on it.

The injured journalists are Ovijit Ghosh, district correspondent of Dhakapost.com; Ashikur Rahman, camera-person of DBC Television, and Farman Sheikh, district correspondent of Dhaka Prakash.

OC Mosharaf Hossain of Gopalpur Police Station said on information, a police team brought the situation under control. "None of the parties lodged any complaint with the police station immediately."

Masud blamed the supporters Tangail-2 (Bhuapur-Gopalpur) constituency AL lawmaker Tanveer Hasan Chhoto Monir for the incident.

Contacted, Chhoto Monir said in the last UP elections, Masud supported rebel candidates for the post of chairman in six

unions of Bhuapur. "I heard that Masud along with these rebels went to Gopalpur in the name of distributing blankets and spoke provocatively against local party men, so people protested."

On Sunday night, Golam went to sleep at a place beside his father's room. At that time, no one was present except him and Fazle.

Due to unknown reasons, he entered his father's room and stabbed him with a knife, killing



From August last year till Sunday, about 4,000 Bangladeshi migrant workers have registered with the embassy to avail the opportunity. This registration is a precondition from the mission's end, he added.

To be regularised, undocumented the Bangladeshis will have to pay €91 each through online banking for processing and issuance of residence cards.

Once the applications are submitted properly, the workers will receive the "white paper" via email.

A Bangladeshi worker must obtain a passport valid for at least two years at the time of application,

In our investigation, we also found that the story lacked the process of due diligence and rigorous fact-checking, which is a hallmark of our reporting.

We apologise to our valued readers and the Hatimara Tea Garden authorities for the grave mistake. And, we are also taking appropriate actions against those responsible for letting The Daily Star down by not following journalistic standards.

10 hurt as AL men clash in **Tangail**

At least 10 people, including three journalists, were injured in a clash between two local Awami League groups over the distribution of warm clothes in Tangail's Gopalpur yesterday.

Few cocktail bombs went off, and around 10 motorbikes and two cars were vandalised. The injured were taken to Gopalpur Upazila Health Complex and different private clinics.

Witnesses and locals said Bhuapur Municipality Mayor Masudul Haque Masud along with his supporters went to distribute warm clothes in Gopalpur. When his motorcade reached Alamnagar Board Bazar area around 12:00pm, an attack was launched on it.

The injured journalists are Ovijit Ghosh, district correspondent of Dhakapost.com; Ashikur Rahman, camera-person of DBC Television, and Farman Sheikh, district correspondent of Dhaka Prakash.

OC Mosharaf Hossain of Gopalpur Police Station said on information, a police team brought the situation under control. "None of the parties lodged any complaint with the police station immediately."

Masud blamed the supporters Tangail-2 (Bhuapur-Gopalpur) constituency AL lawmaker Tanveer Hasan Chhoto Monir for the incident.

Contacted, Chhoto Monir said in the last UP elections, Masud supported rebel candidates for the post of chairman in six

unions of Bhuapur. "I heard that Masud along with these rebels went to Gopalpur in the name of distributing blankets and spoke provocatively against local party men, so people protested."



one point my younger brother moved to Banani while another moved to Shyamoli with his family.

He added that his nieces never suffered from mental health issues. Nahid, a private job holder posted

in Khulna, also claimed that he

struggles to support his family. Relatives said one of Shemi's brothers lives in Canada, the younger brother is a BCS (admin) cadre officer,

2nd balloon flying over LatAm is Chinese: Beijing

Beijing yesterday confirmed that a balloon spotted flying over Latin America is Chinese, while the United States worked to recover what it claimed was an unmanned spy craft it shot down at the weekend.

China has expressed fury at Washington's decision to shoot down a device that it insists was an unmanned weather surveillance aircraft that had veered off course last week.

That balloon sparked outrage in the United States, which accused China of an "unacceptable violation" of its sovereignty and prompted Secretary of State Antony Blinken to call off a planned trip to Beijing.

Beijing acknowledged yesterday that the latest balloon, spotted by US and Colombian officials flying over Latin America at the weekend, was also Chinese. Its foreign ministry said the device was of "a civilian nature and used for flight tests".

"Affected by weather forces in addition to its manoeuvrability being limited, the airship deviated greatly from its expected course, and accidentally entered Latin American and Caribbean airspace,' spokesperson Mao Ning told a media briefing.

That statement came three days after what the Pentagon characterised as another Chinese spy balloon had been seen across Latin America.

Single-use plastic waste rises from 2019-2021 **REUTERS**, Singapore

Polluting single-use plastic production rose by 6 million tonnes per year from 2019 to 2021 despite tougher worldwide regulations, producers making



"little progress" to tackle the problem and boost recycling, new research showed yesterday. Single-use plastics have emerged as one of the

world's most pressing environmental threats, with vast amounts of waste buried in landfills or dumped untreated in rivers and oceans. The manufacturing process is also a major source of climate-warming greenhouse gas. But while growth has slowed recently, the

production of single-use plastic from "virgin" fossil fuel sources is still nowhere near its peak, and the use of recycled feedstocks remains "at best a marginal activity", Australia's Minderoo Foundation said in its Plastic Waste Makers Index.

"Make no mistake, the plastic waste crisis is going to get significantly worse before we see an absolute year-on-year decline in virgin single-use plastic consumption," it said.

Exxon Mobil XOM.N was at the top of the list of global petrochemical companies producing virgin polymers used in single-use plastics, followed by China's Sinopec 600028.SS.

Sinopec also leads the way when it comes to building new production facilities over the 2019-2027 period, the report said.

Tremors felt as far away as Greenland

Tremors from the powerful earthquake that rocked Turkey and neighbouring Syria yesterday were felt as far away as Greenland, the Geological Survey of Denmark and Greenland said. "The large earthquakes in Turkey were clearly registered on the seismographs in Denmark and Greenland," seismologist Tine Larsen told AFP. The first 7.8-magnitude quake struck at 04:17 am at a depth of about 17.9 kilometres near the Turkish city of Gaziantep, the US Geological Survey said.

Aftershock sows fear

Tulin Akkaya had just started to gather her thoughts after being woken by the biggest earthquake to strike Turkey in nearly a century when a second massive jolt sent her scrambling for safety on the street. It was certain to grow and Akkaya was trying to piece together the remains of her life when a second jolt shook her house and sent her rushing out of her apartment. "I am so scared. I felt (the aftershock) so strongly because I live on the top floor," the 30-something housewife said. "I can't go back to my apartment now."

Criminal negligence that could cost lives

Biman, two pilots must answer for 2022 mid-flight incident

We are deeply alarmed by Biman's actions following an incident in which, as reported by this daily, two pilots put passengers' lives at risk. During a Biman flight on February 1, 2022, one of the pilots set the airspeed of the plane to 165 knots (nautical miles per hour) during take-off, which was 20 knots less than the plane's standard operating procedure. While climbing, the pilot changed the airspeed thrice in four minutes. The captain said this was done to climb faster to avoid thunderclouds. However, the meteorological report for the day said there was "no significant cloud". Moreover, this technique is not supported by the standard operating procedure.

The pilots made many other claims, none of which were supported by the plane's flight data recorder, also known as black box. When the speed supposedly dropped to 152 knots, the pilot disengaged the autopilot and pushed both engines to "emergency" power level, which compromises engine components. Consequently, the plane's turbine temperature shot up by over 100 degrees, causing metals inside the engines to melt. Despite claiming to investigators later that they were forced to pursue such actions due to being in a life-or-death situation, they never submitted any air safety report, which is a clear violation of the safety manual. And there was a plethora of such violations that followed – including the pilots seemingly wiping out the maintenance message on the audio and radio control display unit (ARCDU) to hide their own mistakes.

What's worse, despite the damage inflicted on it, the plane flew seven flights before being grounded. And none of this would have even come to light had it not been for the fact that the plane sent automatic data about engine health to the manufacturer, which notified Biman Engineering Services. Biman conducted its own investigations, but the investigation report, submitted in March 2022, was buried. Bizarrely, the senior of the two pilots was even included in a list of pilots set for promotion!

All this raises serious concern about Biman as an institution. It seems the incident happened as a direct result of the pilots' misjudgement. But instead of owning up to it, they tried to erase evidence ignoring all professional ethics. Clearly, they knowingly put hundreds of peoples' lives at risk but, instead of holding them to account, Biman tried to hide it. What does that say about Biman's governance system? Airlines deal with people's lives on a daily basis, making it crucial that they maintain the highest international standard, something that Biman has failed to do.

Even though Biman is our national flag carrier, and we would like to stand beside it, what it and the pilots did deserve an appropriate response. Their actions - or should we say, criminal negligence? - unnecessarily put people's lives at risk and further tarnished the image of our country. Therefore, we urge Biman to make the findings of its investigation public, correct its flaws, and apologise to the people whose lives were put at risk. The pilots, if found guilty of misconduct, must be held to account. And even the role of the regulators needs to be carefully investigated.

Who desecrated idols in Thakurgaon?

Take action against culprits who committed such a condemnable act

We are deeply alarmed by the news of unidentified criminals desecrating idols of Hindu gods and goddesses in Thakurgaon's Baliadangi upazila earlier this week. According to a report, at least 14 idols of Saraswati, Laxmi, and Manasha were vandalised at 12 temples. From what we know so far, whoever carried out the attack did so quietly, in the darkness of the night, as the local people only came to know about it when they went to offer prayers at the temples next morning. And even though the culprits have not been identified yet by police, from the nature of the attacks, it can be said that those were no isolated incidents. Those were rather coordinated.

While we condemn such acts in the strongest terms, we would also want to know what might have triggered the criminals to vandalise the idols. Did they want to create an atmosphere of fear among the Hindu community of Thakurgaon? Or did the criminals simply hold the misguided notion that by desecrating sacred symbols of other religions, they are actually showing love for their own? Whatever might have been their twisted reason, we must send them a strong and clear message that every person in the country has the right to practice their own religion, and that this right is guaranteed by our constitution. We must also remind them that desecrating others' religions totally goes against the ideals of our Liberation War as well as our long-held social values.

Having said that, we also need to find out why such incidents keep recurring in the country, despite assurances by the government that religious intolerance or violence would not be tolerated. If we look at some of the past incidents of religious violence, we will see that in most cases, those involved were never brought to justice. The failure to take action is emboldening others to commit similar crimes.

We need a strong, powerful and uncompromising collective social voice against the growing religious tension and intolerance in the country. While the government must play its part by holding the criminals accountable, our religious leaders must also play their due role. They must tell adherents that religious intolerance is totally unacceptable in a pluralistic society that we aspire to be. They must send out a strong message of interfaith harmony.

As for the Thakurgaon incident, we urge the local administration to identify the culprits responsible for the desecration of idols and take legal action against them and also, equally importantly, extend protection to the local Hindu community. The authorities must create a safe environment for all minority communities by creating a society tolerant of diversity. To do that, it is vital that orchestrators of all previous communal attacks are also brought to book. Only by showing zero tolerance can we prevent repetition of such incidents.



Paternity leave should be the practice, not an option

Recently, a social media post from the clothing and lifestyle brand Aarong went viral. It was titled "Embracing Fatherhood," and mentioned that Aarong provides one month of paternity leave to its male employees to care for and bond with their newborns which people highly appreciated.

Fathers are frequently regarded as the heads of their families, and someone who can have the most impact on children's development. In the initial stage of parenthood, it is necessary for a father to be there for his partner and their newborn, and to celebrate some of the most precious moments of their lives together with family and friends.

An adequate paternity leave period increases a father's likelihood of being involved in the lives of his young children. This can lead to improvements in gender equality at work and at home, and may introduce positive changes in interpersonal interactions, parenting responsibilities, and ingrained preconceptions of how parenthood should be.

In most families, a mother often performs the majority of childcare duties. But fathers are vital to the proper development of their children as well. According to recent studies, fathers who are actively involved in their children's upbringing might be able to have a beneficial long-lasting impact on them.

Normally, if a female employee becomes pregnant while working, she is eligible to receive maternity leave. Assuring a maternity leave period of at least 14 weeks is required under Article 4(1) of the Maternity Protection Convention, 2000 of the International Labour Organization (ILO). Female government employees are entitled to six months of leave under Section 197(1) of the Bangladesh Service Rules, as amended on January 9, 2011, And under Section 46 of the Bangladesh Labour Act, 2006, women employees are entitled to 16 weeks of maternity

But what about male employees whose partners are pregnant or have given birth? Most workplaces in Bangladesh do not offer paternity leave to their male workers, even though this is a well-established practice in many other countries.

In 2021, 115 of the 185 countries assessed by the ILO were found to be offering the right to paternity leave, with 33 new countries having implemented such a policy in the last 10 years. This indicates the growing acceptance of men's role in child care, because it means that 4 out of 10

However, approximately two-thirds of potential fathers (1.26 billion men) don't have access to paternity leave and are thus missing out on the chance to form close relationships with their newborns. In some countries, men are also discouraged from using their paternity leave due to gender norms

that dictate that men should be breadwinners and women should be caregivers.

As such, companies should actively encourage fathers to take time off to care for their newborn children by developing a supportive workplace culture, and ensure that fathers are not subjected to discrimination for engaging in caregiving activities in order to enhance the take-up rates for paternity leave.

Considering how crucial a father is to a child's development, it is long past due for the government to consider passing a paternity leave law for male employees in Bangladesh. Fathers who take paternity leave get the chance to spend quality time with their newborns and are able to participate more actively in family life. Additionally, the increased involvement of men in domestic tasks enables women to better balance their personal and professional

responsibilities. Providing paternity leave benefits the company as well. Levelling the playing field for men and women makes the workplace family-friendly and aids companies in reducing gender gap. Paternity leave should be provided to all male employees so that they can care for their partners and newborns throughout and after pregnancy. Any such provision ought to encourage an accepting workplace where fathers are welcomed into parenthood, including being provided with paid leave as part of the paternity benefits.

Who will defend our public property defenders?

and activists have been subjected to an amplified scale of threats, intimidation, and incarceration at the hands of powerful groups who are allegedly in cahoots with members of the administration. The incidents reveal the campaigners' gaping vulnerability to the elements flexing muscle to establish their illegal private control over public property.

On December 25, a group of six to seven men confronted Abul Azad, a reporter covering environment and politics for a national English daily, when he was taking photos of brick kilns that were allegedly operating illegally in Chattogram's Rangunia upazila. Azad was forced into a vehicle at gunpoint and taken to a local government office, where he was subjected to further assault. Before releasing him, the perpetrators robbed him. His medical records indicate that he suffered a fracture in the neck and endured pain in his chest, abdomen, and hands.

In his testimony to the Committee to Protect Journalists (CPJ), Azad stated that one of the attackers was a member of Islampur Union Parishad. He said his captors deactivated the office's security cameras, beat him with their hands and pistols and kicked him repeatedly, and confiscated his mobile phone, wallet and identification card. They contacted the UP chairman over phone, who threatened Azad saying "nothing will happen if journalists like you are killed" and ordered the men to beat him further and destroy his phone. The men seized Tk 10,000 in cash from Azad, withdrew all the money from his Bkash account and demanded an additional sum of Tk 50,000 as ransom that Azad refused to pay. The CPJ affirms that both the member and the chairman of the UP that assaulted Azad are members of the ruling party.

Kha told the magistrate that he had been subjected to severe beating and electrocution and had been threatened to be killed if he continued reporting on the landless people. The experiences of Azad, Kha, and Hasan provide a glimpse into the hard reality that public property defenders face in today's Bangladesh. All three were engaged on issues of major public concern: air pollution and control over public land and hills. All three were engaged in collecting evidence on the scale of destruction of public property, and all three were motivated to draw the attention of state agencies and the public to the nefarious activities of individuals and groups to establish their control over such property for private gains. If anything, they were simply armed with their pens, paper, and phones, and most importantly, their passion for and commitment to defending public property.

The narrative above raises several important points. First, all three cases were of flagrant usurpation of public property. This suggests that the wrongdoers had the confidence of getting away with their acts. In all likelihood, their connection with the power structure gave them such a sense of immunity. Second, in all three instances, the use and threat of use of lethal weapons were evident. This reflected that, nowadays, rights defenders are at serious risk. Third, subjected to abduction, unlawful detention, and incarceration, and often government offices become places of such detention. Fourth, the perpetrators do not hesitate to inflict grievous bodily harm (such as electrocution in Kha's case) on their victims. Sixth, the extent of the perpetrators' transgression includes robbing the victims of their valuables or commandeering their vehicles. And finally, in both the Rangunia and Chattogram city cases, the enmeshing of local government representatives' interests with criminal activities is palpable.

became obvious when demonstrators in Rampal near the Sundarbans were branded as "terrorists." In May 2021, Shahnewaz Chowdhury had to endure 80 days of incarceration under the much contested Digital Security Act (DSA) for a Facebook post. In that post, he had expressed concern about another coal-fired power plant project in Chattogram's Banshkhali, in southeast Bangladesh, calling on the youth to "resist injustice" against the "environmentally destructive" project. Now, Chowdhury faces up to 10 years in prison if found guilty.

At least 12 workers and locals, who were against the Banshkhali project, have been killed over the last seven years by police fire. The situation stooped to a new low when a member of the parliamentary standing committee on forest and environment insisted that the OC of Keshabpur police station in Jashore implicate a local environment activist in a staged bomb attack on the police station. The audio recording of the conversation went viral (Samakal, January 31, 2021).

In April 2022, the visiting UN special against a large coal-fired power plant rapporteur on human rights and climate change called for an end to "the harassment and threats and intimidation against climate change human rights defenders and Indigenous peoples."

There is an urgent need for our policymakers and senior state functionaries to acknowledge that public property defenders play a crucial role in keeping groups with vested interests at bay. That role has become more pronounced at a time when preserving the environment and the commons holds high priority in the government's development agenda. Therefore, it is incumbent on the authorities to institute credible and proper investigation into all cases of appropriation of public property and hold the perpetrators to account. They must identify and take appropriate action against the kingpins that remain in the shadows, and take visible and concrete actions so that encroachers of land, hills. rivers, and other waterbodies can be effectively deterred.

The top five Open speakers and top three Novice



Including reproductive health in the NCTB curriculum is a step in the right direction

This year, the National Curriculum & Textbook Board (NCTB) has brought about some major changes to their textbooks, including the Science Investigative Reading textbook for class six. It differs from the books of the preceding years in many ways, but a particular portion of the content has been garnering some attention. In particular, a section on adolescence focusing on the physical changes children undergo during puberty has been generating discourse online.

While the detailed nature of the text may feel unsettling at first, it's quite evident that the content seeks to be purely informative without any underlying agenda. The section in question falls under the chapter Manob Shorir or "The Human Body". Physical changes during puberty fall under the territory of basic human anatomy, which is exactly what you would expect from a chapter with that title.

Previous editions of NCTB Science books of the same class were either devoid of such information, or chose to gloss over the topic. As a result, many of us didn't have a reliable source of information about what puberty is, and what it entails while growing up. While we eventually acquire knowledge on these topics from various sources and experiences, many misconceptions about puberty and sexual health are still prevalent health long before this change in the their concerns to a grownup, who maybe among today's youths. As such, NCTB's decision to include a straightforward and

informative overview of adolescence is is commendable nonetheless, as children tend to hit puberty around that age.

The discussion of reproductive health is still considered a taboo in our society, initiative to educate their children about their physical changes. The stigma around

As such, children seeking answers

often end up searching in wrong places, which is a lot more likely in this day and age. Uninformed children are also more susceptible to reproductive diseases, sexual

violence, etc. Educational institutions are to provide children with well-rounded education, so having reproductive health on the curriculum can help in the long run to accommodate a better understanding of their own bodies.

However, the implementation of the study of adolescence and reproductive health caused quite a stir on social media

proving that a huge chunk of people consider sex-ed to be inherently immoral. The contents in the book matter-of-factly describe the process of puberty along with the proper scientific terminologies for it.

Yet, the perception of the general population is such that the content is vulgar and deserves no place in the textbook. Many share the opinion that topics like these being openly discussed may lead children astray, even though it's highly effective in creating self-awareness.

The entire reason simple sex education feels out of place in textbooks is because of the scarcity of it. Be that as it may, puberty and reproductive changes are both natural phenomena, and stigmatising them does more harm than good. The vilification of sex education perpetuates the idea that any discussion on reproductive health is pornographic in nature, when in reality, it's crucial to the physical and mental wellbeing of our adolescents.

So, while we can't expect society's preconceived notions to change overnight due to a few textbook articles, NCTB's decision to include adolescence in the syllabus will definitely help in destigmatising the conversation around reproductive health in the long run.

Mohammedan to defend **Super Cup**

Fallen giants Mohammedan will have a chance to defend their Super Cup title when the big-budget domestic football tournament returns in May after a decade-long gap.

Mohammedan have failed to win a Bangladesh Premier League title since the introduction of professional league in 2007. However, the Motijheel-based outfit won two out of the three editions of the Super Cup held in the intervening time.

The Black and Whites won the inaugural Super Cup in 2009 before regaining the title from archrivals Abahani in 2013, the last-time the crore-taka tournament was held.

Following a decade-long gap due to a lack of interest from sponsors, the tournament is set to be staged again this April. Despite not being directly eligible for automatic qualification, which is reserved for the league's top four, Abahani made it due to Saif Sporting Club's departure from the top-flight football.



According to Bangladesh Football Federation general secretary Abu Nayeem Shohag, Mohammedan will be one of the four direct entrants to the tournament, which will feature six total BPL clubs.

Mohammedan had finished fifth in the last league, but since Saif Sporting, who finished third, opted out of toptier football, Mohammedan will play alongside the rest of last season's top three, including Bashundhara Kings, Abahani and Sheikh Jamal.

"The Super Cup will be held from April 2 to 13 with six teams. Three teams will play be split into two groups. The top two teams from each group will play in the semifinals followed by the final," Shohag told reporters vesterday.

"The two other teams will be selected from the seven lowest teams of last year's table through playoffs on February 14 and 28," the BFF official added.

With the Bangabandhu National Stadium undergoing renovation and the teams' unwillingness to play at the Kamalapur stadium, the tournament might be staged at the Bashundhara Kings Arena or a venue outside Dhaka -- likely in Sylhet. Shohag said the decision would be taken following a meeting with sponsors within a few

'My use of wrist all comes from squash'

Ryan Burl has come leaps and bounds since his early days, with his rise perfectly coinciding with the new-found ambition coming through in Zimbabwe cricket. The 28-year-old spoke about growing up with cricket and other sports and his view on the current generation of Zimbabwe players during an interview with The Daily Star's Abdullah Al Mehdi. The excerpts are

On Zimbabwe's current generation: When you start thinking of the legends, you think of the late 90s and early 2000s. You think of Andy Flowers, Heath Streak or Henry Olonga and Tatenda Taibu. But that was back then, I firmly believe we have our own legends now like Sikander Raza, tampering and fixing things and I am a bit Brendon Taylor, Sean Williams and great of DIY guy at home, although not as good rospects like [Blessing] Muzarabani. So, I believe some years from now, people will call us the legends of Zimbabwe cricket.

On the atmosphere of Zimbabwe from a cricketer's point of view: It's amazing. Not everyone knows you but you are the talk of the town and everyone's talking about cricket. Everyone wants to go to the games and the stadiums are packed and we owe a lot to the crowds.

On that viral tweet about gluing the **shoes back:** It was the kind of thing which you don't expect to see go viral. I couldn't be any more grateful to Puma for stepping up and helping us out. They helped not just me but some of my teammates too and it's an eye-opener in terms of sponsors rallying behind us. Obviously we



are not top five in the world but that's no excuse for the sponsors. At that time, [the tweet] was about giving insight into what us cricketers face in the background. I like as my brother and dad. Cricket can be a bit of an expensive sport and we go through a lot of wear and tear.

On playing hockey and squash and how it helped in cricket: I think those kinds of sports contributed to the player I am today. You see my use of wrist and it all comes from squash. You see me sweeping and reverse-sweeping and that's basically hockey all over -- getting low down. To this day I play all the sports but I came to cricket because it's a team game.

On Zim coach David Houghton's work: We kind of all sat down and talked about the brand of cricket we wanted to play. We wanted to cheer up the fans and play positive cricket to bring in the fans. It doesn't work all the time but works

sometimes. It happens that you go for 180 but manage just a 100. But being defensive and getting 140 means you still lose the game. So that's what we discussed as a

On his experience with Mashrafe: He's a legend of Bangladesh and has an extremely calming presence. He's one of those guys who gives you full belief and backs you hundred per cent. I was originally put down to bat at five or six but there would be an instance when he says: 'No I want you to go at four and want you to express yourself, be confident and enjoy yourself.' He makes integration easier.

On becoming a leggie: You have less space in the garden and sometimes you bowl spin. I used to open the bowling with Sam Curran in Zimbabwe but then one day I told the coach I'm done with seam. Watching Warnie, Stuart McGill and Kumble and you start to bowl the flipper or the slider. It's a proper art form.

On whether leggies are diminishing: It's a weird one since I haven't seen a leggie in Bangladesh. But you look at the T20 rankings, at one stage there were six of seven leggies up there like Adil Rashid, Rashid Khan, Ish Sodhi. It might seem like a dying art and it's high-risk and high-reward thing but you might also get wickets. I discussed grips with others such as Rashid and bringing unpredictability to the field set-up. It's like a community of leggies and we speak to each other. Batters are always trying to figure us out so we're trying to stay ahead.

'We can't relax'

Barcelona stretched their La Liga lead over Real Madrid to a substantial eight points with a comfortable 3-0 win over Sevilla on Sunday.

The Catalans, aiming to win their first Spanish title since 2019, took full advantage of Real Madrid's defeat to Real Mallorca earlier in the day to extend their lead at the top of the table.

However, coach Xavi Hernandez said Barca would not allow any "euphoria" to creep in.

"I don't know if we're the most reliable team in the league. We are in a good moment, but this changes. We can't relax," said Xavi.

Xavi also asked his players to keep working with 'humility', insisting that their work is far from over.

> "This is a long race and we have to keep working with humility. We are building something very good, but nothing has been won. Only the Super Cup. We are hungry," Xavi added. However, goals from Jordi

Alba, Gavi, and Raphinha secured all three points for the hosts and that left Xavi a very satisfied manager.

But Xavi still considered Real Madrid as favourites in La Liga and urged his players to shut the door on a potential Madrid comeback.

"They are still the favourites because they are the reigning La Liga and Champions League champions," said Xavi.

"I know that Real Madrid will keep competing until the end. There have been historic comebacks, we can't let that happen."

Vinicius Jr victim again of racist abuse

Mallorca fans were filmed racially abusing Real Madrid's Brazilian forward Vinicius Jr. in their Son Moix stadium during their 1-0 upset win against the LaLiga holders on Sunday.

Supporters could be heard calling the 22-yearold Brazilian player a monkey in a video published by streaming company DAZN on social media.

Mallorca did not immediately respond to a request for comment. But in a radio interview club manager Javier Aguirre denied that his players had targeted Vinicius, who suffered 10 fouls, the most endured by any player in LaLiga this season.

Vinicius has been subjected to racial abuse by fans on at least three occasions -- at Camp Nou against Barcelona in November 2021, at Atletico in September 2022 and at Valladolid in late December 2022.

Spanish police are also investigating a possible hate crime against the Brazilian.

Coach Carlo Ancelotti defended Vinicius after the Brazilian broke the record for the highest number of fouls received by a Real Madrid player in almost a decade.

"Everything that happens and has happened is not Vinicius' fault. He wants to play soccer and there is an environment of rivals who provoke him and foul him," Ancelotti said.

Nacho Fernandez, who scored an own goal during the game, also commented on the treatment of Vinicius, labelling it as "nonsense." "I think an atmosphere is being created with

the issue of Vinicius that does not favour anyone, neither Vinicius nor anyone else. The public is getting involved with the boy. We have to leave controversy and nonsense aside," Nacho said.

City accused of over 100 irregularities

The Premier League has accused Manchester City of breaking its financial rules on more than 100 occasions between the 2009-10 and 2017-18 seasons following a four-year investigation, referring the reigning champions to an independent

The six-times Premier League champions have been accused of failing to give "a true and fair view of the club's financial position", of failing to "include full details" of player and manager remuneration, of failing to comply with rules regarding financial fair play and failing to co-operate in a Premier League investigation that has concluded after more than four years.

If proven, these would be the greatest offences committed by a club in the history of the competition.

The independent commission could recommend that City be expelled from competition by resigning them to relegation. A lesser infraction may simply lead to a fine or points being docked.

This is not the first time that the team have found itself in hot water for such issues. In February 2020, City were banned from the Champions League by UEFA after being found to have broken financial rules and misled the European governing body, only for the ban to be overturned on appeal by the Court of Arbitration for Sport (CAS).

On the central finding that City's Abu Dhabi ownership had disguised its own funding as independent sponsorship by the state's commercial companies, Cas found: "Most of the alleged breaches were either not established or time-barred."

'Time-barred' was the crucial phrase. It basically means that UEFA have a five-year window to penalise clubs for Financial Fair Play infringements. However, the Premier League does not have include any such clause regarding time.

However, under Premier League rules, clubs cannot appeal to the CAS or FA. If they are found guilty, they will have to go for the drawn-out process of arbitration with another independent panel.

Last season, City won their sixth Premier League title since they were purchased by the Abu Dhabi United Group in 2008. They also won the Premier League title in the 2011-12, 2013-14, 2017-18, 2018-19 and 2020-21 seasons. Since the takeover, Manchester City have spent over two billion euros on new players.

In January 2023, City topped the Deloitte money league -- a list of the world's richest clubs by revenue --for second year in a row ahead of Real Madrid. After the allegations came out, Jamie Carragher tweeted sarcastically: "This can't be right. Man City bring in more commercial revenue than Real Madrid, Barcelona, Bayern Munich, Man Utd and Liverpool."

Abandoned, left to starve

Mother, 2 daughters rescued from Uttara flat

A woman and her 10-year-old twin daughters, who were rescued in critical condition from their flat in the capital's Uttara early yesterday, had not eaten for at least four days.

According to police, there was no food inside the home of Shafana Afifa Shemi, the mother, when officials of the social welfare directorate went there after the rescue. The officials found only some salt and a source of

water -- for which the mother and daughters were able to There were even no clothes of the children or mother in the house, except what they were already wearing,

presumably for a very long time, and a torn salwar kamiz, Muzahidul Islam, inspector (Investigation) of Uttara East Police Station, said, "All three of them were listless.

They did not have the strength to even speak. "We found the mother in the bedroom and the two children in the drawing room. They were so weak that they had urinated and defecated on the bed and floor."

The apartment had no electricity or gas supply. According to a relative, Shemi was unable to pay the

bills and so the lines had been snapped several days ago. Police were notified about the mother and children after a call from someone in the building and later rescued them with the help of the Fire Service and Civil Defence.

ACC sues former director, 22 others for Tk 1,161cr loss

Anti-Corruption Commission yesterday filed a case against former director of Biman Bangladesh Airlines Ishrat Ahmed and 22 others for their alleged involvement in irregularities that caused the national flag carrier to lose Tk 1,161 crore.

filed the case with the commission's Dhaka-1 integrated office, secretary Mahbub Hossain told a press

conference. According case statement, Biman opened a tender to lease B777 aircraft on September 11, 2013.

Four bidders -- Jesco Aviation of the USA, Euro Atlantic of Portugal, Standard Chartered of London, and Egypt Air Holding Co. of Egypt – participated in the bidding.

The complainant said that Egypt Air was considered as the lowest bidder, followed by Standard Chartered.

Egypt Air's aircraft engines were very old and weak and its spare parts were not easily available, whereas Standard Chartered's were in better condition.

Since Standard Chartered, a

world-renowned company, was the immediate lowest bidder, there was an opportunity for negotiations, reads the case statement.

Besides, Standard Chartered was in operation with Singapore Airlines, while Egypt Air had been lying idle for around seven months.

"Despite this fact, ACC Deputy Director Selina Akter Bangladesh Airlines decided to lease two aircraft from Egypt

Air Holding Co.," the statement added. In the primary inspection, led Captain Ishrat, some maintenance works on

both the leased aircraft were found to be pending rendering them both inoperable as per the "The inspection team did not

mention the pending maintenance works in the report," the complainant said, adding that there was an oil leak from the engines.

According to the terms and condition of the tender, the aircraft engine should have at least 4,000 cycles remaining.

Cops now say trader was held earlier

Refute allegations of torturing him to death

A police probe body has found that Gazipur trader Md Rabiul Islam, who died last month allegedly due to torture in police custody, was arrested days before he died.

We have found that the information about Rabiul's arrest four days before his death was partially correct,' said Molla Nazrul Islam, Gazipur Metropolitan Police (GMP) commissioner, while briefing journalists on the probe findings yesterday.

He, however, didn't confirm the date of the 38-year-old trader's arrest by cops from Basan Police Station.

In the early hours of January 18, a person identifying himself as a cop phoned Rabiul's wife Nupur and said her husband died in a road accident.

The trader's family alleged that police picked him up from his tailoring accessories shop in Pearabagan of Bhogra on January 15 night on charges of gambling.

The GMP commissioner yesterday claimed that the probe body didn't find any evidence of torturing Rabiul in police custody. "We have found evidence that he died in an accident."

He said they have found negligence by some cops in discharging their duties.

"We have already suspended two ASIs for neglecting duties. Besides, we have sent a letter to the inspector general of police, recommending that legal and administrative steps should be taken against the OC of Basan Police Station," he added.

Jupiter's moon count jumps to 92, most in solar system

time leader, comes in a close second with 83 confirmed moons. The Jupiter moons were added recently to a list kept by the International

Astronomical Union's Minor Planet Center, said Scott Sheppard of the Carnegie Institution, who was part of the team. They were discovered using telescopes in Hawaii

and Chile in 2021 and 2022, and their orbits were confirmed with follow-up observations. These newest moons range in size from 0.6

miles to 2 miles (1 kilometer to 3 kilometers), according to Sheppard.

"I hope we can image one of these outer moons close-up in the near future to better determine their origins," he said in an email Friday.

In April, the European Space Agency is sending a spacecraft to Jupiter to study the planet and some of its biggest, icy moons. And next year, Nasa will launch the Europa Clipper to explore Jupiter's moon of the same name, which could harbor an ocean beneath its frozen crust.
