

CHILDREN WITH CANCER A parent's worst nightmare

High cost, lack of accommodation and centralised treatment main obstacles to proper care, experts say

Young parents Ringku Mia's and Shifa Akter's world had turned upside down when their four-year-old daughter Farha was diagnosed with cancer stage-4 that originated from a tumour in her kidney.

Ringku, 35, and Shifa, 26, along with their entire family, have been living through a nightmare for the past four months.

They had to mortgage their only cultivable land in Habiganj's Baniachong to pay for Farha's treatment.

In an unfamiliar city with no relatives not initially take it seriously. However, to turn to, Shifa, mother of three, left when Farha showed signs of jaundice her eldest daughter in the care of her

her youngest daughter, just two years old, spend their nights on the floor of the paediatric surgery unit-5 of Dhaka Medical College Hospital. Meanwhile, Ringku stays in the hospital

Dhaka had expressed displeasure when the US State Department published the list of 110 invitees to the first democracy summit held in December 2021. However, Foreign Minster AK Abdul Momen was optimistic that the Biden administration would invite Bangladesh this year.

2 BCL women 'torture' female student at IU

At night, Tabassum in the dining room of the dormitory wanted to know who among the freshers were residing at the hall.

CRITICAL DOCUMENTARY Tax officials raid **BBC** India offices **Opposition Congress party** condemns actions; ruling **BJP terms the raids lawful**

Indian tax authorities raided the BBC's New Delhi and Mumbai offices yesterday, weeks after the broadcaster aired a documentary on Prime Minister Narendra Modi's actions during deadly sectarian riots in 2002.



Press freedom in the world's biggest democracy has suffered during Modi's tenure, rights activists say, and the opposition Congress party condemned the raids, saying there was an "undeclared emergency" in the country.

A spokesman for the ruling Bharatiya Janata Party (BJP) accused the broadcaster of engaging in "anti-India propaganda" but said the raids were lawful and the timing had nothing to do with the government.

"India is a country which gives an opportunity to every organisation," Gaurav Bhatia told reporters, "as long as you don't spew venom."

"If you have been following the law of the country, if you have nothing to hide why be afraid of an action that is according to the law?"

In a statement on Twitter, the broadcaster said it was "fully cooperating" with authorities.

"The Income Tax Authorities are currently at the BBC offices in New Delhi and Mumbai and we are fully cooperating," it said. "We hope to have this situation resolved as soon as possible.

NEW SETTLEMENTS IN WEST BANK Western powers 'strongly oppose' Israeli moves

The foreign ministers of five Western powers said yesterday they were "deeply troubled" by the Israeli government's decision to legalise nine West Bank settlements and build thousands of new units.

The ministers from Britain, France, Germany, Italy and the United States said: "We strongly oppose these unilateral actions which will only serve to exacerbate tensions between Israelis and Palestinians and undermine efforts to achieve a negotiated two-state solution".

They underlined their backing for a "comprehensive, just and lasting peace in the Middle East, which must be achieved through direct negotiations between the parties.

We continue to closely monitor activity as he sought to ease tensions developments on the ground which impact the viability of the two-state solution and stability in the region at large," they added.

Israel's security cabinet had announced on Sunday that it would legalise nine settlements in the occupied West Bank following a series of attacks in east Jerusalem, including one that killed three Israelis.

These so-called "wild" settlements were built without authorisation from the Israeli government.

US Secretary of State Antony Blinken, who signed up to yesterday's statement, had on Monday already criticised Israel's plans on advancing settlements.

Israel's moves came on the heels of a visit by Blinken to the region in which he explicitly warned against settlement

following violence.

More than 475,000 Israelis reside in settlements in the West Bank, where 2.8 million Palestinians live.

Meanwhile, Israeli troops shot dead a Palestinian teenager in the occupied West Bank early yesterday, Palestinian officials said, with the army saying troops opened fire after the suspect approached them with explosives.

The Palestinian health ministry said Mahmud Majid Mohammed al-Aidi, 17, died from "critical wounds he sustained by live occupation (Israeli) bullets to the head" at Al-Fara refugee camp north of Nablus.

The army said Israeli troops carried out "counterterrorism operations" in several West Bank towns and cities early yesterday.

Man held over rape, murder

Rahima Begum, the victim's mother, filed a case against him.

According to the case statement, Fariha was playing near her house around 8:00am. After two hours, locals found her body in a maize field.

On information, police recovered the body and sent it to Thakurgaon Sadar Hospital morgue for autopsy, the OC said.

Police found several injury marks on the body while preparing inquest report, he further said.

BB CYBER HEIST CASE

CID gets another date for submitting probe report

A Dhaka court yesterday asked the Criminal Investigation Department to submit its report on the Bangladesh Bank cyber heist case by April 4.

The CID has now taken 70 dates to complete its probe into the case filed over the heist of \$101 million from Bangladesh Bank's account with the Federal Reserve Bank of New York in February 2016

Metropolitan Magistrate Rajesh Chowdhury passed the order after Raihan Uddin Khan, additional superintendent of police and also investigation officer of the case, failed to submit the probe report by yesterday.

At least \$81 million was transferred to the accounts in Manila-based RCBC, from where it disappeared into the casinos of the Philippines.

Bangladesh Bank Deputy Director (accounts and budgeting) Zobayer Bin Huda filed the case with Motijheel Police Station on March 15, 2016.

So far, Bangladesh retrieved \$15 million from RCBC and recovered another \$20 million sent to a bank in Sri Lanka.

On February 1 last year, Bangladesh Bank sued Rizal Bank in a US court to recover \$66m of stolen funds.

From October to December last year, they provided finances and counselling to 1,368 families," said Jewel Ahmed, country representative of World Childhood Cancer. Although there are no official cancer statistics for Bangladesh, data from DMCH showed that on average, almost 600 children receive cancer treatment per month at DMCH alone, due to the high number of patient referrals there. The lack of paediatric onco-surgeons for solid tumour management has also been an obstacle to managing the flow of patients at DMCH -- the only facility with a tumour board for children. Jewel suggested that if the government's project to establish dedicated cancer hospitals in eight divisions is implemented, it would greatly improve the situation for grassroots children with cancer, as each hospital will have 20 beds designated for them. On the other hand, Prof Shahnoor emphasised the need for the position of paediatric onco-surgeons at those hospitals to reduce patient flow at DMCH. "Unlike developed countries, we need adequate shelter facilities for both children undergoing cancer treatment and their guardians. She also stressed the need for a higher number of molecular labs to reduce delays in returning urgent medical reports, along with more research and training for healthcare professionals to improve childhood cancer treatment in Bangladesh.

According to the Directorate of Primary Education, dropout rate at the primary level was 39.8 percent in 2010 and it fell to 14.15 percent in 2021.

KM Enamul Hoque, deputy director of Campaign for Popular Education, said, "School meals are vital as many children go to school in an empty stomach every day. It makes it hard for them to focus in class, and their learning outcome does not reach the desirable level.

"Students will get better nutrition if they get mid-day meals at schools. It is also a great incentive for families to send their children to school."

Farha's stomach had begun swelling." Shifa sobbed as she spoke. 'They gave her six rounds of

chemotherapy there to shrink the tumour, before referring us to the Dhaka Medical's tumour board for surgery. The doctors at Dhaka Medical performed the surgery on February 5 and removed the tumour and a portion of her kidney to prevent the cancer from spreading. She still needs to receive 27 more doses of chemotherapy and two doses of radiotherapy.

Shifa added, "The whole process has so far cost us Tk 2 lakh, which we had to arrange without any help from others ... We are somehow getting by.' Farha's father Ringku, a farmer,

said, "This reality was beyond my worst nightmares. I've never experienced the streets and roads of Dhaka. My phone was even pickpocketed right before the surgery, and right now, we are living without communication with anyone.'

The situation is similar for four-year old Imamul Hasan, a cancer patient from Sunamganj, who is suffering from a malignant kidney tumour causing blood to flow through his urine.

Imamul had already come to the hospital late.

Once his family was told about the expenses, they had to go back to the village to mortgage his grandparent's land off to arrange the money.

The delay only further deteriorated his condition.

Prof Shahnoor Islam, unit chief of the paediatric surgery department at DMCH, who excels at paediatric surgical oncology, said, "Although early detection can go a long way, a lack of awareness and information leads to late detection, as patients travel many long winding paths before finally reaching us."

She also reported a severe shortage of beds in her unit, with three to four patients sharing a single one. The unit has only eight beds, mostly occupied by cancer patients.

DMCH's Besides, paediatric oncology and haematology departments have only 30 beds, and a few cabins, making it difficult to accommodate the nearly 200 children with cancer, including outpatients.

"Cancer treatment is expensive ranging from Tk 2 lakh to Tk 12 lakh, depending on the stage and nature, making it difficult for families to afford. Although we are concerned about the risk of infection, abandonment of treatment due to high costs cannot be

Critical reporters, particularly women, say they are subjected to relentless campaigns of online abuse.

BR hires joint venture for projects

Bangladesh Railway yesterday hired a joint-venture firm to carry out preparatory works for several upcoming projects, including building a new rail line from Dhaka to Cumilla via Narayanganj.

Mahbubur Rahman, director of Railway Connectivity Improvement Preparatory Facility Project, and Yuji Asano, general manager (Dhaka office) of Oriental Consultants Global -- the firm representing the joint venture -- signed the contract at the capital's Rail Bhaban.

The consortium of Japan's Oriental Consultant Global, France's EGIS and Malaysia's HSS will carry out feasibility studies, prepare detailed designs and conduct other related works for 11 sub-projects. They are supposed to complete the works within 30 months at a cost of Tk 193.64 crore.

The JV will be assisted by five local companies -KS Consultants Ltd, SODEV Consult International Ltd, STRATEGI consulting Company Ltd, DevConsultants Ltd and SARM Associates Ltd. The new chord linefrom Dhaka to Cumilla via

Vice Chancellor Prof Md Akhtaruzzaman approved the suspension yesterday, according to a press release.



Earlier on February 5, a court sent them to jail in a case filed for stanching money from a covered van driver.

On February 6, the DU authorities suspended another two students -- Tanzir Arafat Tushar and Rahul Ray, who were also BCL leaders -- for "breaching discipline".

BNP shifts Dhaka road march to February 17

UNB, Dhaka

BNP has rescheduled its road march in the capital by a day, deciding to organise the programme on February 17 instead of 18 "due to unavoidable reasons".

BNP acting office secretary Syed Imran Saleh announced the decision at a press conference at its Nayapaltan central office yesterday.

He, however, said the date for holding a similar programme in all other metropolitan cities Rajshahi, Chattogram, Khulna, Barishal, Sylhet, Rangpur, Mymensingh, Cumilla. Faridpur, Narayanganj and Gazipur remains February 18 as per the previous announcement.

BSS, Noakhali Awami League General Secretary Obaidul Quader vesterday said sensing defeat, BNP is now afraid of joining the next general elections and







The High Court yesterday started hearing on a rule it issued three years back questioning the constitutionality of sections 25 and 31 of the much talked about Digital Security Act, 2018.


The relevant sections criminalise the publishing of false and intimidating information -- contributing to the deterioration of law and order -- and detail the penalties for offenders.

The HC bench of Justice Zubayer Rahman Chowdhury and Justice Kazi Ebadoth Hossain began the hearing with writ petitioners' lawyer Imran A Siddique placing argument on the rule. They then adjourned the hearing till tomorrow.

Following a writ petition, another HC bench on February 24, 2020 issued the rule asking the government to explain why the two sections should not be declared unconstitutional.

The petitioners are Dhaka University teachers Mohammad Ismail, Md Kamruzzaman and Md Rafiqul Islam; journalist Mohammad Abdullah; and Supreme Court lawyers Md Asad Uddin, Md Asaduzzaman, Md Zobaidur Rahman, Md Mohiuddin Molla and Md Mujahidul Islam.

3 held over forgery of bail orders

STAFF CORRESPONDENT

Criminal Investigation Department of police yesterday arrested three members of an organised gang who allegedly created forged bail orders of Supreme Court Judges to ensure their clients' release from jail in exchange for money.

The gangs' activities came to light in 2011 when the then High Court judge Hasan Foez Siddique, now the chief justice, visited Magura Judge Court and found that in 11 cases, bail orders of SC

judges were forged. He directed the then deputy registrar of the HC Md Mahfuzul Karim Akand to investigate the matter. After the investigation, Mahfuzul filed a probe report accusing Md Rafiq and Md Daud Elahi.

Based on the findings, the then court keeper of the HC division Md Abdul

Waresh filed a case with Shahbagh Police Station on May 20, 2015.

The case was initially investigated by Shahbagh police station and the Anti-Corruption Commission for more than seven years. However, they failed to solve the case and arrest the culprits, said a CID official, requesting anonymity.

Later, the Police Headquarters tasked the CID with the investigation of the much-talked-about case.

A team of CID's Serious Crime Unit -- the investigating body of the case -- finally arrested Md Daud Elahi, exjamadar (lower class staff) of the High Court, Sheikh Abdul Majed, ex-jail guard, and Ashrafuzzaman alias Rony from Magura early yesterday.

The arrestees, all of whom hail from Magura Sadar, were placed before a court seeking remand for interrogation. The court granted a one-day remand SEE PAGE 4 COL 5

China's Xi hails Iran 'solidarity' Calls for early resolution of nuclear issue

AFP, Beijing

Chinese President Xi Jinping hailed Beijing's "solidarity" with Iran vesterday as he hosted the Islamic republic's President Ebrahim Raisi at the start of a three-day trip.

For the first state visit by an Iranian president to China in more than 20 years, Raisi has brought a large trade and finance delegation to Beijing and was earlier greeted by Xi on a red carpet.

"In the face of the current complex changes in the world, times, and history, China and Iran have supported each other (and) worked together in solidarity and cooperation," Xi said,

according to state broadcaster CCTV.

Both countries face pressure from Western nations over their positions on Russia's invasion of Ukraine, while Iran is already under

to its nuclear programme.

Iran has emerged as one of Russia's few remaining allies as Moscow has been pushed deeper into international isolation over the invasion.

Western countries have accused Tehran of supplying armed drones to Russia for use in the war in Ukraine, a charge it denies.

In December, Washington outlined what it said was an extensive relationship between Iran and Russia involving equipment such as helicopters, fighter jets and drones.

China "supports Iran in safeguarding national sovereignty, independence, territorial integrity and national dignity... and in resisting unilateralism and hegemonism", CCTV reported Xi as saying.

Beijing also "opposes external forces interfering in Iran's internal affairs and undermining Iran's security and stability", and will continue to "promote the early and proper resolution of the Iranian nuclear issue", the Chinese leader said.



We need skilled workers for higher remittance

Potential there, political will needed

It is disappointing that Bangladesh is unlikely to get the desired amount of remittance despite sending well over a million migrants abroad last year, simply because four out of five of them were less skilled. We have been a victim of this problem for many years, and experts and migrant rights activists have given the government a number of suggestions in the past, urging it to implement those. Yet, the findings of the Refugee and Migratory Movements Research Unit (RMMRU), based on the government's own data, suggest that whatever little the government has done to address it has been less than satisfactory.

According to the RMMRU's 2022 Migration Trends Report, the percentage of less skilled workers who migrated abroad rose to 78.64 percent last year from 75.24 percent the year before. According to the expatriates' welfare ministry, the percentage of skilled workers migrating abroad has been dropping every year since 2019-2020, when it was as high as 33.3 percent. In the following two years, that figure dropped to 22.68 percent and 20.4 percent, respectively. Because less skilled workers receive lower wages compared to skilled workers, Bangladesh has not been getting as much remittance as it potentially could, at a time when the economy is going through a difficult phase – when we need remittance earnings the most. On the flipside, the migrants themselves are able to send less money back home to their loved ones, and are more likely to become victims of frauds.

According to the 2021-2022 report of the expatriates' welfare ministry, at least 64 technical training centres and six institutes of the marine technology under the ministry's guidance provide training to aspiring migrants on 55 different trades. The ministry's website also said that 86,437 people got training at those institutes in the 2021-2022 fiscal year. Given that more than a million migrants went abroad in the same year, that number seems quite low. Therefore, the government clearly needs to advertise the availability of such training facilities to migrants better, as well as promote the benefits of receiving such training for individuals prior to migrating. It should also find out whether the training it offers can be better targeted, and should include other specialised training besides what is currently being provided.

A leader of the Bangladesh Association of International Recruiting Agencies said that they receive more demand letters for less-skilled and semi-skilled workers than for skilled workers from Middle Eastern countries, where Bangladeshis migrate to the most. However, it is not because of a lack of overall demand, but because the market for skilled workers there is already being catered to by countries like the Philippines and India. The government needs to find out what these countries are doing that Bangladesh is not, and try and compete with them better. At the same time, it should also look into other potential markets to send Bangladeshi skilled workers

Overall, there is a lot more that the government could do to boost our remittance earnings. And these steps should have been taken a long time ago. However, since the current economic crisis clearly demonstrates how valuable remittance earnings is for our economy, the government urgently needs to take these measures now.

Organ donation pioneer Sarah shows the way forward for many others

Modernity has robbed us of many of our virtues and introduced many vices. Individualism has driven us to a level where we think of the well-being of others only as an afterthought. While we still hear many talk the talk of compassion and kindness, we rarely see anyone walking the walk. In a world so driven by cruelty and self-interest, a 20-year-old gave us all pause with her act of kindness, even in her death.

On January 18 this year, the country's first successful braindead organ transplants took place thanks to Sarah Islam's decision to donate her organs after her death, giving new life to four people – two with fully destroyed kidneys and two without evesight - in the country's first successful brain-dead organ donation. Sarah's contribution was so powerful that MP Mahbubul Alam Hanif even proposed that she be given state honour – a sentiment we laud and support. These kinds of generosity should be promoted by the state because such actions are not just good for the direct beneficiaries, but for the society at large.

It seems her brave decision has reminded us of our dormant humanity. She has inspired seven people, including Prof Sharfuddin Ahmed, vice-chancellor of Bangabandhu Sheikh Mujib Medical University (BSMMU), to also donate their organs. We applaud these selfless people who have responded to Sarah's inspiring call for action. We also wholeheartedly welcome the inauguration of the "Sarah Islam Cadaveric Transplant Cell" at the hospital, which will facilitate the process of donation, benefitting, we hope, countless others in the future.

Sarah's act is especially courageous because various stigmas still exist in our society about organ donation, which discourage people from helping those in desperate need. For example, against an annual need of 20,000-25,000 corneas, Bangladesh's lone eye bank, Sandhani Eye Hospital, is only able to collect 25 to 30 corneas. The demand and supply ratio for kidneys and other organs is similar. More than 20 million people in Bangladesh suffer from some form of renal disease, with an estimated 40,000 dying from kidney failure each year. More than 20,000 of them die because they cannot afford the constant dialysis required to keep living.

Sarah's act of kindness - and that of the seven new donors should move us all to reflect about the roles we play, as individuals, within a collective. Are we really doing our part for this society, or becoming more and more self-centred in our relentless quest for a better life, all the while forgetting that such a pursuit is counter-productive for us all in the long run? It is high time that we confront our internal biases and hypocrisy and take part in acts of kindness that can actually save lives. We hope that the recent organ donations and the inauguration of the aforementioned facility will inspire a new culture of posthumous organ transplantation in the country.

Right to information at home and abroad

One of the reasons we write this column is to show our readers how people here and abroad make use of Right to Information (RTI) legislation. Today, we look at two examples each from Sri Lanka and Bangladesh. All four demonstrate the vast range of ways in which RTI can push for government transparency and accountability. The Sri Lankan examples show the use of the law at the state level, while the Bangladeshi examples show its use at the lowest level of administration.

A group of RTI activists in Sri Lanka asked the highest-level police authorities for information on detainees on remand under the Prevention of Terrorism Act. The activists wanted to know how many detainees were held, the condition of their mental and physical health, and how many were released without any charges. This application for information was refused. In October 2022, the Sri Lankan Information Commission directed the police to provide the information.

The police authorities had denied the request claiming that the release of the information would undermine the defence of the state, national security, or territorial integrity. The Commission, however, was incredulous as to how the requested statistical information (such as the number of arrestees, expectant mothers, individuals receiving treatment) could cause harm to the state. In regard to the detainees who were earlier released without charges, the Commission that disproportionate sums of money



The Sri Lankan tales show how powerful RTI can be on matters of ethical, political, and economic concerns of society and the state.

The Bangladeshi examples we cite below are more mundane, downto-earth, and elemental. They also underline the fact that RTI use in this country remains at that level and has failed to attract the attention of the elite, educated classes to achieve broader goals.

The first case was brought to our attention by RTI activists promoting the law at the grassroots level in Bangladesh.

Shamim Ahmed, from Moulvibazar sadar upazila, submitted an RTI request to the local union council asking for the list of persons who

the union, under the government's social safety net programme for the year 2020-21. Upon receiving the application, the secretary of the union council showed up to the applicant's home and scolded him for having the "audacity" to ask for such information. Shamim had to flee, and reported the incident to a senior member of his RTI group. The latter called upon the secretary and had to promise that Shamim would not pursue a formal response to his request. Unfortunately, such an outcome is not uncommon in Bangladesh.

But the next Bangladeshi example has a happier ending. In November 2022, an RTI applicant named Jahar Lal, also from Moulvibazar, wanted to know whether the Forest Department authority in Cumilla was aware of the damage caused to trees under its jurisdiction by the rampant nailing of posters on them. He reminded authorities that trees are living beings and can feel pain. Mohammad Ali, the concerned officer, agreed that the matter was indeed "inhumane" and promised to take proper action. Ali raised the issue to his colleagues and at a meeting on December 3, 2022, it was resolved that the department will ensure that trees in the district are properly protected and not subjected to such torture.

These four stories from two countries demonstrate different the unique power of the RTI Act to address universal concerns of citizens on matters of governance that affect their lives, whether individually or collectively. They also show how individuals or groups can come together and intervene to remind authorities of their responsibilities under the laws of the land, and how they too can benefit from transparency and accountability in their work.

The 'mega serial' of bank scams

Embezzling thousands of crores of with Badal going on to own 22 taka in the name of taking loans from banks is a regular occurrence in Bangladesh. Sometimes behind the front of business and industrial loans, sometimes through direct fraud and deception, such embezzlement takes place. The frequent reporting on such scams, involving a new bank each time, is reminiscent of a popular web series portraying heists. The latest Tk 16.000 crore LC fraud from Social Islami Bank and the Tk 30,000 crore loan scam from Islami Bank by S Alam Group are the latest additions to this parade. These incidents are so systematically organised, using different institutional patronages, that they cannot be called exceptional events and must be seen as an established mechanism of capital accumulation by looting the public's money.

Looting in the name of bank loans

In Bangladesh, the easiest and most common method of primary capital accumulation for businesses is to get loans from public and private banks without collateral or with inadequate collateral using political patronage and by bribing bank managers. Then, they default. Debt restructuring, lawsuits, investigations, and writs continue for vears.

Yunus Badal, who was caught by the police for stealing a car in 2007, emerged as one of Janata Bank's biggest borrowers in 2010 due to his political patronage. Janata Bank violated loan approval rules and provided him with loans worth Tk 5,000 crore in just six years. The chief perpetrator of the Sonali Bank-Hallmark scam, Tanvir Mahmood, embezzled Tk 2,731 crore. Both private sector bank in Bangladesh, is BB agreed and the companies were became businessmen of great scale,

enterprises.

Bank heists by bank owners

Unlike other private or public limited companies, a paid-up capital of Tk 400 crore is required to establish a bank. After that, thousands of ordinary people deposit their savings in said bank. By investing only Tk 400 crore, the bank owners are able to control the deposits of thousands of crores of taka, decide where to invest it, and who to lend it to. So, to accumulate a huge amount of money by investing very little, one first acquires a bank licence using political connections and then embezzles the deposited money under the guise of loans.

According to Bangladesh Bank (BB) policies, no bank director can borrow more than 50 percent of their total shares from their bank. To bypass this regulatory hurdle, bank owners either get loans from their banks through relatives or front companies, or take out loans from other public or private banks by establishing a "mutual understanding" with other directors/owners.

The looting of the Farmers Bank deposits by the owners themselves is a case in point. Due to corruption by the owners, the bank which came into operation in 2013 quickly fell into a capital deficit of Tk 283 crores. By December 2017, its amount of defaulted loans increased to Tk 723 crore. In a report, the BB had held Farmers Bank's former chairman Muhiuddin Khan Alamgir and exchairman of its executive committee Mahabubul Haque Chisty largely responsible for the scams.

The case of Islami Bank, the largest another example of how people's given a rescheduling benefit of only

deposits are looted by bank owners themselves.

In January 2017, the bank fell into a severe financial crisis, just 15 months after its ownership came into the hands of S Alam Group. According to BB's audit report, S Alam Group has taken out more than Tk 30,000 crore in loans from Islami Bank using various unethical mechanisms.

instead of the usual 10 percent. The total amount of the restructured loan was Tk 15,000 crore. Despite these concessions, after two years, six of these companies - Beximco, SA Group, Ratanpur Group, RSRM, Keya, and MR Group – failed to repay instalments. Interestingly, Beximco which had obtained one-third of the

one to two percent down payment, could also avail new loans.

In this way, through rescheduling, defaulted loans are shown to be reduced without even collecting them. Two other methods used to mask the reality of default loans are the relaxation of loan write-offs and classification policies. In February 2019, BB reduced the time period after which banks can write-off bad

steal money from banks.

Although an investigation was carried out in the case of the central bank reserve theft, the investigation report was not published and the guilty persons were not prosecuted. The parliamentary committee related to the finance ministry has not published the investigation report on the Sonali Bank-Hallmark scam, either. The trial of 38 cases filed by the Anti-Corruption Commission (ACC) against Hallmark is still continuing at snail's pace.

Authorities were reportedly fully aware of the irregularities and corruption of the former chairman of BASIC Bank, Sheikh Abdul Hye Bachchu. But no action was taken against him. The ACC filed 56 cases in this regard, but Bachchu, accused of being the mastermind, was not charged in any of them. Expressing dissatisfaction with the ACC's role in this case, the High Court recently said, "Crores of taka have been embezzled. But no work is being done though the Anti-Corruption Commission and so many judges and lawyers are there. Why are they [ACC] silent? This is just like a drama. We are watching the drama. This is not acceptable.'

Recognise the pattern

It is evident that, while disbursing loans, state-owned banks prioritise those who are close to the state power. On the other hand, private banks act for the primitive accumulation of capital, prioritising businesses related to bank owners and directors. Sometimes, powerful loan defaulters obtain stay orders from the HC using legal loopholes to not be included in the defaulters' list and thus continue to take out new loans from other banks.

If we closely observe and analyse the context of each of the ongoing banking scams, a structural pattern becomes evident, one that is directly related to the country's capital formation, the structure of the financial and banking sectors, and the interests of the booty capitalist. And there is no chance of ending this "mega serial" of scams without strong and organised resistance from the people.

VISUAL: SALMAN SAKIB SHAHRYAR restructured loan - made profits and debts from five years to three years,

paid dividends, yet did not pay back loans.

In May 2019, BB issued a directive providing loan defaulters the opportunity to reschedule their classified loans by making a down payment of only two percent, instead of the previous 10-50 percent. The interest rate was capped at nine percent from 12-16 percent and the tenure for repayment was made 10 vears.

In July 2022, the central bank allowed businesses to reschedule their loans by making a down payment of 2.5 to 6.5 percent on their term loan, instead of the previous 10 to 30 percent. It also extended their payment tenure to five to eight years, from the previous maximum of two years. In the meantime, businesses

and increased the amount which banks can write off without filing a lawsuit with the Artha Rin Adalat from Tk 50,000 to Tk 2 lakh. This has been further increased to Tk 5 lakh, according to the latest directive issued on January 5, 2023. And in April 2019, the time period after which an overdue loan can be classified as "substandard," "doubtful," or "bad/ loss" was increased to three months.

Culture of impunity

Habitual bank loan defaulters who are politically connected are not punished for embezzling public money. Only the small fish are caught and put in jail. The probes and trials go on for years without any conclusion. This culture of impunity encourages defaulters to continue to

Unbridled loan restructuring facilities

Default loans are becoming more and more prevalent because vested groups are using their political backing and colluding with bank directors and owners to obtain the loans. Far from recovering thousands of crores of the people's money and punishing the defaulters, the banks are instead giving them rescheduling benefits, with relatively low interest rates and long-term restructuring facilities.

According to a report published by The Daily Star, in 2015, 11 big business groups – each of them having taken out loans of over Tk 500 crore from different banks - led by Beximco made a proposal to Bangladesh Bank for restructuring their bad loans. The

Once a forest, now salt fields

Thirty-five hectares of mangrove forest in Eastern Char Dhurung village under Cox's Bazar's Kutubdia upazila have been turned into salt fields. Thousands of trees were felled in the process, at a cost of the area's biodiversity and environmental balance.

According to forest officials, the mangrove forest, which contained at least 70,000 saplings, was established in 2019-20 as part of a forest department project on Khas land under the jurisdiction of the deputy commissioner.

Shamim Reza, ranger of the Kutubdia coastal forest office, admitted that encroachers have destroyed the forest to make salt fields. "We reported the matter in writing to our higher authorities."

"We could not take legal action against the encroachers as the land is under the DC," he added.

During a recent visit, this correspondent found that most of the trees in the forest have been cut down by the encroachers. Labourers were seen working in the salt fields that were created by massive deforestation.

Mohammed Malek, a worker, told The Daily Star that they have been working there for the last 6 months on daily wages.

"I'm working here according to the instructions of the owner," he added. Local and forest officials said Mohammed

Sujan and Abdul Mazeed, two locals, have taken over most of the forest and turned it into salt fields.

However, Mohammed Sujan claimed that the forest department planted trees in the lands after it emerged as a Char.

"But these lands were our ancestral property, which we lost to river erosion. Now we are producing salt in the land," he said.

When asked about the tree felling, he said they were just "clearing" the land for salt production.

A new hope for **Dhaka-Ctg route** passengers

Railway plans to launch new train after 7 years

After seven years, Bangladesh Railways is planning to launch a new intercity train on the Dhaka-Chattogram route, aiming to provide a quick and hassle-free journey to passengers on this busy route.

'The ministry gave us a demand letter for running a new non-stop train on the Dhaka-Chattogram route last month. Following this, we have already prepared a proposal with a new schedule of currently running trains. We will send it to the railways ministry for final approval soon," said Jahangir Hossain, general manager of the BR (east).

Besides, the schedule of currently running trains on this route will change as a new train is planned to run with the existing engine-coach of other trains plying this route, said an official of the BR.

According to BR officials, the last intercity train on this route -- Sonar Bangla Express -- was added in 2016.

Around 11,000-12,000 passengers travel on the route every day, said Chattogram Railway Station sources.

For them, currently, there are eight passenger trains running daily on the route. Of these, six intercity trains are Subarna Express, Mahanagar Express, Mahanagar Godhuli, Sonar Bangla Express, Chattala Express and Turna Express.

The total number of seats in these trains is 5.235.

Besides, two mail trains -- Dhaka Mail and Karnaphuli Express -- are running every day on this route.

Billah Hossain, a regular passenger on this route, told The Daily Star that travelling on this route and to get train tickets is always a hassle. "We hope the sufferings will reduce with the new train on this route," he said.

Ratan Kumar Chowdhury, manager of Chattogram Railway Station, said the ticket crisis will be solved and passengers will benefit once the new non-stop train is introduced.

According to BR, after witnessing a massive shortfall in revenue due to the pandemic and lockdown, the BR eastern zone has improved its position on this front in the 2021-22 fiscal year and has earned a total revenue of Tk 493 crore 75 lakh in 2021-22 against the Tk 318 crore 22 lakh during the previous fiscal year, thus registering a

From dropout to role model in five years

How a Bandarban youth found success in farming

He was a youngster with big dreams, hailing from Tangpru Para of Bandarban. Thoai Sing Hla Marma came to Dhaka in 2014, to pursue his goal of becoming a civil engineer, and got admitted to the National Polytechnic Institute.

But life in Dhaka is not always easy for youths coming all the way from the Chattogram Hill Tracts. When he was in the eighth semester, he had to drop out and return to his village home due to financial trouble.

"I fell into depression during that time," Thoai told The Daily Star during a recent conversation.

"When I returned home in 2018, I had to work as a day labourer on other people's land for Tk 500 per day. As the eldest child, I had no choice but to bear the burden of my family," he added.

However, being the dreamer that Thoai is, he did not give up that easily. He decided to become an agricultural entrepreneur and saved Tk 20,000 by working relentlessly for two years.

His misfortunes continued to haunt him. After the advent of the pandemic, Thoai lost all avenues to earn money, and his savings depleted quickly.

Thoai did not lose his resilience. When the lockdown eased in 2021, he took a Tk 50,000 loan from the "My house, My farm" (Aamr Bari Amar Khamar) project of the government and started

cultivating papaya.

A year later, he repaid the loan with his earnings, obtained another Tk 1 lakh loan from the same project, and planted 1,000 papaya saplings on an acre of hillside land. The wheels of his fortune started

turning, finally. "I earned Tk 2 lakh the next season by

selling papayas. After repaying the loan, I planted mango seedlings and took lease of a pond with the rest of the money. I began raising fish in the pond and also set up a chicken farm," Thoai said.

Contacted, Mongsanu Marma, a public representative of the area, said, "Thoai had a difficult life. Despite dropping out of college due to the economic crisis, he did not stray. He worked very hard to become self-reliant."

He added that Thoai has become a role model for the youth in the village. "The nation will benefit if educated youth engage in farming rather than seeking jobs.

India to host SAFF C'ship in June

India will host the upcoming SAFF Championship in June, it was announced yesterday after the executive committee of the South Asian Football Federation signed over the marketing and commercial rights to Dubai-based marketing company Sports Partner International for the next four editions of the regional football extravaganza.

"We have approved the tender from Sports Partner International for four editions up to 2029. Although Nepal launched a bid to host the next SAFF Championship, three home matches and three away the first tournament during will

be held in India in line with the marketing company's conditions," SAFF general secretary Anwarul Haque Helal told The Daily Star after a virtual meeting.

Helal also informed that All Indian Football Federation (AIFF) would apprise them of venues and dates by March 10.

The last edition of SAFF Championship was held in the Maldives in 2021 after India played host in 2015.

The marketing company has also proposed holding the 2025 SAFF Championship on a home-and-away basis, which will see each team play matches in a one-month period.

"India has objected to the homeand-away format because it will take a long time, but the marketing company believes there is still room for discussion," Helal added. "If we don't reach a consensus in the coming days, the SAFF Championship will be held in a centralised venue like this time."

The SAFF general secretary also informed that the marketing company will provide SAFF with 1 million dollars for the 2023 SAFF Championship and 1.5 million dollars from 2025 edition, subject to the approval of the new format.

Helal also informed that the SAFF Congress would take place on May 6 April 29 in Dhaka.

Sayeed attends **BHF** meeting after three-and-ahalf-year hiatus

AKM Mominul Haque Sayeed, the general secretary of the Bangladesh Hockey Federation (BHF), suddenly appeared at a meeting of the Bangladesh Hockey Federation's (BHF) executive committee today after a three-and-a-half-year hiatus following his alleged involvement in the 'casino scandal' in 2019.

Sayeed fled aboard after the crackdown in Motijheel's Club Para in September of 2019 and had not attended any BHF executive committee meetings since. In February, 2022, on the back of a 27-month investigation, the Anti-Corruption Commission filed a charge sheet against the former Dhaka South City Corporation (DSCC) councillor for amassing about Tk 5.60 crore from undisclosed avenues of income.

Sayeed joined the meeting at the last moment. When asked about his sudden appearance, BHF president and Air Chief Marshall Shaikh Abdul Hannan said: "If there is no hindrance, he [Sayeed] will be included in the general process. If there is no restriction in principal, then I there are restrictions from my side. The vice presidents and other members will take the appropriate decision."

The BHF president added in a separate response: "He can assume responsibility as general secretary if there are no barriers.'

However, one of BHF executive member, seeking anonymity, informed that the BFF executive committee had released Sayeed from his responsibilities before in line with the constitution due to his continued absence from meetings and had communicated that decision to the National Sports Council.

Another source, preferring to remain unnamed, said that Sayeed was going to manage a sponsor worth Tk 50 lakh for the youth hockey team's training camp ahead of Asian Youth Championship and that Sayeed was likely to represent the BHF in the upcoming Asian Hockey Federation congress.

The meeting also decided to continue the training of the youth team under the guidance of local coach Mamunur Rashid and Hedayetullah Razib.

Election Commissioner Md Alamgir has said the post of president is not an office of profit and there is no obstacle for Md Shahabuddin to hold the post.

According to law, after the end of an individual's service as a commissioner of the Anti-Corruption Commission, the person will not be eligible to hold an office of profit in the service of the government.

After the announcement of Shahabuddin's nomination for president, questions arose as to whether the office of president is profitable.

When reporters asked him about this, Election Commissioner Alamgir yesterday said the EC made decisions knowing the law. "When Justice Shahabuddin became president [in 1996], a case was filed about it, because judges cannot hold any office of profit [after their service]."

The High Court then said there was no bar to Shahabuddin's presidency, he said. "We have before us a specific example of the High Court [verdict] SEE PAGE 6 COL 4

TURKEY-SYRIA EARTHQUAKE 7m children affected

Says UN, voices fear that 'many thousands' more died

More than seven million children have been affected by the massive earthquake and a major aftershock that devastated Turkey and Syria last week, the United Nations said yesterday, voicing fear that "many thousands" more had died.

"In Turkey, the total number of children living in the 10 provinces hit by the two earthquakes was 4.6 million children. In Syria, 2.5 million children are affected," James Elder, spokesman for the UN children's agency Unicef, told reporters in Geneva.

"Unicef fears many thousands of children have been killed," Elder said, warning that "even without verified numbers, it is tragically clear that numbers will continue to grow."

"Tens of thousands of families are exposed to the elements at a time of year when temperatures are bitingly cold, and snow and freezing rain are common," he said, pointing to reports of rising numbers of children suffering from hypothermia and respiratory infections, reports AFP.

The World Health Organization said yesterday that massive earthquake constituted the "worst natural disaster" in 100 years in its Europe region.

"We are witnessing the worst natural disaster in the WHO European region for a century and we are still learning about its magnitude," Hans Kluge, WHO regional director for Europe, told a press conference.

The WHO's European region comprises 53 countries, including Turkey. Syria is a member of the WHO's neighbouring Eastern Mediterranean region.

'Did Modi pressure Hasina to accept Adani deal?' Congress asks BJP govt

Indian National Congress yesterday asked the country's government if Prime Minister Narendra Modi had "put pressure on his Bangladesh counterpart Sheikh Hasina to accept terms that were extremely favourable to Adani Power and unfavourable to Bangladesh" in the agreement for power purchase from a plant in Godda, Jharkhand.

The party said the Congress-led UPA government had signed an MoU in 2010 for the state-owned National Thermal Power Corporation to set up a 1,320MW power plant in Bagerhat.

Congress alleged that after assuming power, the BJP announced that Adani Power and Reliance Power (Ambani) would construct power plants to supply electricity to Bangladesh.

Use of the boxy electric vehicles is to be limited to full time employees who will be able to use the service only to travel the short distance between two Zoox headquarters buildings about a mile apart in Foster City, near San

CAMPUS SHOOTING Three dead, 5 hurt in US

Three people were killed and five others wounded Monday when a gunman opened fire on a university campus in the United States, before fleeing the scene, local police said.

The suspect opened fire inside a building at Michigan State University shortly after 8:00 pm local time, said Chris Rozman, interim deputy chief of campus police.

The gunman then moved on foot to a nearby building where more shots were fired.

"There are three confirmed fatalities," Michigan State University police said in a statement on Twitter. "This is in addition to the five victims who have been transported to the hospital."

Some of the wounded had suffered life-threatening injuries, Rozman told reporters.

Police released a photo of the suspect, a short Black man, wearing red shoes, a denim jacket and a baseball cap.

'A dark spot' in the country's legal history

HC slams B'baria Bar Association for courtroom incident

Brahmanbaria District Bar Association has made "a dark spot" in the country's legal history as they have scandalised the entire lawyers' community by using force, the High Court said yesterday.

"If this situation continues, they [lawyers] will have to face consequences," warned the HC bench of Justice JBM Hassan and Justice Razik-Al-Jalil, blasting the president and two other lawyers of the association for misbehaving with the judge of Nari O Shishu Nirjaton Tribunal-1 and creating chaos in the courtroom on January 2.

"Be it the president or a member of a bar, no one is above the law. We will take action if the [Bangladesh] Bar Council, the licensing authority of the country's lawyers, doesn't do anything to this effect. We learnt from the media what happened at the Brahmanbaria court.

"You are boycotting court, you do it. But the litigants are being disturbed and threatened."

The HC too can examine whether the lawyers are eligible to practice law, said the bench.
