

Ex-employee of TV channel sues in-charge for rape

A former female employee of a private television channel has filed a case against the channel's assignment editor for raping her with false promises of marriage.
The employee filed the case with Wari Police Station on Monday. Police yesterday sent her to the One Stop Crisis Centre (OCC) of Dhaka Medical College Hospital for a medical test.
According to the FIR, the woman met the accused in February last year while working at the channel, where she worked till September 30 last year.
The accused also recorded personal videos and took photographs of

the employee on his phone, with which he blackmailed her, the woman mentioned in the FIR.
This newspaper could not reach the accused over phone despite repeated attempts.
The employee could not be reached either, as she is currently in police protection for her medical examination.
Mostazirur Rahman, officer in charge of Wari Police Station, said, "A case has been filed and we are currently investigating it."
Asked about interrogating the accused, Mostazirur said they are yet to detain or arrest him. "Let us work on this. We cannot disclose the details to you."

Man 'kills father over land dispute' in Mymensingh

A man reportedly killed his father over a land dispute in Mymensingh's Sadar upazila yesterday morning.
The victim is Md Joynuddin, 75, of the upazila's Abdullahpur village, said police.
Quoting family and neighbours, Md Faruq Hossain, officer-in-charge of Kotwali Police Station, said Joynuddin recently registered 30 decimals of land for Abdul Matin, 35, the son of his first wife.

As there was a mistake in the land document, a feud began between them.
Yesterday, Matin allegedly hacked his father indiscriminately. Joynuddin died on the spot.
On information, police rushed to the spot, recovered the body and sent it to Mymensingh Medical College Hospital morgue for autopsy.
None has been arrested as Matin fled the scene, and no case had been lodged till the filing of this report, said the OC.

Ripon has allured one of his neighbour's daughters to send her to Saudi Arabia, telling her that a job will pay Tk 50,000 a month, with food and housing allowances and two-yearly festival bonuses.
On February 3 last year, the victim went to Ripon's office in Paltan. On February 15, they assured the victim to send her to Saudi Arabia to work as a house help.
On October 4 last year, they made the victim's family sign a stamp paper stating that the victim will not return home within the next two years. The expense to send her back will be Tk 3 lakh, including the air ticket and medical fees.
On October 19, the victim was flown to Saudi Arabia on a flight around 5:00pm, reads the FIR.
However, within 15 days, the victim called her family and said she did not get the promised job, adding that her employer was physically torturing her, said the FIR.

There are several cases against the members of the fraud ring and efforts are on to arrest more accused involved in such activities, said the officials.

Narayanganj is expected to reduce the distance between Dhaka and Chattogram by 90 kilometres and travel time by one and a half hours, said BR officials.
The existing Dhaka-Chattogram rail line, which goes through Tongi-Bhairab-Akhaura-Cumilla-Laksham, has a distance of 320 kilometres.
Apart from the chord line, the consulting firm will also carry out the feasibility study and prepare a detailed design for a new bridge parallel to the existing century-old Hardinge Bridge over the Padma River in BR's western zone.
The firm will also assess the future demand for rolling stocks, prepare core and non-core business plans for BR and carry out a need analysis for establishing a signalling training centre for BR, among other assignments.

In June 2020, the government approved the Tk 235.37 crore Technical Assistance Project, with the Asian Development Bank providing Tk 167.14 as a loan. The deadline for the project is December this year, implying that it will be extended.
BR Director General Quamrul Ahsan said among the sub-projects, the chord line and second Hardinge bridge are urgent. "We are requesting you to complete the works [regarding the two projects] at the earliest, so that we can take investment projects," he told the firms.
Railways Minister Nurul Islam Sujan said many projects are not completed citing different excuses. "We hope they will complete the work in time, if possible before the time."
He suggested keeping a provision in future projects which will ensure action against contractors or consultants upon failure to meet project deadline.
Railways Ministry Secretary Humayun Kabir chaired the contract-signing programme.
