## **BCL** factions again clash at CU

### Hall rooms vandalised

Two factions of Bangladesh Chhatra League of Chittagong University locked into a clash on the campus yesterday.

The clash took place between the factions of "Bijoy Group" in front of Suhrawardy Hall around 5:30pm, according to witnesses.

At least 10 rooms of the dormitory were vandalised, they said.

On February 21, at least 12 people were injured when the same groups clashed on the campus over occupying a room in Alaol Hall.

"A BCL activist of Suhrawardy Hall came under attack by the activists of a rival faction when he went to play on the ground of Alaol Hall in the afternoon," said CU BCL Joint General Secretary Md Ilias, when contacted over yesterday's incident.

Ruhul Amin, officer-in-charge of Hathazari Police Station, said, "The proctorial body of the university and a police team rushed to the spot and brought the situation under control."

Md Al Amin, a leader of another faction, said, "The Suhrawardi Hall BCL activists have been threatening their activists in various ways for a long time. They threatened one of his activists again this [Friday] afternoon, which triggered the clash.

# Won't issue injunction to media

Says India's SC on Adani issue

India's Supreme Court yesterday rejected a plea seeking to gag the media from reporting on the Adani-Hindenburg issue till the court pronounces its order.

The apex court had reserved its order on February 20 on a batch of PILs on the recent Adani Group shares crash triggered by the Hindenburg Research's fraud allegations.

A bench headed by Chief Justice DY Chandrachud declined the plea of advocate M L Sharma who mentioned the matter, reports The Indian Express.

"We are not going to issue any injunction to the media", the bench also comprising Justices PS Narasimha and JB Pardiwala

The top court on Monday had refused

the petitioners and a report published by Forbes in a batch of PILs.

The top court on February 17 had refused

to accept in a sealed cover the Centre's suggestion on a proposed panel of experts for strengthening regulatory measures for the stock market. Observing that it wants to maintain full

transparency in the interests of investors, it said it would rather not accept the Centre's suggestion in a sealed cover. "We will not accept the sealed cover suggestion by you because we want to maintain full transparency," the bench had said.

> Till now, four PILs have been filed in the top court on the issue by lawyers M L Sharma and Vishal Tiwari, Congress leader Jaya Thakur and activist Mukesh Kumar. Adani Group stocks have taken a beating on the bourses after the Hindenburg Research made a litany of allegations, including fraudulent transactions and share price manipulation, against the business conglomerate.

The Adani Group has dismissed the charges as lies, saying it complies with all laws and disclosure requirements.

The members of the Coalition are Australia, Canada, Denmark, Netherlands, Norway, Sweden, Switzerland, United Kingdom and United States.

The Media Freedom Initiative (MFC) is a cross-regional partnership of countries working together to advocate for media freedom, and for the safety of journalists and media workers, while holding them accountable who harm journalists and restrict them from doing their jobs.

Established at the Global Conference for Media Freedom in July 2019, the MFC now has over 50 member states from six continents.

Nine foreign missions in Bangladesh on February 9 launched the Diplomatic Network Initiative aimed at supporting media freedom in Bangladesh.

The UNGA resolution adopted reiterated its demand that Russia "immediately. completely unconditionally withdraw all of its military forces from the territory of Ukraine and called for a cessation of

According to UN News, the UNGA were present. resolution urged member states to cooperate in the spirit of solidarity to address the global impacts of the war on food security, energy, finance, the environment, and nuclear security and safety.

Underscoring that arrangements for a lasting peace should consider these factors, the UNGA also called upon all nations to support the secretary-general in his efforts to address these impacts.

The Assembly also reaffirmed its commitment to the sovereignty, independence, unity, and territorial integrity of Ukraine within its internationally recognised borders, extending to its territorial waters.

The resolution also emphasised the need to ensure accountability for the most serious crimes under international law committed in through independent national international or investigations and prosecutions to ensure justice for all victims and the prevention of future crimes

At the outset of the session on Wednesday, the Assembly President, Csaba Kőrösi, said that in this "new chapter of history", the world is facing "stark choices about who we are as an international community.

'These choices will either set us on a path of solidarity and collective resolve to uphold the tenets of the UN Charter," he said, "or a path of aggression, war, normalised violations of international law and collapsed global action."

Days after the February 24, 2022 invasion, UN Security Council members voted to allow the General Assembly to convene the eleventh emergency special session after Russia had vetoed a resolution that would have condemned the invasion

In line with resolution 377A(V), adopted in 1950, the Assembly is able to take up international peace and security matters when the Council fails to do.

# Bangladesh abstains RHD, metro rail authority at odds

Officials of the RHD and the DMTCL and their consultants had a meeting on March 23, 2021. Then RHD chief engineer Abdus Sabur and MRT-5 Project Director Aftab Hossain Khan

At the meeting RHD officials said blocking the highway corridor with metro rail structures would not be sustainable.

They requested the metro rail's consultants to explore other options, including relocating the MRT-5 depot to the south, according to the meeting

But Aftab said the depot cannot be moved south due to technical reasons and that approval for land acquisition for the depot had already been issued.

RHD officials said their feasibility study on the expressway did not consider the metro rail. They asked for the Hemayetpur to Aminbazar section of the rail line to be either moved south or taken underground.

MRT-5 Project Director Aftab said the line was planned on RHD land in accordance with Strategic Transport Plan (STP) or revised STP.

During a televised address in Kyiv yesterday, Zelensky said: "We have become one family. There are no more strangers among us ... Ukrainians have sheltered Ukrainians, opened their homes and hearts to those who were forced to flee the war."

"We withstand all threats, shelling, cluster bombs, cruise missiles, kamikaze drones, blackouts and cold," he said. "And we will do everything to gain victory this year."

Britain announced new sanctions on Russia, and other Western powers were expected to do so around the G7 online summit, led by Biden, who journeyed to Kyiv and gave a landmark speech in Warsaw this week to mark the anniversary.

The United States yesterday announced sweeping sanctions aimed at increasing economic pain for Russia, reports Reuters.

The new sanctions, which target sectors including banks, mining, and the defence industry, will hit "over 200 individuals and entities, including both Russian and thirdcountry actors across Europe, Asia, and the Middle East that are supporting Russia's war effort," the White House said.
