China urges Russia, Ukraine, warns against using nuclear weapons

China yesterday called for urgent peace talks as it released its plan to end the war in Ukraine, but Western powers quickly rebuffed the proposals while warning against Beijing's closening ties to Moscow.

The 12-point paper calling for a "political settlement" of the crisis follows accusations from the West that China is considering arming Russia, a claim Beijing has dismissed

Timed to coincide with the one-year anniversary of Russia's invasion of Ukraine, the paper calls for all parties to "support Russia and Ukraine in working in the same direction and resuming direct dialogue as quickly as possible," reports AFP.

It also makes clear its opposition to not only the use of nuclear weapons, but the threat of deploying them, after Russian President Vladimir Putin threatened to use Moscow's atomic arsenal in the conflict.

But the document was immediately met by scepticism from Ukraine's allies, with Nato chief Jens Stoltenberg saying Beijing "doesn't have much credibility because they have not been able to condemn the illegal invasion of Ukraine"

US President Joe Biden's national security advisor said the war "could end tomorrow if Russia stopped attacking Ukraine and withdrew its forces".

"My first reaction to (the position paper) is that it could stop at point one, which is to respect the sovereignty of all nations," Jake Sullivan told CNN.

And German President Frank-Walter Steinmeier said that while "every constructive suggestion that brings us closer on the path to a just peace is highly welcome... whether global power China wants to play such a constructive role is still doubtful".

Meanwhile, Nato Secretary-General Jens Stoltenberg vesterday reacted reservedly to a Chinese proposal for a ceasefire in Ukraine, saying Beijing did not have a lot of credibility as a mediator, according to Reuters.

North Korea fires more missiles

North Korea said yesterday it had fired cruise missiles and claimed that ramped-up US-South Korean military drills "can be regarded as a declaration of war". It came after the two allies conducted a tabletop

exercise at the Pentagon focused on responses to a nuclear attack by Pyongyang. North Korean forces held a "strategic cruise missile launching drill" in the early hours of Thursday, firing four Hwasal-2s, the official Korean Central News Agency reported yesterday. The exercise demonstrated North Korea's "deadly nuclear counterattack capability against the hostile forces", it said. The defence ministry in Seoul questioned that description of the test, saying there was a difference between what was announced and what US and South Korean surveillance detected.

Bird flu situation in Cambodia 'worrying'

The World Health Organization is working with the Cambodian authorities after two confirmed human cases of H5N1 bird flu were found in the country among one family. Describing the situation as "worrying" due to the recent rise in cases in birds and mammals, Dr Sylvie Briand, the director of epidemic and pandemic preparedness and prevention, told reporters that WHO was reviewing its global risk assessment in light of the recent developments. On Thursday, Cambodian authorities reported the death of an 11-year old girl due to H5N1, and began testing 12 of her contacts. Her father also tested positive for the virus.

"When families face high levels of OOPS, including primary healthcare user fees, they can forego critically important care or resort to borrowing money or selling assets, which can threaten their livelihoods."

The eighth five-year plan names Bangladesh's existing health financing levels as insufficient and specifies that rising OOPS threatens to undermine national poverty reduction efforts, the report said.

Subsequently, the WB called for exploring health financing reforms that increase public financing for the health sector to reduce OOPS. At present, the ministry

of health and family welfare allocates resources based on historic line-item budgets, a practice known as "passive purchasing." However, this
