WAR IN UKRAINE **Balancing** act may get trickier for Bangladesh Say security analysts

Security analysts fear that the Ukraine-Russia war could intensify in the coming days, pushing the whole world into further trouble, unless there are serious peace initiatives to stop the war that began a year ago.

If the war continues, the world will become more polarised between the Sino-Russian bloc and the US-led bloc, and Bangladesh like many other countries that maintain a neutral stance will find it increasingly difficult to make a balance, they said. Russia is now controlling a significant part of Eastern Ukraine and annexed it through a referendum. "So, it is not easily leaving Crimea, which was annexed in 2014, and the newly annexed region," said Bangladesh Institute of Peace and Security Studies (BIPSS) President Maj Gen (retd) ANM Muniruzzaman. "During the winter, the fighting took place at a comparatively low level, but as the spring is starting in March and the Western powers have pledged modern tanks to Ukraine, it is likely that the fighting will intensify then," he added.

Independent power producers warn, want \$1.05b to be in operation for March-June

Private power plants that use furnace oil risk facing severe shortage of fuel and this may result in power cuts during the hottest months of this year.

These plants will need \$ 1.05 billion between March and June to import enough fuel, according to a letter sent by the power producers' association to Bangladesh Bank.

The amount is more than a quarter of the total fuel cost Bangladesh Power Development Board (PDB) estimates that it will need in that period to ensure adequate power supply

Since the power generated by these plants is expensive and the foreign exchange reserve has been in decline, the government may prioritise plants that require cheaper fuel like gas

But the private plants make up as much as 27 percent of the total capacity of the country's grid. The likelihood



of them remaining underutilised raises concerns of major power cuts in summer.

The country's energy security is at peril without Bangladesh Bank's support for import of furnace oil or HFO, lube and spare parts for the plants, said the letter Bangladesh Independent Power Producers' Association sent to the BB on February 20.

"Due to the shortage of US dollars in the market, it is not possible for the member companies to import the required HFO... to meet the demand of electricity... The power producers are unable to import the required fuel and parts," said the letter signed by the association President Faisal Khan.

These power plants need 21.2 lakh tonnes of HFO

Contacted, BB Executive Director Mezbaul Haque said that the central bank will provide support according to whatever decision the government makes. The private power plants have already received over a billion dollars from the BB this year, he told The Daily Star.

However, according to the PDB 2022 report, the government last year spent only about half the budget it allocated for buying HFO and diesel because of shrinking dollar reserves.

BNP ROAD MARCH Over 100 hurt in clashes with police, AL men At least 100 held

Over 100 leaders and activists of the BNP were held during the party's nationwide road march programme yesterday.

At least 100 more people, including six policemen, were injured when police and the ruling party men attacked them.

In Natore, six crude bombs exploded near the BNP's party office.

"Jubo League and Chhatra League men hurled the bombs from motorcycles to scare our men," said Zillur Rahman Khan Chowdhury, general secretary of Natore city unit BNP.

Contacted, Farhad Bin Aziz, president of the district unit BCL, refuted the allegation and said the BNP men were behind the blasts.

Fifty-nine leaders and activists of the BNP were held in this connection, said police.

In Jhalakathi, some 60 BNP activists and six policemen were injured in a clash between police and the party men. The clash broke out when police intercepted the BNP's

march on Amtala road in the town.

"Police attacked our peaceful programme without any provocation," said Sahadat Hossain, member secretary of the district unit BNP.

BNP Chairperson Khaleda Zia can't participate in elections because of her convictions in corruption cases. said Law Minister Anisul Huq.

However, there was no such condition that she would not be able to engage in politics, he added.

The minister was talking to local reporters after attending the centenary celebrations of Jamsherpur High School in Badoir union of Brahmanbaria's Kasba upazila yesterday.

"As Begum Khaleda Zia has been convicted in two cases, she is barred from contesting elections under Article 66 of the constitution."

Anisul, the chief guest at the event, said one of those cases was heard in trial court and the other in the High Court following an appeal, and she was convicted.

'The trial court in one case handed a jail sentence of five years, which was later increased to 10 years by the High Court following an appeal. In the other case, she was sentenced to seven year's imprisonment by the judicial court."

RMP finds kidnappers' torture cell

Detectives in Rajshahi have busted a torture cell, used by kidnappers, in the city's Hetomkhan area and arrested four suspects.

Basak, additional Bijov commissioner of Rajshahi Metropolitan Police, said police came to know about the torture cell while investigating a kidnapping case.

Police arrested four members of a kidnapping gang during a special operation on Friday, and recovered locally-made weapons, the official said during a press conference at the RMP's Detective Branch office vesterday.

The four -- Arefin Ahad Khan alias Sunny, 42, Mostaq Ahmed alias Fahim, 22, Md Parvez, 27, and Sabbir Sarkar, 25 were picked up from different areas of Rajshahi city.

Two cases were filed with Boalia Police Station in connection with the incident

Yesterday, a local court sent the arrestees to jail after they were produced before it.

According to police, the arrestees kidnapped a hawker, Delwar Hossain Mondol, from Rajarhata area on the

Russia sanctions busters to 'face severe costs'

Warns G7; no G20 joint statement after China objections on Ukraine war

AGENCIES

G7 leaders issued a stern warning to any country abetting Russia's war in Ukraine, as G20 finance ministers, facing objections from China, again failed yesterday to agree on a joint statement on the global economy.

The G7 leaders, who were joined by Ukrainian President Volodymyr Zelensky, issued the warning in a virtual call marking the first anniversary of Russia's invasion, while members added a raft of new sanctions on Moscow and its supporters.

We call on third countries or other international actors who seek to evade or undermine our measures to cease providing material support to Russia's war, or face severe costs," the Group of Seven leaders said in a joint statement.

The statement came as both Moscow and Kyiv seek to restock their forces for intensified fighting in what analysts expect will involve offensives by both sides along the long front lines in Ukraine.

In New Delhi, current G20 president India issued a "chair's summary" which

the war in Ukraine" and that there were "different assessments of the situation and sanctions" at the two-day meeting in Bengaluru.

A footnote said two paragraphs in the summary about the war, which it said were adapted from the G20 Bali Leaders' Declaration in November, "were agreed to by all member countries except Russia and China".

Spain's representative Nadia Calvino had said earlier that because of "less constructive" approaches by some unspecified countries at the talks among the world's top 20 economies, agreeing on a statement was "difficult".

China wanted to change the language of the statement from November. officials told AFP, with one saying on condition of anonymity that Beijing wanted to remove the word "war".

Previous meetings of G20 finance ministers and central bank chiefs have also failed to produce a common communique since Russia, a member of the grouping, invaded its neighbour last February.

China has sought to position itself Indonesia in November.

said "most members strongly condemned as a neutral party in the conflict while maintaining close ties with strategic ally Russia

Top Chinese diplomat Wang Yi was in Moscow on Wednesday to meet President Vladimir Putin and Foreign Minister Sergei Lavrov, who is due at a G20 foreign ministers meeting in New Delhi next week.

Chinese state news agency Xinhua quoted Wang as saying China was willing to "deepen political trust" and "strengthen strategic coordination" with Russia.

On Friday, the first anniversary of the invasion, China published a 12-point paper calling for a "political settlement" to the crisis that was met with scepticism from Ukraine's allies.

G20 host India has also refused to condemn Russia, which is New Delhi's biggest arms supplier and has become a major source of oil for India since the invasion.

Western countries -- including the United States, Germany and France had insisted the language in any joint statement could not be weaker than the communique issued by G20 leaders in

Condemned convict dies at DMCH

UNB, Dhaka

A convict in the BDR mutiny case died at Dhaka Medical College Hospital early yesterday.

Deceased Abdul Baten, 70, was given the death penalty.

Inspector Bachhu Mia, in-charge of Dhaka Medical College Hospital police camp, said Baten fell sick around 1:30am in Dhaka Central Jail and was taken to the hospital, where the doctors declared him dead.

Seventy-four people, including 57 army officials, were killed in the mutiny in the capital's Pilkhana headquarters of the erstwhile Bangladesh Rifles (BDR) on February 25 and 26 in 2009.

A total of 58 cases, including one for murder and looting and the rest for mutiny, were filed in connection with the incident.

Some 152 people were sentenced to death and 423 others to different jail terms in the case. Besides, 277 accused were acquitted.

Siblings killed in Sirajganj road crash

A woman and her brother were killed and two others injured when a truck hit a CNG-run autorickshaw in Sirajganj Sadar yesterday.

The dead were identified as Lipi Khatun, 28, and her brother Mukul Hossain, 25, who passengers of the CNG-run auto-rickshaw.

Md Humayun Kabir, officer-in-charge of Sirajganj Sadar Police Station, said the accident took place around 1:00pm when a Sirajganj-bound speeding truck hit the three-wheeler in Kurulia area near Simanto Bazar.

Lipi died on the spot while Mukul died on the way to Sirajganj General Hospital.

The two others injured, including the CNG driver, were admitted to the hospital for treatment.

Police rescued the victims and seized the truck. The driver of the truck, however, had fled after the accident, the OC said.

Magnitude 5.5 earthquake strikes central Turkey DEUTSCHE WELLE

A magnitude 5.5 earthquake struck Central Turkey yesterday, the European-Mediterranean Seismological Center (EMSC) said.

The quake was at a depth of 10 kilometers (6.21 miles), EMSC said, while the local AFAD disaster agency said it occurred at 1.27 pm local time (1027 GMT).

The Kandilli earthquake monitoring center said the epicenter was located in the district of Bor, in the province of Nigde.

Nidge is some 350 kilometers (217 miles) west of the Turkish-Syrian border region that was struck by two major quakes on February 6.

Mayor Emrah Ozdemir told state broadcaster TRT that no damage was reported yet.

Teams are on site to assess the aftermath, Turkish Vice President Fuat Oktay wrote on Twitter.

Prior to this, at least seven tremors over magnitude 4 had been recorded since Friday evening in Turkey, including the quake-hit south, according to AFAD.

came to formation of the [current] government, we were left out," he said.

Five candidates of Workers Party of Bangladesh, a key ally of the 14-party alliance, took part in the last national elections in 2018 under the banner of the grand alliance with Awami League's electoral symbol "boat".

We stood together with the Awami League during BNP-Jamaat's antigovernment movement, during the war crimes trials, and the movement by Hefazat-e Islam in 2013.

"Again in 2014, we resisted the arson attacks by BNP-Jamaat coalition.

Menon said his party had then initially refused to join the cabinet but later changed its mind.

"And again, we took part in the national polls taking responsibility of joining a poorly participated election [2018]." he said.

As another national election is approaching, the ruling Awami League is saying that it would join the polls under the banner of 14-party alliance, he said.

'Recently, Prime Minister Sheikh Hasina addressed a rally in Rajshahi and sought vote for boat, the symbol of the Awami League. Where is hammer? Is the Awami League seeking vote for hammer?" Menon said.

"Is this the 14-party coalition that we forged on the basis of national consensus in the light of the 14-party's 23-point charter?

"We won elections with our own symbol, but when we participate elections with boat, the Awami League voters choose to vote for either BNP or Jatiya Party," he continued.

"This can't be an ideal coalition politics," he said.

Menon said Workers Party general secretary Fazle Hossain Badsha, who is the MP of Rajshahi Sadar, would certainly take part in the next elections with his party symbol "hammer".

Liakat Ali Liku, president of Rajshahi district unit of the party, chaired the rally.

doubled in 2021-2022 fiscal year, compared to the year before.

Since a majority of the private or independent power producers (IPPs) rely on liquid fuel, the price of electricity sold by them rose by 77.43 percent.

Even after spending so much money, the plants sat idle in summer last year due to shortage of fuel, leading to the worst power outages the country had seen in years.

Besides, even if the government cannot supply enough dollars to the banks to meet the demands of the IPPs, it is legally obligated to continue paving capacity charges.

Between 2019 and 2021 capacity

for as much as 45 percent of the total cost of the electricity purchased from them, according to an analysis by this newspaper.

The government currently owes more than Tk 14,000 crore, or about \$ 1.4 billion, in unsettled bills to IPPs, according to PDB sources.

This year, Orion Power with its four HFO-run power plants would require over \$197 million for fuel.

Last year, a plant of Orion Power's Dutch Bangla Power and Associates Ltd in Siddhirganj had a plant load factor (PLF) of just 19 percent.

PLF is the ratio between the actual energy generated by the plant to the maximum possible energy that can be generated with the plant working at payments made to IPPs accounted its rated power and for an entire year.

Summit Power, which has the second largest demand this year, is looking for HFO worth \$ 160 million for its four power plants. Last year, Summit Barisal Power Ltd had a PLF of 6.5 percent and Summit Narayanganj Power Unit 1 Ltd had 19 percent.

Powerpac Jamalpur Power Plant Ltd which is seeking \$ 37 million had had only a 2 percent PLF last year.

Khulna Power Company Ltd is requesting \$ 40 million, and its PLF was 11 percent last year.

"We fear that without this kind support from Bangladesh Bank the country will inevitably face widespread load-shedding during this critical irrigation season, Ramadan and summer," said the letter.

Alam said he was not aware that Phulpori was staying at the dormitory.

Asked whether a fresher needs to have BCL's permission for staying at the hall or getting a seat, he said, "Chhatra League has nothing to do with this. Rather, the hall administration allocates seats."

He said it is usual that first-year honours students would get seats at the end of their academic year or the second-year students would be allocated seats.

Established in Kushtia in 1980, Islamic University has now 15,893 students, including 5,172 females. There are eight dormitories, including three for females.

Although the eight halls have a total of 3,282 seats, 4,876 students are now staving in them.

University authorities and residential students said about 800 students now live in Deshratna Sheikh Hasina Hall against its capacity of about 450. At least 40 students are living in the prayer room of the dormitory. There are nine "gono rooms" in the hall.

A "gono room" student from Lalon Shah Hall said 17 students stay at his room. They usually cannot read properly in the overcrowded room.

These gono rooms are controlled by Chhatra League activists. We haven't seen any student getting a seat without the permission of Chhatra League,' said Emanul Shohan, president of the

IU unit of Bangladesh Chhatra Union. Ashiqur Rahman, Bangladesh Chhatra Maitri IU unit president, said as many students do not get seats in halls, they stay in different places of Kushtia and Jhenidah, about an hour's journey from the university. He said expenses of guardians also increases as students need to rent homes.

Asked about the allegations, Chhatra League IU unit President Faisal Siddike Arafat refuted all of them. He claimed that they never control any 'gono room" or halls.

"There is an acute accommodation crisis at the university. If any students from outside Kushtia contact us, we try to help them.'

He said they never force anyone to join their political programmes.

Vice Chancellor Prof Shaikh Abdus Salam said it is really tough for freshers to get a seat in halls.

'As far as I know, second-year students are allocated seats at dormitories."

He said constructions of four new halls were underway. Once those are opened, the accommodation crisis would ease as each of them will accommodate 1,000 students, the VC added.

Asked about the allegation of Chhatra League controlling the "gono rooms" and compelling students to join political programmes, Salam said, can't give you the answer. The hall

administrations have to work with many people. Our main concern is that there should be no indiscipline."

accessing them.

"I have eight children. We are living in a tent. There is water on top (of the tent) and the ground is damp. We are asking for more tents and they don't give them to us," Melek, 67, who was waiting in a line to collect aid outside a high school in the town of Hassa.

The school was being used as an aid distribution center by a group of volunteers called Interrail Turkey. One volunteer, Sumeyye Karabocek, said the shortage of tents remained the biggest problem.

In Netrakona, 23 BNP men were injured as the ruling party men swooped on them when they were gathering for the road march.

Motorcycles and microbuses were vandalised and set ablaze during the clash.

Police fired two bullets to bring the situation under control and detained five BNP activists.

BNP Secretary General Mirza Fakhrul Islam Alamgir yesterday said the BDR mutiny was part of a long-term conspiracy that aimed to destroy the morale of the country's army.

On the same day, Jatiya Party Chairperson GM Quader said the trial and investigation process of Pilkhana carnage was not transparent; most families of the martyrs believe this as well.

The BNP and JP leaders made the remarks at the capital's Banani army graveyard, after placing floral wreaths at the grave of army officers who died during the BDR carnage

The nation yesterday mourned the death of 74 people, including 57 army officers, in the incident that occurred on February 25-26 in 2009.

Talking to the media, Fakhrul said the BDR mutiny was a serious conspiracy that was against the country. Claiming that around 7,000 jawans of then BDR (now

Border Guard Bangladesh) are innocent, Fakhrul said, hearing of their cases is yet to be completed.

"They have been spending their lives in inhumane prison conditions for 13 to 14 years. Their families and

CLIMATE CHANGE Youngsters unite for solution-based adaptation

Youths coming from different parts of the country were at the centre of a day-long expo yesterday that aimed to promote sustainable products and services as well as encourage innovations for climate-change adaptation.

They came up with various environmentfriendly products and shared their views in interactive sessions on how people can work both in rural and urban areas to bring changes in others' lives to mitigate climate change impacts.

The Earth Society with support from Climate Parliament Bangladesh, United Nations Development Programme (UNDP), Movers, and RR-Imperial Electricals Limited organised the "Climate Expo-2023" at Gulshan Society Lake Park in the capital.

Mikal Hossain Khan, founder of Projjolito Narail, said his organisation has been campaigning in remote areas of Narail district to inspire local farmers to use more organic fertilisers to grov their crops. "These farmers are little aware about health hazard and risk to the environment that mineral fertiliser may pose," he said.

inaugurated the country's first-ever metro rail line, which was opened to the public on the following day.

However, the authorities had to suspend operations for two hours "on safety grounds" on January 1 as a huge number of extinguished sky lanterns fell on the overhead electricity lines after the new year celebrations.

On February 20, DMTCL issued a circular urging people to avoid flying kites or sky lanterns within at least a onekilometre radius of the metro rail line, after the operation of metro rail was halted for two consecutive days.

The authority said metro rail is operating between Uttara and Agargaon using high-powered electric lines and kites, sky lanterns or gas balloons can result in severe accidents or suffering of the passengers due to the delay.

Yesterday, the authorities had to suspend the metro rail's operation for around 22 minutes after a kite got stuck in the overhead electric line.

Contacted, MAN Siddique, managing director of DMTCL, said they have been requesting people using loudspeakers not to fly kites or sky lanterns near metro tracks but to no avail.

"We are planning to carry out mobile court drives if the situation does not improve. However, the number of such incidents is decreasing," he added.



The **BNP-backed** lawyers' group Blue Panel on Thursday boycotted voting in the polls bringing allegations of irregularities rigging and against Abdullah Abu.

Abdullah However, Abu said pro-BNP lawyers' allegations were totally false, fabricated and vague.

The two-day election for the new committee at DBA was held on Wednesday and Thursday where a total of 9,243 out of 19,618 lawyers cast their votes.

A total of 46 candidates from the two panels contested in the polls against 23 posts.

Mosquitoes invade Khulna

Authorities failing to control the menace, claim dwellers

After winter ended, mosquitoes took control of Khulna, making life difficult for many city dwellers. Locals claim that the situation has been going on for a long time, with the authorities continuing to turn a blind eye.

The two youths who were picked up from Jail Gate area in Lalmonirhat, after being acquitted of a militancy case, returned home yesterday.

A group of masked people took them from the spot on February 21. Families of the youths later claimed that a law enforcement agency took them to Dhaka for interrogation.

The law enforcers handed over the two youths Mehedi alias Mehedi Hasan, 27, from Hatibandha upazila, and Jamal Uddin, 32, from Kaligani upazila -- to their families in Dhaka at 11:30pm on Friday, family members told The Daily Star yesterday.

Jamal is doing his master's at a college in Dhaka, and Mehedi is studying at Fazil level at a madrasa in Lalmonirhat.

Mehedi's father Abdul Latif told this newspaper that the law enforcers took them to Dhaka for questioning.

The youths were taken to their village homes yesterday, said families.

According to court sources, a case was lodged against six youths for allegedly being involved in banned militant organisation JMB in 2017.

In this case, four youths -- including Jamal and Mehedi -- were acquitted. Two other youths were jailed for 42 years.

Lalmonirhat Sessions Judge and Special Tribunal-1 Judge Md Mizanur Rahman delivered the verdict on February 19.

Lalmonirhat Sadar Police Station Officer-in-Charge Ershadul Alam told The Daily Star that he heard that two youths missing from Jail Gate were rescued in Dhaka.

He said they returned home, but he has no information about how they went missing and how they were rescued.

Youth hacked to death in Tangail

Locals set house of suspected killers on fire

A youth was stabbed to death in Delduar upazila of Tangail yesterday morning.

Locals torched the house of the suspected killers after police recovered the body of Mohammad Raihan, 20, a resident of Nalua village in the upazila. The body, which was found beside a house near Pathrail-Gadtala road, bore injuries marks, said police.

The victim's family said Raihan was missing since Friday night. Later, his body was found beside the house of Marjina Begum, an alleged drug trader. Police said they had arrested Marjina

a week ago on charge of trading drugs. A local court sent her to jail. Police detained two sons of Marjina, who are also drug traders, in connection with the murder, said Officer-in-Charge of Delduar Police Station Nazrul Islam Mridha.

Following their detention, a mob vandalised their house and set it on fire, the OC added .Raihan's body was sent to Tangail General Hospital for autopsy.

"After preliminary investigation, police suspect that the youth was murdered centring a dispute over trading drugs. However, it will be ascertained after an investigation," the OC said.

When asked if he had the right to judge a rape case, the chairman said, 'I asked the woman in public whether Kaiser raped her. She admitted in front of everyone that she was not raped.'

Female member Josna Akhtar told The Daily Star she took Kaiser into her custody and requested the chairman to settle the matter.

When asked why she took Kaiser into her custody instead of handing him over to the police, Josna said, "I took Kaiser into my custody as the woman said she was not raped." Josna said she saw injury marks on the woman's face.

Meanwhile, the woman told The Daily Star that Kaiser indeed raped

Blinken to meet Asia 'Quad'

AFP, Washington

US Secretary of State Blinken will Antony meet next week with his counterparts from India, Japan and Australia, on the heels of a flare-up in tensions with China.

Blinken will hold the talks with the so-called Quad on March 3 on the sidelines of a Group of 20 meeting in New Delhi, said Donald Lu, the top State Department official on South Asia.

The four will hold an hour-long public discussion as part of the Raisina Dialogue, a major Indian conference on geopolitics, he said.

The latest meeting comes weeks after Blinken scrapped a trip to Beijing after an alleged Chinese spy balloon flew over the US. He later held a meeting with China's foreign policy chief Wang Yi at the Munich Security Conference.

WHAT'S IN CHINA'S UKRAINE PLAN

China has released its position plants must be kept safe and the paper on the Russia-Ukraine war, in which it calls for a ceasefire and talks between the two parties. Conflict and war "benefit no one", China said on Friday in the 12-point paper.

WHAT IS IN THE PLAN?

Released by the foreign ministry, the plan urges an end to Western sanctions against Russia, the establishment of humanitarian corridors for the evacuation of civilians and steps to ensure the export of grain after disruptions caused global food prices to spike last year. The proposal mainly elaborates on long-held Chinese positions, including that all countries' "sovereignty, independence and territorial integrity be effectively guaranteed". It said nuclear power

threat or use of nuclear weapons should be opposed. The plan also called for an end to the "Cold War mentality".

HOW HAS UKRAINE REACTED?

Ukrainian President Volodymyr Zelenskyy said Kyiv needed to cooperate with China to put an end to the war. "It seems to me that there is respect for our territorial integrity, security issues."

HOW THE WEST REACTED?

Western diplomats and experts reacted with scepticism and disappointment, noting that China is not neutral and has not condemned Russia's invasion. Nato Secretary General Jens Stoltenberg said Beijing was not well-placed to negotiate an end to the war.

Nepal ruling coalition in fresh turmoil

Deputy PM and 3 other ministers quit

Nepal's ruling coalition was in turmoil yesterday after the prime minister said he planned to support a presidential candidate from an opposition party, a decision that prompted the deputy prime minister and three other ministers to resign.

Political analysts said the moves did not suggest the fledgling government of Prime Minister Pushpa Kamal Dahal, a former Maoist rebel who goes by his nom de guerre Prachanda, was in immediate trouble as it still enjoys majority support in parliament. But they said the turmoil could lead a new coalition being formed.

Prachanda said on Friday he would support

Ram Chandra Paudel from the opposition Nepali Congress party in next month's presidential election, instead of the candidate of his coalition partner, the Communist Unified Marxist Leninist (UML) party.

Yesterday, Rajendra Lingden, the deputy prime minister who was also minister for energy, water resources and irrigation, resigned in protest, along with the ministers for urban development and legal matters, while a junior minister assisting Lingden also quit.

Prachanda's office confirmed the four ministers had resigned but did not say whether the resignations had been accepted.

Nepal is set to elect its third president on March 9, a ceremonial position which assumed a key role during past political crises.

Macron to visit China

French President Emmanuel Macron said yesterday he will visit China in early April, in part to seek Chinese help with ending Russia's invasion of Ukraine. "The fact that China engages in peace efforts is a good thing," Macron told reporters at an agricultural fair in Paris. "China must help us put pressure on Russia so that it never uses chemical or nuclear weapons, (an effort) which China has already made, and that it stops its aggression as a precondition for talks," he added.

Brazil storm death toll rises to 57

The death toll from heavy rains that devastated coastal areas of Brazil's southeastern Sao Paulo state have reached 57 people, official figures showed. Massive downpours have caused landslides and flooding in coastal towns of Brazil's richest state since last weekend. The city of Sao Sebastiao bore the brunt of the human toll, with 56 of the reported deaths. The Sao Paulo state government said in a statement on Friday that more rains were expected while search and rescue efforts continued with dozens still missing. More than 4,000 people were forced from their homes, it added.

'Tehran still seeking to kill Trump'

An Iranian general warned his country is still seeking to kill former US president Donald Trump and his secretary of state Mike Pompeo in revenge for assassinating top commander Qasem Soleimani. Tehran has repeatedly vowed to avenge

US drone strike on Baghdad airport in January 2020. "We hope we can kill Trump, Pompeo, (former US general Kenneth) McKenzie and the military commanders who gave the order" to kill Soleimani, General Amirali Hajizadeh, the Guards' aerospace unit commander, said on television late Friday.

Philippine President Ferdinand Marcos Jr called for reconciliation and unity yesterday as the Southeast

Asian nation marked the 37th anniversary of the "people power" revolution that toppled his dictator father.

Marcos, who was 28 years old when a helicopter whisked his family from the presidential palace in 1986, said he was one with the nation "in remembering those times of tribulation and how we came out media post. of them united and stronger as a nation.'

Marcos (65) clinched a landslide

victory in last year's presidential election on a simple message of unity. Despite its fall from grace, his family returned from exile in the 1990s and has remained a powerful force in local

politics.

"I once again offer my hand of reconciliation to those with different political persuasions to together come as one in forging a better society one that will pursue

progress and peace and a better life for all Filipinos," he said in a social

Marcos sent a wreath of flowers to the People Power Monument along a major highway in the capital Manila,

where millions of protesters had gathered demanding the ouster of his father amid allegations of plunder and human rights violations. The elder Marcos died in 1989.

The family has denied siphoning off billions of dollars of state wealth during the dictatorship, and has waged a decades-long campaign to resurrect its reputation.

The younger Marcos's "presidency is an insult to the sacrifices of those who fought for freedom and democracy", human rights advocacy group Karapatan said in a statement.

The family of late former President Corazon Aquino, who assumed power after the elder Marcos's ouster, issued a statement saving the spirit of the 1986 uprising "guards and protects our democracy, confronting those who attempt to deceive us and undermine our rights and liberties".

Why must **Bangladeshis bear** huge medical costs?

Govt must invest much more and wisely in healthcare

Although we have been well aware that Bangladeshis, especially those in lower income brackets, have to bear an enormous financial burden when they seek healthcare services, to know that we are well behind our South Asian neighbours is a jarring wake-up call. A recent study by the World Bank found that out-of-pocket-spending (OOPS) accounted for 73.9 percent of health expenditure in Bangladesh. Meanwhile Nepal's was 58 percent, India's 55 percent, Pakistan's 54 percent, Sri Lanka's 46 percent, and Bhutan had the lowest OOPS at 18 percent.

What this tells us is that Bangladesh has done precious little in terms of investing in primary healthcare, which is a fundamental element for a country's social development. The media has extensively reported on how overburdened and understaffed our public hospitals are, as well as on the pathetic state of the upazila health complexes that are supposed to provide citizens with primary healthcare. In remote areas such as the chars, the situation is even more frightening, with no emergency care for miles leading to avoidable deaths, especially of expectant mothers. As government hospitals are often inaccessible due to being overburdened, people seek healthcare in private clinics and hospitals and have to pay exorbitant bills, often by selling assets such as jewellery or land or by borrowing money. In fact, from 2000 to 2017, the OOPS more than quadrupled, says the WB study. The report further found that the eighth five-year plan concludes that "rising out of-pocket-spending undermines poverty reduction efforts."

We agree with the WB that the government must make major health financing reforms and significantly increase public financing for the health sector. It is disappointing that, while the government has embarked on huge, costly, infrastructural projects when it comes to developing the health sector, the efforts have been grossly inadequate.

Bangladesh should adopt the examples of other countries that have successful national healthcare systems and incorporate these models in our own health sector. As suggested, Indonesia is a good example where primary healthcare is part of a new national insurance system which makes basic medical care and facilities available to all citizens. But even within Bangladesh, there have been successful private models that can easily be replicated in a national health plan. Health facility budgets at upazila health complex facilities and union health and family welfare centres must be ensured and increased according to the needs of the local population. As recommended by the study, the government can also explore a capitation payment model in primary healthcare where a fixed remuneration is given in advance to the provider for each patient and per unit of time, regardless of the extent or amount of healthcare services the patient avails.

Access to healthcare is a basic right of all citizens. It is unacceptable that people either suffer in silence when they are sick or are forced to sell their limited assets or borrow money to pay hospital bills. By investing in a functional, efficient, and corruption-free healthcare system, the government will gain unprecedented boosts to its developmental goals - which we desperately need.

Our chronicle of shoddy gas exploration

In the 1960s, the discoveries of five large gas fields, by international oil company Shell, placed Bangladesh in the list of gas-rich provinces. However, this was not followed by similar exploration successes in later years. Exploration remained behind for decades to follow. Chronically poor exploration in a prospective gas-rich country means the gas supply remains below demand and the industrial and economic growth are consequently held back. And, in the 22 years after 2000, Bangladesh drilled 26 exploratory wells - a mere one well per year on average. The above record has given way to one of the least explored hydrocarbon basins in the world.

increasing Realising that dependence on imported LNG renders gas supply vulnerable to unpredictable economic shocks, the government has lately decided to ramp up exploration and development of its own gas in the country. This move, late but better than never, is welcome because of the fact that geoscientists have long been suggesting that significant gas resources still remain underground in the country, and the present gas demands may well be met through extracting our own gas. Experts opine that Bangladesh could stay put on the import of LNG for several years until its own gas resources are exhausted.

In August 2022, Petrobangla, the government agency for oil and gas exploration, production, and transmission, announced a programme for drilling 46 wells in three years (from 2022 to 2025). These include 17 exploratory wells, 12 development wells, and 17 workover wells. When drilled, these wells could reportedly produce 618 million cubic feet of gas per day (mmcf/d) by 2025. This is equivalent to the amount of gas imported in the form of LNG at present.

To put it simply: a) an exploration well, if successful, adds new gas fields and reserves to the country; b) a development well refers to a well drilled in an already known gas field to enhance the gas production of that field; and c) the workover well refers to a discovered but abandoned well that stopped production previously but will now be "worked over" to extract outsource the drilling job. after its announcement, Petrobangla rescheduled the programme of drilling the 46 wells by reducing its timeframe by one year – meaning the 46 wells will now be drilled over two years instead of three years. So, five of the exploratory wells will be drilled in 2023 and 12 will be drilled in 2024. Given that Bangladesh currently drills about one well per year, aiming to drill 12 exploratory wells in a year is certainly ambitious. One may well wonder what's so wrong with being ambitious.

It was some time ago that Petrobangla had announced another programme of drilling 108 wells in the five years between 2016 and 2021. Among these, 55 wells were supposed to be exploratory (meaning 11 exploratory wells per year). But this programme, which received a lot of media attention, has failed to be implemented and was scrapped.

Bapex, the exploration wing of Petrobangla, has the capacity of drilling three wells per year under its present logistical and technical manpower support. So, to drill 12 exploration wells

and managerial conflict with Bapex and the situation turned so bad that Socar left the country without drilling the well and both parties ended up at international court against each other. The case is still pending and the Begumganj well cannot be drilled by Bapex until the case is resolved. A similar lawsuit is active at the International Centre for Settlement of Investment Disputes (ICSID) between Bapex and Canadian company Niko with respect to drilling in Chattak gas field. Niko carelessly blew up the well and Bangladesh took the company to court for compensation. This case has been running for 17 long years, with Bapex not being able to produce gas from the Chattak field until the case is settled. This is despite the fact that Bangladesh is guite starved for gas and has had to resort to buying from the very expensive LNG market.

Another criticism of outsourcing well-drilling is that foreign companies are often given undue privilege by Bangladesh. Gazprom, for example, is engaged in drilling several of Bapex's wells at a cost more than double what revised model PSC has been formulated it would have cost for Bapex to drill the wells.

drilling 46 wells to complete in only two years is not considered wise or practical by technical people in Bapex. Such decisions are presumed to be imposed on Bapex by people from higher up in the administration who do not have a good idea of the practicality of these decisions at the ground level. There are risks of failure when hastily drilling large numbers



of wells in too short a period of time. Besides, an extra year is insignificant when the country has been suffering from gas shortages for so many years.

Now that Petrobangla plans to ramp up onshore gas exploration, there is an urgent need to launch offshore gas exploration programmes in earnest as well. In 2014, the country was awarded territorial and economic rights over a vast offshore area in the Bay of Bengal following the settlement of maritime boundary disputes between Bangladesh, India, and Myanmar. While we really enjoyed marvelling over the idea of a blue economy, we did little to unravel its potential. Years of delay in opening up the offshore for international oil companies (IOC) put Bangladesh way behind its neighbours Myanmar and India, who have experienced successful gas exploration.

Petrobangla had planned to launch the Bangladesh offshore block bidding by December 2022. But the slow pace of administrative steps has apparently delayed this from happening still Å to better attract IOCs. It is high time that this is launched immediately to Rescheduling the programme of begin offshore exploration in earnest.

Ruling party affiliation should not place anyone above the law

That a section of Awami League (AL) leaders and its associate bodies, whose names came up in the illegal casino business scandal, are out on bail and reportedly have become active in politics again is a perfect example of how lack of accountability has become the norm within the ruling party. Despite drumming up a tremendous amount of hype about its "anti-corruption" drive - which led to the so-called crackdown on gambling, extortion, land grabbing, and other forms of corruption with raids at five sporting clubs – the government ultimately seems to have done all these as an eye-wash.

After a series of raids in 2019, more than 250 people, including at least 11 leaders of different organisations affiliated with the ruling AL, were arrested. Most of the top leaders who were allegedly involved with such crimes, however, are now out of jail. And although they are yet to be restored to their previous political posts, they are still carrying out political activities and lobbying top AL leaders to regain their level of influence. Some of these individuals who had amassed huge amounts of questionable wealth, as discovered by law enforcers, are having their loyalists appointed as top leaders of the ruling party. Essentially, they have indirectly reclaimed their influence within the ruling party.

What messages are these incidents supposed to send to the people of this country? That no crime is punishable as long as one is affiliated with the ruling party, as that supposedly places one above the law? Every day now, we see news reports of the Bangladesh Chhatra League (BCL) beating people up and being involved in various types of atrocities, as well as criminal activities. Is it any wonder how BCL members are regularly committing such crimes? When the message they receive is that those involved in criminal activities from within the party can get back to politics one way or another and not be punished in any way shape or form, why wouldn't that embolden criminal elements from within the BCL to run amok?

The ruling party's willingness to allow BCL members who commit atrocities against the general public to get away scotfree will no doubt create significant amounts of resentment among the populace. Additionally, not holding to account the AL leaders who were directly involved with - and in some cases, masterminded – gambling, extortion, land grabbing, etc will also alienate the public and set a terrible precedence in terms of upholding the law of the land.

Before the general election, the any party should look to win the hearts and minds of the people. And for AL, one of the best ways of doing that would be to cleanse its ranks of all criminal elements. There must be accountability for ruling party affiliates who commit crimes.

The Republican Party has long wrapped itself in the American flag, claiming to be the defender of "freedom." The GOP believes individuals should be free to carry firearms, spew hate speech, and eschew vaccines and face masks. The same goes for corporations: Even if their activities destroy the planet and permanently change the climate, the "free market" should be trusted to sort things out. Banks and other financial institutions should be "liberated" from regulation, even if their activities can bring down the entire economy.

Following the 2008 financial crisis, the pandemic, and the acceleration of the climate crisis, it should be obvious that this conception of freedom is far too crude and simplistic for the modern world. As the great twentiethcentury philosopher Isaiah Berlin put it: "Freedom for the wolves has often meant death to the sheep." Or, put another way, freedom for some is unfreedom for others.

In the United States, the freedom to carry guns has come at the expense of the freedom to go to school or the store without being shot. Thousands of innocent people - many of them children have died so that this particular freedom can live. And millions have lost what Franklin Delano Roosevelt thought was so

important, the freedom from fear.

There is no such thing as absolute freedom within a society. Different freedoms must be balanced against each other, and any reasoned discussion among typical Americans would inevitably conclude that the right to an AR-15 is not more "sacred" than others' right to live.

In complex modern societies, there are innumerable ways that one's actions can harm others without one having to bear any consequences for it. Social-media platforms constantly pollute our "information ecosystem" with disinformation and content that is well-known to cause harm. While the platforms present themselves as neutral conduits of information that is already out there, their algorithms are actively promoting a socially harmful substance. But, far from paying any costs, the platforms are reaping billions of dollars in profits every year.

The US tech giants are shielded from liability by a 1990s-era law that was originally designed to foster innovation in the inchoate digital economy. The US Supreme Court is now considering a case involving this legislation, and other countries around the world are also questioning whether online platforms should be able to avoid accountability

for their actions.

For economists, a natural measure of freedom concerns the range of things one can do. The greater one's "opportunity set," the freer one is to act. Someone on the verge of starvation doing what they must just to survive effectively has no freedom. Viewed this way, an important dimension of freedom is the ability to realise one's potential. A society in which large segments of the population lack such opportunities - as is the case in societies with high levels of poverty and inequality - is not really free.

Investments in public goods (such as education, infrastructure, and basic research) can expand the opportunity set for all individuals, effectively enhancing the freedom of all. But such investments require taxes, and many individuals - especially in a society that valorises greed - would rather free ride, by avoiding paying their fair share.

This is a classic collective-action problem. Only through coercion, forcing everyone to pay their taxes, can we generate the revenue needed to invest in public goods. Fortunately, allindividuals, including those who have been forced against their will to contribute to society's investments, may be better off as a result. They will live in a society where they, their children, and everyone else has a larger opportunity set. In such circumstances, coercion is a source of liberation.

Neoliberal economists have long ignored these points and focused instead on "freeing" the economy of what they view as pesky regulations and taxes on corporations (many of which have benefitted massively from public expenditures). But where would

American business be without an educated labour force, the rule of law to enforce contracts, or the roads and ports needed to transport goods?

In their new book, The Big Myth, Naomi Oreskes and Erik M Conway show how business interests managed to sell the American public on the staunchly anti-government, "free market" vision of capitalism that emerged in the decades after World War II. The rhetoric of "freedom" was key. The captains of industry and their academic servants systematically re-characterised our complex economy - a rich matrix of private, public, cooperative, voluntary, and not-for-profit enterprises - as simply a "free enterprise" economy.

In books like Milton Friedman's Capitalism and Freedom and Friedrich Hayek's The Road to Serfdom, capitalism was crudely equated with freedom. Central to this vision of capitalism is the freedom to exploit: Monopolies should have unfettered power to trample potential entrants and squeeze their workers, and firms should be free to collude to exploit their customers. Whatever we call it, it is not an economy that we should want; it is not one that promotes broadly shared prosperity; and the greedy, materialistic individuals that it rewards are not who we should want to be.

Yes, we desperately need free markets, but that means, above all, markets that are free from the stranglehold of monopoly and monopsony, and from the undue power that big businesses have amassed through ideological myth-making.



Making room for Bangla in our public schools

Though language helps us get to the root of finding meaning in our existence, we have long neglected learning Bangla properly in Bangladesh's education system. The rapid decline in the quality of education in the country after liberation led to a rise in people moving towards a separate system of private education with English as the medium of instruction. Later, even the government joined the bandwagon by launching an English version of the national curriculum. But research has shown that the use of a language different from one's mother tongue at the primary level acts as a barrier for a child's cognitive development and their enjoyment of learning. Unesco has found the use of one's mother tongue as being crucial for avoiding knowledge gaps and for increasing the speed of learning and comprehension in children.

Education which does not accommodate one's mother tongue in the early years can be unproductive, ineffective, and

thus do not have good command over Bangla, often lacking reading and pronunciation skills. As such, they also struggle to properly comprehend the study materials of different subjects from Class 6 onwards. The situation is made worse by the widespread habit of not reading books outside the school's curriculum. Besides, many underprivileged high schools, particularly in rural areas, lack any library facilities. The abysmal condition of Bangla writing on social media platforms exemplifies the enormity of this problem perfectly.

Increasingly, there has been less and less literature of high quality in the Bangla curriculum. The new curriculum for Bangla in Classes 6 and 7 did put emphasis on learning Bangla through a functional approach, but it lacks strength in terms of its Bangla literature training on the right pedagogy

Students should be taught Bangla from Class 1 to Class 5, with emphasis on all aspects of the language vocabulary, pronunciation, spelling, speaking, listening, reading, and writing. The textbooks should be designed using materials that young learners can absorb with enjoyment and enthusiasm.

Bangla learning in Classes 6 to 10 should involve teaching essays, stories, and poems of increasing difficulty. The content in the curriculum should include Bangla translations of pieces of literature from other languages as well. This will help open up the imagination of students, giving them a glimpse of the world outside.

In order to teach Bangla, teachers must have a good grasp on language teaching. The success of the curriculum demands immediate

syllabus. Literature invokes thought, to suit the new curriculum. An develops creative thinking, and often requires careful reading so that students can properly comprehend the author or poet's meaning.

In addition to the creative and developmental roles of language studies, there is a practical need for every educated person to be wellversed in their own language. Bangla is now the medium of instruction in the public education system at all levels, though English is more required for acquiring advanced degrees in different disciplines. There are not enough materials available in Bangla at those levels.

In order to overcome the shortcomings related to Bangla in our public education system, at least up to Class 10, there are some specific steps that can be taken.

innovative and compact method of training that empowers teachers to conduct classes in an effective manner has to be designed.

While augmenting the teaching of Bangla up to Class 10, the government should undertake a mega-project inviting authors to produce Bangla versions of advanced level books from different disciplines which are in other languages (particularly in English), or write their own books in Bangla.

The changes in the curriculum should play a positive role in developing students' skills in Bangla. However, adequate training for teachers has been missing. The crucial role played by Bangla in the intellectual development of children must therefore be duly recognised.



The wearable ultrasound sensor is roughly the size of a postage stamp, can be worn for up to 24 hours, and works even during strenuous exercise.

Wearable cardiac ultrasound device allows measurements during stress testing

Increasingly, the miniaturisation of electronic technology allows tiny microsensors attached to the skin to take continuous physiological measurements - heart rate, oxygen saturation, and even blood pressure.

Now, researchers describe a thin (8 μ m), stretchable strip of sensors that can be applied to the chest to obtain continuous cardiac ultrasound images - in multiple orientations that are equivalent to those produced by current commercial ultrasound. The device sends data to a computer which generates real-time estimates of stroke volume, cardiac output, ejection fraction, wall-motion abnormalities, and chamber size; these estimates compare favourably to those of current ultrasound devices.

The principal utility of the device is that it can obtain ultrasound images not only before and after, but also during, cardiac exercise stress testing. This concurrent collection avoids false negative results that can occur when pathological changes generated by exercise have returned to normal by the time the postexercise images are obtained.

More experience with this remarkable technology will be required to determine its clinical value during exercise testing, its potential for ambulatory monitoring, and its possible role in evaluating other conditions such as aortic aneurysms or pleural effusions that threaten to expand. It represents another potentially important step in real-time physiological monitoring and another example of the increasingly important marriage of bioengineering and medicine.

DO NOT SCRATCH! What to do when your eczema itches?

Atopic dermatitis (AD) can be a longlasting condition that causes severe, itchy rashes. At times, you may feel like you cannot stop scratching, which can lead to other problems.

With scratching, breaks in the skin can also get infected, causing impetigo, blisters, and swelling. These blisters can ooze fluid or crust over time, causing rough areas and scabs on the skin.

Here is what you can do to help your skin heal and try to prevent infections. When your skin is damaged or broken:

Try not to scratch: Some people scratch so much they bleed, and that is a setup for infection. Instead of scratching with your nails, try to press the area with your fingertips. Keeping your nails short will help. You can also try to cover your inflamed skin. You may be less tempted to scratch if you cannot see it.

Mirror scratching: Try this when the itch is on just one side of your body. It may sound like a magic trick, but it is more than an optical illusion. Say your left arm itches. Look into a mirror and focus on your reflection's left arm, which is actually your right. Scratch there as you watch, and your brain gets the message that your eczema itch was taken care of.

Moisturise your skin: Damages skin has a hard time holding onto water. Applying a thick emollient multiple times a day can protect and soothe cracked skin while sealing in moisture. Greasy ointments like mineral oil and petroleum jelly often work best, but find a product that you like. You may need to try a couple to see which brands help your skin the most.

Oils from the pantry: One study found that sunflower seed oil does more to soften skin than a popular cream -- and it is a lot cheaper. results, keep the wraps in place for



Coconut oil nourishes and helps lessen inflammation. Look for the word "virgin" on the label: That means it was processed without losing its natural healing properties. As good as olive oil is for cooking, though, it is a no-go for your itchy skin.

Soak in an oatmeal bath: Colloidal oatmeal (finely ground oatmeal) has special compounds that can help strengthen your skin barrier. Add the oatmeal to a lukewarm -- not hot bath and soak for 10 to 15 minutes.

When you get out, gently pat your skin dry and apply moisturiser right away.

> Apply wet wraps: During a severe flare, a wet wrap can soothe inflamed skin and help lock in moisture. Dampen a clean gauze or a cotton cloth with warm water, then gently press it onto your skin. Cover it with a layer of dry cloth or gauze. For best

Take allergy meds: When your itching is intense, an over-thecounter antihistamine can give short-term relief.

Topicals: Menthol has a cooling effect that cancels out itch, but higher than a 1%-3% concentration could irritate. Store your topicals in the fridge.

Know when to ask for more help. Call your doctor if your:

• Condition gets in the way of your daily routine or keeps you from sleeping.

• Skin shows signs of an infection (like pus, red streaks, or yellow scabs).

• AD does not improve even after you try different home remedies.

• AD is severe or covers a lot of vour body.



From our immune system to our mood, our gut affects everything. My father used to say that most diseases started in the gut. Scientists call the gut-regulating enteric nervous system (ENS) the 'little brain' or 'second brain.'

Researchers found 'gut brain connection' or 'brain theory'. They explained that a lesser-known nervous system in our guts (second brain) communicates with the brain in our head. Together, 'our two brains' play a key role in certain diseases in our bodies and overall health and wellbeing.

The ENS is our 'gastro-intestine' nervous system. Through an extensive neural circuit this complex network works with the body's central nervous system (CNS) to control our digestive system. Researchers first called the gut a second brain because it communicates via neurons and neurotransmitters. That means basically, our gut sends signals to our brain, and our brain sends signals to our gut. The 'fight or flight' response concept, the brain to send signals to the gut, causing gastrointestinal issues. Likewise, irritation in the gastrointestinal system will send signals to the brain causing mood changes. Serotonin, the 'feel-good hormone,' stabilises our well-being and happiness. So, we might think that it is mainly produced in the brain. But the digestive tract produces about 90 percent of this well-known brain neurotransmitter. While we usually concentrate our focus on diet and exercise to improve our health; we often overlook sleep. It can restore energy levels and heals both physical and cognitive damage. There is a strong connection between diet and sleep. Low-fiber, highsaturated-fat diets may impair sleep.

United Kingdom (UK) soft drink taxes associated with decreased obesity in girls

Study tracking childhood obesity in England from 2014-2020 found 8% reduction in obesity among 10-11 year old girls coinciding with 2018 soft drinks industry levy. The implementation of the

two-tier soft drinks industry levy in the UK in 2018 was associated with an 8% reduction in obesity among 10-11 year old girls, with the greatest reductions seen in those living in the most deprived areas, according to a new study published on 2023 in open accessed PLOS Medicine by Nina Rogers of University of Cambridge School of Clinical Medicine, UK, and colleagues.

There is strong evidence that consumption of sugar sweetened beverages increases the risk of obesity and other serious diseases. In April 2018. the UK soft drinks industry levy (SDIL) went into effect to incentivise soft drinks makers to reduce the sugar content of drinks.

In the new study, researchers followed students in statemaintained English primary schools, aged 4-5 and 10-11 over time between September 2013 and November 2019. The researchers compared the obesity levels 19 months following the SDIL with predicted obesity levels had the SDIL not happened, controlling for each child's sex Childhood obesity rates in and the level of deprivation of

In 10-11 year old girls, there was an absolute reduction in the obesity rate of 1.6 percentage points. The greatest reductions were seen in girls in the most deprived quintiles (any of five equal groups into which a population can be divided according to the distribution of values of a particular variable), with an absolute reduction of 2.4 percentage points in obesity occurrence in the most deprived

quintile. In 10-11 year old boys, there was no overall change in obesity rates, and no obvious pattern of changes in relation to deprivation, though a 1.6% absolute increase in obesity rate was observed in the least deprived quintile (equivalent to a 10.1% relative increase). In vounger children, no overall associations were found between the SDIL and obesity levels.

"Our findings suggest that the UK SDIL led to positive health impacts in the form of reduced obesity levels in girls aged 10-11 years," the authors say. "Further strategies are needed to reduce obesity prevalence in primary school children overall, and particularly in older boys and younger children."

Does a healthful eating pattern extend life?

Nearly everyone believes that an unhealthful diet has adverse consequences, including heightened risk for early death. A prospective cohort study was conducted to examine the associations of dietary scores for 4 healthy eating patterns with risk of total and causespecific mortality, which was published in the JAMA Internal Medicine recently.

Analysis showed that, for each eating pattern, participants in the most-healthful quintile had significantly lower risks for death (14%–20% lower) than participants in the least-healthful quintiles.

Healthful eating also was associated inversely with death due to cardiovascular disease, cancer, respiratory disease, and neurodegenerative disease. Similar results were obtained among various racial and ethnic groups.

Defending champions Bashundhara Kings have opened up a nine-point lead at the top as the first phase of the Bangladesh Premier League came to an end yesterday.

The win lifted the All Reds to eighth position with 10 points while Sheikh Russel remained in fourth position with 14 points. Sheikh Jamal, with 14 points, were occupying the fifth position.

At the opposite end of the table, newcomers Azampur FC of Uttara look destined for the drop as they have only two points from 10 matches, six behind Chittagong Abahani.

South Africa's women cricketers will go where none of their male counterparts have gone when they contest their very first World Cup final at Newlands in Cape Town on Sunday.

No South African team, men or women, had previously gone beyond the semifinals of either a 50-overs or T20 World Cup. So far, the South African teams had played a combined eleven semifinals at ICC World Cups, failing to win all of those.

The hosts reached the final of the women's T20 World Cup with a thrilling six-run win over England but now they will be up against Australia, a team of proven World Cup winners, who have won five of the previous six T20 finals.

The Aussies also had a tight semifinal when they edged past India by just five runs but they are loaded with experience which their captain Meg Lanning believes will help them in the pressure moments.

"Having been in pressure situations before helps a lot," said Lanning on Saturday.

"We're not going to be the team that everyone's cheering for.

"We're expecting South Africa to

come out to play to their full strength South Africa lost two of their first and they're riding a wave of emotion as well.

"I expect an incredible atmosphere and an incredible game at an amazing venue. It's a World Cup final and there's nowhere to hide."



Lanning said there would be pressure on both teams.

"It comes down to holding your nerve under pressure," she said.

"We've always known we had the ability to get to a final, I think it was just to get through that semifinal," said South African captain Sune Luus

Bangladesh Army detained five suspected militants and seized mortars, foreign-made firearms, and ammunition in Khagrachhari Manikchhari upazila.

The operation was conducted Friday night by army personnel from the district's Sindukchhari zone.

On information, they conducted a raid at a house and detained the five.

Four mortar and shells, one AK-47 rifle, one M1 rifle, one LG (local gun) short barrel, one LG long barrel, one China-made pistol, two walkie-talkies, Indian rupees, and 67 bullets were recovered from the house.

The detainees were involved in various criminal activities and were active members of the militant group named "Mogh Party", the army claimed at a press conference held at Manikchhari army camp yesterday.

The army said militants held the house owner hostage and were using it as a hideout for their criminal activities.

Talking to The Daily Star, Fatikchhari Police Station Officerin-Charge Masud Ibne Anwar said, "Army personnel handed the five detainees to us. Legal steps will be taken against them soon."

This is the first instance that members of the "Mogh Party' have been apprehended in Khagrachhari.

"We have recorded the case and will send the woman for a medical test Bandarban General to Hospital tomorrow morning," the OC said when contacted around 10:30pm yesterday.

"Police are trying to arrest the accused, a Bangalee man," he added.

In all, scientists found six galaxies, which together

threaten to change what scientists know about the beginnings of galaxies in our universe. Researchers say they refer to the objects as "universe breakers" and that they are in tension with 99 per cent of existing models of the universe.

Such galaxies should not be expected to be so big so soon after the beginnings of the universe, the researchers say. The mass of the stars examined in the new research are as much as 100 times greater than researchers had previously thought.

"These objects are way more massive than anyone expected," said Joel Leja, assistant professor of astronomy and astrophysics at Penn State, who modeled light from the galaxies, in a statement.

TURKEY-SYRIA QUAKE Death toll tops 50,000

Ankara begins to rebuild for 1.5m left homeless

Turkey has begun work to rebuild homes following this month's devastating earthquakes, as the combined death toll in Turkey and Syria surpassed 50,000.

More than 160,000 buildings containing 520,000 apartments collapsed or were severely damaged in the Feb. 6 earthquakes that killed tens of thousands in Turkey and neighbouring Syria.

The Disaster and Emergency Management Authority (AFAD) announced the death toll in Turkey rose to 44,218 on Friday night.

With Syria's latest announced death toll of 5,914, the combined death toll in the two countries rose to above 50,000.

Facing an election within months, President Tayyip Erdogan has pledged to rebuild homes within a year, although experts have said the authorities should put safety before speed. Some buildings that were meant to withstand tremors crumbled in the latest earthquakes.

"For several projects, tenders and contracts have been done. The process is moving very fast," the official said, speaking on condition of anonymity, adding there would be no compromise on safety.

Authorities say tents have been dispatched for the many who are homeless, but people have reported trouble SEE PAGE 2 COL 4
