#### ADANI POWER PURCHASE AGAINST 'PUBLIC POLICY'

# How could such a deal be signed?

In 2015, with a flurry of power deals in the bag and overcapacity in existing production capacity, did Bangladesh need to sign another landmark deal? Statistics suggest no.

Perhaps, the raw exuberance surrounding the Bangladesh growth story then could justify the deal struck with Adani Power under the 2011 Indo-Bangla Framework Agreement for Cooperation on August 11, 2015 -- about two months after Indian Prime Minister Narendra Modi's maiden visit to Bangladesh.

But nothing explains the government's rationale for signing the power purchase agreement for the deal two years later: three




legal and energy experts at home and abroad who reviewed the contract at The Daily Star's request found it to be exceptionally expensive, overtly favouring Adani Power and ironclad.

"The way I would put it is heads Adani wins, tails you lose. The contract is so biased against the interests of Bangladesh to the point that one has to wonder why any sensible person would sign it on behalf of the Bangladeshi government," said Tim Buckley, an energy economist and founder of Sydney-based Climate Energy Finance Australasia.

The Daily Star contacted Mina Masud Uzzaman, who signed the deal in his capacity as the secretary of the Bangladesh Power Development Board then, on November 5, 2017 to learn of the government process in the lead-up to agreeing to the deal.

# Health, edn to get chop in ADP

Health and education are set to get the biggest chop in the revised development budget for this fiscal year, when the International Monetary Fund has stipulated more spending in the two sectors as part of its \$4.7 billion loan programme.

In the revised budget for fiscal 2022-23, which is scheduled to be approved tomorrow at the meeting of the National Economic Council, the allocation for the health service division is likely to be slashed by 38 percent to Tk 9,780.96 crore.

The budget for the ministry of primary and mass education would be brought down by 32.6 percent to Tk 7,784.68 crore and for the secondary and higher education division by as much as 48 percent to Tk 7,218.33 crore, according to the draft proposal prepared

for the meeting. Overall, the annual development programme would be trimmed by 7.5 percent to Tk 227,566.09 crore, with the foreign-funded projects shouldering the entire

The allocation for foreign-funded projects would be reduced by Tk 18,500 crore or 19.89 percent.

The government has decided to go for an expansionary fiscal policy and hence the government's own funded projects were left untouched in the

This would revive economic activities and generate employment.

The reason the budgets for the health service division, ministry of primary and mass education and secondary and higher education division are being reduced is their implementation is low, said a finance ministry official requesting anonymity as he is not authorised to speak with media.

In the first seven months of the fiscal year, the health service division has managed to use 11.7 percent of its allocation, the ministry of primary and mass education 15.86 percent and the secondary and higher education



# Respect for rights gone into reverse

#### Warns UN chief, calls for renewal of Universal Declaration of Human Rights

AFP, Geneva

Respect for human rights has gone into reverse, the United Nations chief warned yesterday, calling for a renewal of the Universal Declaration of Human Rights, 75 years after its signing.

Pointing to the war raging in Ukraine, and threats to rights from soaring poverty, hunger and climate disasters, Antonio Guterres said the declaration was "under assault from all sides."

"Some governments chip away at it. Others use a wrecking ball," he told the opening of the UN Human Rights Council's main annual session, describing the disregard and disdain seen for human rights around the world as "a wake-up call".

He said the "Russian invasion of Ukraine has triggered the most massive violations of human rights" being witnessed in the world today.

"It has unleashed widespread death, destruction and displacement," he said.

While the past century has seen astounding progress in human rights and human development, Guterres warned that now, "instead of continuing this progress, we have gone into reverse.'

Russia's war in Ukraine loomed large

over the meeting, due to last a record six weeks, with calls for unity in condemning Moscow and extending a probe into war crimes in the conflict.

The session comes just days after the one-year anniversary of Moscow's full-scale invasion -- which UN rights chief Volker Turk warned that 75 years after the world agreed on the universality of rights, "the oppression of the past can return in various disguises."

Turk cited "the old destructive wars of aggression from a bygone era with worldwide consequences, as we have witnessed again in Europe with the

#### BGB returns 2 firearms of BSF

BSF men left those behind after clashing with villagers in Bangladesh

Border Guard Bangladesh returned two firearms to Indian Border Security Force at Nirmalchar border of Rajshahi's Godagari upazila Sunday afternoon, hours after two BSF members and three Indian nationals intruded into Bangladesh territory and clashed with villagers.

Lt Col Sabbir Ahmed, commanding officer of BGB 1 Battalion, said the trouble began on Sunday morning when some locals were prevented from grazing their buffaloes in Nirmalchar by BSF and Indian nationals.

The BSF members entered Bangladesh territory with three Indian nationals and assaulted three Bangladeshis. Among the three are Firoz, 30, and

As locals attempted to intervene, the BSF members attacked them as well, triggering a clash. At one stage, the BSF members and Indian nationals fled, leaving their weapons behind.

Informed by the locals, BGB members went to the spot, brought the situation under control, and recovered the weapons.

A rifle and a submachine gun were returned to BSF, said Lt Col Sabbir.

He said they held a battalion commander-level flag meeting with the BSF on Sunday afternoon and lodged a strong protest against the illegal intrusion by BSF men.

The BGB has beefed up patrol at the border.

### Two journalists acquitted in ICT case

A Khulna court yesterday acquitted two local journalists in a 6-year-old ICT case filed back in 2017.

Kazi Motahar Rahman Babu, former editor of local newspaper Somayer Khabor, and one of its reporters Shohag Dewan were cleared of the charges as the allegations brought against them were not proven in the investigation.

On May 18, 2017, a report was published in the Bangla daily headlined "Complexities again in recruiting staff in Khulna Chief Metropolitan Magistrate court! President resigned".

"I don't remember anything. It came through the chairman. I was the last step," said Mina Masud, who is now an additional inspector general at the Department of Inspection for Factories and Establishments.

virtually no scope for BPDB to get out of this contract for power purchase from the plant, which was built at an estimated cost of Rs 14,816 crore on 'unconditional and irrevocable' sovereign guarantee from the Bangladesh government that it would purchase the entire power generated

for 25 years. "If there is a material breach, you cannot terminate the contract. You have to seek for remedy and that description has to be in reasonable detail. And you have to give them time for remedy in all termination events," said a top corporate lawyer in Bangladesh, who specialises in drafting infrastructure contracts.

And even in the case of dispute resolution, the government has conceded ground: it waived off sovereign immunity, which would have given it an upper hand.

"It's a plain unfair contract. This is an agreement against public policy," said the lawyer on the condition of anonymity to speak candidly on the

But it is not that the government did not have experience negotiating big PPAs before this: at The Daily Star's request, the experts also reviewed the Payra and Rampal deals and found those to be not ideal either but are much less predatory.

In so doing, Adani Power passed on the entire risks associated with its fixed and variable costs of the power plant, which was set up on a 68:32 debt-to-equity ratio, to BPDB and also line its pockets along the way.

In fact, this is the only PPA of Adani Power in which all variable costs are pass-through, making it a largely lowrisk venture for India's largest private power company.

Major predatory aspects of the PPA with Adani Power, whose chairman Gautam Adani has longstanding ties with Modi, can be found in the pricing

of coal and capacity charge. Coal that would fire the 1,600 megawatt ultra-supercritical power plant located in the Indian eastern state of Jharkhand's Godda district would be calculated based on the average prices of benchmark coal with an energy value of 6,000 kilocalories per kg (kcal/kg) at the Indonesian coal index and the Australian Newcastle index for the relevant month.

'That means if Adani purchased coal from countries other than Indonesia and Australia at a lower

cost, they would be able to charge extra," said M Shamsul Alam, an energy expert who reviewed the 163page document for The Daily Star.

While the PPA mentions that BPDB would be charged for 4,600 kcal/kg, there are significant gains to be made by Adani Power for deciding to arrive at the price based on the rates for higher-grade coal.

The 4,600 kcal/kg coal is of inferior grade and trades at a fraction of the price of 6,000 kcal/kg coal.

"If you tie it to an index that is unrelated to the quality of coal Adani transporter and port operators. is using, how is that fair? It's probably the most generous coal PPA I have ever seen in the world in my decades of energy analysis," Buckley said.

While there is a provision in the Adani PPA to change the index based on which coal would be billed, it is almost impossible to explore that option, according to the lawyer.

"It can be deployed if any of the indexes is withdrawn, unavailable or inappropriate. But we do not know what constitutes inappropriate," he

Coincidentally, Adani Power's sister concern Adani Enterprises is India's biggest coal trader and owns mines in Indonesia and Australia -- and the coal for the Godda plant will most likely be supplied by that vendor.

The entire transportation and logistics-related costs for coal are linked to the relevant global indices: Baltic Exchange Dry Index and Platts Oilgram Bunkerwire Singapore.

BPDB would also have to pay for the transport and logistics of the coal for the Payra and Rampal power plants, but this cost would be baked into the final price of the coal procured through the open tender. Subsequently, a competitive rate is expected that is immune from the agaries of the indices.

The coal for the plant -- located in an Indian village about 100 kilometres from the Bangladesh border -- would be delivered to Odisha's Dhamra port, which is owned by another sister concern, Adani Ports and Special Economic Zone.

Dhamra Port Company has been tasked with port handling including coal unloading, storage, loading onto railway wagons and port-related documentation. From there, coal would travel 695 kilometres in wagons of Indian Railways to the power plant. It is not known whether arm's length pricing would be used for this

Arm's length pricing is the price at which a willing buyer and a willing unrelated seller would freely agree to transact or a trade between related parties that is conducted as if they were unrelated, so that there is no conflict of interest in the transaction.

For Payra and Rampal, separate coal purchase agreements are signed through an open tender and with BPDB's vetting and provisions for discounts.

Their coal purchases would be based on the year-ahead notification given by BPDB about its electricity to BPDB. But the converse is not true,

purchase schedule. But the invoice ould be as per the dispatch to BPDB.

If the coal purchase agreements have a minimum offtake guarantee and BPDB's dispatch is below that, there would be an additional invoice to make up the difference

In the Adani PPA, BPDB must take and pay for at least 34 percent of the power generated by the plant every year. Failure to do so would entail reimbursing all the penalty, damages or compensation paid or incurred by Adani Power to its coal supplier, coal

There is no minimum offtake requirement for Payra and Rampal.

Another major point of difference between the Adani PPA with the other two is in the calculation of capacity payment, which, in essence, is the rent paid to the power plant for the contracted years regardless of how many hours the boiler, the turbine and the generator are run to generate electricity.

Where Payra and Rampal's authorities arrived at the sum using formula based on the capital cost, return of equity, the interest on debt. depreciation, interest on working capital and so on, Adani Power arbitrability slapped on a sum. In addition, it will factor in the US Consumer Price Index for the capacity payment calculations for the 25-year contract duration.

Subsequently, the electricity that would be purchased from the Adani Godda plant, which was built with a Rs 10,075 crore loan from Indian staterun lender Power Finance Corp. and its unit REC at a subsidised rate, will end up costing more than the others

However, the government could have landed a windfall had it approached this PPA with more gumption.

A little over a year after the PPA was signed, India's ministry of commerce and industry designated the 425 hectares of land on which the stateof-the-art power plant was emerging as a special economic zone. This meant Adani Power got tax and levy exemptions.

Naturally, the capacity payment, energy tariff and coal invoices would come down as those were originally calculated factoring in the taxes and

But a clause in the PPA states that Adani Power is obliged to make adjustments only in the cases of taxes or levies or costs going up, in vet another example of the one-sided nature of the contract This proposition is absurd. It is a

clear example of duress. No sane person agrees to such clauses," the lawyer said. The SEZ designation is saving Adani Power upwards of \$1 billion, according to Buckley Where in the other two PPAs, a

in yet another instance of the onesided nature of the contract.

"You cannot catch him [Adani] for his failure to deliver for political events. However, if he invokes a political event, you have to continue to pay the capacity payment, energy payment and the other dues," the lawyer said.

A political event should be force majeure and as per law, during force majeure, both sides are exempted from each party's obligations.

"He will take money by doing nothing. This is another robbery. This is absolutely an illegal clause. It's hard to stay in the right mood after seeing such clauses," he said.

If the plant gets damaged for a political event, Adani Power would bill BPDB for repair works and restoration of normal service, in another unfair inclusion in the PPA.

This supplemental tariff, which was not used in the other two PPAs, can also be invoked in the case of costs going up for Adani Power.

Another favourable clause for Adani is the option to take a second test to check the dependable capacity which is the total electricity the plant can supply to the grid -- should t fail the first one.

As is standard practice in PPAs, the test is carried just once and that result is valid for 300 months. If the plant fails the test, it has to pay a penalty.

Should the Godda plant fail the test, Adani Power could carry out another test at its own cost.

If it gets the expected reading this time, it will supersede the previous one and the compensation paid by Adani Power to BPDB until then would be adjusted with future invoices.

"In every layer, there is a loophole they are giving with one hand and taking it back with the other hand," the lawyer said.

Nasrul Hamid, the state minister

for power, energy and mineral resources since 2014, and Tawfig-e-Elahi Choudhury, the prime minister's energy adviser since 2009, declined The Daily Star's request for comment. "It is a punishable offence to sign

such a contract -- we believe that our agencies have the ability to identify the corruption in this deal," said Alam, also the vice-chairman of the Consumers Association of Bangladesh.

And cancelling the agreement will not solve matters. "We need to bring to book those who made such agreements. It is highly unlikely that Bangladesh

would be able to consume the 1,496 megawatts of electricity that would be produced by the Godda plant. The dedicated transmission line from Godda would bring power to the

northern part of Bangladesh, which is not an industries-dense region and hence the demand for electricity is not that much. "We will need to keep the power plant unutilised and keep spending dollars as capacity charges,' Alam added. 'The whole contract is a gift by

the Bangladesh government to the [previously] richest man in Asia,' Buckley said.

For instance, the reference HBA index for 6,332 kcal coal is \$197, as announced for March 2023 and since the plant would consume 4,600 kcal coal, the effective free-on-board price would be \$143 per metric tonne and not higher!

Would Adami Power not be passing on the benefits of the plant's SEZ designation?

Adani has not charged BPDB anything yet and hence all mischievous propaganda of vested interests.

It is pertinent to note that the cost of power from the Godda project would be lower than the comparable projects since PPA with Adani Power Jharkhand (APJL) provides for a lower freight.

As per the formula provided in the PPA. ocean freight for March would be \$10.4, which would be far lower than other similar power projects that would be charging almost close to double the freight cost owing to pass-through provisions.

Since the Godda project is at a designated SEZ, power consumers of Bangladesh will not have to pay for custom duty, taxes and Cess, as applicable per the current norms.

This makes the power tariff of the Godda project more competitive, compared to other contemporary stations, which would eventually contribute to the people of Bangladesh getting more competitive power.

Is there no formula behind the excessive capacity payment; was it was arbitrarily decided?

This is yet another case of misinformation. Unlike other power generation projects whose electricity bill includes taxes and other duties, APJL's bills shall be without such levies as rightly indicated by you that it has been granted some tax benefits.

Capacity charge, under the PPA with Adani Power, is competitive with other similar generating stations in Bangladesh such as Rampal, S Alam and Matarbari.

Additionally, Adani Power has also, on its own goodwill gesture, waived off fixed charges for being available and never billed any capacity charge until the grid station at Bogura and the associated transmission system becomes operational.

APJL would charge fixed costs as per the terms defined in PPA, once the power supply starts in the right earnestness as envisaged from March

# 'Choosing control over protection'

#### Speakers tell webinar on draft Personal Data **Protection Act**

The draft Personal Data Protection Act will lead more towards the control of citizens' data as opposed to its protection, said speakers at an online discussion yesterday.

"The draft law can be a threat to people's right to privacy," said Saimum Reza Talukder, senior lecturer at the School of Law, Brac University, adding that there is a risk of this law being used against critics of the government and those expressing

difference of opinion. The discussion was organised by the Forum for Bangladesh Studies.

He also commented that the law can threaten the cyber security of the state because it does not clearly define how it will ensure which of the different government organisations will have access to what category of data.

Talukder commented on how the law promises the officers charged with implementing indemnity protection from prosecution, stating, "In the eyes of law, everybody is the same."

Senior journalist Kamal Ahmed commented that the law is more about protecting the interests of the state and the government, protecting the state's sovereignty and cracking down on crime.

"It is less about the protection of personal data. While trying to prioritise security, the law overlooked the rights

of the citizens," added Kamal. "Where is the guarantee that power will not be

abused?" he asked.

# Ensure anyone can file case to save environment

Recommends JS body

RASHIDUL HASAN

A parliamentary body yesterday bringing recommended amendment to the "Environment Court Act" so that any citizen of the country can file a case over environmental damage, pollution, and different forms of irregularities.

parliamentary standing committee on the Ministry of Environment, Forest and Climate Change also recommended adjusting the amount of fine to the gravity of environmental harm.

"Under the existing law, aggrieved citizens cannot just file cases over environmental damage, pollution or irregularities on their own. They need to do so through the Department Environment, after getting permission of its director general," Saber Hossain Chowdhury, chief of the parliamentary body, told The Daily Star after emerging from the meeting.

The meeting was held at the DoE office in the capital's Agargaon.

Saber, also an Awami League lawmaker, said the parliamentary watchdog has recommended dropping the provision of taking permission from the DoE's director general before filing a case.

About increasing fines, Saber said at present, the amount of fine is not proportional to the gravity of polluting the environment. Therefore, polluters prefer just paying the fine rather than addressing the issue.

For example, the committee chief said an owner of a tannery industry used to save Tk 5 to 10 lakh by shutting down the effluent-treatment plant of his factory, as he only had to pay around Tk 20,000 for this crime.

"We have recommended the adjustment so that the fine can be in line with the intensity of the crime of polluting the environment," he said.

The parliamentary standing committee also recommended imposing compensation relative to the harm done to the environment. "At present, there is no clear cut instruction about how to fix the amount of compensation. We have recommended determining a protocol and rule in this regard."

The meeting was also informed that in the last 13 years, the Directorate of Enforcement has imposed compensation of Tk 484.75 crore from 11,883 organisations.

Environment Minister Shahab Uddin and State Minister for Environment Habibun Nahar were present at the meeting among others.

#### HC blasts govt for failing to curb air pollution

The High Court yesterday blasted all departments concerned government for their failure to curb air pollution in Dhaka despite its repeated directives.

The HC bench of Justice KM Kamrul Kader and Justice Mohammad Ali, while hearing a writ petition, said water is not spread sufficiently to reduce air pollution, and the mosquito menace continues.



#### **GUN ATTACK ON ALLEADER** Case filed accusing 6

A case was filed yesterday over the gun attack on Narsingdi's Shibpur upazila chairman Harunur Rashid, accusing six people including Arif Sarkar.

The OC said, "Primarily, we are suspecting that the attack was carried out due to political reasons."

Hasan Sani chairperson of Puthia Union Parishad and the union's AL president, said, "Arif Sarkar has no involvement with Awami League or its associated bodies."



# 10 hurt as AL factions clash in Tangail

At least 10 people, including two journalists, were injured in a clash between two rival factions of Awami League in Tangail's Ghatail upazila yesterday.

were later dispersed when police intervened.

Tensions reached their peak when both the rival factions announced a programme at the same venue yesterday.

At one stage, the supporters of both groups locked into a clash.

Contacted, Azharul Islam Sarkar, officer-in-charge of Ghatail Police Station, told The Daily Star that police dispersed the AL activists as soon as they could.

# 'When I came to Dhaka, I had nothing'

20 years ago, **Sharmin Sultana** Sumi came to Dhaka from Khulna with very few things to her name. During her time in Dhaka University, the vocalist, along with some talented musicians, would form Chirkutt. **Making music** her only strength, the band quickly rose to fame with their poetic lyrics and unique compositions, eventually going on to earn international acclaim.

How does it feel that your band, Chirkutt, just celebrated their 20th anniversary?

You know when you reach the peak of a hill, after climbing it for a long time, and it feels that you could now die in peace? Well, that

is exactly how I feel right now. I never thought we would complete 20 long years, but here we are. Everyone deserves credit, from the person who used to give us tea every day to the person who patted our backs and motivated us. I am

overjoyed that I have been able to do what I love for the last 20 years. Not many people have this type of opportunity.

Looking back, how has your journey

In all these years, I have gone through many struggles and hardships. However, one thing I learned is to never

glorify your struggles. I swallowed every hurdle that life gave me and made it my strength. Sometimes, it was the people closest to us-our friends and fellow musicians-who hurt us the most. However, I forgot those things and moved on. I am grateful to my amazing team, without them, none of this would be possible.

> What is it like to be the female vocalist of a leading band?

I don't see myself as a female vocalist in the band. Rather, I see myself as an artiste, irrespective of my gender. It feels great to see girls and women being motivated by my

work. When a teenage girl from a village hugs me and tells me that she has been inspired by me after seeing me perform on television, it makes my journey worthwhile. Being able to inspire thousands of women with my work is really beautiful.

When you started Chirkutt, did you

complain about these things. Never think the band would still be here 20 vears later?

> I never plan for anything. When I started the band, I did it because I felt like it. I have grown up in a musical family, where the craft was my only inspiration. When I came to Dhaka from Khulna, I had almost nothing to my name. When I love something, I feel like an invisible power guides me. So, when I came to Dhaka, I started writing and composing my songs. I didn't even know any musical grammar or have institutional training. But I still started anyway.

> As a female artiste, did you ever face any discrimination in the Bangladeshi music industry?

> I have faced a lot of challenges as a female artiste in the music industry, but I don't want to glorify myself by talking about them. I am a solutionsbased person. Whenever I am hurt and face any hurdles, I try to find the positive side of the problem and make my inspiration. However, one thing that I always faced was that I had to prove my excellence in every step I took, compared to my male counterparts. As

#### Argentina reopens

In the evening, the two ministers held a meeting and Momen later hosted a dinner for the Argentine delegation. Cafiero, who is leading a 20-member

business delegation, will meet Prime Minster Sheikh Hasina and Commerce Minister Tipu Munshi today. Argentina recognised Bangladesh

in 1973 and then opened its embassy a year later. However, in 1977, an Argentine dictator closed the embassy.

Addressing the inauguration Shahriar Alam said Bangladesh is the world's 35th economy which definitely attracted Argentina to reopen its embassy here, but the love of Bangladeshis for Argentine football also was a triggering factor.

Immediately after the World Cup, Hasina congratulated the Argentine

"Reopening the embassy is not only a diplomatic gesture but an emotional one as well. It is a reflection of the strong bond that exists between our peoples," Shahriar said.

In 2022, the bilateral trade between the two nations was \$765 million. Argentine exports reached \$742.9 million and imports from Bangladesh totalled \$22.1 million.

Cafiero said while trade is definitely an issue why Argentina is reopening its embassy, it is the love and dignity for people that are especially needed in times of war and austerity.

"Give me the strength to make my love fruitful in service... Give me the strength never to disown the poor or bend my knees before insolent might," Cafiero read stanzas from Tagore, before ending his address.

Bangladesh and Argentina signed a visa exemption agreement for diplomatic and official passports, an agreement to facilitate football training and cooperation, and a memorandum of understanding between the foreign service academies in the field of diplomatic training.

'I am confident the agreements will lead to fruitful cooperation," Foreign Minister Momen told reporters after a meeting at the state guest house Jamuna.

submitted the petition as a public interest litigation to the HC seeking its directive on authorities concerned to probe allegations against Abdus Sobhan Miah Golap of purchasing multiple homes in New York and amassing huge illegal wealth at home and abroad by abusing his power, position and through any other means, and concealing information about his wealth in his election affidavit in 2018.

Sayedul Haque Suman submitted the petition based on a report published in The Daily Star on January 16 this year under the headline "AL MP Golap owns nine properties in New York City"

The report said, "Awami League lawmaker Abdus Sobhan Miah Golap concealed information about being an American citizen and owning nine properties in New York City in his election affidavit in 2018, found an investigation by a global media agency -- raising questions about his seat in the parliament."

"Golap, who was given the post

of central committee's publicity and publication secretary in the AL's national council last month (December last year), bought the properties between 2014 and 2019, according to a report by the Organised Crime and Corruption Reporting Project (OCCRP), a global network of investigative journalists," The Daily Star report said.

"Of the nine properties, which cost Golap about \$4 million, eight were bought with upfront cash payments. His last purchase -- a semi-detached house in Jackson Heights that cost \$1.18 million

was made through a small mortgage and cash in 2019, after he became an MP, according to the report, published on Friday (January 13)," the report said.

Sayedul Haque Petitioner Suman himself moved the petition, while Senior Advocate Khurshid Alam Khan and Deputy Attorney General AKM Amin Uddin Manik represented the ACC and state during the petition's hearing yesterday.

The African countries are Egypt, South Africa, Kenya, Algeria, Sudan, Morocco, Ghana, Rwanda, Burundi, Tunisia, Sierra Leone, Libya, Congo, Liberia, Central African Republic, Eritrea, The Gambia, Botswana and Mauritius.

Twelve countries of South America are Brazil, Bolivia, Colombia, Venezuela, Suriname, Argentina, Peru, Ecuador, Chile, Uruguay and

Bangladeshis will also be able to become citizens of Cuba, Dominican Republic, Haiti, the Bahamas, Jamaica, Trinidad and Tobago, Dominica, Saint Lucia, Barbados, Saint Vincent, and the Grenadines, Saint Kitts and Nevis and Fiji.

Prime accused Sanjida was the vice-president of the university BCL and a student of the statistics department.

"This is an initial step we have taken following the probe body's recommendations. We submitted the report to the university authorities. It will be forwarded to the High Court. We will act as per the High Court directive," Professor Shamsul Haque told The Daily Star.

Phulpori, a first-year nonresidential student, alleged that Sanjida and other BCL activists tortured her on the night of February 12 for staying at the Deshratna Sheikh Hasina Hall without their "permission".

They allegedly tortured her from 11:00pm till 3:30am.

On February 14, the victim lodged complaint with the university proctor, student adviser and the hall

The next day, the university authorities formed a three-member probe body, headed by Prof Reba Mandol of the law department, and the hall administration formed a separate committee.

Following an Court directive, Kushtia district formed administration also three-member comprising Kushtia Additional District Magistrate ANM Abuzar Giffari, Kushtia Senior Judicial Magistrate Mahmuda Sultana and the university's Assistant Professor Shahbub Alam.

The university authorities' and hall authorities' probe bodies submitted separate reports to the acting registrar.

The two reports were then submitted together to the Attorney General's office yesterday to place before the High Court.

The district administration also submitted its report to the Attorney General's office vesterday.

"Ihave received two enquiry reports, one from the deputy commissioner

of Kushtia and another one [joined university authorities] from Islamic University this [yesterday] afternoon. I will submit them before the High Court tomorrow [Tuesday]. Both the reports are intact and so I can't say what the contents are," Deputy Attorney General Tushar Kanti Roy

told The Daily Star yesterday. Contacted, Sanjida told the Daily Star that they will go to court regarding the decision taken by the hall authorities and have nothing to say regarding the probe report. "But we want justice and that is why we will go to court."

# **Palestinians** count cost of Israeli reprisals

Dozens of cars, homes set ablaze in West Bank overnight after two settlers were killed

Palestinians in the occupied West Bank yesterday counted the cost of deadly violence and arson by Israeli settlers targeting a town where two Israeli brothers were killed.

Dozens of Israeli settlers set homes and cars ablaze in the northern town of Huwara overnight, after a day of Israeli-Palestinian talks in neighbouring Jordan aimed at quelling a surge in violence in the Palestinian territory.

More than 350 Palestinians were injured, most suffering from tear gas inhalation, the Palestinian Red Crescent Society said.

The Palestinian health ministry said Sameh Aqtash, 37, was shot dead during an attack by Israeli forces and settlers on the nearby village of Zaatara. The violence came hours after two Israeli settlers

brothers Yagel Yaniv, 20, and Hallel Yaniv, 22 -- were shot dead Sunday as they drove through Huwara. Yesterday, an AFP photographer saw damaged homes

blackened by fire, long lines of charred cars, burned trees and smashed windows in the town.

"Whenever we started to push the settlers back, the

army was firing tear gas at us," added the 25-year-old. Wajeh Odeh, a member of the town's municipality, said 30 houses were burned and damaged while more than 100 cars were torched.

Abdel Moneim Aqtash said he and his brother were standing outside a blacksmith's workshop when they were attacked by Israeli settlers.

"They left the area and then came back with the occupation (Israeli) army... The army shot my brother, not the settlers," he told AFP.

The military told AFP that Aqtash "was not shot by an Israeli soldier".

Yoav Gallant, defence minister in Israeli Prime Minister Benjamin Netanyahu's new right-wing coalition government, said he expected "difficult days ahead" and had ordered troops to be reinforced.

"With this being said, I call on everyone to restore calm... We cannot allow a situation in which citizens take the law into their (own) hands," he said.

The Israeli military told AFP no-one had been arrested over the arson or killing of Aqtash.

The search for the gunmen who fired on the two brothers was ongoing.

Splits within Nepal's communistdominated coalition plunged the Himalayan nation into crisis yesterday as a Marxist-Leninist party said it would withdraw support after the Maoist prime minister backed an opposition candidate for the presidency.

Nestled between China and India, Nepal has had 11 governments since it abolished its 239-year monarchy in 2008 and became a republic. The current prime minister, a former Maoist guerrilla leader, Pushpa Kamal Dahal has held the post three times.

Elected in December, the prime minister, who still goes by his nom de guerre Prachanda, formed a sevenparty coalition comprised of his own Maoist Centre party, the Communist

Unified Marxist-Leninist (UML) party and five other smaller groups.

Last week. Prachanda infuriated the UML by pledging support for the opposition Nepali Congress party's presidential candidate, Ram Chandra

Prachanda had earlier agreed to support a UML candidate for the presidency, according to politicians in the coalition.

Members of both houses of parliament and members of seven provincial assemblies will cast their votes on March 9 to elect the president.

Bishnu Paudel, deputy prime minister in charge of finance, and a senior UML leader, said he and all eight ministers of his party will resign as Prachanda failed to "honour the consensus" that was reached while forming the government.

# Failure to control prices is not an option

#### Govt measures have to be effective, not just for show

Before every Ramadan, we see prices of essentials rising in our kitchen markets, in ways that defy logic. At a time when commodity prices are already sky-high, and people are suffering at an unprecedented level economically, the government needs to implement well-thought-out measures to curb commodity prices from rising any further. It is in such a context that the president of the Federation of Bangladesh Chambers of Commerce and Industry (FBCCI) recently commented that deployment of joint forces to keep watch on the essentials market during Ramadan would not yield the desired results. We believe that his comment should be taken seriously by the government in the interest of both consumers and the business community.

The joint forces were engaged in monitoring the market during the tenure of the last caretaker government. We understand that the business community is genuinely apprehensive about being harassed in the name of market monitoring. But at the same time, and more importantly, the tendency to artificially increase prices of essentials right before and during Ramadan must be addressed.

The government needs to conduct careful and detailed market analysis to solve the problem, instead of spewing arbitrary measures, hoping they would work. As the business community has said, to control prices from rising exorbitantly, the government must ensure the adequate availability of all items in the market. For that, import of essentials and their supply chains have to be made smoother. If the price of the dollar rises quickly, it is most likely that the businesspeople will transfer the additional costs onto consumers. The government, particularly the commerce ministry, has to keep a close eve on that.

Extortionists often push up the prices of commodities in our markets. Such disruptive behaviours have to be reined in by the government. The hoarding of goods to fabricate their shortage must be stopped. Collusion among monopolists is another major reason why prices often go up more in the domestic market, as compared to the international market. The government has to try and increase the number of suppliers and increase competition to ensure commodity prices stay reasonable. Consequently, the government also has to make sure that its market monitoring mechanisms are well targeted. There have been times where we have seen traders colluding to artificially push prices up. Instead of harassing honest traders, the government's market monitoring objectives should be to identify such collusive behaviour and to punish those traders who try to manipulate the market.

The government does not have an easy task at hand here. Given our current reality, to prevent prices of essentials from increasing further, the government has to come up with a holistic approach. It should, therefore, involve experts, members of the business community, and all other stakeholders to come up with a comprehensive programme that takes all necessary factors into consideration.

# Why can't children access Dhaka's playgrounds?

#### Create more open spaces, not restrict them

Playgrounds are necessary for the sound development of our future generation. However, due to various reasons such as occupation, renovation, and repurposing, Dhaka city has been fast losing the few playgrounds it has. Take the Lalmatia Block D playground, for example. Reportedly, for the past three months, the contractors in charge of its renovation have been saying that it will be open for all soon, but that day has yet to arrive. The deadline for finishing the project was June 2022. However, the subcontractors say that they have missed the deadline because of the pandemic. Currently, the caretaker of the playground refuses to let children in to play at the park.

Additionally, three other parks – Trikona Park in Lalmatia near Town Hall, Shahid Park, and Sonali Playground in Mohammadpur – are also "under renovation." The project director had said that these three parks would be activated in the last week of February. However, when our reporter went to visit Trikona park recently, he found that development work was going on. The project director said that the delay was caused due to planning complexities. But, as the planners used up time pondering whether or not to build a footbridge, the children of the area (who came to know of this spot as their primary place for sports and recreation) suffered. Only the Sonali playground is now partly operational, giving some scope to the area's children for play.

Opportunities for sports and recreation are instrumental in the development of children. Without access to playtime, the physical and mental growth of children can be severely hindered. This has become worse due to the pandemic. Yet, 25 out of 75 wards under Dhaka South City Corporation and 10 out of 55 wards under Dhaka North City Corporation do not have a single park or playground, according to the new detailed area plan (DAP). Even where there are parks, there are also efforts to snatch them away. For example, last year, the Tetultala playground in the capital's Kalaban was being planned to be used for constructing a police station. Thankfully, the higher authorities stepped in due to vehement protests by locals. But is this sustainable? Do children and other locals have to go on strike every time a new decision of eating up an open space comes about?

One of the major reasons for urban planners and psychologists of saying that Dhaka is unsuitable for children is the city's lack of playgrounds. In the last 22 years, however, the number of playgrounds in Dhaka has come down from 150 to only 24. We urge authorities to save the playgrounds that are currently in danger and to also create more spaces where our children can play freely.

# No change in tune for the EC in its first year



It has been a year since the new Election Commission (EC) was constituted according to a law that has stipulated the qualifications of the chief election commissioner (CEC) and other commissioners, as well as their recruitment process – although the law itself is not above controversy. Since the new EC's appointment, the government and the ruling party have been relentlessly trying to pursue and convince everyone within the country as well as the interested international observers that this institution has the capacity and authority to conduct all elections in Bangladesh independently, ensuring fairness.

However, the functioning and the activities of the new EC, including the election of the new president, local government (zilla parishad) elections and a few parliamentary by-elections during the last one year, have been the least convincing of that idea. The lone issue where the commission has proven its resolve is its tireless but irrational

Putting this EVM debate aside, let's look at the records of the elections the new EC has presided over so far. It must be noted that the EC's firm handling of the botched by-election to Gaibandha-5 constituency on October 12, 2022 showed some encouraging bravery on its part, when it suspended voting amid widespread irregularities four hours after it started. Those irregularities included people either illegally supporting or forcing voters to cast ballots, polling agents wearing clothes bearing the symbol of their nominees, and illegal entry into restricted rooms. CEC Kazi Habibul Awal and his fellow commissioners watched all these violations taking place from the EC office, Nirbachan Bhaban, in Dhaka, hundreds of kilometres away on big monitors through CCTV feeds.

Though the Awami League leadership questioned the EC's decision, they promptly argued that the decision attempt to please the ruling Awami proved the EC had always been in

overlooked by the EC, which was a complete reversal of Gaibandha in 2022.

One of the worst failures of the EC, however, was not investigating the alleged disappearance of a candidate in Brahmanbaria and his agent. The alleged victim, Asif Ahmed, later told journalists that members of the ruling party were the people who would be able to explain his mysterious disappearance. The EC, however, chose to look away.

Before that, the disappearance of a contestant ahead of election day was unheard of in any election in the country. # All hands on deck needed to beat poverty

Over the years, alongside sustained economic growth, Bangladesh has made remarkable strides in reducing poverty. The international poverty line is set at \$2.15 per person per day based on 2017 prices. This means that anyone living on less than \$2.15 a day is in extreme poverty. Based on the World Bank report titled Poverty and Shared Prosperity 2018, the poverty line rate in Bangladesh decreased to 20.5 percent, while the below-poverty line rate decreased to 13.8 percent. Hence, life expectancy, literacy rates, and per capita food production have all concurrently increased.

The Bangladesh government has set different milestones for the achievement of Sustainable Development Goals (SDGs) by 2030. In its 8th Five-Year Plan (8FYP), the government has targeted an eight percent average growth rate during the July 2020-June 2025 period, set the goal to reduce the poverty rate from 20.5 percent to 15.6 percent, and aims to further strengthen the existing social security system while eliminating poverty and narrowing inequality. Furthermore, it plans to increase public spending in healthcare from one percent to two percent of the GDP. The Perspective Plan (2021–2041), released in 2020, outlines the government's goal of bringing down poverty to less than

three percent and its vision to achieve

a "Smart Bangladesh" by 2041.

Despite these achievements, the Covid-19 pandemic, the Russia-Ukraine war, the consequent price hikes and the global economic crisis have impeded the progress towards these goals. Moreover, the head of the International Monetary Fund (IMF) has warned that a third of the global economy will be in recession this year.

Due to the pandemic and the new socioeconomic crisis, the poverty rate almost doubled from 20.5 percent in 2018 to 42 percent in 2022, while the below poverty rate tripled from 13.8 percent to 28.5 percent. The rate tripled in both rural (33 percent) and urban (19 percent) areas compared to their respective rates in 2018, which also had a spillover effect on healthcare. The poor and disadvantaged have faced additional medical costs, poor management and negligence of healthcare facilities, which paint a bleak picture of the overall healthcare landscape of the country

Additionally, most of the poor suffer from non-communicable diseases (NCDs) like hypertension, diabetes, cardiovascular diseases and asthma/chronic obstructive pulmonary diseases (COPD). With the disadvantaged already suffering from economic vulnerabilities, the additional economic burden of having to avail medical treatment led to a crisis of catastrophic proportion. In recent years, the percentage of out-of-pocket expenditure (OOP) in healthcare has increased to about 73 percent from 67 percent. This indicates that they are mostly taking medical treatment from village or local quacks or pharmacies. More often than not, they consume an excessive amount of antibiotics, which invariably leads to antibiotic resistance.

This paints a truly concerning portrait of the dual stresses afflicting the poor – financial and healthcare brought on by the pandemic and the new socio-economic crisis. This has led to the creation of a new group called the "new poor." Presently, their existing coping mechanisms against

this new crisis include selling off their assets, working extra hours, dipping into their savings, and taking on the burden of debts. Failure to manage the basic necessities for survival has driven numerous poor families to leave the capital city and other urban areas and relocate to their village

Most of these people also remain poorly underserved by government

services. Lack of livelihood skills and training, educational opportunities, inadequate and/or poor quality health and nutrition services all impose multiple burdens on the population that are already at or below the poverty line, and keep them trapped in the vicious cycle of poverty.

To mitigate this situation, the government and policymakers are trying to explore and implement new paths and strategies to improve the lives, livelihoods and healthcare of this vulnerable segment of population. Despite some laudable government efforts, non-government organisations (NGOs) and the private sector actors need to be called on for short-to-mid-term solutions, approaches and strategies with integrated interventions.

Increasing social safety net coverage and ensuring accessibility to the poor via service linkage would be a good start to this end. Equally critical are incentivising and providing opportunities for savings, disseminating direct grants or asset transfers, disbursing soft or interestfree loans to create new employment opportunities or facilitate recovery of existing livelihoods, and creating avenues to build livelihood skills. Furthermore, assuring holistic healthcare solutions, providing community-level healthcare, and adopting initiatives to ensure access to affordable, quality healthcare and reducing OOP expenditures will all play vital roles.

These integrated initiatives could facilitate quick recovery of the poor, not only enabling them to develop safety nets against current and upcoming socioeconomic crises, but also helping them achieve economic resilience, receive adequate health coverage, and lead improved lives.

and vibrant song: Murir Tin. It's a phenomenal creation for so many different reasons. It challenges our educated, elite obsession with "standardised Bangla" (promito Bangla), which has long been considered an indicator of socioeconomic-cultural capital. Any deviation from the standardised Bangla or any regional accent has often been deemed "unacceptable" and "inappropriate." As someone Rangpur to Dhaka and who grew up in in the capital, I never learnt how to speak the Rangpur dialect. My father has a strong regional accent. While growing up, I was taught to believe that my dad's accent was not cool and the right way to speak was in my "standardised" Bangla that I learnt in school and from watching mostly BTV. As an adult, I now lament the loss of a part of my Rangpur heritage. Murir Tin blew my mind when I saw these young men writing songs and singing in their own regional dialects. They nurtured their heritage and made a conscious effort to circulate it.

Bangla music is increasingly getting more and more transnational. Murir Tin is a creative fusion of local tunes and American bluegrass and rap music. Bluegrass music originated from the struggles of white working-class communities living in the Appalachian region of the US during and after the Great Depression in the 1940s. Bluegrass composers and listeners come from both conservative, old, white communities and progressive, to the historical clunky local buses young, diverse communities. The progressive turn in bluegrass music

Murir Tin talks about old, broken, crowded local buses and deplorable public transportation in general, the unbearable traffic that kills hours after hours, roads filled with potholes and defects, fighting over getting a seat especially for female passengers, as well as the daily struggles of workers in the transportation system. As Shayan Chowdhury Arnob rightly points out, "The traffic is so stressful that humour is the only tool to cope with the stress."

Since 2018, Bangladesh has observed a series of road safety protests led mainly by students and the youth. The protests called for attention to our failing road and transportation system, crashes, and fatalities that take away thousands of precious lives every year. Therefore, the song *Murir Tin* is not just a testament roaming the streets in the 1980s. The public transportation system in incorporated stronger themes around Dhaka started with Murir Tin (literal

meaning: "a can of puffed rice") buses. After World War II, the leftover army trucks were sold in auctions at a lower price to wealthy, local business owners. The business owners covered the wooden structure of these trucks with tin and converted them into local buses. These buses were satirically called "murir tin" because of the rattling noise they made and the way they packed passengers to an extreme just like a can full of puffed rice. As years passed, any bus that was old and crowded got the tag "murir tin" by the common public. The song Murir Tin moved the nation not just because it brought forward a historical tradition and nostalgia. So many people were able to personally relate to the song because it is a testament to the continuing struggles of working-class people with public transportation.

Nevertheless, Murir Tin specifically covered working-class experience. Almost all the characters featured in the "Murir Tin | Behind

the Magic" video were men – except the Harmonica player and three backing vocalists. The lyrics were also composed by men based on their personal experiences, as mentioned in several interviews. Therefore, it's not surprising that Murin Tin talked about women's experience only in terms of "ladies' seats" being occupied by men. A 2022 survey found that 87 percent of women faced some form of harassment, including sexual abuse, in public transport at least once, and 36 percent experienced sexual harassment regularly in public

Violence against women in public transport is not just a Bangladeshi problem. The 2012 Delhi gang rape in a bus and the feminist protests around the incident brought forward how unsafe public transport and public spaces have always been for women something that was largely invisible in

channel describes the murir tin bus as a "melting pot where the cultures and the people of Bangladesh come and go. Amid a crowd of common people, there lies #RealMagic." It further says that Murir Tin is a unifying space for the people of Bangladesh where all share the same experience in terms of "the journeys we take, the people we meet, the situations we encounter." Is women's experience of sexual harassment in a murir tin shared by men? Do men encounter the situations women face in public transport?

As a middle-class woman who occasionally used local buses in Dhaka, my experience was not as joyful and vibrant as the vibe the Murir Tin composition shared on stage. I did not have to rely on local buses all the time because of my class privilege. trying to secure one of the very limited number of seats assigned for women, or trying to shield my body with my purse or backpack, or riding the bus with a group of friends who kept an eye on each other and protected each other if needed. Sitting in the last row and writing a song ("pisur sidut boi ene lehir ei gaan") would have been the last thing on my mind while riding a murir tin.

Both bluegrass and rap have a male-dominated historical tradition. During bluegrass festivals, male musicians used to play tunes while their wives watched them from the sidelines. The bluegrass lyrics traditionally had a "Madonna-whore" complex that idealised mothers and maternal figures and justified violence against women committing adultery and/or anything that went against the norm of being a "good woman". Later, some prominent women singers challenged the glass ceiling of bluegrass, and aspired to occupy the stage as bluegrass musicians.

Similarly, the rap industry has been historically male-dominated. Even though it brought forward class struggles, it primarily focused on men's struggles and involved hypersexualisation of and violence against women. Hypermasculinity, and often toxic masculinity, have been integral to being a male rapper. Many Black hip-hop feminists and singers have been trying to address this disparity and find a way to engage hip-hop sensibility with intersectional struggles.

I was not surprised to see that Murin Tin - a composition inspired by bluegrass and rap music tradition glamorised the hypermasculine performance of male rappers or ignored women's everyday struggles in public transport. However, the larger problem lies in the fact that major music roles in the industry songwriting and production, in

particular - are mostly occupied by men. The corporatisation of the local music industry has made it extremely difficult to bring radical changes within the existing structure that has already been profitable for music

# The world must not turn away from the Rohingya plight



When Bangladesh opened its border on humanitarian grounds and hosted the Rohingya refugees in 2017, the international community pledged to provide the necessary

decided to cut rations for the Rohingya refugees living in Cox's Bazar, Bangladesh, announcing that it would cut the monthly allotment by 17 percent from March 2023 onwards. For the past few years, there has been a visible

The World Food Programme (WFP) recently

declining trend in aid supply for the Rohingya. Such a worrisome trend is detrimental to the well-being of the refugees living in the camps for the last five and a half years. Owing to their vulnerability, the declining funds also have worrying implications for regional security. WFP decided to cut the rations from the current \$12 to \$10 from March onwards, citing

a budget shortfall. It has also requested a \$125 million immediate fund from its donors to meet the deficit. Such a budget cut means that a Rohingya refugee living in the camps must live on just \$10 every month, which is likely to make life more difficult considering the soaring prices of commodities amid skyrocketing inflation. However, this is not the first time WFP has

reduced ration. In 2020, the organisation cut ration for Uganda's refugees. After two years, it seems the result has been devastating due to widespread malnutrition and hunger. Many refugees are now deciding to go back to their homes even though the situation there has not improved vet. It is also not the only instance of declining

funds for the Rohingya refugees. For the past few years, funds under the Joint Response Plan (JRP) have been on the decline, increasing the shortfall. In 2022, only \$553 million of the required \$881 million was received under JRP with a shortfall of 37 percent. In 2021, the shortfall was 28 percent, and in 2020 it was 40

Such a decline in aid for the Rohingya is increasing pressure on Bangladesh as it has to maintain the camp with inadequate funds. Moreover, it is also not sustainable for the host country to increase its own budgetary support for the Rohingya since the country is already facing an economic downturn fuelled by the war in Ukraine. Skyrocketing inflation, negative balance of payment and fluctuating forex reserves are already hurting the economy. Yet, Bangladesh is hosting Rohingya refugees in Bhashan Char under its Ashrayan initiative.

Theimpact of the aid deficit will be dangerous

refugees could not avail a balanced diet with \$12 per month. Before the ration cut, already 40 percent of Rohingya children have stunted growth and 40 percent of pregnant and breastfeeding women are anaemic, according to the WFP's own calculation.

UN Special Rapporteur on the right to food Michael Fakhri and Special Rapporteur on the situation of human rights in Myanmar Tom Andrews warned about "devastating consequences" due to the ration cut: more malnutrition, more disease, fewer services, and increased insecurity in the camp.

The budget shortfall and ration cut have implications for regional security. There is a common proverb: "Necessity knows no law." To meet their individual and family needs, the Rohingya refugees are likely to seek alternative sources of income. Ultimately, their needs will compel them to be involved in criminal activities, including drugs and arms peddling, human trafficking, kidnapping and extortion, for the refugees. Already, 45 percent of the and many more. Already, many Rohingya have the onset of the crisis.

budgetary support and ensure quick repatriation. Five and a half years on, the international community must not forget their commitment. They must play a more active role as they had pledged to do in 2017. While quick and swift repatriation should be at the centre of the commitment, the budget shortfall must be avoided as long as the Rohingya live in temporary shelters in Cox's Bazar.

The Rohingya already live in inhumane conditions in the camps. The reduction in aid means further worsening the situation. Therefore, budgetary support should increase with time instead of declining. The US recently announced an additional \$75 million fund in Rohingya support. Apart from the US, Japan, and the EU have announced funds for the Rohingya. Such initiatives are welcome. but these are not enough to meet the budget shortfall Bangladesh is facing every year. Therefore, the international community must live up to their commitments they pledged at



Batting has not been an issue, with the 37-year-old producing 77 runs against India during an important partnership with Mehedi Hasan Miraz. Despite that, it was revealed during the course of the interview that the BCB president had asked when he wanted to retire. "I called Mahmudullah a couple of days back and said to him, 'if you have any retirement plans, please a situation where you can retire after playing a series."

While other players have struggled with retirement in the past, the BCB president asking for a plan would not have boosted Mahmudullah's confidence levels.

# Djokovic scales another peak

Novak Djokovic achieved another historic milestone yesterday, overtaking Steffi Graf's record for most weeks as World No. 1 in tennis history.

The Serbian already held the record for the most weeks as No. 1 in the history of the men's rankings (since 1973) when he surpassed Roger Federer's mark of 310 weeks in March 2021. Now he has moved past Graf by beginning his 378th week on top of tennis' mountain.

Djokovic returned to No. 1 last month for the first time since last June by winning a recordextending 10th Australian Open crown.

"Of course with your love and great strength that you have given me over the years, I've managed to achieve many fantastic achievements throughout my career," Djokovic said in a video for the fans. The Serb will spend his 378th week at the top of men's tennis competing in Dubai, where he will play his first tournament since capturing a record-equalling 22nd Grand Slam title last month. "I still want more achievements," Djokovic told reporters on Sunday.



Bangladesh all-rounder Mehedi Hasan Miraz received a cap from the ICC vesterday for claiming a spot in the ICC Men's ODI Team of the Year for 2022 earlier in January this year. The all-rounder, who impressed with 24 wickets and 330 runs at a stunning average of 66 in 15 games last year, will hope to continue his good form this vear as well, starting from the Tigers' upcoming home series against England.

# Ten Hag's United 'happy but not satisfied'

Manchester United's near sixyear trophy drought was almost overlooked in the build-up to the League Cup final as Newcastle United's wait for major silverware spanned nearly seven decades. A clinical 2-0 victory at Wembley

got the Old Trafford trophy cabinet door swinging open again though and, perhaps more importantly, gave a glimpse of greater things to come under astute Dutch manager Erik ten Hag. The former Ajax Amsterdam boss arrived at Old Trafford with

in sixth place in the Premier League last season. But while there is little he can do about the future ownership of the 20-time English champions, which the American Glazer family have expressed a wish to sell, on the pitch he is shaping a team that looks

capable of reviving the glory days. A season that began under a Cristiano Ronaldo-shaped cloud has been transformed since the Portuguese talisman was finally shown the door after a toxic fall-

Ten Hag has quietly gone about his business, moulding an intelligent team that works tirelessly and is beginning to make winning a habit. A sixth League Cup triumph



ended the club's longest wait for a trophy since 1983.

And the season could still get better. They are in the fifth round of the FA Cup, the last 16 of the Europa League after knocking out Barcelona in midweek and in third place in the Premier League and not out of the title race.

Ten Hag experienced some difficult early days. A 4-0 hammering at Brentford in August had some predicting he might be out before the leaves fell off the trees and then there was a humiliating

6-3 defeat at Manchester City. Since that drubbing at The Etihad in early October, United have lost only twice in all competitions, forward Marcus Rashford has

turned into a world-beater and the signing of midfielder Casemiro has looked like a stroke of genius.

A defence built around the terrier-like Lisandro Martinez and the cultured Raphael Varane snuffed out Newcastle on Sunday, winger Antony is becoming a fan favourite and even old-fashioned centre forward Wout Weghorst, a puzzling signing at the time, looks as though he would run through brick walls for Ten Hag.

It is not so much about individuals though. For Ten Hag the key is having every player pulling in the same direction.

"Winning a trophy shows that its worth to suffer and sacrifice to give every day your best," he told reporters. "If you want to prove something you have to win something.

"This shows we are on a good pathway and it's going in the right direction. We will be happy for 24 hours but we will not be satisfied because satisfaction leads to laziness."

Ten Hag said the confidence of Sunday's win could be a key for the rest of the season.

"I hope this is a big inspiration, but you can't look too far ahead," he said. "It's a big win this and we are really happy tonight. Winning breeds confidence as long as you don't go over the top and keep doing the right things.

# Govt moves to introduce cards to ease hassles

Bangladeshis can have dual citizenship in 44 more countries

Prime Minister Sheikh Hasina has asked the authorities to introduce cards for distribution of essentials under the Open Market Sale programme to ease hassles faced by the beneficiaries.

"The government has noticed lack in the OMS management. The issue was discussed today [yesterday]. The prime minister has instructed the authorities to improve the management," Cabinet Secretary Mahbub Hossain said yesterday.

He was briefing reporters at the secretariat after a cabinet meeting at the Prime Minister's Office, with Prime Minister Sheikh Hasina in the chair.

The Trading Corporation of Bangladesh (TCB) sells essentials to one crore poor families at fair prices against family cards issued by the TCB.

The cabinet secretary said the PM has directed the authorities to introduce cards for OMS also. This would help ensure discipline as people won't have to wait for hours in queues, he added.

Mahbub said that the Cabinet Division was working on this. The OMS programme is run by the Directorate General of Food under the food ministry.

### **CRACKDOWN ON BNP PROTESTS** Use of lethal force deeply troubling UN rapporteurs wrote govt in Dec

The United Nations special rapporteur on the rights to freedom of peaceful assembly and of association, as well as four other special rapporteurs and working groups, had written to the government expressing deep concern following the crackdown on BNP rallies and protests across the country.

The letter, issued on December 27, 2022, was made public by the Office of the United Nations High Commissioner for Human Rights yesterday.

"We are deeply concerned by the apparent use of excessive and lethal force by security forces against peaceful protesters across various districts in Bangladesh, including the use of teargas, live ammunition and birdshot, resulting in injuries of several protesters and the death of at least five individuals," read the letter.

"We are also deeply concerned at the allegations that live ammunition may have been used against protesters,'

"Firearms or lethal force may only be used in selfdefence or in defence of others against imminent threat of death or serious injury and there must be no other feasible option. Based on the information received, it does not appear that the circumstances of these protests reached this threshold to make the use of force necessary and proportional," read the letter.

They listed the actions of law enforcers during the BNP rallies held nationwide, including in Bhola, Narayanganj, Dhaka, Munshiganj, and elsewhere, between July and December last year.



### 'Forbidden planet' discovered outside our solar system

Astronomers have found an unusually large planet orbiting a small star, located about 280 light-years from Earth.

The unexpected size of the newly discovered world, called TOI 5205b, has led researchers to call it the "forbidden planet."

About the size of Jupiter, it was spotted by researchers using Nasa's Transiting Exoplanet Survey Satellite, or TESS. Jupiter is the largest planet in our solar system.



The planet-hunting mission, launched in 2018, surveys the light of the nearest and brightest stars to spot dips in starlight, which suggests those stars have planets orbiting them. The TESS mission has found thousands of potential planets.

The exoplanet orbits a red dwarf star called TOI-5205, which is about 40 percent the size and mass of our sun, and about 5,660 degrees Fahrenheit

## **TORTURE AT IU** 5 BCL leaders, activists asked to leave hall BCL probe body finds 'some

Five BCL leaders and activists, including Sanjida Chowdhury, the prime accused in the torture of a female student in Kushtia's Islamic University, have been asked to leave the dormitory by tomorrow.

The authorities of the university's Deshratna Sheikh Hasina Hall yesterday took the decision after a probe body found the allegations of torture to be true.

The decision came at a meeting in the presence of hall provost Professor Shamsul Haque and other house tutors. According to the meeting minutes, the five BCL leaders and activists are directed to leave the hall by 12:00pm on

The Daily Star obtained a copy of the minutes signed by Professor Shamsul Haque.

"The probe committee formed by the hall provost has found proof of the allegation filed by Phulpori Khatun [Finance and Banking Department, Session: 2021-2022] of being mentally and physically tortured in the name of ragging," said the minutes.

The four-member probe body, which was headed by Prof Dr Ahsanul Haq, a teacher of the information and communication technology department, submitted its report to the university's acting registrar on Sunday.
