HC rejects 2 writs challenging legality of Shahabuddin's election process

The High Court yesterday summarily rejected two separate writ petitions challenging the legality of the process of electing Md Shahabuddin as president of the country.

The HC bench of Justice Md Khasruzzaman and Justice Md Iqbal Kabir Lytton passed the order after holding a hearing on the petitions.

The grounds on which the HC rejected the petitions could not be known as the full text of the order is yet to be released.

However, Deputy Attorney General Bepul Bagmar told The Daily Star that the HC rejected the petitions on the ground that the reasons mentioned in the petitions are not acceptable as the president is holding the office of profit in the service of the republic.

The president is the master employer, who is not under the service of the government, the DAG added.

Supreme Court lawyers MA Aziz Khan and Abdul Momin Chowdhury filed the petitions on March 7 and March 12 respectively, also praying SEE PAGE 6 COL 2

3 die in septic tank of Savar factory

Three people, including a cleaner, died yesterday while working inside a septic tank of a garment factory in Ashulia.

Officials of local fire service station and locals said that Mithu, 16, first went inside the septic tank of Al Rahman Knitting Fashion Bd Ltd in Dargarpar area of Shimultala to clean it around 3:00pm.

Not getting any response from Mithu for around an hour, Rakib, 22, a worker of the factory, went in looking for him.

Later, Muhammad Ali, 26, also went inside the tank to look for the duo and he too did not return.

On information, fire service started rescue operation around 8:10pm.

The firemen recovered three bodies around 10:00pm.

Putin wants to 'expand' war

Says Ukraine after US drone crash; Moscow urges Washington to stop 'hostile' flights

Kyiv yesterday accused Russian leader Vladimir Putin of trying to widen the conflict in Ukraine after Washington said Russian fighter jets intercepted a US drone over the Black Sea, causing it to crash.

"The incident with the American MQ-9 Reaper UAV -- provoked by Russia over the Black Sea -- is Putin's way of signalling his readiness to expand the conflict to involve other parties. The purpose of this all-in tactic is to always be raising the stakes," Ukraine's National Security and Defence Council secretary Oleksiy Danilov said on social

Washington has said neither it nor the Russians had recovered the wrecked drone.

US European Command said two Russian Su-27 fighters intercepted the unmanned MQ-9 Reaper over international waters on Tuesday

and one clipped its propeller.

Washington blamed Moscow for the incident, calling its fighters' conduct reckless and unprofessional, but Russia has denied any wrongdoing, reports AFP.

"We assume that the United States will refrain from further speculation in the media and stop flights near Russian borders," Russia's ambassador to Washington, Anatoly Antonov, said yesterday.

"We consider any action with the use of US weaponry as openly hostile," he wrote on social media channel Telegram.

Russia's defence ministry said Tuesday it scrambled fighter jets following the detection of a US drone over the Black Sea and denied causing the crash.

The Pentagon said its drone was on a routine mission when it was intercepted "in a reckless, environmentally unsound and unprofessional manner,", while Russia countered the aircraft was out of control.

"As a result of a sharp manoeuvre... the MQ-9 unmanned aerial vehicle entered an uncontrolled flight with loss of altitude and collided with the surface of the water," the ministry said adding that the two Russian jets had no contact with the US aircraft and did not

use their weapons.

The US State Department said it had summoned Russia's ambassador to protest. White House national security spokesman John Kirby followed up saying, "obviously, we refute the Russians' denial".

He added that police were investigating the murder but are yet to make any headway.

Driver killed, his autorickshaw missing

Police vesterday recovered the body of a battery-run auto-rickshaw drivers in Tangail's Basail upazila.

The deceased is Julhas Miah, 50, of Tangail Sadar. Mohammad Hanif, inspector (investigation) of Basail Police Station, said that locals found Julhas's body lying next to Basail-Nalua road in Gazirbhanga area and informed police, who recovered the body and sent it Tangail General Hospital for autopsy. His vehicle, however, was missing.

The victim's family said Julhas had gone out with his auto-rickshaw on Tuesday and did not return home.

Mostafizur Rahman, officer-in-charge of Basail Police Station, said the victim's hands were tied and mouth was gagged, while there were injury marks on his body, adding that they suspect criminals killed him to snatch his auto-rickshaw and later dumped his body on the roadside.

Talks between Myanmar and Bangladesh had slowed since the start of the Covid-19 pandemic in early 2020, and military takeover of Myanmar in 2021.

Meanwhile, the global pressure piled on the Myanmar junta that is accused of killing thousands of civilians fighting for the return of democracy. On the other hand, a genocide case

Myanmar has shown growing interest for the Rohingya repatriation in recent times and has also arranged a trip for ambassadors of ASEAN countries and of Bangladesh, India and China to Rakhine last week to show the conditions.

They said that out of the list of 8.82 lakh Rohingyas sent to the Myanmar authorities, the identities of around 70,000 had been verified by the latter. "We found that some members of

the same families were left out of the list of verified Rohingyas. When we asked why it happened, the Myanmar authorities said there may have been Patients to get spelling mistakes in the names or addresses," a foreign ministry official

He added that the Bangladesh government then invited the Myanmar officials to visit the Rohingya camps and verify the identities in person. "This visit [of the delegation] is meant to do that."

Refugee Relief and Repatriation Commissioner Mohammed Mizanur Rahman told Reuters there was a

list of 1,140 Rohingyas who are to be repatriated under the pilot project, of which 711 have had their cases

Cases of the remaining 429 on the list, including some newborns, were still being processed, he said.

Those dropped out of the list will be added back and verified. "We are ready to send them

back," Mizanur said, adding that he did not yet know when exactly the repatriation would begin.

However, Chinese Ambassador to Bangladesh, Yao Wen, on Tuesday said he expects the first batch of Rohingya will be repatriated soon.
