Hunger rising sharply in Syria: WFP

Hunger and malnutrition are rising sharply in Syria and more than half its population is short of food after 12 years of war, economic pressures and last month's earthquake, the World Food Program said yesterday.

"The situation is worse than ever in Syria, the United Nations agency's Middle East director, Corrine Fleischer, told Reuters.

About 55 percent of Syria's population of some 12.1 million people are food insecure and a further 2.9 million are at risk of sliding into hunger a WFP report said

are at risk of sliding into hunger, a WFP report said.

Data show malnutrition is rising and that stunting and maternal malnutrition rates are at unprecedented levels.

"We're very, very concerned that hunger is on a steep rise in Syria," Fleischer said.

An earthquake in February which killed at least 53,000 across Syria and Turkey came on top of social and economic hardship of 12 years of war and a weakening Syrian pound. As agencies responded to the earthquake, the head of the WFP a month ago called on authorities in northwestern Syria, which is controlled by insurgents at war with forces loyal to President Assad, to stop blocking access to the area.

Japan parliament expels YouTuber MP

A celebrity gossip YouTuber-turned-lawmaker became the first MP expelled by Japan's parliament in over 70 years yesterday, having not shown up to work once. Yoshikazu Higashitani, known by his online moniker GaaSyy, had been ordered to apologise for his months-long absence earlier in March. But the lawmaker, one of two elected members of the fringe party Seijika Joshi 48, or "Politician Girls 48", did not attend that parliamentary session either. Higashitani, 51, had not set foot in the House of Councillors since his July 2022 election, despite a requirement for lawmakers to be present. The former businessman and YouTuber has instead remained at his home in Dubai, claiming he may be arrested if he returns to Japan, where he reportedly faces questioning over alleged defamation. Japan's Upper House decided on Tuesday to expel him from parliament. The move was made official yesterday -- making him the first Japanese lawmaker to be expelled since 1951, local media reported. Higashitani will be replaced by another member of his party.

CYCLONE FREDDY Death toll in Malawi and Mozambique passes 270

Malawi and Mozambique were racing to rescue survivors from Tropical Cyclone Freddy yesterday as the death toll rose above 270 from one of the most powerful storms recorded in the southern hemisphere.

Freddy tore through southern Africa for the second time in a month over the weekend and was still causing heavy rain yesterday, hampering relief efforts.

Malawi's disaster management department said in a statement that the death toll from the second hit stood at 225, up from 190 on Tuesday.

In neighbouring Mozambique at least 21 people had died as of Tuesday, according to the disaster agency.

The overall death toll since Freddy first made landfall in February is now estimated at more than 270 in Malawi, Mozambique and Madagascar.

Strike grips Lanka

Trade unions cripple hospitals, ports, banks to protest IMF bailout

Sri Lanka deployed armed troops as trade unions crippled hospitals, ports and banks yesterday to protest against high income taxes imposed as a precondition for a crucial IMF bailout.

Schools cancelled term tests and outpatient departments at hospitals closed due to the work stoppage that involved more than 40 trade unions. Fewer vehicles were seen on roads.

Dockers at the main sea port in Colombo stayed away while air traffic controllers joined the combined industrial action to carry out "go slow" for two hours affecting at least 14 international flights.

"All considered, our work-to-rule was for two hours, but we will consider a full-blown strike if the government does not roll back the new tax rates," Rajitha Seneviratne, secretary of the air traffic controllers' association, told AFP.

Armed soldiers were deployed at railway stations as well as the port as the government tried to restore minimum services. Dock workers had a tense standoff with the military inside the port, but there were no reports of clashes.

President Ranil Wickremesinghe's office said 20 trains operated to bring office workers to the capital, but unions said it was less than five percent of the daily services.

State-run buses were also operating, the president's office said, but only a few of them were seen on the roads while attendance in schools, offices and factories had dropped sharply yesterday.

The strike came despite a ban imposed by Wickremesinghe last month, and warnings that violators could lose their jobs.


