Chaos all throughout **SCBA** polls

In one-sided election, pro-AL lawyers win all posts

In a one-sided election marked by scuffles, chaos, police highhandedness, and ruckus raised by lawyers, the pro-Awami League lawyers have won all posts of the Supreme Court Bar Association.

Pro-BNP lawyers who didn't cast their votes demonstrated on the Supreme Court Bar Association (SCBA) office premises

yesterday, the second day of the two-day polls, demanding cancellation of what they said was a "farce of an election".

Pro-Awami League and pro-BNP lawyers shoved each other and engaged in scuffles during the demonstrations around 12:30pm and 4:00pm.

The pro-BNP lawyers demanded that a new date be fixed for holding the polls in a fair manner under an "acceptable" election-conducting committee.



A mighty man's humble birthday

"I have never observed my birthday -- at most my wife would present me a little gift on this day. I would try and stay at home on these days.

"I found in the newspaper that the Dhaka City Awami League is observing my birthday. Must be, because I am in jail! That I am someone whose birthday is even worth observing and is a news feature made me smile.'

This was how Sheikh Mujibur Rahman, the then newly elected Awami League president, described his 47th birthday, which he spent in Dhaka Central Jail in 1967.

Mujib, later known as Bangabandhu -- the father of the nation -- described how the highlight of his birthday would be getting to meet his wife and children.

In jail, he used to note down his daily life in his diary. The diary, which was later turned into a book called "Karagarer Rojnamcha (Prison Diaries)", contains his memories of imprisonment during the Pakistan regime, especially between 1966 and 1968, and also between 1958 and 1960.

My heart was telling me: it would be nice if Renu [Sheikh Fazilatunnesa Mujib] would show up on this day with the children again. On the SEE PAGE 11 COL 2

TEESTA WATER Dhaka will first seek to know the facts on withdrawal


Bangladesh is cautiously observing the situation and verifying media reports on India's plan to withdraw water from the Teesta for hydropower and irrigation projects in West Bengal, the foreign ministry said yesterday.

"The water resources ministry and the Joint River Commission are readying a paper, and we will try to know the facts from Índia. Then we shall take necessary measures, Seheli Sabrin, foreign ministry spokesperson, told journalists at the weekly media briefing at the ministry.

Indian newspaper The Telegraph last week reported that the West Bengal government decided to set up three hydropower plants in Darjeeling, and two of them are likely to reduce the volume of water in the Teesta.

It also reported that the West Bengal government acquired 1,000 acres to dig two canals and divert more water from the river to

13 jailed over Nasirnagar mayhem

Chicken price UNTHINKABLE

Not likely to go down in months

With Ramadan less than a week away, the high prices of chicken and meat are not likely to come down anytime soon.

Yesterday, broiler chicken was sold for Tk 270 a kg in the capital, up from Tk 160 one and a half months ago. "I have never seen broiler chicken

being sold at such a high price. I'm worried that the price may cross the Tk 300-mark in Ramadan," said Shamim Alam, a banker, at the capital's Hatirpool kitchen market.

A trader charged Shamim Tk 510 for a broiler chicken.

"My daughter loves to eat chicken. Otherwise, I would have bought beef," Shamim told the trader.

Prices of all breeds of chicken started going up in the capital one and a half

Yesterday, the Sonalika breed was sold for Tk 370 per kg and local breed Tk 630 per kg, up from Tk 270 and Tk 500 one and a half months back, according to the market analysis of

Dhaka Metropolitan Police. Halima, a resident of Bhashantek slum, went to the kitchen market in the slum yesterday to buy chicken but returned home with chicken liver, head, neck, and feet which she bought at Tk 120 per kg.

The woman, who bought chicken a month ago, said, "I could not even think of such a high price of chicken."

Reajul Huq, director (administration) of the Department of Livestock Services, blamed high prices of chicks and feed and rise in demand for the price hike.

"The department cannot intervene in the market as it is an independent business," he told The Daily Star.

Halima, a resident of Bhashantek slum, went to the kitchen market in the slum yesterday to buy chicken but returned home with chicken liver, head, neck, and feet which she bought at Tk 120 per kg.

Moshiur Rahman, an accountant at a private firm, buys groceries every Friday. 'We live in a large joint family. We

need at least eight chickens of local breed every week. The current price of eight chickens is about Tk 5,200. With this amount, I could buy about 7.5kg beef," he told this newspaper, adding that his family was switching from chicken to red meat.

Seven more abducted in **Teknaf**

Body found in Ukhiya

Criminals have again abducted seven people when they went to collect firewood in Teknaf hills of Cox's Bazar and demanded ransom for their release, said the victims' family members.

This incident took place in Jahazpura hilly area in Baharchhara union of Teknaf around 12:30pm yesterday, said Mashiur Rahman, officer-in-charge of Baharchhara Police Investigation Centre under Teknaf Police Station.

The abductees are Gias Uddin, 17, Fazal Karim, 38, Jaberul Islam, 35, Arif Ullah, 22, Mohammad Rashid, 28, Mohammad Zafar, 38, Mohammad Zainal, 45, of Jahazpura village, said

Around 15 to 20 criminals wearing masks besieged a group of nine villagers, including two children, who went to the hill to collect firewood and held them hostage at gunpoint, said Mohammad Rafiqul Islam, a member of ward-6 of Baharchhara Union

The two children escaped tactfully while the criminals were taking the villagers deep into the forest after an hour of the abduction, said the

The miscreants are demanding ransoms, Rafiqul said.

Abdul Halim, officer-in-charge of Teknaf Model Police Station, said, "Several police teams are conducting raids in the hills.

Locals are also cooperating with police in the operation, he added.

Inspector Moshiur, of Baharchhara Police Investigation Centre, said police were also trying to identify the perpetrators.

Forty-one people, including 17 Rohingyas and 24 locals, were abducted in Teknaf hills in the last six months.

Most of them returned after paying ransoms, locals claimed.

Meanwhile, a Rohingya man was found dead at a refugee camp in Cox's Bazar's Ukhiya yesterday morning, a day after an armed group abducted

The body of Mahbubur Rahman, 35, bore several stab wounds likely inflicted by sharp weapons, police said.

An inhabitant of Kutupalong camp-5, Mahbubur went to his father-inlaw's house in Balukhali camp-9 on Wednesday morning when an armed group picked him up, said Amir Jafor, additional deputy inspector general of Armed Police Battalion-8.

Locals found his body near the bordering area of camp-9 this morning and informed police, the police official

Police are suspecting he was murdered over enmity centring establishing supremacy in the camps, the APBn official said.

The body was sent to Cox's Bazar Sadar Hospital morgue for autopsy.

BLACK SEA DRONE INCIDENT

Pentagon releases de-classified video

Moscow says US directly participating in Ukraine war

In a rare move, the Pentagon vesterday released a de-classified video showing Russia's intercept of a US military surveillance drone downed over the Black Sea two days ago.

It was the first direct US-Russian incident since the Ukraine war began, worsening already tense relations between Washington and Moscow.

In the video, a Russian Su-27 fighter jet comes very close to the US MQ-9 drone and dumps fuel near it, in what US officials say was an apparent effort to damage the American aircraft as it flew over the Black

It also shows the loss of the video feed after another close Russian maneuver, which the Pentagon says resulted from the Russian jet's collision with the drone. It ends with images of the drone's damaged propeller, which the Pentagon says resulted from the collision, making the aircraft inoperable.

The video, which is about 40 seconds long, has been edited by the US military for length but shows events in a sequential order, the Pentagon said.

Russia has denied US accusations that its jets acted recklessly in the incident on

Tuesday over the Black Sea, and instead Shoigu told his US counterpart that US has blamed "sharp maneuvering" by the drone for the crash, claiming its jet did not make contact.

A US official, speaking on condition of anonymity, said Russian ships had been seen near the area where the drone had crashed, though they did not appear to have recovered any parts of the drone yet. It was not clear if they were still in the area.

Washington has said that any recovery efforts relating to the drone would be difficult because of the depth of water in the region. It said it has taken measures to ensure that no sensitive information can be gleaned from the remains of the drone.

The release of the video followed separate calls on Wednesday between the top US general, Mark Milley, and his Russian counterpart, Chief of the General Staff Valery Gerasimov, as well as between US Defense Secretary Lloyd Austin and his Russian counterpart, Sergei Shoigu.

In remarks to reporters on Wednesday, Milley said it was clear that the intercept and harassment of the drone by Russian jets was intentional, but it was unclear whether the Russian pilots meant to slam their aircraft into the drone -- a move that invasion, urged them to invest in their

drone flights near Crimea's coast "were provocative in nature" and could lead to 'an escalation ... in the Black Sea zone," a ministry statement said.

"The Americans keep saying they're not taking part in military operations. This is the latest confirmation that they are directly participating in these activities in the war," Kremlin Security Council Secretary Nikolai Patrushev said.

Russia, in a statement said, has "no interest" in escalation "but will in future react in due proportion" and the two countries should "act with a maximum of responsibility", including by having military lines of communication in a crisis.

Chaos all throughout SCBA polls

The signs that there would be chaos during the election were obvious: The pro-Awami League and pro-BNP camps formed two separate subcommittees to hold the election in what senior lawyers said was an unprecedented incident in the history of SCBA.

After the formation of the two committees by the two opposing camps, Supreme Court's Senior lawyer Khurshid Alam Khan on February 26 warned of chaos during the election.

"I have never seen more than one election sub-committee to conduct SCBA elections. Leaders from the two groups should immediately settle the dispute through discussion," he told The Daily Star then.

SCBA Secretary Md Abdun Nur Dulal who was elected from the pro-AL Bangabandhu Awami Ainjibi Parishad last year, issued a notice on February 23 forming a seven-member election subcommittee led by Shah Md Khasruzzaman.

On the same day, SCBA Senior Mahfuz Bin Yousuf, who was elected from the pro-BNP Bangladesh Jatiyatabadi Ainjibi Oikya Panel last year, issued a separate circular forming another sevenmember subcommittee led by AZM Fariduzzaman Farhad to conduct the election.

Alamgir was talking to reporters at his EC office.

Asked about what happens if the commission has to compromise, he said, "You will not see us in this chair then. If we can't do what we have pledged to do through oath, why should we remain in this chair?'

He said the other election commissioners also have similar thoughts regarding the matter.

Alamgir said it is possible to hold a free and fair election under a partisan government if the commission wants to do so. It depends on how well the Election Commission performs its duties, he added.

"The previous Election Commission can say why they could not do so in the past. The people of the previous and current commission are different from each other," Alamgir said. Asked whether they will take any initiative to bring

an end to the ongoing pollical stalemate over joining the next general election, Alamgir said, "Has the constitution given the EC any such responsibilities?" He said the EC has the power to take opinions from

various stakeholders, civil society. Dialogue can be held with political parties, he added.

Alamgir said, "It is our responsibility that those who will participate in the elections can campaign freely; voters can come to the polling stations and vote for their preferred candidates.'

Wasa cannot hike water tariff until rule formulated: HC

The High Court yesterday declared that authorities of Dhaka Water Supply and Sewerage Authority cannot hike water tariff until a rule is formulated under the Wasa Act in this regard.

The HC bench of Justice Md Mozibur Rahman Miah and Justice Kazi Md Ejarul Haque Akondo delivered the verdict after hearing a petition filed by Consumer Association of Bangladesh, petitioner's Jyotirmoy Barua told The Daily Star.

Details of the HC verdict could not be known as its

full text was not released yet. lawyer Mahshib Hossain told this correspondent that his client will move an appeal before the Appellate Division of the Supreme Court after receiving the HC verdict.

The HC also declared illegal the decision to award performance bonuses to employees of Dhaka Wasa.

According to the petition, in the 291st meeting of Dhaka Wasa board on April 27 last year, it was decided to give performance award (performance bonus) to its employees, which will be equal to three basic salaries.

Child marriage more prevalent in char areas

Speakers tell event

While child marriage is an issue that has plagued the entire country, the prevalence is higher in the remote char lands in the country's northern parts due to poverty. illiteracy and insecurity, said speakers at an event yesterday.

They also said despite continuous efforts, the number of child marriages has again gone up in the aftermath of the Covid-19 pandemic, and to address approach.

Speakers made the remarks at the event, titled "Prevention of Child Marriage in remote and marginalised chars of northern Bangladesh", jointly organised by Friendship and The Daily Star at The Daily Star Centre in the capital.

"I think the figures and regional comparisons on child marriage remain very concerning," said Robert Chatterton Dickson, British high commissioner to Bangladesh.

In his keynote presentation, Ahmed Toufigur Rahman, assistant director (inclusive citizenship) of Friendship, mentioned that the overall prevalence of child marriage in the country is 51 percent, which is the highest among all South Asian nations.

Rajshahi and Rangpur, the prevalence is higher -- around 68 percent, he said. The figure is much higher in char lands," he added.

Onno van Manen, country director of Save the Children, Bangladesh, highlighted how the loopholes in the law are being exploited in favour of child marriage.

"There are various ministries that are looking into the issue. This either results in overlapping or gaps in the initiatives. It has also been challenging to motivate the government staffers to become proactive in resisting child marriage," he said.

"People facilitating child marriages face no consequences. That is also something that the system needs to look at," he added.

Local government representatives from remote char lands in Kurigram also shared their perspectives on child marriage.

"The main reason behind child marriage is poverty. Moreover, illiteracy and insecurity have been adding fuel to continue the problem," said Saidur Rahman, chairman of Bhogdanga Union Parishad of Kurigram.

Fake vaccine factory busted in Keraniganj

On the outskirts of the capital, they set up a small factory in Keraniganj and started manufacturing fake Cervarix vaccines, used to prevent cervical cancer.

As raw materials, the group used hepatitis B vaccine brought illegally from India. They would then campaign at educational institutions in Dhaka and Gazipur through health foundations and vaccination centres. The group even sold the counterfeit products to different pharmacies, claimed police's Detective Branch (DB).

Law enforcers, however, did not further elaborate about the process.

"In the last two years, around 6,000 girls and women of different educational institutions in Dhaka and Gazipur got these fake vaccines," Harun Muhammad Rashid, additional commissioner of DB of Dhaka Metropolitan Police, SEE PAGE 4 COL 4

ACC can dismiss officials without showing reason: SC

The Appellate Division of the Supreme Court yesterday ruled in favour of the Anti-Corruption Commission (Servants) Service Rules, which allows the commission to dismiss its officials without showing any reason.

According to Section 54 (2) of Anti-Corruption Commission (Servants) Service Rules-2008, the commission can terminate any officer either by issuing 90-day notice or paying 90 days' salary in cash.

Yesterday, the Appellate Division overturned a High Court verdict that had scrapped the section.

An eight-member bench of the apex court headed by Chief Justice Hasan Foez Siddique delivered the verdict after allowing an appeal filed by the commission challenging the HC judgement.

Following the SC verdict, the commission can dismiss any of its officials or employees without showing any reason, ACC lawyer Khurshid Alam Khan told The Daily Star.

He said such provision is necessary for the ACC, which is a very sensitive institution, in order to control any

The lawyer also said former deputy assistant director of ACC Sharif Uddin cannot get his job back following the apex court judgement.

On February 16 last year, the commission sacked Sharif following Section 54(2).



Israeli raid in West Bank kills three

AFP, Ramallah

Israeli forces killed three Palestinians in a raid in Jenin in the occupied West Bank yesterday, the Palestinian health ministry said.

There were martyrs from occupation (Israeli) bullets in Jenin," a ministry statement said. while the Israeli army said that "security forces are currently operating in the Jenin refugee camp".

On Wednesday, Israeli security forces killed a man suspected of planting a roadside bomb that injured a man near the occupied West Bank this week, the military said, adding that the suspect appeared to have been planning other attacks.

On Monday, an Israeli motorist was seriously hurt in an explosion on a road near the occupied West Bank, where Palestinian militant attacks have intensified in recent months.

Armenia said yesterday it would appeal to the international community to help prevent "genocide" Nagorno-Karabakh after criticising the role of Russian peacekeepers in the breakaway region in Azerbaijan.

Caucasus-region arch foes have fought two wars for control of the Karabakh mountainous region since the 1990s, with both Moscow and the playing mediation West

Yerevan has said that an Azerbaijani blockade of the only land link between the separatist stronghold and Armenia has spurred a humanitarian crisis there.

Baku has denied the accusations. "Azerbaijan's political-military leadership is preparing an ethnic cleansing, a genocide in Karabakh," Armenian Prime Minister Nikol Pashinyan told a meeting of his cabinet.

"Russian peacekeepers are the guarantors of the security of the population of Karabakh and if they can't ensure it, they must turn to the UN Security Council to prevent genocide," said. Pashinyan added that he had instructed his foreign ministry to "launch mechanisms on preventing genocide."

Japan, S Korea thaw ties

North Korea fires long range missile ahead of talks

AFP, Tokyo

Japan and South Korea announced the end of tit-fortat trade measures and pledged renewed diplomacy as leaders of the two countries met in Tokyo Thursday for a summit to thaw long-frozen ties. The neighbours, both key US partners in the

region, have for years been locked in a bitter dispute over Japan's use of wartime forced labour.

Relations deteriorated after South Korea's Supreme Court in 2018 ordered Japanese firms to compensate

victims of forced labour, but this month Seoul announced a plan to pay those affected without Tokyo's involvement.

President Yoon Suk Yeol has been keen to end the spat and form a united front against regional challenges including North Korea, which launched a long-range missile just hours before Yoon's arrival in Tokyo.

After talks, he and Japan's Prime Minister Fumio Kishida announced the resumption

regular reciprocal visits to build confider

Japanese media said this could include Kishida inviting Yoon to the G7 summit in Hiroshima in May, and then visiting Seoul.

"Strengthening Japan-South Korea ties in the current strategic environment is urgent," Kishida told reporters at a joint press conference with Yoon

"I hope this visit will nurture trust and friendship and significantly elevate Japan-South Korea

Tokyo's trade ministry said earlier on Thursday it would end restrictions on exports to South Korea of key industrial materials needed for semiconductors, and Seoul said it would withdraw a complaint filed with the World Trade Organization.

Kishida said both countries wanted stronger deterrence capacities, and that suspended security and ministerial talks would now resume, along with

trilateral meetings with China.

And Yoon said the nations would revive a military intelligence agreement that Seoul paused when relations nosedived.

In a potent reminder of the security challenges that have pushed Seoul and Tokyo closer together, North Korea fired a long-range ballistic missile just hours before Yoon's arrival.

"As seen from North Korea's long-range ballistic missile launch this morning before I left for Tokyo, North Korea's ever-increasing nuclear missile threat

ARREST WARRANT SUSPENSION Pakistan trial court dismisses Imran's plea

A Pakistan court declined yesterday to cancel an arrest warrant for former prime minister Imran Khan, one of his lawyers said, as hundreds of his supporters held a vigil at his home and vowed to stop police from detaining him.



Attempts by police this week to arrest the 70-year old led to pitched battles with his supporters outside his home in the eastern city of Lahore before a court ordered authorities to stand down Wednesday.

Khan was ousted from office by a no-confidence vote last year and has been snarled in dozens of legal cases as he campaigns for early elections and a return to office.

The court has dismissed our petition to suspend the non-bailable arrest warrant, which means that Khan can be arrested," lawyer Sher Afzal Marwat told AFP.

It was not immediately clear, however, if police would move against Khan, whose lawyers gave an undertaking to the Islamabad court that he would appear on Saturday. However, Shibli Faraz, a senior party leader, said he

would need "foolproof security" to appear. This particular case, brought by the Election Commission of Pakistan, centres on accusations Khan did not declare gifts received during his time as premier, or the profit made from selling them.

He denies the allegations.

MINE EXPLOSION Death toll rises to 21 in Colombia

AFP, Bogotá

An explosion at a coal mine in central Colombia has left 21 miners dead after 10 more bodies were found in the pit, President Gustavo Petro said yesterday. "Sadly, 21 people lost their lives in this tragic accident in Sutatausa," a municipality in Cundinamarca department, the Colombian leader wrote on Twitter. A build-up of methane gas apparently triggered the Tuesday night explosion in the underground complex, according to local officials. Rescuers had found 11 other bodies on Wednesday in the mine, which is some 45 miles north of Bogota. Cundinamarca Governor Nicolas Garcia announced the search was over yesterday.

US 'suppressing' TikTok: China

China urged the United States to stop ilireasonaoly suppressing tiktok yesterday after Washington gave the popular video-sharing app an ultimatum to part ways with its Chinese owners or face a nationwide

ban. The United States and the European Union have been taking an increasingly firm approach to the app, owned by the Chinese firm Bytedance, citing fears that user data could be used or abused by Chinese officials. The White House was reported on Wednesday to have told the app that it will be banned in the United States if it continues to be

owned by the Beijing-based tech firm. A TikTok spokesperson told AFP that "calls for a ban or divestment are unnecessary".

ANIMAL TRIALS Dengue

A new dengue treatment that could become the first to prevent and treat the virus has proven effective in initial trials in monkeys, according to new research.

Dengue is transmitted by mosquitoes and affects tens of millions each year, producing brutal symptoms that have earned it the moniker "breakbone fever".

It is endemic in dozens of countries, but no treatment exists. Two

published researchers work showing a compound could effectively prevent the virus from replicating in cell cultures and mice by preventing the interaction between two proteins. Now the team has refined the compound and tested it in both mice and monkeys, with "very encouraging" results, said Van Loock, lead for emerging pathogens at the Janssen Companies of Johnson & Johnson.

Russian transfer of kids amounts to 'war crime': UN

AFP, Geneva

Russia's forced transfer and deportation of Ukrainian children to areas under its control amounts to a war crime, UN of possible crimes against humanity.

In its first report, the high-level investigation team created by the UN Human Rights Council a year ago determined that Russia had committed a vast array of violations since its full-scale invasion of Ukraine in February 2022.

"Many of these amount to war crimes," the report by the so-called Commission of Inquiry said, highlighting the forced transfers of children.

"The commission has concluded that the situations it has examined concerning the transfer and deportation of children, within Ukraine and to the Russian Federation respectively, violate

international humanitarian law, and amount to a war crime," the report said. According to Kyiv, 16,221 Ukrainian

children were deported to Russia.

The investigators said they could not investigators said yesterday, also warning verify the figures but pointed to indications

that Russian officials had taken measures to place transferred Ukrainian children in institutions and foster homes, and give them Russian citizenship.

The report pointed to a decree signed by Russian President Vladimir Putin facilitating the granting of Russian citizenship to some categories of children.

The report stressed "international humanitarian

prohibits the evacuation of children by a party to the armed conflict," with few exceptions. The investigators reviewed incidents concerning the transfer of 164 children, aged four to 18, from the Donetsk, Kharkiv and Kherson regions.

Syrian President Bashar al-Assad has said he will only meet President Recep Tayyip Erdogan if Turkey withdraws troops from northern Syria, according to a Russian media interview published yesterday.

His comments come one day after he met Russian President Vladimir Putin, who is seeking to repair ties between Erdogan and Assad severed after the Syrian war broke out in 2011.

"(Any meeting) is linked to our reaching the point when Turkey - fully and without any is ready uncertainty -- for a complete withdrawal from Syrian territory," Assad told Russia's state-run RIA-Novosti news agency.

The Syrian leader, who arrived in Moscow on Tuesday, demanded that alongside a withdrawal Turkey end "support for terrorism", a reference to rebel groups that control regions of northern Syria.

"This is the only way in which my meeting with Erdogan could take place," Assad was cited as saying.

"What significance would any kind of meeting have -- and why organise it -- if it doesn't lead to a conclusion of the war in Syria?" he added.

China's brokering of pact 'a good thing'

Says Blinken on Saudi-Iranian deal; UN says the pact opens door to peace in Yemen

US Secretary of State Antony Blinken on Wednesday offered guarded praise to China for brokering a deal between rival Middle East heavyweights Iran and Saudi Arabia, saying it could benefit the region.

"From our perspective, anything that can help reduce tensions, avoid conflict and deter in any way dangerous and destabilising actions by Iran is a good thing," Blinken told reporters on a visit to

"I think it's valuable that countries, where they can, take action, take responsibility for advancing security, for advancing peaceful relations," he said.

China, a major oil importer, last week concluded the deal to restore relations videolink. between Iran, a US foe since the 1979 Islamic revolution, and Saudi Arabia, whose longtime partnership with Washington has frayed over human rights concerns by President Joe Biden.

The United States frequently denounces China's role in the world as destabilising, though it has also said that Beijing needs to take greater responsibility in international affairs if it wants to be a

major power. The surprise rapprochement between

However, this Iranian-Saudi detente will not bring a magic solution to Yemen, where the influence of the two regional powers on the protagonists is only one dimension of the conflict, analysts warn.

LIBYAN SITE 2.5 tonnes of uranium missing

The UN's nuclear watchdog said two and a half tonnes of natural uranium had gone missing from a Libyan site and "may present a radiological risk, according to a confidential report seen by AFP yesterday. International Atomic Energy Agency (IAEA) inspectors on Tuesday found that "10 drums containing approximately 2.5 tonnes of natural uranium in the form of uranium ore concentrate... were not present" as previously declared at the location, it said. The site "is currently not under the regulatory control of Libya's state authority," the report said. The IAEA will conduct "further activities...to clarify the circumstances of the removal of the nuclear material" from the site and investigate the material's "current location".


Poland breaks up Russian spy ring

১৭ মার্চ বাঙালি জাতির ইতিহাসে একটি স্মরণীয় দিন। ১৯২০ সালের এই দিনে সর্বকালের সর্বশ্রেষ্ঠ বাঙালি স্বাধীন-সার্বভৌম বাংলাদেশের মহান স্থপতি জাতির পিতা বঙ্গবন্ধু শেখ মুজিবুর রহমান গোপালগঞ্জের নিভৃতপল্লি টুঙ্গিপাড়ায় জন্মহণ করেন। জাতির পিতার ১০৩তম জন্মবার্ষিকী উপলক্ষ্যে আমি মহান এ নেতার স্মৃতির প্রতি গভীর

গ্রামের কাদা-জল, মেঠো পথ আর প্রকৃতির খোলামেলা পরিবেশে বেড়ে ওঠা বঙ্গবন্ধু শৈশব থেকেই ছিলেন অত্যন্ত মানবদরদি কিন্তু অধিকার আদায়ে আপসহীন। পরোপকার আর অন্যের দুঃখ-কষ্ট লাঘবে তিনি ছিলেন সদা তৎপর। জীবনের প্রতিটি ক্ষণে যেখানেই অন্যায়- অবিচার, শোষণ-নির্যাতন দেখেছেন, সেখানেই প্রতিবাদে নেমে পড়েছেন। মাত্র ১৪ বছর বয়সে ব্রিটিশ বিরোধী সভা-সমাবেশে অংশ নেন তিনি। এছাড়া গরিব ছাত্র-ছাত্রীদের লেখাপড়ার খরচ চালাতে 'মুসলিম সেবা সমিতি' পরিচালনা করেন। চল্লিশের দশকে এই তরুণ ছাত্রনেতা হোসেন শহীদ সোহরাওয়ার্দী, শেরে বাংলা এ কে ফজলুল হক ও মওলানা আবদুল হামিদ খান ভাসানীর সংস্পর্শে এসে সক্রিয় রাজনীতিতে সম্পৃক্ত হন।

১৯৪৭ সালে দেশ বিভাগের কিছুদিন পরই তরুণ নেতা শেখ মুজিব বুঝতে পেরেছিলেন, ব্রিটিশ পরাধীনতার কবল থেকে মুক্তি পেলেও বাদ্তালি নতুন করে পশ্চিমাদের শোষণের কবলে পড়েছে। শাসকগোষ্ঠী প্রথম আঘাত হানে বাঙালির মায়ের ভাষা 'বাংলা'র উপর। বাংলা ভাষার দাবিতে ধর্মঘট পালনকালে ১৯৪৮ সালের ১১ মার্চ বঙ্গবন্ধু সচিবালয় গেট থেকে গ্রেফতার হন। এভাবে আন্দোলন-সংগ্রাম ও কারাভোগের মধ্য দিয়েই তিনি বাঙালির অধিকার আদায়ের পথে এগিয়ে চলেন। ১৯৪৮ সালে 'সর্বদলীয় রাষ্ট্রভাষা সংখ্যাম পরিষদ', '৫২ এর ভাষা আন্দোলন', '৫৪ এর যুক্তফ্রন্ট নির্বাচন', '৫৮ এর সামরিক শাসন বিরোধী আন্দোলন', '৬৬ এর ৬-দফা', '৬৯ এর গণঅভ্যুত্থান', ৭০ এর নির্বাচনসহ বাঙালির মুক্তি ও অধিকার আদায়ে পরিচালিত প্রতিটি গণতান্ত্রিক ও স্বাধিকার আন্দোলনে তিনি নেতৃত্ব দেন। এজন্য তাঁকে বহুবার কারাবরণ করতে হয়েছে। সহ্য করতে হয়েছে অমানুষিক নির্যাতন। কিন্তু বাঙালির অধিকারের প্রশ্নে তিনি কখনো শাসকগোষ্ঠীর সাথে আপস করেননি।

বঙ্গবন্ধু ১৯৭১ সালের ৭ মার্চ রেসকোর্স ময়দানে বাঙালির আবেগ ও আকাঞ্চাকে ধারণ করে বজ্লকষ্ঠে ঘোষণা করেন, "এবারের সংগ্রাম আমাদের মুক্তির সংগ্রাম, এবারের সংগ্রাম স্বাধীনতার সংগ্রাম", যা ছিল মূলত স্বাধীনতার ডাক। একটি ভাষণ কীভাবে গোটা জাতিকে জাগিয়ে তোলে, স্বাধীনতার জন্য মুক্তিযুদ্ধে ঝাঁপিয়ে পড়তে উৎসাহিত করে, বঙ্গবন্ধুর ৭ মার্চের ভাষণ তার অনন্য উদাহরণ। এ ভাষণে বঙ্গবন্ধু শুধু স্বাধীনতার ডাকই দেননি বরং মুক্তিযুদ্ধের রূপরেখা ও ভবিষ্যৎ করণীয় সম্পর্কেও দিকনির্দেশনা দিয়ে গেছেন। ২৫ মার্চ রাতে পাকিস্তানি হানাদার বাহিনী অতর্কিতে নিরন্ত বাঙালির উপর আক্রমণ চালালে ২৬ মার্চ ১৯৭১ জাতির পিতা ঘোষণা করেন বাঙালি জাতির বহুকাঞ্জিত স্বাধীনতা। বঙ্গবন্ধুর নেতৃত্বে দীর্ঘ ন'মাস সশস্ত্র মুক্তিযুদ্ধের মাধ্যমে আমরা অর্জন করি স্বাধীন-সার্বভৌম বাংলাদেশ। মুক্তিযুদ্ধকালীন পাকিস্তানের কারাগারে বন্দি অবস্থায় শাসকগোষ্ঠী তাঁকে প্রহসনমূলক বিচারের মাধ্যমে ফাঁসির হুকুম দিয়েছিল। অকুতোভয় বঙ্গবন্ধু বলেছিলেন, "ফাঁসির মঞ্চে যাওয়ার সময় আমি বলব, আমি বাঙালি, বাংলা আমার দেশ, বাংলা আমার ভাষা"। দেশ ও জনগণের প্রতি তাঁর অসামান্য অবদানের জন্য বাংলা, বাংলাদেশ ও বঙ্গবন্ধু আজ এক ও অভিন্ন সন্তায় পরিণত হয়েছে। স্বাধীনতার পর পাকিস্তান কারাগার থেকে মুক্ত হয়ে জাতির পিতা ১০ জানুয়ারি স্বদেশে প্রত্যাবর্তন করেন। যুদ্ধবিধ্বস্ত অর্থনীতির পুনর্গঠনে তিনি সর্বশক্তি নিয়োগ করেন। দেশকে 'সোনার বাংলা' হিসেবে গড়ে তোলার সকল প্রস্তুতি গ্রহণ করেন। কিন্তু স্বাধীনতাবিরোধী ঘাতকচক্র ১৯৭৫ সালের ১৫ আগস্ট তাঁকে সপরিবারে হত্যার মাধ্যমে বঙ্গবন্ধুর সেই স্বপ্ন পূরণ হতে দেয়নি। কিন্তু হায়েনার দল বুঝতে পারেনি জীবিত বঙ্গবন্ধুর চেয়ে লোকান্তরের বঙ্গবন্ধু অনেক বেশি শক্তিশালী।

জলে-স্থলে-আকাশে বাংলাদেশের অবস্থান সুদৃঢ় করতে চেয়েছিলেন বঙ্গবন্ধু। বঙ্গবন্ধু আমাদের শিখিয়েছেন কীভাবে শত বাধা বিপত্তি পেরিয়ে লক্ষ্যে পৌছা যায়। ঐতিহাসিক ৭ই মার্চের ভাষণে তিনি বলেছিলেন, "৭ কোটি মানুষকে দাবায়ে রাখতে পারবা না"। বঙ্গবন্ধুর নেতৃত্বে যে দেশ স্বাধীন হয়েছিল, অনেক চড়াই-উতরাই পার হয়ে সেই বাংলাদেশ এখন উন্নয়নশীল দেশ। আজ সকল আশঙ্কা ও নেতিবাচক ভবিষ্যৎ বাণী ভুল প্রমাণ করে জাতির পিতার অসমাপ্ত স্বপ্ন বাস্তবায়ন করে চলেছেন তাঁর সুযোগ্য উত্তরসূরি প্রধানমন্ত্রী শেখ হাসিনা। তাঁর বলিষ্ঠ ও দূরদশী নেতৃতে আজ আমরা দুর্বার গতিতে এগিয়ে যাচ্ছি একটি উন্নত ও স্মার্ট বাংলাদেশ গড়ার অভিমুখে।

বঙ্গবন্ধু শেখ মুজিবের জন্ম হয়েছে বলেই স্বাধীন বাংলাদেশের জন্ম হয়েছে মোজাফফর হোসেন পল্ট

পরাধীনতার নিকষ অন্ধকারে নিমজ্জিত বাঙালি জাতির ভাগ্যাকাশে মুক্তির প্রভাকর রূপে জন্ম নেওয়া 'খোকা' নামের সেই শিওটি শিক্ষাদীক্ষা মানবিক দৃষ্টিভঙ্গি, মহন্তম জীবনবোধ, সততা, সাহস, দক্ষতা ও দূরদশী নেতৃত্বে হয়ে ওঠেন বাংলাদেশ নামক স্বাধীন-সার্বভৌম রাষ্ট্রের মহান স্থপতি, সর্বকালের সর্বশ্রেষ্ঠ বাঙালি এবং জাতির পিতা। সেই অবিসংবাদিত নেতা বঙ্গবন্ধু শেখ মুজিবুর রহমানের ১০৩ তম জন্মবার্ষিকী আজ। বাঙালি জাতির এই মহান নেতা ১৯২০ সালের ১৭ মার্চ তদানীন্তন ফরিদপুর জেলার গোপালগঞ্জ মহাকুমার টুঙ্গিপাড়ায় জন্মগ্রহণ করেন।

শেখ মুজিবুর রহমান টুঙ্গিপাড়ার চিরায়ত গ্রামীণ সমাজের সুখ-দুঃখ, হাসি-কাল্লা, আবেগ-অনুভৃতি শিশুকাল থেকে গভীরভাবে প্রত্যক্ষ করেছেন। গ্রামের মাটি আর মানুষ তাঁকে প্রবলভাবে আকর্ষণ করত। শৈশব থেকে তৎকালীন সমাজ জীবনে তিনি জমিদার, তালুকদার-মহাজনদের অত্যাচার, শোষণ ও প্রজা পীড়ন দেখে চরমভাবে ব্যথিত হতেন গ্রামের হিন্দু, মুসলমানদের সম্মিলিত সম্প্রীতির সামাজিক আবহে তিনি দীক্ষা পান অসাম্প্রদায়িক চেতনার। কিশোর বয়সেই তিনি সক্রিয় রাজনীতিতে অংশগ্রহণ করেন। গোপালগঞ্জের মিশন স্কুলে অষ্টম শ্রেণিতে অধ্যয়নকালে তৎকালীন ব্রিটিশবিরোধী আন্দোলনে যোগদানের কারণে শেখ মুজিবুর রহমান প্রথমবারের মতো গ্রেফতার হয়ে কারাবরণ করেন। এরপর থেকে শুরু হয় বঙ্গবন্ধুর আজীবন সংগ্রামী জীবনের অভিযাত্রা। তিনি সারাজীবন এদেশের মাটি ও মানুষের অধিকার আদায়ের জন্য সংগ্রাম করেছেন। বাঙালি জাতির মুক্তির জন্য জীবনের ১৪টি বছর পাকিস্তানি কারাগারের অন্ধপ্রকোষ্ঠে বন্দি থেকেছেন, দুই বার ফাঁসির মঞ্চে মৃত্যুর মুখোমুখি হয়েছেন। কিন্তু আত্মর্যাদা ও বাঙালি জাতির অধিকার আদায়ের প্রশ্নে কখনও মাথা নত করেননি, পরাজয় মানেননি। দীর্ঘ ২৩ বছরের আন্দোলন-সংগ্রামের পথপরিক্রমায় বঙ্গবন্ধু তার সহকর্মীদের নিয়ে ১৯৪৮ সালের চার জানুয়ারি মুসলিম ছাত্রলীগ প্রতিষ্ঠা করেন এবং পরবর্তীতে ১৯৪৯ সালে আওয়ামী মুসলিম লীগ গঠনে কারাগারে বসেই বিশিষ্ট ভূমিকা রাখেন এবং যুগা

শাদক নিৰ্বাচিত হন। ১৯৫২-এর ভাষা আন্দোলন, '৫৪-এর যুক্তফ্রন্ট নির্বাচন, '৬২-এর শিক্ষা আন্দোলন, '৬৬-এর ছয় দফা আন্দোলন, '৬৯-এর গণঅভ্যুত্থান পেরিয়ে '৭০ সালের ঐতিহাসিক নির্বাচনে বঙ্গবন্ধু শেখ মুজিবুর রহমান বাঙালি জাতির একক নেতা হিসেবে প্রতিষ্ঠিত হন। কারামুক্ত শেখ মুজিবুর রহমান জনসমুদ্রে ছাত্রসংগ্রাম পরিষদ কর্তৃক ভূষিত হন "বঙ্গবদ্ধু" ও পরবর্তীতে "জাতির পিতা" খেতাবে। বঙ্গবন্ধুর সাহসী, দৃঢ়চেতা, আপোশহীন নেতৃত্ব ও বীরত্বপূর্ণ সংগ্রামে অনুপ্রাণিত হয়ে জেগে ওঠে শতবছরের নির্যাতিত-নিপীড়িত পরাধীন বাঙালি জাতি। মুক্তির অদম্য স্পৃহায় উদ্বুদ্ধ করে তিনি বাঙ্জালি জাতিকে স্বাধীনতার চূড়ান্ত সংগ্রামে ঐক্যবদ্ধ করে তোলেন।

অবিশ্বাস্য। তবে ১৫ আগস্টের ঘাতকরা যত না মানুষ ছিলো তার চেয়ে বেশি ছিলো পিশাচ।

শিষ্ঠদের প্রতি বঙ্গবন্ধু শেখ মুজিবের মমতা ছিল অপরিসীম। তিনি বিশ্বাস করতেন আজকের শিশুরাই আগামী দিনের ভবিষ্যৎ; শিশুরাই তাঁর স্বপ্নের সোনার বাংলাদেশ গড়ে তুলবে। শিশুদের ভবিষ্যৎ নিশ্চিত করতে হবে সবার আগে- এই ভাবনা থেকেই জাতিসংঘ শিশুসনদের ১৫ বছর আগে ১৯৭৪ সালে তিনি শিশু আইন প্রণয়ন করেন। শিশু শিক্ষার বিকাশ নিশ্চিত করতে প্রাথমিক শিক্ষাকে জাতীয়করণ করেন। শিশুরা যেন সৃজনশীল-মুক্তমনের মানুষ হিসেবে গড়ে ওঠে- তিনি সব সময় সেটাই চাইতেন। এজন্য তাঁর জন্মদিনকে শিশুদের জন্য উৎসর্গ করে আওয়ামী লীগ ১৯৯৬ সালে সরকার গঠন করে ১৭ মার্চকে 'জাতীয় শিশু দিবস' হিসেবে ঘোষণা করে ।

আওয়ামী লীগ সরকার প্রিয় মাতৃভ্মিকে শিশুদের জন্য নিরাপদ আবাসভ্মিতে পরিণত করতে অঙ্গীকারাবদ্ধ। শিশুদের কল্যাণের লক্ষ্যে আমরা একটি যুগোপযোগী 'জাতীয় শিতনীতি' প্রণয়ন করেছি। শিক্ষার্থীদের বছরের শুরুতে বিনামূল্যে পাঠ্যপুস্তক প্রদান করা হচ্ছে। প্রায় শতভাগ শিশু আজ স্কুলে যাচ্ছে। আমরা শিশুদের জন্য জাতির পিতার জীবন ও কর্মভিত্তিক বই প্রকাশ এবং পাঠ্য বইয়ে মুক্তিযুদ্ধের প্রকৃত ইতিহাস তুলে ধরেছি। জাতীয় শিশু দিবসে জাতির পিতার প্রতি শ্রদ্ধা জানানোর পাশাপাশি মহান নেতার জীবন ও আদর্শ অনুসরণে এ দেশের শিশুদের যথাযোগ্য সুনাগরিক হিসেবে গড়ে তোলাই আমাদের সরকারের মৃখ্য লক্ষ্য। আমাদের শিশুরাই হবে ২০৪১ সালের মধ্যে স্মার্ট বাংলাদেশের স্বপ্ন পূরণের সারথ। শিশুদের মনে দেশপ্রেম জাগ্রত করে তাদের ব্যক্তিত্ব গঠন, সৃজনশীলতার বিকাশ এবং আত্মবিশ্বাসী করে গড়ে তুলতে দল-মত নির্বিশেষে আমাদের সকলকে একযোগে কাজ করতে



বাংলাদেশের অপর নাম শেখ মুজিবুর রহমান প্রফেসর আবদুল মান্নান

হাজার বছরের শ্রেষ্ঠ বাঙালি জাতির পিতা বঙ্গবদ্ধ শেখ মুজিবুর রহমানের আজ ১০৪তম জন্মদিন। স্বাভাবিক নিয়মে তাঁর যদি মৃত্যু হতো হয়তো প্রতিবছর আনন্দঘন পরিবেশে পরিবারে আর জাতীয়ভাবে দিনটি পালিত হতো। কিন্তু ঘাতকরা জাতির পিতাকে ১৯৭৫ সালের ১৫ আগস্ট হত্যা করার পর দিনটিকে সেভাবে আর পালন করা হয় না। দিনটিকে এখন জাতীয় শিশু দিবস হিসেবে পালন করা হয়। বঙ্গবন্ধু শিশুদের খুব ভালোবাসতেন। সম্ভবত পরিবারে তাঁর সবচেয়ে আদরের ছিল তাঁর কনিষ্ঠ সম্ভান শেখ রাসেল যাকে ১৫ আগস্ট ঘাতকরা নির্মমভাবে গুলি করে হত্যা করেছিল। শেখ রাসেলের মতো ১০ বছরের একজন শিশুকে কোনো মানুষ হত্যা করতে পারে, তা এক কথায়



বঙ্গবন্ধু এখনো মজিবর। অবশ্য মা-বাবার আদুরে নাম খোকা। হয়তো নিকটাখ্রীয়রা শেখ মুজিবকে সেই নামেই ডাকতেন। বঙ্গবন্ধুর 'অসমাপ্ত আত্মজীবনী'তেই লিখেছেন, তিনি এক মধ্যবিত্ত পরিবারে জন্মহণ করেছিলেন। সেই আমলে বাঙালি মধ্যবিত্তের অস্তিত ছিল হাতে গোনা। বঙ্গবন্ধ ছিলেন আজীবন প্রতিবাদী। স্কুলে পড়ার সময়ই শেখ মুজিব মনে করতেন 'ইংরেজদের এ দেশে থাকার অধিকার নাই।' তখন সারা ভারতবর্ষে স্বদেশি আন্দোলন চলছে। মুজিব সেই আন্দোলনে নিজেকে জড়িয়ে ফেলেছিলেন। বঙ্গবন্ধুর চরিত্র যে কিছুটা একগুঁয়ে স্বভাবের ছিল তা তিনি নিজেই স্বীকার

করেছেন। পিছন ফিরে তাকালে বলতে হয়, তাঁর একগুরে সভাবই তাঁকে পূর্ব বাংলার স্বার্থে আপোশহীন নেতা হতে সহায়তা করেছিল। শেখ মুজিবের প্রতিবাদী চরিত্রের বহিঃপ্রকাশ তাঁর গোপালগঞ্জে বাল্য ও কিশোর জীবনেও দেখা

১৯৪১ সালে অসুস্থ শরীর নিয়ে শেখ মুজিব ম্যাট্রিক পরীক্ষা দিয়েছিলেন। পরীক্ষা প্রত্যাশা অনুযায়ী না হওয়া সত্ত্বেও তিনি দ্বিতীয় বিভাগে পাশ করেছিলেন। পরীক্ষার পরপরই কিশোর মুজিব কলকাতায় যান। তখন পাকিস্তান আন্দোলন শুরু হয়ে গেছে। চল্লিশের দশকে যখন পাকিস্তান প্রতিষ্ঠার আন্দোলন শুরু হয়, সেই আন্দোলনের সঙ্গে তরুণ শেখ মুজিব নিজেকে জড়িয়ে ফেলেছিলেন। যোগ দেন মুসলিম লীগ আর মুসলিম ছাত্রলীগে। এ সময় মুসলিম লীগ নেতা হোসেন শহীদ সোহরাওয়াদী আর আবুল হাশিমের সান্নিধ্যে আসেন এবং সংগঠন সৃষ্টির তালিম নেন। দেশ স্বাধীন হওয়ার পর আবুল হাশিম ঢাকা বিশ্ববিদ্যালয়ে অনুষ্ঠিত এক অনুষ্ঠানে বলেছিলেন শেখ মুজিব একজন ভালো কর্মী ও সংগঠক ছিলেন। তিনি আরও বলেছিলেন শেখ মুজিবের মতো সংগঠক তিনি কখনো দেখেননি

মওলানা আযাদ কলেজ) ছাত্র থাকা অবস্থায় শেখ মৃজিবের রাজনৈতিক জীবনের বড়ো পরিবর্তনগুলো শুরু হয়। এ সময় তিনি অবিভক্ত বাংলার বড়ো মাপের রাজনীতিবিদদের সঙ্গে একজন সাধারণ কর্মী হিসেবে রাজনীতি করার সুযোগ পেয়েছিলেন। নেতাজি সুভাষ বসুর ডাকে তিনি হলওয়েল মনুমেন্ট ভাঙার আন্দোলনে যোগ দেন। ছাত্রজীবনে ছাত্রলীগকে (মুসলিম ছাত্রলীগ) তিনি অসম্ভব

ভালোবাসতেন এবং এর সাংগঠনিক শক্তি বৃদ্ধি করার জন্য বিভিন্ন ধরনের কর্মসূচি দিতেন। ১৯৪৩ সালে বাংলার এক কঠিন সময়ে শেখ মুজিব প্রাদেশিক মুসলিম লীগের সদস্য হন। এ সময় সারা বাংলার বিভিন্ন অঞ্চলে দেখা দেয় ভয়াবহ দুর্ভিক্ষ। বাংলায় দুর্ভিক্ষের সময় মুজিব তাঁর সঙ্গী-সাধীদের নিয়ে বিভিন্ন স্থানে লঙ্গরখানা খুলে ক্ষুধার্তদের জন্য খাদ্য যোগানের চেষ্টা করেছিলেন। বঙ্গবন্ধুর একটি ব্যতিক্রমী গুণ ছিল, তিনি সময় পেলেই উপমহাদেশের বিভিন্ন প্রতিবাদী মানুষের জীবন ও কর্ম সম্পর্কে পড়াশোনা করতেন। সম্ভবত বঙ্গবন্ধুর মতো পড়য়া রাজনীতিবিদ তখনো তেমন একটা ছিল না, এখনতো একেবারেই নেই।

অনেক জল্পনা-কল্পনা ও ষড়যন্ত্রের মধ্য দিয়ে বাংলা, আসাম ও পাঞ্জাবকে ভাগ করে ১৯৪৭ সালে ভারত ভাগ হলো। বঙ্গবন্ধু তাঁর 'অসমাপ্ত আত্মজীবনী'তে লিখেছেন, 'পাকিস্তান হওয়ার সঙ্গে সঙ্গেই ষড়যন্ত্রের রাজনীতি শুরু হয়েছিল। এই ষড়যন্ত্র ছিল মূলত বাঙালিদের বিরুদ্ধে পশ্চিম পাকিস্তানিদের ষড়যন্ত্র। কলকাতা পর্ব চুকিয়ে ১৯৪৭ সালের সেপ্টেম্বর মাসে শেখ মুজিবও ঢাকায় চলে এলেন এবং মুসলিম লীগের রাজনীতির সঙ্গে জড়িত থাকলেন। দেশভাগের পূর্ব থেকেই মুসলিম লীগে ভাঙন দেখা দেয়। এক ভাগের নেতৃত্ব দেন হোসেন শহীদ সোহরাওয়াদী, আর অন্য ভাগের নেতৃত্বে থাকেন খাজা নাজিমুন্দীন। শেখ মুজিব আজীবন সোহরাওয়াদীর ভক্ত ছিলেন এবং তাঁরই অনুসারী থেকে যান। অবিভক্ত বাংলায় যেটি 'নিখিল বন্ধ মুসলিম ছাত্রলীগ' ছিল্, তার নাম বদলে 'নিখিল পাকিস্তান ছাত্রলীগ' করা হয়। নিখিল বন্ধ মুসলিম ছাত্রলীগের কাউন্সিল অনুষ্ঠিত হয়েছিল ১৯৪৪ সালে। এরই মধ্যে অনেকের ছাত্রত্ব চলে গিয়েছিল। শেখ মুজিব বললেন, ছাত্রদের নিয়ে ছাত্রলীগ গঠন করতে হবে, তবে অছাত্রদের নিয়ে নয়। তরু হলো ঢাকা বিশ্ববিদ্যালয় ও অন্যান্য জেলার ছাত্রদের সঙ্গে যোগাযোগ। ১৯৪৮ সালের ৪ জানুয়ারি ঢাকা বিশ্ববিদ্যালয়ের ফজলুল হক হলে অনুষ্ঠিত এক সভায় স্থির করা হয় একটি ছাত্রসংগঠন প্রতিষ্ঠা করা হবে, যার নাম হবে 'পূর্ব পাকিস্তান মুসলিম ছাত্রলীগ'। গঠিত হলো পাকিস্তানের প্রথম ছাত্রসংগঠন 'পূর্ব পাকিস্তান মুসলিম ছাত্রলীগ', পরবর্তী সময় পূর্ব পাকিস্তান ছাত্রলীগ। প্রথম আহ্বায়ক করা হয় নইমউদ্দিন আহমেদকে। সভায় অনেকে তরুণ শেখ মুজিবকে দলের প্রথম আহ্বায়ক হতে অনুরোধ করেন কিন্তু তা তিনি নাকচ করে দিয়ে বলেন, তিনি এখন আর ছাত্র নন, সুতরাং ছাত্র সংগঠনের নেতৃত্বে সব সময় ছাত্রদের হাতেই থাকা উচিৎ। ছাত্রলীগের যাত্রাটা সূচনা করেছিল ছাত্ররাজনীতির এক সোনালি যুগ। ছাত্রলীগের সৃষ্টি ও তাকে গড়ে তোলার একক কৃতিত্ব শেখ মুজিবের। নেতৃত্বের গতিশীলতার কারণে ছাত্রলীগ দ্রুত সাধারণ ছাত্র-ছাত্রীদের মধ্যে জনপ্রিয় হয়ে ওঠে।

১৯৪৮ সালের ফেব্রুয়ারি মাসে করাচিতে পাকিস্তান গণপরিষদ বৈঠকে পাকিস্তানের রাষ্ট্রভাষা প্রসঙ্গে আলোচনা শুরু হলে মুসলিম লীগ দলীয় সদস্যরা এই মত প্রকাশ করেন, পাকিস্তানের রষ্ট্রেভাষা হওয়া উচিত উর্দু। অথচ সেই সময় পাকিস্তানের বেশিরভাগ (৫৬ শতাংশ) মানুষের ভাষা ছিল বাংলা। উর্দুতে কথা বলতেন মাত্র ৬ ভাগ মানুষ যাদের বেশিরভাগই এসেছিলেন মোহাজের হয়ে ভারত থেকে। ১৯৪৮ সাল থেকে তক্ত হওয়া রষ্ট্রভাষা আন্দোলনের প্রতিটি সভা ও মিছিলে শেখ মুজিব ও পূর্ব পাকিস্তান মুসলিম ছাত্রলীগের নেতাদের অংশগ্রহণ ছিল অবধারিত। একপর্যায়ে শেখ মুজিবসহ অনেককে জেলে নেওয়া হলো। ১৯৪৮ সালের ১৯ মার্চ মোহাম্মদ আলী জিন্নাহ ঢাকা আসেন। ২১ মার্চ রমনা রেসকোর্স মাঠে (বর্তমানে সোহরাওয়াদী উদ্যান) অনুষ্ঠিত জনসভায় ইংরেজিতে বলেন, 'Urdu and Urdu shall be the only state language of Pakistan'। শেখ মুজিব সেই জনসভায় উপস্থিত ছিলেন এবং অন্য ছাত্রদের সঙ্গে শ্লোগান তোলেন, 'মানি না'। তিনদিন পর ২৪ মার্চ ঢাকা বিশ্ববিদ্যালয়ের এক বিশেষ সমাবর্তনে জিল্লাহ সাহেব আবার একই কথা বললেন 'My dear students for the sake of Islam I have decided that Urdu alone would be the state language of Pakistan'। বাস্তবে ইসলামের সঙ্গে জিল্লাহর ন্যুনতম সম্পর্ক ছিল না। আবারও তাঁর বক্তব্যের প্রতিবাদ করেন ঢাকা বিশ্ববিদ্যালয়ের ছাত্ররা। জিন্নাহ চলে যাওয়ার কয়েক দিন পর ফজলুল হক হলে একটি ছাত্রসভা হয়। সেই সভায়

কলকাতার ইসলামিয়া কলেজের (বর্তমানে একজন ছাত্র জিল্লাহর বক্তব্যের সমর্থনে কথা বলেন। সভায় উপস্থিত শেখ মুজিব সেই ছাত্রের বক্তব্যের পরবর্তী পৃষ্ঠায় দেখুন

১৯৭১ সালের ২৬ মার্চের প্রথম প্রহরে পাকিস্তানি হানাদার বাহিনীর হাতে গ্রেফতার হওয়ার পর্বে আনুষ্ঠানিকভাবে বাংলাদেশের স্বাধীনতা ঘোষণা করেন বঙ্গবন্ধু শেখ মুজিবুর রহমান। মহান মুক্তিযুদ্ধের সর্বাধিনায়ক বঙ্গবন্ধু শেখ মুজিবুর রহমানের নেতৃত্বে ৯ মাসব্যাপী রক্তক্ষয়ী সশস্ত্র যুদ্ধের মধ্য দিয়ে ৩০ লক্ষ শহিদের আত্মদান এবং ২ লক্ষ মা-বোনের সম্ভ্রমহানির বিনিময়ে অর্জিত হয় স্বাধীনতা। বিশ্বমানচিত্রে অভ্যাদয় ঘটে স্বাধীন বাংলাদেশ নামক রাষ্ট্রের।

বাঙালি ও বাংলাদেশের গৌরবোজ্জল অধ্যায়ে বঙ্গবন্ধু শেখ মুজিবুর রহমান কালজয়ী নাম। বিশ্ববাঙালির গর্ব মৃত্যুঞ্মী মহামানব বঙ্গবন্ধু শেখ মুজিব। তিনি বাঙালি জাতীয়তাবাদের প্রকৃত প্রবক্তা ও বাঙালি মানসে জাতীয়তাবোধ সৃষ্টির নির্মাতা। দীর্ঘ আন্দোলন-সংগ্রাম এবং সীমাহীন ত্যাগ-তিতিক্ষার মধ্য দিয়ে তিনি বাঙালি জাতির জন্য একটি স্বতন্ত্র রাষ্ট্র

প্রতিষ্ঠা করেছেন। ১৯৭৫ সালের ১৫ আগস্টের কালরাত্রিতে বিশ্বাসঘাতকদের নির্মম বুলেটে বঙ্গবন্ধু শেখ মুজিবুর রহমান সপরিবারে

নিহত হন। পরবর্তীতে অবৈধভাবে ক্ষমতাদখলকারী বঙ্গবন্ধুর খুনি স্বৈরশাসক স্বাধীন বাংলাদেশে পাকিস্তানি ভাবধারার বিকত ইতিহাস ও মূল্যবোধের বিস্তার ঘটানোর পায়তারা চালায়। খুনিরা ইতিহাসের পাতা থেকে বঙ্গবন্ধুর নাম মুছে ফেলতে জাতীয় ও আন্তর্জাতিকভাবে নানা ধরনের ষড়যন্ত্রে লিপ্ত হয়। বঙ্গবন্ধু হত্যার পর স্বাধীন বাংলাদেশে সামরিক-স্থৈরাচার তিন দশক ধরে প্রজন্মের পর প্রজন্মকে মিখ্যা ইতিহাস শেখাবার অপচেষ্টা চালায়। খুনিরা বঙ্গবন্ধুকে হত্যা করে

কিন্তু বঙ্গবন্ধুর চেতনা ও

আদর্শকে মুছে ফেলতে

পারেনি।

সত্যি-ই শহিদের রক্ত বৃথা যায়নি। বাংলাদেশ আজ বিশ্বে উন্নয়নের রোল মডেল। বাংলাদেশ স্বল্পোন্নত দেশ থেকে উন্নয়নশীল দেশে অন্তর্ভুক্তির জন্য জাতিসংঘের চূড়ান্ত সুপারিশ অর্জন করেছে। যা সম্ভব হয়েছে কেবল তাঁরই কন্যা মাননীয় প্রধানমন্ত্রী শেখ হাসিনার নেতৃত্বের কারণে। আর এর ভিত্তি স্বাধীনতার পর জাতির পিতা-ই গড়ে

বঙ্গবন্ধুর জন্মদিন অর্থাৎ ১৭ মার্চ দেশে 'জাতীয় শিশু দিবস' হিসেবে পালন করা হয়ে থাকে। তিনি শিশুদের প্রচণ্ড ভালোবাসতেন। তাই প্রইদিনটিতে তিনি আনুষ্ঠানিক জন্মদিন পালন না করে শিশুদের নিয়ে আনন্দঘন সময় কাটাতেন। বাংলাদেশে শিশু উন্নয়নে সুনির্দিষ্ট চারটি পদক্ষেপ নিয়েছিলেন বঙ্গবন্ধু। এক, শিশু কল্যাণের জন্য মায়েদের সম্পৃক্ত করে প্রতিষ্ঠা করেন মা ও শিতকল্যাণ অধিদণ্ডর। দুই, শিতর সার্বিক উন্নতি নিশ্চিত করার লক্ষ্যে প্রতিষ্ঠিত হয় শিত একাডেমি। উল্লেখ্য, এ দুটো প্রতিষ্ঠান সংক্রান্ত ভাবনা-পরিকল্পনা বঙ্গবন্ধুর সব সময়ই ছিল।

তিন, শিশুর শিক্ষাকে রাষ্ট্রীয় দায়িত্বের অন্তর্ভুক্ত করার লক্ষ্যে ১৯৭৩-এ ৩৭ হাজার প্রাথমিক বিদ্যালয় জাতীয়করণ করা হয়। বাংলাদেশের সে সময়ের সার্বিক পরিস্থিতির প্রেক্ষাপটে সিদ্ধান্তটি ছিল সাহসী ও যুগান্তকারী। চার, ১৯৭৪-এর ২২ জুন শিশু আইন জারি করা হয়। এ আইন শিশু অধিকারের রক্ষাকবচ।

বঙ্গবন্ধু বেঁচে থাকলে আজ তাঁর ১০৪তম জনাদিন উদ্যাপন করতাম আমরা। কিন্তু আমাদের দুর্ভাগ্য আমরা তাঁকে ধরে রাখতে পারিনি। এ প্রসঙ্গে স্লেহ ভালোবাসার একটা স্মৃতিচারণ করছি। ১৩ আগস্ট বিকাল তিনটার দিকে আমাকে ফোনে বললেন, "ঠিক পাঁচটার সময়ে গনভবনে দেখা করতে, সাথে তিনি এটাও বললেন, তোর পাঁচটা না ঘড়ির পাঁচটা। আমি গনভবনে গেলাম। উনার একান্ত সচিব সৈয়দ রেজাউল হায়াৎ সাহেবকে বললাম বঙ্গবন্ধ আমাকে আসতে বলেছেন, হায়াৎ সাহেব বললেন তিনি বিশ্রামে আছেন। তখন আমি বঙ্গবন্ধুর কথাটার অবতারনা করে বললাম, বঙ্গবন্ধু কিন্তু আমার পাঁচটা নয় ঘড়ির পাঁচটায় আসতে বলেছেন। সঙ্গে সঙ্গে উনি উপরে গেলেন এসে বললেন বঙ্গবন্ধ আপনাকে ডাকছেন। ওদিন বঙ্গবন্ধ অনেক সময় আমার সঙ্গে কথা বললেন। এক পর্যায় বললেন- দেখ মানুষকে তো বশ করতে পারলাম না, মাছকে কীভাবে বশ করছি সেটা তোকে দ্যাখাই। তখন আমি বললাম আপনি যদি মানুষকে বশ নাই করতে পারলেন তাহলে সাড়ে সাত কোটি মানুষ কিভাবে আপনার ডাকে অস্ত্র হাতে যুদ্ধ করে দেশটাকে স্বাধীন করলো। প্রতিউত্তর তিনি করলেন না। এরপর হাটতে হাটতে লেকের কাছে নিয়ে গেলেন, পানিতে হাত দিলেন অমনি অনেক মাছ তার হাতে চলে এলো। ঠিক এই সময়ে সহকারী সচিব শাহরিয়ার ইকবাল এসে বললেন স্যার ব্যরিস্টার মণ্ডদুদ আহমেদ এসেছেন দেখা করতে। যাই হোক আকস্মিক বঙ্গবন্ধু তার হাতে থাকা লাঠি দিয়ে আমার পিঠে তিনটা বারি দিয়ে উপস্থিত লোকদের বললেন পল্টুকে তিনটা বারি দিলাম, যাতে বঙ্গবন্ধুর কথা ওর মনে থাকে। আসলেই বঙ্গবন্ধুর হৃদয় ছিল যেমন বিশাল তেমনি শিশুর মতো সরল। তাঁর এই সারল্যকে কাজে লাগিয়েছে ঘাতকচক্র। যা আমাদের জন্য চরম দুর্ভাগ্যের।

'৭৫ এর ১৫ আগস্টের নৃশংস এ হত্যাকাণ্ডের পর ব্রিটিশ এমপি জেমস ল্যামন্ড-এর খেদোক্তি ছিল, 'বঙ্গবন্ধুর হত্যকাণ্ডে বাংলাদেশই শুধু এতিম হয়নি, বিশ্ববাসী একজন মহান সস্তানকে হারিয়েছে।' বঙ্গবন্ধু আজ আমাদের মাঝে নেই। কিন্তু তার আদর্শ রয়ে গেছে। তিনি স্বাধীন দেশ দিয়ে গেছেন আমাদের। তাঁর আদর্শ নিয়ে এগিয়ে যাবে বাংলাদেশ এই আমাদের প্রত্যাশা। ১০৪তম জনাদিনে পিতার প্রতি জানাই অতল শ্রদ্ধাঞ্জলি।

মার্চ মাস বাঙালি জাতির জীবনে এক অবিশ্বরণীয় মাস। এই মাসে অমোঘ বজ্রুকণ্ঠে বাঙালি খনেছে স্বাধীনতার ডাক। সেই ডাক দিয়েছিলেন যে পুরুষোত্তম ব্যক্তিটি সেই ক্ষণজন্মা অবিসংবাদিত নেতা জাতির পিতা বঙ্গবন্ধু শেখ মুজিবুর রহমানের জন্মদিন এ অগ্নিগর্ভ মার্চে। যে মার্চের গুরুতেই পাকিস্তানিদের ষড়যন্ত্র যে মার্চেই গণহত্যা সেই মার্চেই মুক্তিসংগ্রামের মহানায়কের কঠে স্বাধীনতার ডাক এবং স্বাধীনতার ঘোষণা। ইতিহাসের কী অপূর্ব যোগসূত্র।

তাঁর হাত ধরেই বিশ্ব মানচিত্রে নতুন দেশ হিসেবে স্থান করে নেয় বাংলাদেশ। ২০২০ সালে তাঁর জন্মের শতবছর পূর্ণ হয়। এ বছর অর্থাৎ ২০২১ সালে তাঁর জন্মশতবার্ষিকী উদ্যাপন করেছি, পাশাপাশি স্বাধীনতার সুবর্ণজয়ন্তীও উদ্যাপন করেছে জাতি।

২৫শে মার্চের রাতে বঙ্গবন্ধুর স্বাধীনতা ঘোষণা নিয়ে সাংবাদিক ডেভিড লোশাক দ্য টেলিগ্রাফ পত্রিকায় লিখেন 'অন্ধকার নেমে আসার কিছুক্ষণ পর, সরকারি মালিকানাধীন পাকিস্তান রেডিওর তরঙ্গের কাছাকাছি একটি তরঙ্গের মাধ্যমে শেখ মুজিবুর রহমানের ক্ষীণ কণ্ঠস্বর ভেসে আসে। শেখ মুজিবুর পূর্ব বাংলাকে গণপ্রজাতান্ত্রিক বাংলাদেশ বলে ঘোষণা করেছেন। তাঁর বাণী নিশুরই ইতোপূর্বে রেকর্ড করা হয়েছিল এবং তাঁর কণ্ঠস্বর শুনে তাই মনে হয়েছে। (তথ্যসূত্র: বাংলাদেশের স্বাধীনতাযুদ্ধ দলিলপত্র: তৃতীয় খণ্ড, সম্পাদক: হাসান হাফিজুর রহমান)

> বঙ্গবন্ধু পৃথিবীর নির্যাতিত মানুষের নেতা, বিশ্বনেতা। গরিব-দুঃখী মানুষের প্রতি ভালোবাসা ও তাদের দুঃখ দূর করার প্রতিজ্ঞা এবং অন্যায়ের বিরুদ্ধে প্রতিবাদী মানসিকতা তাঁকে রাজনীতিতে নিয়ে আসে। স্কুল থেকেই তিনি রাজনীতিতে জড়িয়ে পড়েন। গ্রামের স্কুলে তাঁর লেখাপড়ার হাতেখড়ি। ১৯২৭ সালে শেখ মুজিব গিমাডাঙ্গা প্রাথমিক বিদ্যালয়ে পড়াশোনা তরু করেন

> > ১৯২৯ সালে গোপালগঞ্জ পাবলিক স্কুলে ভর্তি হন এবং এখানেই ১৯৩৪ সাল পর্যন্ত পড়াশোনা করেন। ১৯৩৭ সালে গোপালগঞ্জ মিশন ক্ষুলে সপ্তম শ্রেণিতে ভর্তি হন। ১৯৪১ সালে অসুস্থ শরীর নিয়েই ম্যাট্রিক পরীক্ষা দেন। ছাত্রজীবনেই মানুষের অধিকার আদায়ে সংগ্রাম করেন তিনি। আর এভাবেই সক্রিয়ভাবে যুক্ত হয়ে যান

রাজনীতিতে যুক্ত হওয়ার ক্ষেত্রে তাঁর পিতা তাঁকে বাঁধা দেননি। যা নিজেই লিখেছেন তাঁর অসমাপ্ত আত্মজীবনীতে। বাবা শেখ লুংফর রহমানের কথা উল্লেখ করে 'অসমাপ্ত আত্মজীবনী'তে বঙ্গবন্ধু লিখেছেন, 'বাবা রাজনীতি কর আপত্তি করব না, পাকিস্তানের জন্য সংগ্রাম করছ এতো সুখের কথা, তবে লেখাপড়া করতে ভুলিও না। লেখাপড়া না শিখলে মানুষ হতে পারবে না। আর একটা কথা মনে রেখ, 'sincerity of purpose and honesty of purpose' থাকলে জীবনে পরাজিত হবা না। একথা কোনোদিন আমি ভুলি নাই।' (অসমাপ্ত আত্মজীবনী, পষ্ঠা-২১)

ম্যাট্রিক পাসের পর কিশোর মুজিব ভর্তি হন কলকাতার ইসলামিয়া কলেজে। সেখানকার ছাত্র থাকা অবস্থায় তাঁর রাজনৈতিক জীবনের বড়ো পরিবর্তনগুলো শুরু হয়। তিনি পাকিস্তান আন্দোলনে সক্রিয় হন এবং হোসেন শহীদ সোহরাওয়াদী, আবুল হাশিমের মতো নেতাদের সারিধ্যে আসেন। সোহরাওয়াদী ছিলেন বঙ্গীয় মুসলিম লীগের প্রেসিডেন্ট ও বাংলার মুখ্যমন্ত্রী। অপরদিকে আবুল হার্শিম

ছিলেন মুসলিম লীগের সেত্রেটারি। শেখ মুজিবুর রহমান

তখনই মুসলিম লীগের কাউন্সিলর।

আমি আগেই উল্লেখ করেছি যে, ১৯৬৬ এর ঐতিহাসিক ছয় দফা ভিত্তিক আন্দোলনের মাধ্যমে তিনি হয়ে ওঠেন বাঙালির অবিসংবাদিত নেতা। এ প্রসঙ্গে একটা কথা না বলেই পারছি না। আমরা যখন একাকি আলোচনার সুযোগ পেতাম তখন তিনি ছয় দফা সম্পর্কে বলতেন দ্যাখ 'আমি কি চাই- আমার বাঙালী সেনা/নৌ/বিমান বাহিনী প্রধান হবে, পুলিশের আইজি হবে, সচিব হবে, মুখ্য সচিব হবে, বড় বড় শিল্প কল-কারখানার, ব্যাংক-বীমার মালিক হবে'। তার মানে বঙ্গবন্ধুর কথায় ফুটে উঠতো তিনি কতোটা ধ্যানে স্বপ্নে বাঙালিতকে হৃদয়ে ধারণ করতেন।

নয় মাসের রক্তক্ষয়ী যুদ্ধ শেষে ১৬ ডিসেম্বর পাকিস্তানি বাহিনীর আত্মসমর্পণের মধ্য দিয়ে স্বাধীন বাংলাদেশের অভ্যুদয় ঘটে। এরপর পাকিস্তানের কারাগার থেকে মুক্তি পান বঙ্গবন্ধু। সেখান থেকে ইংল্যান্ড যান। এরপর সেখান থেকে দিল্লি হয়ে স্বদেশের মাটিতে তিনি পা রাখেন ১৯৭২ সালের ১০ জানুয়ারি। স্বাধীনতার স্থপতিকে বরণ করতে সেদিন লোকারণ্য ছিল ঢাকার পথ-ঘাট। পিতাকে কাছে পেয়ে বর্ণনাতীত কষ্টের মাঝেও নতুন করে সামনে এগিয়ে যাওয়ার স্বপ্ন দেখে সব হারানো বাঙালি জাতি। বিজয়ের উল্লাসে আনন্দাশ্রু ঝরেছিল। তাই তো দেশে ফিরেই রেসকোর্স ময়দানে (বর্তমানে সোহরাওয়াদী উদ্যান) তাঁর ভাষণে যুদ্ধ বিধ্বস্ত দেশটি গড়ে তুলতে সবার সহযোগিতা চান বঙ্গবন্ধু। জানান তাঁর পরিকল্পনার কথা। পাশাপাশি তাঁর ডাকে মানুষ যে মুক্তিযুদ্ধে ঝাঁপিয়ে পড়ে সেজন্য সবার প্রতি কৃতজ্ঞতা ও ধন্যবাদ জানান তিনি।

বঙ্গবন্ধু বলেন, "বাংলাদেশ স্বাধীন রাষ্ট্র। বাংলাদেশ স্বাধীন থাকবে, বাংলাদেশকে কেউ দমাতে পারবে না। বাংলাদেশকে নিয়ে ষড়যন্ত্র করে লাভ নাই। আমি যাবার আগে বলেছিলাম ও বাঙালি এবার তোমাদের সংগ্রাম মুক্তির সংগ্রাম। আমি বলেছিলাম, ঘরে ঘরে দুর্গ গড়ে তোল, তোমরা ঘরে ঘরে দুর্গ গড়ে তুলে সংগ্রাম করছো। আমি আমার সহকর্মীদের মোবারকবাদ জানাই। আমার বহু ভাই বহু কর্মী আমার বহু মা-বোন আজ দুনিয়ায় নাই তাদের আমি দেখবো না।"

তিনি বলেন, "আমি আজ বাংলার মানুষকে দেখলাম, বাংলার মাটিকে দেখলাম, বাংলা'র আকাশকে দেখলাম বাংলার আবহাওয়াকে অনুভব করলাম। বাংলাকে আমি সালাম জানাই আমার সোনার বাংলা তোমায় আমি বড়ো ভালোবাসি বোধহয় তার জন্যই আমায়

স্বাধীনতার পর অল্প সময় পেয়েছিলেন জাতির পিতা। তিনি ঠিক শূন্য থেকে তরু করেছিলেন। সম্পদ বলতে তাঁর কিছুই ছিল না। ছিল শুধু জনগণ। জনগণের আস্তা। আর তা নিয়েই শুরু করেছিলেন পথচলা। আর সেই জনগণকেই দেশ গভার কাজে নেমে পভার আহ্বান জানালেন তিনি। বললেন, আজ থেকে আমার অনুরোধ, আজ থেকে আমার আদেশ, আজ থেকে আমার হুকুম ভাই হিসেবে, নেতা হিসেবে নয়, প্রধানমন্ত্রী হিসেবে নয়, প্রেসিভেন্ট হিসেবে নয়। আমি তোমাদের ভাই, তোমরা আমার ভাই। এ স্বাধীনতা আমার পূর্ণ হবে না যদি বাংলার মানুষ পেট ভরে ভাত না পায়, এ স্বাধীনতা আমার পূর্ণ হবে না যদি বাংলার মা-বোনেরা কাপড় না পায়, এ স্বাধীনতা আমার পূর্ণ হবে না যদি এদেশের যুবক যারা আছে তারা চাকরি না পায়। মুক্তিবাহিনী, ছাত্র সমাজ তোমাদের মোবারকবাদ জানাই তোমরা গেরিলা হয়েছো তোমরা রক্ত দিয়েছো, রক্ত বৃথা যাবে না, রক্ত বৃথা যায় নাই।

সত্যি-ই শহিদের রক্ত বৃথা যায়নি। বাংলাদেশ আজ বিশ্বে উন্নয়নের রোল মডেল। বাংলাদেশ স্বল্পোন্নত দেশ থেকে উন্নয়নশীল দেশে অন্তভাক্তর জন্য জ্যাতসংঘের চুড়ান্ত সুপারিশ অজন করেছে। যা সম্ভব হয়েছে কেবল তারহ কন্যা মাননায় প্রধানমন্ত্রা শেখ হাসিনার নেতৃত্বের কারণে। আর এর ভিত্তি স্বাধীনতার পর জাতির পিতা-ই গড়ে দিয়ে যান। 🛘

প্রতিবাদ করে বলেন, 'কোনো নেতা যদি অন্যায় কাজ করতে বলেন, তার প্রতিবাদ করা এবং তাঁকে বুঝিয়ে বলার অধিকার জনগণের আছে। বাংলা ভাষা ৫৬ শতাংশ লোকের মাতৃভাষা, পাকিস্তান গণতান্ত্রিক রাষ্ট্র, সংখ্যাগুরুদের দাবি মানতেই হবে। রাষ্ট্রভাষা বাংলা না হওয়া পর্যন্ত আমরা সংগ্রাম চালিয়ে যাব। তাতে যাই হোক না কেন, আমরা প্রস্তুত আছি।

শেখ মুজিবের বাবা চাইতেন তাঁর ছেলে আইন পড়ুক। কিন্তু যুবক শেখ মুজিবের তাতে তেমন একটা আগ্রহ ছিল না। বাবা তাঁকে এমনও বলেছিলেন, আইন পড়ার জন্য তিনি বিলেতেও যেতে পারেন। তাঁর ইচ্ছা ছেলে ব্যারিস্টার হবে। প্রয়োজনে তিনি জায়গা-জমি বিক্রি করতেও প্রস্তুত ছিলেন। শেখ মুজিব বাবাকে জানালেন, বিলেতে যাওয়ার চেয়ে মুসলিম লীগ নেতাদের বিরুদ্ধে আন্দোলন প্রতিবাদ করাটা তাঁর কাছে অনেক বেশি গুরুত্বপূর্ণ। তিনি আক্ষেপ করতেন, যে পাকিস্তানের জন্য তিনি অন্যদের সঙ্গে আন্দোলন করেছেন আর যেই পাকিস্তান পেয়েছেন দুটির মধ্যে অনেক তফাৎ। তাঁকে গ্রামের সাধারণ মানুষ যখন প্রশ্ন করতেন যে পাকিস্তানে তারা নির্যাতন আর অবিচারের স্বীকার হন, সেই পাকিস্তানের জন্য তিনি কেন আন্দোলন করেছিলেন, তখন তিনি বেশ বিচলিত হতেন। তিনি এও বুঝেছিলেন, কোনো মুসলিম লীগ নেতা পাকিস্তানের রাষ্ট্রভাষা বাংলা হোক তা চাইতেন না। তিনি আরও দেখলেন কীভাবে পশ্চিম পাকিস্তানের উন্নয়ন হচ্ছে এবং পূর্ব বাংলা অবহেলিত হচ্ছে। শেখ মুজিব সবসময় এটি উপলব্ধি করতেন কোনো আন্দোলন প্রতিবাদ করতে হলে প্রয়োজন একটি দক্ষ ও কার্যকর সংগঠন, যে কারণে তিনি ছাত্রলীগ প্রতিষ্ঠা করেছিলেন। কিন্তু এক পর্যায়ে ছাত্রলীগ খুবই মিয়মাণ হয়ে গিয়েছিল। তিনি গোপালগঞ্জ থেকে ঢাকায় ফিরে ছাত্রলীগকে আবার পুনর্গঠন করার দায়িত্ব নিলেন। ঢাকায় ছাত্রলীগের বার্ষিক সম্মেলন হলো শেখ মুজ্লিবের সভাপতিতে নতুন কমিটি হলো। সেই কাউন্সিলে তিনি একটি গুরুতুপূর্ণ ভাষণ দিয়ে বলেছিলেন, 'আজ থেকে আমি আর আপনাদের প্রতিষ্ঠানের সভ্য (এর আগে তিনি ছাত্রলীগের একজন সদস্য মাত্র ছিলেন) থাকব না। ছাত্রপ্রতিষ্ঠানের সঙ্গে জড়িত থাকার আর আমার কোনো অধিকার নাই। আমি আপনাদের কাছ থেকে বিদায় নিচ্ছি। কারণ আমি ছাত্র নই। এমন কথা এখন ভাবা যায়?

ছাত্ররাজনীতি থেকে অব্যাহতি নিয়ে শেখ মুজিব একটি রাজনৈতিক দল গঠনের দিকে নজর দেন। ১৯৪৯ সালের ২৩ জুন পূর্ব পাকিস্তান আওয়ামী মুসলিম লীগ প্রতিষ্ঠিত হয়। তরুণ শেখ মুজিবসহ অনেক ছাত্রনেতাই জড়িত ছিলেন। এতে টাঙ্গাইলের ছাত্রনেতা শামসূল হক বেশ সহায়তা করেন। একটি খসড়া ঘোষণাপত্র প্রস্তুত করা হয়। তাতে পূর্ব পাকিস্তানকে পূর্ণ আঞ্চলিক স্বায়ন্তশাসন দেওয়ার প্রস্তাব করা হয়। তথু দেশ রক্ষা, বৈদেশিক নীতি ও মুদ্রা কেন্দ্রের হাতে রাখার প্রস্তাব করা হয়। পরবর্তী সময় এই প্রস্তাবগুলোই ঐতিহাসিক ছয় দফার ভিত্তি রচনা করে। বলে রাখা ভালো আওয়ামী লীগ গঠন করার সময় শেখ মুজিব জেলে ছিলেন । জেল-জুলুমের মাধ্যমে পাকিস্তান সরকার সবসময় শেখ মুজিবের কণ্ঠ রুদ্ধ করতে চেয়েছিল। পাকিস্তানের ২৩ বছরের শাসনকালে বঙ্গবন্ধু ১৮বার জেলে গেছেন, প্রায় ১৩ বছর জেলে কাটিয়েছেন। মৃত্যুর মুখোমুখি হয়েছেন দুইবার (১৯৬৮ সালের আগরতলা ষড়যন্ত্র মামলা ও ১৯৭১ সালের পাকিস্তান ভেঙে বাংলাদেশ স্বাধীন

কাজের মানুষ শেখ মুজিব বুঝতে পারতেন কোন সময় কী কাজটা করতে হবে। তিনি ঠিকই বুঝেছিলেন, জনগণকে পাকিস্তানের শাসকগোষ্ঠীর বিরুদ্ধে এক করতে হলে তাদের সামনে শাসকদের কীর্ত্তিকলাপ তুলে ধরার কোনো বিকল্প নেই। তিনি সোহরাওয়ার্দীসহ আওয়ামী লীগের অন্য নেতাদের নিয়ে পূর্ব বাংলার বিভিন্ন এলাকায় সভা-সমাবেশের মাধ্যমে মানুষের কাছে পাকিস্তানি শাসকগোষ্ঠীর শোষণ-শাসনের কথা তুলে ধরতেন। শহীদ সোহরাওয়াদীর ওপর সাধারণ মানুষের আস্থা ছিল নিরক্কশ।

১৯৫৩ সাল নাগাদ দেশে একমাত্র রাজনৈতিক দল যা জনগণের দলে পরিণত হতে পেরেছিল, তা হচ্ছে আওয়ামী লীগ। এর অন্যতম কারণ ছিল, দলের সভাপতি মওলানা ভাসানী ও হোসেন শহীদ সোহরাওয়াদী জনগণের কাছে বেশ জনপ্রিয় ছিলেন। আর দলে শেখ মুজিব, শামসুল হক, মোল্লা জালালউদ্দিন, নইমউদ্দিন আহমেদ, খালেক নেওয়াজ খানের মতো একঝাঁক তরুণ নেতার সমাবেশ হয়েছিল। মওলানা ভাসানী আসামের পাকিস্তানে অন্তর্ভুক্তি প্রশ্নে গণভোটের সময় তাঁর ভূমিকার জন্য পূর্ব বাংলার মানুষের কাছে একটি পরিচিত ও জনপ্রিয় নাম হয়ে গিয়েছিলেন। ১৯৫৪ সালের নির্বাচন সামনে রেখে একটি যুক্তফুন্ট হয়েছিল, যেখানে আওয়ামী লীগ ছাড়াও ছিল কৃষক প্রজা পার্টি, নেজামে ইসলামী আর গণতন্ত্রী দল । নেতৃত্বে ছিলেন মওলানা ভাসানী, শেরেবাংলা এ কে ফজলুল হক ও হোসেন শহীদ সোহরাওয়াদী। ১৯৫৪ সালের নির্বাচনে যুজ্জুন্টের কাছে মুসলিম লীগের শোচনীয় পরাজয় ঘটেছিল। সেই নির্বাচনই ছিল ১৯৭০ সাল পর্যন্ত এক পাকিস্তানের প্রথম ও সর্বশেষ সাধারণ নির্বাচন। তবে নির্বাচন শেষে যুজ্জ্রন্ট এ কে ফজলুল হকের নেতৃত্বে যে সরকার গঠন করেছিল তা ছিল ক্ষর্ণস্থায়ী। এরপর তরু হলো নতুন মাত্রায় পাকিস্তানের ষড়যন্তের রাজনীতি। ১৯৫৮ সালে পাকিস্তানের একটি সিভিল সরকারকে উৎখাত করে দেশে সামরিক শাসনপর্ব শুরু হয়। সব রাজনৈতিক নেতাকে জেলে যেতে হয় আর নিষিদ্ধ হয় সব রাজনৈতিক দল ও তাদের কর্মকাণ্ড। সেনাশাসনে বেশি ক্ষতিগ্রস্ত হয় আওয়ামী লীগ। কিন্তু দলটির তৃণমূল কর্মীরা শত বাধা-বিপত্তির মধ্যেও দলটিকে টিকিয়ে রাখেন।

১৯৬৬ সালে শেখ মুজিব কর্তৃক ঘোষিত বাঙালির মুক্তির সনদ ছয় দফায় আইয়ুব খান পাকিস্তান ভাঙার একটি নীল নকশা আবিষ্কার করেন এবং কিছুদিন পরই শেখ মুজিবকে আটক করা হয়। তিনিসহ ৩৫ জন আওয়ামী লীগ নেতা, সামরিক-বেসামরিক আমলার বিরুদ্ধে একটি রষ্ট্রেদ্রোহ মামলা (আগরতলা ষড়যন্ত্র মামলা নামে খ্যাত) রুজ্জু করা হয়। সেই



মামলার শেষ পরিণতি ছিল মৃত্যুদন্ত। কিন্তু সারা দেশে আইয়ুব বিরোধী তুমুল ছাত্র আন্দোলনের (উনসন্তরের গণ-আন্দোলন) তৌড়ে আইয়ুব খানের পতন ঘটে এবং শেখ মুজিব বঙ্গবন্ধু হিসেবে বাংলার রাজনীতিতে আত্মপ্রকাশ করেন। ততদিনে তিনি আওয়ামী লীগের সভাপতি, আর তাজউদ্দীন আহমেদ

আইয়ুব খান ক্ষমতাচ্যুত হওয়ার আগে জেনারেল ইয়াহিয়া খানের কাছে ক্ষমতা হস্তান্তর করেন। ইয়াহিয়া খান ঘোষণা করেন, ১৯৭০ সালের ডিসেম্বর মাসে দেশে একটি সাধারণ নির্বাচন অনুষ্ঠিত হবে এবং নির্বাচিত গণপ্রতিনিধিরা পাকিস্তানের জন্য একটি সংবিধান রচনা করবেন। মওলানা ভাসানীসহ অন্য বামপন্থী দলগুলো এই সেনাশাসকের অধীনে ওই নির্বাচনে যাওয়ার বিরোধী ছিলেন। কিন্তু বঙ্গবন্ধু ঠিকই বুঝতে পেরেছিলেন, এই নির্বাচনই বদলে দিতে পারে পাকিস্তানের ইতিহাস আর উপমহাদেশের মানচিত্র। পূর্ব বাংলার ১৬৯টি আসনের মধ্যে আওয়ামী লীগ বিজয়ী হয় ১৬৭টি আসনে।

বাঙালি পাকিস্তান শাসন করছে, তাতো পশ্চিম পাকিস্তানের শাসকগোষ্ঠী মানতে পারে না। ১৯৭১ সালের ৩ মার্চে ঢাকায় অনুষ্ঠিতব্য জাতীয় সংসদ অধিবেশন নির্ধারিত ছিল। ১ তারিখ ইয়াহিয়া খান এক রেডিও ঘোষণার মাধ্যমে তা স্থগিত করে জিল্লাহর পাকিস্তানের কফিনে শেষ পেরেকটি ঠোকেন। সারা বিশ্বকে অবাক করে দিয়ে পূর্ব বাংলার সিভিল প্রশাসনের ভার বঙ্গবন্ধু শেখ মুজিবের হাতে চলে গিয়েছিল। ইয়াহিয়া খানের সংসদ অধিবেশন স্থগিতাদেশ ঘোষণার পর সারা বাংলা এক উত্তপ্ত আগ্নেয়গিরির মতো ফেটে পড়ে। ৭ই মার্চ রমনা রেসকোর্সের পড়ন্ত বেলায় বঙ্গবন্ধু ঘোষণা করেন, 'আমি প্রধানমন্ত্রিতু চাই না, আমি জনগণের অধিকার চাই'। শেষ করেন এই বলে, 'এবারের সংগ্রাম আমাদের মুক্তির সংগ্রাম, এবারের

৯ মাস রক্তক্ষয়ী মুক্তিযুদ্ধের মাধ্যমে ১৯৭১ সালের ১৬ ডিসেম্বর বাংলাদেশ পাকিস্তানি সৈন্যদের দখলমুক্ত হয়ে এক স্বাধীন দেশ হিসেবে আত্মপ্রকাশ করে। ১০ জানুয়ারি বঙ্গবন্ধু পাকিস্তান কারাগার থেকে স্বদেশে ফিরে আসেন। স্বাধীন বাংলাদেশে বঙ্গবন্ধু বেঁচে ছিলেন মাত্র সাড়ে তিন বছর। এই সাড়ে তিন বছরে তাঁর কীর্তি বাংগার ইতিহাসকে সমৃদ্ধ করেছে। তাঁকে করেছে অমর। তবে যে বিষয়টির ওপর তাঁর সার্বক্ষণিক দৃষ্টি ছিল সেটি হচ্ছে প্রশাসনকে দুনীতিমুক্ত করা। তিনি কখনো দুনীতিকে প্রশ্রয় দেননি। প্রয়োজনে তিনি দলের সংসদ সদস্যদের পদত্যাগ করতে বাধ্য করেছেন। আর সবচেয়ে বড়ো কথা হচ্ছে, তিনি রাষ্ট্রীয় ক্ষমতার চেয়ে দলকে বেশি শুরুতু দিয়েছেন। দলের সভাপতির পদ ছেড়ে দিয়ে দলকে শস্তিশালী করার দায়িতু দিয়েছিলেন কামারুজ্জামানের ওপর। বাংলার হাজার বছরের ইতিহাসে বঙ্গবন্ধু একজনই জন্মেছিলেন। আমরা তাঁকে বাঁচিয়ে রাখতে ব্যর্থ হয়েছি। তবে জন্ম জন্মান্তর ধরে যারা বাংলাদেশকে বিশ্বাস করে মুক্তিযুদ্ধের আদর্শ ধারণ করে, তাদের মাঝেই জাতির পিতা বঙ্গবদ্ধু শেখ মুজিব বেঁচে থাকবেন। বঙ্গবন্ধু ছিলেন এমন একজন নেতা যিনি যে কোনো স্থানে দাঁড়িয়ে ছুঁতে পারতেন ৫৬ হাজার বর্গ মাইলের ৩০ লাখ শহিদের রক্তে বিধৌত এই বাংলাদেশের যেকোনো স্থান যে কোনো সময়। জন্মদিনে তাঁকে আবারো বিন্ম্র শ্রদ্ধা। 🗅

Like him, many others are now switching from chicken to beef. Taking it as an opportunity, meat traders have increased the beef price by Tk 50 to Tk 750 per kg.

The price of mutton has also gone up to Tk 1,100 per kg from Tk 950 in the last one and a half months.

Sumoon Howlader, president of Bangladesh Poultry Association, said taking all related production and supply costs into consideration, the retail price of broiler chicken should not be more than Tk 220 per kg.

"A syndicate of some private companies is controlling the chicken market. It is also involved in price manipulation," he alleged.

Meanwhile, Agriculture Minister Muhammad Abdur Razzaque yesterday hinted that the prices of meat may remain high for several more months.

"The price of poultry won't come down soon. We will have to wait for at least six to seven months to buy chicken at lower prices," he said at a programme in the capital.

14th, Renu had come with the children to meet me. Will they allow them to meet me again so soon then? On the 15th, Renu had come to the jail gate to meet with Moni," Bangabandhu wrote.

"By the time I finished reading the newspapers it was 4 o'clock. I kept thinking -- perhaps there will be a visit after all ..."

And then half an hour later, he wrote, "It was 4:30pm by this time and realised that Renu and the children had not gotten permission to meet me today. Soon it was 5. But just then the head constable said, 'Come -- your wife and children are here!' I put on my clothes quickly and went towards the jail gate.

"My youngest daughter [Sheikh Rehana] and Russell were standing there with a garland of flowers in their hands. I put the garland around Russell's neck instead. He wouldn't wear it though -- he would rather that I wore it ...," the incarcerated Mujib further wrote.

"I took him along with me to the room. I kissed my children. I found out that the City Awami League had sent a huge cake for me. I had Russell cut it although I put a hand in the cutting too.

"Some of the cake was distributed among the people present at the jail gate. I gave instructions so that some pieces of the cake would be sent to my nephew Moni. I was never allowed to meet him, although we are imprisoned in the same jail!"

He kept writing that day.

"It was 6:00pm, and Renu and the children had to take their leave in a hurry. Russell understands the situation better now and doesn't want to take me back with him any longer. My youngest daughter feels very sad every time they have to leave me behind. I can tell as much by looking at her. I feel sad too but there is no way out! Renu is very tight-lipped and will never show her emotions," Mujib wrote, describing the pain of having to watch his family leave him behind in prison.

"I returned to my den. I went inside and they locked me in. They'll open the door again in the morning.'

Sheikh Mujib also noted with gratitude how small gestures by the

the garden, and morning greetings made his day.

He wrote, "In the morning, I woke up to see Nur-e-Alam. He is someone who is interned in Cell-20, which is close by. He had brought some flowers along with him. He said to me, 'My gift to you on your birthday!' I accepted his gift with thanks.

"Then it was Babu Chittaranjan Sutar's turn to give me a red rose and Babu Shudhangshu Bimal Datta's to offer me a white rose; the DPR prisoner Mr Emadullah also presented me with a red dahlia."

Memories of Sheikh Mujib's 52nd birthday in 1971 also showed how simple a man can be, even after he had become the unparalleled leader of the freedom-loving people.

March 17, 1971, was when the noncooperation movement of Bangalees had stepped into its 16th day.

Bangabandhu Sheikh Mujibur Rahman met the then Pakistan president Yahya Khan at the latter's residence for the second consecutive day to resolve the ongoing crisis, and the meeting went on for about an

According to a writing by veteran AL leader and the then political secretary of Bangabandhu, Tofail Ahmed, Sheikh Mujib returned to his home at Dhanmondi 32 afterwards to meet with foreign journalists.

One of them asked him about his expectations for his 52nd birthday. "Total freedom of the people,"

Bangabandhu replied. He added, "I don't observe my

birthday. I am not in the habit of cutting cakes or lighting candles.

"People of the country have no security at all. You are well aware of the situation they are in. They can die anytime at the will of others. I am one of these people; what difference does my birthday or my death make? My birthday and my death are all for the people, as I have dedicated my life to their betterment."

According to Tofail Ahmed, Bangabandhu always recited a line from Rabindranath Tagore's poem "Porichoy" whenever people greeted him on his birthday -- "Let my name be known as this, that I am one of

On March 17, 1920, Bangabandhu,

other inmates -- flowers picked from the architect of an independent Bangladesh, was born in Tungipara.

At the age of 14 in 1934, he was afflicted with the beriberi disease, and two years later, he developed glaucoma, for which he needed two eye surgeries.

Since then, he began to wear his signature black-rimmed glasses.

After a year-long break due to the illnesses, he resumed his education at Gopalganj Mission School in 1937.

In his autobiography Unfinished Memoirs", Sheikh Mujib wrote he was older than most of the boys in his class due to the year-long

Describing himself as a rowdy boy. he wrote about his schoolyard gang, who would get into fights with other boys. He also wrote about how he loved to play and sing.

That very boy went on to lead this nation to liberation.

Beginning his political career in 1939, Bangabandhu either led or played a central role in every single watershed moment for the country -- the Language Movement from 1948 to 1952, the abolition of Zamindari system from 1950 to 1954, the movement for demanding autonomy of East Bengal from 1954 to 1956, the anti-Ayub movement in 1964, the six-point demand movement in 1966, leading Awami League into a landslide victory in 1970, and finally the birth of Bangladesh in 1971.

He spent 13 of his 55 years in prison, sacrificing nearly a fourth of his life for the cause of liberating this country. He dedicated every ounce of his energy, and the entirety of his thoughts and emotions to one single dream -- the freedom of his people.

His struggle for the poor and the downtrodden made him not only an iconic leader but a legend that lives

All his struggle and dedication bore fruit when the nation achieved victory on December 16, 1971.

But before he could turn his dream of a "Sonar Bangla" into a reality, he along with most of his family members was brutally killed in the early hours of August 15, 1975, less than four years into independence.

Bangabandhu might not be here anymore but the legacy he created is.

EU lawmakers demand Tunisia free detained radio chief

The European Parliament yesterday decried Tunisian President Kais Saied's "authoritarian drift" and called for the immediate release of a detained prominent journalist.

Saied sacked the government and froze parliament in a 2021 power grab before imposing sweeping changes to the political system of the sole democracy to have emerged from the Arab Spring uprisings.

More than 20 political figures have been arrested in the North African country in recent weeks, including members the of the main opposition coalition.

EU lawmakers said in a non-binding resolution they are "deeply concerned about President Saied's authoritarian

drift and his instrumentalisation of Tunisia's dire socio-economic situation", a statement said. "MEPs call for an end to the

ongoing crackdown on civil society in the country," the parliament said. The legislators demanded the

immediate release of Noureddine Boutar, the director of Tunisia's largest independent radio station, saying he said had been arrested "on politically motivated grounds".

The European Parliament also called for the government to free "all others arbitrarily detained including journalists, judges, lawyers, political activists and trade unionists".

It urged the EU to cut support programmes to Tunisia's justice and interior ministries over the deterioration in human rights.

Keep up the pressure on Myanmar

Don't let it delay the repatriation of Rohingya any further

A 17-member delegation from Myanmar is in Bangladesh now to verify the identities of Rohingya refugees in Teknaf, with the first batch of refugees reportedly expected to be repatriated in a few months. While this indicates that pressure from the international community has been effective to some extent, it is essential that the community does not take its foot off the pedal until Myanmar authorities live up to their responsibility of creating a safe environment for the return of the refugees, and completely end the persecution campaign against the Rohingya. It is also important to remember that Myanmar has backtracked on most of its previous commitments. Therefore, there is no reason to take its words at face value unless there are substantial actions taken to back them.

The reason for the ongoing visit by the Myanmar delegation, according to Bangladeshi officials, is that there were some issues regarding the earlier verification process. So, the delegation is apparently meeting the Rohingya in person and verifying their names, villages, towns, and other information. Foreign ministry officials say that Myanmar has shown growing interest about the repatriation in recent times, and also arranged a trip for the ambassadors of Asean countries as well as Bangladesh, India, and China to the Rakhine State last week to show them the conditions there. While all this sounds positive, we cannot ignore the fact that there have been two failed attempts of repatriation since 2017, when around 750,000 Rohingyas fled a military crackdown in Rakhine. And on both occasions, it was because of Myanmar authorities.

The latest visit comes ahead of the International Court of Justice's (ICJ) planned hearing (scheduled for April 28) on the genocide case filed by The Gambia against Myanmar. And we sincerely hope that Myanmar's recent activities are not intended to somehow pull the wool over the court's eyes. However, that is not something that can be fully ruled out, as we have seen the Bangladeshi government appealing many times to the authorities in Myanmar to take steps for repatriation, only for it to be ignored. Moreover, we have seen Myanmar authorities delaying the repatriation process over and over again, using trivial excuses and arguments. In fact. every time there seemed to have been a breakthrough in the process, Myanmar found a way to throw a wrench into the

After hosting the Rohingya for more than five years, Bangladesh is now in a position where it cannot afford any more delays in repatriation. That is why the government must work with the international community to continue the pressure on Myanmar authorities to expedite the repatriation process. Given the speed at which Myanmar seems to be working currently, it might take a whole decade for all the Rohingya to return to Myanmar. That would be completely unacceptable. While we cannot forget the humanitarian aspect of things, which means that safe conditions must be ensured for the Rohingya to return, the Myanmar authorities must be pressured to fulfil such conditions and complete the repatriation process much faster.

A most unlawyerlike behaviour

Supreme Court lawyers engaging in violence a worrying sign for the country

We are alarmed to see the chaos and violence that took place on the Supreme Court premises during the two-day election of the Supreme Court Bar Association (SCBA). On Wednesday, the first day of voting, rival lawyers from BNP and Awami League engaged in arguments and scuffles which later escalated. At one point, police intervened, and attacked pro-BNP lawyers and even journalists covering the election, injuring at least 25 people. Due to the situation, voting started two hours late and without the participation of pro-BNP lawyers. Such incidents are unprecedented in the history of SCBA elections.

Reportedly, tension was rising between the two groups of lawyers after one senior lawyer, Mansurul Haque Chowdhury, whom both sides had accepted as convener of the election sub-committee, resigned citing "personal" reasons, just a day before the election. As a new convener took charge, pro-BNP lawyers took issue with it, and demanded that the election be held under someone accepted by both sides. But that did not happen. Voting ended on Thursday amid continued scuffles and chanting, with a little less than 50 percent of votes cast.

Such conduct from lawyers – that, too, on the premises of our apex court - is most "unlawyerlike" and objectionable. Those obscurantist elements that engaged in clashes may only be a segment of the legal fraternity, but they surely besmirched the good name of lawyers who have a rich history of fighting for pro-people and democratic causes in the country. If democratic practices are missing in institutions related to the apex court, what can we expect from other institutions? What signal does it give to the people about the state of our justice

Moreover, the way police entered the court premises and attacked pro-BNP lawyers and journalists is alarming. Noted Supreme Court lawyer ZI Khan Panna tells us that he has never seen police enter the court and attack people, not even during the military regime. Such behaviour is also extremely concerning ahead of the upcoming national election.

Reportedly, the DMP commissioner has regretted police attacks on journalists. That is not enough. The DMP must hold an investigation into the incident and punish those responsible as per the law. Police authorities should also explain whether police can enter SC premises without any prior permission and beat people

Unfortunately, this is not the first time that SCBA elections were marred by chaos. Last year, we saw how it took an unusually long time to even declare the results of the election. If this chaotic trend holds, we have every reason to worry about the future of the legal profession in Bangladesh. We urge the relevant authorities to treat this matter with due seriousness. As for the SCBA election, we think proper actions should be taken so that both the electoral process and the results are acceptable to everyone.

In the annals of the political struggles of Bangalees, March 17 shall forever occupy a special place as, on this day in 1920, Bangabandhu Sheikh Mujibur Rahman was born. Bangabandhu, which means "friend of Bengal," as he was fondly addressed, was indeed special because without him, it is rightly doubted if the advent of a sovereign Bangladesh could have been a reality. To understand the import of such a belief, one has to trace the history of our pre-1971 political struggle.

Even a dispassionate study of our political emancipation would clearly show that years of political mobilisation by Bangabandhu - particularly after February 1966 when the historic Six-Point Programme was presented

had made Bangalees conscious of their identity. In Bangladesh's case, national sovereignty was inculcated into the consciousness of the masses through a deliberate political process. This mass character of consciousnessbuilding provided the underlying strength to the nationalist movement. It also gave substance to the assertion of national sovereignty in March 1971 by Bangabandhu and the people of Bangladesh.

Bangabandhu, through an intense process of national consciousnessbuilding, equipped a people politically to take up arms and be prepared to shed their blood to defend their newly acquired sovereignty. Herein lies his greatness, because in March 1971 "a sense of Bangladesh's sovereign status took root and people became psychologically prepared to defend their sovereignty" (Rehman Sobhan, From Two Economies to Two Nations: My Journey to Bangladesh). When the Pakistan Army launched its attack on the people of Bangladesh on the night of March 25, 1971, the entire population rose up to resist it in the absence of any coordinated military direction.

In 1971, Bangabandhu transcended conventional political reckoning, and his charisma dominated the political campaign. He became a symbol in his own lifetime and personified Bangalee nationalism, "just as Nasser personified Arab nationalism or the Quaid

unchallenged spokesman of Bengal, and his voice was heard beyond Pakistan and within the international community. History chose him to lead Bengal's struggle for emancipation. "For the first time, since the Battle of Plassey, Bangalees awoke to the fact that they were ruling themselves through their freely elected representatives."

Bangladesh "owes a blood debt to the people who shed their blood for the liberation of (the country) and to the leader who played such a critical role in inculcating this sense of nationhood within the people." It is a tragedy that Bangabandhu, the symbol of our nationhood, was not only assassinated but also shamefully marginalised from our historical consciousness for 21 long

Bangabandhu's lifelong struggle was centred on establishing real democracy, as he believed that democracy expresses the long-suppressed desire of the Muslim nationalism." He became the people to govern themselves and to know if, in our political discourses, we Salute to the great patriarch.

Our secularism stands for harmony among members of all religions. Indeed, in the opening of the Koran, Allah is described as Rabbul Alameen, the Lord of all creation, and not Rabbul-Muslimin, the Lord only of Muslims. This is the spirit which underlines our secularism" (Kamal Hossain, Bangladesh: Quest for freedom and

The role of Big Tech and influencers amid conflicts

Meanwhile, Gigi Hadid pledged to donate her earnings from Fall 2022 shows to aid the war victims in Ukraine, as well as to continue to support those affected in Palestine. Vogue reposted Hadid's Instagram post. Angry comments about Hadid's "anti-Semitism" followed, and Vogue edited out Palestine from their post. Then came criticisms of censoring support for Palestine; Vogue amended their post to reflect Gigi Hadid's original

But Vogue isn't the only one doing a little bit of censoring. On February 28, 2022, an 11-year-old Palestinian girl was hit in the face with a stun grenade by Israeli forces. The footage went viral on social media. Both Instagram and Twitter flag posts containing this video as "potentially sensitive content" and YouTube age-restricts it. I would defend these platforms by saying these videos are very disturbing, but so are the footage from Ukraine. Videos of bloodied victims of the Russia-Ukraine war are accessible for anyone with an account on these platforms - no barriers to see their sufferings (and

there shouldn't be).

When footballer Mesut Ozil spoke out against the treatment of Uvghurs, Arsenal said it was his "opinion" and that they adhered to the principle of not involving itself in politics. But when Hector Bellerin tweeted against Boris Johnson, why did Arsenal conveniently ditch its principles?

When influencers show their support for Ukraine, they are not labelled anti-Russia or anti-Christian. However, whenever an influencer speaks out for Palestine, the replies to their posts are rife with "anti-Semite" accusations.

Some influencers are punished for taking the "wrong" stance in conflicts like when Arsenal was reprimanded for Ozil speaking out against the treatment of Uyghurs. Others may get their sponsorships or affiliations cancelled. Many influencers may cave in under the pressure of criticism and hate comments. Mark Ruffalo removed his post supporting Palestinians – not very Hulk of him. On the other hand, many refuse to back down, risking their

careers for what they believe in. The power celebrities hold cannot be underestimated. Fans of BTS, inspired by their idols, have initiated numerous charity drives. But there is a flip side. If a celebrity supports Russia, a country that is attacking another nation, many of the celebrity's fans may follow suit. They may change their mind about donating to Ukraine.

Just as powerful, or perhaps more so, are the brains behind Big Tech.

Meta allowed calls for violence against Russian soldiers in select countries on Facebook and Instagram in 2022. Posts like "death to Russian invaders" weren't a problem soon after the invasion of Ukraine - at least on Meta platforms. Reuters also reported that calls for the death of Vladimir Putin and Belarusian President Alexander Lukashenko were allowed in a limited number of countries. (Later, Meta reverted this decision, saying calls for death of a head of state are banned.)

While Putin obviously deserves reprimand, should social media and tech giants encourage violence?

YouTube said they were limiting reach on Russian media and were blocking access to Russian state media channels globally. Is this not censorship?

If Meta and YouTube could go against Russia because of the invasion and occupation of Ukraine, why did they not do the same against Israel for the invasion and occupation of Palestine?

Perhaps this bias can be explained by Big Tech's profit from war. According to a report by three American rights groups, the Department of Homeland Security and the Department of Defense have collectively spent at least \$44.5 billion on services from Amazon, Google, Microsoft, Facebook and Twitter. Tech giants helped America's conflicts through access to crucial databases, cloud computing services, drone technology, surveillance, and pushing narratives. Facebook ads helped government-owned platforms to promote stories on Islamic extremism.

If the reach that social media sites have is taken into account, we see

So whom a star advocates for affects how easily they can manipulate global perceptions. As of December 2021, Facebook had approximately 2.91 billion monthly active users. YouTube had 2.3 billion, followed by Instagram's 1.22 billion and Twitter's 330 million active users.

Consequently, it is unsurprising that hundreds of former US government officials are involved in key positions of Big Tech companies. Greg Anderson, who used to run psychological operations for Nato, is now Livestream Policy manager for Europe, Middle East and Africa for TikTok.Ben Renda, director of Trust and Safety at Google, used to be Nato's strategic planner and Information Manager. The West knows the power of the internet and has made sure to place their representatives strategically.

Soon after Ukraine's invasion, Russia blocked Twitter, Instagram, Facebook, and TikTok. Adam Mosseri, the head of Instagram, said this ban was "wrong" because this would cut off Russians from connecting with their loved ones.

Adam Mosseri is an influencer in his own right, boasting over 1.9 million followers on his Instagram. He did not, however, speak on the matter of how Meta allowed hate speech towards Russian soldiers. Of course, speaking against Meta's decision would be a blow to his career. This raises the question: how much risk should influencers take to stand up for what is right when it threatens their livelihood?

Both tech giants and influencers have the immense power to nudge public opinions in line with their own. Thus, they have a responsibility to ensure that their opinion is justified, fair and humane. Moreover, everyone should double-check any information they find online before propagating it. If one has the power to control information, they have the power to control the world.



Towards a genderresponsive criminal justice system

Law as an instrument of social change will have to be altered occasionally to deal with the changing social evils.

Gender-based violence against women creates a serious obstacle to achieving sustainable development. As stated in the UN Secretary-General's in-depth study on all forms of violence against women (2006): "violence prevents women from contributing to, and benefiting from, development by restricting their choices and limiting their ability to act, which ultimately affects the overall developmental activities of a State. So, all UN Member States, including Bangladesh, is under a clear obligation to prevent violence against women and girls so that they can participate with their full potential in economic, social, and political spheres.

The government of Bangladesh has undertaken a number of initiatives legal and institutional, to ensure a violence-free life for women. However, these initiatives have not been translated into concrete improvements in the lives of most women who remain marginalised, discriminated against, and at a high-risk of being subjected to violence.

The absence of effective legal protection, lack of political will, absence of awareness, absence of gender-sensitive attitude among duty bearers, and many other socio-legal factors are considered to be the responsible factors behind this heinous occurrence. But the existing legal set-up and its ineffective role remains the major concern in the matter of dealing with violence against women. There is a pressing demand to review the existing legislation not only to ensure equal access to justice for victims of violence but also to allow a woman to live her life without violence. The starting point in this regard should be sure that all acts of gender-based violence are effectively dealt with by law.

Stereotypical assumptions about gender roles, gender identities, and gender relations contribute to the continuance of gendered violence against women. Cultural stereotypes about the role of women and men that men are the ultimate decision makers, and they are superior to women in terms of intellect, strength, quality, etc. permit discrimination whether it is in the domestic sphere or in the public sector. In addition, these stereotypes find their ways in legislation while addressing certain offences, sometimes by sidestepping the offence or sometimes by maintaining ambiguity in defining the scope of the offence. Non-criminalising marital rape can be an example in this regard.

Unfortunately, even when conscious efforts are made to liberate legislation of these gender-biased stereotypes, some other balanced provisions often compromise these efforts. The Child Marriage Restraint Act, 2017 prohibits child marriage (under 18 years for a female child and under 21 years for a male child). However, the Act introduces a special provision, exceptionally allowing child or underage marriages, where a court rules that such marriage is in the 'best interest of the child.' That means the prevalent cultural stereotypes regarding the status of women are so dominant that laws on gender-based violence are yet to achieve a gender-sensitive approach towards women.

The gender-insensitive approach is evident in many prevalent provisions in present gender-based violence laws in Bangladesh, such as, there is no provision for providing

revisiting the existing legislation to make training for officers, who are responsible for handling the victims on their way to justice, though a gender-sensitive justice system highly demands so. Consequently, in every stage of access to justice, ranging from reporting the violent incident to the police station to undergoing an intimate medical examination in a crowded hospital, mostly by male doctors, they (victim) may face discrimination, and harassment causing "secondary victimisation". These stereotypes help perpetuate violence against women, and hence immediate action is needed to address them through appropriate

At the same time, the initiative must be coupled with the incorporation of gender-responsive provisions for better application of laws. A necessary prerequisite for the effective application of laws is that justice agents are gender sensitive and knowledgeable of human rights standards. In this regard, education, training, and awareness raising programmes are crucial.

It is recognised by the policymakers around the world that implementing fundamental, transformative reform is possible if law reforms actively promote equal rights for all. Hence, while designing and implementing laws, the voices, perspectives, and priorities of women and girls should be considered in ways that would ensure that the rights of women and girls are meaningfully protected, promoted, and implemented.

Can a company have both a 'Managing Director' and a 'Chief Executive Officer'?

It is customary for companies to have either a Managing Director (MD) or a Chief Executive Officer (CEO). But can a company have both MD and CEO posts hold by two separate individuals?

At the outset, the Companies Act, 1994 does not define, use or discuss the term "Chief Executive Officer". In practice, the terms "managing director" and "chief executive officer" are used interchangeably. Hence, the question arises as to whether the eligibility and functions of an MD and a CEO are the same. The consequential question that arises is whether in presence of an MD, a CEO can be appointed or vice versa. To address these questions, eligibility and functions of both these positions are to be examined. In this regard, as per section 2(m) of the Companies Act, 1994, a "managing director" is a director with powers of management entrusted to him by virtue of an agreement with the company, or of a resolution passed by the shareholders at their general meeting or by the board of directors. Hence, an MD occupies the dual capacity of being a director as well as an employee of the company. In contrast, a CEO is essentially a C-level executive, a member of senior leadership at the top of a company's corporate hierarchy. A CEO does not need to be a director of the board, he acts as a top employee of the company. So, the eligibility criteria of an MD and a CEO is distinct.



With regards to the functions, typically, a CEO has the responsibility to facilitate business and should also have a strategic vision to align the company, both internally and externally. He plays the role to guide the employees and the executive officers of a company, whereas an MD is the member of the Board with the power of managing hence described as a managing director. Despite the possibility of having some overlapping, the functions of a CEO and an MD are not necessarily the same or identical. As such, from a general point of view, there is no legal bar in appointing a CEO while having an MD so long as the roles and responsibilities of each person are defined. Having said that, if the company is a public limited company, the Corporate Governance

Code issued by the Bangladesh Securities and Exchange demands consideration. Section 4(a) of the Corporate Governance Code states, "The positions of the Chairperson of the Board and the Managing Director (MD) and/or Chief Executive Officer (CEO) of the company shall be filled by different individuals." Section 4(d) states, "The Board shall clearly define respective roles and responsibilities of the Chairperson and the Managing Director and/ or Chief Executive Officer". By using the expression "and/or" in between the terms "Managing Director" and "Chief Executive Officer", the Code essentially indicates that a public company may have both an MD and a CEO; and that if the positions are taken by different individuals, their roles and responsibilities need to be clearly defined.

In addition to the above, the articles of association of the company requires to be examined to identify, if there is any direct or implied restriction to appoint a

CEO in presence of an MD. To reiterate, subject to the provisions in the articles of association of a company, different individuals for both the positions of CEO and MD can be appointed. However, it is of importance that the roles of these individuals are clearly defined to avoid any potential major overlapping.

RIGHTS WATCH Human rights concern over the statelessness of Shamima Begum

With the quashing of the citizenship of the former ISIS bride, Shamima Begum; the legal dilemma regarding statelessness has resurged. Ms. Begum, one of three east London schoolgirls who travelled to Syria in 2015 to support the terrorist organisation, ISIS; was born in the UK to parents of Bangladeshi heritage.

Ms. Begum's appeal was quashed on February 23, 2022, by the UK Supreme Court. The appeal was against the then Home Secretary's removal of her British citizenship on February 19, 2019. So, the verdict has confirmed her being stateless which goes against the standard of human rights.

Under the British Nationality Act of 1981, one can be stripped of their citizenship for "seriously prejudicial act" that goes against the public

Now, the question is whether the verdict of the UK court violates Ms. Begum's human rights. To answer that, two pivotal points are to be

- Whether Ms. Begum is to be punished for her affiliations with the ISIS though she herself has not committed any offence according to official
- If Ms. Begum is to be punished, whether it requires the striking of her citizenship.

The United Nations has two major conventions on statelessness: the 1961 Convention on the Reduction of Statelessness and the 1954 Convention relating to the Status of Stateless Persons. The 1961 Convention is the leading instrument in setting the rules for the nonwithdrawal of citizenship to avoid statelessness. Whereas the 1954 Convention is significant as it has defined a "stateless person" as someone "who is not considered as a national by any State under the operation of its law." It aims at ensuring certain rights of a stateless person. Again article



1(2) has provided certain conditions under which a person would not be considered a stateless person; one of such conditions is that the person has committed a war crime, crime against peace or crime against humanity. The UK Court has not decided on Ms. Begum's committing any of the offences. She has served as a sex slave in the ISIS and regardless of it being a terrorist organisation, she has not been found of any criminal offence since she moved to Syria.

According to section 40(2) the British Nationality Act, 1981, 'The Secretary of State may by order deprive a person of a citizenship status if the Secretary of State is satisfied that deprivation is conducive to the public good.' The Act also mentions that any act being prejudicial to the UK's interest will lead to deprivation of citizenship.

The Court had failed to investigate the matter from the perspective of a teenager who may possibly have been the victim of trafficking and radical brainwashing. Ms. Begum's lawyers argued on the point that if her age during which Ms. Begum went to 'serve' the ISIS was taken into consideration, the verdict could have been different. She was just fifteen at the time, legally a minor. Even if her acts are considered juvenile, that does not validate her being struck out of her citizenship as she can be held legally liable for those actions. Apart from being an ISIS bride, official records do not show her committing any offence during her stay in home and abroad.

European Convention on Human Rights (ECHR) also imposes obligations concerning nationality. Certain case laws have also affirmed the protection granted under article 8 of the ECHR that nationality is part of one's social identity (Karrassev v Finland, 1999).

According to article 15 of the Universal Declaration of Human Rights, 1948, every person has a right to nationality. Ms. Begum had only the UK citizenship and because of her being stripped of it, she is currently stateless. So, the verdict has violated the provisions of the UDHR too.

So, the verdict of the UK Supreme Court remains another stern and unjust approach to the so called 'War on Terror', violating human

Abahani, Gazi notch big wins

Anamul Haque Bijoy continued from where he had left off in the Dhaka Premier League last season, hitting a ton in his very first game this season for his new side Abahani Limited during their resounding 124-run win over Brothers Union at the Sher-e-Bangla National Stadium in Mirpur vesterday.

Bijoy and out of favour national team T20I opener Mohammad Naim put on 157 for the opening stand to set up a big score of 372 for six.

Naim missed out on a ton, departing in the 26th over after a 74-ball 85 but Bijoy carried on and hit a 118-ball 123, laced with six fours and as many maximums. Bijov also starred in a 101-run stand with Afif Hossain before Mohor Sheikh bagged his scalp in the 40th over.

Afif's 47-ball 65 and Mosaddek's 27-ball 46 helped Abahani to a big total before bowlers contained Brothers to 258 for six despite a 116-ball 102 from skipper Mizanur Rahman and Myshukur Rahaman's

Gazi Group also notched a high score as they romped to a 128run victory against Mohammedan Sporting Club at Fatullah's Khan



Shaheb Osman Ali Stadium. After a fast start, Ravi Teja's 79-ball 66 along with fifties from Akbar Ali and Meherob Hasan propelled Gazi to 349 for 7. Khaled Ahmed bagged three for 75 for Mohammedan.

In reply, Soumya Sarkar, another who has fallen out of national team contention like Bijoy and Naim, was still finding form hard to come by. While Rony Talukdar, who got into the national team T20I setup in the England series, continued his form with a smashing 61-ball 80, hitting 12 fours and a six in chase of the big total, Soumya departed for 16. The left-hander's disappointment was apparent as he left his bat on the ground and sat in despair after a particularly low delivery from spinner Anamul Haque disturbed his woodwork.

While all-rounder Shakib Al Hasan was unavailable for Mohammedan, Mahmudullah Riyad, rested from England ODIs, hit 57-ball 58 but did not have much impact in chasing the big target as Mohammedan were bundled out for 221.

In the other game of the day, fifties from Sangeeth Malundu and Aminul Islam, and Farhad Reza's 36 helped Shinepukur Cricket Club chase down Rupganj Tigers' 216 for six in a fourwicket win at the BKSP ground three.



ODI side lacked T20 unit's 'dynamics'

Bangladesh had a lot of ambition going into the recently-concluded ODI series against England. Given their form at home and having secured a series win against India in their prior home series, there was a serious chance to thwart the world champions. But, as the ODI series showed, the game has been evolving and the Tigers were left with too many gaps to plug even in their strongest format.

On the other hand, T20Is have always been a thorn in Bangladesh's side and that a young crop would bring such vitality to record a 3-0 series sweep against the current T20I world champions was not exactly expected. Reporter Simon Burnton of The Guardian was in Bangladesh to cover both the white-ball series and he opined that the T20I side had a dynamic that was missing in the ODI set-up.

"The T20 side appeared to have a bit more in terms of team dynamics but I guess there are lots of variables that are hard to quantify. Liton Das, for example, was abysmal in the ODI series and got out for two ducks. But in the third T20I, he played quite a magnificent innings. I think England have a better side in ODIs, stronger batting, so there's been a less impressive opponent in the T20 series," Simon told The Daily Star during the third T20I at Mirpur.

In the first ODI, the Tigers put up a fight and pushed England but a Dawid Malan ton denied them before Jason Roy left his mark on the second ODI. The batting approach from the hosts in the

second ODI lacked conviction as no one, names responsible for fragile dynamics? bar Shakib Al Hasan, showed intent after a top-order collapse.

When it came to the T20Is, however, there was significant improvement in the batting approach compared to past T20 performances and the effort in fielding was a cut above the ODI unit. The squad also rallied around Shakib, who kept



England guessing throughout the T20Is. Was the ODI side more traditional?

"That's certainly what we are seeing," Simon said. "There is less energy. Lots of potential reasons for that.'

The likes of Mahmudullah Riyad and Mushfiqur Rahim have been mainstays of the middle-order in the ODI team, but with them already out of the T20 set-up, new batters are showing the way. Were older

"That's the key question isn't it? Younger batters coming into the T20 side played well and batting in all the matches has been excellent. There have been very few disappointing performances and Shanto has been the one throughout both series who looked really strong. Whether you lay the blame on the older players is difficult to say. But clearly there is talent coming through," Simon opined.

For Simon, the conditions were not conducive to going for more runs in ODIs, which ends up as an issue away from home on better batting surfaces.

"I think that's maybe the issue with playing in these conditions when there are often low-scoring matches and you defend low scores. It doesn't encourage a team to be as aggressive as they need to be to become a force on the global stage. Obviously, you want to win games against big names on the international stage. But what you end up with is a kind of team with two faces -- different as a prospect to face in home conditions than when away," he said.

Simon also watched both captains at work and when asked if Shakib was making a statement with his captaincy in terms of being more aggressive, he replied: "I think that's probably a fair comment. It's hard to judge over a short period and the England ODI side was stronger."

The England series has now made way for the Ireland series, slated to begin from March 18. With new faces like Rony Talukdar, Towhid Hridoy and the return of Yasir Ali to the ODI set-up, a change in dynamics is expected going forward.

Bangladesh get one foot in semis

Re-elected Infantino 'loves' his critics

Gianni Infantino has been re-elected as president of FIFA until 2027 after standing unopposed at the congress of world football's governing body

The 52-year-old Swiss lawyer, who succeeded the disgraced Sepp Blatter in 2016, was waved in for a third term by acclamation, just as he was four years ago, by delegates from the 211 member federations.

"To all those who love me, and I know there are so many, and also those who hate me, I know there are a few: I love you all," Infantino told delegates in the Rwandan capital, where the voting system did not register the number of dissident voices.

While FIFA statutes currently limit a president to a maximum three four-year terms, Infantino has already prepared the ground to stay until 2031, declaring in December that his first three years at the helm did not count as a full term. His re-election followed a long speech in which

he triumphantly listed his achievements since taking office, alternating smoothly between English, French, Spanish and German. "There is a lot to be looking forward to,"

Infantino said as he turned thoughts to the next four years and declared the 2026 World Cup, the first edition to be enlarged to 48 teams, will be "the most inclusive World Cup ever".

FIFA announced on Tuesday that the tournament in North America will feature 104 matches, a huge increase from the 64 at the most recent World Cup, as it will start with 12 groups of four teams.

The upcoming Women's World Cup in Australia and New Zealand later this year will be the first to feature 32 teams, up from 24 at the last edition in

It will also see overall prize money for participating teams increased to \$150 million, up sharply from \$50 million in 2019 and a huge rise on the \$15 million contributions in 2015.

Infantino has also announced projected income of \$11 billion in the four years to 2026, compared to \$7.5 billion in the last four-year cycle ending in

'Napoli will keep on dreaming'

Victor Osimhen says Napoli are dreaming of Champions League glory after his brace shot the Serie A leaders to a 3-0 win over Eintracht Frankfurt and into the quarterfinals for the first Europe. time in their history on Wednesday.

With Napoli confirming their maiden Champions League quarters, it marks the first time in 17 years that three Serie A sides -- also AC Milan and Inter Milan -- have made it to the last eight of the competition.

Nigeria striker Osimhen struck either side of half-time to ensure no slip-ups in Naples and help his team secure a straightforward, and deserved, 5-0 aggregate win. Piotr Zielinski added Napoli's third from the

penalty spot on a perfect night for southern Italy's biggest club, who Osimhen believes can go all the way.

"It's amazing to make history with this win,"

said Osimhen to Amazon Prime. "We will keep on dreaming, we have the squad to do so (win the Champions League). I think we are on the right path. We have a great coach. We will see what the future holds for us, I think we have a good chance.'

Luciano Spalletti's side are close to securing their first Serie A title in over three decades and an already remarkable season got even better with a place in Friday's draw for the last eight of Europe's top club competition.

They have been powered to an almost certain domestic triumph and a deep run in Europe by the red-hot Osimhen, who has now netted 23 times in all competitions for possibly the

continent's most exciting team.

However Spalletti was less bullish about Napoli's chances than Osimhen, replying with a curt "no" when asked if he was flattered by Pep Guardiola saying his side were the best in

Police yet to file case despite court order

Directive came after 3 women detainees submitted injury note

Even after a Barishal court on March 12 ordered that a case be filed against Babuganj police for torturing three women in custody, police are yet to record one.

Judicial Magistrate Md Nurul Amin passed the order that said the case must be filed within 24 hours.

After being detained for "playing loud music", the three women, Akashi Begum, Rashida and Mala Begum were tortured in police custody by officials of Babuganj Police Station on March 3.

On March 3, Babuganj police received a public nuisance complaint from the residents of Dehergati village saying there was a picnic in the locality, where loud music was being played late into the evening.

The police intervened and tried to confiscate the sound system, leading the party-goers to retaliate.

In a case filed by police, they alleged that the picnic attendees attacked and obstructed them, and injured a sub-inspector and some others, SI Hannan, of the police station and investigation officer of the case, told this SEE PAGE 10 COL 1

Faridpur families sink deeper into despair

No news yet on 11 missing youths

At least 11 young men from Faridpur who were believed to be onboard the recently capsized boat in the Mediterranean Sea remained missing as of yesterday.

Meanwhile, with each passing day, their family members back home sank deeper into despair without any news about the youths.

Thirty people feared to have drowned after the boat capsized in Takukdar, said, "Murad and his men bad weather on Sunday. A total of 17 lied to us. They said they would send others were rescued in the shipwreck incident and brought ashore by the Italian authorities on Monday, Italy's coast guard told Reuters.

The missing youths are Al Amin Matubbar, 20, Mahfuz Mollah, 22, Nazmul Mollah, 23, and Akramul Bapari, 27, of Krishnanagar village; Sawpan Fakir, 27, son of Ishak Fakir of Basgari village; Shamim Kazi, 21, son of Seken Kazi, Bipul Matubbar, 25, son of Sorowar Matubbar, and Biltu Sheikh. 25, son of Malek Sheikh of Sankarpasha village; Miran Sheikh, 22, son of Soleman Sheikh and Tuhin Sheikh, 20, son of Isdrish Sheikh of Shrigal village; and Shaown Takukdar, 22, son of Kashem Talukdar of Naruyahati village.

The youths, from Dangi union in the district's Nagarkanda upazila, were headed to Italy from Libya.

All of them went abroad illegally through Murad Fakir, a member of a human trafficking gang, said officials of local administration.

Topu Raihan, a local journalist,

said, "A total of 12 youths from the Dangi union were on that boat. Of them, four were from my village Shankarpasha. One of them, Mehedy Hasan, was rescued. He sent a message to his family saying that the three others could not make it to the shore.'

Soleman Sheikh, father of Miran Sheikh, said, "I want my son back. We are losing sleep as we're worried sick

Kashem Talukdar, father of Shaown my son on a ship but they sent them on a small boat.'

Bulbul Sardar, former chairman of Dangi union parishad, told The Daily Star, "It has been confirmed so far that 11 youths of Dangi union are missing. Their family members are in extreme anxiety."

The youths went abroad illegally on a contract of Tk 8 lakh per person through Murad Fakir of Krishnanagar village, he said.

Kazi Abul Kalam, chairman of Dangi union parishad, said, "Murad is a human trafficker. He sent at least 200 youths abroad illegally and earned a lot of money."

According to villagers, Murad has been involved in human trafficking with the help of several others in the Miraj Hossain, officer-in-charge of

Nagarkanda Police Station, said, "No one has filed a complaint in this regard so far. If a case is filed, the matter will be investigated."

HAJJ PACKAGE Ministry asks Biman to reduce airfare Hajj registration time extended again
