owns two houses worth Tk 15 20 crore in Moulvibazar town, two poultry farms and a fish farm on 20 acres of land, a brick kiln and several lorries. His children live abroad.

A lawyer wishing anonymity said there have been speculations that sometimes investigators give flawed charge sheets against criminals in exchange for bribe.

Asked about the discrepancies between what is mentioned in the charge sheet and the ex-DB official's claim, Sub-Inspector Shahim Ahmed of DB's Tejgaon zonal team and the IO of the case, suggested taking comments from Md Shafiqul Islam, additional deputy commissioner of Tejgaon division DB.

Contacted, Shafiqul said the IO prepared the charge sheet based on the information he gathered during investigation of the particular case.

However, he said, it was mentioned there that Shahed was also accused in 22 other cases, and was arrested in the case following information given by other arrested accused.

Shafiqul added that in the investigation of another case filed with Tejgaon Industrial Area Police Station over the theft of 11,000 pieces of garments items, his unit found Shahed's direct role as the mastermind, which will be mentioned in the soon-to-be-submitted charge sheet.

Rab again arrested Shahed on February 3 this year and said that from 2004 till 2018, the Sylhet native led a gang and was personally involved in the thefts.

He then started controlling the racket from behind the scenes and received the maximum share from the sale of the stolen goods.

"Shahed has been orchestrating the RMG thefts for over two decades

and now commands a racket of 40-50 members," Khandaker Al Moin, Rab's legal and media wing director, told a press briefing on February 4.

Police and Rab officials said there are 10-12 such gangs that have been involved in stealing 30-40 percent of the products from almost all cartons of readymade garments, mainly from major consignments, being carried to Chattogram port for shipment.

As the cases are filed on charges of "regular theft", which is a bailable offence with a maximum punishment of only three years in jail, the criminals secure bail easily, legal experts said.

The law enforcement officials said almost all of the gang leaders and members were arrested several times earlier, but they secured bail within some days of their arrest and then got back to the crime, putting garments exporters at the risk of losing their reputation along with foreign buyers.

harassment, threats and attacks on human rights defenders, journalists and the political opposition," it said.

"The draconian Digital Security Act continued to be used to target journalists and critics," it added, pointing that journalist Rozina Islam is still facing charges under the Official Secrets Act for exposing corruption.

"In 2022, the Bangladesh authorities coerced and intimidated families of victims of enforced disappearances to silence them and targeted families of journalists and activists in exile. They also vilified leading human rights group Odhikar and arbitrarily revoked its registration."

The report added, "The police have also cracked down on protests and there have been allegations of

torture, ill-treatment and enforced disappearances committed by the security forces, including the Rapid Action Battalion, an elite anti-terrorism unit."

There has also been a sustained attack on the opposition in the lead-up to the 2024 elections, said Civicus.

The rights body recommended that the government stop using excessive force against peaceful protesters, stop preempting and preventing protests and allow the freedom of peaceful assembly.

They also urged that the government "repeal any legislation that criminalises expressions based on vague concepts such as 'fake news' or disinformation, as such laws are not compatible with the requirements of legality and proportionality."

Hossain Zillur Rahman, executive chairman of Power and Participation Research Centre, said Zafrullah wanted to build a just society, and reflection of his dream can be found in his work.

Tapan Chowdhury, managing director of Square Pharmaceuticals, said the people of Bangladesh will benefit from his works for years to come.

In his speech, Zafrullah said he wanted to be a banker when he was young, but his mother inspired him to be a doctor. "Now I can say my mother showed me the right way."

He then said ensuring the

people's right to vote is imperative. The political parties should hold dialogues, and such events can take place publicly.

He also said the ruling party leaders must change their stance of criticising Nobel Laureate Prof Muhammad Yunus. It is also unjust that BNP Chairperson Khaleda Zia has not been granted bail.

Samakal Editor Mozammel Hossain said Zafrullah not only played a role in defining what should be a people-oriented healthcare system but also demonstrated it by creating instances.

lawyers said.

The case has been brought by the Election Commission of Pakistan which has accused Khan of not declaring gifts received during his time as premier, or the profit made from selling them.

Pakistan's courts are often used to tie up lawmakers in lengthy proceedings that rights monitors criticise for stifling political opposition.

Khan claims authorities want to throw him in jail so he is unable to campaign for upcoming elections.

Some 4,000 security officials including elite police commandos, anti-terrorism squads and paramilitary rangers have been deployed around Islamabad with hospitals put on high alert.

Police meanwhile raided his house in a plush Lahore neighbourhood after blocking nearby roads and suspending mobile services in the area.

As the political drama unfolds, Pakistan is in the grip of a stark economic downturn, risking default if help cannot be secured from the International Monetary Fund.

The security situation is also deteriorating with a spate of deadly attacks on police, linked to the Pakistan Taliban.

Last year Khan was shot in the leg during a political rally, an assassination bid he blamed on Prime Minister Shehbaz Sharif.

detailed account of the government's corruption, the BNP leader said, "The corruption of the Awami League is the epicentre of today's problems. It is not that we are saying it... Rather, the Economist reported on this issue a few days back."

Fakhruul alleged that the government has destroyed all the democratic institutions of the country and turned it into a failed state.

"To stop corruption, there is no alternative of ousting the government."

The BNP leader said that they along with the other parties and people of the country would force the current regime to quit and hold the next polls under a caretaker government by dissolving the parliament.

"An elected parliament and a government of elected representatives will be formed through that election."

Fakhruul called upon party leaders and activists to get ready to intensify their ongoing movement.

"The government which has been in power by force without elections by using the state machinery must be forced to quit."

Stating that 17 BNP leaders and activists have lost their lives in the ongoing anti-government movement from August 22 last year, he said, there is no alternative for the BNP to make

the struggle a success to honour the sacrifices of the slain partymen.

The BNP's Dhaka south and north city units arranged the rally in front of the party's Nayapaltan central office to press home their 10-point demand, including holding the next general election under a non-party caretaker government.

The programme was also meant for registering the opposition parties' protest against the "all-pervasive corruption by the Awami League government, rise in the prices of power, gas and essential items, and mounting pressure on the government to release BNP Chairperson Khaleda Zia without any condition, essentially to drop the 'false' cases against her".

As part of a programme of the simultaneous movement, the BNP also arranged rallies in all other metropolitan cities across the country.

Apart from BNP, Ganotantra Mancha, Jatiyatabadi Samamona Jote, Gonoforum and People's Party, Jatiyatabadi Samamona Jote, Peshajibi Ganatantrik Jote, 12-party alliance, Bam Ganatantrik Oikya and LDP held separate rallies from in different areas of the capital.

Meanwhile, BNP leaders addressing a protest rally in Chattogram slammed the government's policymakers for what they said enacting laws for capacity charges making room for

power plants' owners.

BNP's standing committee member Amir Khasru Mahmud Chowdhury said, "Tk 90,000 crore has been looted from public exchequer. To save the corrupted thieves from legal battles in future, the government has also enacted laws so that no one takes action against them. In the power sector, those who get a license for generating power, all are the AL men." Chattogram city unit BNP organised the one and half hour rally in front of BNP's party office Nasiman Bhaban in Kazir Dewri area. Leaders and party workers with banners and posters gathered at the rally spot with a sporadic procession.

another group was in charge of internal communication, claimed DB.

These two groups recruited notorious robbers from different districts and formed a team, the DB official said, adding that one of them was accused in at least 27 cases.

The incident took place in Turag area around 7:15am on March 9 when officials of Money Plant, the firm hired for transporting cash to DBBL ATMs, were heading towards Savar EPZ in a microbus from Mirpur DOHS, with Tk 11.25 crore in four trunks.
