Everything was wrong with the bus

19 lives lost as the vehicle veers off Dhaka-Bhanga road; its registration, route permit suspended last November

The bus that went off the Dhaka-Bhanga expressway and crashed killing 19 people yesterday should have been taken off the roads four months ago when the authorities suspended its permits following a fatal crash.

The fitness certificate of the Emad Paribahan bus also expired on January 18. Yet, the owner of the transport kept it on the road.

"All kinds of approval -- registration and route permit -- of the bus was suspended in November last year as a punishment following a crash

was suspended in November last year as a punishment following a crash involving the bus," said Bangladesh Road Transport Authority (BRTA) Chairman Nur Mohammad Mazumder yesterday.

"But they kept the bus in service violating the suspension. We are now

going to revoke the registration and a case will be filed against its owner," he told The Daily Star.

Yesterday's crash again exposed the serious lack of enforcement of rules

by government agencies, including the BRTA and the Highway Police.

around 4:00am yesterday and crashed in Kutubpur area of Madaripur's Shibchar upazila around 7:30am.

The driver and the bus conductor were among the dead. At least 25

passengers were wounded.

This is the deadliest crash since the expressway was inaugurated three

years ago.

The bus was either speeding, or its front tyre burst at speed, or the

driver dozed off, Madaripur Superintendent of Police Md Masud Alam told The Daily Star yesterday.

Taimur Islam, officer-in-charge of Bhanga Highway Police Station, who rushed to the spot after the crash, said, "We suspect the bus was speeding

rushed to the spot after the crash, said, "We suspect the bus was speeding and the driver could not control the bus after one of its tyres burst.

"The exact cause would be revealed after investigation," he told

The Daily Star, adding that speeding is rampant on the expressway, particularly in the area where the bus crashed.

The highway police know it well that early mornings are risky hours.

The highway police know it well that early mornings are risky hours and they should strengthen law enforcement at that time, said transport expert Prof Shamsul Hoque, adding, "As drivers get away with speeding, they keep doing it."

FY24 BUDGET Focus on inflation, macro stability Economists tell Kamal in

pre-budget session

Economists yesterday stressed on addressing the persistently high inflation, macroeconomic stability and low revenue base in the pre-budget session for the upcoming fiscal year with the finance

The virtual session was the first in the series for Finance Minister AHM Mustafa Kamal before he sits down to finalise the budget for fiscal 2023-24, the last budget for the current Awami League government's five-year term.

At the session, finance ministry officials did a presentation on which recommendations of the economists did they accommodate in this year's budget and their impact.

The International Monetary Fund's timebound conditions for the \$4.7 billion loan, the persistently elevated inflation and the upcoming polls are weighing heavy on the finance ministry's mind as it does its computations for the forthcoming budget. The next fiscal year's budget is likely to be Tk 750,165 crore,

about 10.6 percent higher than this year's.

But economists said the budget falls short of the requirement, The Daily Star has learnt from officials informed with the contents

"The budget will be extremely challenging to fund, realistically," said Ahsan H Mansur, executive director of the Policy Research Institute of Bangladesh.

For funding, the government has become central bank-dependent, which is not right as it is inflationary.

The government has to come out of this practice as inflation will get worse otherwise.

In the first eight months of the fiscal year, inflation averaged 8.74

percent, way above the budgetary target of 5.6 percent, according to data from the Bangladesh Bureau of Statistics.

"Besides, the Bangladesh Bank is printing money through the refinance packages — which a parallel budget. How you are going to
