# A mockery at the cost of life and limb

Most vehicles involved in recent major and sensational road crashes did not have the required documents, including valid fitness certificates, or their drivers were without a valid licence.

Experts and road safety campaigners say that for years such vehicles and drivers have been on the roads because the system of monitoring, enforcement, and issuance of papers is not working.

Vehicles without documents and drivers without licences stay on the road bribing a section of crooked law enforcers, BRTA officials, and politically connected people, they said, adding that this creates anarchy on the roads and results in increasing numbers of crashes.

They said many transport owners and workers find valid documents from the Bangladesh Road Transport Authority (BRTA) to be unnecessary as they can easily run their vehicles paying bribes.

New vehicle registration is rising every year but vehicles getting fitness clearance has dropped to a seven-year low in the last fiscal year. About 5.64 lakh vehicles got their fitness clearance in the last fiscal

year, the lowest number since 2014-15 fiscal year, according to the BRTA. DON'T BLAME THE ROAD -- PAGE 3

# 17 more lives lost on roads

### 2 trucks fall into gorge in Bandarban; bus plunges into ditch in Pirojpur

At least six people were killed and 11 others injured when a truck carrying people rearended another truck and the two vehicles fell into a gorge in Bandarban's Ruma

The crash happened around 1:30pm when the two trucks were descending a steep incline in Boga Lake area, said Alamgir Hossain, officer-in-charge of Ruma

Locals and police said the trucks were coming from Thaikkyong Para area of Remakri Prangsa union.

# **Pro-BNP** lawyers stage demo for fresh SCBA polls

#### **AL-backed lawyers** hold 'peace meeting'

Pro-BNP staged lawvers demonstrations on the Supreme Court premises yesterday demanding a date be set for holding fresh elections to the Supreme Court Bar Association under an acceptable election conducting sub-committee.

Around 300 lawyers under the banner of Bangladesh Jatiyotabadi Ainjibi Forum (BJAF) gathered at the SCBA office around 12:30pm and brought out a procession. They chanted slogans against the police attack on lawyers during the SCBA election on March 15, said witnesses.

The procession, led by BJAF President AJ Mohammad Ali and Secretary General Kayser Kamal, marched towards the Kadam Foara near the Jatiya Press Club. The lawyers staged a sit-in there for around 15 minutes.

SCBA president candidate AM Mahbub Uddin Khokon and secretary candidate Md Ruhul Quddus Kazal, BJAF leaders Gazi Kamrul Islam Sajal and Masud Ahmed Talukder, among others, joined the protest.

They also demanded resignation of Law Minister Anisul Huq and Attorney General AM Amin Üddin alleging that the minister and attorney general instructed the law enforcers to assault the lawyers.

The pro-BNP lawyers said their movement would continue until their demands are met. A number of pro-BNP lawyers from Dhaka Bar Association took part in the demonstration.

Meanwhile, in an apparent counter move, some Awami League-backed lawyers held a "peace meeting" in front of the SCBA president's office room yesterday protesting "snatching of ballots and vandalising of furniture by pro-BNP lawyers" on the SCBA premises during the March 15 election.

# Humanity on 'thin ice'

### Says Guterres as UN climate report gives stark warning

UN Secretary General Antonio Guterres yesterday called on wealthy countries to move up their goals of achieving carbon neutrality as close as possible to 2040, mostly from 2050

now, in order to "defuse the climate time bomb." Introducing

capstone report by the Intergovernmental Panel on Climate Change on the impacts and trajectory of global warming, Guterres delivered a blunt assessment of the challenge to prevent climate catastrophe.

is melting fast," the United Nations chief said in a video message as the IPCC experts group issued its latest report, which he

likened to "a survival guide for humanity." Guterres said the world still has time to

limit average temperature increases to 1.5 degrees Celsius (2.7 degrees Fahrenheit) compared to pre-industrial times but this requires "a quantum leap in climate action" by all countries

in all sectors. "It starts with parties immediately hitting the fast-forward button on

their net zero deadlines," Guterres said, but he acknowledged countries have different levels of responsibility and ability to change course.

Rich countries should commit "Humanity is on thin ice – and that ice to achieving carbon neutrality as close as possible to 2040, he said, "the limit they should all aim to respect."

As things stand now most rich

countries have set their goal at 2050 but some are more ambitious, like Finland (2035), or Germany and Sweden (2045). Leaders in emerging economies must

commit to reaching net zero as close as possible to 2050, he said without naming any specific nation. Major countries in this category have set more distant goals like China (2060) and India (2070).

Guterres, who will hold a climate action summit in September, again stressed the role of the Group of 20 -- the world's largest economies and Europe -- which together are responsible for 80 percent of global greenhouse gas emissions.

"This is the moment for all G20 members to come together in a joint effort, pooling their resources and scientific capacities as well as their proven and affordable technologies through the public and private sectors to make carbon neutrality a reality by 2050," Guterres said.

## Elderly man dies after being hit by train

An octogenarian man was killed after he was hit by a train in Panchbibi upazila of Joypurhat on Sunday night.

The deceased Mostak Ahmed, 80, was a tailor by profession.

Panchbibi Police Station OC Jahidul Haq, said the intercity Simanto Express, that runs on the Chilahati-Khulna route, hit him when he was crossing the rail tracks at the rail gate area of Panchbibi municipality area on Sunday night, leaving him dead on the spot.

Police later handed over the body to the family members without autopsy upon their request.

### **MARCH 19, 2023**

A bus goes off the Dhaka-Bhanga expressway and crashes killing 19 people in Shibchar upazila of Madaripur. The BRTA in November suspended its route permit following another fatal crash. Its fitness certificate expired in January.

### **SEPTEMBER 5, 2022**

The two buses collided head-on in Rangpur leaving at least eight dead and over 50 injured. None of the buses had route permits. One had a fitness certificate that expired 11 years ago.

### **JULY 16, 2022**

A truck in Mymensingh's Trishal upazila mowed down three people, including a pregnant woman who gave birth on the spot. The truck had no fitness clearance, and tax token. Driver had no valid licence. The truck got its fitness clearance while in police impound.

#### **JUNE 5, 2022** A bus went across the central

reservation of Dhaka-Aricha highway in Savar and hit an oncoming staff bus that left six people, including four scientific officers of BAEC, dead. The annual fitness certificate of the bus was last renewed in 2014 and the annual taxes were last paid in 2015.

### **FEBRUARY 8, 2022**

A pick-up ran over and killed six brothers on Chattogram-Cox's Bazar highway. Its fitness clearance, route permit and tax token expired three years ago.

#### **NOVEMBER 29, 2021** A bus runs over and kills SSC examinee

Mainuddin Islam in Rampura. It had no valid route permit or tax token.

#### **NOVEMBER 24, 2021** A DSCC garbage truck runs over and

kills Notre Dame College student Nayeem. A former cleaner of DSCC with no licence was behind the steering wheel.

### **MARCH 19, 2019**

A bus runs over and kills BUP student Abrar triggering a student movement. The conductor with no licence was at the steering wheel.

### **JULY 29, 2018**

Two buses racing ploughs into people waiting for buses. Two students of Shaheed Ramiz Uddin Cantonment College were run over and killed while nine others were injured. Drivers of both buses did not have the licence to drive heavy vehicles.

On owners running buses without papers, he said the association does not support this. It is not possible for the association to monitor over 5.5 lakh buses and trucks, he told The Daily Star yesterday.

A top BRTA official, wishing anonymity, said if an owner or a driver can run the vehicles paying (law enforcers) money, then why will they go to the BRTA for the papers?

Contacted, BRTA Chairman Nur Mohammad Mazumder said only seven magistrates run BRTA mobile courts in Dhaka and Chattogram cities. "Is it possible for them to check all vehicles?

"If all stakeholders do not respect the law, then it becomes very difficult to enforce and bring discipline," he told The Daily Star yesterday.

He said they take action when specific allegations are brought against the BRTA officials.

Highway Additional police Inspector General Md Shahabuddin Khan told this newspaper that they prosecute errant vehicles and drivers, and have fined 1.41 lakh vehicles and drivers Tk 40 crore last year.

He said they also take other measures and hold meetings with stakeholders to increase awareness. "What we observed is that the owners and workers are not serious enough about road safety.'

On law enforcers taking money from errant vehicle owners and drivers, he said they probe each and every specific allegation brought against their members.

# 17 more lives lost on roads

Modernisation and amendment of the customs act, value-added tax (VAT) law and income tax ordinance are needed along the lines of the World Trade Organisation's agreement on trade facilitation.

The decision should be taken in consultation with the stakeholders concerned to make those laws to the global standards, Jashim Uddin added.

The businesses also requested the government to impose duty and tax on the release of exported and imported goods following the best standards of the WTO and World Customs Organisation.

# Quota not met after 4 deadline extensions

Even after extending the registration deadline four times, the quota for sending 1.27 lakh Bangladeshis for hajj is still to be met, prompting hajj agencies to fear losses. The "final deadline" for registration

The agency leaders have pointed to the high cost to perform hajj this year as the reason behind fewer registrations.

According to officials at the capital's Ashkona Hajj Camp, as of yesterday, around 1.12 lakh people have registered. Of the total, 9,749 did so under the government's hajj management and 1,02,759 under private management.

According to an agreement between Saudi Arabia and Bangladesh, 1.27 lakh Bangladeshis will be able to perform hajj this year.

Due to the inadequate response, the government on February 22 first extended the deadline till February 28 and then till

Even after that, authorities did not hit the quota, and so, on March 7, the religious affairs ministry extended the deadline till March 16.

Even after that deadline, 1,08,909 registered. Without finding any alternative, on March 16, the government extended the deadline for the "last time" till March 21.

Contacted, Abdus Salam Aref, general secretary of Association of Travel Agents of Bangladesh (ATAB), said although the government is saying that 1.12 lakh have registered, around 5 percent of registered hajis will not go.

Leaders of Hajj Agencies Association of Bangladesh (HAAB) and ATAB fear that this year's quota will not be met, due to the high cost of hajj packages.

Several officials at Ashkona Hajj Camp said that the quota may be unmet by several thousands.

A Bangladeshi will have to spend around Tk 7 lakh to perform hajj under private and government management this year, Tk 1.61 lakh more than the previous year's amount.

"Our business will be seriously affected if we cannot fulfil the quota. Besides, failure to fulfil it will also negatively impact our country," said the ATAB general secretary.

HAAB and ATAB leaders said despite the huge interest of people to perform hajj, fewer people have registered due to the high cost of hajj packages.

# No eyes on the poster boards

DNCC's initiative to install the structures failing to bear fruit

Despite spending Tk 1.91 crore for installing designated poster boards to keep the metrorail pillars free of posters, the efforts of Dhaka North City Corporation seem to be falling

Even though many of the proposed boards were installed two months ago, they have failed to attract people's attention, according to DNCC officials.

Furthermore, the structures are reportedly not strong, so they might break apart during storms, raising the risk of accidents.

Residents and experts have raised concerns about DNCC's haphazard initiative to resolve this problem. They said DNCC is installing boards without proper planning, policy and awareness campaigns.

can one keep their advertisements there.

According to DNCC officials, the corporation has planned to set up 100 boards around the metro-rail area and already installed 22 of them. It has already spent Tk 1.91 crore for this.

During a recent visit, this correspondent found that near the Moghbazar-Mouchak flyover, next to Eskaton Road, tea stalls have been set up covering half the board, which had no posters on it.

Near a Farmgate foot-bridge, the newlyinstalled board only has two posters of rulingparty leaders and two for a house rental. Below it is a garbage dump and food stall occupying half the footpath.

In Karwan Bazar area, the authorities used a tin fence to set up a board, but the structure is quite weak.







# Town's main kitchen market in a shabby state





Entrance of Park Market, the main kitchen market in Tangail town, left, and a busy lane of the vegetable market remain in such muddy condition for almost all year round as the decades-old market has hardly seen any development work for a long time.

Park Bazar, the main kitchen market in Tangail town, has been in a sorry state due to lack of renovation work for long, causing huge sufferings to the buyers and sellers.

In order to get rid of the problem, townspeople and traders of the market have been urging the authorities concerned to renovate the market, which was set up over three decades ago, but to no effect.

Many traders at the market that though alleged the municipality authority gets revenue from the leased shops, they are reluctant to conduct any development work.

The market was first set up on the premises of a park in the town on a temporary basis in 1977.

It was supposed to be shifted to Chhoy Ani Bazar, another old kitchen market in the town, but that never happened, locals said.

Finally, the kitchen market. locally called Park Bazar, was set up permanently at the park in 1989.

Since then, the market, established on three acres of land, has been the main kitchen market of the district town.

There are around 700 permanent and 300 temporary shops at the market, which is also known as the biggest wholesale vegetable market of the district.

Surprisingly, no drainage facilities were developed for such a large kitchen market, even though there is no alternative to drain out the stagnant water from the market premises, traders said.

As a result, the entire market area remains covered with thick mud and stagnant water for most of the rainy season.

It becomes almost impossible for the customers to enter the market even after a little rain. Moreover, there is no shed for

people to take shelter during rain or excessive heat, traders said. Several meat traders said there

is no designated slaughter house at

the market. During a recent visit to the market area this correspondent saw more shops are constructed at the Eidgah-end of the market in the last several years and allocated to

Joaher Ali, general secretary of Park Market traders' association, said as there is no street light,

darkness covers the entire market area soon after sunset.

Although they have urged the municipality authority on several occasions to develop the kitchen market, nothing has been done so far, he added.

The traders' association Abdul Barek said President though the municipality authority regularly collects revenue from the vendors and vehicles, during loading and unloading goods, no development work has been done to ease the troubles of the buyers and sellers.

Mahbubur Rahman, a resident of Collegepara area in the town, said the kitchen markets in the adjacent districts have been constructed using modern infrastructures to ensue various facilities for both the buyers and sellers.

But the kitchen market in Tangail town looks like a waste dumping place, he said.

Contacted, Tangail Municipality Mayor SM Sirajul Haque Khan Alamgir said they have a plan to construct a four-storey building at the existing market place where vendors of different items can sit

# Uniform admission test for all public universities: UGC

A uniform admission test will be held for all public universities to enrol undergraduate students from the 2023-2024 academic session.

The Ministry of Education took the decision and asked the University Grants Commission to take necessary initiatives in this regard," said Prof Muhammad Alamgir, convener of the uniform admission test committee and UGC member.

He said the commission already notified vice chancellors about this development during a meeting with UGC held yesterday.

Right now, 22 general, science and other public universities hold a "central admission test" under a cluster. Besides, seven agriculture, and three engineering and technology universities hold tests in two different clusters.

Nine universities -- including Dhaka University, Buet, Jahangirnagar University and Chittagong University -- are still out of the cluster system.

Asked whether leading universities would take part in the uniform test, Alamgir said resolutions of the meeting have already been sent to them.

Speaking at the meeting, UGC Chairman Prof Kazi Shahidullah said, "Some problems have arisen owing to the new system, but there is no scope to backtrack."



# Thai PM dissolves parliament

#### Calls election

Thai Prime Minister Prayut Chan-O-Cha dissolved parliament yesterday, setting up a general election in May as the former coup leader seeks to extend army-backed

The vote pits unpopular former army chief Prayut, who came to power in a 2014 putsch, against the daughter of billionaire former PM Thaksin Shinawatra, who still casts a shadow over the kingdom's political scene despite more than a decade in exile.

The main opposition Pheu Thai group, fronted by Paetongtarn Shinawatra, is polling strongly but Thailand's junta-scripted 2017 constitution will make it hard for her to secure the top job.

A statement in the official Royal Gazette published yesterday announced the dissolution, and the Election Commission will confirm the date of the poll later, with May 7 or 14 tipped as most likely.

The election is the second since the 2014 coup and the first since the country was rocked by massive, youth-led pro-democracy protests in Bangkok in 2020.

Unofficial campaigning has been under way for weeks, with rising living costs and kingdom's sluggish recovery from the coronavirus pandemic high on the agenda.

Police in Pakistan have arrested dozens of supporters and aides of former prime minister Imran Khan in raids in two cities as part of a crackdown on those involved in recent clashes with the security forces, Khan's party and police

Khan has asked the chief justice of Pakistan to allow him to appear for court proceedings virtually to reduce the risk of any threat to his life, he said in a video message yesterday, as his Pakistan Tehreek-e-Insaf (PTI) party prepared for a rally in Lahore on Wednesday.

Supporters of Khan's party, clashed with police in the city of Lahore last week as they attempted to arrest him at his home, and later with police in Islamabad as he arrived

to appear before a court on Saturday.
"My life is in danger, why must I appear in court," said Khan in a live video stream, asking to appear by video conference for court proceedings and vowing: "I will appear for all cases".

Khan, a former cricket star, was prime minister from 2018 until 2022, when he was ousted from office in a parliamentary vote.

# Visva-Bharati says land still owned by univ

Visva-Bharati University in Santiniketan yesterday said although the mutation of the disputed 13 decimal plot has been done in economist Amartya Sen's name, its ownership remains vested with the university. On Sunday, the University issued a show cause notice to the Nobel laureate asking him why an eviction order will not be issued against him for not vacating the land he is allegedly occupying illegally. Addressing a press conference in Santiniketan, the university's acting Registrar Ashok Mahato said only the name of the land's leaseholder has changed from Ashutosh Sen, Amartya Sen's father, to the economist. Sen has been asked by Visva Bharati to respond to the notice by March 24. Visva Bharati claims Sen is in possession of 1.38 acres of land on the Santiniketan campus, which is in excess of his legal entitlement of 1.25 acres. The economist had earlier asserted that most of the land he is holding in the Santiniketan campus was purchased from the market by his father while some other plots were taken on lease. Mahato said only 1.25 acres were leased to Ashutosh Sen but not the entire 1.38 acres.

### Lanka seeks 10-yr debt moratorium

Cash-strapped Sri Lanka is seeking a 10-year moratorium on its foreign debt, President Ranil Wickremesinghe's office said yesterday on the eve of a desperately needed \$2.9 billion IMF bailout. Wickremesinghe's office quoted him as saying the widely expected International Monetary Fund rescue "will only give us a breathing space where they will say we are no longer bankrupt". "All the money we have to repay this year, I hope we will be given at least 10 more years to repay it," Wickremesinghe told a meeting of students in Colombo on Sunday. He did not give details of his plans to restructure Sri Lanka's \$46 billion external debt.

# Highway accident or murder?

### A crash that exposes all the problems with our road transport system

The horrific crash that killed 19 people on the Dhaka-Bhanga expressway on Sunday highlights nearly all the problems with our road transport system. Firstly, the bus which smashed through a highway fence and plunged into a ditch should never have been on the road in the first place. Having been involved in another serious accident only four months ago which killed three people and injured 15 others – the bus had its registration and route permit suspended by the authorities. Its fitness permit also expired on January 18. Yet, the owner of the vehicle kept it running. All this exposes the serious lack of enforcement of rules by the relevant government agencies, including the Bangladesh Road Transport Authority (BRTA) and the highway police.

BRTA authorities have reportedly said that they do not have the manpower to check whether all vehicles plying on the roads have proper documentations. Such excuses to escape responsibility for tragic consequences seem to have become the norm among government officials and agencies, but at what cost? The number of lives that continue to be lost as a result of unfit vehicles or drivers keeps piling up. Who will answer for them? As one expert has said, the highway police should be well aware of the fact that early mornings are risky hours and, therefore, should strengthen monitoring at that time. But such steps should be taken before accidents happen although, in our case, they are usually not taken even after so

Even though the cause of the latest crash has not been confirmed yet, witnesses alleged that the bus was speeding. Other suspected reasons include a punctured tyre - which could have been avoided had the vehicle gone through proper fitness testing - or the driver falling asleep at the wheel. Given the inhumane working hours that drivers of passenger vehicles in our country are forced to endure, despite the Road Transport Act 2018 clearly stating that drivers cannot drive for more than five straight hours or a total of eight hours a day, such accidents are, in fact, just waiting to happen.

At the heart of it all is the problem of lack of enforcement of relevant rules and regulations by the authorities. For any improvement to take place, road safety campaigners and experts have repeatedly stressed the importance of a shift in the attitude of those in charge of the transport sector, including the top brass at the Ministry of Road Transport and Bridges. Yet, nothing seems to change.

Such apathy and dereliction can only be considered criminal. This must be fixed before anything else. Responsible agencies and officers must be held accountable for their repeated failure to do their job. As for the Dhaka-Bhanga expressway tragedy, the authorities must punish the vehicle owner for flouting suspensions and keeping the bus running. We don't need exemplary punishment; we need regularly meted out punishment in light of the law so that transport owners/ drivers know better than to breach it. There is no alternative to enforcing the law properly, evenly and regularly.

# Take stern action to stop RMG theft

### Such incidents are becoming a serious problem for apparel exporters

The suspicious handling of a suspected mastermind behind a series of highway robberies involving export-bound RMG products has once again highlighted how highway safety, particularly that of cargo trucks, is still ignored by the authorities. The mastermind in question is Md Shahed alias Sayeed, who was arrested in 2021 for his involvement in the theft of RMG products on their way to the Chattogram port. According to a police statement then, Shahed led highway gangs that stole apparel products from at least 5,000 lorries for around two decades. Yet, in a recently submitted charge sheet in one of the cases filed in this connection, he was downgraded to "accused no. 7" among a group of eight.

The question is, why would police go against their own statement? Why would they submit a charge sheet without naming a mastermind? On the face of it, this seems to be an example of weaknesses in the investigative process. A criminal lawyer told *The Daily Star* thatrecovery of the stolen goods and confessional statements from other accused robbers would have been sufficient to prove whether Shahed was the mastermind. But as we know from experience, flawed investigations are often down to underhand dealings, where investigators show leniency in exchange for bribe, etc. But there is a bigger issue at play here: the threat that unchecked cargo theft poses to our RMG industry, which must ship

products on time and in full. Last month, the BGMEA president also highlighted the problem at a press conference, saying about 20-22 cases of theft occurred on the Dhaka-Chattogram highway in 2022 alone. This, according to him, is posing a serious threat to the RMG sector. "There are gangs who are committing the same crime over and over again and getting away with them without any punishment," he said, adding that often they are abetted by dishonest employees of the industry, buying houses, shipping lines and C&F agents. He also called for severe penalties for

organised cargo thieves, amending the law if necessary. The recommendation for amending the law deserves consideration. According to sources, there are about 10-12 gangs involved in stealing "30-40 percent" of the apparel products, mainly from major consignments, carried to the Chattogram port for shipment. As well as RMG products, cargos of other kinds and passenger buses are also vulnerable on the highways. This is clearly an organised crime, yet miscreants behind cargo theft are charged with "regular theft", which is a bailable offence with a maximum punishment of three years in jail. They usually secure bail within days of their arrest, and get back to the crime.

We must put an end to this cycle. We urge the authorities to take this issue seriously and improve highway security. They must especially take action against RMG robbers and put to rest the concerns of the industry, so that it can prosper further.

Third, different news reports and research findings have informed us of the huge amounts of unexplored gas in the Chittagong Hill Tracts, and in Sylhet, Bhola, and Shariatpur districts. The government has already taken initiatives to explore some of these areas. As such, does the state minister's comment on our gas reserves not contradict the government's own gas exploration initiatives?

In the gas sector master plan of 2017, it was recommended that the government should not spend money to import costly LNG and should explore indigenous gas instead. The plan estimated that Bangladesh would have to spend \$3 billion by 2030 to import LNG, while exploration of indigenous gas resources will be much more cost-effective.

However, we haven't seen much initiative from the government to do so. After the gas crisis hit the country last year, Bangladesh Petroleum and Production started exploring new gas fields. The peril because when the dollar crisis

government's proactive role instantly made it obvious how neglected our gas exploration activities have been in the past. After the crisis began, Bapex drilled nine wells and saved at least Tk 1 lakh crore on LNG import by spending only Tk 812 crore. This means that Bapex can extract gas at a much lower cost, whereas buying LNG from the spot market requires huge amounts of forex reserves.

The increasing import dependency over the last decade is at the root of our current energy crisis. This dependence will only increase if we continue to become dependent on imported coal and LNG. The Rooppur nuclear power plant itself involves massive import of technology and fuel.

This year, the Rampal power plant has already started to supply electricity to the grid. Although the government had informed us that the per unit cost of electricity would be Tk 8, recently we found out that the cost supplied to our grid at high costs. So, we are still implementing the plans we made in 2010.

The master plan seems to have been developed more to serve the interests of producers and technology suppliers than to ensure energy security. As a response to external Company Limited (Bapex) urgently shocks, our energy security is now at

prices. Their concerns have valid grounds, too.

The government's new projects are facing a crisis due to our declining forex reserves. We recently saw that it delayed paying to import coal for Payra. There was also a delay in producing electricity at the Rampal power plant due to coal import payment having to be in US dollars. Under these circumstances, businesses are losing faith in the government's ability to pay for imported LNG from the spot market. Recently, the LNG price has come down to \$14 and the government is planning to import it from the spot

Even if the government can import LNG from the spot market at a relatively lower price than what it is during times of peak demand, there is no guarantee that the price would not increase in the future. Therefore, it is not sustainable to rely on LNG imports for ensuring energy security. What we process. is Tk 14-15. Electricity from Adani's need to do instead is explore our own Godda coal power plant is also being gas resources. There is no alternative to discovering new gas fields and starting gas exploration. It is in no way believable or acceptable that we do not have any gas left.

Moreover, offshore exploration has bright prospects in the country, but we are yet to explore our offshore blocks. While Myanmar has already discovered some offshore gas blocks, we have not conducted any proper

offer around \$10. Bangladesh's share of profit gas might also go down from between 55 percent to 80 percent down to 40 percent to 70 percent. No matter what, we can guess that signing a PSC with any foreign companies will only allow them to take control of our indigenous resources.

To say that we do not have the capacity to explore offshore blocks is illogical. No country in the world starts exploration after developing their capacity, they build it through their efforts and a slow process of technology transfer. A company like India's Oil and Natural Gas Corporation (ONGC) itself outsources its tasks to other companies abroad. Bangladesh can develop its capacity by outsourcing some tasks, retaining overall control over management, developing its regulatory institutions and human resources, and closely engaging in the technology transfer

We have previously seen how the government expressed doubts about Bapex's capacity to explore new gas fields and how it hired foreign companies like Gazprom to spend three times more money. This approach proved to be unsustainable. Instead of being dependent on foreign companies for gas exploration, we should establish our own control over the sector in order to ensure true

# What Ukraine needs to learn from Afghanistan

The greatest enemy of economic development is war. If the world slips further into global conflict, our economic hopes and our very survival could go up in flames. The Bulletin of Atomic Scientists recently moved the hands of the Doomsday Clock to a mere 90 seconds to midnight.

The world's biggest economic loser in 2022 was Ukraine, whose economy collapsed by 35 percent, according to the International Monetary Fund (IMF). The war in Ukraine could end soon, and economic recovery could begin, but this depends on Ukraine understanding its predicament as the victim of a US-Russia proxy war that broke out in 2014.

Unless the proxy war ends soon, Ukraine faces a dire future. Ukraine needs to learn from the horrible experience of Afghanistan to avoid becoming a long-term disaster. It could also look to the US proxy wars in Vietnam, Cambodia, Lao PDR, Iraq, Syria, and Libya.

Starting in 1979, the US armed the Mujahideen (Islamist fighters) to harass the Soviet-backed government in Afghanistan. As President Jimmy Carter's national security advisor Zbigniew Brzezinski later explained, the US objective was to provoke the Soviet Union to intervene, in order to trap it in a costly war. The fact that Afghanistan would be collateral damage was of no concern to US leaders.

Soviet military entered Afghanistan in 1979 (as the US had hoped), and fought through the 1980s. Meanwhile, the US-backed fighters established al-Qaeda in the 1980s, and the Taliban in the early 1990s. In 2001, the US invaded Afghanistan to fight al-Qaeda and the Taliban. This war continued for another 20 years, until the US finally left in 2021.

Afghanistan today lies in ruins. While the US wasted more than \$2 trillion

impoverished. Its 2021 GDP was below \$400 per person.

The proxy war in Ukraine began nine years ago when the US government backed the overthrow of Ukraine's then President Viktor Yanukovych. Yanukovych's sin, from the US viewpoint, was his attempt to maintain Ukraine's neutrality despite the US' desire to expand Nato to include Ukraine (and Georgia). The US' objective was for Nato countries to encircle Russia in the Black Sea region. The US has been massively arming and funding Ukraine since 2014.

But two harsh political realities of Ukraine were overlooked by the US. The first is that Ukraine is deeply divided ethnically and politically between Russia-hating nationalists in Western Ukraine and ethnic Russians in eastern Ukraine and Crimea. The second is that Nato expansion to Ukraine crosses a Russian redline. Russia will fight to the end, and escalate as necessary, to prevent the US from incorporating

Ukraine into Nato. At the end of 2021, Russian President Vladimir Putin put forward three demands to the US: Ukraine should remain neutral and out of Nato; Crimea should remain part of Russia; and the Donbas should become autonomous in accord with the Minsk II Agreement.

group backed Yanukovych's overthrow. In March 2022, Ukraine's President Volodymyr Zelensky seemed to understand his country's dire predicament as a victim of a US-Russia proxy war. He declared publicly that Ukraine would become a neutral country, and asked for security guarantees. He also publicly recognised that Crimea and Donbas would need some kind of special treatment. Yet, the US blocked the peace process.

The basis for peace today is clear. Ukraine would be a neutral non-Nato country. Crimea would remain home to Russia's Black Sea naval fleet, as it has been since 1783. A practical solution would be found for the Donbas (such as a territorial division, autonomy, or an armistice line). Most importantly, the fighting would stop, Russian troops would leave Ukraine, and Ukraine's sovereignty would be guaranteed by the UN Security Council and other nations.

Above all, the government and people of Ukraine would tell Russia and the US that Ukraine refuses any longer to be the battleground of a proxy war. In the face of deep internal divisions, Ukrainians on both sides of the ethnic divide would strive for peace, rather than believing that an outside power will spare them the need to compromise.

# How forestry projects destroy forests

A huge tractor was roaring on a large plot in Dokhola Beat in Dokhola Range in Madhupur sal forest on January 17. It was ploughing the forest land right after harvest of exotic acacia, under the social forestry scheme. The vast area had stands of acacia even a month or two ago. Then, all of it was auctioned and felled. pineapple orchard on plots harvested just plantation plot. six months ago and plots that have just been felled. No "social forestry" tree has yet been planted in these plots!

In addition to 45 percent of the sale proceeds after harvest, social forestry participants are allowed to cultivate crops on the condition that they not plough the land, as per the social forestry agreement.

Social forestry is a controversial scheme to grow fuelwood, initiated in Madhupur sal forest and other forest areas back in 1989-1990 with funding support from Asian Development Bank (ADB) under the Thana Afforestation and Nursery Development Project (TANDP). Patches of natural sal had been cleared to make way for social forestry. In the first rotation, exotic eucalyptus was a major species. The second ADB-funded plantation scheme, Forestry Sector Project (FSP), was implemented amid severe criticism that such plantation projects promote monoculture and require clear-felling at the end of a 10-year rotation, which has led to massive damage to the natural ecosystems.

Though eucalyptus was eradicated from the public forest land starting on the second rotation, social forestry continues at a very high cost to natural ecosystems.

The natural sal forest patches have been replaced by monoculture plantation of acacia on around 5,000 acres in Madhupur. According to the forest department, from 1981 to 2022, it has established block or woodlot plantations on 105,283.03 hectares of land. These plantations, under a number of projects, have had increasingly severe effects on the local environment for years. Madhupur sal forest (still gazetted forest land) has now become pineapple, banana, papaya, lemon, and turmeric orchards.

On public forest land social forestry is a plantation practice in which the local poor people are to be selected as participants to get plots – one ha each. Under such a public forest plantation model, from the fourth rotation, a plot is reduced to one acre to accommodate more participants. This is called co-management, a controversial arrangement that has caused massive destruction of the natural vegetation in the sal forest areas and other public forest patches.

ADB provided funds for two rotations in Madhupur and elsewhere. Then, in 2005, it ceased funding any forestry projects in Bangladesh and other Asian countries. A top official of the bank confessed to me that they had realised the harm the plantations have

The co-management model of social forestry comes with certain conditions. A

participant must be a poor ethnic person or forest villager, member of disadvantaged or backward communities, destitute woman, insolvent freedom fighter or their descendant, landless or someone owning less than 50 decimals of land. A key qualification for a participant to get priority selection is if s/ Attached to this plot lies a huge newly planted he resides within one kilometre radius of the

> But has the forest department, the implementing agency of social forestry, ensured that these conditions in selecting participants have been fulfilled? "Largely not," is the common response of the locals. "Many social forestry participants are not genuinely poor, disadvantaged, and landless. They are well-off," says Eugin Nokrek, president of Joyenshahi Adivasi Unnayan Parishad (JAUP).

> Social forestry indeed has a positive impact, particularly in greening rural areas. But it had a tragic start in Madhupur and other forest patches in 1989-1990. It was supposed to be introduced in degraded and denuded areas. But, to the great disappointment of locals, patches of natural forests were cleared to accommodate plantations of exotic eucalyptus

> Moreover, the first rotation of the social forestry plantation was a disaster. Most of the planted trees disappeared before reaching the harvest period seven to 10 years later. A forest that had existed for thousands of years was thus replaced by a short rotation plantation of

> Meanwhile, a local businessman, who is a participant in the Madhupur Range and is certainly not poor, defended himself: "The trees of the first rotation were plundered because the poor participants could not protect them from forest thieves. From the second rotation, 'strong' men like us were selected and we are protecting the plantation plots."

> Allegations of corruption in the selection of participants for social forestry are widespread. The forest department officials, however, deny the allegations against them.

> One facet of social forestry is financial gains. One widow participant of a one-hectare social forestry plot in Madhupur Range was very happy during harvest time this year. Her plot has been auctioned for Tk 1,122,000 (\$11,220), of which she will get 45 percent, the forest department 45 percent, and 10 percent will go into a fund for future planting.

> In the initial years of a rotation, businessmen rent social forestry plots from the participants to grow pineapple and spices. While the participants earn an income from this deal, the businessmen pocket handsome profits.

> The saddest part of social forestry in Madhupur is that, what used to be natural forest patches even in the 1980s are now covered by high-value agricultural crop fields, which politically connected and influential people benefit from the most. Social forestry in Madhupur and elsewhere has led to the wholesale destruction of forest ecosystems.

> Not that the forest department and dominant finance providers (ADB and World

Bank) do not know of the damage that plantations have caused to forest ecosystems. And they do have a mitigation plan. As I have mentioned above, ADB has completely withdrawn from the forestry sector in Bangladesh and Asia.

But the World Bank (WB), which had cut down financing the forestry projects, has returned with possibly the largest ever forestry project in Bangladesh, the Sustainable Forest and Livelihood (SUFAL), for the restoration of 78,930 ha of forest through collaborative management with around beneficiaries in 28 districts who traditionally depended on forests but were seen to be a threat to the forests.

The idea of Collaborative Forest Management (CFM) is to restore lost forest species and help forest-dependent people.

"We are becoming successful in restoring and regenerating forests on 78,930 hectares of forest land by dint of the Site Specific Plan (SSP)," claims a high-level official of the forest department team overseeing SUFAL.

But Madhupur locals have a different assessment.

"The forest floor was unnecessarily cleared of natural vegetation to plant trees. This has further threatened the surviving wildlife and insects," says Ajoy Mree, a Garo elder from Gachhabari village. "The trees under the shade of standing trees have little chance to survive. The remaining natural forest should be left untouched."

One can see colourful signboards under the project describing the site, specific plantation, and names of species planted in Madhupur national park and other protected parts. But there is little sign of improvement in the vegetation. Pineapple plantation has made its way onto some of the plots.

Soon after a plot is cut, the stumps are hastily uprooted and huge tractors roll in to quickly prepare the land for pineapple plantation. Who is doing this? "Politically powerful gangs who rent the land from participants in social forestry," say the locals. What can SUFAL and its beneficiaries do to contain this? "Very little or nothing," they say.

"Strong political support for high-value agricultural crops such as pineapple, banana, papaya, and spices are the biggest problem,' says a former chief conservator of forests. "Political gangs are destroying the forest."

"We will be successful in protecting our forest only with the right political decisions," whispers a forest official working with SUFAL.

However, a top WB official, though happy about SUFAL, is not ecstatic about forest department officials. "The forest department should pay greater attention to us," he says.

The blame game over factors that led to all the devastation we see in the sal forests of Madhupur and elsewhere does not help. The government, international donors, and other parties with decision-making power must recognise their failures, prevent the situation from getting worse, and contribute to improving the climatic environment.

The forest department and our political heavyweights undoubtedly benefit from forestry projects and assist the WB to justify its comeback in the forestry sector in a big way. What they should not forget is how the forest extraction and forestry projects from British colonial times - which promoted plantations and co-management - have had devastating effects on our forest ecosystems. We would like to see what is missing: passionate and careful attention being paid to ground realities.

# Without support from bureaucracy, EC can't hold fair elections

The phenomenon of high-ranking "out of control" to "fair, disciplined and bureaucrats joining political parties after retirement is a matter of concern raises questions about their true loyalty and the integrity of the bureaucracy. When individuals are appointed to serve in government positions, they take an oath to serve the people and uphold the law. However, if they join a political party immediately after retirement, it sends a message that their loyalty may have been divided all along, and that, while serving in the bureaucracy, they may have worked in favour of a certain section of people in power or from within the power structure. And not only that, their subordinates may have also done the same.

better understand phenomenon, let us look at the Gaibandha-5 by-election.

The events surrounding the Gaibandha-5 by-election have raised country's institutions - particularly the Election Commission (EC). The Chief Election Commissioner expressed his frustration with the widespread irregularities that occurred during the by-election, stating that "elections parliamentary by-elections and local

There was a time when nothing could stop people from exercising their voting rights. Blaming the cold for the lower turnout is perhaps nothing but covering up the weaknesses of the constitutional institutions.

All citizens have a responsibility to vote. Even if the outcome seems predetermined, it is essential to exercise the right to vote and make one's voice heard. It is only by participating in the democratic process that citizens can ensure that their elected officials are held accountable and that institutions remain independent and free from political pressure.

The EC is a constitutional body in Bangladesh. Our constitution has awarded the EC with absolute concerns about the integrity of the power to control and direct the civil administration during elections. But this is rendered meaningless if the civil administration does not cooperate with the EC, but ends up doing the opposite.

suspended the election and announced that it would take legal action against deputy commissioner, one executive magistrate, 126 presiding officers, and five sub-inspectors for their involvement in the irregularities.

The reason behind taking such an action is simple: these officials did not act as they were supposed to under oath. During an election, the civil including administration,

bureaucracy and police, are mandated by law to serve under the direct control of the EC. The EC relies on their integrity to successfully hold a free and fair election. However, during the Gaibandha-5 by-election, the opposite occurred. Officials acted as if they were not under oath and did not provide their allegiance to the Commission, resulting in widespread irregularities.

The fact that public officials acted against their oath raises concerns about who they were serving; the people they were supposed to serve under oath, or the party they are associated with? The aftermath of the by-election sends a negative message to the people, creating doubts about the integrity of these officials and the institutions they serve.

It is not surprising that the EC has not vet taken visible actions against the public officials. The EC is reliant on the civil administration's cooperation, and without it, the Commission cannot act. Unfortunately, this situation is not unique to Bangladesh, and it is not uncommon for public officials to act against their oath, especially when there is political pressure.

The erosion of institutional integrity is a significant issue. It is leading to a loss of faith in the democratic process of the country. When we lose confidence in the integrity of institutions, we become disillusioned with the democratic process. The second round of the voter turnout, and the EC's shift from

So, can the EC hold a free and fair national election? Under the prevailing conditions, it is nearly impossible. Why? With only nine months left before the national election, the law ministry is still sitting on the EC's proposal to amend the Representation of the People Order, 1972, the regulating law of the national election. It is mentioned under Article 126 of the constitution that it shall be the duty of all executive authorities to assist the EC in the discharging of its functions.

Can the EC do anything if the executive authorities feel that these are just words written on a piece of paper? It cannot.

These precedents will continue to have serious implications for the integrity of the bureaucracy and the legitimacy of the government's actions. Bureaucracy, civil administration, and law enforcement agencies need to remain impartial and serve the public interest, rather than aligning themselves with political parties.

Much of Bangladesh's recent economic slump is due to public funds being used to benefit mid- and high-ranking executive further exacerbating inequality. # The scars of childhood bullying that never go away

In 2011, I was unanimously chosen as a sacrificial lamb for the entertainment of our class. It is difficult to recall the finer details of what happened, nor can I put my finger on the exact length of time it went on for. But there is one thing I'm certain of - the trauma of those weeks or months, coupled with that of many that followed throughout the years, has fundamentally shaped who I am today.

Everything was my fault. Every bad word, every act of violence, just about every sort of misbehaviour and misdemeanour, all began to originate with me. For all crimes conceivable by a small child, I was punished especially if I didn't do them. Thus, many times a week, or perhaps every day, I would be forced to play the defendant in that classroom-turned courtroom, with the verdict being the same at the end of each trial. I

Even amongst small children inside a classroom, politics has a way of becoming the dominant force once introduced. The orchestrator of my bullying was universally adored by our teachers, thanks to him being the best student in class, and he, even at that tender age, would weaponise their blatant favouritism to make himself feared and obeyed. The others, being his loyal subjects, could only follow.

> Thus, I became acquainted with a feeling I had never known before, which wouldn't be able

> > to describe until years later. It was a crippling, all-consuming loneliness sensation no child should ever have experience.

The day came when the children finally grew bored of their favourite sport and I breathed a sigh of relief,

thinking it was all over, not knowing that what had just concluded was merely the prologue. From jeering and name-calling to outright social ostracisation, the bullying would continue intermittently, spanning over half a decade. Childishly fearing that everywhere would be the same, I endured, never asking my parents to change my school or section. And once it ended for good, I could only stare at the emptiness of what lay behind me and that which lay within.

It has been many years since I was last tormented in that way. Yet, even now, the trauma from those times still rears its ugly head occasionally. Whenever anybody does anything wrong, my first impulse is always to double-check whether it wasn't me instead. There's also the small, irrational part of me that still lives in cynical anticipation of the day I'll once more be isolated, cornered, and punished for things I never did.

Today, my former bully is a close friend of mine, and I can no longer hate him for the nightmares he put me through when we were both kids. Yet, helplessness of being a marionette in another person's puppet show. That has become one of my worst fears, a terror I wish to never know again.

Even now, this story of mine feels awfully anticlimactic. For me, there was no triumph, no justice, and no closure. But it is poetic in a sense, given that it ended just as it began - suddenly and without any reason. Afterwards, all I had left was to pick up the pieces and silently move on.

# How getting rid of D unit in Dhaka University is affecting admission candidates

This year Dhaka University (DU) has made some significant changes to its admission process, including removing the D unit.

Previously, the D unit was the exchange unit where students from different backgrounds could change their academic tracks. If a student from a Science background wanted to study in the Business faculty at DU, they would sit for the D unit exam. Similarly, commerce students wishing to switch to Science or Humanities majors. D unit also was the gateway into the Social Science departments.

Overall, the D unit would allow you to access a variety of faculties by sitting for only one exam.

From 2023, this gateway has been abolished. The new system requires students to sit for exams of the respective faculties. That means, regardless of your background if you want to access a Business Studies department, you have to sit for the Business Studies unit (C unit). The same applies to Science (A unit) and Humanities, Law, and Social Science (B unit).

For example, if someone suddenly falls sick the day before the A unit exam and cannot give their best, it will only affect the result of that particular unit. They will still have the chance to ace the other units they registered for. Merit positions will also be distinct. A person might be on the waiting list in one unit but high up on the merit list of another. In this way, the chances of succeeding are actually higher.

There is no doubt that admission tests are life-altering. The current candidates are the guinea pigs of this new system. Despite the burden of the seemingly endless syllabuses to cram, the students who strategically make the most out of this opportunity will come out on top.

# 'Dear friends' Xi, Putin meet in Moscow

### Russia ready to discuss China's Ukraine plan; EU to supply ammo to Kyiv

Chinese President Xi Jinping met his "dear friend" Vladimir Putin in Moscow yesterday, seeking both to deepen economic ties with an ally he sees as a useful counterweight to the West and to promote Beijing's role as a potential peacemaker in Ukraine.

Xi was the first leader to meet the Russian president since the International Criminal Court (ICC) issued an arrest warrant for him on Friday over the deportation of Ukrainian children to Russia during its year-old invasion

Moscow said the charge was one of several "clearly hostile displays" and opened a criminal case against the ICC prosecutor and judges. Beijing said the warrant reflected double standards.

Russia is presenting Xi's trip, his first since securing an unprecedented third term this month, as evidence that it has a powerful friend in its standoff with a hostile West.

The two men greeted one another as "dear friend" when they met in the Kremlin yesterday afternoon before a dinner, to be followed by formal talks today.

Putin told Xi he viewed China's proposals for a resolution of the Ukraine conflict with respect and was SEE PAGE 6 COL 5

# **TONU MURDER**

# Not a single arrest made in 7 years

Seven years have passed since the killing of Sohagi Jahan Tonu, but the law enforcers are yet to make any headway in the murder probe.

Not a single arrest has been made in this connection till date.

Tonu, a student of Cumilla Victoria Government College and also a theatre activist, was raped and murdered inside

Cumilla Cantonment on March 20, 2016.

The incident sparked protests across country.

The "cause of her death" also could not be

determined even after two autopsies at Cumilla Medical College.

Officials of the Criminal Investigation Department only could confirm, through DNA tests in May that year, that Tonu was raped before being murdered.

Spermatozoa of three unidentified persons were found in Tonu's clothes. It didn't match with the samples of any suspect, investigators say.

The CID also claimed to have interrogated more than 200 people, including some army men. But there was no breakthrough.

# 54 BNP leaders, activists held at **Banani Club**

Detectives picked up 54 leaders and activists of Munshiganj BNP from the capital's Banani Club early yesterday over allegations of planning "anti-state" activities including "sabotage".

However, the BNP said the party men were attending a social programme there followed by dinner, and alleged that police implicated them in a false case

Preferring anonymity, a Banani Club staffer told The Daily Star that the arrestees were holding a "social programme" followed by dinner there. He, however, declined to say anything further.

Mustafizur Rahman, officer-in-charge of Banani Police Station, said that a team of the Detective Branch of police along with members of the local police station raided the club around 11:30pm on Sunday on information that BNP men  $\,$ were planning "anti-state" and "subversive activities".

Following the raid, a case was filed against the BNP men with Banani Police Station under the Anti-Terrorism Act, said

Ikramul Haque Halder, a sub-inspector of DB (Gulshan Division) and also the complainant of the case. According to the case statement,

the arrestees along with some others were preparing to sabotage government establishments and vehicles to unseat the government, which is punishable under the Anti Terrorism Act.

Fifty-six BNP men were accused in the case. Two of them are on the run.

Yesterday, a Dhaka court granted two-day remand for each of the 52 arrestees. The arrestees are mostly BNP leaders and activists from Munshigani's Sirajdikhan and Sreenagar upazilas. Among them is Momin Ali, former Sreenagar upazila chairman and also a BNP lawmaker candidate in the 2018

Kamruzzaman Ratan, member secretary of Munshiganj BNP, said Momin Ali hosted the dinner for the party men ahead of his scheduled trip to Saudi Arabia

"If the government smells conspiracy or sabotage in every political activity and even in social programmes, then it can impose ban on all political activities of the opposition parties.

"Banani Club is an important establishment. It is not a secret place. Can sabotage be planned by 54 persons in an open place?" he said.

# **FY24 BUDGET** Businesses call for gradual retraction of tax exemption

Businesses yesterday urged the government not to withdraw the tax exemption facility from all sectors in one go in the upcoming budget as it would be too big a knock for them to steer.

The request came at Finance Minister AHM Mustafa Kamal's pre-budget meeting with the leaders of different business chambers and trade bodies. Bringing down the tax exemption

facility, which includes complete relief from taxes, reduced rates or tax on only a portion of items, is one of the conditions agreed upon with the International Monetary Fund for the \$4.7 billion loan.

Before deciding to withdraw tax exemptions, the government should consider the economic importance and impacts of the exemption on the sectors that have been enjoying the facility, said Md. Jashim Uddin, president of the Federation of Bangladesh Chambers of Commerce and Industry, at the virtual discussion.

Rather, it is possible to increase the revenue collection manifold without withdrawing the facility if the National Board of Revenue (NBR) applies its existing rules and modernises its management, he

He also suggested the government expand the tax net rather than increase the tax rate for increasing the revenue collection in the next budget.

The FBCCI also demanded the government brings down the source tax on export receipts to 0.25 percent from the existing 1 percent. The government should also expand

# Remains of ancient glacier spotted on Mars

The remains of a glacier have been found near the Martian equator, suggesting that some form of water could still exist in a region on the red planet where humans may one day land.

The ice mass is no longer there, but scientists spotted telltale remains among other mineral deposits near Mars' equatorial region. The deposits there usually contain light-colored sulfate salts. When scientists took

closer look, they recognised features of a glacier,

including ridges called moraines debris deposited or pushed by a moving glacier. The research team spotted crevasse fields, or deep wedge-shaped openings that form

inside glaciers. The findings shared at the 54th Lunar and Planetary Science Conference in The Woodlands, Texas, last week.

"What we've found is not ice, but a salt deposit with the detailed morphologic features of a glacier," lead study author Dr Pascal Lee, a senior planetary scientist with the SETI Institute and the Mars Institute, said in a statement.

"What we think happened here is that salt formed on top of a glacier while preserving the shape of the ice below, down to details like crevasse fields and moraine bands."

The researchers believe the glacier was 3.7 miles (6 kilometres) long and 2.5 miles (about 4 kilometres) wide, with an elevation between 0.8 to 1.1 miles (1.3 to 1.7 kilometres).

Scientists have an idea of how the imprint of the glacier came to be, based on evidence of

# Govt won't repeal DSA

organised by Human Rights Forum Bangladesh (HRFB) at the

CIRDAP auditorium in the capital. The government will soon be rolling out a nationwide programme to make sure the DSA is not misused, he said. "We are counselling

the law enforcement agencies [to that end]." HFRB, a platform of 20 organisations, at the meeting shared a draft of a report it will submit to the United Nations Human Rights Council for the member states to review during a process called the

universal periodic review (UPR). Dr Iftekharuzzaman, executive director of Transparency International Bangladesh, responded by saying the law should be repealed and that it will be impossible to amend it.
