# US report lists ‘significant’ abuses

The annual US report on human rights practices released on Monday listed “significant human rights issues” and abuses in India, including reported targeting of religious minorities, dissidents and journalists, the US State Department said.

The findings come nearly a year after Secretary of State Antony Blinken said the US was monitoring what he described as a rise in human rights abuses in India by some government, police and prison officials.

Significant human rights issues in India have included credible reports of the government or its agents conducting extrajudicial killings; torture or cruel, inhuman or degrading treatment or punishment by police and prison officials; political prisoners or detainees; and unjustified arrests or prosecutions of journalists, the US report added.

Advocacy groups raised concerns over what they see as a deteriorating human rights situation in India in recent years under Bharatiya Janata Party of PM Narendra Modi.

## Israel court extends house arrest of Palestinian journo

An Israeli court yesterday extended the months-long house arrest of a Palestinian journalist from annexed east Jerusalem, who stands accused of incitement over her Facebook posts, her lawyer said.

Lama Ghosheh, a freelance reporter for various Palestinian media outlets, was detained in September and placed under house arrest after 10 days in jail.

The 30-year-old has been accused of “incitement to violence” and “identification with a terrorist group”, according to the indictment which mentions Facebook posts and messages as evidence.

## US, Russia, China argue at UN

### Washington accuses Moscow, Beijing of ‘encouraging’ North Korea missile launches

The United States, China and Russia argued during a United Nations Security Council meeting on Monday over who was to blame for spurring North Korea’s dozens of ballistic missile launches and development of a nuclear weapons programme.

The 15-member council met over what Pyongyang said was the launch on Thursday of its largest Hwasong-17

intercontinental ballistic missile. North Korea has been under UN sanctions for its missile and nuclear programmes since 2006.

China and Russia blamed joint military drills by the United States and South Korea for provoking Pyongyang while Washington accuses Beijing and Moscow of emboldening North Korea by shielding it from more sanctions.

UN Secretary-General Antonio Guterres “remains deeply

concerned over the divisions that have prevented the international community from acting on this matter,” a senior UN official said at the meeting.

Russia’s deputy UN Ambassador Anna Evstigneeva described the US and South Korean military activity as “unprecedented,” while China’s deputy UN Ambassador Geng Shuang questioned whether they were defensive drills and blamed them for heightening tensions.

# Pak parliament summoned

Pakistan’s parliament is set to meet in a special joint session today to “take important decisions” to enforce the state’s authority, media reported, in the midst of prolonged anti-government defiance by former Prime Minister Imran Khan. Former cricket star Khan was prime minister from 2018 until 2022, when he was ousted from office in a parliamentary vote. Since then, he has been demanding a new election and holding protests across the country to press his case. His supporters have clashed with police several times over recent days as authorities try to force him to appear in court in connection with various cases brought against him. The office of the speaker of parliament, in calling today’s joint session, did not give a reason but the state-run Associated Press of Pakistan (APP) said the ruling coalition had called for parliament to “take important decisions” to ensure the writ of the state was enforced.

# India arrests Kashmiri journo

Anti-terrorism officers have arrested a journalist and rights group worker from Indian-administered Kashmir over accusations he was involved in “funding terror activities”, authorities said yesterday. Irfan Mehraj, a freelance journalist and magazine editor, was summoned on Monday to a police facility in the main city of Srinagar where members of the National Investigation Agency (NIA) took him into custody, the agency said in a statement.


