Two schoolboys stabbed to death over feud with juniors

Two schoolboys were stabbed to death during a feud with their juniors in Patuakhali's Baufal around 4:00pm yesterday.

The victims are Nafis and Siam, grade-X students at Indrakul Secondary School, said Al Mamun, officer-in charge of Baufal Police Station.

After their classes were over for the day yesterday, they headed towards home. On the way, they locked into a feud with some junior students, he said.

At one point, they were stabbed allegedly by some students of grade-IX. Hearing their hue and cry, locals rescued them and rushed to Baufal Upazila Health Complex. They were then referred to Sher-e-Bangla Medical College Hospital in Barishal as their conditions were critical, he added.

They breathed their last at the hospital around 7:30pm, he further said.

Police are trying their best to arrest the attackers, the police officer said.

Hajj package cost cut by Tk 11,725

The government yesterday reduced the cost of hajj packages by Tk 11,725 after Saudi Arabia cut the service charges for pilgrims worldwide.

Pilgrims willing to perform hajj this year under government management will have to pay Tk 6,71,290 each, while those willing to perform the ritual under private management will have to spend Tk 6,60,893 each, said an emergency circular of the religious affairs ministry.

Meanwhile, the government has extended the deadline for hajj registration to March 27 from March 21.

Once the registration quota of 1.27 lakh is reached, the registration process will close automatically.

Sri Lanka's president yesterday warned of more economic pain to come for the crisis-hit nation, with strict austerity measures needed to restore its ruined finances after an IMF bailout deal.

The International Monetary Fund approved its long-delayed rescue package on Monday after China, the South Asian island's biggest bilateral lender, offered debt relief assurances.

President Ranil Wickremesinghe lauded the deal in a speech to parliament as a milestone in Sri Lanka's recovery from last year's unprecedented economic crisis.

But he also told lawmakers that the bailout was only the first step in more difficult structural reforms.

But fair price remains a distant reality in the country, said Mosammat Khanum, former Nazmanara secretary of the food ministry.

"It's like a cat and mouse game. When the prices of essentials shoot up on different occasions, drives are carried out. Those only bring some temporary relief, but the problem persists," she said. Consumers have been struggling to cope with the price volatility for about two years. The situation worsened in the last six months after the overall inflation rate hit 9.5 percent in August last year, the highest in 12 years. The food inflation also increased during this period because of the economic crisis stemming from the Russia-Ukraine war and the Covid-19

pandemic. LAWS THERE, BUT ENFORCEMENT LAX

The Section 19 of the Agricultural Marketing Act says that a person will be sentenced to a maximum of one year in prison or fined Tk 1 lakh or both for creating an artificial crisis of farm produce, agricultural ingredients and essential goods and making an more profit than that fixed by the government.

Creating obstructions to the transportation of agricultural goods, cheating in weighing, not displaying both wholesale and retail prices at visible places, and failing to supply goods from stocks as per the government's directives during a crisis period are also punishable offence as per the law.

For similar offences, the Consumers Right Protection Act and the Control of Essential Commodities Act have stipulated different punishments.

The food ministry is working on amending the Control of Essential Commodities Act to incorporate in it a provision for capital punishment for hoarding, said officials.

"There are many laws in our country but the problem lies in their implementation," said Mohammad Yusuf, a former director general of DAM.

the three government Of organisations, the DAM works closely with farmers for marketing of agricultural products.

Last year, the department fixed the profit margins for retailers of essentials after a meeting with the stakeholders. But there was no visible monitoring afterwards.

The former DAM chief said one single organisation should be tasked with market monitoring.

Food ministry Secretary Ismiel Hossain said his ministry mainly looks after the prices of rice and wheat while the agriculture ministry monitors the prices of agricultural products and commerce ministry keep a watch on the prices of other essentials.

He claimed that there is no lack of coordination between the three organisations as the Cabinet Division oversees the matter.

Omar Md Imrul Mohsin, DG of DAM, said though the Agricultural Marketing Act allows his department to punish market manipulators, it could not enforce the law properly due to lack of its magistracy power.

"We sought magistracy power, but we have been denied. We depend on others to conduct drives," he said.

AHM Shafiquzzaman, DG of the Directorate of National Consumers Right Protection, said the directorate carries out drives to check whether sellers charge people extra for commodities and create instability in the market.

Asked about the reason for high prices of chicken and beef despite drives, he asked this correspondent to talk to the livestock department.

SM Nazer Hossain, vice-president of the Consumer Association of Bangladesh, said the three departments were formed to ease consumers' sufferings, but they failed to do so.

He suggested setting up consumer affairs ministry to look after the welfare of the consumers.

Meeting sources said the two sides had a detailed discussion on the election, election observers, the recently published annual human rights report by the US, and some other issues.

"They [US] said they want a free, fair and inclusive election. However, they don't favour any party," an AL source told The Daily Star.

The US side said they don't have an opinion about whether there should be a caretaker government or not during the election, slated to be held late this year or early next year.

"What the US wants is an election in which all political forces have equal rights," the source said.

"We told him our Election Commission and even the president invited the BNP for dialogue, but the party did not attend either, which shows its lack of sincerity.'

He also said the AL delegation raised some observations regarding the US' annual human rights report, which said the 2018 national polls were neither free nor fair.

The report also mentioned the shrinking freedom of the press, abuse of the Digital Security Act, and enforce disappearances.

It added that only seven of the 22 Election Working Group NGOs were approved by the home ministry, NGO Affairs Bureau, and the Election Commission to observe the 2018 election.

In a confessional statement, Rabiul's wife Suriya Akhter Keya, another accused in the case, said he and his cohorts rented the flat to run a sex racket.

Wealthy men would be invited there on various occasions, such as birthday parties, and get tricked into posing for indecent photos, so they could be blackmailed later.

Keya was told by an aide that Rahmat Ullah, an engineer by profession, could be a potential target. She shared the information with Rabiul, who planned to bring him to the flat.

Being invited to a "birthday party", Rahmat asked his police inspector friend Mamun to join the gathering.

As Rahmat and Mamun reached Banani, Keya and two other girls of the gang took them to the flat.

As the two were sitting in a room, Rabiul's cohorts Swapan, Didar, Atik and Mizan came in and introduced themselves as law enforcement members and started to charge them for being there for "anti-social activities".

As Mamun identified himself as a police officer and challenged them, the four started beating the officer indiscriminately. They tied up his hands and gagged him. At one stage, Mamun fell unconscious.

Rabiul, who was then outside the building, left for his Aftabnagar residence around 10:00pm, and more.

To confirm the officer's death. Rabiul asked Swapan to cut a toe from Mamun's feet to see if blood gushed out from the wound. The body was dumped in a Gazipur bush and burnt the next day.

Rabiul also paid Tk 1,000 for refilling the car -- in which the body was carried for dumping -- at a gas station in the city's Khilkhet.

PROBE AND TRIAL

Police submitted a probe report before a Dhaka court in 2019 containing details of the murder.

According to the report and statements of the four accused, Rabiul took the police officer's motorcycle from the Banani flat and handed it over to Swapan to sell it.

As Swapan failed to find any customer for it, Rabiul asked him to leave the bike on the premises of Dhaka Medical College Hospital, from where it was later recovered.

On March 31, 2019, investigation officer Sheikh Mahbubur Rahman, an inspector of the Detective Branch of police, pressed charges against 10 people, including two minors.

On November 25, 2021, Additional Sessions Judge's Metropolitan Court-1 of Dhaka framed charges against eight people -- Rabiul Islam, Rahmat Ullah, Swapan Sarker, Didar Pathan, Mizan Sheikh, Atik Hasan, Suraiya Akter Keya, and Sarowar Hossain.

The court set April 9 for the next hearing in the case.

In addition, the Juvenile Court-7 of Dhaka framed charges against two minor girls in the case on November 11, 2019.

Swapan, Didar, Mizan, and Atik in their statements said Rabiul "employed" them for the Banani flat to look after the sex racket and extort money.

Keya, who made her confessional statement to a magistrate after her arrest in connection with the murder, went into hiding after obtaining bail.

While Rabiul was never arrested, six others are behind bars.

Out of 38 prosecution witnesses, only complainant Jahangir Alam Khan testified before the court.

train was seen coming from Kamalapur. But the traffic congestion made it impossible for the bus to leave the tracks.

Witnesses said the train operator saw these and slowed it down.

After hitting the bus, the locomotive dragged it for around 100 feet before coming to a complete stop, blocking DIT Road and the rail lines.

Soon afterwards, the Dewanganj Express, which was going towards Kamalapur, had to stop at the levelcrossing because of the bus.
