## Little room for trimming as austerity fails

In the end, was the government's austerity stance just lip service?


After rolling back most of the austerity measures earlier this month, the government's apathy towards prudence was reflected in the revised budget.

In the revised budget, more allocation has been made for interest payment and subsidies for food, agriculture and power, while funds were made available for resumption of normal service after the retraction of austerity measures.

As a result, the budget could be downsized by about 3.6 percent to Tk 654,537 crore, The Daily Star has learnt from finance ministry officials involved with the proceedings.

On the first day of the fiscal year, the government announced several austerity measures such as bans on vehicle purchases and foreign trips and reduced allowances for petrol, oil, fuel, lubricant and gas.

Now, vehicle purchase is allowed, while the ministries and divisions can spend up to 80 percent of their



allowance for petrol, oil, fuel, lubricant and gas. Only the ban on foreign tours by government officials remains.

As a result, Tk 11,500 crore has been made available for these purposes in the revised budget, down from Tk 18,000 crore in the original budget.

In other words, it can be assumed that the austerity measures yielded savings of about Tk 6,500 crore.

"Although the allocation is there in the revised budget, the total amount might not be spent at the end of the year," said one of the officials on the condition of

For instance, the ban on foreign tours remains but some officials need to go abroad out of extreme necessity. "So an allocation was kept to accommodate such trips," the official added.

In the revised budget, the government's subsidy for the power sector has increased by a staggering 59 percent to Tk 27,000 crore despite the recent increases in the electricity price.

At a time when fuel and energy prices are on the decline around the world, the government thrice increased the electricity price by 5 percent each time this year.

However, the subsidy for liquefied natural gas purchase has been slashed by a third to Tk 4,000 crore as LNG prices plunged more than 70 percent since the start of

Commodity prices soaring due to domestic reasons

#### Says CPD; rice, sugar, soybean oil pricier here compared to other developing countries

Prices of essentials are rising sharply and going beyond the people's reach due partly to domestic reasons, including market distortions by a small number of dominant firms and lax regulations, said the Centre for Policy Dialogue

The CPD made the observation at an event titled "CPD's Recommendations for the National Budget FY2023-24", held at its office in the capital's Dhanmondi.

There are some essentials such as rice, sugar, soybean oil and beef that are more expensive in Bangladesh than in other developing or industrialised countries, said Fahmida Khatun, executive director of the think-tank.

Many families, including those having minimum wage earners, are struggling to afford them. So, many of them are excluding meat and fish from their menus, she said.

Comparison of prices shows that the prices of essentials don't fall in Bangladesh even when the international prices decline. Moreover, the prices of some food items have remained consistently higher at home than those in the global markets, according to Fahmida.

At least 28 imported essential food items carry high

incidence of tax, she observed.

"In the backdrop of the soaring inflation, the National Board of Revenue should reduce the duties and taxes both at the import and domestic levels in order to provide some respite to consumers with low and limited incomes."

## 'We'll deliver justice'

Says HC voicing concern that state hasn't filed case

The High Court has expressed grave concern and resentment as the state has not filed any case after the death of Sultana Jasmine in Rab custody.

"Her death in law enforcers' custody after sustaining injury in the head has become a burning issue in the country. A case has to be filed in connection with the incident.

"If her family cannot lodge the case, the state has the responsibility of filing one. The people of the country want justice to be delivered on the matter. We will deliver justice," the HC bench of Justice Farah Mahbub and Justice Ahmed Sohel told Assistant Attorney General Md Abul Kalam Khan Daud during a hearing on the issue yesterdav.

## SULTANA'S DEATH IN CUSTODY

# She had head injury, cause still unknown

Sultana Jasmine, a union-level land employee in Naogaon who died in the custody of Rapid Action Battalion on Friday, had suffered a head injury along with brain haemorrhages but what caused it all remains unexplained.

Forensic doctors at Rajshahi Medical College (RMC) conducted an autopsy a day after her death that triggered a barrage of criticism from human rights groups with the High Court asking questions.

"Sultana Jasmine suffered an injury to her head apart from haemorrhages in her brain," said Associate Prof Kafil Uddin, who led a three-member board

formed to conduct the autopsy. The team sent to RMC's sample pathology department for a histopathological report.

"We will know the ultimate cause of her death after the report is available," added Kafil Uddin, head of forensic medicine department at the

college.

Sultana, 38, an office assistant Naogaon Municipality-Chandipur Union Land Office, was picked up by a Rab-5 patrol team on Wednesday while she was walking to her office from



Later in the day, she was taken to Naogaon Sadar Hospital and then to Rajshahi Medical College Hospital, where she breathed her last on Friday, according to hospital

authorities. In her death certificate, the cause of death is stated as SEE PAGE 2 COL 1

Police on Sunday evening sued 265 BNP men in two cases field in Netrakona's Durgapur upazila over alleged attack on police and obstructing police in performing their duties that morning.

## 7 injured in Sweeper Colony fire

Two children were among seven people who suffered burn injuries in a fire at an illegal slum under the Mayor Hanif Flyover near the Sweeper Colony in Dhaka's Wari early yesterday.

They were rushed to Sheikh Hasina National Institute of Burn and Plastic Surgery and the burn unit of Dhaka Medical College Hospital with up to 10 percent burns, said hospital sources.

At least 40 shanties were burnt after the fire broke out at the slum near Joy Kali Temple around 3:15am.

Seven fire engines doused the blaze around 6:45am, said Rakibul Hasan, duty officer of Fire Service and Civil Defence control room.

The cause of the fire could not be

## Female shooter kills 6 in Nashville school attack

A female shooter killed three children and three adults at a private Christian school in Nashville of the US's Tennessee state vesterday before police shot her dead. The assailant appeared to be a teenage girl, police said.

Police began receiving calls at 10:13am of a shooter at The Covenant School, which teaches children up to 6th grade. Officers could hear gunfire coming from the school's second floor, Don Aaron, a spokesperson for Metropolitan Nashville Police Department, told reporters.

The shooter had at least two semiautomatic rifles and a handgun, Aaron said. Two officers from a five-member team shot at her in what Aaron described as a lobby area and she was dead by 10:27am.

"We do not know who she is at this juncture," Aaron said.

Three students were pronounced dead after arriving at Monroe Carell Jr Children's Hospital at Vanderbilt with gunshot wounds, John Howser, a hospital spokesperson, said in a statement. Three

adult staff members were killed by the shooter, police said. Besides the deceased, no one else was

shot, Aaron said. Students' parents were told to gather at

a nearby church.

The Covenant School, founded in 2001, is a ministry of Covenant Presbyterian Church in the Green Hills neighbourhood of Nashville with about 200 students, according to the school's website. The school serves preschool through 6th graders and held an active shooter training program in 2022, WTVF-TV reported.

Nashville Mayor John Cooper expressed sympathy for the victims and wrote on social media that his city "joined the dreaded, long list of communities to experience a school shooting."

Deadly mass shootings have become commonplace in the United States, but a female attacker is highly unusual. Only four of the 191 mass shootings since 1966 catalogued by The Violence Project, a nonprofit research centre, were carried out by a female attacker.

### Man to die for killing wife in Satkhira

## 'BROUGHT UNCONSCIOUS' TO

Sultana was admitted to the Naogaon hospital at 1:15pm on Wednesday, according to Dr Zahid Newaj, superintendent of the hospital, which means she was taken there within one hour and 25 minutes of her detention.

She was then showing symptoms like dizziness, nausea, physical weakness and vomiting. At 3:05pm, her condition started deteriorating when she developed breathing problems, the doctor said.

Doctors then referred her to RMCH or Ziaur Rahman Medical College Hospital in Bogura at 3:55pm, and she was taken out of the hospital for RMCH at 7:00pm.

During her admission to RMCH, Rab officials stated that she had suffered a head injury from a fall, said hospital officials.

According to RMCH Director Brig Gen FM Shamim Ahmed, Sultana was brought by Rab officials in an unconscious condition at 9:20pm on Wednesday.

"She was unconscious and was immediately rushed to the neurology ward. From there, she was transferred to the intensive care unit because her condition continued to deteriorate. We did a CT scan and found multiple intracranial bleeds in her head," he

They also found an external bruise on her head and her health deteriorated too fast on Thursday, he

Sultana died in the ICU at 10:00am on Friday.

Though the RMCH director on Sunday said Sultana was brought to the hospital on Thursday, yesterday he told The Daily Star, "I stand corrected. I mistakenly said that. She was admitted on Wednesday."

THE DSA CASE A day before Sultana's death, Enamul Haque, the local government director at the office of Rajshahi divisional commissioner, filed the case under

Sultana was the second accused in the case while the prime accused was Al Amin, 32, of Chandpur. The case document says she was picked up at

11:50am on Wednesday.

The two were made accused of hacking Enamul's Facebook ID and using it to con people by luring them with jobs.

Director Md Masud, detained Enamul in the case said he learnt

from his assistant clerk named Md Jamal that the accused swindled some persons in front of his office in Rajshahi city on March 19.

He further stated that he went to Naogaon on an official tour on Wednesday. On his way, he met the Rab-5 patrol

team at the Naogaon Bus Stand and informed them that his Facebook ID was being used to swindle people. Talking to this newspaper at his

office yesterday, Enamul claimed he informed the Rab team that one Sheikh Arif of Barishal told him about Sultana's bank account.

And Arif was asked from Enamul's hacked ID to make a payment to that bank account for a government job.

The Rab team took Enamul with them and located Sultana at Muktir Mor in the town, read the case

It also stated that Rab members interrogated her there and she admitted before Enamul, the officers and locals that she was involved in swindling people.

Rab also seized her smartphone in which evidence of transactions in her Sonali bank account was found, it added.

'TAKEN TO UNKNOWN LOCATION' Although the case stated that Sultana was interrogated by Rab members at Muktir Mor, her family members said she was picked up from the spot and taken to an unknown location.

"We heard about her arrest between 9:30am and 10:00am. Then we checked with the police and detectives and looked for her for several hours. We then found her at the Naogaon hospital," said her maternal uncle Nazmul Haque

Montu said when he went to the Naogaon hospital to see her around noon, he found two female Rab members in uniform on both sides of

Rab men in plainclothes were surrounding her when she was unconscious and having breathing

"She opened her eyes once but fainted soon after seeing the Rab

members," he said vesterday.

Montu had asked the two female Rab officials why they were beside her bed. They told him to talk to their superiors. A Rab member in Enamul was present when a Rab-5 plainclothes showed him a photo patrol team, led by Deputy Assistant saying he is a high official named Enamul and Sultana Facebook ID to con people.

"I left the hospital few moments later as I didn't dare stay there alone."

Montu said a sense of fear had been prevailing at Chalkdeb Jonokolyan Moholla in Naogaon town, where Sultana, a divorcee, lived with her only son in a rented house.

When a group of journalists visited the area on Monday, the house was found vacant. Even the house owner was unavailable.

None of the neighbours agreed to talk and Montu took the journalists to a distant location to speak with

He claimed to have received a call from a Rab official on Wednesday afternoon, and the caller asked him to visit her again at the Naogaon hospital.

He sent Aminul Islam, Sultana's brother-in-law, to the hospital, hoping to join him after evening

As soon as Aminul reached there, Rab members left for RMCH with Sultana and Aminul. "They were trying to show that the treatment was going on in the presence of Sultana's relatives," Montu said.

He also claimed plainclothes Rab members have been guarding their area round-the-clock since her death. **RAB VERSION** 

Meanwhile, Commander Khandaker Al Moin, director of the legal and media wing of Rab, told The Daily Star that they had arrested the woman based on specific complaints. "We have found proof of transaction of around Tk 20 lakh from the woman's account," he said.

"Soon after the arrest, she fell sick and we rushed her to the Naogaon hospital. Later, she was shifted to Rajshahi Medical College Hospital for better treatment. She was not even taken to the Rab camp after the arrest," he said.

She was provided treatment at the hospital under family's observation, the director claimed.

"Still, if any Rab members are found involved in any irregularities, we will take action following proper investigation," he added.

The AAG informed the court that no case was filed in this connection and the body was handed over to the family after an inquest and an autopsy.

Lawyer Manoj Kumar told the HC bench that a case was filed against Sultana under the Digital Security Act more than 31 hours after she

was detained, and that she was not

produced before any court during this period which is illegal.

He prayed to the HC bench to pass necessary directives on this matter. The court asked the lawyer to move

a writ petition before this court in this

regard and fixed today for its hearing and passing orders on the matter. Meanwhile, different human rights organisations yesterday expressed grave concern over Sultana's death

and demanded a fair and neutral probe into the incident. They also demanded appropriate legal action against those responsible for the death and ensuring their

accountability. In a statement, Ain O Salish Kendra said it is evident from the family's allegation, doctor's statement and media reports that the provisions of the constitution and related laws have been violated in detaining and

interrogating Sultana in Rab custody. Though this is not the first allegation against the law enforcers, allegations of torturing people and deaths in custody are raised very often, the rights body said.

Human Rights Forum Bangladesh in another statement said though the Rab claimed that Sultana died while receiving treatment at Rajshahi Medical College Hospital after suffering a brain haemorrhage, her family members alleged that she died of torture in custody.

The allegations brought by the family have to be looked into and justice must be ensured, it said.

Sultana was detained before a case

was filed against her; she was illegally interrogated and police were not informed about the actions which is an example of violation of the constitution, fundamental principle of human rights, Supreme Court directives, and existing laws, the statement added.

# Draw beyond censorship

Political cartoons have slowly been lifted off from the face of print and digital media due to a growing intolerance

Many cartoonists need to resort to self censorship, although the country had once witnessed a glorious history of such caricatures, said cartoonists at a panel discussion yesterday.

The discussion was organised as part of an exhibition of political cartoons in Dhaka.


Earki, a satire platform, in collaboration with Bangladesh Cartoonists Association and EMK Center, held the three-day exhibition at the EMK Centre in Dhanmondi.

#### **DSA CASE** Inspector fined Tk 5 lakh for remarks against JS whip

COURT CORRESPONDENT

A Dhaka tribunal yesterday fined a suspended police inspector Tk 5 lakh in a case filed over remarks on social media against parliament whip Shamsul Haque Chowdhury September 2019.

Judge AM Zulfiker Hayet of Dhaka Cyber Tribunal found Mahmud Saiful Karim alias Saif Amin guilty and pronounced the punishment, said Special Public Prosecutor Nazrul Islam Shamim.

"If the inspector fails to pay the fine, he will have to serve 18 months in jail," the judge said in his judgment.

Soon after the verdict, the convict submitted two applications, seeking bail and seven days for payment of the fine. Both were granted by the judge.

#### Police arrests 2 DU students on assault charges

arrested members of "Prolov Gang", a group based at Dhaka University, yesterday for allegedly assaulting a fellow student on campus on Saturday evening.

The arrestees -- Naimur Rahman Durjoy and Faysal Ahmed Sakib -- were sent to jail after being charged by victim Zubaer Ibne Humayun's mother, who filed a case against 19 university students with Shahbagh Police Station on Sunday night.

Zubaer, a criminology department student and leader of the social science faculty's BCL unit, was reportedly beaten by the gang members.

said the Witnesses incident began when a speeding car splashed muddy water on Zubaer and his friends near the faculty building on Saturday evening. After chasing down the car near Tin Netar Mazar area for an explanation, a quarrel ensued with those inside the car.

About an hour later, Zubaer received a phone call asking him to come to the Kabi Jasimuddin Hall area. When he arrived, a group of around 15 students, some of whom are also BCL activists, allegedly attacked him with sticks, cricket stumps, and leather belts.

The incident condemned by a group of teachers and students from the criminology department demanded justice for Zubaer, standing in solidarity with him at the base of Raju Memorial Sculpture yesterday.

# Revisiting memories of struggle and sacrifice

You are looking at a large portrait of Bangabandhu, depicting his powerful speech on March 7, 1971. An audiovisual of the precise moment in history plays in the background, making you feel as if you are experiencing the historical moment

But your mood takes a sudden turn as you enter the next room. A dark tunnel leads you towards a bright light that momentarily blinds you. As you adjust your eyes, you realise the source of the brightness: a Pakistani soldier's jeep crashes through the wall, its headlights shining brightly.

You find transcripts that display conversations between Pakistani army personnel on how they planned operation searchlight. You witness the violence and brutality

the Pakistani army inflicted on innocent civilians on the night of March 25, 1971. The Liberation War museum, situated

in Dhaka's Agargaon, is where you can get this vivid experience. The 3D visuals described above can be "Our Rights, Our Sacrifice"

In this gallery, the dark tunnel provides a haunting portrayal of the horrors of the night. It showcases the sheer devastation wrought upon the country, with countless large photographs, diaries written homes and businesses burned to the by freedom fighters detailing their



Visitors can witness the tragedy through an elaborate collection of photographs, videos, and symbolic forms, which may elicit fear and discomfort. However, this is the harsh reality that Bangalees had faced that night.

The museum boasts an impressive

witnessed in the second gallery named collection of over 20,000 monuments showcased across four exhibition galleries, designed by the talented architects

Tanzim Hasan Salim and Naheed Farzana. The museum's exhibition halls feature experiences on the battlefield, and letters they wrote, weapons they used, and much more information on their struggle, presented through paper cuttings and historic documents.

The first gallery named "Our Tradition, Our Struggle" starts with displaying maps of ancient Bengal and the Indian independence movement against British rule. It features artefacts from prehistoric times to 1970, including relics from the Pal, Sen, and English periods, as well as

items related to the Language Movement. Then the exhibition gradually depicts the revolts, uprisings, and the various stages of the 1971 war through different displays and exhibits.

The third gallery -- "Our War, Our Allies" showcases the Bangalee's struggles and sacrifices during the Liberation War.

## ARCHITECT IMTIAZ MURDER 'Blackmailing racket tortured him to death'

STAFF CORRESPONDENT

Architect Imtiaz Mohammad Bhuiyan was trapped by an app-based blackmailing racket and was tortured to death at a Kalabagan flat as he refused to pay money to them.

The Detective Branch (BD) of Dhaka Metropolitan Police said this after arresting three persons from different areas in connection with the sensational murder.

They are Millat Hossain Munna, 19; Anwar Hossain, 38; and Ehsan alias Megh Hijra, Harun Or Rashid, chief of DMP's Detective Branch told reporters at his office in Dhaka yesterday.

Imtiaz went missing on March 7 after he went out of his Tejgaon residence. His wife Fahmida Akhter later filed a general diary with Kalabagan Police Station.

Meanwhile, Munshiganj police recovered his body from Chitrakot Kamarkanda Bridge area in Sirajdikhan on March 8. Anjuman Mufidul Islam, a voluntary organisation, buried him on March 9 as an unclaimed

The family following a media report later identified the body as that of Imtiaz.

Briefing reporters yesterday, Harun said at least five persons took part in the killing and they are trying to arrest two others.

Police from Narayanganj recovered a car that was used to carry the body to Munshiganj from Dhaka, he said.

The DB official said the racket used to run a dating app, and Imtiaz got acquainted with one of the racket members Alif, who is on the run, through the app.

As the Imtiaz called Alif on March 7, and Alif asked him to come to a flat in Kalabagan area. The other accused then started blackmailing victim

## **Breaking fast** while catching a train

Kaspia, a sixty-year-old woman, sat under a tree on a bench next to the platform at Kamalapur Railway Station in Dhaka, waiting for her son to return with iftar items. She had never broken her fast in a railway station before, but keeping the traffic situation in mind, she had no choice but to come early as she had to catch a return train from Dhaka shortly after iftar.

As she sat there, she noticed Syed Mahbub Alam, a man from Bogura, who was waiting with his wife and daughter to break their fast on the platform. Despite not being in the comfort of their home, they were determined to carry out their religious obligations.

Khadiza Aktar, a medical student from Bajitpur of Kishoreganj, was also waiting for her train with her father, having purchased boxes of iftar items from a nearby shop. She had been living in a hostel in Dhaka for several months for medical admission purposes and was now returning home.

The railway platform had turned into a makeshift iftar gathering, as many passengers sat on benches and waited for the azan of magrib to signal the breaking of their fast. Md Faruk Hossain, who had come to Dhaka for legal purposes with his elder brother, said that doing iftar with family members at home was a different experience

## Teacher plotted torture of father, son: police

The incident of torturing a father and his son in a Faridpur school classroom "over rape" was a teacher's ploy to get custody of the man's girl, said police.

İsrat Zahar Lipi, 44, an assistant teacher of Aruakandi Government Primary School under Faridpur's Madhukhali upazila, was the mastermind of the plot, said police.

"She [Lipi] incited the incident to take guardianship of the man's girl," said Md Shahjahan, the district's superintendent of police (SP), in a press conference at his office.

However, Lipi denied the allegation.

The eight-year-old girl lives with her father Yamin Mridha, 40, and step brother at Majkandi area under Madhukhali upazila.

'The girl's mother died when she was born. Lipi does not have a child. The teacher liked the girl so much since she was admitted to the school. She often took the child to her residence," the SP added.

But the girl's father did not like it. As a result, a feud grew between the teacher and the father.

On March 17, the teacher called the child's father and step brother to the school. Then, some locals along with the teacher confined them inside a classroom and brought a "false" allegation that the step brother raped the girl. Then, the people brutally tortured the father and son, said the SP.

On March 20, Yamin Mridha filed two cases with Madhukhali Police Station. One was field against 13 people for torturing him and against his son

## 'Re-excavate Pakhimara canal' Farmers demand at human chain

Hundreds of farmers staged a human chain yesterday demanding the re-excavation of Pakhimara canal in Patuakhali's Kalapara upazila for agricultural purposes.

Farmer Zakir Hossain Gazi, development worker Iman Al Ahsan, farmer Quddus Hawladar and others spoke at the programme.

Farmer Zakir Hossain Gazi said about 20,000 farmers of 11 villages on both sides of the 10-kilometre-long and 500-foot-wide Pakhimara canal cultivate vegetables, aman and boro paddy, along with vegetables throughout the year by conserving fresh water. However, around half a kilometre of the Kumirmara section of the canal has been filled up.

"It is now a football field. Motorcycles run in the area. Farmers on both banks are unable to cultivate crops in their fields. This is a disastrous situation for agriculture," said Zakir.

Farmers also said if the government permits, they can continue agricultural production by digging and conserving fresh water on their own initiative. "We don't want relief. We just want fresh water from the canal for our work," one demanded on behalf of others.

In this regard, Kalapara Upazila Agriculture Extension Officer ARM Saifullah said efforts are underway to dig the canal to conserve fresh water.

Contacted, Kalapara Upazila Nirbahi Officer Jahangir Hossain, said necessary measures will be taken to dig the canal for the benefit of farmers.







Bazar Sadar upazila on January 7. "Dr Mahbubur and Dr Titu had arranged for our stay at a dormitory of Bangladesh Medical Association that night, saying many of our colleagues would also be there. But when we got there, we found we were the only ones staying over."

"A little while later, Dr Titu called and said he and the civil surgeon would soon be coming to our room. As we didn't want to be alone with them, we fled the dorm right away.

"Later, I got another call from Dr Titu. He said the civil surgeon was very angry because we left without meeting them."

On January 30, the day the allegations came to light, Bangladesh Nurses Association and Bangladesh Diploma Nurses Association issued statements, condemning "the acts of sexual harassment committed by the officials using their position of authority".

They also demanded the health ministry initiate an impartial investigation into the harassment allegations and remove the accused from their duties within 48 hours.

#### FORCED TO ST MARTIN'S

Talking to The Daily Star recently, Hena Parvin, nursing supervisor at the Teknaf Upazila Health Complex, said she wanted a written order from Dr Titu when he asked on January 24 for the nurses to go to the island.

"However, he threatened me saying it was a direct order from the civil surgeon. I had no alternative but to comply," she claimed.

According to the complaint, after lunch on January 25, Dr Titu pressured the two nurses to go to the Parabar Beach Resort on the island, where the civil surgeon was staying.

"When we arrived, Dr Titu asked everyone there to leave except for us. At one stage, he started making lewd suggestions to us to entertain the civil surgeon and forced us to enter the latter's room," the complaint

The nurses left the place saying they needed to return to the hospital. The civil surgeon asked them to

come back in the evening (to join the

"When we went there in the evening as instructed, we found the civil surgeon and Dr Titu dancing and singing. When we tried to leave, Dr Titu got in the way. He grabbed one of us and said 'you are here to entertain the civil surgeon'. He tried to force us to dance with the civil surgeon. But we managed to avoid it and leave the place," the complaint

In the complaint submitted to the health ministry, the nurses also mentioned that they had audio and video clips of the incident.

The Daily Star has the video footage of the incident.

Contacted, Dr Titu Chandra Das said the allegations against him were baseless and intended to tarnish his reputation.

"As there was no nurse on the island, the civil surgeon wanted a nurse and a midwife to attend to the patients there. Why should I force them to go there? It was the upazila health and family planning officer of Teknaf who ordered them to go there." Titu claimed.

However, Dr Ali Ahsan, the then upazila health and family planning officer of Teknaf, said the nurses did not go to St Martin's Island on his orders. "They had to go there on the order of Dr Mahbubur and Dr Titu. And I was powerless to do anything about it."

Moreover, Dr Ali said he has lately been transferred to Patuakhali as he did not take departmental action against the nurses upon Dr Mahbubur's order. When queried, Cox's Bazar Civil

Surgeon Mahbubur Rahman claimed he was unaware of any complaints lodged against him. He also denied inviting any nurses

to his room when he stayed at the Parabar Beach Resort on the night of January 25.

Md Saidur Rahman, additional secretary (administration) Health Services Division of the health ministry, said they had received the complaints and would take necessary action after an investigation.

Of the estimated cost (Tk 6,114.48 crore), Tk 4,250.56 crore is expected to come from foreign funds, while the rest is to be paid by the government.

A BR official said the nearest rail line in the Indian side from Sonamasjid land port is around 12km from the border.

"If Indian Railway takes initiative to expand it towards the Bangladesh border, Sonamasjid and Mahadipur of West Bengal's Maldah can be another railway interchange between the two neighbouring countries," he

Currently five railway interchanges between the two countries are in operation -- Darshana (Bangladesh)-Gede (India), Benapole (Bangladesh) Petrapole (India), Rohanpui (Bangladesh)-Singhabad (India), Birol Bangladesh)-Radhikapur and Chilahati (Bangladesh)-Haldibari (India).

Rohanpur is situated in Chapainawabganj.

## 'Grim' criminal abuse of ChatGPT is coming: Europol

Criminals are set to take advantage of artificial intelligence like ChatGPT to commit fraud and other cybercrimes, Europe's policing agency warned yesterday. From phishing to disinformation and malware, the rapidly evolving abilities of chatbots will be used not only to better mankind, but to scam it too, Europol said in a new report. Created by US startup OpenAI, ChatGPT appeared in November and was quickly seized upon by users amazed at its ability to answer difficult questions clearly, write sonnets or code, and even pass exams. "The potential exploitation of these types of Al systems by criminals provides a grim outlook,' The Hague-based Europol said. Europol's new "Innovation Lab" looked at the use of chatbots as a whole but focused on ChatGPT during a series of workshops as it is the highest-profile and most widely used, it said. Criminals could use ChatGPT to "speed up the research process significantly" in areas they know nothing about, the agency found. This could include drafting text to commit fraud or give information on "how to break into a home, to terrorism, cybercrime and child sex abuse," it said. The chatbot's ability to impersonate speech styles made it particularly effective for phishing, in which users are tempted to click on fake email links that then try to steal their data, it said. ChatGPT's ability to quickly produce authentic sounding text makes it "ideal for propaganda and disinformation purposes, as it allows users... reflecting a specific narrative with relatively little effort."

## **ROHINGYA REFUGEES** Nearly 200 land in Indonesia's Aceh

At least 184 Rohingya refugees, including many women and children, landed in Indonesia's westernmost province yesterday, officials said, after they were dropped at sea by boat and made to swim ashore. Thousands



mostly Muslim Rohingyas, persecuted in Myanmar, risk their lives each year on long and expensive sea journeys, often in poor-quality boats, in an attempt to reach Malaysia or Indonesia.

Locals in the East Aceh town of Peureulak alerted

police yesterday morning after discovering the group that officials said included 94 men, 70 women and 20 children. "There was no boat on the beach when they arrived," Nasri, the head of Peureulak subdistrict who, like many Indonesians, has one name, told AFP.

"There are some refugees who look weak, they probably have not been eating for days."

At least five were taken to hospital, while others were taken to a mosque compound for shelter, food and medical treatment, he said.

An official from East Aceh social affairs agency, Saharani, confirmed the same arrival total to AFP.

A United Nations refugee agency (UNHCR) spokesperson said it was still gathering information on the new arrivals. According to one of the passengers, they were dropped

offshore and told to swim to land by the boat's captain. "After that, the ship we were on immediately left," Rohingya refugee Ali told state news agency Antara. The refugees were trying to reach Malaysia from Myanmar, Ali

## We demand an independent probe

#### Rab's way of operation needs an overhaul

The untimely and cruel death of a young woman who was in the custody of the Rapid Action Battalion (Rab) raises a number of questions and concerns. The woman, an employee of a Naogaon union parishad land office, died in the custody of Rab-5 after suffering haemorrhages of the brain. She was picked up at 10am on March 22 when she was on her way to Chandipur Union Land Office, where she worked as an office assistant. However, just 48 hours later, on March 24, she was declared to have died at the Rajshahi Medical College Hospital.

According to Rab, the woman died after suffering a stroke. But her family members said she was in perfect health. So, why would she suffer from a stroke while in Rab's custody? In fact, why is it that so many people who were apparently in perfect health, according to those who knew them, suffered from fatal health issues while in the custody of our law enforcement agencies? Shouldn't that be a major concern? According to doctors, the woman in question had an external bruise on her head as well as multiple intracranial bleeds. Rab's explanation for that was that she had fallen down. So again, we must ask, why do people so frequently fall ill, have accidental injuries, or suffer from fatal health problems suddenly while in Rab's custody? How is the Rab handling its detainees that such incidents have become so common?

On that same topic, why did the Rab record her case - of syphoning off money from job seekers using a Facebook account, under the Digital Security Act (DSA) – more than 31 hours after she had been picked up and when she was unresponsive in a hospital bed? According to Rab, there were allegations of unusual transactions in her bank account, which it found to be authentic after scrutinising her bank statement. So why is it that the case was not filed earlier? The incident raises serious questions about Rab's way of conducting its operations, as did another occurrence only a few days ago, on March 17, which had resulted in the death of a 65-year-old man during a shooting incidence; another victim was also shot in the leg. Neither of them, however, had any involvement with

Needless to say, all such unexplained occurrences have resulted in a deep sense of injustice building up among the people – particularly because, in many cases, Rab's version of the story differs substantially from that provided by witnesses and others. Unfortunately, we never see any independent investigation being conducted to find out the truth and clear the air, despite repeated calls to do so.

We are heartened by the High Court passing an order suo moto, wanting to know the details of Rab personnel involved in arresting and interrogating the woman. We would, however. like to plead to the court to launch an investigation into the incident. Given the numerous serious allegations against Rab, as well as the imposition of international sanctions, independent investigation is the only way of restoring the government's already dwindling credibility when it comes to handling such deaths.

## A riverine horror show

#### Saga of three rivers a reminder of how catastrophically mismanaged our rivers are

Not long ago, a study by the Rivers and Delta Research Centre (RDRC) revealed that 56 rivers across the country are suffering from extreme pollution. It was an alarming if not entirely shocking revelation. But new details of the year-long study, courtesy of a recent report, throw further light on the scale of the damage being wrought, which makes you sit up and take notice. Apparently, key pollutants including microplastics have been found in all the rivers surveyed, meaning that industrial and municipal wastes dumped in rivers near cities and towns are flowing into rivers in far-flung coastal areas. Which, in other words, means that if preventive steps are not taken, the pollution of these rivers will affect all other rivers

Another important revelation is about three rivers which have been identified as the most polluted. These are Labandaha in Gazipur, Haridhowa in Narshingdi, and Sutang in Sylhet. Of them, the Labandaha river, once called "Labalong Sea" because of its size, has now been reduced to a canal through constant pollution and encroachment. Some 250 factories have been found on the banks of this river, and industrial waste generated by them, together with waste from the Sripur municipality, are all dumped in the river, choking it to death. The same thing has happened to Haridhowa, which was once used for fishing and agricultural purposes but is now little more than a dumping ground. The story of Sutang, a cross-border river in Sylhet, is no different; so polluted has its water become that it is no longer distinguishable as a river.

Plastic waste, household waste and industrial waste are all landing, untreated and unopposed, in these rivers and others, robbing them of their life. The question is, why are we allowing this to happen? A more worrying question is, are these rivers damaged irreversibly? Only the other day, the shipping minister warned that Bangladesh will not survive if our rivers stop flowing. Studies like the one by RDRC suggest that we may already be headed in that direction. Our country is a victim of not just negligent handling of its wastes by individuals and institutions but also of a development/urbanisation policy that pays little heed to environmental concerns. Just imagine: industries and EPZs are being constructed near rivers. Tanneries are being relocated near rivers. Urban authorities are using rivers as dumping grounds. How long can Bangladesh survive in such a toxic environment?

Because of unchecked pollution, not only are the ecosystems of rivers being damaged, but the lives and livelihoods of people living near rivers, as well as our agriculture, public health and sources of clean water are also being threatened. Such catastrophic mismanagement can no longer continue. We urge the authorities to take stern actions in this regard.



# Terminal 3 alone can't turn Dhaka into an 'aviation hub'

Recently some images have been circulating of the under-construction third terminal of Hazrat Shahjalal International Airport (HSIA) in Dhaka, which shows what we can expect the interior of the terminal to look like. Most netizens and experts were vastly impressed.

Many believe that the third terminal megaproject will be a game changer for the country's aviation sector. At a recent conference, the prime minister herself expressed her wish to turn Bangladesh into an aviation hub. On the other hand, Biman Bangladesh has reportedly been in discussion with Airbus to purchase new aircraft, admittedly a step in the right direction because only a shiny new terminal will not be enough to transform Bangladesh's aviation sector. Biman, our national flag carrier, must grow, expand, and possibly revamp itself to complement the whole project.

The question remains as to whether Bangladesh can truly be an aviation hub in the region when there are already big players such as Singapore, Bangkok, Hong Kong, and Delhi. The

third terminal project does include auxiliary projects such as high-speed taxiways and a large cargo village. But frankly speaking, there are several highly important elements that are still missing. It is quite surprising and disappointing that no one yet has pointed out these missing elements in the megaproject – all of which are so

The first and most important of these is the need for a new ATC (Air Traffic Control) tower. HSIA currently lacks not only a proper ATC tower, but also the right equipment and technology to control air traffic. A new airport would practically be useless without modern navigation and communication systems. So, one can't fathom why a new ATC tower and radar system have not been included as part of this megaproject. Radio communication between Dhaka's air traffic controllers and pilots is easily listenable online and one can hear how unclear the communication seems to be due to the airport's old and outdated equipment. One could be forgiven for wondering how foreign airlines still fly into the HSIA.

Secondly, there has always been a debate over whether a second parallel runway would be feasible. Every major airport around the world has at least two operational runways. Therefore, it is only fitting that HSIA should also have another runway not only as backup but also to handle increasing passenger and aircraft movement, as the taxiways and the sole current runway get busier. However, the lack of space for a second runway might be an issue here. The authorities have allowed illegal constructions and settlements around the airport's perimeter to such a degree that a significant threat is posed to flight safety while landing or taking off from Dhaka. This is an issue that needs urgent attention from relevant authorities. Once the safety concerns are duly addressed, a second runway would still be possible, with certain adjustments.

Then there is the matter of ground handling and the quality of airport services. As a major gateway to Bangladesh, the HSIA reflects the image of our country. No matter how shiny an airport is, if the passenger experience is still sub-par, our aviation sector can never progress forward. Incompetency, mismanagement, and corruption have plagued passenger experiences and ground handling services for too long at the Dhaka airport. Many are still worried that, despite a new terminal, these unpleasantly familiar scenarios will

remain. Internationally reputable ground

handling agencies such as Dnata, Swissport, and Celebi have previously offered to invest in Dhaka's ground handling. But these offers were unfortunately denied due to Biman's monopoly. And we have all witnessed and experienced what good this has

But no more. New changes are necessary for the benefit of all and it is time for a more competent entity to take over the day-to-day operation of the HSIA once the third terminal is fully operational.

Finally, branding is a vital tool to market almost anything these days. All major airports across the world have their own logo and branding, but none of the airports in Bangladesh practice any form of branding. This must not be overlooked. After the completion of the third terminal, the HSIA will need to brand itself with at least an appealing logo. And the red neon signs displaying the name of the airport on top of the present terminals iust won't do. No other internationally renowned airport has such signs displayed on the facade of the landside terminals given that everyone knows where an airport is located and what it could look like. Bangladesh cannot become an aviation hub overnight, but the completion of the third terminal (along with the additional projects to transform the HSIA into a 21st century airport) could be the first step in that direction. And for that, this roadmap, with all the elements of a modern functioning airport, will be necessary for the Dhaka airport.





# Managing the politics of budget-making

budget is an important annual event. The government conducts numerous consultation sessions with a wideranging group of stakeholders. Many views, hopes, aspirations, and criticisms are exchanged through this consultation process. In the end, the budget that is approved by the parliament is a political document. In an election year, the politicallydetermined contents of the budget get added prominence. This is not unique to Bangladesh.

Yet, the forthcoming national budget for FY2023-24 cannot be a business-as-usual budget and needs some deft management in view of the ongoing macroeconomic instability, the requirements of the IMF loan, the uncertain global economic and financial environment, and the risk effort. of derailing medium-term growth

Being political in nature, budgetmaking is an art and not a science. Even so, it must take into account prevailing socioeconomic realities and the implementation experience of the recent budgets.

The budget means different things to different people. In the process, there is a risk that the focus and core messages of the budget might get diluted. The current macroeconomic situation is uncomfortable. Inflation is high, difficulties regarding balance of payments persist with a continued loss of foreign exchange reserves, volume of import is constrained, tax revenues as a share of GDP are low, and fiscal deficits have been increasing. These factors suggest that the main focus of the FY24 budget must be on economic stabilisation.

Attempts to finance higher spending through bank-financed fiscal deficits will simply fuel further inflationary pressure and contribute to import pressure on the dwindling forex reserves

**Target for fiscal deficit:** Research shows that fiscal deficit as a share of GDP has been rising steadily from a low of 1.1 percent of GDP in FY14 to tax service agency; introducing a an estimated 5.3 percent of GDP in FY23. While the fiscal deficit of 5.3 percent of GDP is not excessively high, in the present context of high inflation, a rising fiscal deficit is not consistent with the task of reducing demand. Given this situation, it will be prudent to limit the fiscal deficit within five percent of GDP in the forthcoming FY24 budget.

Financing of fiscal deficit: Data shows that over the past two fiscal vears, there was a progressive increase in the recourse to bank financing of the fiscal deficit. Indeed, the average growth of credit to the government has been in the 30 percent range since June 2021. This has added to

The presentation of the national the growth of total credit at a time when the rate of credit expansion should be curbed to fight inflation. For the FY24 budget, all efforts should be made to use low-cost domestic and foreign borrowing to finance the deficit. Establishing a well-functioning T-bill market with access to the general public will help reduce the demand pressure of the budget deficit.

Resource mobilisation: The inability to introduce meaningful tax reforms over the past several vears has constrained tax revenue mobilisation. Tax revenue as a share of GDP has been virtually stagnant at around 7-7.5 percent of GDP. Ad-hoc tax measures announced during the budget seasons have failed to make a dent in the resource mobilisation

Meaningful reforms require that involves major institutional changes in tax planning and tax administration. These reforms include separation of tax planning

from tax collection; modernisation of the National Board of Revenue (NBR) through simplification and digitisation of tax administration; eliminating expenditure accounting requirement in tax filing; removing the interface between taxpayer and tax collector; adopting a true self-assessment system with enforcement through selective and productive computer-based audits; converting the NBR from a tax policing department to a proper property tax system; and full implementation of the 2012 VAT law. These are far-reaching reforms and can be best introduced through a detailed workout of a modern tax system designed by an Expert Tax Reform Commission (TRC). Similar TRC-based reforms have helped to modernise the Indian tax system and raise the tax-GDP ratio.

In the meantime, for FY2023-24 budget, some of the easy reforms can be introduced by doing away with the expenditure accounting requirement of the tax form, introducing online tax submission and payments, and conducting selective but productive audits

focused mainly on the large taxpayer units. All efforts to eliminate rentseeking venues for tax collectors and avoid harassment of taxpayers will substantially boost tax revenues by providing incentives for voluntary tax compliance and reducing revenue leakages.

Some minimal state-owned enterprise (SOE) reforms can also be introduced to improve their financial performance by implementing a hard budget constraint, improving the pricing policies for SOEs, and strengthening corporate governance.

With these reforms, it should be possible to increase the tax effort from 7.1 percent of GDP estimated for FY23 to 7.6 percent of GDP in FY24. Non-tax revenues can be increased from one percent to 1.2 percent of GDP.

Size of the budget: It may be politically appealing to announce a large budget in an election year. However, it would be imprudent from the standpoint of macroeconomic management and would undermine the political value of a large budget by increasing inflationary pressure. The size of the budget should depend upon a realistic assessment of the likely magnitude of tax and non-tax resources and the size of the fiscal deficit. As noted, with some minimal reforms, the total revenue can be increased from 8.1 percent of GDP in FY23 to 8.8 percent of GDP

Applying a budget deficit target of five percent of GDP, total size of the FY24 budget would amount to about 13.8 percent of GDP. Converting this in terms of taka by using the projected GDP for FY24, this amounts to about Tk 7 trillion. This will be about 19 percent higher than the estimated budget implementation for FY23.

It is important to note that this size of the budget is contingent upon implementing the suggested reforms for strengthening revenue mobilisation. If, for example, the proposed reforms are not implemented and total revenues in FY24 remain unchanged at 8.1 percent of GDP as in FY23, the size of a prudent budget would fall to Tk 6.7 trillion, which is about 13 percent higher than the estimated budget outcome for FY23.

**Expenditure priorities:** Since some 50 percent of the budget is already committed to fixed spending items (wages and salaries, civil service pensions, materials supplies, security spending, and interest cost), the flexibility strengthening expenditure priorities is rather limited. Even so, the government must make an effort to curb subsidies and phase the implementation of capital-intensive large infrastructure projects, while increasing allocations for health, education, irrigation and flood control, water supply, and social protection. Along with efforts to lower inflation, these spending can also help the government politically by improving the income levels of the poor and vulnerable.

The tendency to accelerate spending on large, visible and long gestational infrastructure projects may appear politically appealing in an election year, but in reality, they do not create immediate benefits for the common citizens. Income transfers from social protection programmes, and spending on irrigation, flood control and water supply are where benefits are more direct and immediate.

# My memories of Prof Abdur Razzaq

About 72 years ago, Prof Abdur Razzaq completed his thesis paper titled "Political Parties in India," which is now in the public domain, thanks to the University Press Limited (UPL). Submitted to the London School of Economics in 1950, the paper delves into contemporary political realities and ideas that were tested in their own time. The writer posited that a sovereign state was essential for the political parties to function. He believed that India needed Westminster-style liberal politics where political parties would be equally invested, whether in government or in opposition. At that time, however, the environment in South Asian countries was not conducive to any Westminster-style politics. Power was concentrated in the hands of a few leaders, while dynasty politics was a dominant influence. Issues like this and much more were explored through the

The belated publication in the form of a book of this now historic paper offers an opportunity to take a look at the man that Razzaq Sir would go on to become, and the long shadow that he would cast over not just his students, peers, the academia and intelligentsia, but also anyone who would come into contact with him, like me.

Prof Abdur Razzaq was known as "Gyantapas" because, in the words of historian Prof Salahuddin, "he spent his entire life learning and pursuing knowledge." Salahuddin further said, "It will not be an exaggeration to call him one of the best symbols of Bangalee intellectualism. He could be called a living encyclopaedia because of his extensive reading of history, social science, economics and so on."

He was a humanist and a progressive thinker. Although he didn't like politics, he was drawn to the separatist movement in his early life because he believed that a separatist agenda supporting the establishment of Pakistan was subscribed to this view would be in for a rude awakening after the 1947 Partition. Events of those days would profoundly shape the worldview of Abdur Razzaq, who tried to make politicians see the error of their thoughts. During the 1971 war, he didn't leave the country. He was hiding in his village home, and was tried in absentia by the Pakistan military court that sentenced him to 14 years of rigorous imprisonment. After independence, Bangabandhu Sheikh Mujibur Rahman designated him as a national professor.

I met Prof Razzaq for the first time at the Dhaka University teachers' lounge, courtesy of my late friend ZM Obaidullah. He was playing chess then. In 1961, I was appointed as a section officer at the finance ministry in East Pakistan. I remember that I went to visit him one day. He wanted to know about my work, so I told him, "Sir, it's quite interesting, although, frankly, I don't understand it much." He said, "Why don't you study economics then?" reversing the decision. studies abroad by taking a study leave. This completely changed my career path in later life.


In 1969, between March and October, I was in London on a fellowship. There, I had the chance to meet him again and we grew close. During our conversations, he would often share his thoughts about politics, especially the future of Pakistan. He would say that we needed independence, but he was against having an active military force in an independent Bangladesh. In later life, I went to visit him every time I got the opportunity, sometimes with my friends, including Anisuzzaman, Nurul Huq and Justice Habibur Rahman. Meeting him was a chance to learn. He encouraged us to read. He talked about many things, but was also curious to know our thoughts.

Once, after Sir Fazle Hasan Abed decided to establish Brac University, he thought it would be better to get first-hand knowledge of the university system. He encouraged me to pursue higher decided that India's capital would be shifted to New Delhi, although that decision couldn't be implemented immediately. > I also remember that Razzaq Sir once presented a written speech titled "State of the Nation" in 1980. It was his only written speech, later published in 1981. I had the good fortune of listening to his speech live. It was divided into two parts, the first involving a discussion on economics and politics. In it, Razzaq Sir said Bangladesh's assets were its land, people, unique geographical location, rivers as well as their effects in agricultural production. The present government's Delta Plan 2100 is, in a way, a reflection of Prof Razzaq's thoughts shared in his 1980 speech.

systems. Upon returning to a nation, is the exclusive passion to Bangladesh, I learnt that Prof Razzaq was looking for me. So I visited his house, and told him about Fazle Hasan Abed's initiative. # What it takes to get into IBA, DU

One question most of my mentors used to ask me was, "What other places are you trying for besides IBA?" This question is built upon layers of societal and psychological realities. We tend to put a premium on certain institutions, which makes the DU-IBA admission test a high-stake situation. Stakes tend to be higher if you have invested all your time and

effort into

When I look around my class at the Institute of Business Administration (IBA), Dhaka University (DU), I see people with diverse admission journeys.

Some of them, like my friend Abdullah Al Faiaz, prepared only for the IBA entrance exam. Some, like me, wanted to play things safe and made sure we secured seats elsewhere like in DU's D-unit. Many went through the brunt of engineering admission tests before they started preparing for IBA. Then there's another bunch who didn't prepare for IBA at all but still managed to ace the admission test.

With the admission test being extremely competitive and the question pattern different from most other public admission tests, students are often left asking what it really takes to get into IBA, DU.

Based on my own experience and that of the people around me, here are some factors that can impact your odds of getting in.

## Science, Commerce, and Arts - does it

The IBA admission exam is basically an aptitude test. The exam topics – Math, English, and Analytical Ability – are not derived from any of the National Curriculum and Textbook Board (NCTB) curriculums. Instead, they focus on a student's core mathematical, language, and analytical skills. Hence, students from all backgrounds (Science, Arts, and Commerce) can apply and have an equal chance.

In practice, an overwhelming number of IBA students come from a Science background. Since science subjects tend to be comparatively math-heavy, there is a gap that exists between the mathematical skills of the average student in science and those in other curricula. Given the competitive nature of the exam, students

who haven't taken many quantitative subjects in the past few years should put in some extra effort to get comfortable in working with numbers. Being fast is particularly important because it helps tackle the biggest challenge in the IBA admission test.

#### The time constraint

Students get 90 minutes to answer around 75 MCQs followed by 30 minutes of descriptive writing. This leaves them with one minute for each question. But many of these questions, especially some from maths and analytical ability, will take longer. A common fix to this problem is being quicker in the English section to invest more time in the other two.

Having a plan about the order in which you will approach the section is important. Start with the subject you're most comfortable with and then get into the more difficult ones. Ample time should be allocated for all three sections as each of them need to be passed separately.

The passing bar differs yearly according to the difficulty level of the entrance exam.

#### **Negative marks**

For every wrong answer, 0.2 is deducted from your total obtained marks. So, avoid marking a question unless you're sure about it. However, educated guessing – used in moderation – can help elevate your score.

## **Practice**

Practice will help you increase your speed and accuracy. It will also help recognise your mistake patterns and you can learn to minimise errors.

Sitting for mock exams is important. In addition to the MCO sections, consider including the descriptive writing part in your mock exams. It will teach you to be more organised in the writing section.

#### Vocabulary

Being able to answer vocabulary-related noushin2411@gmail.com

questions correctly gives you confidence. Since these require less thinking compared to the other question types, time is freed up to be invested elsewhere.

Rote memorisation of word meanings won't be useful. The questions are designed to test your knowledge of not only the meaning of the words but also their correct usage. This makes it important to be more involved with the new words you're learning. Constructing sentences with these words is a practice I and many others included in our IBA admission study routine.

#### The psychological aspect

One question most of my mentors used to ask me was, "What other places are you trying for besides IBA?" This question is built upon layers of societal and psychological realities. We tend to put a premium on certain institutions, which makes the IBA, DU admission test a high-stake situation. Stakes tend to be higher if you have invested all your time and effort into this one exam. The pressure to get in increases and can negatively impact your performance during the admission test.

Since the IBA, DU entrance exam takes place late in the admission phase, securing a place in some other university you might want to study in helps in being more confident going into the IBA admission test.

# A definitive guide to the digital SAT

The SAT, or the Scholastic Assessment Test, is a standardised test conducted by the College Board that is needed for undergraduate university admissions in the United States. Until very recently, the SATs were taken by paper. However, a few years back, the College Board announced its intentions of fully digitalising the SATs and the very first digital SAT was administered internationally on March 11, 2023.

If you are thinking of applying to universities in the US and are confused about the new SATs, here are a few guiding points for you.

#### The key differences between the digital and paper SAT

While the previous SATs required students to physically solve the paper and write in the answers on an answer sheet, the digital SATs are conducted through an app named Bluebook where you can digitally access the paper and input your answers.

The paper SAT consisted of an English section and a Math section, with them being divided into two sub-sections each - Reading and Writing, and Calculator and Non-calculator. The digital SATs also consist of two sections but they are divided into two modules each and the two modules have no difference between them in regard to the pattern of questions. Both the English modules have 27 questions each and both are 32 minutes long. The Math modules have 22 questions each, and are both timed at 35 minutes.

A major reason behind students struggling with the previous SAT was its length of over three hours. The digital SAT is comparatively shorter at 2 hours and 14 minutes, and there is a 10-minute break between the Math and English sections.

The digital SAT also claims to be adaptive, which means how well you do on the first module for each section determines the difficulty level of your questions on the second module.

The style of questions is a little different now. Instead of focusing on Reading and Writing skills separately, the digital SAT tests your evidencebased reading and language skills simultaneously. The English section, which previously had long passages with multiple questions from each passage, has been altered so that it contains smaller passages and only one question per passage. This makes it easier for people who struggle to keep their attention perfectly attuned to stay focused and means that you will likely find the answer to your evidence-based question with less searching.

The Math section doesn't have many differences in terms of question pattern. The big change is

the fact that students can use calculator in both the modules as opposed to before when its use was restricted to one module. The app, Bluebook, in fact has a built-in graphing calculator that students can use in addition to their own approved calculator. The percentage of student-generated responses as compared to multiple choice answers is also higher now in the Math section.

The key skills required to excel at the SATs remain roughly the same as before.

#### How exactly do you sit for the SATs?

In order to register for the SATs, you have to head over to the College Board website, create an account, select a session and then proceed to fill in a form and pay a fee (USD 100 for the March session). A few different test centres are available and you get to choose a location which is

convenient for you. During registration, they provide you with the necessary information about your testing device. You have to bring your own testing device - a laptop or a tablet – to the physical testing centre. If you don't have a device of your own, you can request a device from College Board and the testing centre will arrange one for you. My testing centre had charging portals available, but it is advisable that you take a fully charged device with a battery life of at least three hours. You will be provided with scratch paper by the invigilator.

#### How can you prepare for the digital SATs?

The best way to prepare for a test that is as dependent on your time management skills as the SAT is to practise. Khan Academy, in collaboration with College Board, has an official digital SAT prep course that is free of cost. Four full length mock tests are available on the Bluebook app. Once you take them, the app marks them digitally and provides you with a score from 400-1600. Doing these will give you a better idea of the question pattern as well as the areas where you may need to put in more effort.

# Cambridge Majlis celebrates South Asians and Anti-Colonial history

The Cambridge Majlis is a student society at Cambridge founded in 1891 as a platform for discussion of social and political issues in South Asia. The Majlis moulded some of South Asia's most influential political figures and leaders like India's first Prime Minister Jawaharlal Nehru and Nobel Prizewinning economist Amartya Sen. Figures like Mahatma Gandhi, Netaji Subhas Chandra Bose, E.M. Forster, and Bertrand Russell also addressed the Majlis.

Over the past few years, Majlis members have uncovered much of the society's long-neglected history. An archival exhibition at the Wren Library in Trinity College showcases many of the region's leaders and thinkers. It highlights how Majlis members played an active role in the Indian independence struggle in the 1930s and 40s. Archives from the British Library show that the Majlis' "seditious activities" and "communist leanings" led the Metropolitan Police and Scotland Yard to begin monitoring its activities.

The Majlis debated and discussed issues such as the Government of India Act and Britain's policy of divide and rule and also engaged in political action to further the independence movement. Protests were held, petitions were signed, and money was raised to "Get the British out of recently India". In response to a proclamation include his correspondence with



by Gandhi that Indian students should 
Irish nationalist leaders expressing hold monthly demonstrations and meetings to demand the release of political prisoners, the Majlis held a gathering at St. John's College, Cambridge on February 10, 1945. The Cambridge Majlis received wires from both Gandhi and Nehru, thanking them for their contribution to the Indian Independence movement.

One of those under scrutiny in this period, Subrata Ray Chowdhury, went on to become a leading constitutional lawyer in India. Scotland Yard's declassified records

support for freedom fighters against the British Raj. Chowdhury also reportedly travelled to Ireland where he was expected to meet Seán O'Kelly, the new President of Ireland and De Valera, who had a leading role in introducing the 1937 Constitution of

Chowdhury also met with both Seán and Irish republican, revolutionary and suffragette Maud Gonne MacBride on this visit. MacBride was also a long-time love interest of the poet W.B. Yeats. Her son Seán MacBride, the Irish independence activist and

later politician, founded Amnesty International. Interestingly, reinforcing the ties to South Asia, Seán MacBride later formed part of the "people's commission of enquiry" created in September 1980 to investigate the circumstances impeding the prosecution of those responsible for the assassination of Bangabandhu Sheikh Mujibur Rahman and his family members.

In the 1950s, as ideas of statebuilding, economic policy and modes of government dominated discourse, the Majlis provided a way for South Asian students to directly engage with public and political life in the postcolonial, post-partitioned world. Majlis members during this period went on to become influential policymakers in their respective countries.

The Majlis stopped its activities after 1971, reportedly following the rising tensions between Indians and Pakistanis at Cambridge over Bangladesh's war of Independence. After almost five decades, following Mahid Qamar and Sahil Baid's rediscovery of the Archives, the Majlis returned to being a centre of South Asian intellectual and cultural life at

Cambridge. Since its revival, it has had presidents from India (Sara Saloo, 2021), Pakistan (Mahid 2019 and Sahil 2020) and now, Bangladesh (Laleh Bergman Hossain

## Booters eye backto-back victories

Bangladesh are looking forward to tasting consecutive victories after a long time when they square off against Seychelles in the second FIFA friendly match at the Sylhet District Stadium today.

The match will get underway at 3:45pm, with satellite channel T-Sports telecasting the game live from the venue.

Bangladesh won the first of the two matches 1-0 and they won't want to repeat the mistakes they made last September when they lost 3-1 against Nepal after beating Cambodia 1-0 in back-to-back friendly matches.

The last time the men in red and green tasted back-toback victories was four years ago when they beat Bhutan 4-1 and 2-0 in two FIFA friendly matches in Dhaka under Jamie Day, who also guided the team to another back-toback wins against Bhutan and Pakistan during the SAFF Championship in Dhaka in 2018.

"Everyone is aware of the whole objective which has not been achieved yet. We have come to Sylhet to win both matches but we are halfway there," Bangladesh coach Javier Cabrera said yesterday.

"We don't want to make the same mistakes we made last September and everyone is aware of it and everyone knows we are going to face challenge again as we faced the day before yesterday," the Spaniard added.

Seychelles are expected to come stronger in the second match, especially given their second-half performance in the first match. Bangladesh are ready to deal with the challenge though.

"I think tomorrow's match is going to be more challenging and tough for us because Seychellois, who are ahead of us physically, will also come to win the match.



The last time the men in red and green tasted back-to-back victories was four years ago when they beat Bhutan 4-1 and 2-0 in two FIFA friendly matches in Dhaka under Jamie Day, who also guided the team to another back-to-back wins against Bhutan and Pakistan during the SAFF Championship in Dhaka in 2018.

They are likely to play attacking football and in that case we should take chances on the break," said captain Jamal

Seychelles' coach and captain appeared more confident than their counterparts as they vowed to win the second

"We will definitely go for a win because the team spirit is quite high and we believe we can play much better than we played in the first match and we can win the game," said coach Neville Both, adding that they would bring three to four changes to their playing eleven.

# 'If they can, so can we'

T20 cricket has been Bangladesh's Achilles heel for a long time. The Tigers' record in the format has been way below par and their style of play, planning, mindset and approach in T20s have always left a lot to be desired.

However, things have changed in the past few weeks. Following a dominant 3-0 series sweep of world champions England earlier this month, Bangladesh began the three-match T20I series against Ireland in commanding fashion in Chattogram yesterday.

The 22-run victory [via DLS] in the rain-affected game at the Zahur Ahmed Chowdhury Stadium not only helped the Tigers take a 1-0 lead in the series and see them record their best winning streak in the format with four wins in a row. but also showed that the Shakib Al Hasan-led side could finally become a force to be reckoned with in the format.

In the past, even in the Tigers' rare wins in T20Is, Bangladesh's performances often did not include the elements that fans look for in a T20 contest. Rarely have the Tigers dominated things on the batting front in T20Is as they did during their 207 for five in 19.2 overs vesterday.

Openers Rony Talukdar and Liton Das starred in a blistering 91run opening stand as the Tigers set a number of records. Liton began by taking on Harry Tector, using his feet to hit the off-spinner for a

Bangladesh never slowed down since, with Rony joining in on the act and surpassing Liton when it came to putting away the Irish bowlers for boundaries. Courtesy of their carnage, Bangladesh recorded the fastest team fifty by any side in T20Is at the venue, crossing the 50run mark in just 4.1 overs.

We were wondering if something similar was afoot here," Taskin Ahmed, who registered career-best T20I figures of four for 16 in two overs, said.

In a record T20I chase, the Proteas on Sunday got to the 259run target set by the West Indies with six wickets in hand and seven balls to spare in Centurion -- a game that had plenty of entertainment in store for the T20 lovers.

Although it has not happened often in the past for Bangladesh, the Tigers now think that they too can pull off something like the Proteas in the coming days.

"After Liton got out and came to the dressing room, I asked him: 'Were you hitting like that after witnessing South Africa's game last night?' And he said: 'Yes, if they can do it, so can we'," Taskin added.

What Liton said to Taskin only shows that the players have already imbibed head coach Chandika Hathurusingha's philosophy of aggressive and fearless cricket by disregarding the fear of failure.

And that is not only the case for batters as similar aggression was shown by Taskin himself with the ball in hand. Being set a revised target of 104 runs in eight overs, Ireland had gotten off to a great start, amassing 32 for no loss in the first two overs.

Pacer Hasan Mahmud broke the deadlock in the third over before Taskin buried Ireland with three wickets in the fourth over to see them reeling at 44 for four -- from where the visitors could not bounce

## Messi eyes 100th Int'l goal

Argentina captain Lionel Messi will go in search of his 100th international goal when the world champions host Curacao in Tuesday's friendly.

The PSG superstar led by example in Saturday's win over Panama, scoring his side's second with a trademark free kick on a night of unbridled celebration, which also marked his 800th career

Victory over Panama marked Argentina's seventh win in a row across all competitions, with La Albiceleste scoring at least two goals in all of those successes since being shell-shocked by Saudi Arabia in their opening World Cup contest.

Each of Argentina's last five friendly matches has also ended in victory - with five clean sheets in tow - and Lionel Scaloni's charges can enjoy one final pressure-free contest before the qualifying cycle for the 2026 World Cup commences in six months' time.

While Argentina's 2022 was unforgettable for all the right reasons, Curacao's calendar year was a largely forgettable affair, and the world's 86thranked nation could not upset the apple cart in their Nations League group with Canada and Honduras

Since the dissolution of the Netherlands Antilles in 2010, Curacao have never tackled Argentina in competitive or non-competitive action, but few will expect the visitors to spoil the party mood on Tuesday.

Coach Hansi Flick promised Germany will play "a style and manner of football that excites the fans" as his side continue their post-World Cup redemption against Belgium on Tuesday.

Flick's Germany were booted out at the group stage in Qatar, their secondconsecutive World Cup group exit, but the coach said on Monday his focus was on the way the team plays rather than just winning. "Wins always do us well, for self-confidence and self-worth. But I think the style and manner of football we play can excite the fans."

Germany qualify for the 2024 Euros as hosts and therefore will only play friendlies until the tournament takes place.

return from Qatar. Flick however admitted Belgium would be "another calibre of opponent" and could give Germany a chance to assess their comeback. "They have a new manager and a new spirit, you can see that they have outstanding footballers... Under pressure they find good solutions."



Cristiano Ronaldo continued to score goals for fun, netting twice during Portugal's 6-0 drubbing of Luxembourg in a Euro 2024 qualifier on Sunday. "Two games, two wins! Objective accomplished. Happy to have contributed to this very positive start. Let's go," CR7 wrote on Twitter afterwards.

# 2 nurses 'sexually harassed' by civil surgeon, aide

#### They file complaints with health ministry, Directorate General of **Nursing and Midwifery**

Sexual harassment allegations have surfaced against a physician in Cox's Bazar who, according to a complaint, coerced two nurses into travelling to Saint Martin's Island so they could "entertain" the district's civil surgeon.

The nurses accused Dr Titu Chandra Das, upazila health and family planning officer of Cox's Bazar Sadar, of attempted rape and groping one of them at a resort on the island after they refused to dance with Cox's Bazar Civil Surgeon Dr Mahbubur Rahman.

Dr Titu also made a number of lewd suggestions to the nurses in an effort to please Dr Mahbubur, said a written complaint, submitted to the Health Services Division and Directorate General of Nursing and Midwifery on January

The incident occurred on January 25, the day a telemedicine centre was inaugurated at the 20-bed health centre on the island, added the complaint.

The health ministry officials confirmed receiving the complaint and said an investigation was already underway. The ministry will hold a hearing on the matter tomorrow. The accused physicians and the victims have been asked to appear.

This was not the only complaint of sexual harassment and intimidation against the duo that the ministry has

In a separate complaint, also filed on January 30, another nurse said she and her colleague had to leave their dormitory fearing for their safety, as Dr Mahbubur and Dr Titu expressed keen interest in spending time in their room during a government programme in Cox's SEE PAGE 6 COL 2

## Avdiivka becoming 'post-apocalyptic'

Says a top official of the Ukrainian city as Russian forces step up shelling along frontline

Ukraine shut the eastern town of Avdiivka to non-military personnel yesterday, describing it as a postapocalyptic wasteland, as Kyiv seeks to break the back of Russia's flagging winter offensive before a counterassault of its own.

A top Ukrainian general said Kyiv was planning its next move after Moscow appeared to shift focus from the small city of Bakhmut, which Russia has failed to capture after half a year of the war's bloodiest fighting, to Avdiivka further south.

Front lines in Ukraine have barely budged for more than four months despite a Russian winter offensive using hundreds of thousands of freshly called-up reservists and convicts recruited as mercenaries from jail. The Ukrainian military aims to wear down Russian forces before a counteroffensive in coming weeks or months.

ground Ukrainian commander Colonel General Oleksandr Syrskyi, who said last week that the counterattack could come "very soon", visited front line troops in the east and said his forces were still repelling Russian attacks on Bakhmut.

Defending the small city in the industrialised Donbas region that Russia has tried to seize for months was a "military necessity", said Syrskyi,

praising Ukrainian resilience in 'extremely difficult conditions".

Last week, the Ukrainian military warned that Avdiivka, a smaller town 90 km further south, could become a "second Bakhmut" as Russia turns its attention there. Both towns have been reduced to rubble in fighting that both sides have called a "meat grinder".

"I am sad to say this, but Avdiivka is becoming more and more like a place from post-apocalyptic movies," said Vitaliy Barabash, head of the city's military administration. Only around

# Asteroid big enough to destroy city flying close to Earth

A vast asteroid, big enough to destroy a whole city, is coming closer to Earth. The space rock will fly between Earth and the Moon, marking extraordinarily

Scientists say there is no chance that the asteroid will cause any harm to Earth. But it will provide an important opportunity for researchers to study it from relatively close-up.

Saturday's close encounter will offer astronomers the chance to study a space rock from just over 100,000 miles (168,000 kilometres) away. That's less than half the distance from here to the moon, making it visible through binoculars and small telescopes.

While asteroid flybys are common, Nasa said it's rare for one so big to come so close -- about once a decade. Scientists estimate its size somewhere between 130 feet and 300 feet (40 metres and 90

Discovered a month ago, the asteroid known as 2023 DZ2 will pass within 320,000 miles (515,000 kilometres) of the moon on Saturday and, several hours later, buzz the Indian Ocean at about 17,500 mph (28,000 kph).

# RAHUL'S REMOVAL AS MP

## **Parliament** adjourned after protests

India's parliament was adjourned twice yesterday after lawmakers held rowdy protests and threw paper at the Speaker following the expulsion from the house of top opposition figure Rahul Gandhi.

Gandhi lost his parliamentary seat on Friday after being convicted in a case that critics say shows how the rule of law is under threat in the world's largest democracy under Prime Minister Narendra Modi.

The Speaker called off proceedings less than a minute after opposition MPs wearing black erupted in shouting, some of them throwing bits of paper at him.

"I want to run the House with dignity," Speaker Om Birla said. The session resumed several hours later only to be abandoned again after about 10 minutes as opposition MPs chanted anti-Modi slogans and waved "Democracy in danger" placards.

It was the latest in a string of stoppages in recent weeks in India's often raucous parliament among lawmakers representing India's 1.4 billion people.

Opposition MPs have been demanding a probe into potential links between Modi and the business empire of tycoon Gautam Adani, which has been hit by allegations of accounting fraud.

Debates have also descended into shouting matches
