

# China warns Taiwan leader over US visit

President Tsai hits defiant note; sr US officials say no reason for Beijing to overreact

External pressure will not stop Taiwan engaging with the world, President Tsai Ing-wen said yesterday as she left for the United States, hitting a defiant note after China threatened retaliation if she met US House Speaker Kevin McCarthy.

China, which claims democratically-ruled Taiwan as its own territory, has repeatedly warned US officials not to meet Tsai, viewing it as support for the island's desire to be seen as a separate country.

The United States says such transits by Taiwanese presidents are routine and that China should not use Tsai's trip to take any aggressive moves against Taiwan.

The United States sees no reason for China to overreact to planned transits of the United States this week and next month by Taiwan's president, senior US officials said ahead of Tsai's departure.

China staged war games around Taiwan last August when then-US House Speaker Nancy Pelosi visited Taipei, and Taiwan's armed forces have said they are keeping watch for any Chinese moves when Tsai is abroad.



Tsai is going to Guatemala and Belize, transiting through New York first and Los Angeles on the way back. While not officially confirmed, she is expected to meet McCarthy while in California.

"External pressure will not hinder our determination to go to the world," she said at Taiwan's main international airport at Taoyuan, in a veiled reference to China.

"We are calm and confident, will neither yield nor provoke. Taiwan will firmly walk on the road of freedom and democracy and go into the world. Although this road is rough, Taiwan is not alone," added Tsai, who was due to arrive in New York yesterday afternoon.

Speaking in Beijing shortly before Tsai left, Zhu Fenglian, spokesperson of China's Taiwan Affairs Office, said Tsai's "transits" of the United States were not just her waiting at the airport or hotel, but for her to meet US officials and lawmakers.

"If she has contact with US House Speaker McCarthy, it will be another provocation that seriously violates the one-China principle, harms China's sovereignty and territorial integrity, and destroys peace and stability in the Taiwan Strait," she said.

"We firmly oppose this and will definitely take measures to resolutely fight back," Zhu added.

## Musk, Wozniak, other experts urge pause on AI

### Cite potential risks to society, humanity

Elon Musk and a group of artificial intelligence experts and industry executives are calling for a six-month pause in developing systems more powerful than OpenAI's newly launched GPT-4, in an open letter citing potential risks to society and humanity.

The letter, issued by the non-profit Future of Life Institute and signed by more than 1,000 people including Musk, Apple co-founder Steve Wozniak called for a pause on advanced AI development until shared safety protocols for such designs were developed, implemented and audited by independent experts.

"Powerful AI systems should be developed only once we are confident

that their effects will be positive and their risks will be manageable," the letter said.

The letter detailed potential risks to society and civilization by human-competitive AI systems in the form of economic and political disruptions, and called on developers to work with policymakers on governance and regulatory authorities.

Co-signatories included Stability AI CEO Emad Mostaque, researchers at Alphabet-owned GOOGLE DeepMind, as well as AI heavyweight Joshua Bengio. According to the EU's transparency register, the Future of Life Institute is primarily funded by the Musk Foundation, as well as London-based effective altruism group Founders Pledge, and Silicon Valley Community Foundation.

## UN adopts resolution on climate justice

The UN General Assembly yesterday adopted by consensus and to cheers a landmark resolution calling for the world body's top court to lay out nations' legal obligations in combatting climate change.

"Together, you are making history," UN chief Antonio Guterres said, emphasizing that even if non-binding, an opinion from the International Court of Justice "would assist the General Assembly, the UN and member states to take the bolder and stronger climate action that our world so desperately needs."

## PAKISTAN NAT'L ASSEMBLY Bill passed to curb top judge's suo moto powers

Pakistan's National Assembly yesterday passed the Supreme Court (Practice and Procedure), Bill 2023, which aims to deprive the office of the chief justice of Pakistan (CJP) of powers to take suo motu notice in an individual capacity. The bill, presented by Federal Minister for Law and Justice Azam Nazeer Tarar, was passed hours after the Standing Committee on Law and Justice approved the cabinet's proposed amendments. PPP Chairman Bilawal Bhutto Zardari, while addressing the law minister, termed the initiative "too little and too late", and said that it should be called a "judges empowerment" bill. When Tarar spoke, he said, "It is being said that a constitutional amendment should be made. I want them to know there is no need for a constitutional amendment. They should go and read Article 191 of the Constitution, which empowers the Assembly to legislate. The Supreme Court also made their rules according to the Constitution and law since 1980 and it is written on the preamble as well."

## NATIONAL ANTHEM CASE Bombay HC refuses to grant relief to Mamata

The Bombay High Court yesterday declined to grant relief to West Bengal Chief Minister Mamata Banerjee in a complaint seeking action against her for allegedly disrespecting the national anthem at an event in Mumbai in 2022. Justice Amit Borkar dismissed the application filed by Mamata challenging a sessions court's order issued January this year and sent the matter back to the magistrate's court. A magistrate's court in Maharashtra state had in March 2022 summoned Mamata Banerjee over the complaint filed by activist Vivekanand Gupta alleging that during a public function at an auditorium on Cuffe Parade in Mumbai, she had started singing the national anthem in sitting position and later stood up and sang two verses before abruptly stopping and leaving the venue.
