Shams sent to jail 35hrs after being picked up

Nearly 35 hours after he was picked up from home, Prothom Alo reporter Samsuzzaman Shams was yesterday produced before a Dhaka court that sent him to jail in a case filed under the Digital Security Act.

The uncertainties over his whereabouts came to an end when he was taken to the Chief Metropolitan Magistrate's Court premises around

Around six hours later, law enforcers brought Shams out of the prison cell on the court premises and walked him to a courtroom for a hearing on the case. He was wearing a blue polo shirt at the time.

Prothom Alo Editor and Publisher Matiur Rahman, an unnamed photographer and unnamed others are also accused in the case.

Around 4:00am on Wednesday, he was picked up from his home in Ambagan area near Jahangirnagar University in Savar allegedly by the Criminal Investigation Department. Until yesterday, neither the CID nor any other law enforcement agencies admitted taking him. At the court yesterday, Additional Chief Metropolitan Magistrate

Tofazzal Hossain rejected Shams' bail petition and sent him to jail. Around 3:30pm, Shams, a staff correspondent of the newspaper based in Savar, was then taken to Dhaka Central Jail in Keraniganj. The case drew widespread condemnations from journalist

associations, rights and professional bodies at home and abroad. However, ministers and Awami League leaders continued to criticise

DSA CASE AGAINST MATIUR Noab, editors, rights bodies voice worries

Newspaper Owners Association of Bangladesh (Noab) has termed the filing of cases against some journalists under the Digital Security Act over the last few days unacceptable.

"We think the use of sections of the Digital Security Act especially against Prothom Alo Editor and former Noab president Matiur Rahman is tantamount to harassing him and muzzling the bold journalism his newspaper does," Noab said in a statement yesterday.

It said the increasing use of the DSA against journalists is concerning. "We conveyed our reservations to the government high-ups about the DSA at

Such a law is not consistent with the freedom of expression and free journalism, and it is also against the dream and system of building a progressive society, said Noab.

RAPE, DEATH OF 12-YR-OLD

A poor family's cries for justice go unheeded

A year on, no culprit identified or arrested

"I will not work at this house anymore. They torture me. I will come back to you." This was what Iti Akter said to her mother Sarkis Akter in her last phone call in the evening of January 28 last year.

Sarkis was informed the next day that her daughter was being taken Better Life Hospital in the capital's Rampura.

Sarkis, who is a domestic worker in the Rayerbazar area, then rushed to the hospital only to find her daughter dead.

"I saw my daughter in a white body bag. As I was crying and asking what happened to her, the people around me said my daughter had hung herself with a scarf," said Sarkis.

"But after seeing her body, I was convinced that something very bad had happened to my daughter who was as pure as a flower."

The 12-year-old was working as a domestic help at the flat of a lawyer couple, Rajin Ahmed and Iffat Jahan Chowdhury, in the East Hajipara area of Rampura in the capital. Rajin's father Kamal Uddin Ahmed, a retired bureaucrat, is the owner of the house.

According to a report at Better Life Hospital, the girl was dead when she was brought to the hospital at 4:50pm on January 29, 2022. "A case of hanging as described by the landlord, Kamal Uddin Ahmed; hanging mark on throat."

She died around 80 minutes before she was brought there, according to a police inquest report.

The police report also said her rectum was abnormal, suggesting that she had been raped.

Ministers and ruling party leaders yesterday continued to blast Bangla daily Prothom Alo for an online report on March 26.

Coming down heavily on the paper, Information and Broadcasting Minister Hasan Mahmud said the base of the state was hit and the country's independence was mocked by the report.

"Circulating this kind of news against the state, society and Liberation war, according to everyone, is a digital crime. [committing] crime and journalism are not the same thing. If someone commits a crime, will he or she not be punished?" he said while speaking at a viewsexchange meeting with journalists at his ministry in the Secretariat.

Replying to questions from reporters after attending an event at a city hotel, State Minister for Foreign Affairs Shahriar Alam, said, "The Liberation War of Bangladesh, Language Movement and the sacrifices of 30 lakh people are not trivial matters that can be compared to anything. We all need to be responsible."

"No matter what, Prime Minister Sheikh Hasina's government will take Bangladesh forward in the coming days ... And these comments, statements

SC BAR ASSOCIATION A section of lawyers seeks to hold fresh election

A section of Supreme Court lawyers vesterday announced they would hold a fresh election to the Supreme Court Bar Association on June 14 and 15, saying that what took place on March 15 and 16 was not an election.

They made the decision at a meeting at the SCBA Hall with former SCBA president M Amir-Ul-Islam in the chair.

They formed an ad-interim committee with senior lawyer Mohammad Mohsen Rashid as the convener and Shah Ahmed Badal as the member secretary.

The committee will conduct the annual election in line with the SCBA constitution.

Eminent jurists Dr Kamal Hossain, M Amir-Ul-Islam, Mainul Hosein, Jamir Uddin Sircar, AF Hassan Ariff, Zainul Abedin, Habibur Rahman Bhuiyan, AJ Mohammad Ali, MK Rahman and Abu Sayeed Sagar were named as the advisory council members of the committee, said a press release signed by Shah Ahmed Badal.

Forms will soon be handed to lawyers to prepare a voter list.

The committee will meet the chief justice and conduct the routine tasks that include looking after SCBA bank accounts and its office.

SCBA officials and staff members will function under the ad-interim committee, the press release added.

On March 15 and 16, the SCBA election was held amid police assault on lawyers and journalists and clashes between pro-Awami League and pro-BNP lawyers.

Pro-BNP lawyers did not cast their votes, demanding cancellation of what they said was a "farce of an election". The pro-AL lawyers' panel, Bangabandhu Awami Ainjibi Parishad, won all 14 posts of the SCBA polls.

Philippine ferry fire kills 31

At least 31 people died and 230 were rescued after a fire engulfed a ferry in the southern Philippines, authorities said yesterday.

The Lady Mary Joy 3 was travelling from Zamboanga City on Mindanao Island to Jolo Island in Sulu province when the fire broke out late Wednesday, prompting passengers to jump overboard, disaster officer Nixon Alonzo said. Rescuers, including the

Philippine Coast Guard and fishermen, saved 195 passengers and 35 crew as the blaze ripped through the ferry off Baluk-Baluk Island in Basilan

Basilan Governor Jim Salliman said 31 bodies had been retrieved, including 18 found inside an air-conditioned cabin.

Firefighter Jayson Ahijon, who was among the passengers, said people panicked as fire and thick smoke overwhelmed the vessel.

in a bucket and lowered over the side of the boat.

Marfe said coast guard investigators were on their way to inspect the ferry and determine the cause of the fire.

A prosecutor then said police arrested the accused on specific charges and the case was at the primary stage of investigation. The prosecutor appealed to the court to confine him in jail until the investigation is done.

Upon hearing from both sides, the magistrate turned down the bail plea. Meanwhile, Home Minister Asaduzzaman Khan yesterday said

MIGRANTS Rights body raps Europe for their 'inhuman' treatment

Europe's top rights body yesterday blasted the "inhuman" treatment of migrants who were brutally turned away at its borders, especially the EU's external frontier.

Migrants had been beaten and suffered "punches, slaps, blows with truncheons, other hard objects... by police or border guards," the Council of Europe's Committee for the Prevention of Torture (CPT) said in its annual report.

"Other forms of inhuman and degrading treatment were also deployed, such as firing bullets close to the persons' bodies while they lay on the ground," it added.

The Editors' Council has expressed concern over the filing of the case against the Prothom Alo editor under the DSA and sending of its reporter to

The council in a statement yesterday said they issued another statement on Wednesday demanding scrapping of all cases against journalists filed under the DSA.

"But it was unfortunate that Shamsuzzaman was sent to jail after his bail petition was rejected," read the press release signed by Editors' Council President Mahfuz Anam and General Secretary Dewan Hanif Mahmud.

A case was filed against daily Jugantaor Staff Reporter Mahbubul Alam Bablu under the DSA yesterday. "Editors' Council thinks that filing of cases under the Digital Security Act one after another is a massive blow to the newspaper industry and freedom of expression," said the release.

The law minister had talked about amending the DSA to prevent its misuse and also promised that the law won't be used arbitrarily against journalists. But the Editors' Council is observing with great concern that cases are being filed against journalists under this law even after the assurance, read the statement.

"These activities are clear examples of threat to the freedom of press," the

ARTICLE 19, an international human rights organisation, has expressed deep concern over the suing of the Prothom Alo editor under the DSA.

Faruq Faisel, regional director of ARTICLE 19 (South Asia), said, "Filing a case against Matiur Rahman under DSA is an example of weaponising to victimise journalists, communicators and editors. It's a clear signal of threat and fear to the media actors of the country.

"This continuation of harassment by abusing instruments must be stopped as this kind of action is hampering the image of Bangladesh globally as a democratic country," he said in a press statement.

Different international and local rights organisations yesterday also condemned the arrest of Shams and his production before a Dhaka court 35 hours after his detention.

The Media Freedom Coalition in Bangladesh said it was concerned by the recent reports of violence against and intimidation of journalists.

In a statement issued by 12 detention of journalist Shams, and urged the authorities to investigate the instances impartially.

'We, the undersigned members of the Media Freedom Coalition in Bangladesh, are concerned about recent reports of violence against and intimidation of journalists, including violence directed at reporters covering the Supreme Court elections, an assault on the brother of a London-based journalist for Al Jazeera, the attack on a Dhaka Tribune photojournalist, and the recent reported detention of a Prothom Alo journalist. We urge the authorities to investigate each of these instances promptly and impartially," the statement said.

The signatories to the statement are Australia, Canada, Denmark, France, Germany, Italy, Netherlands, Norway, Switzerland, the UK and the US.

European Union Bangladesh in a post on their verified Facebook page said, "Arrests of, and criminal proceedings against, journalists in any country warrant particular scrutiny and attention."

CLEARLY AN ACT OF INTIMIDATION'

Reporters Without Borders (RSF) has called for the immediate release of journalist Shams, who was arrested early Wednesday after being sued in a case filed under the DSA.

"Make no mistake, the arrest of Shamsuzzaman Shams and the case filed against Matiur Rahman have no legal basis and are clearly an act of intimidation by the government towards all journalists," says the Paris-based organisation in a statement.

"We demand that the charges filed against them be dropped at once and, with less than a year to go to parliamentary elections, we call on Sheikh Hasina's government to respect journalistic pluralism and independence, or else these elections will lack all democratic credibility."

The RSF sent an email yesterday to Additional Inspector General of Police Mohammad Ali Mia, also the head of Criminal Investigation Department, asking on what evidence he based his decision to order Shams' arrest, read the statement.

It was just a regular water-pump house, but in 1971, the Pakistan army transformed into an embodiment of horror -- a mass killing field, where the officers killed and dumped countless bodies.

The epicentre of this horror are the wells that saw many martyrs' bodies fall into

For years, this dark chapter in history remained ignored, and its significance was almost lost into oblivion. It only gained attention in 1999, when several mass graves were discovered in the capital's Mirpur.

To uncover the truth, the Liberation War Museum collaborated with Bangladesh Army and conducted excavation work at the site that year. This later led to the establishment of Jalladkhana Killing Field Memorial in 2007. During excavation, the remains of numerous victims were found.

KM Nasir Uddin, in-charge of the memorial, shared his memories with The Daily Star.

"Before excavating, we found that a family was still staying at the abandoned pump house. However, they SEE PAGE 4 COL 6

PREVENTING DEATH BY DROWNING

Ministry project sees little to no progress

NILIMA JAHAN

To address children's death by drowning, the Ministry of Women and Children Affairs in February 2022 approved a childcare development and safety project with a budget of Tk 271.82 crore, with an implementation period of January 2022 to December 2024.
The project, titled "Integrated

Community Based Center for Child Care, Protection and Swim-Safe Facilities", aimed to set up 8,000 childcare centres for two lakh children under the age of five in 16 districts, initiate parenting sessions through the centres, and introduce 1,600 swimming facilities for 3.6 lakh children between the ages six and 10, in partnership with the high-quality instructional programme "Swim-Safe".

Bangladesh Shishu Academy (BSA) and the ministry received the responsibility to implement the project nationally. But BSA, which works under the ministry, has not yet been able to complete preparatory works, including selecting NGOs for collaboration. Meanwhile, more than one-third of the implementation duration has passed.

Contacted. Tariqul Chowdhury, project manager at BSA, stated that despite receiving approval in February 2022, they received the government order from the ministry in May last year, for which they were unable to commence work.

"We have started our work in July 2022 and expect to commence fullscale operations once the NGOs are selected. The project may receive a total of 18 months to complete all works," he

Tariqul also mentioned that the project hired 16 assistant project managers last November to oversee the work of NGOs in 16 districts, and they have undergone a two-day orientation in two batches.

"In mid-February 2023, we hired procurement specialist to draft the terms of reference for selecting NGOs. This process took time due to advertising in newspapers for the recruitment," he said.

On March 20, a cost-estimation committee was formed to approve the cost for eight packages in 16 districts, and upon its approval, the "expression of interest" will be released in April, he

For the first time in history, an exhibition displaying images and stories of the 1971 genocide started at the United Nations Headquarters in New York for three days.

The Permanent Mission of Bangladesh to the UN organised the exhibition, titled "Remembering the victims of 1971 genocide in Bangladesh", in collaboration with Liberation War Museum, stated a press release.

The exhibition kicked off on Wednesday featuring 27 photographs of the 1971 genocide along with a corresponding historical narrative, in commemoration of National Genocide Day on March 25.

Inaugurating the exhibition, Bangladesh Foreign Secretary Masud Bin Momen said. "It's a historic step in our efforts to garner international recognition of the horrendous genocide that was committed by the occupation army and their collaborators against our people in 1971."

Ambassador Muhmmad A Muhith said, "We need more efforts to share the stories of our great Liberation War and the genocide among international audience."

"This will not only help us secure the muchneeded recognition of the 1971 genocide but also raise awareness on the need to prevent genocide and other atrocity crimes," Muhith added.

Ambassadors, UN officials, eminent persons from the Bangladeshi community, including the family members of the freedom fighters and the martyrs, were present during the inaugural ceremony. The exhibition will end today.

According to the guideline, the service will be available from 3:00pm to 6:00pm every day, but the service cannot be closed until all the patients registered in a day are served.

A patient has to pay Tk 500 to get consultation from a professor, Tk 400 from an associate professor or senior consultant, Tk 300 from assistant professor or junior consultant or postgraduate physician, and Tk 200 from MBBS or BDS or equivalent qualified physicians.

A portion of the fees, Tk 25 to Tk 50 will be paid to the supporting staffers while an equal portion will be taken as service charge for hospitals.

In addition to the consultation services, patients will get diagnostics and laboratory, surgical, and procedures like endoscopy, procedures endoscopy, colonoscopy, echocardiogram, etc.

The patient will pay Tk 1,000 for minor surgeries while Tk 1,500 for major ones.

If any patient requires hospital admission, respective physicians will arrange it, according to the protocol.

Each doctor of the hospitals will have to participate in the Institutional Practice twice a week.

US, allies concerned

Myanmar's ousted leader Aung San Suu Kyi, 77, is serving 33 years in prison for various offences and dozens of her NLD allies are also in jail or have fled. The NLD had repeatedly ruled out running in the election, for which no date has been set, calling it illegitimate.

"We are seriously concerned that the exclusion of the NLD from the political process will make it even more difficult to improve the situation," Japan's foreign ministry said in a statement.

"Japan strongly urges Myanmar to immediately release NLD officials, including Suu Kyi, and to show a path toward a peaceful resolution of the issue in a manner that includes all parties concerned."

A spokesperson for Myanmar's military could not immediately be reached for comment. Its leader Min Aung Hlaing on Monday urged international critics to get behind his efforts to restore democracy.

US State Department deputy spokesperson Vedant Patel told reporters that the United States "strongly condemns" the decision to abolish 40 political parties.

"Any election without the participation of all stakeholders in Burma would not be and can not be considered free or fair," Patel said, using the Southeast Asian nation's former name.

Britain's foreign office criticised the dissolution of the NLD and other parties as an "assault on the rights and freedoms" of the Myanmar people.

"We condemn the military regime's politically motivated actions and their use of increasingly brutal tactics to sow fear and repress opposition," a foreign office spokesperson said.

Australia's Department of Foreign Affairs and Trade said it was seriously concerned about a further narrowing of political space in Myanmar due to tough election registration requirements.

A section of lawyers seeks

autopsy. After nearly 10 months, police informed Sarkis that the autopsy report had mentioned that her daughter had been raped before her death.

Three cases were filed over the incident between January 29 and November 22 last year, but police neither arrested anyone nor made any headway in the investigation.

The victim's parents have been alleging since her death that she was raped and then killed at her employer's flat.

"It has been a year since my child was raped and killed, but no culprits have been identified and arrested. Only Allah knows when we will see justice," said Iti's father Alamgir Mia, a rickshaw puller.

"To support our poor family, we sent her to work. But she had to suffer this kind of death within a few weeks," he told The Daily Star.

THE CASES

Iti's parents said they went to Rampura Police Station to file a murder case soon after seeing her body at the hospital. But the police registered an unnatural death case

"I sent my daughter to work at the house of Iffat's parents in Dhanmondi. After around 20 days, she came back and stayed for a few days. I had to convince her to return to work. I learnt that she was working in Rampura when I talked to her for the last time," said Sarkis.

"If my daughter had died by suicide, why didn't they call the police and us to their house? I don't believe she killed herself."

On February 23 last year, Iti's father Alamgir filed a case with a Dhaka court accusing Rajin and Iffat of murder. The court first asked the Criminal

Investigation Department to probe the case. After the CID failed to come up with a report in nine months, the court asked the Police Bureau of Investigation to probe it, according to court documents.

PBI Sub-Inspector Nazim Uddin, who is investigating the murder case, told The Daily Star that he has been working on the case.

Meanwhile, the autopsy report was

Police then sent the body to Dhaka Begum, lecturer of forensic medicine the probe.

It said, "Considering autopsy chemical findings, histopathological report of viscera, and microbiology and DNA analyses, the cause of death was asphyxia as a result of hanging, which is antemortem and suicidal in nature, but the sign of forceful sexual intercourse was present in the victim's body."

Asked why the report was delayed, Towhida said autopsy reports often get delayed because it takes longer to get the DNA report.

On November 22, around a month after the autopsy report came, Sarkis filed a case with Rampura Police Station over rape and suicide instigation, accusing unnamed individuals.

In the case statement Sarkis wrote her daughter worked in a house where Kamal Uddin Ahmed, his wife Kahinoor Kamal, son Rajin Ahmed, daughter-in-law Iffat Jahan Chowdhury and maid Rokeya live. Their driver, Monzur Alam frequently visits the house.

"I suspect my daughter was raped by a man living or visiting that house," the statement read.

Rampura police then submitted the First Information Report before the Chief Metropolitan Magistrate's Court of Dhaka.

investigating the case, has yet to file any report on the probe. Asked, Golam Mowla said, "We are

CHINA-EU TIES Ukraine 'determining factor': EU chief

EU chief Ursula von der Leven vesterdav warned Beijing that its stance on Russia's war in Ukraine would determine Chinese-EU ties but said Europe was not looking to "decouple" from China.

The head of the European Commission will accompany French President Emmanuel Macron to Beijing next week as EU leaders reach out to China's Xi Jinping.

The visit -- and another by Spanish Prime Minister Pedro Sanchez starting yesterday -- comes after Xi staged a show of solidarity with Russian President Vladimir Putin in Moscow last week.

"Far from being put off by the atrocious and illegal invasion of Ukraine, President Xi is maintaining his 'no limits friendship' with Putin's Russia," von der Leyen said in a major policy address.

China has tried to position itself as a neutral mediator and pitched what it describes as a plan to help end the fighting.

But it has refused to condemn Moscow's war and there have been warnings from the West against any potential moves to send Russia arms.

Von der Leyen said any "viable" peace plan needed to be on Ukraine's terms and should not consolidate the Kremlin's grip over territories it has seized.

Asia must avoid chaos, conflicts Warns Chinese premier

Asia must avoid "chaos and conflicts" or the region's future will be lost, Chinese Premier Li Qiang has said.

Speaking to an international audience of political and business leaders yesterday, Li said China can be an "anchor for world peace" and stability, and will continue undertaking reforms and opening up.

"In this uncertain world, the certainty China offers is an anchor for world peace and development," Li told the annual Boao Forum for Asia on China's Hainan Island. "This is the case in the past and will remain so

Dozens of business leaders, including Apple Chief Executive Tim Cook, HSBC Chief Executive Noel Quinn, and Blackstone founder Stephen Schwarzman, are attending the forum, which comes as China faces heated competition with the United States as well as the task of reviving the world's second-largest economy after nearly three years of isolation under a tough "zero-Covid" policy, reports Al Jazeera online.

and interferences have never been an obstruction, and will never be."

TEMPLE FLOOR COLLAPSE 12 dead after falling into Indore well

Twelve people have died after more than 30 people fell into a stepwell at an Indore temple yesterday morning. The roof of the well, which housed the shrine, had collapsed due to heavy footfall on the occasion of Ram Navami. Seventeen people have been rescued and many of them hospitalised as rescue work at India's Beleshwar Mahadev temple continues. The incident at Beleshwar Mahadev temple took place amid a rush of devotees on Ram Navami. Visuals from the spot indicate that the floor of the temple caved in owing to heavy footfall, throwing people into the well. The videos showed devotees being brought out using ropes and ladders. Madhya Pradesh Chief Minister Shivraj Singh Chouhan earlier said all efforts are being made to rescue those who fell into the well.

One of his friends witnessed Sultana being picked up around 10:00am on March 22 and told him.

Montu went to the local police station and the detective branch but failed to trace her until 1:45pm when Sultana's son called.

"A Rab man called Sultana's son using her mobile phone to inform him about her hospitalisation," he said.

Montu went to see her at the Naogaon hospital with one of Sultana's sisters and her husband, but they left after a while.

After 5:00pm that day, Montu received several calls from a Rab personnel who used Sultana's phone to ask him to visit the hospital

"I told the caller that we went to the hospital but we returned home due to bad behaviour of Rab men," Montu said.

"The caller apologised and nsisted we visit the hospital." Montu sent Sultana's

brother-in-law to hospital after iftar and on his arrival, Rab men took Sultana to Rajshahi Medical College Hospital.

The Naogaon hospital authorities earlier said they referred Sultana to a better hospital at 3:55pm on March 22, but she left the hospital for Rajshahi at 7:00pm.

Around midnight on March 22, Sultana's brotherin-law called Montu to say that Sultana was taken to the ICU of RMCH immediately on arrival.

He told Montu that doctors detected haemorrhages but wanted to observe her for 72 hours before a surgery.

Sultana was put on life support two hours before her death at 10:00am on March 24, Montu said. He said, "During her

treatment, Rab men kept family members [her sisters, a brother, a brother-in-law, and her son] in a hotel in Rajshahi city ... but kept them under watch."

Sultana was detained based on a verbal complaint of her boss, he said, adding that she was watched over and chased like a criminal.

Lawfare on the press must stop

Prothom Alo incident exposes deeply upsetting approach to press freedom

We are deeply alarmed by the relentless lawfare (legal warfare) being waged against press freedom and the freedom of speech using various legal instruments. The latest victims of this are a reporter and the editor of *Prothom Alo*, who have been sued under the Digital Security Act (DSA) for "tarnishing the country's image" using its platforms. The hint, of course, was to the daily's May 26 publication of a report on the astronomical prices of food using a comment from a day labourer, which has since gone viral. The question is, how does the coverage of poor people's struggles constitute a crime? This is nothing but an attempt to intimidate journalists and discredit the message so powerfully captured in said comment.

Reportedly, the general secretary of the ruling party called the report "politically motivated". In all fairness, it is the DSA case that seems politically motivated. The report was done following standard journalistic practices, and Prothom Alo was quick to take appropriate action after an apparent inconsistency was pointed out in its social media post. That should have been the end of it. Anyone with the remotest idea of how the news media works would know that the reporter, Samsuzzaman Shams, was innocent of the "crimes" alleged by pro-AL factions. Yet, he was picked up from his house by officers of the Criminal Investigation Department (CID). His whereabouts were kept hidden for about 20 hours. And two cases were filed against him before he was finally shown arrested in one and produced before court.

This elaborate charade to harass him reminds us of the legal mumbo jumbo in which another Prothom Alo reporter, Rozina Islam, was implicated not long ago. On Thursday afternoon, Shams was denied bail by the court and sent to jail. On Wednesday, a journalist of Jugantor was sued under the DSA for reporting on a railway syndicate operating in Chattogram. In mid-March, journalists covering the election of the Supreme Court Bar Association were assaulted by police. The frequency with which journalists are coming under attack, legally or physically, is really alarming.

The DSA, for obvious reasons, has emerged as the most preferred tool of repression of journalists and critical voices, as a review by the Centre for Governance Studies (CGS) has shown. The judiciary's role in this regard has also been wanting. We expect the judiciary to stand in favour of journalists especially when they are harassed with trumped-up charges. Unfortunately, just like DSA, the entire legal infrastructure is being instrumentalised today to "chill critical reporting", undermine press freedom, and encourage a culture of selfcensorship. This is no doubt an affront to everything that we stand for as a nation. The question is, how long will the authorities ignore calls to create an environment in which the press can function without any fear of consequences?

Shams doesn't deserve to be in jail. The Prothom Alo editor, Matiur Rahman, doesn't deserve to have a DSA case filed against him. All such cases do not deserve to be entertained. We hope that the judiciary will stand with the press and take appropriate steps in this regard soon.

A sheer waste of public money

Why were the trauma centres built if they were to be left unused?

It is disappointing to learn about the numerous development projects taken up by the government that ended up not serving the public as promised because of lack of necessary research, proper planning, and execution. Although these projects failed to bring desired results, a lot of public money was spent on them. One example of this is the 21 trauma centres that were built in the last 20 years along our highways. According to a recent report by Prothom Alo, almost all of these centres remain inoperative as there is neither the manpower nor the equipment required to run them. The question is, why were these centres built then?

Reportedly, among these 21 trauma centres, 16 are currently inoperative, two have only outdoor units, while one is currently being used as the orthopaedic department of a district hospital. These centres were constructed along the highways with the aim to quickly transport and treat the injured in the event of a road crash, so that lives could be saved. But that purpose was defeated by the lack of initiative on the part of our health authorities. After the recent tragic road crash on the Dhaka-Bhanga expressway, we have seen how the injured had to be taken to several upazila health complexes and even to a private hospital near the expressway for treatment. If the nearby trauma centre were functional, the injured could get proper treatment on time. This is really frustrating.

And now, after spending around Tk 140 crore on the construction of these centres, the Director of Health Directorate (Hospitals and Clinics) is telling us that the idea of a trauma centre is not realistic in the context of Bangladesh, and that they are planning to repurpose these unutilised buildings. However, it is not clear why the government can't put them to proper use by appointing the required manpower

doctors, nurses, pharmacists, technicians, etc. – and handing them proper equipment? Given the extremely high number of road crashes taking place on our highways, these centres can certainly play a great role in treating the injured. We think the government should consider this fact before abandoning these

The fate of these trauma centres again exposes the sheer lack of accountability in our health department. If there was any accountability, such projects could not be taken without doing the necessary feasibility study. If there was any accountability, so much public money could not be wasted on projects doomed to failure. This is just one example of how lack of planning and execution has been plaguing many finished government projects. We have seen many such ill-planned projects undertaken by government institutions, including the railway ministry in the last few years alone. Such practices must stop. Those responsible for these projects must be held to account.



Even the High Court has questioned under what authority Rab picked up Sultana, as she wasn't an accused in a case at the time. The High Court bench asked what happened to her between the time of her detention (11:50 am on March 22) and her being taken to the Naogaon hospital (1:15 pm the same day). Rab's official statement regarding Sultana is that she fell ill while being was taken to the hospital.

According to Rab, after detaining Sultana, some of its members were

Rab accountable for her death. In Bangladesh, however, accountability of any security force is overwhelmingly absent, except in a very few number of

Sultana's death eerily reminds us of the death of writer Mushtaq Ahmed, who was also accused under the DSA, picked up by police and sent to jail. > As civilians, we know that asking these questions will never bring any satisfactory answers. It may even be dangerous. Does this mean that, at any time, for any reason, anyone can be picked up from their home, office or from the streets, and whisked away in a microbus with no guarantee whatsoever of whether they will ever return to their loved ones? There are still many individuals languishing in jail, arrested under the notorious DSA that seems to have become a weapon of the powerful to "tame" anyone they consider their enemy.

The High Court has shown its integrity by raising the pertinent questions against Rab's arbitrary acts. A Supreme Court lawyer has filed a public interest litigation, seeking court's proactive intervention will to Sultana Jasmine, and if there has been any breach of her human rights, legal action will be taken against the officials involved.

A window of opportunity to phase out fossil fuels

Next week, the UN's top experts on climate science will release a landmark report on climate change. Already, we are clear on what it will portend: a warming world, an unsure future, and a more severe climate chaos than we are already experiencing across the globe. We're not yet on track to save ourselves from this dire destiny, which will require us to keep the world from warming more than 1.5 degrees Celsius – the threshold beyond which climate change will trigger the most devastating consequences.

That news will be no surprise for the people we represent: millions of Bangladeshis and US Americans already hit by floods, droughts, and other extreme weather events made worse by climate change.

But there's a sliver of hope. The latest science says that it's still narrowly possible to limit global warming to 1.5 degrees Celsius, but only if we agree to phase out fossil fuels starting right now.

It's the latest and direst warning that we need to drastically reduce our reliance on fossil fuels. The International Energy Agency

has already said that new oil and gas development needs to stop immediately. The reason is glaringly obvious: burning of coal, oil and gas has been the source of 80 percent of carbon dioxide emissions since the industrial revolution. It drives up the Earth's temperature and creates a spiralling crisis of extreme weather, rising sea levels, disease, biodiversity loss, water stress and poverty.

The fossil fuel industry continues to put profits first, so we need leaders who will put the people first. That includes having leaders at international financial institutions like the World Bank, who will firmly commit to addressing climate change and to better supporting vulnerable nations - not double down on fossil fuel investments - as well as electing leaders in nations across the globe who will commit to working in concert to address this planetary crisis that knows no borders.

We need strong climate leadership in every hall of power, including in the boardrooms of multilateral development banks. Since Paris Agreement was signed, the World Bank has continued to invest billions in fossil fuel projects. It has fallen behind on its already meagre climate commitments, which are less ambitious than the baseline targets set by other development banks. International financial institutions have a responsibility to meet the moment by ending fossil fuel funding and stepping up on climate aid to

On the national level, we need heads of state to pick up the pace on talks to end fossil fuels and follow the example of those who are leading the way. Tuvalu, Vanuatu, and the European Parliament have endorsed the Fossil Fuel Non-Proliferation Treaty. Colombia says it will ban new

PERSECUTION OF JOURNALISTS

Condemnation isn't enough

The way Prothom Alo correspondent comfort in this arrest as a "success" Samsuzzaman Shams was picked up from his residence at around 4am on Wednesday by plain-clothed police, and later reported to have been arrested under the Digital Security Act (DSA), demonstrates the deeply disturbing state of freedom of expression in Bangladesh. This was followed up by more disconcerting news that a case has been filed against the editor of the newspaper, Matiur Rahman.

That Samsuzzaman's detention was not acknowledged by police for at least 18 hours after he was picked up is not something unique, but only the latest example of a pattern we have witnessed over the claimed no knowledge of his arrest, later Law Minister Anisul Huq and Road Transport and Bridges Minister Obaidul Quader told the press that specific complaints had been filed against Samsuzzaman. According to the available information, Samsuzzaman was "arrested" in a case filed by a man named Syed Md Golam Kibria under the DSA with Tejgaon police station in Dhaka. The case against Matiur Rahman was filed under the same law by Abdul Malek, a lawyer of the Supreme Court.

No matter how much the ruling party claims that the large number of media outlets in the country is evidence of freedom of the press, incidents like these are enough to lay bare the real picture. Add to this the government's decision to close down newspapers supported by the opposition party and the cancellation of domain allocation of 191 online news portals based on the information of government intelligence agencies, and one can get a better picture.

The annual freedom of the press index published by Reporters Without Borders (RSF) in May 2022 shows that Bangladesh has slipped down 10 notches in a single year. Bangladesh was ranked 162nd out of 180 countries in the index, with a score of 36.63 in 2022. There is no reason to think that this year's report, expected to be published in May, will show any sign of improvement. This can be assumed from the fact that a recent human rights report released by the US Department of State highlighted the impediments to freedom of expression and the internet in Bangladesh. According to the report, the media, known to be critical of the government and the Awami League, have been harassed. Advertisements in those media have been cut. For this reason, many media houses have voluntarily avoided criticising the government.

Samsuzzaman's arrest exposed the intimate relationship between the government and the ruling party supporters, including "journalists," "editors" and "media," who have been running a fierce campaign against him after the publication of a report on Independence Day. They can take

of their campaign. But they not only jeopardised Samsuzzaman's safety as an individual, but also harmed Bangladesh's image and interests. Ironically, these individuals and media outlets are often concerned about the image of the country. Those who think that the way these supporters are explaining these actions will be acceptable to everyone live in an echo chamber.

The entire saga pertaining to the report in question is wellknown. As explained by *Prothom* Alo, a "card" used for social media promotion was posted on Sunday quoting Zakir Hossain, a daily wage labourer, highlighting a news report past decade. While police initially on *Prothom Alo's* Facebook page. Although Zakir Hossain's name and quote was used on the card, a picture of a child was attached to it (who was also quoted in the report). As the newspaper understood that the quote of one and a symbolic picture of the other could be misconstrued, it was removed from social media less than 17 minutes after it was posted. Later, the report was revised, and the amendment was mentioned and published online again. Nowhere in the report was it said that the highlighted statement was made by the child. Rather, it has been clearly stated that the quote belongs to Zakir Hossain. There was no factual error in this report. One can at best complain about not-soapt visuals, but that, too, is a stretch as using a symbolic picture with a report is not unusual in the media. Yet, the newspaper considered it an error, admitted the "mistake," and corrected it in a short time.

For more than a decade, legal and extra-legal measures have been employed by the government to muzzle the press. Common citizens have been subjected to harassment even for expressing the slightest dissent. Relatives of journalists have been detained, attacked, and harassed. For this, state agencies are being used in white clothes. Additionally, censorship has been "outsourced" or "franchised" to activists of the ruling party. Both offline and online, these forces are engaged in harassing and attacking people who hold contrarian views. It was well-known that these were perpetrated with the knowledge and consent of the government and the ruling party, but the arrest of Samsuzzaman has made it clear that and the government and these activists release. The detention and "death" of Sultana Jasmine have once again shown the nature of the existing system of governance. They showed that the "verbal complaint" of an official of the government is sufficient to activate a force and act against a citizen. The presence of the said government official during "the interrogation" by Rab defies any logic or prevalent laws. But, there have been repeated attempts to justify the unlawful detention, socalled interrogation, the mysterious presence of an official, and the "sudden death" of an arrestee.

It is also worth noting that the legality of this detention is now being constructed through post facto filing of a case under the DSA. Needless to mention that the law, since its introduction in October 2018, has been criticised by human rights activists at home and abroad. I have demonstrated with data of 47 months, gathered under a project of the Centre for Governance Studies (CGS) (January 2023), that the law is nothing short of a tool of persecution. The United Nations High Commissioner for Human Rights Volker Türk said on March 7 that under the DSA, "criminal sentences continue to be handed down against those exercising their rights to free expression and belief." The law has provided state agencies with the power to pick up anyone from the street, as was the case of Sultana Jasmine.

The incidents of being picked up by plain-clothed state actors, denied freedom of expression, being tortured, and dying in custody are essentially no different from the incidents of extrajudicial killings and enforced disappearances. These are now commonplace because the country is being governed by imparting fear. Coercion and intimidation are at the heart of the system of governance. The 2023 annual report of the Varieties of Democracy (V-Dem), one of the world's leading research institutes on democracy, has once again called Bangladesh an "electoral autocracy." In each of the indicators used by V-Dem to measure the state of democracy in a country, the situation in Bangladesh has worsened in 2022 from the previous year. Another research organisation, International Institute for Democracy and Electoral Assistance (International IDEA), has been classifying Bangladesh as an autocracy for quite a few years. This kind of rule survives through the denial of the right to freedom of expression, assembly, and voting.

It is our moral duty to condemn the arrest of Samsuzzaman Shams demand his immediate must condemn the case against Matiur Rahman. There's something about moving whether it's to a new town or a new continent - that always makes me seek out the familiar. And although I don't always notice when I'm doing it - or feeling it – this morning, when it starts to rain in Dhaka for the first time in months, wonderful light, clean rain, I find myself standing on the balcony, breathing in the scent of damp leaves and being transported back to the straggly meadows near where I grew up in England that seemed to shimmer after the rain, revelling in their bright green-ness. I remember the fields so clearly that I can almost taste the tinny wet-earth smell and feel the slippery mud that squelched under my shoes. For an instant it's as though I'm there again, back in a place where I felt like I belonged.

Yet I wonder about belonging. Where its joy and relief live in my body. And whether it's also responsible for the moments of loneliness I've struggled with over the years - moments of disconnection and isolation tinged with sadness.

The first time I left London to live overseas with my young family was when we moved to the Caribbean with my husband's job. Everyone back home thought we'd won the relocation lottery and would repeatedly tell me how envious they were of the fact that I got to live next to white sandy beaches and take the kids to paddle in the clear, warm, turquoise sea after school.

Barbados was, and is, a stunningly beautiful island. Yet I struggled with homesickness. I missed my mum, my sisters and my friends – people who made me feel grounded, supported. I wasn't used to seeking out the familiar and became disconnected from myself, struggling to find a way

There was also a heaviness to the place. A dark atmosphere that felt particularly strong when I drove through the interior of the island, along narrow roads that cut through winding fields of sugar cane to the east coast, and connects us?

stood on the shore looking out over the Atlantic. I later learned that's where the slave ships used to come in, ships that contained people chained together for weeks in horizontal rows, packed in layers like dead fish – many of whom were dead by the time the boat landed.

The survivors are the relatively close - ancestors of those who now belong to the island, its soft sea breezes and rangy coconut trees, its legacy of derelict cane factories and its dark history. Despite this deeply traumatic beginning, people who call themselves Barbadian today have accepted the land as theirs. And in a sort of enforced yet tender adoption, they, like many of the world's displaced people, have found themselves in the land. a home. And after four confusing, changes when I see that we all

I wonder about this when I find myself moving through Gulshan one day on a rickshaw. I pass a tea stall, noticing how tired and relieved some of the men gathered on the pavement look, how I've seen that look on faces so many times before, and I watch as a battered bus slows down and a frail old man starts to get off and nearly falls to the ground before a crowd of people rush over to help him. Then there is a dog lying asleep in the road near my building, unflinching, completely relaxed as the cars and rickshaws veer around her. As the evening call to prayer begins, a plaintive song that reminds me where I am, over and over again, I notice how witnessing these interactions makes me feel connected, safe. And I remember that everything

All You Need to Know about Fire Safety Regulations in Bangladesh

To prevent a spate of fatal fires. it is crucial to establish an effective authority for monitoring systems and collaboration at the local level, as it would not be feasible to control the fire concerns otherwise.

In the wake of two recent fire explosions in Narayanganj and Mogbazar, a surge of deadly fires has plagued the country with daily reports of fire explosions. From the Gulistan building explosion to the blasts at Science Lab and at Sitakundu, the country has witnessed a spate of deadly fires that have caused fear and anxiety among the people. With each new fire-related fatality, the public has grown increasingly alarmed and concerned about compliance with fire safety regulations. Considering this, this piece aims to illuminate the present legislative framework for fire safety and the reasons for non-compliance.

The first law worth noting in this context is the Bangladesh National Building Code (BNBC), 2020. This law has been subject to several amendments due to the past firerelated experiences. Part 4 of the Code covers the requirements for fire prevention. It specifies the general conditions of fire protection (Chapter 1), precautionary requirements (Chapter 2), provisions for exit (Chapter 3), and requirements necessary to minimise danger to life from fire, smoke, fumes, and so forth. Some of the vital fire safety provisions of the Code include:

(a) Fire-resistant construction: The Code mandates that all buildings must be constructed with fire-resistant materials that can withstand the spread of fire (Part III);

(b) Fire detection and alarm systems: The Code requires that buildings be equipped with fire detection and alarm systems that can detect smoke, heat, and fire and alert occupants in case of a fire (Part IV, Chapter 5);

(c) Means of escape: The Code requires buildings to have multiple means of escape, such as staircases, corridors, and exits, to enable occupants to evacuate quickly in case are yet to have been formed even after two of a fire (Part IV, Chapter 3);

(d) Firefighting equipment: The Code mandates that buildings must be equipped with firefighting equipment such as fire extinguishers, fire hoses, and sprinkler systems to help control and extinguish fires (Part IV,

(e) Smoke management systems: The Code requires buildings to have smoke management systems such as smoke vents, exhaust fans, and pressurisation systems to control the spread of smoke in case of a fire (Part IV, Chapter 3); and

(f) Fire drills and training: The Code mandates that building owners and occupants must conduct regular fire drills and training sessions to ensure that everyone is prepared to evacuate safely in case of a fire (Part 4, Chapter 1, Appendix B).

Compensatory provisions for road accident victims

Compensation to victims of road accidents has been a public demand. The Road Transport Rules, 2022 issued pursuant to the Road Transport Act, 2018 provides some clarity in this regard.

Chapter 8 of the 2022 Rules has elaborately discussed the provisions regarding compensation and treatment to road accident victims and also the insurance of motor vehicles.

According to rule 142, a financial assistance fund will be formed for road accident victims under a trustee board. As per rule 143, the owner of a bus, truck, and prime mover truck will pay Tk 1,500 a year for the fund, while the fee is Tk 750 for a minibus, minitruck and pickup.

Moreover, the 2022 Rules has also mentioned how much money the other vehicles' owners must pay to the compensation fund regulated by the trustee board. On the other hand, if any vehicle owner fails to pay the fee on time, he will have to pay a fine of Tk 50 for each month of delay.

Rules 144 and 145 have discussed the trustee board's duties and liabilities. The board will investigate and dispose of any complaint or grievance of the victims or the heirs of the deceased. Again, rules 146-148 have tried to analyse the administrative and procedural functions of the board.

As far as the amount of compensation is concerned, rule 149 has set up the minimum compensation for road accident victims.

> If someone dies in a road accident, the one-time compensation will be at least Tk 500,000, and victims who lose a limb or suffer other life-changing injuries will receive financial assistance of at least Tk 300,000 each. Further, a victim likely to recover from injuries and return to normal life will get at least Tk

100,000. It is important to note that the trustee board can reduce or increase this amount of compensation with the government's prior approval.

Rule 150 has elaborated the procedure for disbursement of financial assistance, inquiry, application approval, and disbursement period. According to this rule, an application should be made in the prescribed form to the chairman of the trustee board within 30 days of the occurrence of the accident. The chairman of the board will form a probe committee within 10 days of receiving the application, and the committee will submit a report on the damages within 30 days of formation. Then the board will take measures to compensate the victim or the heirs of the deceased within 30 working days of receiving the report.

In case of disagreement with the original order, rule 152 has provided the scope for filing a review, and further, an appeal petition by an aggrieved person against the board's decision.

Next, if the decision of the appellate authority aggrieves any person, rule 153 has conferred upon him another opportunity to apply before an arbitrator, who will resolve the issue within 30 working days.

These legal provisions shall enlighten a road accident victim or the heirs of the deceased to secure payment of compensation.

The 2015 Policy recognises the jobs of domestic workers as 'labour', which ensures the protection of their rights. Moreover, it necessitates the welfare, entertainment, leisure, leaves, and congenial and decent working environment of domestic workers. of a domestic worker is 14 years, and the matter for further action.

Alternatively, a criminal case can be filed against the perpetrators under the Penal Code, 1860. They may be fined and/ or imprisoned for up to 7 (seven) years, depending on the seriousness of the harm done to the domestic worker. Furthermore, the Prevention of Offences Against Women and Children Act, 2000 (Nari O Shishu Nirjaton Daman Ain, 2000) protects all oppressed children.

Indonesian players and fans were dismaved on Thursday after the country was dropped as host of the Under-20 soccer World Cup following outrage among politicians in the predominantly Muslim nation about Israel's participation.

FIFA made the call after Indonesia's football federation (PSSI) said it had cancelled the draw for the tournament because the governor of Bali refused to host Israel's team.

One Indonesian national team player blamed politicians.

"We sacrificed our time, thoughts, sweat and even blood. But it suddenly failed due to your political reasons, striker Rabbani Tasnim Siddiq said

Another player, Hokky Caraka, said he had lost the chance to fulfil a "life goal to make my parents proud, scoring goals in the Ú-20 World Cup".

The stripping of the hosting rights also means Indonesia loses its automatic berth in the tournament.

The Brazilian forward is out for the season due to his ankle surgery in March, and is using some of his free time to indulge in his passion for poker.

Neymar often tries his luck in online games on his Twitch platform. In doing so on this occasion, he threw away a staggering amount of money. Not that the Brazil international seemed to care.

According to reports from Brazilian outlet Globo Esporte, he lost 1 million in just an hour, causing him to fake cry and scream while a mock Titanic theme played in the background.

Neymar also saw his Twitter account hacked on the same night he suffered the big loss. Among the messages was a directed profanity towards a Brazilian news outlet, which is uncharacteristic of the usually calm and collected footballer.



Tigers look to maintain intensity in final T20I

Bangladesh captain Shakib Al Hasan had already given the cue that there may be changes in the line-up for the third and final T20I against Ireland, but what he would not want to see change is the hunger and drive from his players. If that intensity is carried forward, more records may tumble in the third T20I today.

It has been evident that the Tigers have had the mental edge against Ireland this series, having successfully shown aggression in all three departments. The Irish were the only side to beat England in the T20I World Cup last year, so a lack of intensity will allow the visitors to gain a foothold ahead of the away series in England in May.

"If we go to Australia or England and they are 2-0 up, they will look to go 3-0. We will not be complacent. Maybe we'll try new guys, but they will be just as hungry to score runs or get wickets," Shakib had said after the series-clinching second T20I.

The Tigers are undergoing a purple patch in T20Is, which includes \bar{a} historic 3-0 whitewash of England in their previous

The pace attack has been tremendous in the last few series and only a bit of tinkering might be possible. It may be likely that Shoriful Islam gets into the side considering the need to manage Taskin Ahmed's workload.

The bigger question is whether the Tigers will play leg-spinner Rishad Hossain to reinvigorate the outlook of the side for the

When it comes to leg spin, Bangladesh have been afraid for a while. In domestic games, leg-spinners are not the attacking options that they are usually intended to be. Without performances to back him up, Rishad will have to make way as well. But from the team's perspective, a leg-spinner playing without fear is the priority.

The opening slots have been promising in the recent two series. Rony Talukdar has been able to reciprocate the management's faith by showing that he can come out and attack during the Powerplay. Like Rony, others have been given the licence to play without the fear of being dropped.

"We play to the plan which the team management gives us.



series, and Shakib would not like to see that slip in the final T20I. The basic plan is to stay positive and show that intent. The team management is trying to emphasise one thing in the dressing room and that is being able to play fearless cricket. That's our main task," Rony said yesterday.

The openers have been able to find a similar groove in their approach this series and open possibilities with lofty Powerplay ambitions. For Rony, their aggression was not founded on swinging their bats at anything that comes their way.

"We talk a lot and try to play according to the merit of the ball and focus on playing proper cricketing shots. If you can rotate the strike with positive intent, there is more chance that the innings will be big," he said.

The batting order has found more flexibility as well. Shakib promoted himself up the order in the last match and such changes could be the norm.

"We make our plans match by match. The plans aren't made for how to play series against England or series against Ireland. If we could go in a similar vein, it will work for us in the future. As a team, the team management wants to boost the idea of playing aggressively," he said about the constant urge to go forward.

Alfaz laments lack of spirit

Except for suspended Sri Lanka, all subcontinent nations grabbed the opportunity to play international friendlies in the FIFA window in March to assess their performances ahead of the upcoming SAFF Championship, slated for June 23 to July 3 in India.

Bangladesh, India, Nepal, and Bhutan had played a maximum of two matches apiece. 106-ranked India predictably registered wins against two strong sides in Myanmar and Kyrgyzstan while Nepal defeated Laos before being held by Bhutan. Elsewhere, Maldives beat Pakistan in the two side's only match in the FIFA window.

Meanwhile, hosts Bangladesh beat Seychelles first-up 1-0 before a dismal performance allowed the visitors to bounce back with a victory by an identical margin in Sylhet.

The defeat to Seychelles had triggered scrutiny towards the Bangladesh booters. Their latest performance remained subpar despite having prepared for nearly two weeks in Saudi Arabia, where they played two practice matches, before facing the East African nation, comprising a majority of amateur players who can only afford to focus on the sport on weekends.

Bangladesh legend Alfaz Ahmed lamented the approach of the players for having lacked "mentality" and "commitment", and the former



national striker specifically criticised the tactics of head coach Javier Cabrera.

"I will blame everyone, including the coach, for the defeat in the second match but we have to accept the defeat because such upset happens in football," said Alfaz, who is also the head coach of Mohammedan Sporting Club.

Alfaz was baffled by the defensive formation from the onset and he thinks the subsequent substitutions were odd enough for Cabrera to be "held accountable" for game plan.

"What did he [Cabrera] want to execute in the second match? The coach should be asked why he sent Jamal Bhuiyan in the second half after choosing two defensive midfielders in the starting

"I think the team went on the back foot after Robiul was substituted by Jamal. Two wings also did not work effectively despite sending Mohammedan Ibrahim, who was instrumental in

the couple of previous matches by scoring goals. "Before playing the second match, the players got an idea about the opponents. They should play attacking football on the back of the first-match win but they played with two defensive midfielders, leaving Suman Reza as the lone forward in th

attacking third," opined Alfaz. He remains unwilling to bank on Cabrera's charges to go the distance at the upcoming regional extravaganza. "Seychelles may be ahead of Bangladesh in terms of physicality, but ... if we put such a poor display on the back of good preparation, then we don't see any hope for this team. There was no spirit among the boys," said Alfaz, adding if Bangladesh can grow as a team in remaining weeks, there could be a possibility to go beyond the group stage of the SAFF Championship.

Back to familiar format, IPL begins today REUTERS, Bengaluru

Gujarat Titans begin the defence of their Indian Premier League (IPL) title against four-times champions Chennai Super Kings on Friday as the Twenty20 tournament returns to its traditional home-and-away format after a gap of four years.

The 2020 edition of the moneyspinning league and the second half of the 2021 tournament took place in the United Arab Emirates as India battled the COVID-19 pandemic.

Last year's expanded 10-team event was held mostly in Mumbai and Pune. This time the IPL is also set to see three Bangladesh players feature -- Shakib Al Hasan and Liton Das for Kolkata Knight Riders and Mustafizur Rahman for Delhi Capitals. This is the highest participation in the money-spinning from Bangladesh. However, Liton and Shakib might miss a few games for KKR as the duo are yet to be released by the cricket board of Bangladesh, who are scheduled to play a one-off Test against Ireland from April 4.

Ahmedabad side Gujarat, one of the two expansion teams along with Lucknow, capped a fairytale debut season by defeating inaugural champions Rajasthan Royals in front of around 100,000 fans in

the final at home. Hardik Pandya's side are the bookmakers' favourites to retain the

trophy but five-times champions Mumbai Indians - the most successful IPL outfit and Chennai will aim to reclaim the crown in the 16th edition of the event.

Home support could play a major role and Chennai's fans served up a reminder of what teams have missed with a thunderous round of applause for Mahendra Singh Dhoni during a recent practice session amid media speculation it could be his last IPL.

While a return to familiar settings will be a welcome boost for teams, they will need to quickly master the new rule that adds another strategic dimension to the

For the first time IPL sides will be allowed to make a tactical substitution with an "Impact Player" coming in to bat or bowl as needed.

Delhi Capitals head coach Ricky Ponting said the move would almost negate the need for all-rounders.

With one eye on that tournament, India captain Rohit Sharma has suggested his national team players should consider skipping some IPL games to manage their

Top Indian players Rishabh Pant (Delhi), Jasprit Bumrah (Mumbai) and Shreyas Iyer (Kolkata Knight Riders) are missing the IPL this year due to injury, while England batsman Jonny Bairstow (Punjab) is still recovering from surgery.

Govt using DSA to gag the media Alleges Fakhrul

Voicing deep concern over journalists getting sued one after another, including Prothom Alo Editor Matiur Rahman, under the Digital Security Act, BNP yesterday said the government was carrying out extreme repression using the "black law" to gag media.

In a statement, BNP Secretary General Mirza Fakhrul Islam demanded the immediate repeal of the DSA and the withdrawal of all cases filed against journalists.

After law enforcers picked up Prothom Alo reporter Samsuzzaman Shams early Wednesday, Fakhrul said a DSA case was filed against the editor of the newspaper, Matiur Rahman.

Besides, he said a Jubo League leader filed another DSA case against Daily Jugantor's Special Correspondent and former general secretary of Crime Reporters' Association Mahbub Alam Lavllu in Chattogram.

The BNP leader strongly protested and denounced the filing of DSA cases against the journalists on "false charges".

Ukraine admits Russian gains

Moscow detains US reporter on espionage charges

Ukraine acknowledged some Russian gains inside the eastern battlefield city of Bakhmut, while insisting yesterday that it was inflicting greater losses on the Russian attackers than its own forces were taking in defence.

In a potential escalation of Russia's diplomatic feud with the United States, Moscow's FSB security service said it had arrested an American reporter for The Wall Street Journal, Evan Gershkovich, on suspicion of spying for Washington.

The newspaper denied the allegations and demanded the immediate release of "trusted and dedicated reporter" Gershkovich. There was no immediate response from Washington.

Gershkovich, a 31-year-old who has worked in Russia as a journalist for six years, is the highest-profile American arrested there since basketball star Brittney Griner, who was freed in December after 10 months in jail on drugs charges.

The FSB said it arrested Gershkovich

in the Urals industrial city of Yekaterinburg. He was brought to Moscow, where a court at a closed hearing ordered him held in pre-trial detention until May 29.

The TASS state news agency said he pleaded not guilty. The authorities released no evidence publicly, and TASS said the case had been marked "top

secret". Kremlin spokesman Dmitry Peskov said he believed Gershkovich had been "caught red-handed".

The small mining city of Bakhmut has been the site of the bloodiest infantry battle in Europe since World War Two as Russian forces have sought their first victory since mid-2022 in a huge winter assault.

GOVT HOSPITALS 51 begin serving outpatients after working hours

A total of 51 public hospitals have started serving outpatients after regular working hours in exchange for fees, read a press release.

Health Minister Zahid Maleque inaugurated the new service Institutional Practice -from his office at the Secretariat through videoconferencing yesterday noon.

Top officials of the health ministry, health directorate and the hospitals also joined the event.

Of the healthcare facilities, 12 were district hospitals and 39 upazila health

Addressing the event, the minister said, "We think the introduction of this system will benefit mass people. So, we have started piloting it in 51 hospitals. If people like it, we will expand it to all public hospitals within this year."

He also informed that the new system will operate in accordance with a protocol which has already been adopted.

"The protocol has every detail of how a healthcare staff will work in this afternoon service," the minister said.

SUU KYI'S PARTY US, allies concerned over its dissolution


The United States, Britain, Japan and Australia on Wednesday expressed their concern over the dissolution of Myanmar's former ruling party and urged a more inclusive process to return the country to democracy.

Myanmar's ruling junta on Tuesday disbanded Aung San Suu Kyi's National League for Democracy (NLD) and 39 other parties over their failure to meet a deadline to register for an election that is set to extend the army's grip on power.

Myanmar has been in turmoil since a military coup in early 2021 that upended a decade of tentative democracy, with a bloody crackdown on protests giving rise to an armed struggle against the junta. More than a million people have been displaced by fighting, according to the United Nations.

Earth-sized planet devoid of atmosphere Finds Webb telescope

The new James Webb Space Telescope observations of a far away solar system thought to have water found that its innermost planet is devoid of atmosphere, an advance that could lead to better ways of determining whether such celestial bodies host life.

An international team of scientists behind the discovery said the results mark an important step in determining whether planets orbiting small active stars can sustain atmospheres needed to support life.

The findings, published in the journal Nature, indicate that the dayside of the exoplanet Trappist-1b - about 40 light years from Earth - has a temperature of about 500 kelvins, or 450 degrees Fahrenheit, and suggests that it has no significant atmosphere.

The study also marks the first detection of any form of light emitted by an exoplanet as small, and as cool as, the rocky planets in our own solar system.

"These observations really take advantage of Webb's mid-infrared capability. No previous telescopes have had the sensitivity to measure such dim mid-infrared light," study co-author Thomas Greene said.

Astronomers discovered the planet system orbiting an ultracool red dwarf star (or M dwarf) in 2017.

Later observations revealed that its innermost planet Trappist-1b has an orbital distance about one hundredth that of Earth's, receiving about four times the amount of energy that Earth gets from the Sun.

While trappist-1b is not within the system's habitable zone, researchers say observations of the planet can provide important information about its sibling planets, as well as those of other M-dwarf systems.

OF GOLDS AND GREENS ... A golden-fronted leafbird perched on a flowering plant in Habiganj's Satchari National Park. These bulbul-sized birds' range extends from the Indian subcontinent and south-western China to south-east Asia and Sumatra, and they generally prefer tropical areas as their habitat. Tiny but territorial, golden-fronted leafbirds will not tolerate other species in their zone. They prefer being in the comfort of their own kind and tend to stay in pairs. What makes them striking is the various colours in their plumage – the green feathers extending to the dark face bordered with a yellow throat, a blue chin, and a spectacular orange finish on the forehead, for which they are called "golden-fronted". Their calls are like fluid chirps -- if you can mimic it, they will chirp right back at you!
