## Editors Guild, **DUTA slam** Prothom Alo report

Criticising a report of the Prothom Alo for not maintaining the highest standards of journalism, the Editors Guild Bangladesh yesterday said publishing the report on the Independence Day was inappropriate.

**Editors** Guild Bangladesh President Mozammel Babu and General Secretary Inam Ahmed in a statement said the March 26 report was tantamount to undermining the great independence.

"Nobody is above the law. However, we are calling for soliciting opinion from the Press Council before filing any case if anyone feels aggrieved at any report run by any mainstream media outlet," they said.

In another statement, Dhaka University Teachers Association vesterday said the Prothom Alo report mocked the country's independence.

"At a time when the news of Bangladesh's economic turnaround after fighting the crisis stemming from the Covid-19 pandemic and Ukraine war is being circulated across the international media outlets, the attempt to make the state ineffective in the name of opposing the government through a national daily cannot be accepted in any way. We urge everyone not to get confused by such news...," read the statement, signed by DUTA President Nizamul Haque Bhuiyan and General Secretary Zeenat Huda.

The statement, however, didn't mention the name of the Prothom Alo.

## Blinken affirms Israel ties

US Secretary of State Antony Blinken on Thursday pledged enduring ties with Israel but warned against inflaming tensions with the Palestinians, following a rare public spat between the allies.

President Joe Biden on Tuesday called on Israeli Prime Minister Benjamin Netanyahu to step back from a bid to weaken the judiciary that has set off massive protests.

# ChatGPT blocked in Italy

Italy's privacy watchdog said yesterday it had blocked the controversial robot ChatGPT, saying the artificial intelligence app did not respect user data and could not verify users'

The decision "with immediate effect" will result in "the temporary limitation of the processing of Italian user data vis-avis OpenAI", the Italian Data Protection Authority said.

The agency has launched an investigation. ChatGPT, created by US startup OpenAI and backed by Microsoft, can answer difficult questions clearly, write code, even passing difficult sonnets, or essays -exams for students.

But the app that appeared in November is controversial, with teachers fearing students will use it to cheat, and policymakers concerned about the spread of misinformation.

The watchdog said that on March 20, the app experienced a data breach involving user conversations and payment information.

It said there was no legal basis to justify the mass collection and storage of personal data for the purpose of 'training' the algorithms underlying the operation of the

It also said that since there was no way to verify the age of users, the app "exposes minors to absolutely unsuitable answers compared to their degree of development

It said the company had 20 days to respond how it would address the watchdog's concerns, under penalty of a 20-million-euro (\$21.7-million) fine, or up to 4 percent of annual revenues.

The blocking of ChatGPT in Italy comes days after the European policing agency Europol warned that criminals were set to use the app to commit fraud and other cybercrimes, from phishing to malware.

## Suspend use of DSA immediately

Apart from Shams, Prothom Alo Editor and Publisher Matiur Rahman, an unnamed photographer, and unnamed others were accused in the case filed under the DSA.

The UN office mentioned that in February, a young man, Poritosh Sarkar, was sentenced to five years in prison under this law after being accused of hurting religious sentiments through a Facebook post.

"My Office has consistently raised concerns about the overly broad and ill-defined provisions of the Digital Security Act.

"The government has promised there will be safeguards against the arbitrary or excessive application of the law but that is not enough when arrests continue. The law itself needs a proper overhaul," read the statement.

The high commissioner called for the creation of an independent judicial panel to review all pending cases brought under the DSA with a view to those accused being released.

The UN rights office also said over 2,000 cases have been brought under the DSA, which came into force in October 2018. Demanding immediate scrapping

of the DSA, Dhaka Reporters Unity yesterday said the law is a threat to independent and investigative journalism. Repeated misuse of this act

is an impediment to journalists discharging their professional responsibilities. Instead of going to the Press Council to seek redress for grievances over newspaper reports, most individuals are now filing lawsuits under the controversial act and harassing journalists, the DRU said in a press release. US state Meanwhile. the

department expressed deep concern over the Bangladesh government's use of the DSA.

During a question-answer session, US state department's Principal Deputy Spokesperson Vedant Patel said, "So broadly, what I would say is we remain deeply concerned about the government's use of the Digital Security Act. And freedom of expression, including for members of the press, is an essential element

of democracy and is especially in Savar around 4:00am on important in an election year.

Journalists (CPJ) in a statement published on its website, said, "Bangladesh authorities' harassment of staff members with the Prothom Alo newspaper and the arrest of correspondent Shamsuzzaman Shams under the draconian Digital Security Act are clear attempts to quash critical reporting."

CPJ Program Director Carlos Martinez de la Serna said. "Authorities must immediately release Shams and cease abusing the legal process against journalists, which produces a chilling effect on the media.'

Workers' Party Bangladesh in a statement said the case against Prothom Alo journalists set another example of how the DSA is being used as a weapon of repression.

While posting a report written by Shams on social media on March 26, the Independence Day, Prothom Alo made a "card" with a quote of a labourer named Zakir Hossain. Though the card contained Zakir's quote, it had the photo of an adolescent boy taken from behind.

The mistake was noticed within 17 minutes, and the card was removed. Besides, corrections were made to the report and the news was again published online mentioning the corrections.

Jahangirnagar University students kept the Dhaka-Aricha highway blocked for almost an hour, demanding release of Shams and scrapping of the DSA.

Around 50 students marched through the campus in the afternoon before blocking the road.

Prothom Alo Bandhu Sabha Chattogram, a platform of readers of the paper, formed a human chain demanding withdrawal of the cases filed against the journalists.

People from different of life formed a human chain in Thakurgaon town where speakers said instead of arresting journalists, the government should take proper steps to address market manipulation that contributes to the rising prices of food.

## Death toll in India temple collapse rises to 36

The death toll after a floor collapsed the law. He was taken to Kashimpur be threatened, harassed, physically at a Hindu temple in India had risen to 36 yesterday after rescuers discovered the body of the last person still missing, police told AFP.

Dozens of worshippers celebrating a major religious holiday plunged into the stepwell -- a stair-lined communal water source Thursday after the floor covering it collapsed in the central city of Indore.

"Seventeen people were rescued vesterday. Thirty-six bodies have been recovered," senior police officer Manish Kapooria told AFP. Women, children and an

18-month-old baby were among those standing on the grill covering the well when it buckled and gave way, plunging them into about 7.5 metres (25 feet) of water. The bodies of dozens of victims

were cremated on pyres near the scene of the accident yesterday after brief funeral rites. Prime Minister Narendra Modi

said Thursday he was "extremely pained" by news of the accident. "My prayers with all those affected

and their families," he added. Modi's office said compensation

payments of 200,000 rupees (\$2,400) would be given to the next of kin. Narottam Mishra, home minister

of Madhya Pradesh state, told reporters on Thursday that an investigation had been launched into the mishap.
